Have your say on the implementation of RBMP

Minister Eoghan Murphy has published the draft timetable and work programme for the preparation of Ireland's RBMP for the 3rd WFD Cycle which sets out the process and milestones to be achieved over the next 3 years until the final RBMP is published in December 2021. It also highlights the measures the Department will take to comprehensively engage with the public on the plan and the steps it will take to engage with all stakeholders across the work programme.

An online survey monkey questionnaire aims to determine public opinion on the current RBMP and the level of engagement between the implementing bodies and the stakeholders. It will help to evaluate the success of measures within the current plan for improvement of water quality.

Community Information Meetings in Priority Areas For Action

The River Basin Management Plan lists 190 water bodies for targeted water quality improvement actions up to 2021, these are known as 'Priority Areas for Action' (PAAs). Water quality improvements will deliver multiple benefits for: human health, wildlife, and local economies through tourism and sustainable industry. This approach will require ongoing coordination and collaboration between local authorities, state agencies and stakeholders, together with continued public engagement and participation.

The Local Authority Waters Programme will host public meetings in these PAAs to inform local communities and stakeholders of planned activities on water bodies identified for further assessment. These meetings started in November 2018 and will continue over the lifespan of the RBMP. Meeting details will be advertised in local press, radio and on social media and upcoming meetings in the Midlands and Eastern region are on the next page.



EVERY PERSON HAS A ROLE TO PLAY IN PROTECTING WATER QUALITY

WHAT

Conserve:

-Fix leaky taps to conserve

water

-Use water butts to capture rainwater for use in the garden -Install hippo bags in toilet cisterns (a red brick would do) 1/3 of water used in our house-holds goes down the toilet

Protect:

-NO grease, oil or fats go down the drain (brown waste bag) -Only 3 Ps down go down the

toilet (pee, poo, paper)
-Check the septic tank regularly

and desludge when necessary -Minimise your use of garden

chemicals

-Buy local foods and do fewer car journeys where possible

WHY:

Water is precious
-It takes 140 litres of water to make a cup of coffee (to grow the beans, transport and process them, prepare and make your coffee)

-Every day each person in Ireland uses between 80 and 150

litres of water

-lt takes 1500 litres of water to make 1 kg of beef (that is four fat hamburgers). That is for the animal to grow, process,

transport and package the meat -528,000 disposable coffee cups are discarded in Ireland every

Ongoing activities

The Catchment Assessment Team supported by the Community Water officers have been undertaking desk studies and delivering Community Information Meetings in counties Offaly, Westmeath, Wicklow, Kildare, Longford, and Dublin.

The Silver River (Kilcormac) is a priority area for action in Co. Offaly and our first Agricultural Sustainability Support and Advisory Programme farmers meeting was held on a farm in the catchment on the 20th February 2019. 25 farmers listened to David Webster of the ASSAP team and Joan Martin and Kate Tynan from LA Waters Programme as they discussed local plans and some water quality issues in the catchment. Mr. Webster explained the Source, Pathway, Receptor Model and the various actions farmers can take to improve water quality around the farm. The value of silt traps on the farm was noted as they break the pathway to the river.

At the meeting the LA Waters Programme science team presented macroinvertebrate samples from Cadamstown, where the water quality is good, and compared it to a macroinvertebrate samples taken at Ballynacarrig Bridge, where there is moderate water quality. They pointed out the key sensitive species that were missing in the Ballynacarrig sample. They also discussed how the river supports the croneen trout and white-clawed crayfish. Armed with a scientific understanding of the issues at play, David explained how we hope to improve stakeholder relationships with the aim of agreeing local measures on the ground to improve water quality in a non-enforcement collaborative way.





Community Water Development Fund 2019 (CWDF)

The Community Water Development Fund is a new fund, administered by the Local Authority Waters Programme on behalf of the Department. One element of the Community Water Development Fund is an open call. The first open call was issued in in 2018 & the second open call was issued in early 2019.

The aim of the Community Water Development Fund is to support communities in progressing water related projects and initiatives, delivering benefits locally whilst also helping to meet the objectives of the River Basin Management Plan for Ireland and the wider EU Water Framework Directive. The objective of the fund is to enable communities to get more involved in the management of their local water environment, delivering multiple benefits for present and future generations. The fund assists in the protection and management of water quality, both locally and in the wider catchment.

In 2019 the CWDF received 150 applications Nationwide, up from 104 in 2018. In the Midlands/East Region 6 applications were received from Westmeath, 5 from Kildare, 6 from Offaly, 7 from Dublin, 4 from Meath & 2 from Longford. All applications are currently under review with results due end of April 2019.
