FORM OF COMPULSORY PURCHASE ORDER UNDER SECTION 76 OF AND THE THIRD SCHEDULE TO THE HOUSING ACT, 1966, AS EXTENDED BY SECTION 10 OF THE LOCAL GOVERNMENT (No.2) ACT, 1960 AND AMENDED BY THE PLANNING AND DEVELOPMENT ACTS, 2000 TO 2016

LOCAL GOVERNMENT (No.2) ACT, 1960
SECTION 10 OF THE LOCAL GOVERNMENT (IRELAND) ACT, 1898 AS
AMENDED BY SECTION 11 OF THE LOCAL GOVERNMENT (NO.2) ACT, 1960
AND SECTION 213 OF THE PLANNING AND DEVELOPMENT ACT, 2000 TO
2016

WHEREAS in pursuance of section 10 of the Local Government (No. 2) Act, 1960, as substituted by section 86 of the Housing Act, 1966 as amended by section 6 and the Second Schedule to the Roads Act, 1993 and by the Planning and Development Acts, 2000 to 2016, the Kildare County Council (hereinafter referred to as "the local authority") have decided to effect the acquisition of the land to which this order relates under the Housing Act, 1966:

NOW THEREFORE it is hereby ordered that -

- 1. Subject to the provisions of this order, the local authority are hereby authorised
  - (a) to acquire compulsorily for the purposes of a Landfill Remediation Project between the Townland of Kerdiffstown in the District Electoral Division of Kill in the County of Kildare and the Townland of Maudlins in the District Electoral Division of Naas Rural in the County of Kildare including the end use as a Public Access Park, with Playing Pitches, Changing Rooms and Playground, the lands described in Part II (lands being permanently acquired) Part III (lands being temporarily acquired) of the Schedule hereto which land is shown on a map marked;

KILDARE COUNTY COUNCIL COMPULSORY PURCHASE KERDIFFSTOWN LANDFILL REMEDIATION PROJECT ORDER 2017 deposited map, Drawing No. KLRP/3300/01 and sealed with the seal of the local authority and deposited at the offices of the local authority (hereinafter referred to as "the deposited map").

- (b) To extinguish the public rights of way described in Part IV of the Schedule hereto by order made after the acquisition of the land, where the said public rights of way is over the land so acquired or any part thereof, or over land adjacent to or associated with the land so acquired or any part thereof, and
- (c) To acquire compulsorily the rights as described in Part V of the Schedule.
- 2. The land described in Part II and Part III of the Schedule hereto and coloured grey on the said map is land other than land consisting of a house or houses unfit for human habitation and not capable of being rendered fit for human habitation at reasonable expense.
- 3. Subject to any necessary adaptations, the provisions of
  - (a) the Land Clauses Acts (except sections 127 to 132 of the Lands Clauses Consolidation Act, 1845, and article 20 of the Second Schedule to the Housing of the Working Classes Act, 1890),

and

(b) the Acquisition of Land (Assessment of Compensation) Act, 1919, as amended by the Acquisition of Land (Reference Committee) Act, 1925, the Property Values (Arbitrations and Appeals) Act, 1960, and the Local Government (Planning and Development) Act, 1963 (as applied by section 265(3) of the Planning and Development Act, 2000), and as amended by Section 48 of the Planning and Development (Strategic Infrastructure) Act, 2006,

as modified by the Third Schedule to the Housing Act, 1966, are hereby incorporated in this order and the provisions of those Acts shall apply accordingly.
