NOW THEREFORE the Local Authority in exercise of the powers conferred upon them by Section 81 of the Housing Act, 1966, as applied by Section 10 of the Local Government (No. 2) Act, 1960 as substituted as aforesaid, hereby order that the said land shall on the 21st day of December, 2020, vest in the Local Authority in fee simple free from encumbrances and all estates, rights, titles and interests of whatsoever kind (other than any Public Right of Way).
