2.1 POLICY

This Part of the Plan sets out the detailed policies of the Council in respect of the major areas of the county where pressures for development have arisen or where a need for conservation has been identified in Part One. In addition, it sets out general policies relating to the proper planning and development of the county.

2.2 BASIC POLICY AIMS

The main policies of the Development Plan are to provide an adequate framework for all land use needs providing for the integration of new development with the existing physical fabric, to achieve a better quality of life for the people of the county by providing a better living and working environment, and to ensure the use of resources in a sustainable and environmentally acceptable manner.

It is the policy of the Council:-

- To create conditions conducive to economic expansion, environmental enhancement and social cohesion.
- To ensure that sufficient and suitably located land is allocated to satisfy development needs within the period of the Plan and in accordance with a strategy to ensure the balanced development of the county.
- To rationalise existing land uses and to create a coherent and clearly defined land use structure.
- To facilitate the development of amenities in the countryside and to conserve and improve the physical character of urban environments.
- To protect the existing physical character and landscape of the county.
- To protect heritage items of architectural, artistic, archaeological, historical and scientific interest and safeguard their environmental settings.
- To protect and conserve areas of natural amenity and develop their inherent recreational potential.
- To provide a framework and guidance for development control.
- To provide for the development of environmental areas in residential estates
- To ensure that the necessary public utility and social services are provided.
- To ensure the provision of a safe and comprehensive road system capable of satisfying the requirements of both vehicular traffic and pedestrians
- To ensure the implementation of the Housing Strategy 2001-2005
- To ensure that 20% of any land zoned solely for residential use or for a mixture of residential and other uses shall be made available for the provision of social/affordable housing in accordance with the requirements of Part V of the Planning and Development Act 2000 and the Housing Strategy 2001-2005.

- To facilitate the provision of services for the community including, in particular, schools, creches and other education and childcare facilities

2.3 REGIONAL DEVELOPMENT POLICY

It is the policy of the Council to encourage the preparation of a Regional Development Strategy in order to clarify the role of the towns and villages which are in the area of influence of Dublin. The Eastern Regional Development Organisation's Strategy (1988) provided some guidance in this regard, especially in the definition of the Dublin-subregion (which has been subsequently adopted by the Dublin Transportation Initiative). However, with the changes in circumstances, particularly demographic, administrative and developmental, since then, it is desirable that a new strategy be prepared.

The Strategic Planning Guidelines for the Greater Dublin Area, which have been published recently, and which broadly confirm the strategic direction of the county development policy, as set out in this Development Plan, will provide this overall strategy.

2.4. FUTURE DEVELOPMENT STRATEGY FOR CO. KILDARE.

2.4.1 Modifying existing planning policies in the light of the current trends, established policies and the DTI.

From the examination of issues and data presented in Part One of the Plan, it is clear that renewed policies with regard to strategic County development are now needed in the following areas:

- Considerable extension of the DTI area to include major centres such as Maynooth, Kilcock, Naas, Droichead Nua, Kilcullen and Kildare, in order to facilitate rational planning of the entire area under the commuting and other influences of the Capital.
- Zoning policies for the development of housing on a strategic and settlement basis, including a hierarchical settlement pattern for the County as a whole and also taking into account the Housing Strategy 2001-2005. The influences driving the market needs to be re-directed to other areas.
- Linked to the above, policies are required on the future of smaller settlements along the Dublin boundary, close to existing rapidly growing larger centres or beyond the existing growth area in the North East.
- Strategies for the development of shopping in the county.

2.4.2. Possible Strategies

A number of possible land-use and development strategies were considered by the Council as possibilities:

1. Continuation of market-led development in the North East of the County (the current position).
2. Control of development throughout both the Central and north-eastern areas of the County (the favoured DTI approach).

3. Linear high density developments along the public transport arteries (as advocated by the Mid-Eastern Regional Report, including growth centres in each County).
4. Balanced development in all urban centres.
5. Central Development emphasis around the original development triangle of Naas/Newbridge/Kilcullen as proposed in the Myles Wright report.

Each of the above strategies has advantages and disadvantages. In order to test the alternative strategies a number of objectives were identified:-

- ◊ Match settlement patterns to job locations.
- ◊ Support retention of rural population.
- ◊ Minimise opposition to market led developments.
- ◊ Reduce travel to work times and reduce car borne travel to work.
- ◊ Maximise use of public transport
- ◊ Reduce dependence on Dublin for shopping, service provision and employment
- ◊ Foster the development of retailing in the county.
- ◊ Protect the environment in terms of water quality, landscape and general environmental degradation.

Analysis of the above strategies indicated that (3) and (4) were the least attractive options, while the most attractive were:-

- Strategy 1. Market led development in the North-East supported by the required infrastructural provisions.
- Strategy 5. Central Development emphasis around the Droichead Nua/Naas/Kilcullen Development Triangle.

Strategy 5 is overall the most effective in meeting the objectives set out and if effective can achieve, or is more likely to achieve, a balanced development of the county overall. The major issues which will have to be tackled with Strategy 5 are the market pull of the North-East and associated mis-match between jobs and residential location. (This strategy is also that which is generally envisaged in the Strategic Planning Guidelines for the Greater Dublin Area (1999).

2.4.3 Recommended Strategy

2.4.3.A. Strategy for the Expanding Areas of the County

Planning strategies which call for a radical reversal of market trends can be unsuccessful, but it is often possible to re-direct market trends to locations which are more appropriate from an orderly planning point of view. In the present context there is an opportunity to encourage a movement of the focus of development within County Kildare by adopting a more pro-active strategy which influences the location of development.

The heart of this strategy will be to redirect the outward movement of population currently flowing along the N4 in the north-east in a southward direction to the centre of the county. This strategy would have the following strong advantages:

- There is a proposal in the Mid-East Regional report for the development of what is termed Priority Route 1 which skirts Dublin and extends from Drogheda to Wicklow. Part of the route goes from Maynooth/Kilcock to Naas and Blessington via Clane. This is in fact a heavily used route at present and the Council have long pressed for funds for its improvement.
- A north-south link would further enhance the attractiveness of the Kildare central area for distribution and warehousing, because it would provide ready access to the north-west of the county.
- With the major shopping centres of Blanchardstown, Quarryvale (Liffey Valley) and Tallaght, it is unlikely that regional shopping centres will emerge in the North-East of the County.

The better option would be to promote a location nearest the centre of the County, in the Droichead Nua/Naas area. Pulling residential development southwards would enhance the prospects for successful retail development in this area.

- There are strong arguments for the development of office centres at Naas and Droichead Nua, since they are accessible, and have established urban infrastructure.

The proposed strategy seeks to modify very strong market trends in favour of more rational patterns of development.

This Strategy must, however, be subject to critical examination of infrastructure on a settlement by settlement basis.

2.4.3.B Strategies for the Disadvantaged Areas of the County.

In order for the development of the county to be better balanced, there will also be a need to define a strategy for the more disadvantaged areas of the county. While it will be difficult to re-direct the market this far from the Dublin Metropolitan area, the re-direction of development to the central area of the county will have spin-off effects for the south and west of the county. A development strategy for the disadvantaged areas and settlements in the south, north-west and west of the county will be prepared, in conjunction with other agencies, during the period of the Plan.

The following points may be made in respect of a strategy for these disadvantaged areas of the county.

- In the North-West, development should be considered independent of the North-East, except insofar as backward linkages might be developed to such locations as Edenderry. The peat fired power station in this area will be of significant benefit.
- In the South of the County the position is more difficult. Here rural development strategies as outlined in the County Leader Plan, and the Programmes of Action South Kildare and those of the County Enterprise Board will be required for locations such as Castledermot. At the very southernmost part of the County, consideration should be given to the development of growth strategies which would link the area to Carlow, which is a dynamic growth centre, possibly focused on the food sector.
- Athy is the major urban centre in south Kildare, and has considerable potential for future development. Road access to the town and its hinterland has improved with the construction of the Kilcullen Motorway By-Pass and rail access can be readily improved. It should be noted that the development of Athy would be best served by the Myles Wright strategy, since such a strategy will promote major services at a location accessible to the South of the County. In the South itself, it is likely that the food processing sector may be the key to further development if adequate water and sewerage treatment is available. The designation of Athy as a Heritage Town and its potential for tourist development based on this and on the canal and River Barrow should also be stressed.
- In general, it is considered that a Southward move of the County's development focus is more likely to benefit the remoter rural areas than the current market-led developments concentrating on the north-east.

2.5 COUNTY DEVELOPMENT POLICY

It is the policy of the Council to promote the southward move of development within the county to re-direct pressures from the north-east and to encourage the spread of development through the towns of the centre to the west, north-west and south of the county.

In order to achieve this, the Council has decided to define an overall settlement strategy, providing for a hierarchical settlement pattern within the county. This involves the definition of target populations for the towns of the county to the year 2006. The individual Development Plans for these towns, where these have not yet been adopted, will be governed by these target populations, and residential lands will be zoned in those plans, where required, to a level not greater than the zoning amounts set out in this Development Plan, which are in addition to the amount of committed and uncommitted residential lands already zoned in the towns concerned. These targets and zoning amounts take into account the need to allow for choice in residential location and lands not coming onto the market, and the need to allow for decreasing household size in the period concerned.

* The development plans for these towns are currently being reviewed by the planning authorities concerned - Naas and Athy U.D.C.s, - and it is the Council's policy to seek co-operation with these authorities in the development of the county as a whole.

It is considered essential that the towns and villages within the north-east of the county should retain their individual identities and physical separation. The Council will protect the character and amenities of the open countryside which separates the towns. Council policy in relation to the expansion of these towns and villages will take into consideration the desirability of their future expansion, the availability of water and sewerage facilities to service proposed developments, the proper provision of community facilities and the development of a satisfactory traffic and circulation system.

The Council recognises that parts of the county, which historically have been dependent on the extraction of turf, and associated electricity generation, have special developmental needs which have more in common with parts of Counties Laois and Offaly than with the east of County Kildare. It is the policy of the Council to encourage job creation, environmental enhancement and infrastructural provision in order to facilitate the development of this area, in co-operation with national, regional and local bodies and authorities.

2.6 DEVELOPMENT OF TOWNS.

It is the policy of the Council to encourage the development of balanced commercial, industrial and community facilities in all of the towns in the county, in addition to their residential expansion. It is intended that employment opportunities should be provided for in reasonable proximity to residential areas within such towns, so as to minimise the need for private transport.

At the same time, it is recognised that many of the towns of the county perform a function as residential areas for persons whose employment is in other locations, particularly within the Dublin metropolitan

area. It is the policy of the Council to provide for this need, while seeking to facilitate commercial, social and community facilities to serve their needs.

The Development Plans for these towns set out the policies of the Council in respect of their own development areas. It is the policy of the Council to ensure that the environs of towns are not prejudiced by urban development, particularly housing in a linear ribbon fashion along the approach roads. It is also the policy of the Council to prohibit retailing outside the towns of the county and particularly in the north-east, in order to protect the commercial viability of town centres.

2.7 DEVELOPMENT OF VILLAGES AND OTHER SETTLEMENTS

Many of the villages and smaller hamlets, listed in Part One of this Plan, have a basic nucleus of community facilities and services (in the form of small shops, school, church or community hall), but are not likely to develop a wider range of services, nor at such a large scale, as the towns of the county. However, these villages and hamlets perform an important social and environmental function within the rural countryside, and the value of this is recognised by the Council. Accordingly, it is the Council's policy to seek to retain existing services and facilities in such villages and hamlets, and to allow for their limited expansion where possible. It is also the policy of the Council to encourage infill housing development within these settlements, and to seek to direct the pressure for individual one-off housing from the outlying rural areas into such settlements by encouraging low density development within them.

It is Council policy to encourage clusters of houses within the settlements listed in this Plan. In such clusters, it is the policy of the Council that the occupancy of houses would not have to comply with the rural housing policy set out in section 2.9.1. below.

Housing developments, consisting of groups of houses developed for sale, will not be permitted in the rural countryside, but will be encouraged in existing villages and other settlements, as indicated above.

It is the policy of the Council to prepare and facilitate Village Renewal Schemes during the period of the Plan, incorporating environmental improvements, provision of infrastructure and amenities, and the development of small enterprise and employment opportunities. A County Action Plan for Village and Urban improvement, under the EU Operational Programme for Urban and Rural Development, for the period 1995 - 1999 has been prepared and approved by the Council and by the Department of the Environment and Local Government. This involves a five-year programme of works in selected towns and villages within the county. Further such programmes will be prepared for other villages and towns within the county during the period of the Plan.

2.8 SPECIAL VILLAGES/TOWNS OF SPECIAL TOWNSCAPE/HERITAGE CHARACTER

These are villages and small towns identified as having overall special amenity character and special quality. It will be the policy of the Council that this character and quality will be retained, and that all new developments will be in sympathy with this. It will also be Council policy to encourage amenity and environmental improvements schemes to these villages, so to enhance their character.

2.9 RURAL DEVELOPMENT

2.9.1. Housing in the Rural Countryside

The Council recognises the need to retain the rural population of the county, and to support rural communities and their services (such as schools, small shops etc.). This is particularly the case in the south, north-west and parts of the west of the county, where this population is declining or static.

However, it is also recognised that some rural areas of the county are under development pressure, particularly from scattered urban-generated housing. As indicated in Section 1.12 in Part One, this is creating problems for the balanced development of the county as a whole.

In order to preserve the rural character of these areas, to prevent the degradation of the rural landscape resource, to protect the operations of the bloodstock industry, and to ensure economies of servicing and settlement, it is the policy of the Council that sporadic one-off housing in the rural areas of the county (i.e. outside towns, villages and smaller settlements identified in para. 1.11.6) will not be permitted, subject to the exceptions set out below.

Accordingly, in order to retain the rural population of the county, and to support rural communities and their services (such as schools, small shops etc.), the general policy set out above will not be applied in respect of certain categories of persons. These are as follows:-

A. Within the Areas of Development Pressure outlined on map no. 4, and other than in Areas of High Amenity, and along National Routes and certain Regional Routes (The Naas to Kilcock route, the Clane to Barberstown to Maynooth route and the Edenderry to Enfield route), a positive presumption will be given toward the building of one-off houses, for their own occupation, of the following classes of persons:-

1. Persons whose primary employment is in agriculture, horticulture, forestry or bloodstock, or,
2. Members of farm families, seeking to build on the family farm, or,
3. Landowners and members of landowners families (landowner for this purpose being defined as persons who owned the land in question at the date of adoption of the Draft Development Plan in June 1998)
4. Persons whose primary employment is within Co. Kildare, and need to live in a rural location because of that employment, or whose employment would provide a service to the local rural community.
5. Persons who have existing family linkages with the rural location in which they wish to build.

B. Outside the Areas of Development Pressure outlined in map no. 4, and other than in Areas of High Amenity, and along National Routes and certain Regional Routes (The Naas to Kilcock route, the Clane to Barberstown to Maynooth route and the Edenderry to Enfield route), a positive presumption will be given toward the building of one-off houses, for their own occupation, of the following classes of persons:-

1. Persons whose primary employment is in agriculture, horticulture, forestry or bloodstock, or,
2. Members of farm families, seeking to build on the family farm, or

3. Persons whose primary employment is within Co. Kildare, and need to live in a rural location because of that employment, or whose employment would provide a service to the local community, or,
4. Persons who have existing social or community linkages with the rural location in which they wish to build (whether by family history, educational or social connections).

In order that such one-off housing will not contribute to ribbon development, especially along approach roads to towns, villages and settlements, and will not interfere with the maintenance of a clear line between town and country, the Council may permit clusters of houses for the categories of person set out in A and B above. Such clusters will not consist of more than 8 dwellings.

In Areas of High Amenity, and on National Routes and certain Regional Routes (The Naas to Kilcock route, the Clane to Barberstown to Maynooth route and the Edenderry to Enfield route), whether or not within the Area of Development Pressure, only members of farm families, or landowners and their families (landowner for this purpose being defined as persons who owned the land in question at the date of adoption of the Draft Development Plan in June 1998), who cannot obtain an alternative site away from these Routes or outside these Amenity Areas, will be considered for a one-off house for their own occupation.

2.9.2. Other Developments in the Rural Countryside

Apart from one-off housing development, there are many uses which may take place in the rural countryside. Where an area of land is not within an identifiable settlement, and is not otherwise zoned as part of this Development Plan, or of the town Development Plans, the use of such land will be deemed to be primarily agricultural.

Agricultural development generally, with some significant exceptions, is classified as exempted development and such development which is not classified as exempted by the Exempted Development Regulations will be considered on its merits.

The Council will encourage the development of broadleaved forestry within the rural countryside, especially oak and beech. Amenity forestry, which will be of value for recreation and tourism, will also be encouraged.

Agriculturally related industries which are environmentally sustainable are, in general, considered a suitable use, subject to the development of tourism, the protection of amenities (including rivers, lakes and canals), and the protection of the requirements of certain activities, such as those associated with the Bloodstock Industry.

The Council will seek to facilitate the development of rural enterprise, and in particular the alternative use of agri-buildings for industrial, workshop, services or training on a micro-enterprise level. Conversion of redundant farm buildings for owner-run enterprises of these kinds, and for agri-tourism accommodation and similar use, will be encouraged. The use of farm buildings for the development of dwellings will not be permitted, other than in accordance with the provisions of Section 2.9.1 above. In particular, the development of redundant farm buildings for dwelling units for sale will not be permitted.

In addition, the Council will encourage the development of tele-working throughout the county, and especially in rural areas. The Council will also co-operate with the economic development agencies in providing "tele-cottages" to service the needs of local enterprise in the remoter parts of the county.

All other development will be treated on its merits having regard to the interests of amenity and the inherent requirements of the Bloodstock Industry.

2.10. INDUSTRY AND EMPLOYMENT

It is the policy of the Council to promote environmentally sustainable industrial and warehousing employment generating developments in those areas of the county where the necessary infrastructure exists or can be provided.

It is the policy of the Council to encourage and facilitate the expansion of existing industry where this conforms with good planning practice and to provide for the establishment of new industries, in association with national, regional and local development agencies, including Forfas, IDA, Enterprise Ireland and the County Enterprise Board, where appropriate. It is an objective of the Council to encourage and facilitate employment-generating development on the former ESB properties at Allenwood and at the former Bord na Mona Lullymore Plant.

In relation to applications for industries in rural areas, it is recognised that regard must be had to tourism and amenity and the inherent requirement of certain activities such as those associated with the Bloodstock Industry.

The Council recognises the substantial employment potential of small enterprises, and will encourage their establishment. To this end, it is the policy of the Council to provide, as resources permit, in conjunction with national, regional and local development agencies, sites and premises for small industries and services in particular locations within the county, and especially in areas suffering population decline or economic disadvantage. It is also Council policy to facilitate home-based economic activity in towns and villages, subject to limitations of amenity and traffic.

The Council recognises the importance of agricultural employment in the economic structure of the county. It is the policy of the Council to provide and expand services necessary to the agricultural sector, and to encourage the development of viable agricultural enterprises.

Because of its location close to the Dublin Metropolitan Area, and especially as a result of improved transportation infrastructure, the county is well suited for the establishment of tertiary service industry. The Council recognises the future employment potential of such industry, and will encourage its provision and expansion.

The Council recognises the advantages of clustering of smaller enterprises around major industrial and service industries, both indigenous and multi-national, and will facilitate, through zoning and through co-operation with the relevant agencies, their establishment. The Council will also seek to co-operate with the NUI Maynooth in the provision of a Technological Innovation Centre and/or a science park on University lands at Maynooth.

2.11. BLOODSTOCK INDUSTRY

The Council recognises the importance of the bloodstock industry in the county, both in land use and landscape terms, and in the direct and indirect employment generated by it. The expansion of this industry is one of the primary goals of the Council as a development agency. To this end, it is the Council's policy to protect the environmental qualities necessary for its successful operation. The high amenity value, which investment in this industry requires, will be protected from encroachment or spoilation by urban sprawl, ribbon development or other anti-amenity features or incompatible developments.

The Council will co-operate with the relevant statutory and voluntary bodies to facilitate the establishment of a National Equestrian Centre in the county. It is the Council's policy to continue to

foster activities such as bloodstock sales and other features of breeding and racing aspects of the bloodstock industry.

2.12. SERVICES

2.12.1. Utility Services

It is the policy of the Council:-

- (1) to extend water, sewerage and refuse disposal services to meet the expanding needs of the county within the limits of cost effectiveness and availability of finance.
- (2) to improve the provision of services in those areas of the county where deficiencies exist at present.
- (3) to comply with discharge standards to waters as required by European and national legislation, subject to the availability of finance.
- (4) to hold industry, including agriculture, responsible for the treatment and safe disposal of all its waste and effluent in a manner and to a standard acceptable to the Council.
- (5) to co-operate with an Bord Gais in any future extension of Kinsale Gas to Kildare towns and industry.
- (6) to co-operate with the E.S.B. in the development of electricity services, subject to amenity requirements.
- (7) to co-operate with Telecom Eireann and any other telecommunications service provider in the development of this service, subject to amenity requirements.
- (8) it is the policy of the Council to preserve the capacity of water and sewerage services solely for the use of developments, including industrial development, within County Kildare, particularly in those areas under pressure for development from the Dublin Metropolitan Area, subject to agreement with adjoining local authorities,
- (9) to ensure that all new cabled services in towns and villages within the county are located underground, and to seek to have all existing overhead cables undergrounded on a phased basis.
- (10) to ensure that all villages and settlements are provided with an adequate water supply within the limits of cost effectiveness and availability of finance.

2.12.2. Waste Disposal

It is the Council's policy to encourage waste prevention, minimisation, reuse, recycling and recovery as methods of managing waste, and to examine the possibility of converting waste to energy. It is the policy of the Council that such strategies will take precedence over other forms of waste disposal such as landfill.

It is the Council's policy to ensure that a comprehensive wheeled bin collection service is provided in the county. The Council's policy in respect of waste collection will, where possible, include sorting of waste to facilitate re-use and recovery as well as composting.

In accordance with E.U. directives and national legislation, it is Council policy to identify and quantify the amounts of hazardous waste arising in the county. Companies generating such waste will be required to dispose of it in accordance with the legislation and in a manner satisfactory to the County Council.

It is the Council's policy to undertake the removal of abandoned vehicles and to implement the Litter Act for this purpose. It is the Council's policy that landfill sites, waste transfer stations and other waste handling operations be run to acceptable standards and that they be rehabilitated on completion of tipping.

It is the policy of the Council to rigidly enforce all planning conditions, legal requirements, and E.U. Directives applying to the landfill dump at Arthurstown, Kill, both during its development and its operation, and also to ensure that the dump shall cease to operate within ten years of the date of the granting of the planning permission on 10th July 1994.

The Council will require the operator of any private landfill to obtain planning permission and to obtain a permit under the E.C. (Waste) Regulations 1979 and the Waste Management Act 1996.

2.12.3. Water Pollution

It is the policy of the Council to carry out its statutory functions under the Water Pollution Act 1977/1990 and to take all necessary action against all individuals who cause or permit polluting matter to enter waters. The Council will issue licences for trade and sewerage effluents in accordance with acceptable standards and a Register of these licences will be kept for public inspection.

2.12.4. Air Pollution

It is the policy of the Council to carry out its statutory functions under the Air Pollution Act 1987. Air emission licences are issued to industries in the county who are included in the Schedule to the Act. A register of these licences will be kept for public inspection.

The Council will ensure that, in its policies and operations, it complies with the obligations arising from the Kyoto agreement and other international conventions in this area. In particular, the Council will have regard to the manner in which policies relating to industry and settlement strategy may contribute to air pollution. This includes the impact of increased levels of traffic, and traffic congestion, on air pollution.

2.12.5. Cemeteries

It is the policy of the Council to extend existing cemeteries as the need arises. When suitable land adjoining cemeteries is not available it is the policy of the Council to seek suitable sites in the immediate vicinity of the existing cemeteries. The Council, where necessary, will exercise its power of compulsory purchase to secure the necessary land. The Council will encourage the involvement of local communities in the maintenance of cemeteries.

2.13 LITTER ACT

The Council recognises the importance of protecting the roadside verges from indiscriminate dumping and litter and in keeping the environment in general, free from litter. It is the policy of the Council to carry out its statutory functions in relation to the Litter Act 1990.

2.14 TRANSPORTATION

2.14.1 Roads

The National Roads Authority (NRA) now has overall responsibility for National Primary and secondary roads. All works of design, construction and maintenance of these roads will be done in co-operation with the NRA.

It is the policy of the Council to protect the traffic capacity of all public roads. For this purpose, it is the policy of the Council to restrict new access points and to restrict developments which are likely to give rise to traffic hazard.

It is the policy of the Council to continue to implement the NRA's national programme for the provision of motorways where it affects the county, and also to continue to investigate the provision of an integrated network of major roads by-passing the principal towns of the county, and, where funds are available, to provide by-pass routes in order to remove through traffic from towns.

2.15.2 The roads of the county are divided into five categories:-

- (A) Motorways
- (B) National Primary Routes
- (C) National Secondary Routes
- (D) Regional or Main Roads
- (E) County Roads

A) Motorways

Access to Motorways is restricted by law to the official interchanges provided. It is the policy of the Council, in order to preserve the inherent safety and capacity of these roads, to pay particular attention to building lines, signs and external lighting when considering development near this type of road.

B) and C) National Primary and Secondary Routes

It is the Council's policy to give special protection to National Primary and National Secondary Routes in the interest of safety and maintenance of traffic capacity. In accordance with national policy, and in order to maintain the safety and traffic capacity of these routes, it is the policy not alone to restrict new entrances, but, where feasible, to close unnecessary entrances.

D) Regional or Main Roads

Many of these roads are of a high standard and are heavily used. It is the Council's policy to continue their improvements and to restrict new access points in the interest of traffic safety.

Recognising the importance of Priority Route I (Kilcock to Blessington) as an economic and tourist route linking North to Central Kildare it is the policy of the Council that the improvement of this heavily trafficked route be prioritised.

E) County Roads

These are generally the local roads of the county and their primary function is to serve local traffic. Each application for development on county roads will be considered on its merits, including the need to preserve road capacity and structure. It is the Council's policy in improving dangerous bends and junctions to integrate the improvements with the adjoining landscape.

2.14.2 Specific Roads Objectives

National Routes

- ◇ To continue the design (and subsequently the construction) of the Kilcock-Kinnegad Motorway in co-operation with Meath and Westmeath County Councils, when finance becomes available, to re-examine lines to the north and south of Enfield and to protect these lines and the remainder of the "preferred" line in the meantime.
- ◇ To provide an interchange on the M4 at Kilcock.
- ◇ To provide a grade-separated interchange on the M4 between Maynooth and Leixlip, connecting the M4 to the R148 (Leixlip to Maynooth road), the R405 (Celbridge to Maynooth Road), county roads 100 and 100A (Easton/Kilmacreddock road) and to existing industrial developments, together with associated ancillary works..

- ◇ To provide a by-pass of Kildare town, as part of the National Motorway Network.
- ◇ To upgrade the existing dual-carriageway between Naas By-Pass and the Dublin South County boundary, and provide grade separated interchanges at suitable locations.
- ◇ To design and construct a motorway from Hybla to the Heath by-passing Monasterevin in co-operation with Laois County Council, as part of the National Motorway Network.
- ◇ To provide for a new motorway between Naas By-Pass and the county boundary with South County Dublin, as part of the National road network, and to investigate alternative route alignments for this motorway.

- ◇ To improve the road from the Athy Road Interchange to the Carlow County Boundary, including the Moone-Timolin By-Pass and the Castledermot By-Pass.

N9 WATERFORD TO DUBLIN - GENERAL POLICY OBJECTIVE

NATIONAL PRIMARY ROUTE FROM WATERFORD CITY TO DUBLIN CITY

To facilitate the development of the National Primary Road Network in accordance with "Ireland, National Development Plan 2000-2006" and with the policy of the National Roads Authority as it applies to the provision of a national primary route from Waterford City to Dublin City. The extent of the new national primary route is from the proposed Waterford City Bypass in the South, to the N9/N7 National Primary routes in the North, with associated ancillary roads and services. It is the policy of this Council to assist and facilitate the achievement of this objective.

N78

- ◇ To improve substandard sections of the Kilcullen - Athy road in phase with finance.

N81

- ◇ To improve substandard sections of the N81 in phase with finance and in co-operation with Wicklow County Council

Regional Roads

- ◇ To improve substandard sections of regional roads, in particular those most heavily trafficked, those providing access to motorways and to existing or proposed industrial or commercial developments.
- ◇ To prioritise the improvement of the Blessington to Kilcock regional route.

- ◊ To co-operate with Offaly County Council in up-grading the Enfield to Carbury to Edenderry road, and that this work would also cater for the improvement of the road serving Rathangan.
- ◊ Apart from the above, to prepare and rank in order of merit a series of improvement schemes for non-national roads (regional and county) and bridges in order to take maximum advantage of any grants made available for these roads.

Local Roads

It is Council policy to improve local roads having regard to the availability of finance and the restoration programme for non-national roads.

To co-operate with Naas Town Council to provide the necessary roads infrastructure to facilitate the development of zoned land in Naas Town and Naas Environs

To provide a distributor road from the Newbridge Road (R445) to the Naas Town Boundary as shown on the Naas Environs Map No. 9

2.14.3 Public Transportation

It is the policy of the Council to encourage the use of public transportation, in preference to private car transportation, both on grounds of sustainability, and on grounds of proper planning and development. The Council will therefore co-operate with the various public and private agencies responsible for public transportation, including the Dublin Transportation Office, Dublin Bus, Iarnrod Eireann and Bus Eireann, and the private bus and coach companies, in the provision of new services, and supporting infrastructure such as depots, bus-bays, bus shelters and other facilities.

In the interest of promoting the use of public transport, in particular rail transportation, and of discouraging indiscriminate car parking in adjacent residential areas, the Council, in co-operation with Iarnrod Eireann and the DTO, will encourage the provision of adequate and secure "park and Ride" facilities at all commuter rail stations within the county, both existing and future. The specific objectives in relation to the locations of such facilities are included in the relevant Town Development Plans.

2.15 HOUSING

It is the policy of the Council to carry out its responsibilities in the housing sector, both public and private, to meet the needs of the county, so far as it is financially feasible. Surveys will continue to be carried out to determine the level of housing needs. It is the policy of the Council to eliminate unsatisfactory housing. All new housing will be required to be of a high standard of design and construction.

It is Council policy to take such action as may be necessary to acquire land needed to enable the implementation of housing programmes for both the social housing and private housing sectors, and in particular for the provision of sites and Joint Venture housing schemes.

It is Council policy in respect of social housing that all estates will be small, and that the density and design of social housing will be to the same standards and requirements as are applied to private sector housing.

The Council in its policy will aim for a balance in the provision of Council housing between the large towns and the smaller villages and settlements, while also providing for isolated cottages. The grouping of Council houses and services in villages and settlements will complement the Council's policy for the development of growth centres in rural areas acting as viable settlements for the provision of social services, thus facilitating the retention of rural populations. It is Council policy that all village housing developments will be related to the existing scale and character of those villages.

Part V of the Planning and Development Act 2000 requires that Planning Authorities adopt a Housing Strategy and insert it into their County Development Plan. Kildare County Council's Housing Strategy 2001-2005 is inserted in this plan as Appendix A. It is an objective of this Council to ensure the achievement of the objectives of the Housing Strategy 2001-2005. It is an objective of this Council to integrate housing provided under Part V of the Planning and Development Act 2000 into private development in a layout that prevents segregation and promotes good design and layout. A minimum of 20% social and affordable housing will be required on all sites that are zoned for residential development or a mixed use site that includes residential. The social and affordable housing requirements shall be met as set out in the Housing Strategy 2001-2005 which indicates an apportionment of 8% for social housing and 12% for affordable housing.

2.16 COMMUNITY FACILITIES

Kildare County Development Plan 1999

It is the policy of the Council to ensure the development of community facilities for the population of the county and to co-operate with other organisations in their provision.

It is the policy of the Council to facilitate the provision of additional second level schools in appropriate locations due to residential expansion in the county.

These facilities shall include school requirements, shopping facilities, swimming pools, community halls, churches and public open space, etc. It is the policy of the Council to prepare action plans for the growth areas of the various towns and also for areas where these facilities are inadequate at present. The policy will be to group these facilities advantageously in relation to developing residential areas.

In towns and villages in which the Council has purchased sites for community and recreational use, it is policy to develop these as soon as finances permit and in conjunction with other agencies and community associations. Major facilities such as swimming pools and major sports centres will be provided on a hierarchical basis so as to serve the widest possible population, subject to the provision of finance for such purposes. The Council will ensure that swimming pools and sports centres in its ownership will be maintained and improved, subject to the availability of the necessary finance.

The Council will seek to ensure that the time lag between the provision of recreational facilities in expanding towns in the county, and the development of residential areas, is kept to a minimum.

2.16.1 Third Level Education

The Council considers that there is an established need for an Institute of Technology in County Kildare and it is Council policy to co-operate in the provision of a suitable site located centrally in the county.

It is the policy of the Council to co-operate with other bodies in order to establish outreach centres of third level institutions in the county.

2.16.2 CHILDCARE FACILITIES

It is the policy of the Council to facilitate the provision of Childcare facilities in accordance with the "Childcare Facilities – Guidelines for Planning Authorities – June 2001". The Council will encourage the provision of a range of quality childcare facilities at a variety of locations. In particular childcare facilities should be provided :

- at Business Parks and other high employment locations
- in the vicinity of schools
- at Neighbourhood and District Centres
- at major Educational Institutions
- adjacent to public transport nodes and
- at large scale retail developments

All relevant development proposals shall indicate how the need for childcare facilities is being met. Further reviews of Town Plans and / or Local Area Plans shall take account of the "Guidelines on Childcare Facilities" and shall identify suitable locations for their provision, where this is feasible. The Council will assess the continuing need for childcare facilities, and progress on its provision, in conjunction with other relevant bodies.

2.17 LIBRARIES

It is the policy of the Council to continue to improve the library service throughout the county and to improve existing library facilities where these are found to be inadequate. It is intended to provide

facilities at selected libraries in order to avail of material made available by the National Museum and the Arts Council.

2.18 MUSEUMS

The Council recognises the need to provide facilities for the collection and display of natural, artistic, historical and scientific objects. It is the policy of the Council to provide a County Museum in Kildare Town. This museum will incorporate a section dealing with items of folk interest. The Council will continue to develop local museums reflecting items of specific interest in particular areas of the county. The Council will also continue to co-operate with various bodies involved in the provision of museum facilities.

2.19 THE ARTS

The Council recognises the need to provide facilities for the exhibition of works of art. It is the policy of the Council to provide a County Art Gallery in Kildare Town. In addition, facilities for the exhibition of works of art will continue to be provided in the County Council Offices, the County Library and branch libraries.

The Council recognises the need to promote the performing arts, to encourage and develop talent and, in particular, to provide opportunities for young people to perform in public. It is the policy of the Council to provide an Arts Centre in Newbridge.

2.20 RECREATIONAL OPEN SPACE

It is the policy of the Council to continue to review the recreational needs of communities in the county and to develop lands for recreational use, both active and passive, where lands suitable for this purpose are available to it.

It is the policy of the Council to ensure the retention of lands of special character and / or amenity for recreational use within the development areas of towns and villages. Such lands will often abut Areas of High Amenity such as Carton Demesne, lands adjacent to the Liffey and other rivers or the canals, lands adjacent to Castletown House and existing woodlands in Celbridge.

The loss of existing public or private recreational open space will normally be resisted by the Council unless alternative recreational facilities are provided in an equally suitable location, or it can be demonstrated that there is no longer sufficient demand to sustain the facility.

The Council will investigate ways of improving the quality and capacity of existing sporting and active recreational facilities through initiatives in both the public and private sectors. Sources of funding will be investigated to achieve this at government level through the National Lottery, with the governing bodies of the sports, and through private development proposals.

In new residential areas, it will be the policy of the Council to seek financial contributions from developers towards the provision of recreational open space, both passive and active, which is required to serve the needs of the new residential area, or where there is a loss of an existing facility to the residential land use. Developers will also be required to provide for sport and recreational infrastructure commensurate with the needs of the development as an integral element of their proposals. Provision on and off site should be made, or a development contribution imposed to fund appropriate alternative provision.

It will be the policy of the Council to support the development of active recreation within the county, through support of existing sports clubs and facilities, and though multi-use of public open space and recreational lands owned by the Council, by a variety of sports clubs and organisations.

It is the policy of the Council to provide and maintain recreational facilities where the need for such has been established and as finances permit. A priority list for recreation provision will be prepared and considered during the period of the Plan, based on a detailed survey on recreational needs.

2.21 COUNTRYSIDE RECREATION

The Kildare countryside generally and in particular rivers, waterways, items of archaeological, architectural and historical interest, upland and commons, provide major amenity and recreational opportunities for public enjoyment. It is the policy of the Council to ensure access to and conserve and develop the capacity of these areas. It will also be necessary to protect certain sensitive environments and to prepare and implement management plans for these. It is the policy of the Council to preserve or create rights-of-way where the need for such has been established. It is the Council's policy to co-operate with Cospoir, Duchas and other interested bodies in the development of long distance footpath systems.

2.22 TOURISM AND AMENITIES

The Council recognises the importance of sustainable tourism to the development of the county, to employment provision and to wealth generation. It is the Council's policy to encourage sustainable tourism, especially that based on the county's archaeological, historic and architectural heritage, and that based on the county's bloodstock and equine activities. It is also Council policy to promote the development of the canal system for tourist purposes, as outlined in section 2.26 below.

The landscape is a significant aspect of the tourism potential of the county. The subtle landscape of County Kildare has been identified as an important amenity feature which could be easily spoiled. It is the policy of the Council to keep a clean line between town and country and to ensure that urban expansion will be carried out in a compact manner particularly along the main tourist routes.

It is the policy of the Council to ensure that demesnes of national and international significance within the county are retained for their intrinsic value as part of the National Heritage. The Council recognises the contribution which such demesnes make to tourism as attractions in their own right, and will ensure that no development is permitted which would detract from the character and integrity of such demesnes. Proposals for leisure uses or other development may be open for consideration in demesnes of lesser significance provided such developments would not impinge on the intrinsic quality and character of the demesnes.

It is the Council's policy to preserve the tourist attractions of the county and to co-operate with Bord Failte, M.E.R.T.A., Kildare Failte and other private bodies in the development of tourist facilities. The quality and siting of new buildings, overhead wires, cables, paving, fencing and hedging will be strictly controlled. It is the Council's policy to preserve the regional landscape characteristics and local idiom of building materials and to strictly control outdoor advertising.

The policy on building lines has been developed not only for road traffic reasons, but also to help minimise the visual impact of new development on the landscape. The Council is concerned that the siting of agricultural buildings should comply with the requirements stated above.

2.23 AREAS OF HIGH AMENITY

Kildare County Development Plan 1999

As outlined in Section 1.23, County Kildare contains some areas which because of their out-standing natural beauty and/or unique interest value are classified as areas of high amenity. It is the policy of the Council to protect and conserve these areas and to exclude from them any development which would be prejudicial to their natural beauty. Apart from that general policy objective, which applies to all of the High Amenity Areas, detailed specific policies for each of the areas are listed below.

(a) The Curragh and Environs

Because of its unique importance as an open plain, and its significant archaeological, cultural and historical importance, and given its unique environmental characteristics and geology, it is the Council's policy to restrict development, particularly on the Curragh edge, or where it obtrudes on the skyline as viewed from the Curragh Plains. It is the Council's policy to ensure that fencing, earth works or planting should not conflict with the intrinsic quality of the landscape.

It is the policy of the Council to try, subject to all legal requirements, to confine sheep to the Curragh Plains by the construction of grids on the main approach roads.

It is the policy of the Council to consider the making of a Special Amenity Area Order for the Curragh and Environs. It is also the policy of the Council to co-operate with the Department of Defence, the Office of Public Works, the racehorse industry, the owners of sheep grazing rights and the various interests currently with rights to the Curragh, with a view to its designation as a National Park.

(b) The Valley of the River Liffey

It is the policy of the Council to preserve and enhance the natural amenities of the River Liffey and its environs. It is the policy of the Council to co-operate with the various bodies involved in the development of its recreational uses and also to improve access to, and develop facilities on, the river banks in the interests of recreation and tourism, particularly by maintaining existing and creating further rights of way. It is the Council's policy to exclude from this area any development which would be prejudicial to the natural beauty or amenity of the River Liffey. Apart from the general restriction of development on the banks because of their amenity importance it is particularly important to restrict development in those areas which are subject to natural flooding or potential flooding attendant on the siting of the E.S.B. hydro-electric scheme on the river. It is Council policy to co-operate with appropriate authorities in preparing a water quality management plan which would ensure the monitoring and protection of water quality and the conservation of fish stocks.

It is the policy of the Council to examine and promote the creation of a "Liffey Way" walking route along the course of the River from Poulaphuca to the Dublin border and to co-operate with the relevant Dublin local authorities in extending the route to Dublin City.

The Council considers the Liffey and riverside area at Victoria Bridge to be a local area of high amenity. It is Council policy to secure continued rights of public access and to prepare an Action Plan for the area.

It is the policy of the Council to co-operate with adjoining local authorities and with the State authorities in the development of the Liffey Valley Park between Leixlip and Lucan for amenity and recreational purposes.

It is the policy of the Council to seek an extension of the proposed Special Amenity Area Order for the Liffey Valley from Lucan to Leixlip (which is envisaged by the Dublin local authorities) to other parts of the Valley within County Kildare.

It is noted however that the River Liffey runs through a number of areas which are already effectively urban and therefore the criteria to be used is somewhat different. In such cases the policy of the Council is to investigate the possibility of the transfer of lands to public ownership and for public access to the river for amenity purposes. Any development in such an area must have already been specifically envisaged under the Town Plan/Local Area Plan for the area and such development must respect the special nature of its proposed location.

(c) Valley of the River Barrow

It is the Council's policy to exclude from this area any development which would be pre-judicial to its natural beauty, amenity or recreational capacity. It is Council policy to co-operate with appropriate authorities in preparing a water quality management plan which would ensure the monitoring and protection of water quality and the conservation of fish stocks. The minimum flow of water necessary for the conservation of the river's ecology will be identified by a study, and it will be the Council's policy to maintain that flow.

It is the policy of the Council to pursue the establishment of the Barrow Valley, as outlined as A3 on the map of Areas of High Amenity (Map No. 3) as an S.A.A.O. Area.

(d) Pollardstown Fen

It is the policy of the Council to co-operate with the Office of Public Works in the protection and conservation of the Fen. The Council will promote the amenity, ecological and educational value of the Pollardstown Fen Area while at the same time ensuring the conservation of its fauna and flora. The Council will also ensure the protection of the quantity and quality of the water supply to the Fen from the Curragh aquifer. All applications for development in this area and its wider environs will be considered taking into account the policies stated above. The Pollardstown Fen area is listed elsewhere as a Natural Heritage Area and Special Area of Conservation.

The Council will, in conjunction with the relevant statutory bodies, assist in the preparation and implementation of a management plan for the Fen, which will recognise the amenity, ecological and educational value of the Fen area, while at the same time ensuring the conservation of its flora and fauna.

The Council will encourage the appropriate Department of State to acquire additional lands surrounding the Fen, in view of the pressures of urban expansion from Newbridge in this direction.

(e) Castletown and Donaghcumper Area

It is the policy of the Council to safeguard the amenities of Castletown and Donaghcumper and environs (including St. Wolstan's), as shown on Map No. 1.2, and as outlined in Section 1.23 (e), except in so far as is necessary to achieve roads objective under paragraph 2.14.2, relating to the M4 Interchange. This includes the main avenue and the axial views between Castletown House and Conolly's Folly, and between Castletown House and the Wonderful Barn, Leixlip, the views from the House to the river and across the back parterre and from the main avenue to the river, and also from Donaghcumper and St. Wolstan's along and across the river towards Castletown, and up and down the river to Celbridge and New Bridges respectively.

It is the policy of the Council that the mound between the avenue and the existing housing development on the west side (Castletown Estate) be maintained and suitably planted, and that no structures or unsympathetic uses be allowed in the area between the avenue and mound.

It is the policy of the Council that the views of the River Liffey and the amenities of the lands on each side of the river be preserved, and that the setting of Castletown House, and the demesne lands

complimentary to the vast scale of the house, including all those lands included in the area outlined in black on Map 1.2, be preserved free from residential development.

It is the policy of the Council to preserve all the existing woodlands in this area, including individual trees, groups of trees and avenues. The making of Tree Preservation Orders under the Local Government (Planning & Development) Acts will be considered for those areas of woodland which are not at present under State control.

The preceding paragraphs are not to be construed as preventing the development of lands which are specifically zoned in a Town Development Plan or Local Area Plan provided such development is carried out in accordance with the provisions of the relevant plan and in particular any special provisions relating to that specific zoning.

(f) East Kildare Uplands

It is Council policy to continue to recognise the great amenity value of the East Kildare Uplands, and to ensure the protection of the area through the pursuance of the specific policies as set out in the rural detail plan contained in Section 4.24 of this Development Plan and as indicated on rural detail map No. 1.3

(g) Carton Demesne

It is the policy of the Council to ensure the preservation of Carton House, Demesne and its environs including the lake, woodlands and parklands, and the boundary wall, together with the Rye Water Valley, which is a candidate Special Area of Conservation under the E.U. Habitats Directive.

Because of its international heritage importance as an 18th Century landscape that has remained largely unchanged, it is the policy of the Council to ensure that the landscape within the demesne walls is not altered or modified.

Part of the Demesne is located within County Meath, and it is the policy of the Council to co-operate with that body in the preservation of the landscape, woodlands and walls, gates and other features.

While the Demesne is currently in agricultural use, the Council will continue to monitor the estate to ensure that any agricultural and woodland management and conforms with the basic qualities of the house and its landscape and to make Tree Preservation Orders where considered necessary.

In the event that a leisure development (for which planning permission exists) takes place, the Council will seek to ensure that no development which would detract from the high amenity quality of the demesne will take place. Any modifications to the permitted development will be considered in that light.

Subject to the overall heritage preservation and amenity requirements, the Council may consider any proposed schemes which will include the opening of the Demesne to the public.

It is the Council's policy to preserve the views to and from the house within the demesne walls.

The important buildings and interiors and items of artistic and historic interest which the Council consider should be preserved are listed in Section 3 of this Plan.

It is the policy of the Council to prevent the encroachment of building development from Leixlip and Maynooth up to the boundary roads at the edge of the Demesne.

(h) Robertstown Countryside

he Council to protect the amenities of this area and to encourage the development of n facilities and other amenities in line with the objectives as outlined in Section 1.24 will assist the Robertstown Countryside Committee and other bodies interested in terways, walking routes and other amenities of the area and will strictly control extent of the Robertstown-Countryside Area is shown in Rural Map 1.5.

(1) Donadea Forest

It is the policy of the Council to ensure the preservation of the Forest and Demesne as an entity, including the surrounding walls, towers and other structures and features. (The individual structures which are listed for preservation are included in Section 3.2 of this Plan). To this end, it is the policy of the Council that the Forest shall remain as a recreational resource for public use, and that no part of the Area may be developed for private use. In particular, no housing will be permitted within this Area, and all existing public rights of way will be retained.

It is the policy of the Council to preserve all the existing woodlands in this area, including individual trees, groups of trees and avenues. The making of Tree Preservation Orders under the Local Government (Planning & Development) Acts will be considered for those areas of amenity woodland where the Council consider that this is necessary in the light of circumstances then obtaining.

The Council will encourage the further development of the Forest Park for public recreational and amenity purposes, subject to the policies set out above.

2.24 VIEWS AND PROSPECTS

In general, it is the policy of the Council to preserve, improve and open up places or areas from which views or prospects of high amenity value may be enjoyed by the public. Parking places and viewing places will be constructed and any walls, fences, hedges or other obstructions to these views will be lowered or removed. It is intended to exclude from these areas any development which would be prejudicial to their natural beauty. (See Section 3.4 of this Plan).

The environmental setting and environs of all buildings, features and items listed for preservation are considered to be views which are themselves worthy of preservation. Such views are considered to be of special amenity value and/or special interest.

2.25 BOGLANDS

The Council recognises the vast amenity and productive potential of the bog areas of the county. The Council will consult with Bord na Mona, Teagasc, Irish Peatland Conservation Council, Coillte and other appropriate bodies to ensure that the productive development of the bogland is carried out in such a way as not to prejudice the amenity potential. (Specific anti-amenity activities such as unauthorised dumping will be investigated and eliminated in accordance with extended powers available under the Litter Act 1990).

In the case of cut-away bogland, where the peat resource has been depleted, it will be Council policy to encourage the use of these areas for amenity forestry, using a growth of mixed native deciduous woodlands where possible, in line with the policies for the Robertstown Countryside, and in other areas for forestry and agriculture. In cases in which planning permission is required, it will be the policy of the Council to ensure that the creation of tourist and amenity resources will be facilitated, and that the quality of ground and surface water will not be impaired.

It is the Council's policy to create a Kildare Millennium Forest in this area.

2.26 CANALS

It is the policy of the Council, in association with the Duchas- Waterways, to encourage the protection and development of the amenity and recreational value of canals in the county. The Council will facilitate the development of boat centres and other infrastructural developments, as indicated in the OPW Management Strategy for the Canal system within the county, including the Barrow Navigation.

The Council is convinced of the substantial tourism resource represented by the canal system, particularly as this system runs through many of the more disadvantaged areas of the county, and feels that the development of the system for sustainable tourism is long overdue. The Council will therefore support the objectives of Duchas-Waterways as expressed in the Royal and Grand Canal Corridor studies, and will support the Canal Action Plans which have been prepared by the development agencies for the canal system within the county.

It is Council policy to protect items of architectural or industrial archaeological interest associated with the canals, such as bridges, navigation aids, locks, etc., and to develop the towpath system for walking routes. Any maintenance repairs and/or improvements should be carried out in a sympathetic manner.

It is the policy of the Council to co-operate with the Duchas - Waterways and other relevant statutory bodies in efforts to establish linear Parks along the canal system in the county, except in so far as such policy would interfere with the Council policy on rural housing.

It is the policy of the Council to preserve the quality and quantity of the water in the Milltown Feeder, in co-operation with the Duchas - Waterways and other relevant statutory bodies.

2.27 RACECOURSES

The Curragh, Punchestown and Naas Racecourses are located in the county. It is the Council's policy to protect them from any development which would interfere with their amenity qualities. While Naas Racecourse is located in the area of Naas Urban District Council, it is Council policy to co-operate with Naas U.D.C. in its protection.

2.28 HILL OF ALLEN, CHAIR OF KILDARE AND NEWTOWN HILLS, DUNMURRY HILL, BOSTON HILL

It is the policy of the Council to protect the scientific and amenity value of these hills. The Council will investigate the provision of areas which provide views over the plains.

The Hill of Allen has been subjected to extensive rock quarrying for some time. It is the Council's policy to monitor the development of the area and to investigate how the extraction might be controlled in order to safeguard the prominence of the hill which, in addition to its mythological associations, forms an important feature on the skyline of the plains and boglands. It is also Council policy to protect the Aylmer monument situated on the summit.

2.29 EXTRACTIVE INDUSTRIES

2.29.1 Sand and Gravel and Rock Quarrying

Kildare County Development Plan 1999

It is recognised that the gravel resources are important to the general economy and that the sand and gravel extraction industry is a valuable source of employment in some areas of the county. However, the industry can have seriously detrimental effects on the landscape, on the operation of bloodstock, and on residential amenities. The impact on the county road network has been substantial.

It is the policy of the Council that a survey and examination of both existing pit areas and potential sand and gravel deposits in the county be undertaken and to assess the interactions between the development of these resources and future land uses. To assist in the survey, it is intended that an aerial survey of all sand and gravel workings in the county will be made. This will establish the current extent of existing workings and will pinpoint areas where rehabilitation is needed. The survey results could be used as evidence against any future unauthorised sand and gravel developments. It is intended that this survey would be continually updated.

No sand and gravel extraction will be permitted under Class A soils, in areas of high amenity (as defined in this Plan) and their environs, or where conflict with the bloodstock industry might arise. Apart from these exclusions, sand and gravel extraction will be considered on its merits elsewhere within the county, having regard to the policies of this Plan. Within the East Kildare Uplands Area, sand and gravel extraction will be permitted only in areas zoned for that purpose.

It is the policy of the Council to ensure that all existing workings shall be rehabilitated to suitable land uses and that all future extraction activities will allow for the rehabilitation of pits and proper land use management. The use of landfilling with waste, other than topsoil, subsoil and builder's rubble, is not considered to be an acceptable method of rehabilitation of pits.

It is the policy of the Council to ensure that the full cost of road improvements which are necessitated for this industry, shall be borne by the industry itself.

It is Council policy to ensure that rock quarry workings should not detract from the visual quality of the landscape. It is Council policy that all such workings should be subjected to landscaping requirements, similar to those for sand and gravel workings, and that worked out quarries should be rehabilitated.

Detailed objectives and standards for the development and regulation of sand and gravel extraction are set out in Part 4, Section 4.22.

2.29.2 Minerals

In the event of major mineral finds being made in County Kildare, it is the policy of the Council to encourage their development where compatible with the protection of the landscape, the continued operation of agriculture and the bloodstock industry, and the preservation of amenities generally. In any such cases, it will be necessary to demonstrate that the rehabilitation of these areas to proper land uses can take place. In areas of high amenity, as defined in this Plan, the preservation of the relevant amenity, which constitutes an ecological, landscape or heritage resource, will take precedence over the need to extract the mineral resource.

2.30 HERITAGE ITEMS

It is the policy of the Council to preserve and protect items of artistic, historical, architectural, archaeological and scientific interest in the county. These items are listed in Part 3 of this Plan. The Council will continue to investigate such items.

It is the policy of the Council to make use of its special powers of preservation and conservation as may be necessary to safeguard such items. The Council will not hesitate to invoke its powers if the need for action should arise in particular areas. In order to further awareness of heritage items among the general

public, it is Council policy to publish explanatory booklets and maps on heritage items for circulation to schools in the county, as well as for tourism.

2.30.1. Areas of Scientific Interest

The Council recognises the educational, scientific and recreational value of these areas. It is the policy of the Council to ensure the protection of these areas, and to exclude from them any development which would be inimical to the preservation of their essential characteristics. Applications for developments which would affect these areas will be considered in the light of this policy. These areas are listed in Section 3.3.

2.30.2. Natural Heritage Areas/Areas of Special Conservation

The Council recognises the educational, scientific and recreational value of these areas. It is the policy of the Council to ensure the protection of these areas. Although the designation of these areas by State agencies, in accordance with E.U. Directives, will confer further protection on them, it is the Council's policy, as Planning Authority, to exclude from them any development which would be inimical to the preservation of their essential characteristics. In addition, it is Council policy to preserve and monitor their environs. Applications for developments which would affect these areas will be considered in the light of this policy. These areas are listed in Section 3.3. It is an objective of the Council to preserve the Wildlife Habitat of Kilwoghan Bog, Celbridge and to investigate it's designation as an N.H.A./S.A.C.

2.30.3. Items of Artistic, Historical, Architectural & Archaeological Interest

It is the policy of the Council to preserve these items, to protect them from unsympathetic development and to encourage their use as recreational and tourist resources.

It is the objective of the Council that to preserve sites of archaeological importance, as defined by the Office of Public Works in its Record of Monuments and Places - County Kildare, and its Urban Archaeological Survey. Any developments within these areas will have to be undertaken subject to the supervision of professional archaeologists.

The Council is aware of the importance, from the amenity viewpoint, of traditional buildings including thatched cottages, the number of which is decreasing year by year. It is the policy of the Council to continue to protect surviving examples of vernacular buildings, particularly on tourist routes, and to encourage their restoration and maintenance.

It is the policy of the Council to protect significant streetscapes, including road furniture, pumps and pavings, old wells, old walls, particularly demesne walls. It is also policy to protect traditional shops and pubs, and dwellings, including chimneys, windows etc., and interiors, where historically or visually important.

It is the policy of the Council to advocate the provision of financial incentives by European, national or regional bodies, in order to assist owners of heritage properties and items in their maintenance and conservation.

2.31 WILDLIFE ACT

Kildare County Development Plan 1999

It is the policy of the Council to co-operate with the Office of Public Works and the Wildlife Advisory Council in securing the conservation of wildlife in the county in accordance with the provision of the Wildlife Act 1976.

2.31A HEDGEROWS

The hedgerows of County Kildare are amongst its most important environmental features. Their continued protection is essential to the preservation of the traditional landscape and vital to the conservation of its wildlife.

It is the policy of the Council to protect and preserve existing hedgerows and to encourage the planting of new hedgerows, using traditional native species. The Council will promote the environmentally sensitive management of hedges, and it is the Council's policy to enforce strictly the prohibition of cutting hedgerows during the nesting season.

2.32 QUALITY OF EXISTING BUILT ENVIRONMENTS

The Council will carry out a survey of existing streetscapes in Kildare towns, villages and settlements, and will protect those which have special merit from an architectural and urban design point of view. Some buildings, including many vernacular buildings, while not of such individual character as to warrant listing, merit retention because of their contribution to the streetscape. In the granting of planning permission, the protection of hedgerows will be given high priority.

2.32.1 Infill Development

It is the policy of the Council that all infill structures should harmonise visually with adjoining buildings where appropriate in order to enhance and conserve the overall character of the county.

2.32.2 Shop Fronts

The towns and villages of the county have many shop fronts of traditional character and design. The Council will seek to ensure their retention and where it is proposed to rebuild, it is Council policy to ensure that redevelopment is carried out in a sympathetic manner.

2.32.3 Advertising

It is the policy of the Council that advertisements and advertising structures shall conform strictly with amenity requirements. Detailed standards and guidelines are contained in Section 4 of this Plan.

2.32.4 Overhead Services

Many of the towns and villages of the county are disfigured by overhead service cables, particularly in their centres and historic cores. It is the policy of the Council to seek to have all new services undergrounded, and to progressively eliminate existing overhead services, either as part of a village or town centre streetscape renewal scheme, or individually, as finances permit.

2.33 AMENITY SCHEMES

Kildare County Development Plan 1999

It is the policy of the Council to continue to undertake, and to support communities in undertaking schemes for the improvement of the general amenity of towns and villages. In this regard, it will be a particular policy of the Council to support the "Tidy Towns" competition.

2.34 RIGHTS OF WAY

It is the Council's policy to protect and improve all existing rights of way especially those giving access to items of archaeological and amenity interest. The Council will co-operate with Cospoir and other Bodies in the creation of further rights of way where necessary, especially in the establishment of long distance walking routes. It is the Council's intention to compile and update a register of rights of way in the county which will be made available for public inspection.

2.35 OPEN SPACE MANAGEMENT

The Council is responsible for the maintenance and management of a large number of open spaces, amenity areas and the development of parklands in the county. It is the policy of the Council to continue to undertake these responsibilities as finances permit. It is also the Council's policy to assist and co-operate with residents associations and community groups in the planning, maintenance and development of open spaces.

2.36 THE QUALITY OF NEW DEVELOPMENT

2.36.1 New Development Generally

It is the policy of the Council to ensure that new building development will contribute to the general benefit and amenity of the area.

It is the policy of the Council to ensure that buildings and other structures such as power lines will not be allowed to obtrude on the skyline, particularly on sites visible from the main roads. It is the policy of the Council to have regard for the visual environment of existing development in terms of height, density, scale, materials, colour, texture, landscaping and open space.

2.36.2 New Residential Development

The Council policy with regard to new residential areas in settlements is:-

- (i) that any large new housing areas be developed as residential environmental areas, and Action Area Plans will be prepared as appropriate.
- (ii) that a high standard of design be incorporated in structures and layout, with the design of estate development such as to facilitate pedestrian safety, and restrict vehicular traffic speeds.
- (iii) that there be diversity in the density of development and in the form, size and type of dwelling within residential areas and that density should be appropriate to the location.
- (iv) to carry out its responsibilities under the Housing Acts and to provide Local Authority dwellings, Joint Venture, co-operative housing and private sites as the need arises and as finances permit.

- (v) it is the policy of the Council to implement the Housing Strategy 2001-2005 as contained in Appendix A of this plan.
- (vi) that in accordance with Part V of the Planning and Development Act 2000 and the Council's Housing Strategy 2001-2005, a minimum of 20% of land zoned wholly or partially for residential development must be made available for social and affordable housing.
- (vii) any submission made in compliance with a developer's responsibilities under Part V of the Planning and Development Act 2000 and the Council's Housing Strategy 2001-2005 shall provide for a minimum of 8% social housing and 12% affordable housing, unless otherwise agreed by the Planning Authority due to the exceptional circumstances of any particular case.
- (viii) the Council recognises the necessity for a further 18,563 housing units during the period of the Housing Strategy.
- (ix) it is an objective of the Council to integrate housing provided under Part V of the Planning and Development Act 2000 into private development in a layout that prevents segregation and promotes good design and layout.
- (x) it is the policy of the Council to ensure that sufficient and suitable land is zoned for residential use, or for a mixture of residential and other uses, to meet the requirements of the housing strategy and to ensure that a scarcity of such land does not occur at any time during the period of the development plan.
- (xi) in implementing the Housing Strategy Kildare County Council will (a) seek to ensure that housing is available for persons who have different levels of income, (b) seek to ensure that a mixture of house types and sizes is developed to reasonably match the requirements of the different categories of household and including the special requirements of elderly persons and persons with disabilities, and (c) seek to counteract undue segregation in housing between persons of different social backgrounds.
- (xii) the favoured option for compliance by developers with Part V of the Planning and Development Act 2000 will be for developers to build the required houses and then make them available to the Council in order to:
 - (a) ensure the fullest achievable degree of social integration
 - (b) ensure complete and efficient development of building sites and
 - (c) to facilitate the implementation of policy in regard to social and affordable housing
- (xiii) it is the policy of the Council to require the provision of Childcare Facilities in all new residential developments as appropriate. The indicative standard is one childcare facility, accommodating 20 children, for each 75 dwellings. This standard may be modified in any particular case where there are significant reasons for doing so. Criteria that may be taken into account in such an assessment include the existing geographical distribution of childcare facilities and the emerging demographic profile of the area.
Such facilities should be located and designed so as not to cause nuisance to existing or future residents and shall make adequate provision for safe access and convenient parking for customers and staff and sufficient outdoor play area.

To facilitate orderly development and to expedite the processing of planning applications, the Council will produce a handbook for the guidance of individuals and developers. The handbook will outline the general planning principles contained in this Plan, and will provide details of the Council's basic requirements for applicants. A draft of the handbook will be considered and adopted at a meeting of Kildare County Council prior to its publication.

2.36.3 Commercial Vehicle Parking

The indiscriminate parking of commercial vehicles or machinery in residential areas detracts from the amenities of these areas. The Council, in the protection of these amenities, will co-operate with all other bodies in the exercise of control over this type of parking to eliminate the nuisance created. It is Council policy to investigate and, where feasible, provide commercial vehicle parking areas, suitably sited, landscaped and screened. The Council will encourage the provision of secure commercial vehicle parks within industrial areas in the towns of the county.

2.37 TREES

In general, trees and groups of trees on development sites which form a significant feature of an area shall be preserved and where development is to be permitted, all such trees or groups of trees shall be incorporated into the development and maintained. Where appropriate, Tree Preservation Orders will be made and it is Council policy to prosecute in situations where a Tree Preservation Order is contravened. It is Council policy to survey all trees on zoned land within development boundaries to assist in the development control process

In rural areas, the use of native deciduous trees will be encouraged, especially for the creation of new hedgerows, the planting of screening belts around agricultural buildings and houses, and in the development of amenities.

It is Council policy to encourage the planting of new deciduous woodlands, in order to ensure the restoration and repair of the characteristic Kildare landscape.

2.38 CARAVAN PARKS

2.38.1. Tourist Parks

It is the Council's policy in consultation with M.E.R.T.A. to consider suitable sites for caravanning and camping and to provide them where feasible. Development of sites will be subject to Bord Failte's regulations and regulations laid down by the Council.

2.38.2. Residential Caravan Parks

It is Council policy that sites for new residential caravan parks, where permitted, should comply with proper planning and pollution control requirements.

2.39. TRAVELLERS SETTLEMENTS

The Council will implement measures, as required by law and National policy and in accordance with the Housing Strategy 2001-2005 to provide accommodation for members of the travelling community, whether by way of residential caravan sites/halting sites, or by housing, as may be appropriate. It is considered that all such sites, or housing, should be limited in size or extent.

2.40 OBSOLETE AREAS AND RENEWAL

It is the policy of the Council to continue to survey such areas during the period of the Plan and to use their statutory powers where appropriate. Many obsolete areas within the towns, villages and settlements of the county are also classified as "derelict" within the meaning of the Derelict Sites Act 1990, and in such cases their inclusion in the Derelict Sites Register will be considered and other aspects of that legislation may be used, as appropriate.

It is the policy of the Council to prepare renewal advice briefs and schemes, in respect of obsolete and derelict areas, with a view towards their redevelopment.

2.41 CASUAL TRADING

The Council will carry out its statutory functions under the Casual Trading Act 1995, including the issuing of permits and the designation of Casual Trading areas where the Council considers these to be necessary. It is the Council's policy to prosecute in situations where the Act is being contravened.

It is Council policy that in the designation of areas cognisance will be taken of the proper planning and development of the county, including the preservation and improvement of amenities, the safety and convenience of pedestrians, the traffic likely to be generated by casual trading, the promotion of tourism, and all other matters that the Council considers appropriate.

2.42 GAMING/AMUSEMENT ARCADES

It is Council policy to refuse planning applications for Amusement/Gaming Arcades, as they are considered to be an undesirable use and potentially detrimental to the business and commercial environment of the county. (A similar policy applies in all of the town Development Plans within the County).

2.43 CARNIVALS, CIRCUSES AND FESTIVALS

It is Council policy that the holders of carnivals, circuses, festivals, etc., will be required to give prior notification to the County Council so that permission can be obtained, and appropriate conditions imposed to abate nuisance and annoyance. The Council may also require a sum of money to be lodged which, if necessary, would be used to repair damage caused to open spaces.

2.44 ACCESS FOR THE DISABLED

It is Council policy to provide for suitable access and facilities for persons with physical disabilities. Detailed standards in this regard are set out in the Development Control section of this Plan.

2.45 ARTERIAL DRAINAGE ACT 1945

It is Council policy to take into account the requirements of the O.P.W. with regard to the siting of structures in the vicinity of drainage channels for which they have maintenance responsibility under the Arterial Drainage Act 1945. In relation to County Kildare this relates to the Boyne Catchment Drainage Scheme.

In dealing with applications for development in the vicinity of such drainage channels, it is Council policy to have regard to the requirements of the O.P.W., a strip of approximately 10 metres on either side of the channel free from development to allow for access and maintenance.

2.46 AIRPORT

It is Council policy to investigate the feasibility of locating an airport in the County.

It is also Council policy to encourage the extension and improvement of Weston Aerodrome to include a stopway/clearway (and phased executive passenger/air freight related repository/storage buildings, airport-related offices and ancillary services (but not retail development))

2.47 CONTRIBUTIONS

The Council, bearing in mind the capital expenditure necessary for the provision of services, including open space, which facilitate any proposed development, will require contributions towards the provision of such services as are provided for in the Local Government (Planning & Development) Acts. It is also Council policy that the rate of contribution will be adjusted on an annual basis having regard to the rise in the building cost index or in the consumer price index.

2.48 FINANCIAL LIMITATIONS

The policy, objectives and proposals, as set out in this Development Plan, are subject to the limitations imposed by the availability of resources, including financial resources and including Government Grants and the approval, where required, of appropriate Government Departments.

2.49 RESOURCES AND ORGANISATION

(i) In principle, as and when land comes on the market, consideration shall be given to its purchase in order to facilitate the proper development of the county and its amenities. Subject to the availability of finance, the Council will facilitate the provision of sites for industry, recreation and housing.

(ii) It shall be the policy of the Council, where agreement cannot be reached for the purchase of such lands or buildings as may be required to carry out its statutory powers and functions, that such land and buildings as are necessary will be acquired by Compulsory Purchase.

2.50 BONDING

It is Council policy to ensure that all developments are properly completed in accordance with all of the conditions of planning permissions. To this end, the Council will require all developers of housing estates to produce satisfactory bonds for the completion of estates to the standard required by the Council. In determining the amount of bond, the previous record of a developer in the county will be a factor. Similar bonding will be required in appropriate areas, such as sand and gravel, quarrying operations, and private industrial estates, as the Council considers necessary.

2.51 RENEWABLE ENERGY

The Council strongly supports national and international initiatives for limiting emissions of greenhouse gases and encouraging the development of renewable energy sources. Renewable energy comes from natural, inexhaustible sources such as the sun (solar), wind, falling water (hydro), oceans (wave, tidal

Kildare County Development Plan 1999

and OTEC - ocean thermal energy conversion), plants (biomass and biofuels) and the earth (geothermal and heat pumps). Renewable energy can also be derived from a range of waste products (sewage, municipal and agricultural waste).

The Council is supportive of the State renewable energy strategy of April 1996, and of the targets set within this strategy of providing 100 MW electricity generating capacity from renewable sources by the end of 1999, with further annual targets for installed capacity until 2010. The Council will co-operate with the Irish Energy centre in providing advice and information on all aspects of renewable energy development.

The Council will seek to provide positively for the development of appropriate renewable energy sources, which makes use of the natural resources of the county in an environmentally acceptable manner. The Council will respond to planning applications for renewable energy developments on a case by case basis, in the context of the government strategy, and taking into account other policies set out in this Plan relating to land usage, agriculture, tourism, the protection of the bloodstock industry, and the preservation of heritage items, the landscape resource of the county, and the preservation of Areas of High Amenity.

2.51.1 Wind Energy

The Council will encourage the development of wind energy, in accordance with government policy, and in particular will encourage its development in bogland areas and areas of cut-away bog, especially where there are already existing electricity power lines which can be utilised. Such developments will not generally be permitted in Areas of High Amenity, as set out in this Development Plan. Except in such Areas, the assessment of wind energy proposals will have regard to the "Guidelines for Planning Authorities on Wind Farm Development", published by the Department of the Environment, and "Planning Guidelines for Wind Energy", published by the Irish Planning Institute.

Where developers wish to install wind measurement masts and carry out wind resource analyses, the Council will seek to facilitate this through the granting of temporary planning permissions for this purpose.

2.51.2 Hydro Energy

The Council will respond to applications for hydro energy in the context of the government targets for this area to 2010, and will also seek to respond positively to applications which have been awarded E.U. support through the Thermie Programme.

In responding to applications, the Council will seek to ensure that the free passage of fish is provided for by incorporating fish passes and other features.

The Council will not permit the use of the canal system, which is designated for tourist and amenity use, for hydro energy, but will encourage the use of the rivers within the county for this purpose.

2.51.3 Energy from Waste

The Council will incorporate energy from waste into the overall Council waste management strategy in the context of government targets for the provision of electricity generating capacity from biomass/waste. The location of any such facility will have regard to the location of urban and built-up areas, and the necessity of preserving the amenity and tourism resource of the county. Accordingly, such facilities will generally only be permitted with, or adjacent to, landfill facilities, or in industrially-zoned areas.

2.51.4 Solar Energy

The Council will encourage the provision of solar energy, and in particular will encourage the development of passive solar heating in domestic and industrial buildings.

3.1 INTRODUCTION

This Part of the Plan sets out specific objectives which it is the policy of the Council to implement. Specific objectives in relation to the Council's own operations are set out in Part 2 of this plan. The objectives set out in this part of the Plan relate to the preservation or protection of specific items, structures, areas, sites or views.

3.2 PRESERVATION AND RESTORATION OF HERITAGE ITEMS

3.2.1 CAVES, SITES, FEATURES OR OTHER OBJECTS

It is an objective of the Council to preserve caves, sites, features and other objects of archaeological, geological or historical interest as set out in List A below.

Note: * indicates that an item is divided between two or more Ordnance Survey Six Inch Sheets.

3.5 ZONING OBJECTIVES

3.5.1 NAAS ENVIRONS

The Council has zoned lands in the environs of Naas, as indicated on Map No. 9, for a variety of uses, as follows:-

1. Industrial/Warehousing. The zoning objective in this case is "to provide for industrial and warehousing uses". The purpose of this zone is to provide sites for industrial, and especially warehousing uses, at locations which are outside the built-up area of Naas, and which are, or could be made with appropriate roads improvements, readily accessible to the national road network.

Lands zoned for this purpose are located at the following areas:-

- (a) adjoining the M7 junction to the west of Naas at Newhall.
- (b) at Osberstown, adjoining the M7 and the Council's Sewerage Treatment Plant
- (c) at Ladytown/Red House, adjoining the former N7 between Naas and Newbridge.

In the case of (b), the development of the lands will be contingent on substantial prior roads improvements to the Caragh Road into Naas, and the connection of this road to the Newbridge road, including a new bridge over the Corbally Branch of the Grand Canal, at sufficient clearance to permit future use of this waterway for barges and other tourist craft.

In the case of (c), no vehicular access will be permitted onto the adjoining county road to the west, but only from the Regional road (former N7). In addition, this zoning is contingent on the provision of a green belt of a minimum of 30 metres width along the south-western and south-eastern boundaries of the lands, within which no development of any kind whatsoever will be permitted other than the planting of native deciduous trees, and the provision of a perimeter fence (on the inner - industrial - side of the green belt).

In the case of all of these zonings, the development of the lands in question will be contingent on the prior provision of piped water, sewerage and surface water services, and on adequate treatment capacity in the case of sewerage services at Osberstown Treatment Plant

2. Industrial/Information Technology Business Park. The zoning objective in this case is "to provide for industrial and information technology-related industrial and office development, and ancillary services". The purpose of this zone is to encourage mainly services-type employment, on a campus-type environment.

This zoning is located at Killashee, to the south of Naas. The development of these lands will be contingent on the prior provision of roads improvements to the Kilcullen Road, and of the direct connection of this road with the Newbridge Road, and improvements from that connection point onto the Newbridge Road to the M7 junction. In addition, the development of the lands in question will be contingent on the prior provision of piped water, sewerage and surface water services, and on adequate treatment capacity in the case of sewerage services at Osberstown Treatment Plant.

3. Low Density Housing The zoning objective in this case is to provide for residential housing at a low density. The purpose of the zoning is to facilitate the erection of a small number of dwelling units on large sites. The maximum density of the lands in question are set out on Map No. 9, and it is the policy of the Council that housing development in excess of these density maxima will not be permitted. This zoning applies to three plots of land, all to the north east of the town of Naas, and all taking access to Fishery Lane.

3.5.2 KILCOCK ENVIRONS

Kildare County Development Plan 1999

The Council has zoned lands in the environs of Kilcock, as indicated on Map No.10, as follows:-

Integrated Leisure Development. This zoning objective is to facilitate the provision of an integrated leisure development, including golf course, hotel and tourist accommodation, conference and leisure facilities, and equestrian centre, together with limited housing not exceeding fifty dwelling units. Any additional housing units shall be for tourist accommodation only and not for sale.

3.5.3 APPLICATION OF ZONING OBJECTIVES

It is an objective of the Council to carry out its development control function, in relation to the zonings set out in sections 3.5.1 and 3.5.2, in accordance with the Matrix Table for each zone, as set out below. However, it should not be assumed that if a proposed development complies with the Matrix Table, it will necessarily be accepted. Factors such as density, height, traffic generation, design criteria and physical environmental factors are also of importance in establishing whether or not a development proposal conforms to the proper planning and development of these areas. (Guide-lines and Standards on these matters are set out in the Development Control Section of this Plan).
