Section 1 Introduction

1.1 Background

Kildare County Council has prepared Proposed Variation No. 1 to the Athy Town Development Plan 2012-2018 under Section 13 of the Planning and Development Act 2000 (as amended).

This is the Appropriate Assessment (AA) Screening Report for the Proposed Variation in accordance with the requirements of Article 6(3) of the EU Habitats Directive¹. This report is divided into the following three sections:

Section 1 - Introduction Section 2 - Stage 1 Screening Section 3 - Conclusions

1.2 Legislative Context

The Council Directive 92/43/EEC on the Conservation of Natural Habitats and of Wild Fauna and Flora, better known as "The Habitats Directive", provides legal protection for habitats and species of European importance. Articles 3 to 9 provide the legislative means to protect habitats and species of Community interest through the establishment and conservation of an EU-wide network of sites known as Natura 2000. These are candidate Special Areas of Conservation (cSACs) designated under the Habitats Directive and Special Protection Areas (SPAs) designated under the Conservation of Wild Birds Directive (Directive 2009/147/EC - codified version of Directive 79/409/EEC as amended), hereafter referred to as European sites.

Articles 6(3) and 6(4) of the Habitats Directive set out the decision-making tests for plans and projects likely to affect Natura 2000 sites. Article 6(3) establishes the requirement for AA:

"Any plan or project not directly connected with or necessary to the management of the [Natura 2000] site but likely to have a significant effect thereon, either individually or in combination with other plans or projects, shall be subjected to appropriate assessment of its implications for the site in view of the site's conservation objectives. In light of the conclusions of the assessment of the implications for the site and subject to the provisions of paragraph 4, the competent national authorities shall agree to the plan or project only after having ascertained that it will not adversely affect the integrity of the site concerned and, if appropriate, after having obtained the opinion of the general public.

If, in spite of a negative assessment of the implications for the [Natura 2000] site and in the absence of alternative solutions, a plan or project must nevertheless be carried out for imperative reasons of overriding public interest, including those of a social or economic nature, Member States shall take all compensatory measures necessary to ensure that the overall coherence of Natura 2000 is protected. It shall inform the Commission of the compensatory measures adopted.

Where the site concerned hosts a priority natural habitat type and/or a priority species the only considerations which may be raised are those relating to human health or public safety, to beneficial consequences of primary importance for the environment or, further to an opinion from the Commission, to other imperative reasons of overriding public interest."

These requirements are implemented in the Republic of Ireland by the European Communities (Birds and Natural Habitats) Regulations 2011 (as amended) and the Planning and Development Act 2000 (as amended) and the Planning and Development Acts 2000-2015. The European Communities (Birds and

Natural Habitats) Regulations consolidate the European Communities (Natural Habitats) Regulations 1997 to 2005 and the European Communities (Birds and Natural Habitats) (Control of Recreational Activities) Regulations 2010, as well as addressing transposition failures identified in judgments of the Court of Justice of the European Union (CJEU)².

1.3 Stages of Appropriate Assessment

This AA Screening Report has been prepared in accordance with the following guidance:

- *Appropriate Assessment of Plans and Projects in Ireland. Guidance for Planning Authorities.* Department of the Environment, Heritage and Local Government, 2010.
- Assessment of plans and projects significantly affecting Natura 2000 sites: Methodological guidance on the provisions of Article 6(3) and (4) of the Habitats Directive 92/43/EEC, European Commission Environment DG, 2002.
- Managing Natura 2000 sites: The Provisions of Article 6 of the Habitats Directive 92/43/EEC: European Commission, 2000

Appropriate Assessment comprises up to four stages:

Stage One: Screening

The process which identifies the likely impacts upon a European site of a project or plan, either alone or in combination with other projects or plans, and considers whether these impacts are likely to be significant.

Stage Two: Appropriate Assessment

The consideration of the impact on the integrity of the European site of the project or plan, either alone or in combination with other projects or plans, with respect to the site's structure and function and its conservation objectives. Additionally, where there are adverse impacts, an assessment of the potential mitigation of those impacts.

Stage Three: Assessment of Alternative Solutions

The process which examines alternative ways of achieving the objectives of the project or plan that avoid adverse impacts on the integrity of the European site.

Stage Four: Assessment where no alternative solutions exist and where adverse impacts remain

An assessment of compensatory measures where, in the light of an assessment of imperative reasons of overriding public interest (IROPI), it is deemed that the project or plan should proceed.

The Habitats Directive promotes a hierarchy of avoidance, mitigation and compensatory measures. First, the plan should aim to avoid any impacts on European sites by identifying possible impacts early in the plan-making process and writing the plan in order to avoid such impacts. Second, mitigation measures should be applied, if necessary, during the AA process to the point where no adverse impacts on the site(s) remain. If the plan is still likely to result in impacts on European sites, and no further practicable mitigation is possible, then it must be rejected. If no alternative solutions are identified and the plan is required for imperative reasons of overriding public interest (IROPI test) under Article 6(4) of the Habitats Directive, then compensation measures are required for any remaining adverse effect.

In the case of this AA screening exercise, it is found that the Proposed Variation only requires Stage 1 AA Screening.

Section 2 Stage 1 Screening

2.1 Description of the Town Development Plan and associated Proposed Variation No. 1

The Athy Town Development Plan 2012-2018 sets out an overall strategy for the proper planning and sustainable development of the town over the period 2012-2018. It is prepared with reference to the Kildare County Development Plan 2011-2017 which sets out strategies, policies and objectives for the development of County Kildare.

The following vision statement is included within the Plan: "To plan for and facilitate appropriate levels of sustainable development in Athy, addressing its weaknesses and building on its strengths based on high quality employment, residential and recreational areas with a balanced range of facilities to meet the needs of those living, working or visiting the town, thereby improving the quality of life for all."

The Proposed Variation:

- 1. Provides clarity in relation to the specific intentions of Kildare County Council in relation to a Distributor Road for Athy.
- 2. Ensures consistency with the Kildare County Development Plan 2011-2017 which the Council is also planning to vary³.

2.2 European Sites

This section of the screening process describes the European sites within a potential zone of impact of the Plan area to which the Proposed Variation relates. A distance of 15 km is currently recommended in the DoE document *Appropriate Assessment of Plans and Projects - Guidance for Planning Authorities*, however, sites beyond this distance can also be considered as a result of, for example, hydrological linkages with the County.




Figure 1 European sites within the Plan area and within 15 km of the Plan area

Based on the above approach, an initial total of two European sites (two SACs) require consideration in the AA process. A map indicating the locations of the sites is presented as Figure 1.

Table 2.1 below lists the European sites that are within the Plan area.

Table 2.2 below lists the European sites that are within 15km of the Plan area (no additional sites are necessary to include beyond this 15km distance, given, for example, hydrological linkages).

Table 2.1 and Table 2.2 also present the qualifying features of each site. cSAC sites are selected for a range of different habitats and species listed on Annex I and Annex II of the Habitats Directive, known as Qualifying Interests (QIs).

In order to determine the potential for impacts from the Proposed Variation, information on the qualifying features, known vulnerabilities and threats to site integrity pertaining to European sites was also was reviewed and is presented in Appendix I⁴. The assessment considers the potential implications of the implementing the Proposed Variation against the qualifying features of each site.

2.3 Assessment Criteria

2.3.1 Is the Plan Necessary to the Management of European Sites?

Under the Habitats Directive, plans that are directly connected with or necessary to the management of a European site do not require AA. For this exception to apply, management is required to be interpreted narrowly as nature conservation management in the sense of Article 6(1) of the Habitats Directive. This refers to specific measures to address the ecological requirements of annexed habitats and species (and their habitats) present on a site(s). The relationship should be shown to be direct and not a by-product of the plan, even if this might result in positive or beneficial effects for a site(s).

The primary purpose Proposed Variation is not the nature conservation management of European sites. Therefore, the Proposed Variation is not considered by the Habitats Directive to be directly connected with or necessary to the management of European designated sites.

2.3.2 Elements of the Proposed Variation with Potential to Give Rise to Effects

The Proposed Variation has been assessed in relation to its potential to result in effects on European Sites within and beyond the Plan area taking into account the baseline, the content of the Proposed Variation and other plans and programmes.

As outlined in the European Commission Environment DG document "Assessment of plans and projects significantly affecting Natura 2000 sites: Methodological guidance on the provisions of Article 6(3) and (4) of the Habitats Directive 92/43/EEC", impacts that require consideration can be categorised under a number of headings:

- Loss / reduction of habitat area (e.g. due to the development of new projects);
- Disturbance to Key Species (e.g. increased public access to protected sites, or during the construction phase of infrastructure projects);
- Habitat or species fragmentation;
- Reduction in species density; and
- Changes in key indicators of conservation value such as decrease in water quality / quantity (e.g. through inadequate wastewater treatment, run-off of pollutants during construction and operation of developments, agricultural runoff).

In summary, it is determined that the Proposed Variation will not result in any effects on European Sites.

2.4 Other Plans and Programmes

Article 6(3) of the Habitats Directive requires an assessment of a plan or project to consider other plans or programmes that might, in combinations with the plan or project, have the potential to adversely impact upon European sites.

The existing Town Development Plan 2012-2018 to which the Proposed Variation relates was subject to its own Appropriate Assessment process that determined that, having incorporated mitigation measures, it is considered that the Plan shall not give rise to significant effects on the integrity of any European Site⁷.

It has been determined that the individual parts of the Proposed Variation will not result in any effects on European Sites.

Taking into account all of the above it is determined that there are no 'in-combination' effects arising from the Proposed Variation.

Table 2.4 lists the plans or programmes that relate to the Town Development Plan to which Proposed Variation No. 1 relates.

Section 3 Conclusion

The requirement for a Stage 2 AA would arise if Proposed Variation No. 1 to the Athy Town Development Plan 2012-2018 were likely to have effects on the integrity of the network of designated ecological sites known as Natura 2000. This screening report evaluates the Proposed Variation in order to determine if it needs to be the subject of a Stage 2 AA.

The AA Screening finds that the Proposed Variation shall not give rise to any effect on the integrity of any Natura 2000 sites. Therefore, in accordance with the methodological guidance on the provision of Article 6(3) and (4) of the Habitats Directive 92/3/EEC, it is concluded that the Proposed Variation does not require any further assessment to demonstrate compliance with the Directive.
