PROPOSED LOCAL AREA PLAN FOR NAAS 2019 - 2023

Pursuant to Section 20 of the Planning and Development Act 2000 (as amended) notice is hereby given that Kildare County Council, being the Planning Authority for the area, has prepared a Draft Local Area Plan (LAP) for Naas.

The Draft Naas Local Area Plan 2019-2023 comprises a written statement and maps and is accompanied by:

- An Environmental Report on the likely significant effects on the environment on implementing the LAP - pursuant to the Planning and Development (Strategic Environmental Assessment) Regulations 2004-2011;
- An Appropriate Assessment Screening Report - pursuant to the EU Habitats Directive (92/43/EEC);
- A Strategic Flood Risk Assessment Report - pursuant to Section 28 of the Planning and Development Act 2000 (as amended);
- A Strategic Planning and Infrastructure Assessment.

TEMPORARY CLOSING OF ROADS NOTICE OF DECISION ROADS ACT, 1993

ROADS REGULATIONS 1994

Kildare County Council gives notice on behalf of Gas Networks Ireland in accordance with Section 75 of the Roads Act, 1993 and the Roads Regulations, 1994 that it will close the following road:

The L50422 Robert St. in Newbridge will be closed from its junction with the R445 Main St. and its junction with the L70418 Eyre St.

From Tuesday, 30 April 2019 to Wednesday, 1 May 2019 inclusive.

The closure is required to facilitate gas connection works at this location.

Alternative Routes:

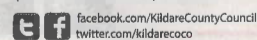
Traffic travelling north on the R445 Main St. will be diverted via the L-50425 John St.

Traffic travelling south on the R445 Main St. will be diverted via the R416 Charlotte St.

Diversions routes will be clearly signposted, as agreed with the council and An Garda Síochána. Emergency access and restricted local access will be maintained.

TEMPORARY CLOSING OF ROADS NOTICE OF INTENTION ROADS ACT, 1993

ROADS REGULATIONS 1994

Kildare County Council gives notice in accordance with Section 75 of the Roads Act, 1993 and the Roads Regulations, 1994 that it intends to close the following road:

The L-8007 (Approx. 3.7km section) from its junction with the R418 (Fontstown – Kilcullen Road) to its junction with the L-4002 (Maddenstown – Craddockstown Road).

from Monday, 13 May 2019 to Friday, 17 May 2019 inclusive.

This closure is required to facilitate the construction of a cattle underpass on the L-8007 (Ballyshannon Road).

Alternative Routes:

Eastbound traffic using the L-8007 will be diverted southwards on the L-4002 to junction of the R418, turn left and travel north eastwards on the R418 to junction of the R418 and the L8007.

Westbound traffic using the L-8007 will be diverted southwest on the R418 to its junction with the L-4002, turn right and travel northwards on the L-4002 to its junction with the L-8007.

Diversions routes will be clearly signposted as agreed with the council and An Garda Síochána. Emergency access and restricted local access will be maintained. Any objections/observations should be lodged in writing to the **Senior Executive Officer, Roads Transportation and Public Safety** at the address below or by e-mail to roadsubmissions@kildarecoco.ie on or before **5.00 p.m. on Tuesday, 23 April, 2019.**

NOTICE OF ELECTION

An election of members for each of the local electoral areas of the above-mentioned local authority is about to be held. The local electoral areas are **Athy, Celbridge, Clane, Kildare, Leixlip, Maynooth, Naas and Newbridge.**

Nomination papers may be obtained from the address below during the usual office hours.

A person may nominate himself/herself as a candidate or may, with his/her consent, be nominated by a proposer who is registered as a local government elector in the local electoral area of the local authority for which he/she proposes to nominate the candidate.

A nomination paper from a candidate of a registered political party must have a certificate of political affiliation attached which must be produced to me with his/her completed nomination paper.

If no certificate is attached, the candidate must, before the latest time for receiving nominations, either:

- secure 15 assents to the nomination by way of statutory declarations by local government electors registered in the relevant local electoral area (forms available from me or the registration authority), or
- make a deposit of €100 (deposit may also be made on the candidate's behalf).

The latest time for receiving nominations is **12.00 p.m. on the 4th day of May, 2019.**

Completed nomination papers may be delivered to me in person by the candidate or his/her proposer at any time when I am at my office, from **10.00 a.m. on the 27th day of April, 2019, until 12.00 p.m. on the last day for receiving nominations.**

I am required by law to attend to receive nominations between **10.00 a.m. and 12.00 p.m. and between 2.00 p.m. and 5.00 p.m. on the 3rd day of May, 2019 and between 10.00 a.m. and 12.00 p.m. on the 4th day of May, 2019.**

If the election is contested, a poll will be taken on the **24th day of May, 2019** between the hours of **7.00 a.m. and 10.00 p.m.**
