Council issues letter

Carbury quarry gets warning

Kildare County Council has issued a Carbury quarry with a warning letter to stop importing writes materials, Niamh O'Donoghue.

In response to a query from the Leinster Leader, the council said a S.55 notice under the Waste Management Act 1996 was issued to GCHL Ltd in relation to lands at Ballinderry, Carbury last week.

The notice requires the owner to cease accepting waste material at Ballinderry Quarry by 22 March 2017 and to remove all waste material by 16 April 2017," said the council. The local authority said it will continue to monitor the site.

On Monday, March 6 the High Court made an order preventing protesters from obstructing access to and from the site of the former quarry. The case was due back before the courts last Friday.

Mr Justice Paul Gilligan granted GCHL Ltd a temporary injunction preventing protesters from blocking, obstructing or impeding the Ballinderry site. The company claimed the protests resulted in the site having to be shut down. The site contains a quarry pit, which is undergoing remediation. However, the court heard local landowners believe the works are damaging the lands and affecting local groundwater, and had blockaded the site.

Speaking on March 6, Matthew Jolley Bl for the company said its activities are lawful, and the protesters are acting unlawfully. He said infill is being brought in to restore the site with the consent and permission of both Kildare Co Council and the Environmental Protection Agency. The court was told, on foot of a court order obtained by the Council last year, the company had been taking steps since December to restore the site. Legal counsel said testing has shown that fears about the land being damaged are unfounded.



96-bed nursing home

James Fagan wants to build a 96-bed nursing home, including a service wing, staff facilities, laundry facilities, kitchen/dining room, chapel, library, offices and day rooms, as well as an enclosed service yard and a new entrance, on the Kildare/Rathangan road at Rathangan Demesne.

The plans also include car parking facilities for staff and visitors, dementia friendly gardens, and a service road accessing lands to rear of site.
