

## **PART 8 DEVELOPMENT PLANNING AND DEVELOPMENT ACT 2000** (AS AMENDED) - PART XI PLANNING AND DEVELOPMENT REGULATIONS 2001 (AS AMENDED) - PART 8

Site Location: Coill Dubh/Blackwood, Co. Kildare

Proposed Development: Pursuant to the requirements of the above, notice is hereby given by Kildare County Council of a proposed social housing development at Coill Dubly Blackwood, Co. Kildare.

The proposed development comprises the construction of 10 no. houses consisting of:

- 3no. three bedroom units,
- 3no. two bedroom units,
- 4no. one bedroom units,
- 10no. garden storage sheds,
- Vehicular and pedestrian entrance with footpath to the front of the site,
- 6. Boundary and road improvement works including:
- a. Removal of part of the boundary hedge at the junction to the L1019.
- b. Cutting of hedges.
- c. Pruning existing trees.
- d. Culvert the existing land drain to the front of the site.
- e. Proposed new site boundary treatment consisting of masonry walls and railings,
- f. Undergrounding of existing services.
- 7. Pedestrian link through the site and an entrance to the adjoining soccer field,
- 8. Associated site works.


#### **DREHID COMMUNITY GRANT SCHEME INFORMATION MEETING**

# TEMPORARY CLOSING OF ROADS NOTICE OF INTENTION ROADS ACT, 1993

The R414 at Clonagh and Lullymore between its junction with the L-7004 (Cappanargid) and its junction with the R403 (Shee Bridge)

#### **Alternative Routes**

Southbound traffic using the R414 will be diverted via the R415 at Allenwood to Kilmeague, the L3002 at Allen Cross and the R415 at Boherkill to Rathangan.

You must be an Irish citizen, ordinarily resident in the constituency and 18 years or over on polling day to vote in the presidential election. (If you recently sent in a RFA form for inclusion on the Supplement Register, your details will not appear online as the Supplement is additional to the Live Register which was published in February. It is only the Live Register which is visible online.)
