'Carer's love for her son shines through'

MAYNOOTH woman Donna Moran has this week been announced as the 2022 Netwatch Kildare Family Carer of the Year.

Donna cares for her son Evan who is aged 15. He was diagnosed with Duchenne muscular dystrophy in 2011 and is a wheelchair user.

Very involved in Evan's care, Donna is always advocating for what is best for him and other children and parents in similar situations. Her love for her son shines through whenever she talks about him.

She says that she takes take every day as it comes, deals with a difficult situation with dignity and strength and

tries to have fun along the way too. Evan is an avid gamer, loves movies and Lego, and both he and his mum adore Evan's nine-year-old assistance dog Glen provided by the charity Dogs for the Disabled. Sarah Houlihan, Family Carers Ireland' Community

Support Manager for Kildare & Wicklow, said that family carers must be recognised for what the do.

"Caring for a loved one at home can be rewarding but it can also be challenging, particularly in the absence of vital supports and services including respite," said Ms Houlihan.

'This can take a toll on a person's physical, mental, financial and social wellbeing.

"Often, a person can find themselves taking on the role

of a family carer with little or no warning. "These are mums, dads, sons, daughters, siblings, relatives, friends and colleagues who sometimes don't even see themselves as family carers.

"They are doing extraordinary work that is too often unseen and undervalued."

Recognition

This is the value of the Netwatch Family Carer-of-the-Year Awards which are now in their 15th year.

"These awards are an important event in our calendar every year as we seek to provide some small recognition to all of those who care at home for loved ones with additional needs and to ensure their stories are heard, said Ms Houlihan, who lives in Clane.

"As a charity, we want family carers to know that they are not alone and that we are here to help them no matter where they find themselves on their caring journey.

"As a society, we must ensure that family carers are not only recognised for their immense contribution, but truly supported to care safely at home.

The proposed development comprises the construction of 65 no. dwellings consisting of:

- 26 houses, 28 apartments and 11 duplex apartment units.
 - 1 no. one-bedroom single storey house.
 - 7 no. two-bedroom two storey houses.
 - 16 no. three-bedroom two storey houses.
 - 1 no. four-bedroom single storey house.

The proposal has also undergone Appropriate Assessment Screening under the Habitats Directive (92/43/EEC), the Planning and Development Act 2000, as amended, and the European Communities (Bird and Natural Habitats) Regulations 2011 - 2015. Kildare County Council has determined that an Appropriate Assessment is not required. The proposed development will not have a significant effect on a European Site.

In addition, the proposal has also undergone screening for Environmental Impact Assessment under the EIA Directive 2011/92/EU as amended by Directive 2014/52/EU, (and the relevant provisions of the Planning and Development Act 2000, as amended, and the Planning and Development Regulations 2001, as amended) and Kildare County Council has determined that there is no real likelihood of significant effects on the environment arising from the proposed development and that an Environmental Impact Assessment is not required.

In accordance with Article 120 of the planning and development Regulations 2001 (as amended), any person may, at any time before the expiration of 4 weeks beginning on the date of this notice, apply to An Bord Pleanála for a screening determination as to whether the proposed development would be likely to have significant effects on the environment.
