## Planning and Development Act 2000 (as amended) – Part XAB Planning and Development Regulations 2001 (as amended) – Part 8

Proposed development at 1 Maddenstown Terrace, Maddenstown North, Curragh, Co. Kildare. R56 T183.

#### Appropriate Assessment (AA) Screening Determination

Pursuant to the requirements of the above, Kildare County Council is proposing the construction of an extension to an existing dwelling and associated works.

The proposed development comprises:

- Demolition of unauthorized 2 storey rear extension.
- Construction of a new single storey rear extension and Internal alterations, retro-fit fabric upgrades to the existing dwelling.
- Boundary walls including new 2.1m high rear garden walls, new masonry bin store to the front garden.
- Associated site development works.

A detailed description of the proposed development has been provided with drawings provided with the Part 8 application. Having regard to Article 6(3) of the Habitats Directive and Part XAB of the Planning and Development Act 2000 (as amended), the guidance contained in the document entitled "Appropriate Assessment of Plans and Projects in Ireland Guidance for Planning Authorities" (published by the Department of Environment, Heritage and Local Government in 2009) and following an examination of the information provided in the Appropriate Assessment Screening Report, Kildare County Council, as the Competent Authority, determines that the proposed development at 1 Maddenstown Terrace, Maddenstown North, Curragh, Co. Kildare, individually or in combination with other plans and projects, does not have the potential to give rise to likely significant effects on European sites, their conservation objectives or integrity, and therefore does not require an Appropriate Assessment.

#### Key points in the determination –

- The proposed development site is not located within or adjacent to any Natura 2000 sites, so there is no risk of habitat loss, fragmentation or any other direct impacts.
- Pollardstown Fen SAC (000396) is approximately 4.2km northeast of the site and the River Barrow and River Nore SAC (002162) is approximately 6.8km southwest of the site
- No potential pathways were identified to Natura 2000 sites.
- There are no surface water, groundwater or other pathways linking the Site to any European sites, so there is no risk of indirect effects.
- There are no SPAs in the vicinity of the site.

It is therefore highly improbable that a project of this nature and scale will have any measurable impact on the qualifying interests of Natura 2000 sites.

Therefore a Stage 2: Appropriate Assessment will not be required to inform the project appraisal either alone or in combination with other plans or projects, with respect to any Natura 2000 sites and their Conservation Objectives.
