SUBMITTED: File herein together with report dated 10/4/2017 from Clodagh Lyons, Senior Executive Engineer, and endorsed by John Coppinger, Senior Engineer and Ms. Evelyn Wright, Acting Director of Services recommending the preparation of a Compulsory Purchase Order pursuant to the powers under Section 10 of the Local Government (No. 2) Act, 1960 as substituted by Section 86 of the Housing Act, 1966 as amended by section 6 and the Second Schedule of the Roads Act, 1993, and Section 76 of the Housing Act 1966 and the Third Schedule thereto, and the Planning Development Acts, 2000 to 2016 and under Section 213 of the Planning and Development Acts, 2000 to 2016 in order to acquire lands for the construction of the Athy Distributor Road and the provision of infrastructure facilitating public transport. An Environmental Impact Statement and Natura Impact Statement have been prepared for the Athy Distributor Road and will be submitted to An Pleanála for approval.

ORDER: I hereby order the following that the Compulsory Purchase Order for the acquisition of lands for the Athy Distributor Road and the provision of infrastructure facilitating public transport be prepared pursuant to the powers under Section 10 of the Local Government (No. 2) Act, 1960 as substituted by Section 86 of the Housing Act, 1966 as amended by section 6 and the Second Schedule of the Roads Act, 1993, and Section 76 of the Housing Act 1966 and the Third Schedule thereto, and the Planning Development Acts, 2000 to 2016 and under Section 213 of the Planning and Development

(b) To make the Compulsory Purchase Order pursuant to Section 10 of the Local Government (No. 2) Act, 1960 as substituted by Section 86 of the Housing Act, 1966 as amended by section 6 and the Second Schedule of the Roads Act, 1993, and Section 76 of the Housing Act 1966 and the Third Schedule thereto, and the Planning Development Acts, 2000 to 2016 and under Section 213 of the Planning and Development Acts, 2000 to 2016 and to submit same to An Bord Pleanála for confirmation.

(c) That all statutory advertisements and notices be published and served on all appropriate landowners and bodies in relation to the CPO, EIS and NIS as appropriate.

(d) To submit all required documentation to An Bord Pleanála as appropriate.
