Site Location & Context

The subject site located c.500m to the west of the village of Ballymore Eustace and c.845m to the northwest of Ballymore Eustace Bridge. The subject site straddles both sides of the River Liffey, which flows east to west at this location. The subject site has a stated area of 0.75ha.




Fig 1: Site Location Map (taken from GIS)

The subject site is located within the Liffey Valley Meander Belt a pNHA.

An Appropriate Assessment (AA) Screening Report has been prepared for this application by Altemar Marine & Environmental Consultancy and concludes that "the proposed works are not likely to have a significant impact on any features of interest or conservation objectives of Natura 2000 sites within 15km of the proposed works or Natura 2000 sites with a hydrological link to the proposed works". The nearest Natura 2000 site is the Pollaphuca SPA which is located approximately 3.1 km to the west of the application site.

Description of the proposed development

The proposed development is describes as follows:

- 1. The permanent realignament of approximately 160m of the River Liffey to follow the former alignment of the river approximately 150 years ago. A temporary diversion channel will be constructed as part of the works.
- 2. The slope stabilisation works will include: clearance of the remaining vegetation at the slope failure location, reprofile the slope to a stable gradient along the north bank of the River Liffey, establish scour protection at the toe of the slope, backfill of the temporary channel and reinstate lands.
- 3. The reconstruction of the local road (L6047) over a distance of 300m.
- 4. Maintain a road width of 5m, introduce a 2m grass verge, construct 100m of wall with 50m of safety barrier on the approach to and departure from the wall.

- MT 7 Focus on improvements to the national, regional and local network that provide additional capacity in order to reduce congestion and provide for current and future demand.
- MT 11 Focus on improvements to the local road and street network that better utilise existing road space and encourage a transition toward more sustainable modes of transport, while ensuring sufficient road capacity exists for trips which will continue to be taken by private vehicle.
- RS 1 Ensure ongoing competitiveness and the efficient movement of people and goods in the county through the improvement and expansion of the road and street network within the county to support economic development and provide access to existing communities, new communities, employment areas and development.
- RS 2 Improve safety on the road and street network and manage congestion.
- LR 1 Ensure that the safety and capacity of the local road network is maintained and improved where funding allows and to ensure that local streets and roads within the county are designed to a suitable standard to accommodate the future needs of the county. The design of these roads and streets should balance the needs of place and movement with providing a safe street environment for all road users.

Evaluation of proposed development - as per Section 17(3)(b) of the Planning and Development Act 2000 as amended.

The L6047 is a 5m wide carriageway and extends for c6.5km connecting the R411 and the R412. At the site location the River Liffey is c18-20m wide and flows from east to west. The Flow is controlled by the ESB at Golden Falls Dam, which is located c1.8km upstream of the site. The Poulaphouca Dam is located c2.5 further upstream from Golden Falls Dam and controls the flow from Poulaphouca Reservoir.

The proposed works includes the permanent realignment of c160m of the River Liffey, to reinstate a course the River ran some 150 years ago. Over time the River has meandered and this movement has created the steep embankment which exists today. By returning the River Liffey to the pre-existing course, space is provided to re-profile the embankment to create a stable natural slope. To accommodate this work the diversionary works must be completed in dry conditions and therefore a temporary river channel is proposed to facilitate work on the

permanent realignment. To reduce the risk of further erosion from occurring, geogrid reinforcement will be installed a 1m vertical centres and scour protection will be installed along the base of the slope.

It is noted that currently the road is closed due to safety concerns and failure of sections of the L6047. The works outlined above will allow for the L6047 to be reconstructed for a distance of 300m with the existing width of 5m maintained and a grass verge of 2m along its edge on the river side. Along the grass verge a wall will be build for 100m and a 5m safety barrier installed to the approach and departure of the wall.

It is considered that the L6047 is an important piece of infrastructure for the Ballymore Eustace and the wider environs. The road is the most direct route from Ballymore Eustace to Kilcullen and Two Mile House and surrounding areas. Currently the detour imposed as a result of the road closure is significant in terms of distance and inconvenience for road users. The proposed works accord with the policies and objectives as set out in Chapter 6 Movement and Transport of the Kildare County Development Plan 2017 – 2023 and outlined previously in this report.

AA Screening

An Appropriate Assessment Screening Report has been prepared and is included with the plans and particulars accompanying this application. The report confirms that the nearest Natura 2000 site is the Pollaphuca SPA which is located approximately 3.1 km to the west of the application site. The following table extracted from the AA screening report details all Natura 2000 sites within 15km of the subject site.

The AA Screening report states that potential for significant adverse effects on European Sites is unlikely given the nature of the proposed development which would not impact on the features of interest of the Pollaphuca SPA and the considerable distance to the nearest downstream Natura 2000 site (Dublin Bay -70km downstream). The AA Screening concludes that no significant effects on Natura 2000 sites are likely and therefore a Natura Impact Statement is not required. A determination and Chief Executive's Order has been prepared and states that a Stage 2 Appropriate Assessment is not necessary.

EIAR Screening

An Environmental Impact Assessment Screening report has been prepared by O' Connor Sutton Cronin & Associates Ltd. The Screening Decision formed on completion of the Environmental Impact Assessment Screening report states that having regard to the nature, scale and location of the proposed development, by itself and in combination with other plans and projects the overall impact of on the receiving environment is considered low. The report concludes therefore that an EIA is not required. A determination and Chief Executive's Order has been prepared and states that the environmental effects arising from the proposed project will generally be localised minor in nature and occur principally during the construction phase and the EIA is not required.


Modifications:

- The proposed development shall be carried out in accordance with the plans and 1. particulars placed on public display on 5th February 2019, except where altered or amended by the following modifications.
- The Contractor shall liaise and agreed work proposals with Inland Fisheries Ireland 2. prior to commencement.
- The existing stile accommodating access to the River bank shall be relocated to a 3. location to be agreed with the Trout and Salmon Angler's Association and Inland Fisheries Ireland.
- Prior to construction the Contractor shall prepare a Construction and Environmental 4. Management Plan (CEMP) to be agreed in writing with the Roads and Transportation Department and Inland Fisheries Ireland. The Construction and Environmental Management Plan shall detail inter alia site controls and method statements for the in stream works to include floating silt curtains during the opening and closing of the temporary and permanent channels. Such works shall be subject to agreement with Inland Fisheries Ireland.
- The Contractor shall liaise with all respective utility providers regarding works in 5. proximity to their services and where works by utility providers are required within the subject site; these shall be coordinated to take place during the construction phase of the proposed development.
- Where damage occurs to the existing stone walls on the L6047 or the R413, they 6. shall be repaired with materials consistent with the existing stone walls.
- The Contractor shall provide to the Geological Survey Ireland a copy of all reports 7. detailing all site investigations and photographic recording conducted on site.
- Prior to the commencement of works the works area shall be subject to a badger 8. survey and an otter survey and the completed surveys shall be submitted to the Planning Authority.
- Areas of Riparian vegetation should be retained in so far as possible; any cleared 9, areas should be replanted with native species to mitigate any negative ecological impacts.
- The recommendations raised in the report of the Roads, Transportation & Public 10. Safety Department shall be implemented.

The ESB provided the Engineering Consultant's with flow data to be used in the flood modelling

Responses to Submissions

O'Connor Sutton Cronin on behalf of Kildare County Council, have examined the submissions made by the contributors listed above. The principle points raised are summarised below. These points are considered a fair representation of the issues raised. The following responses have been prepared cognisant of the requirement for a scheme to address the needs of vulnerable road users through the stabilisation of the adjacent embankment.

- 1. Need to complete otter and badgers surveys prior to works (Comment from An Taisce)

 Response: This survey is already underway. A mammal ecologist is currently on site

 completing a survey for otters and badger setts.
 - Request to obtain any site investigation report or photographic recording of the site for information purposes (Comment from Department of Communications, Climate Action & Environment)

Response: The Contractor will be instructed to provide weekly updates of the work progression using drone footage and high resolution cameras.

 Works to be kept in line with CEMP, commitment to be provided that works will proceed only with agreement and consultation of the IFI (Comment from Inland Fisheries Ireland)

Response: The Contractor will be instructed to continue liaising with the IFI throughout the works. It will be stipulated in the tender documents that any works proposals will need to be agreed with the IFI prior to commencement.

 Utility services to be contacted regarding services (Comment from Gas Networks Ireland)

Response: The Contractor will be responsible for liaising with the respective utility providers regarding the proximity of works to their services and facilitating any works that may be required to take place.

 Any damage to Trout and Salmon Anglers' Association stiles must be repaired and anglers must continue to have access to the River Liffey (Comment from Trout and Salmon Anglers' Association (TSAA))

Response: The current location of the TSAA stile will be identified in drawings provided to the Contractor. It will be stipulated in the tender documents that the Contractor must carefully move the stile to a location to be agreed with the TSAA for the duration of the works. The





Contractor will move the stile back to its' existing location, and reinstate the stile following the completion of the works.

6. Any damage to stone walls on L6047 or R413 must be repaired with similar material. During construction of site compounds, opening and closing of the temporary and permanent channel, request made that hourly monitoring takes place of suspended solids in conjunction with the floating silt curtains. Sewage and litter control to be put in place for construction compounds (Comment from TSAA)

Response: The Contractor will be instructed in the tendering documents to make provisions for wall repairs in line with existing materials used. The Contractor will be required to prepare a Construction and Environmental Management Plan (CEMP). Site controls and mehod statements for the instream works will be subject to consultation with the IFI. Additional allowances will be made for floating silt curtains during the opening and closing of the temporary and permanent channels.

Fish stock survey to take place following the works in conjunction with the IFI (Comment from TSAA)

Response: Works will be completed, in consultation with, and to the satisfaction of the IFI.

 Recommendation to complete breeding bird survey in the period April to Mid-May and Mid-May to late June which should follow the Countryside Bird Survey Methodology (Comment from Benson Ecology)

Response: Irish Wildlife Trust, Bird Watch Ireland, the Tree Council of Ireland and National Parks and Wildlife Services were circulated the proposed plans and particulars for the proposed development. Consultation on site was undertaken with the NPWS prior to submitting the Part 8 planning application. All necessary surveys as equested by the prescribed bodies have been carried out or are currently in progress.





Conclusion

O'Connor Sutton Cronin, on behalf of Kildare County Council, considers the proposed scheme of great importance to the local communities as the scheme will enable the L6047 to be reopened to the public. This road is an important local amenity.
