Pursuant to the requirements of the above, Kildare County Council proposes to provide a segregated high quality cycle route on Green Lane, Leixlip.

The site is 700m in length and is located along Green Lane between Accommodation Road and Station Road (R148) in Leixlip.

Green Lane is a single lane carriageway with no existing cycle infrastructure in the site area. There are footways on both sides of the road.

The Proposed Development comprises:

- The provision of a 2m protected cycle track and 2m footway on both sides of Green Lane
- The provision of a shared use path in front of existing schools on Green Lane
- Reduction in road carriageway width to 2 No. 3m carriageways
- The introduction of raised crossings on all side roads to prioritise pedestrian movements
- Straight through cycle track crossings on all side roads to prioritise cyclists
- Realignment of side road junctions
- Adjustment of existing signalised crossing
- Removal of car parking spaces on Green Lane
- Realignment of existing car park to increase car parking spaces
