## Planning and Development Act 2000 (As amended) Planning and Development Regulations 2001 (As amended) (PART 8)

## Proposed Pedestrian/Cycle Bridge in Celbridge Town Centre Planning Reference: P82022.07

Pursuant to the requirements of the above, Kildare County Council proposes to provide a shared pedestrian and cycle bridge over the River Liffey in Celbridge town centre.

The site extends to the following locations in Celbridge:

- Main Street and English Row at the R405 / R403 Junction.
- Celbridge Bridge (R405) from the Main Street Junction to the Newtown Road / Dublin Road (R403) and R405 Junction.

The proposed development comprises of a shared pedestrian and cycle bridge from the footpath adjacent to the former Bank of Ireland car park in Celbridge to the footpath outside the Abbey Lodge public house. The bridge will span over the River Liffey for approximately 50m. It will be constructed directly adjacent to the

The existing footpath will be removed from the existing road bridge and a rubbing strip will be installed at

The kerb line will be built out slightly in front of the Abbey Lodge and the existing pedestrian crossings will be maintained on all three arms of this junction.

The footpath will be built out on Main Street at the arm of the junction and a new pedestrian crossing will

The proposed scheme will also be available for inspection at Celbridge Library, St Patrick's Park, Celbridge W23 VA47. (Opening hours 10:00 a.m. - 5:00 p.m. Monday, Wednesday, Friday, Saturday, and 10:00 a.m. -8:00 p.m. Tuesday and Thursday).

The proposed development has undergone Appropriate Assessment Screening under the Habitats Directive (92/43/EEC) and the Planning and Development Act 2000, as amended and the Planning Authority has determined that a Stage 2 Appropriate Assessment is not required in this instance. In addition, the proposal has also undergone screening for Environmental Impact Assessment under the EIA Directive 2014/52/EU (and the relevant provisions of the Planning and Development Act 2000, as amended) and the Planning Authority has determined that there will be no real likelihood of significant effects on the environment arising from the proposed development and therefore an Environmental Impact Assessment is not required. In accordance with Section 120 of the Planning & Development Regulations (as amended), any person may, within 4 weeks from the date of this notice, apply to An Bord Pleanála for a screening determination as to whether the proposed development would be likely to have significant effects on the environment.


