Pursuant to the requirements of Part 8 of the Planning and Development Regulations 2001, as amended, Kildare County Council hereby gives notice that it intends to carry out the following development:

Description:

P82021.01 Environmental improvement works in Rathangan Town Centre, Co. Kildare.

Nature and extent of the proposed development:

Kildare County Council proposes to carry out the following works -

Proposed environmental improvement works in Rathangan Town Centre, comprising:

- a. Footpath widening and resurfacing
- b. Upgrade of street furniture and street lighting
- c. Replacement of existing trees with new trees and additional trees (5 existing trees to be removed, 14 trees proposed to replace)
- d. Formalisation of car parking spaces and resurfacing, including additional disabled parking bays
- e. Sensitive restoration of water pump NIAH No. 11810056
- f. Re-design of 'William A Byrne memorial garden
- g. Welcome signage at approach to town
- h. Gateway feature artworks on approach to town
- i. New street lighting columns and pedestrian feature lighting to replace existing

The development has been the subject of an Appropriate Assessment screening in accordance with Article 6(3) of the EU Habitats Directive (Directive 92/43/EEC) and Article 250(1) of the Planning and Development Regulations 2001, as amended. The Appropriate Assessment screening concluded that the proposed development would not be likely to give rise to significant or indeterminate impacts on any Natura 2000 site.
