**PART 8 - PROPOSED ENVIRONMENTAL IMPROVEMENT WORKS IN RATHANGAN TOWN CENTRE, CO. KILDARE**

- h. Gateway feature artworks on approach to town
- i. New street lighting columns and pedestrian feature lighting to replace existing


