De réir Chuid 8, Airteagal 81 de na Rialachán um Pleanáil agus Forbairt 2001 (arna leasú), tugann Comhairle Contae Chill Dara fógra leis seo go bhfuil sé ar intinn acu an fhobairt seo a leanas a dhéanamh:

Moltar mar chuid den togra, 2 droichead breise a sholáthar ar Chéim 2 de Ghlasbhealach na Canálach Móire. Tá Droichead 1 suite i mBaile Ló, agus tá Droichead 2 suite díreach soir ó Dhoichead Healy (Droichead Bonynge) atá ann faoi láthair.

O theorainn Ulbh Fhailli, taistealonn coisithe agus rothaithe ar an taobh thuaidh den chanáil. Ag an droichead nua do choisithe (Droichead 1) i mBaile Ló, rachaidh siad trasna na Canálach Móire go dtí an taobh ó dheas. Leanfaidh siad ar aghaidh ansin ar an gcosán tarraingthe uasgráidaithe i dtreo Dhoichead Healy. Beidh siad ag taisteal faoi bhun Dhoichead Healy atá ann cheana féin ar an taobh theas den chanáil agus ag trasnú an droichead nua coisithe (Droichead 2) ar an taobh thuaidh, sula rachaidh siad ar aghaidh go dtí Na Solláin. Cuireann an droichead nua do choisithe ag an mBaile Ló ar chumas úsáideoirí rochtain a fháil ar bhealach Ghormbhealach na Bearú freisin.

Ligeann na droichead bhreise seo rochtain níos sábhláite d'úsáideoirí an Ghlasbhealaigh trí thrasnú agus taisteal feadh codanna contúirteacha den bhóthar poiblí a sheachaint.

Rinneadh Scagadh Measúnaíthe Cui ar an togra faoin Treoir um Ghnáthóga (92/43/CEE), agus faoi fhórálacha ábhartha an Acharta um Pleanáil agus Forbairt 2000, arna leasú, agus na Rialachán um Pleanáil agus Forbairt 2001, arna leasú, agus Rialachán na gComphobhal Eorpach (Gnáthóga Éan agus Nádúrtha), 2011 – 2015. Chinn Comhairle Contae Chill Dara nach mbeidh tionchar suntasach ag an bhforbairt bheartaithe ar Shuiomh Eorpach agus nach bhfuil Measúnú Cui ag teastáil.

Rinneadh scagadh ar an togra freisin maidir le Measúnú Tionchair Timpeallachta faoi Threoir MTT 2011/92/AE arna leasú le Treoir 2014/52/AE agus forálacha ábhartha an Acharta um Pleanáil agus Forbairt 2000, arna leasú, agus na Rialachán um Pleanáil agus Forbairt 2001, arna leasú. Ag féachaint d'fhórálacha na reachtalocha do chineál agus do scála na forbartha atá beartaithe, don fhaisnéis a sholáthraitear de réir Sceidleadh 7A de na Rialachán, agus ag féachaint do scála, do chineál agus suíomh na dtionchar atá beartaithe, do na tionchar ionchasaacha agus do na bearta maolaithe atá beartaithe agus do thorthaí aon mheasúnuithe ábhartha eile ar na héifeachtaí ar an gcomhshaol. Chinn Comhairle Contae Chill Dara nach bhfuil aon fhíor-dhochúlacht ann go mbeidh tionchar suntasach ag an bhforbairt bheartaithe ar an gcomhshaol agus nach bhfuil Measúnú Tionchair Timpeallachta ag teastáil. De réir Alt 120 de na Rialachán um Pleanáil agus Forbairt (arna leasú), feadfaidh aon duine, laistigh de 4 seachainte ó dháta an fhógra sin, iarratas a dhéanamh chuig an mBord Pleanála ar chinneadh scagtha i dtaobh an dóigh go mbeadh tionchar suntasach ag an bhforbairt ar an gcomhshaol.

Beidh Pleananna agus sonraí na forbartha beartaithe, Tag. uimh. P82024.07, ar fáil lena n-iniúchadh nó lena gceannach ar tháille nach mó ná an costas réasúnach a bhaineann le cíp a dhéanamh le linn gnáth-amanna oscailte ag Comhairle Contae Chill Dara ag an seoladh thíos ó 9:00 am – 5:00 pm. Luan go hAoine ar feadh tréimhse 6 seachtaíne ón gCéadaoin, 14 Lúnasa go dtí an Chéadaoin, 25 Meán Fómhair (san áireamh).

Notice of Proposed Development by Local Authority

**Location: Along the route of the Grand Canal Greenway Phase 2
at Downings South and Lowtown**

Project: Grand Canal Greenway Phase 2 Additional Bridges

In accordance with Part 8, Article 81 of the Planning and Development Regulations 2001 (as amended), Kildare County Council hereby gives notice that it intends to carry out the following development:

The proposal is for the provision of 2 no. additional bridges on Phase 2 of the Grand Canal Greenway. Bridge 1 is located in Lowtown, and Bridge 2 is located just east of the existing Healy's Bridge (Bonynge Bridge).

From the Offaly border, pedestrians and cyclists travel on the north side of the canal. At the new pedestrian bridge (Bridge 1) in Lowtown, they will cross over the Grand Canal to the south side. They will then continue on the upgraded towpath towards Healy's Bridge. They will travel underneath the existing Healy's Bridge on the south side of the canal and cross over the new pedestrian bridge (Bridge 2) to the north side, before carrying on to Sallins. The new pedestrian bridge at Lowtown also enables users to access the Barrow Blueway route.

These additional bridges allow for safer access for users of the Greenway by avoiding the crossing of and travelling along dangerous sections of the public road.

The proposal has undergone Appropriate Assessment Screening under the Habitats Directive (92/43/EEC), and the relevant provisions of the Planning and Development Act 2000, as amended, and the Planning and Development Regulations 2001, as amended, and the European Communities (Bird and Natural Habitats) Regulations 2011 – 2015. Kildare County Council has determined that the proposed development will not have a significant effect on a European Site and an Appropriate Assessment is not required.

The proposal has also undergone screening for Environmental Impact Assessment under the EIA Directive 2011/92/EU as amended by Directive 2014/52/EU and the relevant provisions of the Planning and Development Act 2000, as amended, and the Planning and Development Regulations 2001, as amended. Having regard to the provisions of the legislation, the nature and scale of the proposed development, the information provided in accordance with Schedule 7A of the Regulations, and having regard to the scale, nature and location of the proposed impacts, the potential impacts and proposed mitigation measures and the results of any other relevant assessments of the effects on the environment. Kildare County Council has determined that there is no real likelihood of significant effects on the environment arising from the proposed development and that an Environmental Impact Assessment is not required. In accordance with Section 120 of the Planning and Development Regulations (as amended) any person may, within 4 weeks from the date of this notice, apply to An Bord Pleanála for a screening determination as to whether the development would be likely to have significant effects on the environment.

Plans and particulars of the proposed development, Ref. No. P82024.07, will be available for inspection or purchase at a fee not exceeding the reasonable cost of making a copy during normal opening times at Kildare County Council at the address below from 9:00 a.m. 5:00 p.m. Monday to Friday for a period of 6 weeks from Wednesday, 14 August to Wednesday, 25 September (inclusive).
