If the Casual Trading Licence is granted, the information supplied by you will be kept securely for a period of up to seven years.

If you do not provide the personal data required under the Casual Trading Act 1995 and the Casual Trading Bye-Laws Kildare County Council **will not be in a position to process** your application.

Registers of Licences

A local authority is obliged to establish and maintain a register (which shall be known as the Register of Casual Trading Licences and referred to subsequently as "the register") for the functional area of the authority of the casual trading licences granted by it under the Casual Trading Act 1995 and contain particulars as the Minister considers appropriate and specifies to the authority.
