1. To consider draft minutes of meeting held on 24 February 2017

The minutes of the meeting held on 24 February 2017 were proposed by Councillor Hillis, seconded by Mr. G. Prendergast and duly adopted.

2. To receive an Update on Development Control

Mr. Willie Hannigan presented a report on Development Control. The main issues were:

- 11,746 houses in 154 estates with a population of c.31,746 persons taken in charge by Kildare County Council since 2006.
- Bonds Performance bonds paid by developers from €2,000-€9,000 per unit depending on housing densities however bonds do not take into account other infrastructural requirements.
- Street lighting noted that developers are responsible for arranging connection and paying bills until taken in charge.
- Irish Water Some initial issues with taking in charge of estates when Irish
 Water was established and issues remain with taking in charge of older estates.
- Management companies Noted that apartment developments are not taken in charge by the local authority.

3. Update on Forward Planning

Peter Minnock, Director of Services advised that the Celbridge and Leixlip Local Area Plans were on public display and would be adopted during the year. The preparation of the Naas and Athy Local Area Plans would commence later in 2017.
