This was noted by the members who commended both the Council as well as the Tidy Towns Groups on the considerable progress which was made in recent years.

6. TO RECEIVE AN UPDATE ON ENVIRONMENTAL AWARENESS INITIATIVES

An outline of current initiatives was given by Ken Kavanagh, Senior Executive Officer, which focused on the following aspects:

This was also noted by the members. It was agreed that this would continue to be a key policy area which would be revisited by the SPC from time to time.

7. TO NOTE PROPOSED REVIEW OF THE LITTER MANAGEMENT PLAN AND PUBLIC CONSULTATION PROCESS

Mr Ken Kavanagh, Senior Executive Officer, confirmed that the Litter Management Plan is due to for review in 2020. Initially, this would include a significant level of public consultation where it was hoped to use the council's new online public consultation portal. In this context, the members of the SPC highlighted the following aspects:

- To be innovative in terms of such consultation (South Dublin County Council and Kerry County Council were cited as a possible example of good practice)
- Ensure coordination among stakeholders (Athy MD cited as an example)

Other points raised referred to the need for measures to combat the 'man in the van', dog fouling as well as the pervasive nature of fly-tipping.

Mr Kavanagh would endeavour to have a draft plan available for the next meeting. He would also take on board the suggestions of the Committee.

8. TO RECEIVE AN UPDATE ON THE FLOOD ALLEVIATION PROGRAMME

A presentation was given by Ms Edele O'Brien, Senior Executive Engineer, which focused on the following aspects:

- Flood relief schemes generally
- CFRAM programme in conjunction with OPW
- Plan Structures & Content
- Plan measures
- · Update on current schemes

From a policy perspective, the SPC members highlighted the need to liaise with other stakeholders (eg Bord na Mona in the case of re-wetting boglands) as well as the desirability of linking with climate action initiatives.

The Director of Services highlighted the importance of progressing the Athy CFRAMs scheme at an early date and, in this context would be liaising with the MD at an early date.

9. TO AGREE A WORKPLAN FOR 2020

The Committee noted the work programme of the outgoing SPC. Some concern was expressed regarding possible duplication of work in terms of the Climate Action SPC although such could also be complementary in some instances (pollination plan, grass cutting etc). It was also noted that there were some outstanding issues from the previous SPC. Reference was also made to the following:

- The opportunity to feed into environmental policies relating to the forthcoming review of the County Development Plan
- Examining models of good practice in other local authorities

It was agreed that members were free to submit policies items for consideration to the Senior Executive Officer in advance of the next meeting.
