Regional Spatial and Economic Strategy (RSES)

The Eastern and Midland Regional
Assembly (EMRA) adopted the
Regional Spatial and Economic
Strategy (RSES) which came into
effect on 28 June 2019. A Draft
Ministerial Direction was served on the
EMRA on 07 August 2019 concerning
aspects of future rail transport.
The EMRA held an official launch of
the RSES on 13 November 2019 in the
Glenroyal Hotel, Maynooth.

The Office of the Planning
Regulator (OPR)/Department of
Housing, Planning and Local
Government (DHPLG)

Separate meetings took place with the OPR and the DHPLG on 15 November. It is understood that additional training for members will take place in 2020.

County Development Plan (CDP)

The Minister and the Office of the Planning Regulator were informed on 26 July 2019 that Kildare County Council will be proceeding with a development plan variation in accordance with the Planning and Development Act 2000 (as amended). The Draft Variation No 1 will go on public display on 09 January 2020. Local Area Plans (LAP's)

The council, at its meeting on 29 July 2019 resolved to not make the Naas Draft LAP under Section 20 of the Planning and Development Act, 2000 (as amended).

Leixlip LAP

Strategic Housing Development (SHD) Applications to An Bord Pleanála

The Strategic Housing Development (SHD) process was created in 2016 as a fast-track planning mechanism to facilitate the delivery of larger housing projects. The SHD provisions came into effect on 03 July 2017 and apply for an initial period, until the end of 2019. While the process originated as part of the Government's Housing Action Plan Rebuilding Ireland, it also has to be seen in the longer-term

context of the National Planning
Framework, which set a target of
providing over half a million new
homes by 2040. Since the legislation
came into effect in July 2017,
applications for planning permission
for SHD's are made directly to An Bord
Pleanála.

Built Heritage Investment Scheme 2020

The scheme supports small scale, labor intensive conservation projects. The minimum level of funding awarded will be €2,500 up to a maximum of €15,000 per application.

Historic Structures Fund 2020

This scheme offers funding in 2 streams; Stream 1 offers grants from

€15,000 - €50,000 aimed at essential repairs and smaller capital works for the refurbishment and conservation of heritage structures. Stream 2 offers a smaller number of grants from €50,000 to €200,000 for larger enhancement, refurbishment or reuse projects involving heritage structures, where a clear community or public benefit is demonstrated. The closing date for all applications is Friday 31 January 2020.

Passport Online

A national campaign is underway directing the public to libraries to avail of enhanced passport online renewal facilities. Internet access is provided free of charge in all Kildare Libraries.

Laptop and Tablet Lending

Ten Kildare Libraries have commenced laptop and tablet lending this month. Devices can be borrowed free of charge for use in the library.

Energy Audits

All Kildare Libraries are undertaking energy audits in 2020. The library service will account for energy expenditure through window and boiler upgrades in selected libraries.

Castledermot Library Upgrade Works and Refurbishment

Castledermot Library is currently temporarily closed to the public until early 2020 for essential upgrade works. The refurbishment project is now well underway. Library staff have already fully cleared the building and all library stock and IT equipment are in temporary storage.



Extensive conservation works have begun on the original stained-glass windows:

- A full upgrade of the internal lighting system to energy efficient lighting is due to start in the coming days
- Procurement of internal fit-out, decorating and new flooring is underway
- The new layout and design will allow for a community space for talks, workshops and small meetings
- We hope to be ready to re-open early in 2020 once all work is completed

In order to ensure minimum disruption to services the mobile library service will visit Castledermot Community
Centre on 04 December and 08 and 29 January from 2:30 p.m-4:00 p.m.
In addition, during this period library members can borrow and return to any library in the country. Library members can continue to avail of the online services which include eBooks, eMagazines, music downloads and eAudio books at anytime, anywhere.
This service is totally free of charge; fines have been abolished in all library branches. Regular updates on the

Naas Library and Cultural Centre

My First Library Card

Kildare Library Service is working in conjunction with Wicklow Library Service on a *Right to Read* initiative to encourage parents and guardians to sign children up for library membership from birth. Literacy begins with

learning language and looking at books in early infancy. This process continues from birth throughout the early childhood years. Library membership and use can have a big impact on a child's literacy and numeracy levels. The Library Services have worked with author and illustrator Chris Judge (The Baby Beast, The Snow Beast, The Brave Beast, The Lonely Beast) on a specially designed My First Library Card to be made available in all Kildare and Wicklow Libraries. Brochures to advertise the card are being delivered to Public Health Nurses and childcare facilities throughout the two counties.

Kildare Libraries to be drop-off point for donated new books for Christmas

The Society of St Vincent de Paul (SVP) runs the **WordPower** scheme throughout the year in Dublin, Kildare and Wicklow to provide new books to children in the families they visit.

During the pilot period this year a total of 3,099 children received book packs from WordPower. The pilot has been such a success that the project has now been introduced permanently in the region. This Christmas Kildare and Wicklow libraries and KFM in

conjunction with SVP WordPower are collecting new books and book vouchers/tokens for families. KFM will promote the appeal starting this week. Kildare and Wicklow Libraries will be the drop-off locations for the donated books/tokens and SVP will arrange for families to receive the books. Books can be donated until the week of the 16 December.

Family Time at Your Library

Right to Read is the national programme to promote literacy and reading development for people of all ages and backgrounds. It currently includes four national programmes designed to promote children's reading and literacy, in addition to local programming. Family Time at Your Library events and activities take place in all libraries during the month of December to support a family's focused approach to reading with children and to increase awareness of the benefits of reading and promote reading as a fun, recreational activity for children. Family Time at Your Library events will take place throughout the month of December in all Kildare libraries.



Better Basics Boosting Reading

The Better Basics Boosting Reading Programme is run in Kildare primary schools in conjunction with County Kildare Leader Partnership (CKLP). Children are supported through paired reading to improve their reading skills and develop greater confidence in reading aloud. This programme also creates important links between the school and the library. This year the programme runs from November to March/April and has just begun. The Local Studies Section of Kildare Library Service co-organised a seminar 'Aspects of the Curragh', in association with the County Kildare Archaeological Society on Saturday 16 November. This event was supported by Creative Ireland with the opening address by Cathaoirleach, Councillor Suzanne Doyle. The event featured a number of distinguished speakers who explored different aspects of the unique heritage of The Curragh.



A new edition of Dr John Feehan's long out of print book on The Curragh *Cuirreach Life* was launched at the event, along with the newly digitised journals of the County Kildare Archaeological Society and the formal launch of the Abarta audioguide to the Curragh.

Decade of Commemorations Committee [including 120 Years of Local Democracy Exhibition]

The work of the Decade of
Commemorations Committee
continues apace, with planning for
2020 events already underway. The
Irish Military Seminar will again take
place in June 2020, while partnerships
with local history groups and
community groups are again planned
for throughout 2020. Key events which
took place during 1920 which will be
commemorated in 2020 include the
Bloody Sunday events in Dublin
(including the role of Kildare man Mick
Sammon as referee in Croke Park), an
ambush in Kill during the War of





Independence and historic local elections held in County Kildare in 1920. An exhibition marking '120 Years of Local Democracy' which details key local government events over the past 120 years is on display in Maynooth Library from 09-20 December. This mobile exhibition, curated by the Local Archivists and Record Managers Group, will subsequently go on display in Monasterevin Library in January and Leixlip Library in February.

Local Studies Collections

The Local Studies Department continues to acquire a wide range of items of historic and contemporary relevance to County Kildare, including postcards, and other rare publications. The Library Service recently acquired a scrapbook associated with the Aylmer Family of Donadea which offers interesting glimpses into the sporting lives of members of the aristocracy in 19th Century Kildare. It includes interesting information on tennis and cricket events held in the grounds located in Oldtown Estate. An autograph book from a County Kildare internee in the Curragh Camp (War of Independence period) has also been recently donated to the collections.

The Local Studies are always delighted to receive donations of such valuable historic items to the collections, which are available to be consulted along with being preserved for future generations in our collections in Newbridge.

Kildare Arts Service investment in Youth Theatre acknowledged in national research

At the recent launch of Centre Stage+20, a national youth theatre research project undertaken by Youth Theatre Ireland every ten years, the impact of Kildare Arts Service's sustained investment in Youth Theatre was highlighted. Kildare was highlighted among the top five counties with high provision for youth theatre, having one youth theatre for every 5,434 young people aged 10-19 in the county. The report states that the other counties in the top 5 (Cavan, Leitrim, Laois, Longford) have high provision, they also have low youth populations, whereas Kildare has a high youth population plus a large number of youth theatres. A case study on youth theatre provision in Kildare is highlighted in the research and states: "Autonomous youth theatres and youth theatres run by





theatre companies and amateur drama groups have flourished in Kildare to form a thriving youth theatre community. These youth theatres are between 3 and 22 years old, with a mixture of paid and volunteer youth theatre facilitators delivering activities. Two decades of active youth theatre development has built a strong youth theatre culture in the county. Though Kildare has a high youth population, the number of youth theatres means there is a good ratio of youth theatres to young people. They are mainly located in the north of the county where the youth population is concentrated. Although Kildare Arts Service did not initiate any of these youth theatre groups, its openness to funding youth theatre groups which are not part of its own activity programme has contributed significantly to the sustainability of youth theatre in the county. Kildare Arts Service gives two independent youth theatres the status of regularly funded organisations and assigns them core funding. The county now has a mix of provision including: two large youth theatres (Kildare Youth Theatre and Griese Youth Theatre); a smaller autonomous youth theatre with paid facilitators; two small,

autonomous

youth theatres run by volunteers; and one voluntary youth theatre run by an amateur drama group."

Maynooth Film for All – Transit

Maynooth Film for All will finish off 2019 by showing the French/German co-production *Transit* based off the 1944 novel of the same name. There will also be an introduction by Professor Gerry Kearns from the Department of Geography in Maynooth University.

The Maynooth Film For All Film Club is a partnership between Kildare County Council Library and Arts Service and the English Department and Media Studies at Maynooth University.

On a Winters Night – Festive Traditions from Around the World

"On A Winter's Night" celebrates
Christmas and festive traditions from around the world. In 2018 'On A
Winters Night', written by Ms Susan
Boyle and Mr Eoghan Doyle, was
performed to over 1,800 children
throughout schools and libraries in
Kildare, with the performances in 2019
likely to exceed this number. Inspired
by the highly successful 'Joy to the





World' exhibition which, since 2007, has been seen by thousands of people in County Kildare, this fun and thoughtful interactive storytelling session is the perfect antidote to Christmas commercialism.

Visual Artists Café Kildare

A Visual Artists Café will take place on Wednesday, 11 December in the Riverbank Arts Centre. The Café is run by Visual Artists Ireland in association with Kildare County Council's Arts Service and is a follow on event to the 3 successful professional development workshops for artists held in Kildare this autumn.

Water Services

Infrastructural Projects

Contract 2A (Newbridge Eastern Interceptor Sewer)

The contract was signed by Irish Water and Roadbridge on 20 February and it has a 24-month construction programme. Work is progressing well on site. Murphy International Ltd., on behalf of Lidl (subject to an Irish Water agreement), is laying part of the Eastern Interceptor Sewer along the route of the Newbridge Outer Orbital Relief Road between the dual carriageway and the Great Connell Road. These works are now well advanced.

Contract 2B (Network)

The contract was signed by Irish Water and Coffey Construction Ltd On 08
August 2019 and it has a 30-month construction programme.
Works commenced on site in September 2019.

Osberstown Sludge Treatment Facility DBO Contract Variation

Veolia Water Ireland is advancing works on this variation to the DBO contract.

Maynooth Transfer Pipeline

This project involves the upgrading of the existing Maynooth Sewerage Pumping Station and the construction of a new sewerage pipeline along a new route from the pumping station to the Leixlip Wastewater Treatment Plant. The project is at planning and design stage. Irish Water has commenced engagement with landowners as part of the land and wayleave process.

Capital Projects

Kilmeague Waste Water Treatment Plant (WWTP) Upgrade

The plant was commissioned in late September 2019. It is being operated by the contractor for three months during a process proving period before handover to operations in early January 2020.



Allenwood Sewerage Network (Vacuum System) Modification

The legacy land payment is being progressed by Irish Water. Irish Water's consultants are reviewing the Design Review Report and preparing new land acquisition/wayleave maps for the project.

Timolin WWTP Upgrade

This project is being assessed by Irish Water Asset Planning under the National Certificate of Authorisation Programme (NCAP) Process and a site assessment report is being finalised by Irish Water's consultants.

Rathangan WWTP Upgrade

This project will now have to be progressed as a Capital Scheme rather than through operations.

Allenwood North WWTP Upgrade

This work is scheduled for tender in Quarter 4, 2019.

Water Networks Projects Newbridge Town Watermain Rehabilitation Works

All works are currently under review for the remainder of 2019 regarding the Water Network Programme Schemes, as Irish Water's targets have been met and exceeded for this year. As a result, the following projects are now likely to commence in 2020:

 Services (BYS) Scheme.
- Piercetown, Newbridge BYS Scheme
- St. Patricks Terrace, Naas BYS Scheme.
- Dublin Road, Naas Mains
 Rehabilitation Project

Pairc Mhuire, Newbridge BYS scheme

Works on site resumed in Pairc
Mhuire, Newbridge, as of 14 October.
A total of 1,230 metres of new HDPE
watermain have since been installed
as part of this scheme. Customer
private side service connection works
commenced on 13 November. To date
40 customers have had private side
works carried out within their
properties as part of the upgrades.

Kildare Town Watermain Rehabilitation Works

Watermains have been laid in Rowanville, Lourdesville, Cleamore Terrace, Assumpta Villas and Campion Crescent. The transfer of





services is ongoing. A number of customers have yet to provide consent to allow for the completion of the private side works so that decommissioning works can be completed in these estates. This work cannot commence until all customers consent has been obtained. There are 16 No customers/premises where consent has not been provided.

Taghadoe to Maynooth Watermain Replacment

Upgrade works and decommissioning works have now been completed. The new section of watermain is now live. Permanent road reinstatement works have yet to be completed as part of this scheme.

Suncroft Village – Transfer of Service Connections

This scheme is now under review and works will now not proceed in 2019.

Environment

Catchment Flooding

Catchment Flood Risk Assessment and Management Study (CFRAMS)

Meetings have taken place with the Office of Public Works (OPW) regarding the prioritisation of works. A Steering Group with the OPW has been established to progress the consultants brief for the Naas Study and Leixlip Scheme. The municipal districts will be briefed on the emerging CFRAM Programme.

Morell Flood Management Scheme

A Judicial Review has been lodged against An Bord Pleanála's decision. Kildare County Council, as notice party cannot commence any works until the review is heard or withdrawn. Efforts are ongoing to resolve issues and progress is being made.

Athy Flood Modeling

Scenarios have been completed meaning that the proposed flood measure can be adopted into the Local Area Plan (LAP) as part of the Dominican Masterplan, subject to the approval of the elected members.





Hazelhatch

The contract for a further hydrological study into flooding at Hazelhatch has been awarded to RPS Ireland. Delivery of revised mapping of the area is scheduled for the end of Quarter 4, 2019, with a preliminary flood risk management options report due in Quarter 1, 2020. The revised mapping will be used by the OPW to update flood extents in the catchment.

Kerdiffstown

Taking possession of properties under the CPO is now complete.

An advanced works contract is near completion in connection with the St Vincent de Paul property.

The L2005 realignment contract has been awarded to David Walsh Civil Engineering and works have commenced. Shortlisting of candidates for the main contract has been completed. Tenders are to be issued before Christmas. A presentation was given to Naas Municipal District Committee on Tuesday 19 November.

Cemeteries

Churchtown Cemetery

Public lighting is to be commissioned with the ESB subject to funding agreement.

Kildare Town Cemetery

The updated design for upgrade works is under consideration. It is anticipated that works will take place in early 2020.

Newbridge Cemetery

Work on the upgrade of the car park is to commence in early 2020.

Columbarium Walls

Derrinturn,

It is hoped to appoint a contractor to carry the work in 2020 in Derrinturn Cemetery.

Rathangan, Newbridge and

Crookstown

It is hoped to begin construction in Quarter 2/Quarter 3, 2020.



Eastern and Midlands Climate Action Regional Office (CARO)

All governance arrangements are in place. Partnership with Kilkenny County Council was formally signed on 11 October and the regional/subregional structure will be further strengthened in the new year following representation to the 17 Chief Executives. A sectoral training plan has been finalised and approved following presentation to the County and City Management Association (CCMA). The training plan was further presented to all local authority Training Officers on Tuesday 05 October. All (17) adaptation plans in the Eastern and Midlands Region have been approved. The CARO's are now developing a strategy for implementation and Key Performance Indicators (KPIs) for agreement at a national level. The CARO has also commenced working with the constituent local authorities in relation to the actions contained within the Government Climate Action Plan.

Kildare Climate Action Team

The Chief Executive's Report on the draft adaptation strategy was approved at the plenary council meeting on 23 September and the Climate Action

Team will convene soon to commence implementation of the actions emerging from the Adaptation Strategy. A successful climate summer camp for younger people was delivered over the summer in conjunction with the Irish National Stud. The Kildare LEADER 'Communities 4 Climate Action' community training programme has concluded and the group intend to continue networking in order to promote climate action in their communities.

The council will also commence the recruitment process for a Climate Action Officer, at Senior Executive grade, over the coming weeks and this appointment will work closely with the Climate Change Strategic Policy Committee (SPC) and Climate Action Team to deliver on the relevant requirements of the various policy frameworks, not least the council's adaptation strategy, the All of Government Climate Action Plan and



the Climate Action Charter to be signed with the Minister for Communications, Climate Action and Environment.

New Initiatives


Countywide Green Kilometer

Allenwood Playground

Work is continuing on the development of a design for the ACDAL campus. It is hoped to have this completed in January and then to advertise the Part 8 for it.

Newbridge Skatepark

Quotations have been sought for contractors to install CCTV. It is hoped to award the work in January.

Tree Works Programme

Tenders are being awarded for tree works in Celbridge /Leixlip and Naas Municipal Districts. It is hoped these works will commence in early 2020 and be completed by the end of March. The programme of works will be circulated to the elected members of each municipal district before the works commence. Roads, Transportation and Public Safety

M7 Widening, Osberstown Interchange and Sallins Bypass Project

SIAC Construction Ltd/Colas Ltd. is the contractor. The contractor has opened 3 lanes both eastbound and westbound from Junction 8 Johnstown to Junction11 (M7/M9 merge). As works are continuing in this area an 80kph speed limit is in place.

Maynooth Eastern Relief Road and Bridge

The preferred route option, (C), was presented in committee to the Clane-Maynooth Municipal District Committee on 05 April.

The Clane-Maynooth Municipal District Committee confirmed approval of the Part 8 in respect of Option C on 29 July. Detailed design and CPO preparation stages are now underway.

Athy Distributor Route

An Bord Pleanála's approval issued on 11 October, 2017. A Notice of Confirmation for the Athy Distributor Road was published in the Nationalist and Leinster Leader on 28 November 2017. No objections/Judicial Reviews were received by the deadline on 23 January 2018. €3 million was included in the Department of Transport, Tourism and Sport (DTTAS) road grants in 2019 for this project. Notices to treat have been issued. Notice of entry on lands has been issued. Advance works between Corran Árd and Fortbarrington Road have been completed. The railway abandonment is complete. The removal of the rails and sleepers will be the next visible sign of works. A further advance contract is under procurement.

Maynooth Inner Relief Street

Moyglare Road to Dunboyne Road – Planning approval was issued by An Bord Pleanála to Cairn Developments Plc. Works are progressing well and the expected completion date is the end of 2019.



Newbridge Outer Orbital Route

Naas Road to Great Connell Road
Newbridge: Construction has
progressed well to date and much of
the realignment of the south bound
lane of the R445 is complete —
underground services, kerbing,
footpaths, roundabout, traffic islands,
road surfacing, public lighting and line
marking. The estimated completion

Voucher to improve online trading capabilities – Trading online vouchers are available to the value of €2,500 (50% of eligible costs up to the maximum of €2,500) Available to any business with less than 10 employees.

Voucher to explore new export markets – This grant can part-fund the costs that you will incur in investigating and researching export markets. Grant covers 50% of eligible costs (subject to a maximum of €2,500 per company in any one calendar year) Available to any business with less than 10 employees.

Business Priming and Expansion Grants – Up to 50% of the investment or €150,000 Available to any business with less than 10 employees in the manufacturing sector or internationally traded services.

Grants for improving shopfronts – to assist and support independent business owners to improve the appearance of their shop fronts/commercial properties. Grants are given for €5,000 or up to 75% of costs Open to all businesses.

Small Business Loans with Micro Finance Ireland – works with small businesses with fewer than 10 employees and turnover up to €2 milllion, by providing unsecured business loans of €2,000 to €25,000 for commercially viable proposals. Available to any business with less than 10 employees.
