### **Children Book Festival (CBF)**

The Children's Book Festival is coming to Kildare! Author and illustrator visits will take place in all Kildare County Libraries as part of the national celebration of books and reading for children. With a total of 22 visits across 15 branches, and special CBF storytimes, it is expected to attract attendance figures of up to 800 across all events. Visits are taking place between the 08 and 24 October in libraries and as outreach to local schools.

Carmel Uí Cheallaigh is the author of six children's books in Irish and English. She will visit Ballitore, Monasterevin, Rathangan and Clocha Rince. She will introduce her two recently published centenary chapter books commemorating Irish incidents of World War 1. Hear about Fr William Doyle, a brave chaplain who paid the ultimate price in the war and also the story of the biggest ever loss of life in the Irish Sea. These are the first books ever published for children on these subjects.

Judi Curtin is the best-selling author of the 'Alice and Megan' series, the 'Eva' series and many childhood favourites. Judi's new series, beginning with *Time After Time*, is about Beth and Molly, accidental timetravelling best friends. Judi's latest





book, *Lily at Lissadell*, is published this September. She will visit Celbridge, Leixlip and Naas libraries, talking to the classes about her writing, and answering the pupils' questions.

An interactive story and art workshop will be given by illustrator **Gerry Daly** in Kildare, Newbridge, Naas, Athy, Leixlip, Maynooth, Celbridge. Gerry is the illustrator of *Where are you*, *Puffling*, which tells the story of a little puffling who lives on Skellig Michael.

Pádraig Kenny is a children's author from Newbridge in County Kildare. His debut novel *Tin* was published in 2018 and was Waterstones Children's Book of the Month. His second novel, *Pog*, was published in April 2019 and was Independent Bookseller's Book of the Month. Pádraig will visit Kilcullen, Newbridge, and Castledermot to talk classes through how books are published, and he will reveal the secret ingredient that goes into making a really good book.

Sadhbh Devlin is author of *Bí ag*Spraoi Liom! an Irish-language picture book for children. She has worked as a television researcher for TG4 and is currently the DLR Writer-in-Residence.

She will visit Maynooth, Kilcock, Clane,

Athy, Kildare. Sadhbh will give a talk on how picture-books are made - from getting an idea to the finished book, incorporating some of the 'technical' aspects. Children will make their own picture-books to bring home.

# Summer Stars Summer Stars Reading Challenge 2019

Kildare Library Service ran the national Summer Stars reading challenge for children in all library branches from 15 June to 31 August. Summer Stars is an exciting reading-based programme which is available free of charge to children across the country. Each child was invited to register at their local library and enjoy reading many books as part of the adventure during the summer holidays. Many book related events were held in the libraries throughout the summer such as storytelling, 3D printing workshops, arts and crafts, Harry Potter workshops, etc. Over 6,000 children attended 263 events. Children were encouraged to continue reading throughout the programme and there were rewards and incentives along the way. The award ceremonies took place in September, where all children who participated were presented with





their own Summer Stars certificate and medal. More than 2,700 children participated in the programme this year which is an increase on last year's figures.

#### **Kildare Readers Festival 2019**

This is the tenth year of Kildare Readers Festival which is an entirely free literary festival with the aim of connecting readers with authors and artists. The festival programme has something for everyone, including regular favourites such as Ten Books You Should Read with Stefanie Preissner and Mary Costello and Sunday Morning Session will pair Mr Dermot Bolger with bestselling author Mr John Boyne. The library service is excited to welcome bestselling author of 12 internationally acclaimed novels Mr Douglas Kennedy, in conversation with RTE Broadcaster Mr Rick O'Shea. Mr Joseph O'Connor returns to celebrate our tenth anniversary in conversation with Kit de Waal and Henrietta McKervey. This year the library service will host writing workshops with Mr Christodoulos Makris and Kildare based Ms Pauline Clooney which are already fully booked! We look forward to an excellent memoir panel with Ms Emilie

Pine, Mr Arnold Fanning and Ms Emily Hourican (also on Sunday). Fantastic events will take place throughout the county over the festival fortnight including Ms Anne Griffin in Celbridge, Ms Hazel Gaynor and Ms Antoinette Tyrrell in Leixlip and new Irish voice in short stories Ms Lucy Sweeney Byrne in conversation with Mr John MacKenna in Maynooth to name but a few! ## Contract 2A (Newbridge Eastern Interceptor Sewer)

The contract was signed by Irish Water and Roadbridge on the February and it has a 24 month construction programme. Work is progressing well on site.

Murphy International Ltd., on behalf of Lidl (subject to an Irish Water agreement), is laying part of the Eastern Interceptor Sewer along the route of the Newbridge Outer Orbital Relief Road between the dual carriageway and the Great Connell Road. These works are now well advanced.

### **Contract 2B (Network)**

The contract was signed by Irish Water and Coffey Construction Ltd. on the 08 August 2019 and it has a 30 month construction programme. Works commenced on site in September 2019.

### Osberstown Sludge Treatment Facility DBO Contract Variation

Veolia Water Ireland is advancing works on this variation to the DBO contract.

### **Capital Projects**

## Kilmeague Waste Water Treatment Plant (WWTP) Upgrade

The plant was commissioned in late September 2019. It is being operated by the contractor for three months during a process proving period, before handover to operations in early January 2020.

## Allenwood Sewerage Network (Vacuum System) Modification

The legacy land issue has been resolved.

### **Timolin Plant WWTP Upgrade**

This project is being assessed by Irish Water Asset Planning under the National Certificate of Authorisation Programme (NCAP) process and a Site Assessment Report is being finalised by Irish Water's consultants.





### Rathangan Plant WWTP Upgrade

Irish Water has reviewed the Options
Report prepared by its consultant. Irish
Water will be progressing this upgrade
through minor upgrade works by
operations.

### Allenwood North WWTP Upgrade

Scheduled for tender in Quarter 4, 2019.

### **Water Networks Projects**

### Newbridge Town Watermain Rehabilitation Works (Back Yard Services-Lead Replacement)

A detailed design has been completed for both the Highfield and Piercetown Back Yard Service (BYS) Schemes Works commenced in Pairc Mhuire on the week of 22 July 2019. To date, approximately 900 metres of new HDPE watermain has been laid. All works are currently under review for the remainder of 2019 regarding the Water Network Programme Schemes, as Irish Water's targets have been met and exceeded for this year. As a result, the following projects are now likely to commence in 2020:

- Highfield, Newbridge BYS scheme.
- Piercetown, Newbridge BYS Scheme.
- St.Patricks Terrace, Naas BYS Scheme.
- Dublin Road, Naas Mains Rehabilitation project.

### Kildare Town Watermain Rehabilitation Works

Watermains have been laid in Lourdesville, Cleamore Terrace, Assumpta Villas and Campion Crescent. The transfer of services is ongoing. A number of customers have yet to provide consent to allow for the completion of the private side works so that decommissioning works can be completed in these estates. This work cannot commence until all consents have been obtained.

## Taghadoe to Maynooth Watermain Replacment

Approximately 1,750 metres of new HDPE watermain has been now installed. Decommissioning works are near completion for this scheme.





### Suncroft Village – Transfer of Service Connections

This scheme involves the transfer of service connections from an existing cast iron watermain to an existing HPPE watermain, and subsequently the decommissioning of a section of Cast Iron mains. This work is due to commence in Quarter 4, 2019.

## Environment Catchment Flooding

## **Catchment Flood Risk Assessment** and **Management Study (CFRAMS)**

Meetings have taken place with the Office of Public Works (OPW) regarding the prioritisation of works. A Steering Group with the OPW has been established to progress the consultants brief for the Naas Study and Leixlip Scheme. The municipal districts will be briefed on the emerging Catchment Flood Risk Assessment and Management (CFRAM) Programme.

#### **Morell Flood Management Scheme**

A Judicial Review has been lodged against An Bord Pleanála's decision. Kildare County Council, as notice party cannot commence any works until the review is heard or withdrawn. Efforts

are ongoing to resolve issues.

Progress is being made.

### **Athy Flood Modeling**

Scenarios have been completed meaning that the proposed flood measure can be adopted into the Athy Local Area Plan (LAP) as part of the Dominican Masterplan, subject to the approval of the elected members.

#### Hazelhatch

The contract for further hydrological study into flooding at Hazelhatch has been awarded to RPS Ireland. Delivery of revised mapping of the area is scheduled for the end of Quarter 4, 2019, with a preliminary flood risk management options report due in Quarter 1, 2020. The revised mapping will be used by the OPW to update flood extents in the catchment.

### Kerdiffstown

An Environmental Protection Agency (EPA) licence was granted on 07 March 2019. Taking possession of properties under the CPO has commenced. Notice to Enter will be served on the remaining propertes shortly. An advanced works contract is ongoing in connection with the St. Vincent de Paul property.





The L2005 realignment will be awarded shortly. A letter of intent has been issued. Demolition works has been completed. The shortlisting of candidates for the main contract has also been completed.

Tenders have been advertised and the proposal is to have works commenced by the middle of October 2019.

## Columbarium Wall at Laraghbryan, Works are complete.

A consultant has been appointed to deliver a new columbarium wall for Derrinturn Cemetery. A separate competition has been advertised to procure the delivery of the 3 others.

All governance arrangements are in place. A partnership with Kilkenny County Council is to be formally signed on 11 October. Draft Sectoral training plan has been finalised for presentation to CCMA.

All 17 adaptation plans in the Eastern

The Chief Executive's Report on the Draft Adaptation Strategy was approved at the plenary council

The completion of the MERITS (Mid-East Region Innovation Think Space) building in Naas will realise a vision to serve the emerging technology sector by connecting organisations and people, acting as a centre of excellence in supporting innovative companies across county and wider region. MERITS was awarded nearly





€2 million in funding from Enterprise Ireland and has also received significant financial support from Kildare County Council. The tender for this project was published in July and a contractor will be appointed by the end of October 2019.

### Athy Food, Drink and Skills Innovation Hub

Launched by Minister Heather
Humphreys in April, the conversion of
the historic Model School in Athy into a
centre for educational and
entrepreneurial excellence for the food
sector will promote economic
development and creative learning for
Athy and surrounding areas. The Athy
Food, Drink and Skills Innovation Hub
will comprise a:

- Skills Hub
- Community Timeshare
   Incubator Kitchen
- Community Food Discover
   Centre
- Co-Working / Collaboration
   Zone

Coca Cola have provided an initial funding investment for the project. The economic development team submitted an application for funding for

this ambitious project to the Regional Enterprise Development Fund (REDF) at the end of September. The application will be assessed over the coming weeks and a decision is expected from Enterprise Ireland before the end of the year. Mr Donnachadh O'Brien Engineers worked with the team on the feasibility study design for the project and application.

### **Kildare Food and Beverage Strategy**

Kildare County Council has identified the food, drink and hospitality sector in the county as an economic growth area which requires a strategy that supports initiatives that will further develop and enhance the sector. The economic unit tendered for a food and beverage strategy and James Burke and Associates were awarded the contract in August. The consultants are carrying out research currently and engaging with key stakeholders to seek their views. The first stakeholder forum meeting took place on Tuesday 08 October. A food survey is also being launched to ascertain the views of the wider public. The strategy is due to be published in Quarter 4, 2019.





### Equine Innovation Centre @ The Irish National Stud

The establishment of this facility at the Irish National Stud will act as a sectoral stimulus to develop an equine innovation hub of enterprise, innovation, applied research, commercialisation and learning.

**TOVS** – Trading online vouchers are available to the value of €2,500 (50% of eligible costs up to the maximum of €2,500) Available to any business with less than 10 employees.

**TAME** – This grant can part-fund the costs that you will incur in investigating and researching export markets. Grant covers 50% of eligible costs (subject to a maximum of €2,500 per company in any one calendar year) Available to any business with less than 10 employees.

**Priming and Expansion Priming** – Up to 50% of the investment or €150,000 Available to any business with less than 10 employees in the manufacturing sector or internationally traded services.

**Shopfront** – to assist and support independent business owners to improve the appearance of their shop fronts/commercial properties. Grants are given for €5,000 or up to 75% of costs and are open to all businesses.
