Local Area Plans (LAP'S)

Leixlip Local Area Plan (LAP) Ministerial Direction issued in March 2018 confirming that the Leixlip LAP is not in compliance with the requirements of the Planning and Development Act. A new LAP is to be prepared for Quarter 1, 2019. Public consultation is taking place regarding existing social infrastructure and future requirements with a public session scheduled for 31 January 2019 in Leixlip library.

Naas LAP

It is anticipated that a Draft Naas LAP will be published and put on public display early in 2019.

Athy LAP

Work on the preparation of the Draft Athy LAP is ongoing.

Newbridge LAP

At the December 2018 meeting of the Kildare-Newbridge Municipal District the members extended the life of the Kildare-Newbridge LAP by two years to December 2021.

Urban and Rural Regeneration and Development Fund (URDF) A list of successful Urban Regeneration and Development Fund



projects/proposals was received on 27 November 2018 and has been circulated to the members.

Conservation

The Department of Culture, Heritage and the Gaeltacht are inviting applications for conservation projects for buildings contained on the record of protected structures and in architectural conservation areas within County Kildare under the following schemes:

Built Heritage Investment Scheme 2019 (BHIS 2019)

This scheme will support small-scale, labour intensive conservation projects. The minimum level of funding awarded will be $\in 2,500$ up to a maximum of $\in 15,000$ per application.

Historic Structures Fund 2019 (HSF 2019)

This scheme replaces the Structures at Risk Scheme and offers funding in two streams;

Stream 1 offers grants from €15,000 -€50,000 aimed at essential repairs and smaller capital works for the refurbishment and conservation of heritage structures.

Stream 2 offers a smaller number of grants from €50,000 to €200,000 for larger enhancement, refurbishment or reuse projects involving heritage structures, where a clear community or public benefit is demonstrated. Both schemes operate on a match funding basis and details have been publicised on the council website. The closing date for submission of applications for both the BHIS 2019 and the HSF 2019 is 4:00 p.m. on 31

January 2019.





Major Infrastructural Projects

Contract 2B (Network) Irish Water has published the CPO and has notified Coffey Construction that it is the preferred tenderer. It is anticipated that the works contract will be signed in Quarter 2, 2019.

Contract 2A (Newbridge Eastern Interceptor Sewer)

Murphy International Ltd., on behalf of LIDL, is laying part of the Eastern Interceptor Sewer along the route of the Newbridge Outer Orbital Relief Road between the dual carriageway and the Great Connell Road. These sewer works are already well advanced. Irish Water has notified Roadbridge that it is the preferred tenderer for the scheme. It is expected that the main works contract will be signed in February.

Minor Capital Projects Red Bog Watermain This project is now complete. Allenwood to Kilmeague watermain The contract is now substantially complete.

Suncroft to Brownstown watermain replacement

The contract is now substantially complete. Final road restoration works will be carried out at a later stage.

Kildare Town watermain rehabilation works Watermains have been laid in Lourdesville, Claemore Terrace, Assumpta Villas and Campion Crescent.

Timolin Waste Water Treatment Plant (WWTP) Upgrade Part 8 approval was received in December 2017. The design can now be progressed further by Irish Water.

Calverstown WWTP Upgrade Works are now substantially complete.

Kilmeage WWTP Upgrade

A contractor is now on site and works are progressing well and due for completion in Quarter 2, 2019.





Newbridge Sewer Relining Contract Irish Water is appointing a contractor to do these works. Rathangan WWTP Upgrade

Irish Water has appointed a consultant to prepare the tender documents for this contract. The consultant is currently carrying out survey works and preparing the design.

Launch of free Alert text system -MapAlerter

Citizens of county Kildare are now able to receive alerts about severe weather, road works, road closures, water service disruptions, flooding and community events throughout the county via MapAlerter system -<u>https://kildare.mapalerter.com/</u>

Maynooth Eastern Ring Road Local Infrastructure Housing Activation Fund (LIHAF) Project

The Roads, Transportation and Public Safety Department continue to work with Roughan & O'Donovan, Consulting Engineers, in the design of a road scheme in Maynooth which links the R148 Leixlip Road and the R405 Celbridge Road. This scheme will include the construction of a bridge over the railway and Royal Canal. The ground investigation works have commenced. The Appropriate Assessment screening and Environment Impact Assessment (EIA) screening processes are ongoing. Once these works are completed the council will be in a position to announce the preferred route option. The council is aiming to make this announcement in March/April.

Celbridge Southern Relief Road and Second Liffey Crossing

The Roads, Transportation and Public Safety Department applied for funding for the construction of the Celbridge Southern Relief Road and Second Liffey Crossing under the Urban Regeneration and Development Fund (URDF). Kildare County Council received notification that funding was approved for 2019. Details of the 2019 allocation has yet to be confirmed.

Maynooth North–South Corridor, Phase 5 - Leinster Street to Kilcock Road

The final design revisions for Phase 5 of the North South Corridor are being undertaken by the consultant for this scheme. The council intend, that subject to funding approval being granted by the National Transport Authority (NTA), it will go to tender in





April/May for a July/August construction phase.

Maynooth North–South Corridor, Phase 6 - Moyglare Road Improvement Scheme The contract for the construction of Phase 6 - Moyglare Road Improvement Scheme will be awarded within the next few weeks with construction commencing during the school summer holiday period.

Prosperous Town Park – Town and Village Renewal Scheme

The Roads, Transportation and Public Safety Department is preparing tender documents to engage the engineering services required to design the drainage of the site, the car parking area with entrance and the earthworks associated with design of the park features. A pre-works contract to install the surface water drainage to facilitate this scheme commenced on 03 December 2018 and will continue until the end of January.

Other Maynooth Municipal District Projects

The full Restoration Improvement and Restoration Maintenance allocation for 2018 has been fully completed and claimed.

Royal Canal Greenway

The construction of the greenway ramp at Moyvalley is currently being fabricated off site with a March 2019 completion date. Contractors are also currently on site constructing the 2 kilometer Greenway section from Cloncurry to Fernslock.

Main Street Maynooth

The Design of potential future Irish Public Bodies (IPB) funded scheme for Maynooth Main Street is now complete and it is intended to go to tender in February/March 2019.

Dublin - Galway Greenway This project is progressing satisfactorily and the council expect to complete the final design and tender



documents by May for the Maynooth to Dublin boundary section.

Kildangan Railway Bridge Footpath Scheme

The Kildangan Railway Bridge Footpath Scheme is being considered for approval by the board of CIE / larnród Éireann. This approval will take the form of a licence with insurance and engineering conditions attached. It is proposed to proceed to the tender process following consideration of the particulars of the licence, subject to National Transport Authority (NTA) agreement on a funding contribution.

Kildare Town Northern Link Street and South Green Area Access Improvement Scheme

The Roads, Transportation and Public Safety Department has appointed Aecom Consulting Engineers to design the Kildare Town Northern Link Street and South Green Area Access Improvement Scheme. The route selection process is ongoing. Consultation with Iarnród Éireann has commenced regarding the design of an upgrade/replacement bridge over the railway. The application to secure funding for this project under the Rural Regeneration and Development Fund (RRDF) was not successful in 2018 in the first round of applications.

Kilcock Park and Ride Facility Kilcock Park and Ride Facility, which is located on the Maynooth Road, Kilcock, was officially opened on Friday 23 November 2018. This new pay by phone and pay and display car park is located in very close proximity to Maynooth Train Station and will facilitate commuters and long term parking in Kilcock. The signs contractor under the supervision of the Roads, Transportation and Public Safety Department has erected the new parking signs in Kilcock and Kildare County Council Community Wardens are issuing information notices of imminent enforcement of Kilcock Parking Bye-laws which include two hour maximum stay in the town centre to facilitate business.

Naas Transport Strategy

The Roads, Transportation and Public Safety Department has completed the tender process to identify a preferred consultant for the Naas Transport Strategy. The preferred consultant has been identified as Aecom Ireland Ltd. and a project inception meeting with Aecom was held in December 2018. The Naas Transport Strategy will contain recommendations for traffic, public transport, cycling and walking facilities in Naas. It is anticipated that the strategy will be completed within an approximate eight month timeframe. The first wave of public and stakeholder consultation associated with developing the strategy will be undertaken in February 2019.

Naas Municipal District 2019 The Naas Municipal District Road Works Programme for 2018 is now substantially complete.

Taking in Charge

The taking in charge policy is currently being updated and is at draft stage. It is expected to be presented to the Roads, Transportation and Public Safety Strategic Policy Committee (SPC) at the end of February 2019. A list of estates that are to be taken in charge for the first six months of 2019 will be presented to each of the municipal district meetings commencing with the Maynooth Municipal District meeting on 01 February 2019.

The Development Control Section has seen a surge of activity over the past 12 months notably: There has been an increase of 33% in the active development sites in County Kildare which gives an indication of the volume of housing being developed in the county. The Building Control Section has seen an increased amount of activity and there is also an emphasis on announced and unannounced inspections being carried out. There has been a 19% increase in the amount of valid commencement notices received in 2018 and a 25% increase in the total number of certificates of compliance on completions submitted in 2018. There has been an 8.5% increase in the number of Disability Access Certificates submitted in 2018.





Local Enterprise Office

National Ploughing Association (NPA)

The Chief Executive Officer of Kildare County Council and the Head of Enterprise met with Anna May McHugh in relation to the National Ploughing Championship 2019 which takes place in Ballintrain, Carlow. Given its proximity to the south of the county, commercial opportunities were discussed which would benefit accommodation providers, it was agreed a campaign will be prepared to publicise these opportunities to the register providers and members of the public who may wish to offer accommodation for the 2019 championships .The World Championships which are to be held in Ireland were also discussed, as of yet no decision has been made on the location and while are many offers of land across the country, it was agreed by the Chief Executive Officer that a bid would be prepared by Athy to host the World Championship in the coming weeks.
