Financial Reports

Annual Financial Statement

The Annual Financial Statement for year ended 31 December 2018 is currently being prepared and will be completed by 31 March 2019. It will be presented to council when complete.

Schedule of Uncollected Rates

The schedule of uncollected rates was completed in January 2019. The total amount collected on rates for 2018 was €53.3 million compared to €50.3 million for 2017. The closing arrears





balance has decreased from €13.6 million for 2017 to €12.7 million for 2018. The overall collection percentage for 2018 was 82%, an increase of 1% on the 2017 collection which was 81%.

Monthly Management Reports

Actual expenditure v budget reports for 2019 will be submitted to council as part of the monthly management report from March onwards.

Rates Demands 2018

The rate demands for 2019 were issued in February to all ratepayers.





Planning and Strategic Development

Regional Spatial and Economic Strategy (RSES)

The Report of the Director of the Eastern and Midlands Regional Assembly on Submissions was received by Kildare County Council on 18 February 2019.

Kildare County Development Plan 2017-2023

A two year progress report on the Kildare County Development Plan is being prepared and it is intended to circulate this for the April council meeting.

Local Area Plans (LAP's)

Leixlip LAP

Ministerial Direction was issued in March 2018 confirming that the Leixlip LAP is not in compliance with the requirements of the Planning and Development Act. A new LAP is to be prepared for Quarter 1, 2019. In January 2019 public consultation took place regarding existing social infrastructure and future requirements.

Naas LAP

It is anticipated that a Draft Naas LAP will be published and put on public display early in 2019.

Athy LAP

Work on the preparation of the Draft Athy LAP is ongoing.

Conservation

Built Heritage Investment Scheme 2019 (BHIS 2019)

A decision from the Department of Culture, Heritage and the Gaeltacht regarding successful applications is awaited. This scheme will support small-scale, labour intensive conservation projects. The minimum level of funding awarded will be €2,500, up to a maximum of €15,000 per application.

Historic Structures Fund 2019 (HSF 2019)

A decision from the Department of Culture, Heritage and the Gaeltacht regarding successful applications is awaited. This scheme replaces the Structures at Risk Scheme. €2,500, up to a maximum of €15,000 per application.





Housing

Kildare Housing Summit

Following the National Housing Summit, the Chief Executive held a Kildare Summit to specifically consider delivery of social housing and affordable housing in Kildare. The summit was attended by officials from the Department of Housing, Planning and Local Government, Housing Agency, Construction Industry Federation (CIF), together with representatives of the larger approved housing bodies and developers operating in the county. The purpose of the summit was to inform Approved Housing Bodies (AHBs) and developers in relation to the type and quantity of social housing units required in the county and also to brief them on the various mechanisms for delivery. The summit was very well received by those who attended and it is proposed to hold a similar summit for local AHBs and developers in the coming months.

Traveller Accommodation Programme 2019-2024

A recent meeting of the Local Traveller Accommodation Consultative Committee (LTACC) considered the draft Traveller Accommodation Programme for the county for the period 2019-2024. A notice will be published in a newspaper confirming that the draft programme is available for inspection as and from 01 April and a copy will be circulated to all stakeholders. Written submission can be made up to 31 May 2019.

Mortgage to Rent

A presentation was recently received by the Housing Strategic Policy Committee (SPC) from Home for Life (HFL). To date, mortgage to rent has been delivered by Approved Housing Bodies (AHBs) for indebted borrowers (of commercial lending institutions). Following a review of the mortgage to rent scheme HFL has been included as a provider of the scheme; HFL is a private company. The key distinction





between AHBs providers and HFL is that, when the ownership of the property transfers to HFL, the occupant of the property becomes a tenant of Kildare County Council, HFL is responsible for maintenance of the property. Further information on the Mortgage to Rent Scheme is available from the Leasing Section.

advertised and new applications will be invited. The terms of the scheme will be the same as in previous years.

The maximum funding available is €2,500 or 90% of the total cost of works. Tenants must have a clear rent account in order to qualify for consideration. The scheme will be advertised by mid- April.

Self-Help Scheme

In the first instance the Self- Help Scheme for 2019 was offered to approximately 80 applicants who were unsuccessful in 2018. Based on the response received to date there will be a surplus of funding available.

Work Matters at the Library 2019

Funding has been made available from the Department of Rural and Community Development to develop the national online eBooks, an eAudiobook service. Kildare Library Service has been assisting with development of this collection.

Irish Language Events 2019

A number of events are taking place for Seachtain na Gaeilge including; writing workshops for schools with Richie Conroy, Raidió Rí-Rá which gives students the opportunity to learn and practice radio and television skills. Enda Reilly will visit the part-time branches for bilingual workshops on Climate Change. There will be Sean Nós dancing with Mary Beth Taylor in





the seven main library branches and a trad music workshop with Rick Epping. Kildare Town Library and Kildare County Council in conjunction with the Kildare Tourism Board and Kildare Town Heritage Centre and Tourist Office have created 'Say it As Gaeilge' pocket mini 'dictionaries' and these will be officially launched on 15 March 2019. Following on from the success of last year, the plan again is to incorporate the Four Celtic Festivals, Imbolc, Bealtaine, Lúnasa and Samhain as part of our schedule of programming for the year. The first, Imbolc, took place in February as part of Féile Bríde in Kildare Town Library with a Sean Nós evening. The second festival, Bealtaine, will involve a walk led by the group Na Cnócadóirí from Maynooth Library to Leixlip Library along the river path. Lúnasa will be celebrated in Leixlip Library with a Céilí Mór and Pop up Gaeltacht and Samhain will be incorporated as part of the Kildare Readers Festival.

Parenting Programme

The 'Lets talk about Parenting' Programme was launched with a talk by Clinical Psychologist David Coleman in Athy Library on Tuesday 26th February. The talk covered the topic 'Scared Kids: Supporting children and teenagers growing up in an uncertain world' and was a great success with over 150 people in attendance. Other talks that have taken place so far include "Helping children who worry too much", "the 15 minute parent", "Healthy food made easy" and "Helping your child to behave well". Upcoming talks include "Keeping your child safe online" in Newbridge and Maynooth Libraries and "Raising bilingual children in Ireland" which takes place in Celbridge Library.





Toys Technology and Training (TTT)

The new series of talks/workshops for 2019 designed to offer support to children and adults with learning difficulties or disabilities was launched on 07 February in Leixlip Community Library with a screening of the documentary "This is Nicholas – Living with ASD". This screening was so successful and demand so high that a second screening will be taking place. Over 75 talks/workshops will take place as part of this programme in 2019.

Science, Technology, Engineering, Arts and Mathematics (STEAM) Programme

Libraries in County Kildare hosted free workshops for primary school classes during Engineers Week 2019 (02-08 March 2019). Scribble-Bot, Paper Circuit and LEGO Engineering were among the topics covered in these free workshops which took place as part of the STEAM Programme. Engineers Week events and the entire STEAM Programme brings the fascinating world of engineering and science to

children helping inspire them to engineer the Ireland of tomorrow.

Free Tech Week and Biodiversity

Week events for primary schools will also be taking place in libraries in

County Kildare as part of the wider

STEAM Programme in May 2019.

Kildare Young Filmmakers

Filmmakers from County Kildare are amongst the finalists for Ireland's 2019 Young Filmmaker of the Year, a competition which received over 1,700 entries this year. 16 year old filmmaker Ben Hatton Walsh, Scoil Dara, Kildare made a film, 'A Day in the Life' which explores bullying, while 16 year old Molly Hoque's film 'I Don't Know' is about two girls who are faced with a difficult decision. Director Liam Boland, aged 15, who worked with Kildare Young Filmmakers, Cabinteely Young Filmmakers and Playacting Youth Theatre (Celbridge) made a film 'Just a Friend' about a young girl who develops an online friendship. Films shortlisted for the final will be screened at Fresh Film Festival 2019 in Limerick in late March and Ireland's Young Filmmaker of the Year Awards





will be announced. Two members of the group also recently presented at the First Cut Film Festival in Youghal.

Arts, Health and Wellbeing

Kildare's Arts, Health and Wellbeing specialist recently presented to 28 third year nursing and midwifery students, 94 second year medical students and bio engineer students in University College, Dublin (UCD), for their elective modules in arts and health, with a presentation 'But Then Again Once More: A look at Arts and Health in County Kildare.'

Major Infrastructural Projects Contract 2B (Network)

Newbridge Town Watermain Rehabilitation Works

The design for replacement of watermains in Piercetown, Highfield and Pairc Mhuire has commenced.

Kildare Town Watermain Rehabilitation Works

Watermains have been laid in Lourdesville, Claemore Terrace, Assumpta Villas and Campion Crescent. The transfer of services is ongoing.

Timolin Waste Water Treatment Plant (WWTP) Upgrade

The design will be progressed by Irish Water.

Calverstown WWTP Upgrade

Works are now substantially complete. The contractor is now process proving.

Taghadoe to Maynooth Watermain Replacment

Installation works have commenced.

Kilmeague WWTP Upgrade

The contractor is now on site and works are progressing well and due for completion in Quarter 2, 2019.

Newbridge Sewer Relining Contract

Irish Water is appointing a contractor to do these works.

Rathangan WWTP Upgrade

Irish Water has appointed a consultant to prepare the tender documents for this contract. The consultant is currently carrying out survey works and preparing the design.





Environment

Flooding

Catchment Flood Risk Assessment and Management Study (CFRAMS)

Meetings have taken place with the Office of Public Works (OPW) regarding the prioritisation of works. A workshop with the OPW to progress the consultants brief for the Naas study has taken place. The municipal districts will be briefed on the emerging CFRAM Programme.

Langton Road, Newbridge

This scheme is now substantially complete, with final seeding of the green area to take place in March, depending on weather conditions.

Morell Flood Management Scheme

A Judicial Review has been lodged against An Bord Pleanála's decision. Kildare County Council, as notice party cannot commence any works until the review is heard or withdrawn. Efforts are ongoing to resolve issues.

Athy Flood Modeling

Scenarios have been completed,
meaning that the proposed flood
measure can be adopted into the Local
Area Plan (LAP) as part of the
Dominican Masterplan, subject to the
approval of the elected members.
A briefing will be given to the April
meeting of the Athy Municipal District.

Kerdiffstown

An Environment Protection Agency (EPA) Licence was granted on 07 March. Taking possession of properties under the CPO has commenced. Once the advanced works contract is out to tender, the second will be tendered shortly on etenders. Short listing of candidates for the main contract has commenced.

Eadestown Playground

Construction on Eadestown

Newbridge Skatepark, Moorefield Park

All work on the completion of the installation of the new paths, resurfacing of the existing paths, and installation of new public lighting in the new skatepark in Moorefield Park, Newbridge has been completed. The official opening of the facility will take place on Saturday 13 April at 10:00 a.m. with the Mayor of Kildare, Councillor Seán Power.





Bawnogues, Kilcock

Work on the planting of 1,500 saplings is currently underway. This will be complete by the end of the month. A tree planting ceremony in conjunction with The Tree Council will take place on 04 April at 11:00a.m. in the Bawnogues. This is to mark National Tree Week. The project is also part of a partnership between the Tree Council and the Laudato Great Green Wall project, an environmental initiative between Ireland and sub -Saharan Africa to combat the effects of climate change which is increasing desertification across the Sahel, a region to the south of the Sahara Desert. Planting a Great Green Wall of trees 8,000 kilometres long and 15 kilometres deep, through 13 countries

from Senegal to Djibouti will prevent soil degradation and erosion, sequester carbon from the air as well as directly help dozens of local communities. Trees that are indigenous to each area will be planted. It will be a new Wonder of the World, crossing the entire width of Africa and the project will run until 2030.

Tree Planting Programme

160 semi mature trees and 7,000 saplings will be planted at various locations around the county to replace trees that have been removed or planted at new locations in housing estates, parks and open spaces. This should be complete by the end of the month.





Roads, Transportation and Public Safety

Athy Distributor Route

Advance works between Corran Árd and Fortbarrington Road have commenced on site.

Naas Inner Relief Road

The Part 8 application for the proposed Naas Inner Relief Road is on display until 26 March. The closing date for submissions is 10 April 2019. The delivery of a Naas Inner Relief Road has been an objective of Kildare County Council since 1992 and was granted Part 8 planning approval in February 2006. Due to funding constraints it was not possible to deliver the route at that time to complete the inner relief road. Naas town and environs has undergone a considerable increase in population since 1992, with the population of the urban area now circa 21,000. The Draft Regional Spatial and Economic Strategy (DRSE) (as published by the Eastern and Midlands Regional Assembly, 2018), identifies

Naas as a key town providing employment with public transport links. The population forecast for Naas is 30,000 by 2023.

More than 17,000 vehicles currently travel through Main Street Naas on weekdays. Over 90% of Naas households have at least one car while over 94% of households in Sallins have at least one car; both towns have a high car mode share for work and education trips. Kildare County Council secured Local Infrastructure Housing Activation Funding (LIHAF) funding of €4,500,000 towards the costs to complete the Naas Inner Relief Road to deliver the following local benefits:

 Improved access to and a reduction in congestion in Naas Town Centre, facilitating public realm improvements in the town, the redesign of Poplar Square, new and improved footpaths and street furniture,





and the undergrounding of overhead cables

- Completion of the Southern Ring Road around Naas diverting heavy good vehicles from the town centre
- Improved infrastructure, e.g. footways, cycle tracks, and bus bays for pedestrians and cyclists for the existing/new residential population bordering the roadway
- 4. Delivery of the "Minor
 Greenway" as per Greater
 Dublin Area (GDA) Cycle
 Network Plan; improving
 physical fitness levels and
 promoting a non-car based
 future for many of Naas
 residents and the business
 community
- The new road will facilitate the provision of much needed housing and whose lack of delivery would likely restrict further development (beyond

already granted planning permissions) in the environs of the Naas Inner Relief Road. In October 2017, Clifton Scannell Emerson Associates (working on behalf of Kildare County Council) undertook a detailed and extensive route selection process. This involved identifying a suitable study area for the examination of alternative routes, the development of feasible route options and the carrying out of a systematic assessment of those options leading to the selection of a preferred route corridor which would form the basis of a follow-on detailed design. This process also involved taking into account the most up to date road design standards and EU regulations. Further to the carrying out of detailed noise modeling, noise barriers (varying between 1.5 meter and 3.5 meter high), and 2 meter high block walls are proposed at various locations along the





preferred route of the Naas Inner Relief Road (Route 2). All surrounding estates will have full access to the proposed road, new cycle tracks and footways. At Stage 1 of the selection process, eight alternative routes were fully assessed using the Transport Infrastructure Ireland (TII) Project Management Guidelines, based on the criteria of Environment, Economy and Engineering. The result of the Stage 1 analysis was announced to the public at a non-statutory public consultation that was held at Kildare County Council Offices in February 2018. For Stage 2, three routes were selected for a further detailed analysis. In compliance with the Government's Common Appraisal Framework for transport projects and programmes, those routes were examined against the following six multi-criteria categories; Economy, Safety, Physical

Activity, Environment, Integration and Accessibility and Social Inclusion. As part of the analysis, traffic modeling was carried out to determine the best route option. The model was calibrated and validated in line with TII's Project Appraisal Guidelines. Extensive traffic studies were undertaken to take full account of the current traffic volumes throughout Naas. Future traffic growth up to 2035 was accounted for in the modeling process by generating traffic growth profiles based on the predicted growth in population and employment in Naas in the period 2018 to 2035. As outlined in Figure 6.2 and Table 6.4 of the Route Selection Report and in accordance with the traffic modeling, the opening year





Annual Average Daily Traffic (AADT) is predicted to be less than 7,500 vehicles (report available at:

www.kildarecoco.ie/PublicConsultations Part 8 Schemes).

A maximum AADT of 11,278 vehicles is predicted on the proposed road by 2035.

Maynooth North South Corridor, Phase 5 - Leinster Street to Kilcock Road

Final design revisions for Phase 5 of the North South Corridor are being undertaken by the consultant for this scheme. The council intend, that subject to funding approval being granted by the National Transport Authority (NTA), to go to tender in April/May for a July/August construction phase.

Maynooth North-South Corridor, Phase 6 - Moyglare Road Improvement Scheme

The contract for the construction of Phase 6 – Moyglare Road Improvement Scheme has been awarded and construction will commence week beginning 18 March.

Dublin - Galway Greenway

This project is progressing satisfactorily and the council expects to complete the final design and tender documents by May for the Maynooth to Dublin boundary section.

Proposed new Machinery Yard and Regional Salt Barn at Newhall, Naas

The Part 8 application for the proposed new machinery yard and Regional Salt Barn at Newhall, Naas is on display until 26 March. The closing date for submissions is 10 April, 2019.





Provision of Car Parking Management Services

The current parking enforcement tender contract expires mid 2019 and the contract for the provision, installation and maintenance of parking meters expires in quarter 4, 2019. The Roads, Transportation and Public Safety Department is currently drafting a mini competition for managed car parking services with Kildare County Council's Procurement Officer and the Office of Government Procurement (OGP). This tender will be managed by the OGP and the contract, when awarded, will include enforcement of parking services, Provision, installation and maintenance of all parking meters and cash collection services will all be under one contract. It is expected that this tender will be advertised in early Quarter 2, 2019.

R411 Naas to Ballymore Road Realignment

Realignment of the R411 Naas to Ballymore Road has been in progress for the past two months. From 11 February 2019, a full road closure is in place for up to eight weeks in order to allow for the realignment to tie into the existing R411 at each end. Diversions will be in place for the duration of the works. The works are being carried out by Cairn Homes as part of the construction of Oak Park residential development.

Coghlanstown, Ballymore Eustace - Slope Remediation Project

The public consultation process commenced on 05 February, 2019, for the statutory Part 8 process for the Slope Remediation Project at Coghlanstown, Ballymore Eustace. The project documents and drawings will be on display for a period of four weeks from the 05 February, 2019 with the closing date for submissions not later than 5:00p.m. Tuesday19 March, 2019. Newbridge Southern Outer Orbital Route

Work on the construction of the NSORR has been ongoing of a number of months and is being delivered by Lidl Ireland as part of the development of their regional distribution centre.
