## Kildare County Council Services and Arrangements for Council Meetings During COVID-19

The delivery of services by Kildare County Council has had to change significantly in recent weeks and, as required by Government, all Council Offices are now closed to the public until further notice. Council staff are now focused on the delivery of **critical essential services** that must be maintained through this Pandemic. While the offices are closed council staff are available to deal with queries relating to essential services and members of the public are encouraged to make contact by phone and email.

In line with requirements associated with social/physical distancing, and in order to focus efforts on service delivery, the elected members of Kildare County Council decided to cancel all meetings of the council up to and including 05 May. This will be reviewed on a continuous basis over the coming weeks. Despite the fact that the elected members are not meeting in the usual structure, there is continuous interaction between the executive and staff of the council and the Councillors, to ensure that all efforts are on delivering essential services to our citizens and coordinating the community response. Members receive briefings on activities through the Cathaoirleach, SPC Chairs, and Directors of Services. Arrangements for meetings post the 05 May are being considered.

A dedicated community support helpline has been established in Kildare County Council to assist at risk members of the public in accessing non-emergency and non-medical supports and advice during the current public health emergency. The confidential phoneline service established by the new COVID-19 Kildare Community Response Forum includes over a dozen agencies and organisations working with the community. The helpline is focused primarily on ensuring that vulnerable members of the community or those living alone can access deliveries of groceries, medicine and fuels. The role of the Forum is to ensure that there is a coordinated community response and to enable all voluntary statutory agencies to collaborate in support of our communities and particularly of our most vulnerable members.

# Finance and Information Technology

#### **Rent Accounts**

Kildare County Council continues to encourage tenants to make repayments towards their rent every week to avoid going into arrears. It should be noted a "rent freeze" means rent will not increase, not that tenants may stop paying their rent. The council is very sympathetic to the difficulties facing tenants, however, as rent is assessed based on income, a rent assessment form needs to be completed and returned without delay. This can be downloaded on Kildare County Council website: http://kildare.ie/countycouncil/housing/ HousingRents/ alternatively you can request a form by emailing

rents@kildarecoco.ie or phoning the Finance Section at 045 980 654 or the Housing Section at 045 980 705.

As a temporary measure the Finance Rents Team may discuss the tenant's new financial situation over the phone before estimating and agreeing a rent payment according to the revised circumstances of the tenant. If a tenant under declares their income during this estimate process, this will

need to be promptly addressed by the tenant once the Housing Section has completed the Rent Assessment.

The current rent charge continues to accrue until the Rent Assessment is done by the Housing Section and any revised rent charge will then be back dated to reflect the changes in circumstances, as Finance are only agreeing a temporary change to rent payment.

Tenants can estimate the change to their rent on-line, however, they need to make contact with the Finance Rents Department before changing their payment - the schedule of rents can be downloaded at:

http://kildare.ie/countycouncil/housing/ HousingRents/ The primary income should be identified on the schedule of rents and the corresponding rent is the base rent. €10 should be added for every additional earner in the family and €1.50 deducted for each child under 18.

# Local Authority Rent Accounts - Update as at 17 April 2020

There are 4,422 local authority rent accounts in Kildare County Council.

Since the beginning of this emergency:

- Housing have issued over 300 rent assessment forms (based on enquiries received); Finance have issued a further 46
- Finance have agreed 81
   reduced payments based on

advise borrowers to continue to pay as much as they can afford.

Revised repayment arrangements will only be agreed by submitting proof of reduced financial circumstances, for example, a letter from an employer/proof of payment from Department of Social Protection.

# Mortgages - Update as at 17 April 2020

Circular 9 2020 issued on 10 April 2020 and provides guidance on the approach to local authority mortgages. Kildare County Council has 470 borrowers with housing loan accounts.

To date, 30 borrowers have requested a reduced payment plan:

- 3 Rebuilding Ireland Home Loan borrowers
- 7 converted shared ownership borrowers (i.e. these were originally shared ownership loans, but have recently converted to standard annuity)
- 2 affordable loan borrowers





- 13 shared ownership loan borrowers
- 5 standard annuity loan borrowers (HPLs)

The reduced payment agreements (borrowers must continue to pay MPI), whilst a short-term practical solution, is likely to cause difficulties and adversely affect the good progress being made with the council's Housing Loan collection rates. They will also have negative effects on borrowers as the borrowers need to make up the shortfall within the term of the loan — i.e. repayments will be increased.

#### **Rates Accounts**

Procedures are now in place to deal with the Deferred Rates Payment announced on Friday, 20 March by Minister Murphy, and re-iterated by Minister Donohoe on Tuesday 24 March. For clarity - there is no rates alleviation scheme involved at this stage, simply the ability to defer payments for a period of 3 months.

Customers who would like their direct debits to be deferred must e-mail <a href="mailto:rates@kildarecoco.ie">rates@kildarecoco.ie</a> and the following direct debit will be amended. Kildare County Council is dependent on

customers advising them of the need to defer direct debits as there is a requirement for advance notice of 14 days for Kildare County Council to make any changes.

# Rates Accounts - Update as at 17 April 2020

Kildare County Council has 5,092 rates accounts.

#### To date:

 192 have requested a deferral of between 50 and 100% for three months

It will however be May before the council properly see the effect of the closures of businesses and the actual deferrals as customers can cancel their standing orders and direct debits directly with their bank without advising the council.

#### **Accounts Payable**

The Accounts Payable Team is working with all sections in Kildare County Council to ensure payments to suppliers continues to be made within the usual timescales.

Payments continue to be processed and are being made within the timescale agreed.

# Housing

## **Update on COVID-19 Measures**

The three areas identified by the Local Government Management Agency (LGMA) as critical services in the Housing Department are set out below:

- Homeless Services
- Housing Assistance Payments (HAP)
- Traveller Accommodation

#### **Homeless Services**

Engagement with the Mid East
Regional Homeless local authorities
(Meath and Wicklow) and the HSE is
ongoing, in addition to weekly
engagement with the Housing Agency
and Department of Housing, Planning
and Local Government (DHPLG).

Kildare County Council has made provisions for accommodation in the event that homeless clients require to self-isolate and/or members of the traveller community who reside in caravans/mobile homes, and the requirement to self-isolate arises.

The council are working with their service provider, The Peter McVerry Trust (PMVT), and 10 units from

Kildare County Council stock have now been set aside and are fitted out for the purposes of temporary isolation (one and two bedroomed accommodation and two houses).

A further 10 units have also been refurbished and are now available for use as isolation units should they be required for this purpose or for general allocation.

The units are being managed by PMVT in consultation with the HSE. All of these isolation units will be returned for allocation to social housing applicants when the COVID-19 period has ceased. The council is also engaging with Kildare Civil Defence to provide support if necessary.

An appointment-only presentation system is being operated for those who are homeless or likely to become homeless. Private Emergency Accommodation Services are operating as normal and the Supported Temporary Beds and Family Hubs are also operating.





# Housing Assistance Payments (HAP) COVID-19 Update

The Housing Assistant Payment (HAP) and Homeless HAP Sections, assisted by the Rental Accommodation Scheme (RAS) Section, continue to accept and process HAP applications. Priority is being afforded to homeless HAP cases. The council are receiving a large volume of calls from HAP tenants experiencing reduced income, such tenants are entitled to apply for a rent review (please see further information under the heading of rents).

The following new legislative measures are now in place:

- Any rent increase which was to take effect during the emergency period will no longer take effect
- Any notice of termination which was to take effect during the emergency period will no longer take effect

## **Traveller Community**

The COVID-19 emergency has identified travellers as an at-risk group and additional funding has been made available for the provision of basic

welfare services such as water and sanitation.

Following an assessment of Kildare
County Council halting sites and
roadside families, no additional needs
were identified on the Kildare County
Council sites. One roadside
encampment was deemed as in need,
and basic services have been provided
on this site for the duration of this
emergency period.

The social work team are maintaining daily contact with traveller families particularly those who may be at risk or vulnerable. An information pack has been prepared and circulated to provide information on social distancing and traveller support groups.

#### Other COVID-19 Related Issues

#### **Rent Reviews**

Due to the employment losses and changes in working situations, a significant number of tenants have requested rent reviews. This work is carried out by the Traveller Accommodation Team who have been deemed essential staff, therefore this work should progress over the coming



weeks. COVID-19 reviews will be prioritised. To date 175 review forms have been received, however the council expect this to increase significantly as in excess of 300 forms have been issued by the Housing Section. Tenants are also accessing forms directly online and from Customer Services and the Finance Department.

**Rent Supplement** 

The following information has been provided by the Department of Social Protection regarding private renters who do not qualify for the housing list, are not in receipt of HAP and are experiencing difficulties meeting rent payments:

Changes are being made to Rent Supplement to relax some of the rules and a new form will be issuing shortly. Rent Packs are available at reception in the Intreo Centre in Newbridge, if a customer cannot attend the office it can be posted to them. One of the main changes is customers applying for Rent Supplement will not be referred to the local authority for a Housing Needs Assessment until after the COVID-19 emergency.

## **Response Maintenance**

Response Maintenance is providing an emergency response service only.

Emergencies and urgent requests include the following:

- Any electrical issues
- Plumbing including heating, boilers, leaks, shower not working, no water supply
- Blocked sewers
- Locked out of house
- Exterior doors that will not open or close
- Fallen boundaries or trees
- Major roof repairs
- Fire damage

# Public Private Partnership (PPP) Bundle 1 Site at Craddockstown

Works are currently suspended due to Government direction regarding construction work. The last reported programme completion date was mid-April but this site is running a number of weeks behind. The Allocations Team has completed its work for this development. A letter has been issued by the Chair of the Project Board for PPP Bundle 1 to the Housing Agency requesting that the site at Craddockstown is designated an essential site to allow this site to reopen. Designation was received on Friday, 17 April and relates to 36 of the 74 units to be completed by 29 May 2020.





# PPP Bundle 2 Site at Nancy's Lane, Clane

Works have currently been suspended due to Government direction regarding construction work. The programmed completion date is April 2021.

All other capital projects at design stage are progressing with staff working from home and liaising with the Department of Housing, Planning and Local Government (DHPLG).

A number of Stage submissions have been lodged with the DHPLG.

## **Part Vs and Turnkey Developments**

Units in developments which have Irish Water, ESB, and where relevant, Gas connections and only require minor snagging are progressing to completion with permission from Kildare County Council to contractors to complete this work.

#### Grants

DPG projects are only progressing where works are necessary to allow a tenant to return home from hospital. Housing Aid Grants (inspections) are currently suspended. Basic inspections of Housing Aid Grants commenced again from Monday 20 April to allow grants to be drawn down.

# **Library and Arts Service**

## **COVID-19 Impacts and Innovations**

Following public health advice in relation to the global pandemic, all public libraries have been closed since Friday 13 March and will remain closed until further notice.

The council's online library services remain open 24/7, including eBook, eMagazine, eComic & eAudiobook lending, music streaming, online educational courses and language learning. Libraries Ireland have simplified online membership to enable easier access for the public to online services due to the COVID 19 emergency. As expected, usage of eServices has increased dramatically during this period and Libraries Ireland have added 5,000 new titles to the national online catalogue to address the demand. In Kildare, online courses have increased, with 200 new registrations, online language learning has increased by 280% and online newspaper access has increased by 250%. Library staff have been promoting these services in local papers, on local radio and on social media.

#### **Online Events**

Library staff have been working with facilitators to move events to an online environment. In April events are being delivered online via a mixture of zoom classes and recorded videos.

This includes yoga suitable for families, aiming to give them the tools to cope with everyday challenges as well as exceptional ones, in a fun and engaging way. Also chair gym sessions for people of all ability levels with exercises that can be done using bodyweight and household objects.

As part of the STEAM programme the Library Service has organised online coding workshops for teens and a series of online environmental workshops for children for Biodiversity Week.

Art classes are being provided for children and adults with Florence and Milly.

As part of the Toys, Technology and Training (TTT) Programme 2020, which supports children and adults with learning difficulties, disabilities or more significant needs, facilitators have been using mixed media to



deliver their talks/ workshops via the council's social media platforms.

These include an informative session from Dyspraxia/DCD Ireland on 'Primary School and Dyspraxia,' behavioural therapy presentations by Ms Audrey Cully on Autism Spectrum Disorder (ASD) and visual strategies and self-management. A webinar series from CAINT speech and language therapy featuring an Introduction to language development, prelinguistic skills, promoting play and language development. There will also be an upcoming talk on Attention Deficit Hyperactivity Disorder (ADHD) by ADHD Ireland, and further online sessions on various topics to follow.

As part of the Let's Talk About
Parenting Programme, online classes
with first aid for everyone are taking
place in support of parents working
from home.

## **Spring into Storytime**

The annual Spring into Storytime
Programme has moved online this
year and runs from 01 April to 30 May.

Kildare library staff have been producing and posting story time sessions for the council's social media

platforms with daily events on the library Facebook page at 2:00 p.m. and 2:30 p.m. on the library Instagram page.

Kildare Library Service is collaborating with the Riverbank Arts Centre in an online event with Ms Sarah Crossan, Laureate na nÓg on **National Poetry Day**, 30 April. The event will take place on the Laureate na nÓg Instagram page.

## **Better Basics, Boosting Reading**

The end of year celebration for the children taking part in this reading programme 2019-2020 has been rescheduled due to the Covid-19 emergency. We hope to host the event later in the year.

#### **Library Blog**

The Library Service has launched a new blog with lots of book reviews, interest pieces and recommendations, highlighting titles available through the council's online services and more. Library staff have also produced craft and gardening videos.





### **Library IT**

Due to the sudden demand for remote working capabilities, the library service deployed all its public lending laptops to Kildare County Council's IT Section for distribution to essential staff.

The Library Service was delighted to loan its 3D Printers to Surfbox, who have been working to manufacture protective face shields for front line health care works.

## **Kildare Community Call Helpline**

The helpline is up and running with support from library staff who are answering calls, texts and emails from 8:00 a.m.- 8:00 p.m., 7 days a week. The service is designed to meet the needs of vulnerable people in Kildare by linking them to supports in their community. Library staff are triaging the calls and emails and referring the cases to the Community Team when required.

Library staff who are working remotely have been utilising library communication tools to promote key health and social guides from the HSE and Kildare County Council.

### **Naas Capital Project**

The final stage 4 has been submitted to the Department of Rural and Community Development (DRCD) and the Library Service is awaiting a response in order to progress the appointment of a contractor.

# Local Studies and Archives Decade of Commemorations

The Local Studies and Archives
Department of the Library last month
acquired a unique ledger originally
from Hennessy's Garage in
Castledermot which dates from 19201928. It provides an insight into the
socio-economic life of South Kildare
during this tumultuous period in Irish
history.

The Local Studies and Archives
Department continue to add free
digitised content to
www.kildare.ie/ehistory including
historic postcards, long out of print
publications, historic newspaper
articles and essays.

The County Kildare Decade of
Commemorations Facebook and
Twitter pages continue to promote the
history and heritage of County Kildare.
Material relevant to the Decade of
Commemoration events such as the



cancellation of Punchestown in 1920, the County Council elections of June 1920 and other events which took place between 1912 and 1923 will be added to <a href="https://www.kildare.ie/ehistory">www.kildare.ie/ehistory</a> and social media pages also.

The Local Studies, Genealogy and Archives Section continues to answer research queries, although staff are currently working on the Community Call helpline so the family history/genealogy queries can be sent to cilldaragenealogy@gmail.com\_and local history research queries can be emailed to localhistory@kildarecoco.ie or a message can be left on 04544835.

Historic Artwork Commissioned to Commemorate 'Squires' Gannon, Kildare, First Captain to Lift the Sam Maguire Cup

Following an extensive selection process, Kildare County Council have announced that Mr Mark Richards, FRSS has been commissioned to create a permanent artwork in Kildare Town to commemorate Mr William 'Squires' Gannon who captained Kildare to win the 1928 All-Ireland football final. 'Squires' was the first captain to raise the Sam Maguire

Cup which is the most treasured trophy in Irish sport. It is expected that the artwork will be installed early in 2021, coinciding with the extensive refurbishment of the Square. Mr John Horan, GAA President, commented: 'from 1928 to 1987, the original Sam Maguire Cup was presented to 54 captains from 12 different counties. It is the dream of every captain to lead his county team to victory in the All-Ireland final. I wholeheartedly welcome the announcement of this statue in honour of a wonderful Irishman and look forward to its installation.' Mr Mark Richard created the definitive sculpture of Antarctic explorer Mr Ernest Shackleton, located near his birthplace in South Kildare in 2016.

The Square in Kildare Town has already had an artistic boost this year, with the refurbishment of Brigid's Flame in Kildare Town, to include an elegant domed glass 'flame' acorn. It was created by the artist Mr Alex Pentek, who was originally commissioned to make the artwork.





# Arts Grants 2020 - Delay in Adjudication

The Arts and Cultural Sector has been badly affected by the COVID-19 crisis and the Arts Service Team is committed to delivering Kildare's Arts Grants and Awards 2020 to provide much needed support to the sector. ## **Update COVID-19**

All construction work has ceased as of 30 March 2020 due to COVID-19 restrictions.

# Contract 2A (Newbridge Eastern Interceptor Sewer)

The contract was signed by Irish Water and Roadbridge on 20 February 2019 and it has a 24-month construction programme. Works are progressing well on site. Murphy International Ltd., on behalf of Lidl (subject to an Irish Water agreement), is laying part of the Newbridge Eastern Interceptor Sewer along the route of the Newbridge Outer Orbital Relief Road between the dual carriageway and the Great Connell Road. These works are now substantially complete. All construction work ceased on 30 March 2020 due to the COVID-19 restrictions. All sites have been secured and plant demobilised to the main site compound.

## Contract 2B (Network)

The contract was signed by Irish Water and Coffey Construction Ltd on 08
August 2019 and it has a 30-month construction programme. Works commenced on site in September 2019 and are advancing well. All construction work ceased on 30 March 2020 due to COVID-19 restrictions. All sites are being/have been secured and plant de-mobilised to the main site compound.

# Osberstown Sludge Treatment Facility DBO Contract Variation

Veolia Water Ireland is advancing works on this variation to the Design Build Contract (DBO) contract, with an expected completion date in Quarter 2/3, 2020. All construction work has ceased as of 30 March 2020 due to COVID-19 restrictions. Operational commissioning is continuing the THP Plant.





### Osberstown Wastewater Treatment Plant (WWTP)

The upgraded Osberstown WWTP was handed back to Irish Water/Kildare County Council operations in January 2020.

#### **Maynooth Transfer Pipeline**

This project involves the upgrading of the existing Maynooth Sewerage Pumping Station and the construction of a new sewerage pipeline along a new route from the pumping station to the Leixlip Wastewater Treatment Plant. This project is at planning and design stage. Irish Water has also commenced engagement with landowners as part of the land and wayleave process.

#### **Capital Projects**

## Kilmeague Waste Water Treatment Plant (WWTP) Upgrade

The plant was commissioned in late
September 2019. Following completion
of the process proving period the plant
was handed back to Irish
Water/Kildare County Council
operations in January 2020.

### Allenwood Sewerage Network (Vacuum System) Modification

Irish Water's consultants are reviewing the Design Review Report and preparing new land acquisition/wayleave maps for the project to facilitate the construction of a new pumping station.

#### **Timolin WWTP Upgrade**

This project is being assessed by Irish Water Asset Planning under the National Certificate of Authorisation Programme (NCAP) process and a site assessment report is being finalised by Irish Water's consultants.

#### Rathangan WWTP Upgrade

This project will now have to be progressed as a Capital Scheme rather than through operations.

**Silliot Hill, Kilcullen:** Monday to Friday, 8:00 a.m. to 3:45 p.m. Both sites will be closed at weekends until further notice.

For the safety of staff and the public in preventing the spread of COVID-19 the following measures will be in place: contactless card payments should be made, where possible, the public should assist staff in complying with social distancing guidelines when using the facilities and minimise their visits to both locations

#### **Bottle Banks**

A number of recycling bank facilities are closed to the public, as the GAA and other sporting groups have been asked to close their facilities. # Catchment Flood Risk Assessment and Management Study (CFRAMS)

Meetings have taken place with the Office of Public Works (OPW) regarding the prioritisation of works. A Steering Group with the OPW has been established to progress the consultants brief for schemes within

Kildare. The municipal districts will be briefed on the emerging CFRAMS Programme.

#### **Morell Flood Management Scheme**

A Judicial Review has been lodged against An Bord Pleanála's decision. Kildare County Council, as notice party cannot commence any works until the review is heard or withdrawn. Efforts are ongoing to resolve issues. Progress is being made.

#### **Athy Flood Relief Scheme**

The Kildare County Council/OPW
Steering Group has started developing
the scope of the Athy Flood Relief
Scheme. The first stage will be the
procurement of consultants to carry
out the design of the scheme.

#### Hazelhatch

The contract for a further hydrological study into flooding at Hazelhatch has been awarded to RPS Ireland. The study is due to be completed in Quarter 2, 2020. The revised mapping will be used by the OPW to update flood extents in the catchment.





#### Naas Flood Relief Scheme

Tenders have been received for consultancy services for the Naas Flood Relief Scheme. Assessment of these tenders is ongoing. The first stage of the scheme will be a review of the existing hydrology and mapping. Consultants are to be appointed in Quarter 2, 2020.

#### Kerdiffstown

Currently all works are paused due to the COVID-19 Pandemic save for a security presence to secure the site. The council's team will continue to monitor the site remotely and only attend the site if essential. Leachate levels were brought down to a low level in anticipation of the lockdown, however tankering may need to resume next week subject to weather conditions. The flare is operating normally and has been serviced recently so there should be no odour issues as a result. The Community Liaison Group have been notified and contact details have been given to them. The tender process for the main works contract for the project is nearing conclusion, with tenders to be submitted on 17 April.

#### Cemeteries

#### **Churchtown Cemetery**

Public lighting is to be commissioned with the ESB subject to a funding agreement.

#### **Kildare Town Cemetery**

The updated design for upgrade works is under consideration. It is anticipated that works will commence in late Quarter 2, 2020.

#### **Newbridge Cemetery**

Following the tender assessment, it is hoped to commence works on car park improvements in late Quarter 2, 2020.

#### **Columbarium Walls**

#### Derrinturn

Following tender, a contractor will be appointed shortly.

#### Crookstown

It is hoped to begin construction in Quarter 3, 2020.

## Eastern and Midlands Climate Action Regional Office (CARO)

A sectoral training plan is now being rolled out. The following packages are now at tender stage:





- Elected members and senior staff (following pilots in Kildare and Monaghan County
   Councils) – tenders issue this week and the date for receipt of tenders is 28 April.
- Climate Action Team (3-day intensive course) - courseware has been developed and is now subject to peer review. Pilot sessions planned for April have been cancelled due to COVID -19 restrictions.
- The Environmental Services
   Training Group (ESTG)
   Conference on Climate Action in Local Government has been cancelled due to COVID-19 restrictions.

Other relevant issues are as follows:

- All Sub Regional Working Group meetings have been cancelled due to COVID -19 restrictions
- Work on developing sectoral level KPI's to be piloted in the Eastern Midlands Region is ongoing.

#### **Kildare Climate Action Team**

A second meeting of the (reconstituted) team took place on 28 February 2020. The following key tasks were prioritised:

- Driving the 121 actions for the Adaptation Strategy
- Initiating a climate awareness day within the organisation

Shortlisting has taken place for the position of a Climate Action Officer. The closing date for applications for Energy Efficiency Officers was 19 March 2020. The new Climate Action Strategic Policy Committee (SPC) held its first meeting on 11 March 2020. Progress was made with three Kildare Sustainable Energy Communities (SEC's) (Clane, Maynooth and Kilcullen) who are due to receive approval from the Sustainable Energy Authority of Ireland (SEAI) to complete Energy Master Plans. Work is ongoing to support others such as Monasterevin and Naas SEC's.

The Environment SPC met on 11 March 2020.





#### **Tidy Towns Network**

A Tidy Towns Networking event took place in Áras Chill Dara on 03 March. There was a large turn out from the County Kildare Tidy Towns Network members, who were welcomed by the County's Tidy Town's Ambassador, Mr Johnny Doyle. Presentations were made by Dr Fiona MacGowan and Dr Christy Boylan.

#### **New Initiatives**

#### **Green Kilometre Scheme 2020**

Fifteen groups have signed up to this scheme so far in 2020 and a total of 800 saplings have been planted by these groups this year. A community-based litter removal scheme for rural areas has also become a good biodiversity project with native species such as holly, hazel, spindle and alder buckthorn being planted into Kildare hedgerows. It is hoped the scheme will gain momentum over the course of the year.

#### **Civic Amenity Site North**

The Part 8 has been approved by the Celbridge-Leixlip Municipal District Committee. The council is in the course of putting together an expression of interest invitation for a Concession/Public Private Partnership (PPP) type contract.

#### **Dog Pound**

The dog pound extension and upgrade works are now complete. The facility is now fully reopened. Public access is by appointment.

#### Rathangan Public Realm

The Part 8 will be published as soon as the COVID-19 restrictions are lifted.

#### Kilcullen Public Realm

The Part 8 will be published when the COVID-19 restrictions are lifted.

#### Monasterevin Public Realm

This is now progressing to the next stage of design. A second round of public consultation is to be arranged once the COVID-19 restrictions are lifted.

### Public Realm Upgrade for Kildare Town

The Part 8 in respect of The Square (first phase) has now been prioritised (a traffic plan needs to be progressed to facilitate phase 2).





### Public Realm Upgrade for Newbridge

A working draft has now been completed and was presented to the Kildare-Newbridge Municipal District Committee. It is proposed to progress to a further round of public consultation before progressing to the next stage of design.

#### **Management of The Curragh Plains**

The tender for consultants closed on 12 March 2020. The tender assessment will be carried out jointly between Kildare County Council and the Department of Defence.

#### The Barrow Blueway

A Project Team has been established.



#### **Parks**

#### COVID-19

All playgrounds, outdoor gyms and skateparks remain closed for use until further notice. All park users are requested to continue to observe the social distancing guidance when accessing parks and open Spaces. The maintenance of parks and open spaces continues as part of essential services. This includes grass maintenance and litter control.

#### **Open Space Strategy**

Work on the procurement of consultants to develop an open space for the county is ongoing and it is hoped to have a tender of the work advertised by the end of the month.

#### Summer Bedding Leixlip Village

A contract for this work has been awarded. It is hoped to have the bedding in place for early June.

### Bawnogues Athletic Track Improvement Works

Sole Sports have been appointed as contractors to carry out the improvement works in The Bawnogues. This will involve the installation of synthetic sprint lanes, long jump and high jump area. New lighting, drainage of the infield area and the relocation of the steeplechase pit are also part of the work. A start date for the work is subject to the relaxation of COVID-19 working restrictions and when the contractor can schedule the work.





# Economic, Community and Cultural Development

#### **Community Grants**

This is a dynamic situation and the council are considering how best to process grant applications considering current restrictions under COVID-19.

#### Kildare Fáilte

#### **Key activities March 2020**

The Chief Executive Officer of Kildare Fáilte, Ms Mangan attended a Twinning Group event and presented tourism plans for County Kildare in the chamber, Áras Chill Dare. Great interest was shown in relation to tourism in the county and a Q & A session took place after the presentation.

Kildare Fáilte organised a meeting in partnership with Kildare Village for Kildare-based attractions to establish an interest towards creating a web cluster of attractions. The event was a great success and it was attended by over 20 people - 16 attractions, with 8 other parties interested.

Communication was made via the minutes of the meeting which were distributed to all the interested parties. A follow-up meeting will be held after the lockdown for COVID-19 is lifted.





Kildare Fáilte met and directed the Taste of Kildare volunteer committee in planning for the event in September 2020 at the Mahon's Boardroom.

AGM communication was sent out to members to postpone the event due to COVID-19. Notice to postpone the networking and communication event was also sent out.

Kildare Fáilte rolled out a social media competition to find a new Chief Experience Officer for Kildare Fáilte.

Ms Joanne Byrne was appointed on 12 March as the new Chief Experience Officer, whom Ms Mangan the Chief Executive Officer met for a photo shoot.

An ezine was sent out to all members of Kildare Fáilte regarding dealing with COVID-19 and detailing supports which are available. Also, Kildare Fáilte were directly in touch with members through a phone conversation to better understand the situation they are in and to ensure the organisation is working on a strategy to keep things moving and to keep County Kildare on the forefront of people's minds. This is ongoing. A press release was created and published on the <a href="https://www.intokildare.ie">www.intokildare.ie</a>

website regarding COVID-19. In addition, an updated list of members and their revised opening hours was created.

Social media activity was increased in March due to COVID-19 highlighting the outdoors and beautiful scenery of Kildare to keep it at the forefront of people's minds. Various blog posts were created to keep people engaged, including general knowledge quizzes of Kildare, and also highlighting Kildare businesses that are open for 'click and collect' food services. All these items received very high engagement rates through the social media channels.





# Local Community Development Committee (LCDC)

The last Local Community

Development Committee (LCDC)

meeting was held via teleconference
on Wednesday 25 March 2020.

### COVID-19 Community Response Forum

The LCDC played a pivotal role in establishing, supporting and informing the Kildare COVID-19 Community Response Forum. The purpose of the forum is to lead the co-ordination of COVID-19 community supports and resilience. The forum has had three meetings to date via teleconference. A dedicated Covid-19 support helpline was established on 30 of March by Kildare County Council and operates from 8:00 a.m. to 8:00 p.m., 7 days a week.

#### **Healthy Ireland**

The Healthy Ireland project partners are making great progress given the COVID-19 restrictions they are working under. They are running a wide range of online activities from work out classes from home to

movement programmes for older people and those with limited mobility.

A positive mental health video series is underway, a physical activity booklet for older people will be circulated by post and a physical literacy animation video for children is being developed.

## Social Inclusion Community Activation Programme (SICAP)

Work is progressing to roll out the SICAP Programme in Kildare under COVID-19 restrictions. County Kildare LEADER Partnership are the programme implementers and will report progress at the next LCDC meeting.

#### Heads-up (Mojo)

All current participants and those from other programmes are being supported by regular phone calls and zoom. Staff are uploading resources to the Facebook page to promote positive mental health. A Be Well pack is distributed weekly to current and some of their past participants.





### **Rural Development LEADER**

Work continues to promote and support applications to the LEADER Programme. Seven applications were approved at the last LCDC/LAG meeting.

#### **Public Safety**

# M7 Widening, Osberstown Interchange and Sallins Bypass Project

SIAC Construction Ltd/Colas Ltd. is the contractor. The contractor has opened 3 lanes both eastbound and westbound from Junction 8 Johnstown to Junction11 (M7/M9 merge). Works continued the Newhall and Osberstown Interchanges and the R407 Sallins Bypass until further restrictions were announcement by the Taoiseach, Mr Varadkar on 27 March 2020. The site is now closed until further notice and the contractor is maintaining the security and traffic management on the site.

#### M4 Maynooth to Leixlip

The 'M4 Maynooth to Leixlip' is listed as a section of the transport network to be progressed through pre-appraisal and early planning and prioritised for delivery under the National Development Plan 2018–2027. The aim of the project is to assess the needs of the M4/N4 mainline corridor and junctions from Maynooth to Junction 5 Leixlip in terms of catering

for future demand from a capacity, safety and operational perspective.

The project is currently in the early stages of Phase 1, Concept and Feasibility (see image below), Arup have been appointed as technical advisors to support the delivery of the project through Phases 1 to 4. These Phases include:

- Phase 1 (Concept and Feasibility) which would determine if an intervention (project) is required and if an intervention is feasible.
- Phase 2 (Option Selection)
   would examine feasible options
   for intervention that could
   address the aim of the project.
- Phase 3 (Design and Environmental Evaluation)
   would develop the design of the preferred option from Phase 2





for further assessment including evaluation of environmental impacts; and Phase 4 (Statutory Processes) would include undertaking the Statutory Processes

As highlighted, the project is currently in the early stages of Phase 1 (Concept and Feasibility) and will take a number of years to pass through the various steps required for Phase 1 (Concept and Feasibility), Phase 2 (Option Selection), Phase 3 (Design and Environmental Evaluation) and Phase 4 (Statutory Processes), provided it successfully progresses through each Phase.

Due to the recent announcements for restricted movements the design team for the N4 Maynooth to Leixlip upgrade scheme have been working remotely and continue to progress Phase 1 of the scheme.

### Maynooth Eastern Relief Road and Bridge

The preferred route option, (C), was presented in committee to the Maynooth Municipal District Committee on 05 April 2019. The Clane-Maynooth Municipal District Committee confirmed approval of the Part 8 in respect of Option C on 29 July. Detailed design and CPO preparation stages are now underway.

The next phase of the project will be the completion of design and procurement of the main contract. However, Kildare County Council is currently endeavoring to gain control of the lands (identified under the Local Infrastructure Housing Activation Fund (LIHAF) Scheme as a prerequisite to the contract going ahead. The preparation of CPO documentation is near completion and the documentation for the procurement of valuers is under way. Discussions are ongoing with landowners, the LIHAF, Irish Water, Waterways Ireland and larnród Éireann. The procurement of a NOBO consultant (an independent consultant to assess adequacy of the proposed design in relation to the EU Interoperability Directive) is currently under way.





#### **Athy Distributor Route**

An Bord Pleanála's approval issued on 11 October, 2017. A Notice of Confirmation for the Athy Distributor Road was published in the Nationalist and Leinster Leader 28 November 2017. No objections/Judicial Reviews were received by the deadline on 23 January 2018. €3 million was included in the Department of Transport, Tourism and Sport (DTTAS) road grants 2019 for this project. Notices to treat have been issued. Notice of entry on lands has been issued. Advance works between Corran Ard and Fortbarrington Road have been completed. The railway abandonment is complete. The removal of the rails and sleepers is complete. The Córas Iompair Éireann (CIE) lands have been secured form trespass and the main contract commenced tender on 25 March. The procurement is under the restricted procedure and involves a two-stage process. The first stage return will be due at the end of May. The consultants are currently focused on document preparation for Stage 2 and dealing with queries for stage 1. The agreements with CIE and Waterways Ireland are a necessary pre-requisite to commencement of construction and are being

progressed. Land acquisition is also progressing. The team are currently closing out archaeology before the main contract is awarded. Work to achieve a Bridge Agreement with larnród Éireann continues with the submission of various technical reports. The following procurements are currently under way:

- Main Contract,
- Category 3 check by independent consultant

#### **Maynooth Inner Relief Street**

Moyglare Road to Dunboyne Road:
Planning approval was issued by An
Bord Pleanála to Cairn Developments
Plc. Works are progressing well and
the road is expected to open in
Quarter 2, 2020.

#### **Newbridge Outer Orbital Route**

Naas Road to Great Connell Road
Newbridge: Construction has
progressed well to date. The estimated
completion date is Quarter 2, 2020.





### Northern Link Street and South Green Area Access Improvement Scheme (Kildare Town)

The route selection process is ongoing and consultation with larnrod Eireann has commenced regarding the design of an upgrade/replacement bridge over the railway. A briefing was delivered to the Kildare Newbridge Municipal District Committee on 12 June. A non- statutory Public Consultation was held on 18 June at the Kildare Education Centre. All submissions received have been considered and the Route Selection process will reach a conclusion in Quarter 2, 2020. The project is unlikely to proceed to statutory procedures until the Kildare Town Transport Strategy has been completed due to the reservations of Kildare-Newbridge Municipal District Committee.

#### **Naas Municipal District 2020**

With the current COVID-19 restrictions, the Naas Municipal District outdoor crew are available for winter maintenance, emergency and street cleaning works. The crews have also been informed of potential requirements in assisting the "Community Response" helpline.

#### Roads, Footpaths and Drainage

The Naas Municipal District has developed a programme of works for roads, drainage, footpath and low-cost safety improvement works for 2020. This is based on funding made available to the Naas Municipal District. These works will be developed to construction stage in the coming months (subject to the current COVID-19 restrictions being removed).

### Local Property Tax (LPT)/Carpark Funded Works 2020

The LPT/Carpark funded road works programme for 2020 has been agreed by the Naas Municipal District Committee. These works will be developed to construction stage in the coming months (subject to the current COVID-19 restrictions being removed).

#### **Works Ongoing**

The footpath/cycle track extension on the Kilcullen Road, Naas (at Kilashee) to the multi-denominational school is currently at construction stage. This is being funded by LPT monies. The works are substantially complete and contractors are off-site due to the COVID-19 restrictions.



Three bus shelters are being constructed in the Naas Municipal District. One in Johnstown Village and two on the Newbridge Road, Naas (near Sheehy motors). Works commenced but were stopped due to the current COVID-19 restrictions. A contract has been awarded for footpath improvements to Sarto Park, Naas (Canal Walk). The construction works have not commenced due to the current COVID-19 restrictions.

**Kildare Civil Defence** 

Kildare Civil Defence as a Voluntary
Emergency Service has been working
to support the response of the local
authority and the HSE as requested
and where the requests fall within the
Civil Defences ability and training to
deliver. Some of the supports
provided to date include food delivery
to vulnerable communities and support
to the Blood Transfusion Service in
their local clinics

#### **Fire Service**

All Kildare Fire Stations remain available. The service has a Business Continuity Plan which outlines the specific risks and control measure that are necessary to ensure continuity of service during the COVID-19 crisis.

The senior officers within the service have been working in conjunction with the other senior managers across Kildare County Council to develop business continuity arrangements for the wider organisation.

#### **Building and Development Control**

The Building and Development Control Section has been identified by Government as an essential service and the staff in this section have been ensuring that the BCMS system continues to be monitored and responded to. Fire Safety Certificate and Disability Access Certificates continue to be received and processed. Currently the section is only accepting these applications by post as all public counters are closed and electronic applications are not being processed.

### 1. Financial Supports Business Continuity Voucher -

Businesses may also be eligible for a Business Continuity Voucher worth €2,500. This initiative provides advisory specialists in fields including finance and HR to help develop a lean, robust business strategy as enterprises face an extended period of great uncertainty. As of 20 April, three weeks into the launch of the initiative, 152 Kildare businesses





have availed of the voucher.

#### **MicroFinance Ireland Loans**

Changes have been made to the MicroFinance Ireland loans available through the LEO Kildare. The maximum loan available through the programme has been doubled to up to €50,000 as an immediate measure to deal with the impact on micro-enterprises. The interest rate for loans has been reduced from 6.8% to 4.5%. The LEO are working with clients on applications to expediate the process. The LEO has processed 11 applications. • Trading Online Voucher

The Trading Online

Voucher provides funding of up
to €2,500 towards improving
online training capabilities. This
scheme is crucial at this time as

it allows businesses to bring their business online. Recent expansions to this support mean that now, businesses who previously benefitted from the Trading Online Voucher Scheme can apply for a second voucher of up to €2,500. Another significant expansion to this support is that co-funding is available for 90% of eligible costs up to the maximum of €2,500 where in the past co-funding was 50%.
