That of the homes available for allocation in 2022 in Kildare that the Housing department work with domestic violence service providers to develop a system for the allocation of a specific number of units in each Municipal District to use as transitional accommodation units for families seeking to flee domestic abuse situations and that the housing allocations policy be amended to acknowledge the exceptional needs of



applicants seeking accommodation transitioning from refuge centres.
