#### Communications

Kildare County Council welcomed the latest phase in the reopening of the tourism and hospitality sector, the return of outdoor dining for hospitality businesses across the county.

Photocall with Cathaoirleach and Mayor of Naas Municipal District, to welcome the reopening of outdoor dining and highlight the pilot outdoor projects.

Kildare County Council's Local
Enterprise Office has been supporting
tourism and hospitality businesses
across Kildare with the rollout of the
outdoor seating and accessories grant
scheme. Hotels, restaurants, cafes,
public houses and attractions have
been availing of financial supports of
up to €4,000 to purchase or upgrade
outdoor seating and equipment for the
summer of 2021.

The communication also focused on the broader messaging of national government focusing on enjoying a safe and sustainable summer outdoors; and Kildare County Council was pleased to highlight the proactive development of a number of pilot projects to make our public spaces more people-friendly, usable and fun spaces to be, including Poplar Square, Naas pictured left.

#### **Meetings**

#### **Full Council**

Council meetings continued to be held online in May with the press and public in attendance. A decision was made by the elected members at their May meeting that the Council AGM on Friday 25 June and the monthly meeting on Monday 28 June would be held in Newbridge Town Hall. It was agreed that Municipal District Committees would remain online in June with each municipal district to decide on online meetings or a return to the council chamber in July.





At the May meeting of Full Council, the members approved the Annual Report 2020, the Casual Trading Selection Policy, Standing Orders for SPCs and Standing Orders for Petitions to the Cathaoirleach which will enable members to action items related to non-council functions. The members also received a presentation from the Climate Action SPC and the Environment and Water Services SPC.

# Section 40 Data Protection Act – Representations by the Elected Members

The Corporate Services Department are working with the members in addressing concerns related to the operation of Section 40 of the Data Protection Act and will keep members advised in this regard.

#### **Cotton Mills**

Facilities section have demolished derelict buildings located just off the Aras Chill Dara Car park.

The buildings had to be removed as a matter of public safety. A Part 8 for further works is being prepared along with a tender for replacement of the roof.





## Finance and Information Technology

#### Commercial Rates Waiver for Quarters 1, 2 and 3 of 2021

On 30 December 2020, the
Government announced a waiver of
commercial rates for certain
businesses, for the first quarter of
2021. This exemption was extended in
February for the second quarter until
the end of June 2021. As part of the
Government's Economic Recovery
Plan on 01 June the rates waiver was
extended for a third quarter until the
end of September 2021.

Kildare County Council has applied this six-month waiver to 2,365 properties in the county. A dedicated online appeal portal for businesses who are not eligible for the waiver was launched and 41 appeals have been received.

# Small Business Assistance Scheme for Covid (SBASC)

The Small Business Assistance Scheme for Covid (SBASC) is intended to help businesses that do not qualify for the COVID-19 Restrictions Support Scheme (CRSS) operated by the Revenue Commissioners, cover operating costs.

The closing date for receipt of applications was 21 April 2021. As at 11 June 2021, 210 applications are on the system. 73 applications have been paid totalling €292,000. 53 applications have been rejected. 16 applications awaiting the applicant to provide further information. 68 applications started on the system but only partially completed and not progressed by applicant for processing, if not progressed by 14 June they will be taken off the system.

As part of the Government's Economic Recovery Plan on 01 June another SBASC scheme was announced and this went live on the 10 June 2021 and the closing date for receipt of applications is 21 July 2021. SMEs (Small and Medium Enterprises) and microenterprises can apply for a grant of €4,000 for those with turnover above €50,000 and €1,000 for microenterprises with a turnover of between €20,000 and €49,999, This scheme has been extended to include those businesses that are operating





from non-rateable premises such as a home office or hot-desk.

#### **2020 Audit**

The Local Government Auditor will commence the audit of the 2020 Annual Financial Statements on 27 July 2021. Members were emailed with the confirmed date earlier in June.

#### **Local Property Tax**

As a result of the decision to amend the Local Property Tax bands and to bring post-2013 properties into the LPT system, Revenue advised the Department of Housing, Local Government and Heritage that the variation of the base rate needs to be notified to Revenue by 31 August 2021 instead of the traditional 30 September.

On 10 June 2021, the Department advised that the Local Property Tax (Local Adjustment Factor) Regulations 2014 had been amended. These regulations reduce the minimum public consultation period from 30 to 14 days. This change is aimed at ensuring that local authorities can proceed with the required consultation in time for the July meeting. The public consultation

period for Kildare will be from the 23
June to the 09 July 2021 and will be
advertised in the local press, on social
media and on the Kildare County
Council website.

A report, summarising the written submissions, shall be brought to the July meeting.

#### **Motor Tax**

Motor Tax is continuing to provide a full suite of services during restrictions. Direct customer contact is by appointment only and times are restricted. Customers are encouraged to use the online motor tax facility at <a href="https://www.motortax.ie">www.motortax.ie</a>. If they are not in a position to use the online facility, we accept and continue to process postal applications.

#### Housing

#### **Homeless Services**

The National Homeless Lead meeting was held on the 08 June and there continues to be no positive cases of COVID-19 in Homeless Services in the county.

Fortnightly meetings continue with the Department of Housing, Local Government and Heritage and subsequently with the HSE, Meath and Wicklow to monitor any COVID-19 developments in the region. There are currently no positive COVID-19 cases in Homeless Services in the Mid-East Region.

The programme to vaccinate the Homeless Service users is complete with the assistance of the Peter McVerry Trust who facilitated this in the Kerdiffstown facility.

The 12-unit own front door facility at
Jigginstown Manor is now in operation
with the first two placements made.
This facility is being operated by Tiglin
in conjunction with the Homeless
Team and referrals will be made to this
service for young adults leaving
emergency accommodation.

The Pathway Accommodation and Support System (PASS) 2 Homeless system is due for release with an anticipated go-live date of the end of June.



#### **Number of Allocations**

Allocations continued in May and included allocations to Kildare County Council and Approved Housing Bodies (AHBs) units. Several transfers were also facilitated. All allocations took place within the controls and restrictions of COVID-19.







## Inspection of Private Rented Properties

In accordance with recent guidance issued from the Local Government Management Agency (LGMA), the physical inspection of occupied properties continues to be suspended, we are awaiting guidance from the Local Government Management Agency to resume inspection of occupied properties.

## Housing Assistance Payment (HAP) Tenancies

A total of 215 tenancies have been signed up year to date.

#### **Traveller Community**

Traveller accommodation continues to demand resources in terms of both the halting sites and roadside encampments. Demands on the council's social work service is high and the team are maintaining daily contact with traveller families, particularly those who may be at risk or vulnerable.

### Applications under the Self-Help Scheme 2021

The 2021 Self Help Scheme was advertised on the council's website, uploaded to the Members Information Portal (MIP) and in the local press with a closing date of 14 May 2021.

269 application forms were sent out and 164 forms were returned.

Processing of these forms has now commenced. Successful applicants must have up-to-date rent accounts.

#### **Infrastructural Projects**

## Contract 2A (Newbridge Eastern Interceptor Sewer)

These works were completed and commissioned in 2020. The sewerage network is due to be handed over to Irish Water/Kildare County Council Operations by the end of Quarter 2 or 3, 2021. The pumping stations are being operated by the contractor for a 12-month proving period before being handed over to Irish Water/Kildare County Council Operations in the summer of 2021.

#### **Contract 2B (Network)**

Works commenced on site in September 2019 and are advancing well. The major pipeline improvement works on the Clane and Sallins rising mains are complete and both rising mains have gone live in Quarter 1, 2021. In Naas, pipeline works are continuing on private lands between the M7 Motorway and Monread Road. In Newbridge, pipeline works are continuing on the R445 towards Langton's Cross / McLoughlin's Oil

junction. Pipeline works are substantially complete in the Páirc Mhuire housing estate.
Upgrade and improvement works are continuing at Clane, Monread and Sallins Pumping Stations.

# Osberstown Sludge Treatment Facility - Design Build Operate (DBO) Contract Variation

Veolia Water Ireland advanced works on this variation to the Design Build Operate (DBO) contract and completed these works in Quarter 4, 2020. Operational commissioning of the Thermal Hydrolysis Process Plant is continuing. The Exelys Thermal Hydrolysis Process (THP) is intended to be fully operational by end of Quarter 2 2021.

#### **Maynooth Transfer Pipeline**

This project involves the upgrading of the existing Maynooth Sewerage Pumping Station and the construction of a new sewerage pipeline along a new route from the pumping station to the Leixlip Wastewater Treatment Plant. This project is at planning and detailed design stage.





Irish Water and its representatives are currently negotiating with affected landowners and Irish Water's consultants are preparing Compulsory Purchase Order (CPO) documentation for this scheme as option agreements have not been reached with all landowners.

#### **Capital Projects**

# Allenwood Sewerage Network (Vacuum System) Modification

While funding constraints have emerged on the part of Irish Water in light of the current COVID-19 crisis, the council continues to work with the utility to progress a temporary solution. This involves laying new pipe, land acquisition and temporary pumping arrangements to transfer sewage from the buffer tank to the public gravity sewerage system and on to the Allenwood Wastewater Treatment Plant (WWTP) for treatment and disposal.

It is hoped that the land acquisition can be completed reasonably quickly so that these temporary works can be arranged and completed by Quarter 2 or Quarter 3 2021. Consultants have been appointed to progress the longerterm pumping solution at the buffer tank site.

## Timolin Waste Water Treatment Plant (WWTP) Upgrade

This project has been included in the Small Towns and Villages Growth Programme (STVGP) which will be subject to Irish Water approval. Irish Water agreed to the priority list submitted by the council following a workshop held recently. This scheme was ranked high in the council's priority list due to commitment made to locals and public representatives in 2017 and the approval of the planning process for a Part 8. Irish Water has notified the Director of Services that they will progress this to next stage subject to funding being available after the first priority (Derrinturn) and second priority

# Water Networks Management Projects

(Nurney) are progressed.

## Boycetown, Kilcock Water Main Extension Scheme

As Kilcock has been deemed as an area for development under the Local Infrastructure Housing Activation Fund





(LIHAF) and the Major Urban Housing Delivery Sites Scheme (MUHDS), an extension of the water main infrastructure is now required to facilitate the planned housing development demands in this area. This project involves the construction of 755 metres of a new watermain. Works commenced on 22 February 2021, with an eight week construction programme to completion of the project. Permanent road reinstatement works were completed during May 2021. All works have now successfully been completed as part of this scheme.

Suncroft Village Water Connection Service Transfer Works

This project involves the transfer of approximately 30 water service connections within the village of Suncroft. Works will also involve the decommissioning of 850 metres of cast iron mains along this route.

To date, all planned service transfer works have been completed as part of this scheme. An additional package of work has since been identified and is required to allow for the full

decommissioning of the cast iron water mains in this area. Additional funding has been allocated and works commenced in May 2021 which involve the installation of approximately 250 metres of new watermain together with associated assets along School Lane, within Suncroft Village. It is expected that this work will be completed in Quarter 2 2021.

Newbridge Town Watermain Rehabilitation Works –

Pairc Mhuire, Newbridge Back Yard Services Scheme (BYSS)

All public and private side watermain installation works have now been completed as part of this scheme.

Permanent road reinstatement works are now complete.

Full decommissioning of the existing cast iron watermain cannot be completed until further BYSS projects within the areas of Highfield Estate and Piercetown have been carried out. These projects are currently under review by Irish Water's Asset Planning.





#### Kildare Town Watermain Rehabilitation Works -

#### Lourdesville BYSS

All public and private side watermain installation works have now been completed as part of this scheme. The decommissioning of the existing cast iron mains in Lourdesville is now expected to commence in Quarter 2 2021.

#### **Campion Crescent BYSS**

All necessary customer consent has now been obtained. Decommissioning works have still to be completed. This work will commence when all consent from customers in Assumpta Villas has been provided.

#### **Assumpta Villas BYSS**

There are currently four premises whereby customer consent has not yet been obtained throughout Assumpta Villas. Private side service connection works need to be carried out on each of the remaining properties prior to decommissioning works commencing in both Assumpta Villas and Campion Crescent.

#### Rowanville BYSS

There is currently one property remaining within this scheme whereby customer consent has not yet been obtained. Decommissioning works have yet to commence. This work will commence once consent from the final customer has been provided and the properties service connection is installed.

The two civic amenity sites continue to operate as normal. Members of the public are asked to continue to prioritise payment by contactless cards and to exercise social distancing at all times onsite.

#### **Recycling Banks**

In May, the decrease in glass tonnages at recycling banks continued on from the previous month. In May last year, 598 tonnes of glass and cans were recovered. This year, for the same month, the figure is 505 tonnes. As businesses reopen it will be

important to monitor this trend to prevent problems at sites.

## Domestic/Commercial Refuse Collections

Domestic and commercial waste collections are continuing as normal. Domestic waste collectors have however been granted permission by the National Waste Collection Permit Office (NWCPO) to carry out collections outside of their conditioned waste collection hours due to COVID-19 restrictions. #### **National Tidy Towns/Spring Clean**

The National Tidy Towns competition will proceed this year, with the adjudication being done remotely.

The Environment Department is supporting the entrants by providing grants early in the year to enable works to be done, as well as offering advice on the wide range of areas the competition covers.

National Spring Clean proceeded well this year with over 230 cleanups organised and undertaken by Tidy Towns groups, Scouts, residents associations and community groups. Bags and pickers were made available from Aras Chill Dara and the Municipal District offices and the latter is proving to be a great way of getting the equipment to groups easily without the volunteers having to travel long distances. The Roads Department are to be thanked for accommodating this.

#### **Green Kilometre Scheme**

This scheme continues to grow. Over 127 separate Green Kilometres have been established and 42 tonnes of litter and dumped materials were collected to date this year.

This is a huge amount to be gathered by hand and indicates that Kildare County Council will need to support these groups and individuals in





providing clean up equipment and collecting the waste in a timely fashion.

#### **Environmental Education**

In line with Government Guidelines, all in-person educational talks and events are suspended until further notice in the interests of public health and will be rescheduled at a later date where feasible. The Green Schools programme has continued in a number of schools and online assessments are now taking place in order to award the green flag. While the number of flags awarded will be substantially down on previous years, many schools are organising themselves to participate over the coming year. ## **Catchment Flood Risk Assessment** and **Management Study (CFRAMS)**

A steering group with the Office of Public Works (OPW) has been established to progress the consultant's brief for schemes within Kildare. The municipal districts will be briefed as schemes from the Catchment Flood Risk Assessment Management (CFRAM's) Programme commence. Flood defence schemes have been classified as essential works by the County and City Management Association (CCMA).

### **Morell Flood Management Scheme**

Construction of this scheme is now underway, beginning with Phase 1 embankments and walls in the Tuckmilltown and Turnings areas. Further details of the scheme can be found at: <a href="https://www.morellfms.ie">www.morellfms.ie</a>.

### **Athy Flood Relief Scheme**

The Kildare County Council and OPW
Steering Group has commenced
developing the scope of the Athy Flood

The contract for consultancy services for the Naas Flood Relief Scheme has been awarded to ARUP. The first stage of the scheme will be a review of the existing hydrology and mapping. ### Kerdiffstown

Wills Bros Ltd was appointed in October 2020 for the remediation of the landfill and the construction of the park. The contract period is for 54 months but Kildare County Council is working with the contractor to deliver the project sooner.

Gas extraction wells are being installed along with the capping system. The photo below shows the drilling rig.







The contractor has already commenced the capping of the site with the Linear Low Density Polyethylene (LLDPE) sheeting and subsoils being placed as can be seen in the following photo.



As can be seen in the next photo, the site compound is progressing well with the site offices roofed, the leachate storage tank complete and the leachate treatment building soon to be clad.

Monitoring of the gas and groundwater boreholes as well as the management of the leachate and gas continues, in accordance with the Environmental Protection Agency (EPA) Licence.
This will continue through the COVID-19 lockdown and the works.

### **Cemetery Capital Programme**

This programme, which includes cemetery extensions, capital type internal improvements and proposals for columbarium walls is currently being reviewed and is likely to be intensified.





### **Kildare Town Cemetery**

A tender has been awarded for the renovation of the front wall and gates, the removal of the old bunker and the resurfacing of many of the internal roads and pathways. Works commenced in early January but stepped down due to the level 5 restrictions. Works recommenced recently and will soon be completed.

**Newbridge Cemetery Carpark** 

It is intended to re-advertise a new tender in Quarter 2 2021.

### **Ballymore Eustace Cemetery**

New paving works are taking place around the old part of the Ballymore Eustace cemetery and are due to be completed soon.

### **Risk Management**

Risk management cycle for 2021 is now complete.



The Climate Action Regional Office (CARO) works to support its constituent local authorities to drive

climate action projects in their counties, with particular focus on implementing actions contained within climate adaptation strategies. A number of projects are ongoing across the Eastern and Midlands Region:

## Economic Opportunities arising from Climate Action:









This project aims to determine how local government can engage policies and actions to exploit opportunities arising from climate action. Following the successful webinar on this theme which took place on Thursday 20 May 2021, exploring potential economic and enterprise opportunities from climate action for local authorities, additional research is now being undertaken into local government activity in this area internationally. In addition, training to raise awareness for local authority staff including the Local Enterprise Offices is under development. Plans are also underway for a conference to be held in collaboration with the project





partners, later in the year. This is likely to take place in mid-October.

### **Capacity Building:**



The CARO continues to work with its strategic training partners, to implement on behalf of the local government sector, a national training programme for all elected members and local authority staff. Details of the training programme, which includes six pillars and has received CPD accreditation from a number of bodies (Engineers Ireland, Irish Planning Institute, CIWEM), have been circulated to all local authorities.



### **Elected Members/Senior Staff**

The Climate Leadership training for senior staff and elected members has now been scheduled across 25 counties before the end of 2021 with the remaining counties to be completed in early 2022. A provisional date of 24 September has been provided to Kildare County Council.

Feedback to date on this training has been excellent.



### **Climate Action Teams**

This programme commenced with participants from the midlands subregional counties (Offaly, Longford, Roscommon, Laois, and Westmeath), has now moved to local authorities of the Atlantic Seaboard North CARO region and will be rolled to other regions as the year progresses.



### **Online Training**

The rollout of the Raising Awareness online training programme is ongoing; Grade 7, Grade 6 and technical equivalents have completed this programme across each of the 31 local authorities and the rollout has now cascaded to Grade 5 and equivalents. To date, 3,315 Grade 5's have registered for the programme, with a further 2,260 to follow.







### **Thematic Training**

In the first training course of the Actioning Policy training pillar, the Planning for Climate Change training has been rolled out to all local authority planners. Through eight specifically focused modules, set out over four half days, this course supports the target training group in their role and responsibilities, to embed and implement climate action considerations across the forward planning and development management dimensions of the regulatory planning function of the local authority. This training course further supports Part 3 (n) of the Local Authority Climate Action Charter.

Other training courses falling under the Actioning Policy pillar are at various stages of design and progression towards delivery:

- Procurement Officers on promoting green procurement through supply chains.
- Impact of Climate Change on Flood and Water Management.

- Older Persons Council on raising awareness on climate change and climate action.
- Economic and Enterprise
   Opportunities arising from Climate
   Change.
- Climate Change and Roads
   Infrastructure.



### **Outdoor Staff**

Training for outdoor staff remains under design and development with delivery informed by the easing of COVID-19 restrictions. The Local Authority Services National Training Group (LASNTG) are working with Chief Executives in all local authorities to identify suitable candidates to deliver this training within each local authority. "Train the Trainer" type training will be provided to all candidates once health restrictions allow and access to the Regional Training Centres is permitted.







### **Frontline Staff**

Training for front line or community engagement staff remains under design and development with the Institute of Public Administration with delivery to be informed by the easing of COVID-19 restrictions.



# Guidance for Local Authorities – Preparing Local Authority Climate Action Plans:

The Eastern and Midland CARO working in partnership with the EPA / Climate Ireland have recently commenced work on the development of Guidelines for Local Authorities on preparing their Local Authority Climate Action Plans. As per the provisions of the Climate Action and Low Carbon Development (Amendment) Bill 2021, each local authority will be required to prepare and make a Climate Action Plan containing mitigation measures and adaptation measures, to be adopted by the local authority. The

guidelines are an expressed provision of the Amendment Bill also. These guidelines will support local authorities in terms of both the content and the process of making their own Climate Action Plans, when formally directed to do so, by the Minister for the Environment, Climate and Communications.



## Creative Ireland's Creative Climate Action Fund:

The Creative Ireland Programme in collaboration with the Department of the Environment, Climate and Communications launched the Creative Climate Action Fund – a €2 million fund for creative projects which can meaningfully connect people with profound changes happening in our environment, society and economy arising from climate change. The first funding call, which closed on the 31 May, sought proposals which can use creative and artistic approaches to transform connection and awareness





into climate action and behaviour change. The CARO has partnered / collaborated on / supported a number of application proposals, including a large scale project with local authorities in the South East subregion. These will now be assessed for funding support.

## Climate Change Adaption Strategy (CCAS)

The Climate Action Team (CAT) are the main drivers of action under the CCAS. The CAT met on 03 June. Thematic Group 6, Community Health and Wellbeing presented a very informative and inspiring account of the work being undertaken and progressed to date.



A presentation was made by a fledgling Irish company Vyra. Their Zero to Sustainable programme asks

participants to engage for five minutes a day to reduce their carbon footprint by 30kg week through behavioural change in their daily activities. CAT members have opted to join the trialling of the application.

# Sustainable Energy and Climate Action Plan (SECAP)/Climate Action Plan (CAP)

It is a requirement under the Covenant of Mayors and will be a requirement of the amended Climate Action and Low Carbon Development (Amendment)
Bill that Kildare County Council prepare a 5-year Sustainable Energy Climate Action Plan/Climate Action Plan (SECAP/CAP). The tender competition has closed, and tender evaluations have concluded with a successful tenderer outcome. The awarding of the contract is being processed.





## Climate Action Strategic Policy Committee (SPC)

The committee met on the 12 May and progressed through a heavy agenda. The highlight was an overview by the National Peatlands Park Group on the creation of a National Peatlands Park in the midlands and the need to progress the concept from a business, tourism, climate action, biodiversity, and heritage viewpoints.

The committee's action plan will be taken account of during the development of the SECAP/CAP.

### **Energy**

### **Energy Management Team**

Kildare County Council's Energy
Management Team has been meeting
monthly since its re-establishment in
February 2021. The team is currently
progressing several key areas,
including the development of Kildare's
register of opportunities (projects,
initiatives for energy savings), analysis
of Kildare's top twenty energy users
and potential areas for reducing their
energy consumption. The team
received a presentation from 3
Counties Energy Agency at its May
meeting to inform the group on ISO

50001 as the team is currently considering applying for this recognised energy management standard for Kildare County Council. A sub-group of the Energy Management Team is focusing on developing a proposal to hold a Climate and Energy week event in October of this year. The group has progressed the event proposal and hopes to submit to senior management for consideration later in June. The event itself will be targeted at both the internal workings, staff of Kildare County Council and outward looking to the wider communities within the county.

## Energy Usage Monitoring and Reporting (M and R)

Kildare County Council continues to make good progress on reducing its energy usage across the council.

Latest information as of the 13 May for year ending 2020 would suggest Kildare is now at 32.7% energy reduction against its baseline year of 2009, which is significant progress from the 2019 figure of 24%. Although this is a provisional figure from Sustainable Energy Authority of





Ireland (SEAI) it shows continued progress on energy efficiencies through Kildare County Council driven largely by the Facilities Team to date. It must also be taken into account the impact COVID-19 restrictions would have on energy reduction in 2020 with remote working and reduced services.

### **Energy Bureau**

Progress is ongoing regarding the formation of an Energy Bureau to provide energy related services and projects at a regional level through SEAI's pathfinder grant funding. The group representing each of the Local Authorities with support from CARO met with SEAI on May 28 to put forward the Bureau's Position Paper for consideration and are currently awaiting feedback from SEAI on next steps. It was also learned at this meeting that Louth County Council no longer wishes to be included in the proposed energy bureau, which results in Kildare, Wicklow and Meath LA's leading this initiative.

## Sustainable Energy Communities (SEC's)

Kildare County Council continues to make good progress on Sustainable Energy Communities in the county. There are currently 21 SEAI registered SEC's in County Kildare, with four of these nearing the end of their energy master plan stage which will allow them to move to the action phase. A meeting was held with these four SEC's to receive feedback on their progress to date in this process and to learn what changes if any might be needed to ensure positive outcomes and hence encouragement for fledgeling SEC's. The feedback received centred on an additional "community engagement" piece to be included in the Energy Master Plans. The council have engaged with SEAI and the energy consultant ORS Ltd to address this missing piece. Naas SEC are currently compiling their application to join with Kildare County Council to deliver their energy master plan.





### Fleet Electrification



In communication with Area Engineers in Kildare's municipal district offices there has been agreement with two of the municipal district offices to progress the area of fleet electrification by way of receiving quotations to supply and install EV charging points in both Celbridge and Naas Municipal District offices. While there are currently four small EV vans in Kildare County Council's fleet it is very much hoped to increase the presence of EV's in the fleet in the coming years and by having the infrastructure in place to support fleet electrification this will facilitate such growth.

As fleet electrification starts to embed in Kildare County Council through infrastructural changes and greater awareness of EV's it will also be key to facilitate specific EV driving training for all drivers of fleet vehicles to ensure potential EV drivers are fully informed and upskilled in this area.

## Celbridge – Leixlip Municipal District Initiative

The Celbridge-Leixlip Municipal District has provided LPT funding of €25,000 for a Climate Innovation Fund.

Work has commenced on the two projects with updates to be provided in mid to late summer. Both projects are examples of Community Activation by demonstrating Climate Action at a local level with potential for scalability.

### **Forestry**



An Roinn Talmhaíochta, Bia agus Mara Department of Agriculture, Food and the Marine

The finalised document 'Woodland Creation on Public Lands Scheme' was released on the 28 May, 2021. The project is being advanced by a subgroup of the CAT called, Coillteach Chill Dara, with the respective functional areas of the council being notified of the potential sites being considered in each municipal district. The management team's support is required to advance the establishment of woodlands on public lands in response to the Environment Strategic Policy Committee (SPC) Works Programme. Template tender documents for procuring the different





elements of this scheme are currently being drawn up by a CARO Working Group and these will be available for use by all local authorities. The CARO is seeking clarifications to inform the application process.

### **Ezine**

The Climate Action Office published its second edition of the year during the week ending 13 June with a view to circulating widely as a mainstreaming tool.

This edition is focusing on actions, enterprise greening opportunities, SPC involvement and training aspects.

### **Partnerships**

The Climate Action Office has partnered with Creative Kildare Team and the Age Friendly Alliance to assist in streamlining Climate Action through their work.

Climate Action's first proposed joint project in Ballymore Eustace has been initially assessed and potential programme of objectives set out. A walkability survey is to be undertaken by the Age Friendly local members to advance the project once restrictions allow.

Climate Action's first proposed joint project with Creative Kildare was submitted on 31 May under the call associated with the Creative Ireland Grant. The proposal is called 'Just Transition Estates – A Feast for the Future'. The submission is a collaboration between Libraries, Heritage, National University of Ireland, Maynooth, Climate Action Office and creative entities. The proposal, if successful will be undertaken, in lower income housing estates - Lough Na Mona in Leixlip, Castlefen, Sallins and Zero Waste Garden in Rathcoffey. Through practical education it will build awareness and community resilience around local food production. The footprint of their estates will be used to provide communal food that will be celebrated through street feasts and creation of cookbooks etc. If funded, this project instils fundamental learnings in Climate Awareness in a fun community atmosphere that is easily replicable across the county.





#### **Graduate LGMA**



The Climate Action Office is delighted to welcome a graduate under the LGMA's Graduate Recruitment Competition, who will progress climate activation initiatives in the community. The PPN, LCDC and Community Section have been consulted to ascertain the areas of most need and the synergies to allow the graduate to best target their skills.

### **Just Transition**

The municipal districts of Athy, Clane-Maynooth and Kildare-Newbridge have generously contributed €15,000 per municipal district to establish a fund to engage a consultant to carry out research to identify possible initiatives which could be advanced in order to provide the necessary supports for the most affected communities. The tender has been advertised on eTenders and bids are to be returned by 25 June.

### **Alternatives to Herbicides Project**

The CARO assisted the Parks/Climate Action Office to promote the project on alternatives to herbicide use in the upkeep of amenity public open spaces. The scientific research together with practical assessment in the field (Kildare County Council Parks Department and National University of Ireland, Maynooth) is designed to produce a practical maintenance guide for public open spaces. Collaborators include University College Dublin, National University of Ireland, Maynooth and Teagasc. The National Biodiversity Data Centre has committed to aligning research to this area.

The number of partners including local councils and other entities will be known in the coming weeks.

The project was presented to the Cork City Council's Environment, Water and Amenity SPC on the 18 May. The stakeholders welcomed the initiative and were strongly in favour of the need for the research. Cork City Council have confirmed their partnership.

Sophia Couchman commenced the Master's position in National University of Ireland, Maynooth on the 08 June





and is familiarising herself with the sites as she looks forward to the challenges and working with all parties involved. The Parks Department and Community Section have contributed enormously regarding their expertise, time, and financial contribution to make Sophia's position possible.

## Roads, Transportation and Public Safety

The 'M4 Maynooth to Leixlip' is listed

### M4 Maynooth to Leixlip

as a section of the transport network to be progressed through pre-appraisal and early planning and prioritised for delivery under the National Development Plan 2018–2027.

The aim of the project is to assess the needs of the M4/N4 mainline corridor and junctions from Maynooth to Junction 5 Leixlip in terms of catering for future demand from a capacity, safety and operational perspective.

Arup have been appointed as technical advisors to support the delivery of the project through Phases 1 to 4.

These phases include:

- Phase 1 (Concept and Feasibility) which would determine if an intervention (project) is required and if an intervention is feasible.
- Phase 2 (Option Selection)
   would examine feasible options
   for intervention that could
   address the aim of the project.

 Phase 3 (Design and Environmental Evaluation)
 would develop the design of the preferred option from Phase 2 for further assessment including evaluation of environmental impacts; and Phase 4 (Statutory Processes) would include undertaking the Statutory Processes.

TII deliverables for phase 1 are now complete and signed off by both Kildare County Council and Transport Infrastructure Ireland (TII). The scheme has now moved to Phase 2 Option Selection. The scheme will take a number of years to pass through the various steps required for Phase 1 (Concept and Feasibility), Phase 2 (Option Selection), Phase 3 (Design and Environmental Evaluation) and Phase 4 (Statutory Processes), provided it successfully progresses through each phase.

### **Athy Distributor Road**

An Bord Pleanála's approval issued on 11 October, 2017. A Notice of Confirmation for the Athy Distributor Road was published in the Nationalist





and Leinster Leader on 28 November 2017. No objections/Judicial Reviews were received by the deadline on 23 January 2018.

Notices to Treat have been issued.

Notice of Entry on lands has been issued. Advance works between Corran Árd and Fortbarrington Road have been completed. The railway abandonment is complete. The removal of rails and sleepers is complete. The Córas Iompair Éireann (CIE) lands have been secured from trespassers.

The tender process has commenced. The PQQ (Stage 1) has been completed with six contractors short listed for tendering. Stage 2 tender documents were submitted to the Department of Transport and the Minister for Transport and approval to proceed to Stage 2 of the tender process was granted. The Stage 2 tender process closed on the 17 May 2021. A tender assessment board is currently assessing the quality component of the completed tenders and will report on this by the end of June. It is expected to have a

contractor on site by Quarter 4 2021, subject to COVID-19 restrictions.

The CIE/ larnród Éireann (IE) Bridge
Agreement and Waterways Ireland
Licence documents are at draft stage
and currently being reviewed.

## New Machinery Yard Relocation and Regional Salt Barn

Part 8 approval in respect of the New Machinery Yard and Regional Salt Barn Project was confirmed on the 13 May 2019.

The development will replace the existing Machinery Yard in Newbridge and will include a new Regional Salt Barn. This barn will provide storage for approximately 22,500 tonnes of salt for use by Kildare County Council and a number of other local authorities in the region.

The Enabling Works Contract started on site in July 2020 but has been delayed by COVID-19 restrictions.

Clonmel Enterprises Ltd. have completed the storm attenuation system and the lime/soil stabilisation works. The enabling works contract is





now scheduled to be substantially completed by the end of June.

The design and tender documents for the main contract are being progressed by Kilgallen and Partners Consulting Engineers. The equipment contract tender analysis has been completed and the preferred tenderer will be novated into the main contract. The main contract is due to go to tender in July.

It is expected to have a main contractor on site for Quarter 4 2021, subject to COVID-19 restrictions.

### Maynooth Eastern Ring Road

The preferred route option (C), was presented in-committee to the Maynooth Municipal District Committee on 05 April 2019. The Clane-Maynooth Municipal District Committee confirmed approval of the Part 8 in respect of Option C on the 29 July 2019.

The next phase of the project will be the completion of the design and procurement of the main contract.

Kildare County Council is currently endeavoring to gain control of the

lands (identified under the Local Infrastructure Housing Activation Fund (LIHAF) Scheme) as a prerequisite to the CPO going ahead.

The preparation of CPO documentation is near completion. Valuers have been appointed. Discussions with Waterways Ireland, larnrod Éireann and CIE are ongoing in relation to the design of the bridge structure which will span the Royal Canal and Dublin/Sligo railway line. The procurement of a NOBO consultant in respect of the design of the bridge structure (an independent consultant to assess adequacy of the proposed design in relation to the EU Interoperability Directive) has been completed and the assessment has commenced.

Detailed design of the scheme, including drainage design, is at an advanced stage.

Further discussions are required with the Department of Housing, Local Government and Heritage (LIHAF) regarding project funding and with Irish Water regarding the inclusion of water





and sewerage services along the proposed road infrastructure.

### **Funding**

Discussions are needed as soon as possible with the Department of Housing, Local Government and Heritage (LIHAF), the Department of Transport and the NTA with regards to the financial direction of this project.

### **Services**

Agreement is needed with Irish Water on the servicing of the lands associated with the MERR LIHAF project.

### Celbridge to Hazelhatch Link Road

Engineering Consultants RPS have been engaged for the Celbridge to Hazelhatch Link Road Project. Their brief is to bring it from scheme concept and feasilibilty through to statutory processes. Kildare County Council was successful in securing funding from the Department of Housing, Local Government and Heritage under Call 1 of the Urban Regeneration Development Fund (URDF). The scheme, which will connect Celbridge

Town and the Hazelhatch Train
Station, will include a second bridge
over the River Liffey. The project is
currently at route selection stage. A
four week virtual public consultation on
the route corridor options has been
completed and submissions have been
compiled. This is facilitating the
ongoing development of the project to
emerging preferred route stage.

A URDF Call 2 application for further funding has been successful with Kildare County Council receiving €10,237,500 for this project (75% Funding, Kildare County Council to contribute 25%). This will facilitate the development of this project to construction stage.

### **Newhall Junction Improvement**

Newhall Crossroads is located on the R445 dual carriageway between Naas and Newbridge. It is the junction of three roads: the R445 the L2031 local road and the L6064 local road. The existing junction is considered unsafe as it is a cross-roads junction on a busy dual carriageway.





An Options Selection Report to determine the most appropriate junction type to replace the existing arrangement was completed in June 2020. This report determined that a roundabout was the preferred option. A preliminary design for a new roundabout at Newhall has been developed. Documentation associated with the Part 8 process have been completed and discussions have taken place with the Planning Department. Kildare County Council departments have been notified of the Part 8 process associated with this project.

An in-committee meeting with the Kildare-Newbridge Councillors was held before their March statutory meeting, to discuss the scheme.

Affected landowners are being consulted at present.

The Part 8 process has commenced and the submissions period closed on 26 May 2021. A Part 8 report is being prepared at present. It is proposed to present the Part 8 scheme to the Kildare-Newbridge Councillors at the July meeting.

### **Naas to Sallins Greenway**

Kildare County Council are currently engaging with the National Transport Authority on this project and have secured funding to bring this scheme to Part 8.

The tender process to appoint a consultant is currently at tender assessment stage. It is expected that the appointment will be made in the coming weeks.

It is expected to proceed to Part 8 in Quarter 4 2021, subject to COVID-19 restrictions.

### Naas / Sallins Transport Strategy

The Naas/Sallins Transport Strategy has been completed and published.

## Athy Area Based Transport Assessment (ABTA)

The Athy Area Based Transport
Assessment has recently been
completed and the Planning
Department have included it in the
Draft Athy LAP Process.





**Kildare Town Transport Strategy** 

The draft Transport Strategy for Kildare Town is currently being finalised. It is anticipated that a Phase 2 non-statutory public consultation will commence in June 2021, after which the strategy will be finalised.

### **Maynooth Transport Strategy**

A brief and tender documentation have been prepared to facilitate the appointment of Consultants for the development of the Maynooth Transport Strategy. The tender process is now complete, and the consultants have been appointed. It is expected to take six months to complete.

This will facilitate the development of the Maynooth LAP going forward.

### **Bridge Rehabilitation Programme**

Kildare County Council received funding for 2021 from the Department of Transport for bridge rehabilitation works at six locations. Design works and tender documentation are being prepared at present and it is expected to deliver these works during Quarter 2/Quarter 3 2021, subject to COVID-19 restrictions.

2020 bridge rehabilitation works are near completion, with some parapet works on-site at present.

Monasterevin bridge is progressing through the approval process with An Bord Pleanala and it is proposed to proceed to construction stage Quarter 3 2021.

Brook bridge has commenced the approval process with An Bord Pleanala and it is proposed to proceed to construction stage Quarter 3 2022.

## Newbridge Southern Relief Road / Second Bridge Crossing

The section of the Newbridge
Southern Relief Road (NSRR)
between the Newbridge to Naas dual
carriageway (R445) and the Great
Connell road is now substantially
complete and the Roads Planning
Section is currently engaging with the
developer on the completion of snags,
the transfer of lands and the
submission of the taking in charge
documentation.





A URDF Call 2 Application for funding for the Great Connell to Athgarvan Road section, including a new bridge over the River Liffey has been unsuccessful and we are currently reviewing feedback from the URDF. The offer of a feedback session with the Department has been accepted. The process to procure consultants for this project has commenced and a brief is being prepared to appoint consultants and bring the project through to planning stage. It is expected that consultants will be appointed in October.

### **Maynooth Inner Relief Street**

This road with signalised junctions and a new bridge over the Lyreen River has been substantially completed by the Cairn Developments PLC. The Kildare County Council Roads Planning Section is engaging with the developer on the opening of the street to traffic, pedestrians and cyclists. The road safety audit stage 3 is being carried out on the completed works. It is proposed to be opened in Quarter 3 2021, subject to COVID-19 restrictions.

# Kildare Town Northern Link Road and South Green Area Access Improvement Scheme

The Route Selection Report is substantially complete. This project will not proceed further until the Kildare Town Transport Strategy is completed, which is due to go to public consultation in June 2021.

## Royal Canal Greenway – Maynooth to Moyvalley

The Royal Canal Greenway provides a dedicated and substantially off-road recreational cycle facility from Dublin to Galway along the route of the Royal Canal.

The Greenway from Maynooth to Moyvalley is now substantially complete and operational. A stage 4 safety audit and snags are now being completed for this project.

## Kildangan Railway Bridge Footpath Scheme

The scheme is now substantially complete and the footpath is operational.





# Maynooth North South Corridor – Phase 6 – Moyglare Road Improvement Scheme

This scheme is substantially complete, except for snags which are outstanding due to COVID-19 restrictions.

### **Broadband Connection Points**

Kildare County Council is progressing the Broadband Connection Points (BCPs) in Kildare. These sites will provide high speed broadband to the public until the NBI fibre broadband is available:

- Bigstone Community Hall,

# Local Community Development Committee June 2021

The last meeting of the Local
Community Development Committee
(LCDC) meeting was held via
Microsoft Teams on 26 May 2021.

## COVID-19 Community Response Forum

The Kildare COVID-19 Community Response Forum have had 25 meetings to date via Teams. The purpose of the forum is to lead the coordination of COVID-19 community supports and resilience. A dedicated COVID-19 support helpline was established on the 30 March by Kildare County Council. The response forum has representation from key statutory and voluntary organistions across the county. Mr Peter Carey Chief Executive chairs the forum and high levels of collaboration to ensure the most vulnerable are responded to during the COVID-19 pandemic. The last meeting discussed the vaccination roll out and an update on responses from members.

### **Rural Development LEADER**

Projects were approved by the LCDC/Local Action Groups (LAG) on 26 May totalling €84,809.62

- Robert Kirwan Forestry was grant aided €48,060 towards specialist equipment to develop his enterprise.
- Maynooth University Barnhall Rugby Football Club was grant aided €19,999.62 towards a lighting initiative to upgrade their facilities.
- County Kildare LEADER
   Partnership were grant aided
   €16,750 towards the delivery of a Smart Villages training programme in County Kildare as an in house project.

The Department of Rural and Community Development recently announced addition Transitional Programme funding under the LEADER programme for 2021 and 2022.

County Kildare has a confirmed commitment of €1,076,236 to allocate to projects. An additional EU (EURI) budget is being negotiated with an additional €478,327 available when agreed to spend on LEADER projects in Kildare.

### **Key Activities**

Inter-county travel recommenced in May which provided a boost to the tourism and hospitality businesses throughout the county, in particual outdoor attractions and golf courses. As hotels and restaurants prepared for reopening in June, ongoing calls were made by Kildare Fáilte to support.

At the Into Kildare industry meet-up, Fáilte Ireland presented the latest customer sentiment research and





shared marketing plans as well as supports available for industry. Fáilte Ireland presented their domestic marketing campaign, Keep Discovering, to industry and the campaign officially launched.

Kildare Fáilte continued their collaboration and communication with monthly calls in particular with a focus on content for the Fáilte Ireland Keep Discovering campaign. Plans for promoting Kildare as a destination across all media channels is underway and due to commence mid-August, following the funding Fáilte Ireland received on behalf of Kildare last August.

Kildare Fáilte took part in a digital workshop for tourism businesses in Ireland's Ancient East which was organised by Fáilte Ireland and attended by tourist attractions, accommodation providers and other tourism boards from the region.

The monthly Shackleton Museum
Project meeting took place, of which
Kildare Fáilte is on the Marketing
Steering Group. Kildare Fáilte also
attended meetings to discuss the
support and promotion of the Derby

Festival in June and meetings of the Thoroughbred Country Committee.

The Royal Canal Greenway Marketing Group met to agree on the communication plan for the remainder of 2021 and up to March 2022, including press and fam trips and filming.

Kildare Fáilte attended the Association of Irish Professional Conference Organisers (AIPCO) conference, Power of the Past, Force of the Future, which looked at how business tourism can recover from the pandemic. Overall there was a sense of optimism with some concern regarding flight schedules and travel arrangements for inbound tourists.

Media coverage in May concerned the reopening of tourism attractions and encouraged visitors to take their staycation in Kildare this summer. Kildare Fáilte placed a full page advert in the Holiday at Home supplement across 14 titles, and secured editional in the same edition. To support this activity, there was also a podcast interview with the CEO of Into Kildare which will boost the profile of Kildare as a destination.





Social media content in May focused on accommodation providers promoting mid-week breaks throughout the summer, golf, dine at home and activities for families. Kildare Fáilte also ran a competition to win a dine at home box from the Cliff at Lyons.

Visitor engagement across all social media channels remains strong with a new suite of weekly posts inviting users to recommend their favourite places in Kildare. The most popular content was staycation offers and outdoor activities. The message, We Care in Kildare, and support local continues to be a key priority.

#### **Creativity in Older Age**

#### 'Making MAC Project'

The Making MAC Project received funding under The Creative Ireland Programme in response to the Creativity in Older Age Scheme. This project centres on supporting positive ageing groups in communities in Kildare to explore, discuss and question artworks from the Kildare County Council Municipal Art Collection, through gentle, but structured conversation. These sessions will take place online (in live format) with facilitator and artist Vera McEvoy. This experience is aimed at people in isolation, in nursing homes and care settings, those feeling a sense of loneliness, family members, friends and neighbours. Phase 1 begins in June with nursing home residents followed by individuals in the community in September.

# Support - Live Performance Industry

Kildare County Council has recently secured funding from the Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media for the new Kildare Local Live Performance Programming scheme.

The award (€143,000) will support the creation of employment opportunities for local professional artists, technicians, crew, engineers, designers, and other support staff working in the live arts and culture sectors in county Kildare. It aims to assist producers, promoters, and venues to programme outdoor live performances in summer 2021 animating town centers for local communities, should public health considerations permit. The call out for expressions of interest, managed by Kildare Arts Service, closes on 23 June.

#### **Supporting Artists' Development**

Kildare County Council, through the
Arts Service, continues to provide
professional development supports to
artists working and living in the county,
through collaborations and
partnerships with arts and educational
organisations:

23 June: Visual Artists Ireland (VAI) presents a webinar exploring new methods in which Irish artists are presenting their work in non-traditional formats. This event is part of a collaborative series of webinars





between VAI and Kildare County
Council Arts Service, combining
resources to support the professional
development of visual artists at
regional level.

24 June: Community and Youth Work students at Maynooth University will showcase films created as part of their participation in the pilot Artist in Residence Scheme with Young Irish Filmmakers (YIFM), supported by the National Youth Council of Ireland (NYCI) National Youth Arts Programme and Kildare County Council Arts Service. This showcase is programmed as part of the 'What's the Story?' conference, hosted by the Centre for Youth Research and Development, Maynooth University (24 and 25 June).

#### **Parks**

#### **Castledermot Playground**



The playground opened for the June Bank Holiday Weekend. It features 20 different types of play equipment most of which was chosen by the local community after an extensive consultation exercise. These include a tube slide and multi activity unit, double zip wire, trampoline, swings including an hexagonal swing, adventure trail, sensory play panels and mud play area. The playground was built by Gardenescapes. The playground was funded from development levies, local property tax and a grant from the Department of Children and Youth Affairs. It cost €180,000. Part of the works also involved creating a new paved entrance, circulation paths and landscaping around the Fairgreen. All this work was carried out by locally based Walsh Civil Engineering. This cost €200,000 and was funded from the Community Enhancement Programme and Leader funding.

#### **Allenwood Playground**

Work on the tendering process has been temporarily paused pending the appointment of a replacement staff member for the Parks Team. This is unfortunate but could not be helped.





As soon as is practicable the process of tendering for the playground will recommence. The objective is to have a tender ready by the end of the year and for construction to take place in 2022.

#### **Tree Works Programme**

The tree works programme for the Kildare-Newbridge Municipal District has been completed. Works have started on the Naas and Athy Municipal District Programmes and works are due to start on the Celbridge-Leixlip Municipal District works programme this month.

#### **Leixlip Playground**

A consultation exercise with local children is underway to ascertain their views on the playground in Leixlip.

This will inform the upgrade of the playground.

#### **MERITS – Innovation Hub**

Having recommenced at the beginning of May construction on the building has gathered pace with the main contractor on schedule to finish in early July. This will be followed by internal ICT and furniture fitout, with the MERITS and LEO teams moving in during





August, followed by the StartUp tenants in September.

The initial Accelerator programme recently finished with 11 companies pitching to a team of investors and advisors, including some of the leading Venture Capital firms in the country. A number of the companies are now in negotiations with those investors with a view to securing investment to fuel their growth. A further 11 companies are now enrolled on a Pre-Accelerator Programme and are undertaking deep market research and customer validation exercises.

On 02 June, MERITS and LEO hosted a webinar on Finance Options for StartUps and SMEs, with speakers from SBCI, Spark Crowdfunding, LinkedFinance, Flender, EI, LEO, Grant Thornton, Halo Business Angel Network and the Irish Venture Capital Association. A new website was also launched and is available for viewing at <a href="https://www.merits.ie">www.merits.ie</a>.

#### **Equine Tech Innovation Hub**

Construction has commenced on the development of a National Equine Innovation Centre at the Irish National Stud. The project is an exciting partnership between Kildare County Council, Kildare Local Enterprise Office and the Irish National Stud. The first of its kind for the equine sector in Ireland, the innovation centre will facilitate and promote enterprise, innovation, applied research, commercialisation and learning.

The transformation of the existing museum at the National Stud into a 14-desk workspace complete with a dedicated meeting room has been funded with the support of County Kildare LEADER Partnership and Kildare County Council. Following a competitive tender process, GPD Building Contractors will carry out the refurbishment works and the project is being managed by Vivian Cummins Architects from Athy.

Following a 16 week construction programme, it is anticipated that companies will being to locate at the equine innovation centre in September.
