



## Chief Executive's Management Report – October 2021



#### Access to Public Offices

The Council's COVID-19 Team working with the Council's Business Continuity Group continue to support Management Team to apply the relevant public health advice in relation to the management of COVID-19 in our workplaces while continuing service delivery in a safe and sustainable manner across Council facilities/premises.

As outlined in *Reframing the Challenge: Continuing our Recovery and Reconnecting*, important and necessary public health guidance will remain in place after the 20 September and until the 22 October, 2021. This includes the requirement for physical distancing, the wearing of masks and appropriate ventilation along with the continued requirement for self-isolation / restricted movements for those with symptoms. These requirements remain as a core component of our response to prevent the spread of COVID-19. The situation will be reviewed in line with decisions of government and public health advice post 22 October 2021.

With restrictions and remote working continuing through the current phase of *Reframing the Challenge: Continuing our Recovery and Reconnecting* access to our public offices is by appointment only.


#### Draft Register of Electors 2022/2023

Kildare County Council is currently preparing the Draft Register of Electors for 2022/2023. This Register of Electors will come into effect as the Live Register of Electors on Tuesday, 15 February 2022 and is used at every election and referendum held during the following 12 months.

Persons aged 18 or over on Monday 15 February 2022 and ordinarily resident in the constituency on 01 September 2021 are entitled to be included on the Register.

In addition, the following categories of persons may apply for registration as postal or special voters:

- Studying full time at an educational institution in Ireland, which is away from your home address where you are registered.
- A member of the Garda Síochána.



- Diplomats and their spouses.
- Electors with a physical illness or disability residing in a Nursing Home, Hospital or similar care facility.
- Electors with a physical illness or disability residing at home but unable to go to a polling station.

- Unable to vote at your polling station because of your job or service.
- Unable to vote at your polling station because you are in prison as a result of an order of a court.

#### **Budget 2022 Meeting**

Commercial Rates Waiver for Quarters 1, 2 and 3 of 2021 On 30 December 2020, the Government announced a waiver of Commercial Rates for certain businesses, for the first quarter of 2021. This exemption was extended in February for the second quarter until the end of June 2021. As part of the Government's Economic Recovery Plan on 01 June the rates waiver was extended for a third quarter until the end of September 2021. Kildare County Council has applied this nine-month waiver to 2,421 properties in the county totalling €13.6m.

#### 2020 Audit

The Local Government Auditor is currently auditing the 2020 Annual Financial Statements.

Finance Customer Portal and App for Rates and Rent Customers In July 2021 the Finance Department launched a new customer portal and app for Rent and Rates Customers. These new services allow rates and rent customers to make payments and view their account information online via their smartphone, tablet or PC.

There are currently 1,700 rent customers and 750 rates customers signed up for the service. Over €200,000 of payments have been processed through the service since it's launch just over a month ago.

Housing for All: A new Housing Plan for Ireland

**Social Housing Delivery Targets** By letter dated 20 September 2021, the Minister for Housing, Local Government and Heritage confirmed the targets for social housing delivery for Kildare for the period 2022 to 2026 as follows:

"Build" includes delivery under the various local authority and approved housing body build schemes, in addition to all Part V delivery.

For comparison the council targets for the period 2018 to 2021 under the Rebuilding Ireland: Action Plan for Housing and Homelessness were as follows: Build/Acquisition/Leasing Target = 2,426 Build Target = 1,626 Note: On target to exceed the council's overall target for 2018-2021 by 240 plus [est.] units.

#### Some initial points to note:

Social housing delivery targets are focussed on new build.
 Note: meeting this target for new build will be challenging for Kildare given the limited land available in our land bank that is suitable for social housing delivery and the difficulties competing in a strong market to acquire additional lands.

- No targets for acquisitions under Housing for All; social housing acquisitions capped at 200 per annum nationally.
- Long-term leasing will be ended under Housing for All by 2025; provision for 200 short-term leases per annum.
- Targets awaited for affordable housing delivery.
- Resourcing of housing delivery teams to meet the demands of Housing for All is currently under review by the Department for Housing, Local Government and Heritage. Note: further details awaited.

Each local authority to prepare a Housing Delivery Action Plan by December 2021. The Act provides for the regulation of Approved Housing Bodies (AHBs) for the purposes of protecting housing assets provided or managed by such bodies. It seeks to support stronger governance, financial management and reporting, property and asset management, and tenancy management by AHBs, with a focus on safeguarding the significant public investment being made in the delivery of social housing by AHBs.

## Homeless Services Homeless presentations remain high with increased presentations from families.

## Update from National Homeless Leads Meeting The National Homeless Leads COVID-19 meeting was held on the 28

September and there continues to be no positive cases of COVID-19 in Homeless Services in the county.

#### **Tenancy Support**

There are currently 42 active tenancy support cases in the county with 10 new cases taken on in September 2021. 15 Families having received tenancy supports have moved on from this service.

#### Homeless HAP (HHAP)

There were seven new HHAP tenancies for the month of September. HHAP Officer has been in contact with 36 families who have been served with Notices to Quit however there has been a significant slow down in the availability of properties for HHAP.

## Kildare County Council Homeless Outreach

The Outreach team have recently engaged in the integrated services approach to homelessness.

This model uses a collective solution focused approach to addressing homelessness and focuses on building skills required to sustain a tenancy with supports from required agencies.

This engagement has taken place in the Athy, Kildare-Newbridge and Naas Municipal Districts to date and it is intended to extend this to the remaining municipal districts in the coming months. It is anticipated that this will have a positive impact on reducing rough sleeper numbers and on reducing single adults entering homeless services in Kildare.

#### Family Hub Events

A series of family events for children residing in emergency accommodation is commencing this week with crafts and storytelling for pre-school children in our family hubs. There are six events including two outdoor events in gardens at family hubs in Athy and Prosperous, weather permitting. This is a collaborative approach involving staff from the Homeless Team, Library Services and PMcVT. At present there are 15 children of preschool age in the family hubs and a safe space will be created for everyone to engage and participate. Each family will attend indoor events in their own bubbles.



As the demographic of the families within the hubs is quite fluid, events will be curated in consultation with the families and case workers in the hubs on an ongoing basis to tailor events to a family's needs.



#### **Number of Allocations**

Allocations continued in September and included allocations to Kildare County Council and Approved Housing Bodies (AHBs) units. Allocations were made to Whitewell and Barnhall and several transfers were also facilitated. All allocations took place within the controls and restrictions of COVID-19.



#### **Traveller Community**

Traveller accommodation continues to demand resources in terms of both the halting sites and roadside encampments. Demands on the council's social work service is high and the team are maintaining daily contact with traveller families, particularly those who may be at risk or vulnerable.

## Applications under the Self-Help Scheme 2021

87 applications were successful and were notified. Due to current Covid related restrictions, the deadline for completion of approved work under the Scheme has been extended to 31st January 2022 and the successful applicants have been notified of this.

## Planning and Strategic Development

### **Infrastructural Projects**

### Contract 2A (Newbridge Eastern Interceptor Sewer)

These works were completed and commissioned in 2020. The sewerage network is due to be handed over to Irish Water/Kildare County Council Operations by the end of Quarter 4 2021 pending all operation outstanding issues and HSQE issues are addressed.


The pumping stations are being operated by the contractor for a 12month proving period before being handed over to Irish Water/Kildare County Council Operations in the Autumn of 2021.

### Contract 2B (Network)

Works commenced on site in September 2019 and are advancing well. The major pipeline improvement works carried out in Clane and Newbridge are substantially complete. The remaining permanent reinstatement works in Pairc Mhuire commenced on Monday 13 September. Pipelaying works in this area were only completed in May of this year and hence the permanent reinstatement works are actually planned to be carried out ahead of time in this instance. Coffey's have engaged a sub-contractor to carry out these works and the intention is that all of the reinstatement will be carried out together including the green area.

Some pipeline works continue in Naas off the Monread Road. Permanent road reinstatement has commenced in Clane town centre. Upgrade and improvement works are continuing at Clane, Monread and Sallins pumping stations.

Osberstown Sludge Treatment Facility - Design Build Operate (DBO) Contract Variation Veolia Water Ireland advanced works on this variation to the Design Build Operate (DBO) contract and completed these works in Quarter 4, 2020. Operational commissioning of the Thermal Hydrolysis Process Plant is continuing. The Exelys Thermal



#### Maynooth Transfer Pipeline

This project involves the upgrading of the existing Maynooth Sewerage Pumping Station and the construction of a new sewerage pipeline along a new route from the pumping station to the Leixlip Wastewater Treatment Plant. This project is at planning and detailed design stage. Irish Water and its representatives are

currently negotiating with affected landowners and Irish Water have published a Compulsory Purchase Order (CPO) for this scheme in late September as option agreements have not been reached with all landowners.

### **Capital Projects**

Allenwood Sewerage Network (Vacuum System) Modification While funding constraints have emerged on the part of Irish Water in light of the current COVID-19 crisis, the council continues to work with the utility to progress a temporary solution. This involves laying new pipe, land acquisition and temporary pumping arrangements to transfer sewage from the buffer tank to the public gravity sewerage system and on to the Allenwood Wastewater Treatment Plant (WWTP) for treatment and disposal.

It is hoped that the land acquisition can be completed reasonably quickly so that these temporary works can be arranged and completed in 2021. Consultants have been appointed to progress the longer-term pumping solution at the buffer tank site.

### Timolin Waste Water Treatment Plant (WWTP) Upgrade

Irish Water confirmed that the green light has been given for the upgrade of Timolin Wastewater Treatment Plant as part of the Small Towns and Villages Growth Programme. This will unlock growth and development by ensuring the treatment infrastructure is in place to meet the needs of the community. There is no time line available at this stage. This follows the announcement of the upgrade of





Derrinturn Wastewater Treatment Plant already this year. the final sections of existing mains within Assumpta Villas.

#### **Rowanville BYSS**

There is currently one property remaining within this scheme whereby customer consent has not yet been obtained. Decommissioning works have yet to commence. This work will commence once consent from the final customer has been provided and the properties service connection is installed.

All public and private side watermain installation works have now been completed as part of this scheme. Prior to the decommissioning of the existing cast iron watermains throughout Lourdesville, further investigational works are required to ensure all properties are connected to the new supply. It is now expected that these works will be completed in Quarter 4 of 2021.

### Assumpta Villas BYSS

There are currently two premises remaining whereby customer consent has not yet been obtained throughout Assumpta Villas. Private side service connection works have still to be completed at each of the remaining properties prior to decommissioning



### Environment

Pre-Draft Notice of Preparation of the "National Waste Management Plan for the Circular Economy" The three Regional Waste Management Planning Offices have given notice of intention to commence preparation of the "National Waste Management Plan for a Circular Economy" to replace the existing Regional Waste Management Plans. The current plans are available on www.mywaste.ie

### **Civic Amenity Facilities**

The two civic amenity sites continue to operate as normal.

### **Recycling Banks**

Tonnages at recycling banks continue to reduce in line with recent trends. In September 2020, 427 tonnes of glass and cans were recycled at the recycling banks. In 2021, this reduced to 368 tonnes, in line with previous years. All the recycling banks sites were cleaned this month by a specialist contractor with further works planned to improve signage, landscaping etc. **Enforcement Priorities 2021**

All the council's cemeteries remain open to the public.

### **Environment Complaints**

Pollution complaints will be investigated in accordance with national guidelines.

### Domestic/Commercial Refuse Collections

Domestic and commercial waste collections are continuing as normal. Domestic waste collectors have however been granted permission by the National Waste Collection Permit Office (NWCPO) to carry out collections outside of their conditioned waste collection hours due to COVID-19 restrictions. ### **National Tidy Towns**

The National Tidy Towns competition will proceed this year, with the adjudication being done remotely. The Environment Department is supporting the entrants by providing grants to facilitate works, as well as offering advice on the wide range of areas covered by the competition.

There are 41 groups in County Kildare and 32 of them have entered the Supervalu Tidy Towns competition.

Grants are currently being processed.

### Anti-Dog Fouling Initiative

An anti-dog fouling initiative was carried out in each of the five municipal district areas. The wardens and staff from the Environment Department met with councillors in Naas, Athy, Kildare, Maynooth and Celbridge to hand out dog waste bags/dispensers to passing walkers. Stencils and an audio message reminding them to dispose of the waste were placed in each of these areas. There are plans to continue the scheme in several other areas suggested by the Community Wardens.

#### Green Kilometre Scheme

The Kildare Green Kilometres has been shortlisted for the Chambers Ireland Local Authority Awards under the Sustainability category. Kildare

County Council continues to support these groups by providing clean up equipment and collecting the waste in a timely fashion. Over 130 kilometres registered and well over 50 tonnes of waste gathered in the year to date.

### **Environmental Education**

In line with Government guidelines, all in-person educational talks and events are suspended until further notice in the interests of public health and will be rescheduled at a later date where feasible. The Green Schools programme has continued in a number of schools and online assessments are now taking place in order to award the green flag. While the number of flags awarded will be substantially down on previous years, many schools are organising themselves to participate over the coming year. ### Civic Amenity Site North – Near Celbridge Consultants have been appointed to progress this project to the next stage

which will involve seeking expressions of interest from the market.

### Anti-Dumping Campaign and Litter Initiatives The national "My Country/County/Town/Village My Waste" campaign was promoted locally through print and social media.



This campaign is to highlight the consequences of dumping on the wider community. Anti-Dumping Initiative funding secured from the Department of the Environment, Communication and Climate to the tune of €69,440 for seven separate projects county-wide. These projects are all in progress with the majority scheduled to be completed by end October 2021. A free Mattress and Couches recycling day was successfully held at Silliot Hill Civic Amentiy Site on Sunday 03 October 2021. The event was very successful and exceeded the volume of waste taken in during the same event in 2020.



### **Catchment Flooding**

Catchment Flood Risk Assessment and Management Study (CFRAMS) A steering group with the Office of Public Works (OPW) has been established to progress the consultant's brief for schemes within Kildare. The municipal districts will be briefed as schemes from the Catchment Flood Risk Assessment Management (CFRAM's) Programme commence

#### Morell Flood Management Scheme

Construction of this scheme is continuing, with embankments and walls in the Tuckmilltown and Turnings areas nearing completion and further works in Tuckmilltown, Killeen and Killeenmore commencing. Further details of the scheme can be found at: https://www.morellfms.ie/

### Athy Flood Relief Scheme

The Kildare County Council and OPW Steering Group has commenced developing the scope of the Athy Flood Relief Scheme. The first stage will be the procurement of consultants to carry out the design of the scheme and documentation to advance this is being currently being drafted.

### Naas Flood Relief Scheme

The contract for consultancy services for the Naas Flood Relief Scheme has been awarded to ARUP. The first stage of the scheme will be a review of the existing hydrology and mapping. Topographical and drainage surveys to facilitate this has just been completed. Further details of the scheme can be found at:

#### Kerdiffstown

Wills Bros Ltd was appointed in October 2020 for the remediation of the landfill and the construction of the park.

The capping of the site is progressing well. Most of the internal movement of waste is now complete, with Zone 1 lined and now receiving subsoil and topsoil capping, as seen below.



The construction of the site compound is continuing, with Mechanical and Electric works commencing. The ponds in Zone 4 are now lined and covered with soil, as can been seen in the photo below.



The changing rooms walls construction has just commenced, as per the photo below

Monitoring of the gas and groundwater boreholes as well as the management of the leachate and gas continues, in accordance with the Environmental Protection Agency (EPA) Licence. This will continue through the works.

### **Cemetery Capital Programme**

This programme, which includes cemetery extensions, capital type internal improvements and proposals for columbarium walls is currently being reviewed and is likely to be intensified.

### Kildare Town Cemetery

Works on significant improvement work to the St. Conleth's Cemetery were completed in September 2021. Some additional work is being planned to aid with waste management.



Newbridge Cemetery Carpark Tenders will be advertised by end October 2021 for the resurfacing of the carpark, together with new boundary fencing and barrier system. It is proposed to also proceed with the installation of a pedestrian crossing as part of these works in conjunction with the Roads Department.

### Newbridge Cemetery Road and Path Resurfacing

Tenders have been advertised for some footpath and roadway improvement works and it is proposed to commence the works during November 2021.

### **Ballymore Eustace Cemetery**

New paving works were carried out around the old Altar and other minor improvement works in the cemetery are completed.

### **Cemetery Maintenance Grants**

Cemetery Maintenance Grants, to assist local groups with the maintenance of cemeteries, are currently being processed.

#### **Risk Management**

2021 cycle is now complete and presentations are being made to Audit Committee on a rota basis of departmental risk registers, commencing with Water/Environment/ Climate and Corporate Services.

The Climate Action Regional Office (CARO) works to support its constituent local authorities to drive climate action projects in their counties, with particular focus on implementing actions contained within climate adaptation strategies. A number of projects are ongoing across the Eastern and Midlands Region:

### **Capacity Building**



LOCAL AUTHORITY Climate Action Training Programme

The CARO continues to work with its strategic training partners, to implement on behalf of the local government sector, a national training programme for all elected members and local authority staff. The training programme, which includes six pillars and has received CPD accreditation from a number of bodies (Engineers Ireland, Irish Planning Institute, CIWEM), are available to all local authorities:





Elected Members/Senior Staff The Climate Leadership training for senior staff and elected members has been delivered to a total of 632 participants in 19 local authorities to date, with a further six scheduled to year end. The remaining six counties will be completed in early 2022. To date, in excess of 700 senior staff and elected members have completed this module.



### **Climate Action Teams**

This highly collaborative programme, with contributions from Met Éireann, Climate Ireland, the CAROs, the SEAI, the AIEI (Association of Irish Energy Agencies) and the IPA, is aimed at members of local authority Climate Action Teams. It is scheduled to be rolled out to remaining counties (including Kildare), in the Eastern and Midlands CARO in October c. 220 people have already registered.



**Online Training** The rollout of the Raising Awareness online training programme is ongoing;

To date, a total of 6,563 staff at Grade 7, Grade 6, Grade 5 and technical equivalent level have completed this programme across each of the 31 local authorities. The programme has recently been rolled out to Grade 4's and their technical equivalent and this means that a further 2,997 people have been enrolled in the training.

- - Impact of Climate Change on Flood and Water Management. Pilot training was held on 27 September.
  - Older Persons Council on raising awareness on climate change and climate action.



### **Thematic Training**

In the first training course of the Actioning Policy training pillar, the Planning for Climate Change training has been rolled out to 291 local authority planners of all disciplines.

Other training courses falling under the Actioning Policy pillar are at various stages of design and progression towards delivery:

 Procurement Officers on promoting green procurement through supply chains. Tender process for trainers underway.



### **Outdoor Staff**

LASNTG are currently recruiting an inhouse trainer to deliver this programme to outdoor staff on a county by county basis.



### Frontline Staff

Training for front line or community engagement staff remains under design and development with the Institute of Public Administration with pilot training scheduled for December this year.





### Guidance for Local Authorities – Preparing Local Authority Climate Action Plans

The Eastern and Midland CARO working in partnership with the EPA / Climate Ireland have recently commenced work on the development of Guidelines for Local Authorities on preparing their Local Authority Climate Action Plans. An expected deadline of 05 November for completion of the guidelines is anticipated. As per the provisions of the Climate Action and Low Carbon Development (Amendment) Bill 2021, each local authority will be required to prepare and make a Climate Action Plan containing mitigation measures and adaptation measures, to be adopted by the local authority. The guidelines are an expressed provision of the Amendment Bill also. These guidelines will support local authorities in terms of both the content and the process of making their own Climate Action Plans and will be ready for submission to the Minister for the Environment,

Communications and Climate in early November.



Sub-Regional Energy Projects The CARO are working with local authorities in each of the four subregions to develop regional energy bureaus or regional energy efficiency projects.

In the Mid-East (Kildare, Meath, Wicklow, Louth): A position paper for pathfinder support has been developed and is currently under review by SEAI. The three local authorities involved (Kildare, Meath, Wicklow) are meeting regularly and it is hoped to progress this further before the end of the 2021.

In the Border sub-region (Cavan, Monaghan, Leitrim): A public building energy efficiency report for the three local authorities went to tender, with Codex Energy being appointed.

CARO has been successful in receiving funding from the SEAI



Project Assistance Grant (PAG) Programme for the respective local authorities and this grant may cover up to 50% of the costs of the report.



### **Decarbonising Fleet:**

The vision of this project is to develop a pathway for decarbonizing local authority fleet with a view to realizing emission reduction and energy efficiency targets. A working group is being established under the stewardship of the CCMA Climate Change, Transport and Networks Committee and will include representatives from the CCMA Committee, the LGMA, the Eastern and Midlands and Atlantic Seaboard South CAROs, the SEAI and Local Authority representatives from counties Cork, Kilkenny, Dublin City and Donegal, as well as the Department of Transport and the Office of Government Procurement.

## Coastal Erosion Challenges for Local Authorities:

The Eastern and Midlands CARO, in collaboration with the Atlantic Seaboard South CARO are currently establishing a sectoral level working group to identify the various challenges and opportunities for local authorities in dealing with coastal erosion issues in their jurisdiction. This working group will ultimately support the development of guidelines for council engineers and planners.

### Kildare County Council Climate Action

## Climate Change Adaption Strategy (CCAS)

CCAS Action Reporting is being finalised for the country by Eastern and Midlands CARO with input from the individual county's Climate Action Teams. The number of actions being undertaken and completed by Kildare continue to increase with the final data to be released.

### Sustainable Energy and Climate Action Plan (SECAP)/Climate Action Plan (CAP)

It is a requirement under the Covenant of Mayors and will be a requirement of the amended Climate Action and Low Carbon Development (Amendment) Bill that Kildare County Council prepare a five-year Sustainable Energy Climate Action Plan/Climate Action Plan (SECAP/CAP). The successful tenderer has been identified and initial meetings have taken place between Kildare County Council and the consultant. Contract terms and conditions have just concluded and works on SECAP/ CAP are to commence immediately.

### Decarbonising Zone – Maynooth Nominee



The Climate Action Office, while awaiting the guidelines from the Department, is progressing the likely needs of the challenge ahead to decarbonize by 7% per annum between 2021 and 2030. To this end the team is aligning collaborations within and outside the council, is progressing funding opportunities for the local community and council, developing linkages to create a steering group and sub groups with stakeholders, seeking business opportunities, policies and projects established or in development, developing methods of citizen engagement and researching findings from other initiatives. It is envisaged this background work through the lens of climate action will inform the implementation plan and potential actions to create a proactive and achievable approach. The Climate



Action SPC is being made aware of progress to inform its work.

### Energy

**Energy Management Team** Kildare County Council's Energy Management Team has been meeting monthly since its re-establishment in February 2021. The Energy Management Team is currently progressing several key areas, including the development of Kildare's register of opportunities (projects, initiatives for energy savings), analysis of Kildare's top twenty energy users and potential areas for reducing their energy consumption. The Energy Management Team has strengthened its membership with a representative from Fire Services and Libraries. It is hoped to have a representative from Leisure Facilities in the near future. The Energy Management Team is evaluating the benefits of applying for ISO 5001; this being a recognised energy management standard being adopted by many local authorities and other public bodies to assist in reducing energy consumption in a standardized manner.

Kildare Climate and Energy Week (26 October to 29 October)

The Event Team have now moved to planning and delivery phase, with the key direction on the event being to demystify climate and energy topics and mainstream awareness through engaging and interactive events. The Event will also host a mix of in-person and online platforms.

The event itself will be targeted at both the internal workings, staff of Kildare County Council and outward looking to the wider communities within the county.

There is a comprehensive communications plan for the Event to ensure maximum exposure through local media and online social media sources. The Event is also being supported by SEAI and Creative Ireland.



### Energy Usage Monitoring and Reporting (M and R)

Kildare County Council continues to make good progress on reducing its energy usage across the council. Our provisional scorecard for energy usage in 2020 shows a 33.3% energy reduction against its baseline year of 2009, which is significant progress from the 2019 figure of 24%. Although this is a provisional figure from Sustainable Energy Authority of Ireland (SEAI) it shows continued progress on energy efficiencies and also meets the National target of 33% reduction by 2020.

### Mid-East Energy Bureau

Kildare County Council is engaged in a process with other local authorities to form an Energy Bureau to drive energy efficiencies at a regional level. It is proposed to establish the Bureau with the assistance of SEAI's pathfinder program which will assist with funding towards energy related projects across the region and also funding for the Bureau establishment and staffing needs over a fixed period of time. Currently Kildare, Wicklow and Meath Local Authorities are partnered to deliver this initiative, with support from CARO. Kildare's Energy Efficiency Officer is also assisting with a subgroup of the Bureau establishment Team to develop tender documentation to procure a suitable consultant to drive this project.



Kildare County Council continues to make good progress on Sustainable Energy Communities in the county. There are currently 22 SEAI registered SEC's in County Kildare, with four of these nearing the end of their energy master plan stage which will allow them to move to the action phase. Further strengthening of the Energy Master Plan process has been developed by SEAI, which now includes greater structure and guidelines to ensure quality standardized Energy Master Plans are



delivered. Kildare County Council can now also utilize a EMP delivery framework structure established by CODEMA.

It is expected that three other established SEC's in Kildare are considering applying to Kildare County Council for support in delivering their energy master plan.

The Climate Action Office is considering working with Codema to streamline the administration of the system for all parties involved.

### Fleet Electrification



The CCMA has recently published its Electric Vehicle Guidance Document for Local Authorities; this is a welcome development which gives direction for LA's as demand for public EV charging and fleet electrification grows. Kildare County Council's suitable small vehicle fleet can also be considered for electrification. We currently have four EV vans in our fleet but there is growing interest in the electrification of other suitable vehicles in the fleet. Some Municipal District Offices have also expressed interest installing electric vehicle charging points in their depots to facilitate EV charging. As fleet electrification starts to embed in Kildare County Council through infrastructural changes and greater awareness of EV's it will also be key to facilitate specific EV driving training for all drivers of fleet vehicles to ensure potential EV drivers are fully informed and upskilled in this area.

### Forestry

The finalised document 'Woodland Creation on Public Lands Scheme' was released on 28 May 2021. The project is being advanced by a subgroup of the CAT called, Coillteach Chill Dara. Potential sites are being investigated with the relevant functional areas. Template tender documents for procuring the different elements of this scheme are currently being drawn up by a CARO Working Group and these will be available for use by all local authorities. The CARO is seeking clarifications to inform the application process.

#### Ezine



The Climate Action Office will publish its third edition of the year during the first week of October with a view to circulating widely as a mainstreaming tool.

The edition will have items of relevance to council staff with a sprinkling of fun.

#### **Just Transition**

The municipal districts of Athy, Clane-Maynooth and Kildare-Newbridge have generously contributed €15,000 per municipal district to establish a fund to engage a consultant to develop and prepare a 'Local Just Transition Plan for West Kildare'. Urban Regeneration Limited are working in earnest to finalise the plan by late November and have undertaken consultation with stakeholders of varying backgrounds. Consultation with public representatives is being organised presently. Alternatives to Herbicides Project The Parks/Climate Action Office's project including scientific research together with practical assessment in the field (Kildare County Council Parks Department and National University of Ireland, Maynooth) is designed to produce a practical maintenance guide for public open spaces.

Cork City, Galway City, Meath, Kilkenny, Westmeath, Roscommon Fingal, Offaly Tipperary and South Dublin Councils have confirmed their partnership. Waterways Ireland has confirmed that they will partner shortly and have already worked with us on trials on pavement cleaning.

Sophia Couchman, Masters student, has since June, undertaken field data collection from the research sites, citizen science initiatives, commenced desktop research and initial baseline experiments have taken place on the Millenium Link Road in Naas. During October Maynooth University, Trinity College, NBDC, Teagasc and Kildare County Council are reviewing the data collected to date. Together the potential experiments and follow up research items will be designed to





inform the scientic and practical process during 2022.



Community Stories is continuing to roll out monthly updates and profile posts of those involved in the background and of the work being undertaken.

Work on a circular economy model with regard to disposal of grass not suitable for use as fodder is well advanced with material being sent to Green Generation in late September and October to ascertain it's potential use to create bio-energy. The results of the experiment when known will have the potential to reduce the carbon footprint of maintenance and disposal works.

The Climate Action Office is delighted to be working with various functional areas to enhance their work through a Climate Action lens. We are working with planning to inform

the CDP, community including Age Friendly and Climate Action Plan for Ballymore Eustace, sustainable transport with future community consultation. The Climate Action Office were delighted to be part of the Kildare Town 'Hear my Voice' Community Roadshow Wednesday 29 September to create awareness of Climate Action in the community.



## Roads, Transportation and Public Safety

### **Projects Update**

### M4 Maynooth to Leixlip

The 'M4 Maynooth to Leixlip' is listed as a section of the transport network to be progressed through pre-appraisal and early planning and prioritised for delivery under the National Development Plan 2018–2027. The aim of the project is to assess the needs of the M4/N4 mainline corridor and junctions from Maynooth to Junction 5 Leixlip in terms of catering for future demand from a capacity, safety and operational perspective.

TII deliverables for Phase 1 are now complete and signed off by both

Kildare County Council and Transport Infrastructure Ireland (TII). The scheme has now moved to Phase 2 Option Selection. The scheme will take a number of years to pass through the various steps required for Phase 1 (Concept and Feasibility), Phase 2 (Option Selection), Phase 3 (Design and Environmental Evaluation) and Phase 4 (Statutory Processes), provided it successfully progresses through each phase.

### Athy Distributor Road

The letter of acceptance is to be issued to the preferred tenderer in the coming week. Notices to Treat have been issued. Notice of Entry on lands has been issued. Advance works between Corran Ard and Fortbarrington Road have been completed. The Córas lompair Éireann (CIE) lands have been secured from trespassers. The CIE/IE Bridge Agreement has been signed by both parties and the Waterways Ireland Licence is being finalised. Compensation for compulsory land acquisition is ongoing. The resident engineering (RE) team is currently being procured.



It is expected to have a contractor on site by Quarter 4 2021.

## New Machinery Yard Relocation and Regional Salt Barn

The Part 8 approved development will replace the existing Machinery Yard in Newbridge and will include a new Regional Salt Barn. This barn will provide storage for approximately 22,500 tonnes of salt for use by Kildare County Council and a number of other local authorities in the region.

The Enabling Works Contract undertaken by Clonmel Enterprises Ltd. has now been completed. The design and tender documents for the main contract are being progressed by Kilgallen and Partners Consulting Engineers. The equipment contract tender analysis has been completed and the preferred tenderer will be novated into the main contract. The main contract is due to go to tender in October 2021.

It is expected to have a main contractor on site for Quarter 4 2021.

Maynooth Eastern Ring Road The Clane-Maynooth Municipal District Committee confirmed approval of the Part 8 in respect of Option C, the preferred route, on the 29 July 2019.

Kildare County Council is currently endeavouring to gain control of the lands (identified under the Local Infrastructure Housing Activation Fund (LIHAF) Scheme) as a prerequisite to the CPO going ahead.

Valuers have been appointed. Discussions with Waterways Ireland, larnrod Éireann and CIE are ongoing in relation to the design of the bridge structure which will span the Royal Canal and Dublin/Sligo railway line. Agreement has been reached with Irish Water on the servicing of the lands associated with the MERR LIHAF project. Detailed design of the scheme, including drainage design, is at an advanced stage.

Arrangements are being made for funding discussions with the Department of Housing, Local Government and Heritage (LIHAF), the Department of Transport and the National Transport Authority.



Celbridge to Hazelhatch Link Road Engineering Consultants RPS have been engaged for the Celbridge to Hazelhatch Link Road Project. Kildare County Council was successful in securing funding under Call 1 of the **Urban Regeneration Development** Fund (URDF). The scheme, which will connect Celbridge Town and the Hazelhatch Train Station, will include a second bridge over the River Liffey. The project is currently at Route Selection stage. A four-week virtual Public Consultation on the route corridor options has been completed and submissions have been compiled.

A URDF Call 2 Application for further funding has been successful with Kildare County Council receiving €10,237,500 for this project (75% funding - Kildare County Council to contribute 25%). This will facilitate the development of this project to construction stage.

A public consultation associated with the emerging preferred route will commence in Quarter 4 2021. Newhall Junction Improvement Newhall Crossroads is located on the R445 dual carriageway between Naas and Newbridge. It is the junction of three roads: the R445 the L2031 local road and the L6064 local road. The existing junction is considered unsafe as it is a cross-roads junction on a busy dual carriageway.

A preliminary design for a new roundabout at Newhall has been developed. The Part 8 process has been completed with approval to proceed with the project confirmed at the July municipal district meeting.

Affected landowners are being consulted at present and a decision on whether to proceed with a CPO (rather than by agreement) will be confirmed in early October.

#### Naas to Sallins Greenway

Kildare County Council are currently engaging with the National Transport Authority on this project and have secured funding to bring this scheme to Part 8. Consultants (ATKINS) have been recently appointed. It is



expected to proceed to Part 8 in Quarter 4 2021.

Naas/Sallins Transport Strategy The Naas/Sallins Transport Strategy has been completed and published.

### Athy Area Based Transport Assessment (ABTA)

The Athy Area Based Transport Assessment has recently been completed and the Planning Department have included it in the Draft Athy LAP Process.

### Kildare Town Transport Strategy

The Kildare Town Transport Strategy is currently at draft stage. Meetings with the Kildare-Newbridge Municipal District councillors were held on the 07 April 2021 and the 26 April 2021. The non-statutory public consultation was completed in August 2021. It is expected to have a final document available in October.

Maynooth Transport Strategy AECOM Consultants have been appointed to the develop of the Maynooth Transport Strategy. It is expected to take 12 months to complete and this will facilitate the development of the Maynooth LAP. The first public consultation is to commence on the 06 October and run for six weeks.

**Bridge Rehabilitation Programme** Kildare County Council received funding for 2021 from the Department of Transport for bridge rehabilitation works.

The Monasterevin Bridge has significant structural issues in two centre-pier cutwaters. Emergency works are not deemed necessary at this stage. An application to ABP for an EIAR/NIS approval (as the river Barrow is a SAC) has been approved subject to conditions. It is anticipated that rehabilitation works will be undertaken in Quarter 3 2021.

Four bridge projects funded by the Department of Transport for 2021 have been awarded to TRUIR and are to be completed by Quarter 4 2021.

Brook bridge has commenced the approval process with An Bord



Pleanála and it is proposed to proceed to construction stage Quarter 3 2022.

### Newbridge Southern Relief Road / Second Bridge Crossing

The section of the Newbridge Southern Relief Road (NSRR) between the Newbridge to Naas dual carriageway (R445) and the Great Connell road is now substantially complete and the Roads Planning Section is currently engaging with the developer on the completion of snags, the transfer of lands and the submission of the taking in charge documentation.

Following the unsuccessful application for funding under URDF Call 2, the Project Team has commenced the tender process for the appointment of consultants to progress the project to stage 4 of the TII Project Management Guidelines (Planning Stage). It is expected to award the contract in October 2021.

### Maynooth Inner Relief Street

This road with signalised junctions and a new bridge over the Lyreen River has been substantially completed by Cairn Developments Plc. The Roads Planning Section is engaging with the developer on the opening of the street to traffic, pedestrians and cyclists. The road safety audit stage 3 is being carried out on the completed works. It is proposed to be opened in Quarter 4 2021.

Kildare Town Northern Link Road and South Green Area Access Improvement Scheme The Route Selection Report is substantially complete. This project will not proceed further until the Kildare Town Transport Strategy is completed.

### Royal Canal Greenway – Maynooth to Moyvalley

The Greenway from Maynooth to Moyvalley is now substantially complete and operational. A stage 4 safety audit and snags are now being completed for this project.

### **Targeted Youth Application**

Lorraine Flynn, the ETB Youth Officer for Kildare, presented an overview of KWETB's New Site Submission 2022-2023 to the LCDC on 'UBU Your Place Your Space Youth Funding Scheme'.

The submission is for a targeted youth project in Celbridge to provide out-ofschool supports to young people. The outcome from the application will be known shortly.

Kildare Town Community School Mr John Hayes, Principal, Kildare Town Community School made a presentation to the LCDC on work taking place within the school to address literacy/numeracy issues through innovative programmes. These programmes are based on US and UK models.

### Sláintecare

Athy is one of 19 successful towns selected to be part of the National Healthy Communities initiative. This

will mean greater resources and opportunities for Athy as a healthy town. A dedicated co-ordinator will be employed and work to co-ordinate approaches between Kildare County Council, HSE and Tusla is agreed.

## Community Enhancement Programme 2021

The Department of Rural and Community Development announced Community Enhancement Programme funding of €148,013 for Kildare. There were 32 applications received with 27 approved for funding by the LCDC.

## Social Enterprise Community Grant Scheme

Social Enterprise Community Grant Scheme funding was recently announced to support small capital projects. The funding available under this grant scheme in Kildare is €35,053.13. The closing date for receipt of applications is 15 October at 5:00 p.m., in line with national guidelines. See below for the online application link.

### LEADER Programme

## Kildare Fáilte

At the end of August, the plan for the easing of restrictions was announced starting with the return of live music and outdoor sporting events in September. This was celebrated by many tourism and hospitality providers as they welcomed more people back for live events. This was just in time for Culture Night which was supported by Kildare Fáilte across social media and the Into Kildare website.

Fáilte Ireland continue to offer supports to the tourism industry and

hosted the first in-person business tourism industry briefing in Dublin since the easing of restrictions which was attended by Kildare Fáilte. The shoulder season webinar by Ireland's Ancient East was also attended by Kildare Fáilte, which highlighted how tourism businesses can be supported in the shoulder season. A Fáilte Ireland Keep Discovering Toolkit was shared. Kildare Fáilte attended the Tourism Ireland industry briefing webinar on their new Push the Green Button Campaign to encourage visitors to push the button and book now.



Kildare Fáilte were delighted to continue to host press trips in September and welcomed travel writer Michelle Jackson who experienced the luxury of Kildare and will share her experience in the Irish Independent and the Irish Daily Mail. Futher press trips will take place in October.



Kildare Fáilte participated in a workshop with Fáilte Ireland and Repucon Consulting regarding the Shackleton Museum project. Fáilte Ireland shared feedback from their site visit to the museum and an interactive discussion was held to map out the next steps for the business plan.

The Kildare Fáilte team were invited on a guided walk of the De Burgh Woodland with Councillor Seamie Moore where he shared insights and history on the site with hopes of it opening to the public in the near future.

Kildare Fáilte presented to new tourism businesses setting up on the Barrow Blueway as part of the Local Enterprise Office Start Your Business program. The Royal Canal visitor experience workshop was attended for a review of a report carried out by Sport Ireland. This included putting itineraries in place for journalists and influencers visiting in the coming weeks. Filming took place in Maynooth to create content for the Royal Canal Greenway Autumn campaign 'Your Path to...'.

Media coverage in September encouraged visitors to explore the hidden parts of Kildare they may not have visited before which included magical places to stay in Kildare and outdoor walks to embark on this Autumn.

The Kildare campaign will take place from 27 September as part of the Keep Discovering campaign using the additional funds secured from Fáilte Ireland last August and will run for four weeks across national press and radio. Several Kildare properties also featured in House and Home at the beginning of September in an article featuring 25 of Irelands best design hotspots.

Social media content in September also focussed on hidden gems to visit. Kildare Fáilte supported September, National Bike Week and National Walking Day which encouraged locals to walk and cycle in Kildare. Live music and events were promoted as businesses could welcome audiences back again across all social media channels.

Visitor engagement on all social media channels remains strong with users interested in posts inspiring where to visit this Autumn with places to eat, walk and go with family being the most popular. The message, We Care in Kildare, and support local continues to be a key priority.

#### **Easing of Restrictions**

From 20 September there was an easing of restrictions in all libraries. Public computers are now available, along with print, scan and copy services. Browsing times have been increased to one hour and a higher volume of visits are being accommodated per hour. Remaining restrictions are expected to be lifted in late October.

Kildare Readers Festival 2021 Kildare Readers Festival is brought to you every year in October by Kildare County Library and Arts Service. The festival brings the very best from the world of literature to our audiences through the provision of exciting, innovative, and accessible events. Since its inception in 2010, the festival audiences have continued to grow. This year's festival is a hybrid mix of some live events, some online live events, and some recorded online events. As always, the events are free but do require advance booking, especially the live events being held in the Riverbank Arts Centre. There is a host of amazing authors and artists lined up between 26 September and 17 October, with festival favourites such as Ten Books and Sunday Sessions making their return. With a shared love of history and debate John Bowman and Abie Philbin Bowman are ideal interviewer and interviewee as they discuss John's book Ireland the Autobiography: One Hundred Years in the Life of the Nation, Told by its People. On Saturday night Luke Cassidy's Iron Annie Cabaret is a celebration of music, theatre and literature based on his debut novel Iron Annie. On the Sunday the Kildare Readers Festival welcome writer and artist Sara Baume covering wide ground in the spellbinding audio-visual essay, The Alphabet of Birds, a show about our obsessions and passions. With 24 events to choose from, there is something for everyone. Check out kildarereadersfestival.ie for more information.

Children's Book Festival 2021 The annual Children's Book Festival helps spread the enjoyment of books and reading among children and

families, authors and illustrators, teachers, and librarians all over Ireland. The further promotion and support of the Children's Book Festival is a central tenet of the Right to Read initiative.

This year Kildare Libraries will hold 14 public events and 25 school events across the month of October to celebrate Children's Book Festivals. Authors involved include Helen Corcoran, Kieran Fanning, Paddy Donnelly, and Carmel Uí Cheallaigh as well as some exciting literary based cookery and writing workshops. This year also will include a talk with the Dyslexia Association of Ireland for parents and caregivers on how to best support young people in celebration of Dyslexia Awareness Month.

#### **Reader Services**

Kildare Libraries have purchased copies of the Children's Books Ireland annual reading guide, this year entitled 'Free to be me'. This themed reading guide highlights books that celebrate diversity, representation and inclusion for children and young people aged 0– 18. The Free to Be Me reading guide promotes equity and visibility of diverse stories in both school and

## public libraries, bookshops, and shelves in the home. Every child has the right to be free to be themselves. The guide is available in all Kildare Libraries.

### **Dormant Account Funding**

An application to run a programme of events for Deis schools was successful under the Dormant Account Funding scheme. The programme called "Stories and Science ", combines Storytime, Art and Science inspired by Roald Dahl books. The workshops were completed in September to eight classes, each class participating in a story workshop and it's associated science workshop. The result of the workshops was children either making glue or a wormery with plenty of fun, discussion, stories, and science along the way. The feedback was very positive, and the workshops were described as "The quality of teaching and learning was exceptional."

### Keep Safe Campaign

Keeping Active – Final Phase Kildare Library Service in conjunction with Kildare Sports Partnership organised online talks for secondary

schools to focus on keeping well, physically and mentally. Dr Mary O'Kane spoke on anxiety, it's effects and how young people can take control, Jennifer Ryan spoke on communication and its role in improving relationships and Eric Donovan spoke on Motivation and Resilience discussing his own life and adversity with motivational tips. 11 talks were delivered to four secondary schools reaching 1200 students. The final four talks are scheduled to take place in October.

## Library IT Projects

New Library Management System Civica are the company contracted to supply the new national Library Management System (LMS) which Kildare Library Service hope will go live in March 2022. The new LMS, called Spydus, is an improvement on our current LMS as it is web based and much more user friendly. Kildare Library Service have already begun our engagement with Civica which is going very well with 30 hours of preparatory workshops delivered so far. For the library user Kildare Library Service expect a lot more integrated experience with eServices such as

eBooks accessible from library user accounts as well as the Borrowbox app. Kildare will have its own unique library catalogue as well as a shared Libraries Ireland catalogue.

## Age Friendly Programme

Age and Opportunity are working on an Arts and Creative Charter for Older People. Part of the charter is a survey that began Monday 27 October and closes on Monday 08 November. Naas Library delivered 10 copies of the survey to each of the large branches and seven copies to the smaller branches. Included with the survey was: A letter outlining details of the pack including the survey website link, A Poster, Draft Laminated Charter. The libraries will play a big part in getting this survey completed.

Metropolitan Workshop Architects have been appointed as the Design Team lead and are working with the Public Realm and Special Projects Team and the Library Service on the design in advance of the Part 8 Planning process.

The tender for the Architect led Design Team is complete and successful architect will be appointed in the coming weeks.

## Local Studies, Genealogy and Archives (LSG&A)

#### Access to Collections

Local Studies, Genealogy and Archives are currently based in Kildare Town, to facilitate works to the old county library building in Newbridge. Staff continue to assist researchers, local history groups, and students with research queries. Contact <u>localhistory@kildarecoco.ie</u> or <u>archives@kildarecoco.ie</u> or 087 3611439.

Local History Groups and Schools The LSG&A Department continues to work with local history groups and schools throughout the county. Presentations to schools and local history groups are continuing. Kildare Library Service are also working with the Federation of Local History Groups on its AGM planned for late October, at which we will launch audio recordings of the poems of Thomas Behan who was killed during the Civil War. These recordings of over 15 local historians took place on11 September.

#### Archives

Processing of archival material is ongoing, including the Medlicott Family

papers and the Drummin House archive. Kildare Library Service also received some smaller deposits of archival material.

Work is continuing the development of a Records Management policy and procedures for Kildare County Council. A conservator from Muckross House, Killarney, visited LSG&A to assess some of our material and give advice on possible conservation needed.

Newbridge Library, Archives and Local Studies Capital project Work on the design of the above has commenced and LSG&A facilitated site visits to the collections and visited Wicklow County Library and Archives to view its newly opened premises.

**Decade of Commemorations Plans** Preparatory work on the Decade of Commemorations Programme for 2022 is underway. Feedback has been provided to the Department, which will be issuing its community strand guidelines shortly. A major commemorative event to mark the centenary of the arrival, training, and subsequent mutiny of the Civic Guards in Kildare Town, will take in April 2022, while the centenary of the foundation of the Civic Guard, later An Garda Síochána, is being planned for May 2022. Activities to mark the centenary of the Treaty, the death of Ernest

Shackleton and the outbreak of the Civil War will also take place.
