Accessto Public Offices

The Council's COVID-19 Team working with the Council's Business Continuity Group continue to support Management Team to apply the relevant public health advice in relation to the management of COVID-19 in our workplaces while continuing service delivery in a safe and sustainable manner across Council facilities/premises.

As outlined in *Reframing the Challenge: Continuing our Recovery and Reconnecting*, important and necessary public health guidance will remain in place after the 20 September and until the 22 October, 2021. This includes the requirement for physical distancing, the wearing of masks and appropriate ventilation along with the continued requirement for self-isolation / restricted movements for those with symptoms. These requirements remain as a core component of our response to prevent the spread of COVID-19. The situation will be reviewed in line with decisions of government and public health advice post 22 October 2021.



Kildare County Council is currently preparing the Draft Register of Electors for 2022/2023. This Register of Electors will come into effect as the Live Register of Electors on Tuesday, 15 February 2022 and is used at every election and referendum held during the following 12 months.

Persons aged 18 or over on Monday 15 February 2022 and ordinarily resident in the constituency on 01 September 2021 are entitled to be included on the Register.

In addition, the following categories of persons may apply for registration as postal or special voters:

- Studying full time at an educational institution in Ireland, which is away from your home address where you are registered.
- A member of the Garda Síochána.
- A whole-time member of the Defence Forces.
- Diplomats and their spouses.
- People with a physical illness or disability residing in a Nursing

Home, Hospital or similar care facility.

- People with a physical illness or disability residing at home but unable to go to a polling station.
- Unable to vote at your polling station because of your job or service.
- Unable to vote at your polling station because you are in prison as a result of an order of a court.



Finance and Information Technology

Commercial Rates Waiver for Quarters 1, 2 and 3 of 2021

On 30 December 2020, the Government announced a waiver of commercial rates for certain businesses, for the first quarter of 2021. This exemption was extended in February for the second quarter until the end of June 2021. As part of the Government's Economic Recovery Plan on 01 June the rates waiver was extended for a third quarter till end September 2021.

Kildare County Council has applied this nine-month waiver to 2,421 properties in the county totalling €13.6 million.

Small Business Assistance Scheme for Covid (SBASC)

As part of the Government's Economic Recovery Plan on 01 June SBASC for Quarter 2 scheme was announced. The scheme went live on the 10 June 2021. The closing date for receipt of applications was 21 July 2021. Small and medium-sized enterprises (SMEs) and microenterprises can apply for a

grant of €4,000 for those with turnover above €50,000 and €1,000 for microenterprises with a turnover of between €20,000 and €49,999, This scheme has been extended to include those businesses that are operating from non-rateable premises such as a home office or hot-desk. To date 59 grants of €4,000 have been paid out amounting to €236,000 and 8 grants of €1,000 have been paid out amounting to €8,000. This scheme is now closed.

2020 Audit

The Local Government Auditor is currently auditing the 2020 Annual Financial Statements.

Finance Customer Portal and App for Rates and Rent Customers

In July 2021 the Finance Department launched a new customer portal and application for rent and rates customers. These new services allow rates and rent customers to make payments and view their account information online via their smartphone, tablet or PC.

There are currently 1,700 rent customers and 750 rates customers signed up for the service. Over €200,000 of payments have been processed through the service since it's launch just over a month ago.

Housing

Housing for All, a new Housing Plan for Ireland was launched on the 02 September. The council awaits specific targets relating to the new plan.

Housing for All provides four pathways to achieving the overarching objective of providing everybody in the state with access to home purchase or rental at an affordable level, built to a high standard and in the right location.

The four pathways are:

- Supporting home ownership and increasing affordability.
- Eradicating homelessness, increasing social housing delivery and supporting social inclusion.
- Increasing new housing supply.
- Addressing vacancy and efficient use of existing stock.

Attached to each pathway are specific objectives, thirty in total.

Housing for All has a budget of €20 billion over a 5-year period, funding will be provided through the Exchequer,

the Land Development Agency and the Housing Finance Agency.

The projected delivery from the period 2022-2030 is:

- Social Homes: 88,400.
- Affordable and Cost Rental Homes: 53,800.
- Private Rental and Home
 Ownership: 170,550.

Following are the main points from the plan:

- Provision of 4,000 affordable purchase properties per annum.
- A local authority led affordable purchase scheme, targeting prices of €250,000.
- A shared equity scheme for private developments.
- Revised local authority home loan.
- Revisions to Part V 20% of developments set aside for affordable and home ownership.
- Provision of an average of 2,000 cost rental homes per annum.
- Phasing out of long-term leasing.
- Strengthened mortgage to rent scheme.





- Reformed Tenant Purchase scheme.
- Revision and reform of eligibility for social housing.
- Eradication of homelessness by 2030.
- Increase in Housing First tenancies to 1,200 over five years.
- Ending of Strategic Housing Development planning applications.
- Revised taxation on vacant sites.
- Increasing funding of the Land
 Development Agency for the development of public lands.
- Planning exemptions for abovethe-shop conversions.
- A nationwide local authority led CPO scheme to purchase vacant homes.

Summary of Social Housing Assessments 2021

We have been directed by the Minister for Housing, Local Government, and Heritage under Section 21 of the Housing (Miscellaneous Provisions) Act 2009, that each housing authority is required to prepare a summary of housing needs of the social housing

assessments carried out in its administrative area. The Minister for Housing, Local Government, and Heritage has directed that the summary be prepared on 17 November 2021. The 2021 summary is the continuation of the process of annual assessments of national housing need, commenced with the 2016 Summary. The applications that require review are Households that are on the waiting list but not reviewed since 30 July 2020.

The key output of the summary remains the net need figure i.e. the number of qualified households on our housing list whose housing need has not been met. It is, therefore, essential that all households included on the list of qualified households meet the criteria of eligibility and need set out in the Social Housing Assessment Regulations, and also that our total figure does not include certain households, such as those on transfer lists or in accommodation provided under RAS or HAP.

Over the coming weeks the housing department will be making contact with applicants on our housing list from 01





January 2011 to 31 December 2015 to ensure these applicants are compliant with the social housing assessment regulations and are still in need of housing. In the meantime we would encourage housing applicants to ensure that their housing applications are up to date.

Homeless Services

Update from National Homeless Lead Meeting

The National Homeless Lead COVID-19 meeting was held on the 31 August and there are no positive cases of COVID-19 in Homeless Services in the county and while the volume nationally has increased slightly it still remains low. Units reserved for isolation purposes can be considered for general use subject to there being adequate provision should an outbreak occur in the county. It is proposed to put three of the existing seven isolation units back into stock in the coming weeks as it is considered that sufficient capacity is in place to deal with any potential COVID-19 outbreaks in the county.

The Department of Housing, Local
Government and Heritage have
received advice that new entrants into

emergency accommodation who have not been vaccinated will be required to isolate and to meet with a Medical Practitioner to discuss the Vaccination Programme.

Shared Housing

Expressions of Interest for the provision of supports to three units for shared tenancies was advertised in June 2021. These Expressions were assessed and Teach Íosa have been selected for the operation of the two units in Athy and the Peter McVerry Trust were selected for the unit in Naas. It is anticipated that two of these units will be available for shared tenancies in the coming weeks and work to prepare the remaining unit in Naas for Occupation is currently being planned.

Housing First

There are currently 10 active tenancies for Housing First with further tenancies being considered and properties being prepared for this purpose.

Jigginstown Supported Transitional Accommodation

Six tenancies are now in place in the Jigginstown facility with a further two potential clients being identified. It is expected to have this facility fully





occupied by Quarter 4 and the team continue to work with the service provider Tiglin in ensuring all the relevant supports are in place.



Number of Allocations

Allocations continued in August and included allocations to Kildare County Council and Approved Housing Bodies (AHBs) units. Several transfers were also facilitated. All allocations took place within the controls and restrictions of COVID-19.



Inspection of Private Rented Properties

The inspection of private properties has now recommenced. Additional COVID-19 health and safety protocols has resulted in a reduced number of daily inspections.

Private Rented Tenancies

From the 16 July 2021, there is a new method for the calculation of rent in a Rent Pressure Zone whereby rents cannot exceed the rate of inflation as recorded in the Harmonised Index of Consumer Prices. In addition, landlords are only permitted to request a deposit equivalent to one months rent and an advance payment of one months rent. In effect landlords cannot request payments in excess of two months rent to secure a tenancy.

Housing Assistance Payment (HAP) Tenancies

A total of 311 tenancies have been signed up year to date.

Traveller Community

Traveller accommodation continues to demand resources in terms of both the halting sites and roadside encampments. Demands on the council's social work service is high and the team are maintaining daily contact with traveller families, particularly those who may be at risk or vulnerable.

Applications under the Self-Help Scheme 2021

164 applications were received under this scheme. Of this number, 87





applications were successful and were notified. Due to current COVID-19 related restrictions, the deadline for completion of approved work under the Scheme has been extended to 31

January 2022 and the successful applicants have been notified of this.

Water Services

Infrastructural Projects

Contract 2A (Newbridge Eastern Interceptor Sewer)

These works were completed and commissioned in 2020. The sewerage network is due to be handed over to Irish Water/Kildare County Council Operations by the end of Quarter 3 2021. The pumping stations are being operated by the contractor for a 12-month proving period before being handed over to Irish Water/Kildare County Council Operations in the Autumn of 2021.

Contract 2B (Network)

Works commenced on site in September 2019 and are advancing well. The major pipeline improvement works carried out in Clane and Newbridge are substantially complete.

The remaining permanent reinstatement works in Pairc Mhuire commenced on Monday 13
September. Pipelaying works in this area were only completed in May of

this year and hence the permanent reinstatement works are actually planned to be carried out ahead of time in this instance. Coffey's have engaged a sub-contractor to carry out these works and the intention is that all of the reinstatement will be carried out together including the green area.

Some pipeline works continue in Naas off the Monread Road. Permanent road reinstatement has commenced in Clane town centre. Upgrade and improvement works are continuing at Clane, Monread and Sallins pumping stations.

Osberstown Sludge Treatment Facility - Design Build Operate (DBO) Contract Variation

Veolia Water Ireland advanced works on this variation to the Design Build Operate (DBO) contract and completed these works in Quarter 4, 2020. Operational commissioning of the Thermal Hydrolysis Process Plant is continuing. The Exelys Thermal Hydrolysis Process (THP) is intended to be fully operational by end of Quarter 3 2021.

Maynooth Transfer Pipeline

This project involves the upgrading of the existing Maynooth Sewerage





Pumping Station and the construction of a new sewerage pipeline along a new route from the pumping station to the Leixlip Wastewater Treatment Plant. This project is at planning and detailed design stage.

Irish Water and its representatives are currently negotiating with affected landowners and Irish Water are preparing to publish a Compulsory Purchase Order (CPO) for this scheme in the coming weeks as option agreements have not been reached with all landowners

Capital Projects

Allenwood Sewerage Network (Vacuum System) Modification

While funding constraints have emerged on the part of Irish Water in light of the current COVID-19 crisis, the council continues to work with the utility to progress a temporary solution. This involves laying new pipe, land acquisition and temporary pumping arrangements to transfer sewage from the buffer tank to the public gravity sewerage system and on to the Allenwood Wastewater Treatment Plant (WWTP) for treatment and disposal.

It is hoped that the land acquisition can be completed reasonably quickly so that these temporary works can be arranged and completed in 2021.

Consultants have been appointed to progress the longer-term pumping solution at the buffer tank site.

Timolin Waste Water Treatment Plant (WWTP) Upgrade

This project has been included in the Small Towns and Villages Growth Programme (STVGP) which will be subject to Irish Water approval. Irish Water agreed to the priority list submitted by the council following a workshop held last November. This scheme was ranked high in the council's priority list due to commitment made to locals and public representatives in 2017 and the approval of the planning process for a Part 8.

Irish Water has notified the Director of Services that they will progress this to next stage subject to funding being available after the first priority (Derrinturn) and second priority (Nurney) are progressed.





Water Networks Management Projects

Kildare Town Watermain Rehabilitation Works -

Lourdesville BYSS (Back Yard Services scheme)

All public and private side watermain installation works have now been completed as part of this scheme. Prior to the decommissioning of the existing cast iron watermains throughout Lourdesville, further investigational works are required to ensure all properties are connected to the new supply. It is now expected that these works will be completed in Quarter 3 of 2021.

Campion Crescent BYSS

Works involved in the decommissioning of the existing cast iron mains were completed in August 2021. This scheme is now fully complete.

Assumpta Villas BYSS

There are currently two premises remaining whereby customer consent has not yet been obtained throughout Assumpta Villas. Private side service connection works have still to be completed at each of the remaining

properties prior to decommissioning the final sections of existing mains within Assumpta Villas.

Rowanville BYSS

There is currently one property remaining within this scheme whereby customer consent has not yet been obtained. Decommissioning works have yet to commence. This work will commence once consent from the final customer has been provided and the properties service connection is installed.

The two civic amenity sites continue to operate as normal.

Enforcement Priorities 2021

Burial Grounds

All the council's cemeteries remain open to the public. Social distancing guidelines should be observed when visiting cemeteries.

Environment Complaints

Pollution complaints will be investigated in accordance with national guidelines regarding social distancing and the safety of staff and the public.

Domestic/Commercial Refuse Collections

Domestic and commercial waste collections are continuing as normal.





Domestic waste collectors have however been granted permission by the National Waste Collection Permit Office (NWCPO) to carry out collections outside of their conditioned waste collection hours due to COVID-19 restrictions. For details of approved operators, check the NWCPO website: www.nwcpo.ie

National Tidy Towns/Spring Clean

The National Tidy Towns competition will proceed this year, with the adjudication being done remotely. The Environment Department is supporting the entrants by providing grants to facilitate works, as well as offering advice on the wide range of areas covered by the competition.

There are 41 groups in county Kildare and 32 of them have entered the Supervalu Tidy Towns competition.

Anti-Dog Fouling Initiative

An anti-dog fouling initiative was carried out in each of the five municipal district areas.

The wardens and staff from the
Environment Department met with
councillors in Naas, Athy, Kildare,
Maynooth and Celbridge to hand out
dog waste bags/dispensers to passing

walkers. Stencils and an audio message reminding them to dispose of the waste were placed in each of these areas.

There are plans to continue the scheme in several other areas suggested by the Community Wardens.

Green Kilometre Scheme

Over 127 separate Green Kilometres have been established and 44 tonnes of litter and dumped materials were collected to date this year.

This is a huge amount to be gathered by hand and Kildare County Council support these groups by providing clean up equipment and collecting the waste in a timely fashion.

Environmental Education

In line with Government guidelines, all in-person educational talks and events are suspended until further notice in the interests of public health and will be rescheduled at a later date where feasible. The Green Schools programme has continued in a number of schools and online assessments are now taking place in order to award the green flag. While the number of flags awarded will be substantially down on





previous years, many schools are organising themselves to participate over the coming year. Information at: http://kildare.ie/CountyCouncil/EnvironmentalEducation/

New Initiatives

Civic Amenity Site North – Near Celbridge

Consultants have been appointed to progress this project to the next stage which will involve seeking expressions of interest from the market.

Anti-Dumping Campaign and Litter Initiatives

The national "My
Country/County/Town/Village My
Waste" campaign was promoted
locally through print and social media.



This campaign is to highlight the consequences of dumping on the wider community.

Anti-Dumping Initiative funding secured from the Department of the Environment, Communication and

Climate to the tune of €69,440 for seven separate projects county-wide.

These projects are all in progress with the majority scheduled to be completed by end September.

Catchment Flooding

Catchment Flood Risk Assessment and Management Study (CFRAMS)

A steering group with the Office of Public Works (OPW) has been established to progress the consultant's brief for schemes within Kildare. The municipal districts will be briefed as schemes from the Catchment Flood Risk Assessment Management (CFRAM's) Programme commence. Flood defence schemes have been classified as essential works by the County and City Management Association (CCMA).

Morell Flood Management Scheme

Construction of this scheme is continuing, with embankments and walls in the Tuckmilltown and Turnings areas nearing completion and further works in Tuckmilltown, Killeen and Killeenmore commencing. Further details of the scheme can be found at: https://www.morellfms.ie/





Athy Flood Relief Scheme

The Kildare County Council and OPW
Steering Group has commenced
developing the scope of the Athy Flood
Relief Scheme. The first stage will be
the procurement of consultants to
carry out the design of the scheme and
documentation to advance this is being
currently being drafted.

Naas Flood Relief Scheme

The contract for consultancy services for the Naas Flood Relief Scheme has been awarded to ARUP. The first stage of the scheme will be a review of the existing hydrology and mapping. Topographical and drainage surveys to facilitate this has just been completed. Further details of the scheme can be found at:

Kerdiffstown

Wills Bros Ltd was appointed in October 2020 for the remediation of the landfill and the construction of the park.

Monitoring of the gas and groundwater boreholes as well as the management of the leachate and gas continues, in accordance with the Environmental Protection Agency (EPA) Licence. This will continue through the works.

Cemetery Capital Programme

This programme, which includes cemetery extensions, capital type internal improvements and proposals for columbarium walls is currently being reviewed and is likely to be intensified.

Kildare Town Cemetery

Contractor has been appointed for the renovation of the front wall and gates, the removal of the old bunker and the resurfacing of many of the internal

roads and pathways. Works commenced in early January but stepped down due to the level 5 restrictions. Works are due to be completed by the end of September.

Newbridge Cemetery Carpark

Tenders will be advertised by end September.

Newbridge Cemetery Road and Path Resurfacing

Tenders will be advertised for these works within the next month.

Ballymore Eustace Cemetery

New paving works were carried out around the old Alter, and other minor improvement works in the cemetery are expected to be completed by the end of September.

Risk Management

Risk management cycle for 2021 is complete and has been presented to the Audit Committee which will now examine individual departmental risk registers on a rota basis.







The Climate Action Regional Office (CARO) works to support its constituent local authorities to drive climate action projects in their counties, with particular focus on implementing actions contained within climate adaptation strategies. A number of projects are ongoing across the Eastern and Midlands Region:

Economic Opportunities arising from Climate Action:









This project aims to determine how local government can engage policies and actions to exploit opportunities arising from climate action. Following the successful webinar on this theme which took place on Thursday 20 May 2021, the Steering Group has just completed research into the role of local government internationally; this was compiled by the LGiU and endorsed by the CCMA Business, Enterprise and Innovation Committee. In addition, a national conference

building on the success of the conference on the same theme will take place on 12 and 13 October 2021.

Capacity Building:



The CARO continues to work with its strategic training partners, to implement on behalf of the local government sector, a national training programme for all elected members and local authority staff. The training programme, which includes six pillars and has received CPD accreditation from a number of bodies (Engineers Ireland, Irish Planning Institute, CIWEM), are available to all local authorities:



Elected Members/Senior Staff

The Climate Leadership training for senior staff and elected members has





been delivered to a total of 632 participants in 17 local authorities to date, with a further nine scheduled to year end. The remaining six counties will be completed in early 2022. Training under this module is due to take place in Kildare on 24 September. Feedback on this training to date has been excellent.



Climate Action Teams

This highly collaborative programme, with contributions from Met Éireann, Climate Ireland, the CAROs, the SEAI, the AIEI (Association of Irish Energy Agencies) and the IPA, is aimed at members of local authority Climate Action Teams. It commenced with participants from the Midlands subregional counties, moving on to the Atlantic Seaboard North CARO region and has been also completed in the Dublin Metropolitan CARO region. It is scheduled to be rolled to remaining counties (including Kildare), in the Eastern and Midlands CARO and Atlantic Seaboard South CARO regions later this October and

November with registration for this programme currently ongoing across the Climate Action Team in Kildare.



Online Training

The rollout of the Raising Awareness online training programme is ongoing; To date, a total of 6,563 staff at Grade 7, Grade 6, grade 5 and technical equivalent level have completed this programme across each of the 31 local authorities. The programme has recently been rolled out to Grade 4's and their technical equivalent and this means that a further 2,997 people have been enrolled in the training.



Thematic Training

In the first training course of the Actioning Policy training pillar, the Planning for Climate Change training has been rolled out to 291 local authority planners of all disciplines.





Other training courses falling under the Actioning Policy pillar are at various stages of design and progression towards delivery:

- Procurement Officers on promoting green procurement through supply chains. Tender process for trainers underway.
- Impact of Climate Change on Flood and Water Management. Pilot training event to commence on 27 September.
- Older Persons Council on raising awareness on climate change and climate action.



Outdoor Staff

Training for outdoor staff has been piloted across five local authorities (Carlow, Kilkenny, Limerick, Tipperary and Waterford), with the aim of ensuring the training is relevant, accessible and user friendly, as well as informing the final course content before rollout to all local authority nominees later this year. The LASNTG are currently recruiting an inhouse trainer to deliver this

programme to outdoor staff on a county by county basis.



Frontline Staff

Training for front line or community engagement staff remains under design and development with the Institute of Public Administration with pilot training scheduled for December this year.



Guidance for Local Authorities – Preparing Local Authority Climate Action Plans:

The Eastern and Midland CARO working in partnership with the EPA / Climate Ireland have recently commenced work on the development of Guidelines for Local Authorities on preparing their Local Authority Climate Action Plans. An expected deadline of the end of October 2021 for completion of the guidelines is anticipated. As per the provisions of the Climate Action and Low Carbon





Development (Amendment) Bill 2021, each local authority will be required to prepare and make a Climate Action Plan containing mitigation measures and adaptation measures, to be adopted by the local authority. The guidelines are an expressed provision of the Amendment Bill also. These guidelines will support local authorities in terms of both the content and the process of making their own Climate Action Plans and will be ready for submission to the Minister for the Environment, Communications and Climate in early November.



Sub-Regional Energy Projects:

The CARO are working with local authorities in each of the four subregions to develop regional energy bureaus or regional energy efficiency projects. In the Mid-East (Kildare, Meath, Wicklow, Louth): A position paper for pathfinder support has been developed and is currently under review by SEAI. The three local

authorities involved (Kildare, Meath, Wicklow) are meeting regularly and it is hoped to progress this further before the end of the summer.

In the Border sub-region (Cavan, Monaghan, Leitrim): A public building energy efficiency report for the three local authorities went to tender, with Codex Energy being appointed.

CARO have been successful in receiving funding from the SEAI Project Assistance Grant (PAG) Programme for the respective local authorities and this grant may cover up to 50% of the costs of the report.



Decarbonising Fleet:

The vision of this project is to develop a pathway for decarbonizing local authority fleet with a view to realizing emission reduction and energy efficiency targets. A working group is being established under the stewardship of the CCMA Climate Change, Transport and Networks Committee and will include





representatives from the CCMA
Committee, the LGMA, the Eastern
and Midlands and Atlantic Seaboard
South CAROs, the SEAI and Local
Authority representatives from
counties Cork, Kilkenny, Dublin City,
and Donegal, as well as the Dept. of
Transport and the OGP.

As well as realising the vision of this project, the group may also identify areas for further possible interventions at national level to support the transition in local authority fleet, or identify other potential interventions, such as fleet rationalisation and driver behaviour, in support of the transition.

carbon footprint by 30kg week through behavioural change in their daily activities. 11 members took part in the two week pilot and saved an estimated 759kg of carbon dioxide equivalent or the same as 12 flights from Dublin to London.

Sustainable Energy and Climate Action Plan (SECAP)/Climate Action Plan (CAP)

It is a requirement under the Covenant of Mayors and will be a requirement of the amended Climate Action and Low Carbon Development (Amendment)
Bill that Kildare County Council prepare a five-year Sustainable
Energy Climate Action Plan/Climate
Action Plan (SECAP/CAP). The successful tenderer has been identified and initial meetings have taken place between Kildare County





Council and the consultant. Contract terms and conditions are being finalized and it is hoped to have the consultant appointed by mid September. Works on Kildare's SECAP to commence immediately after contract signing.

Decarbonising Zone – Maynooth Nominee



The Climate Action Office, while awaiting the guidelines from the Department, is progressing the likely needs of the challenge ahead to decarbonize by 7% per annum between 2021 and 2030. To this end the team is aligning collaborations within and outside the council, is progressing funding opportunities for the local community and council, developing linkages to create a steering group and sub groups with stakeholders, seeking business opportunities, policies and projects established or in development, developing methods of citizen engagement and researching findings from other initiatives. It is envisaged this background work through the lens of climate action will inform the implementation plan and potential actions to create a proactive and achievable approach. The Climate Action SPC is being made aware of progress to inform its work.

Climate Action Strategic Policy Committee (SPC)

The committee met on the 08
September and progressed through a full agenda. The highlight was a thought provoking presentation by the Strategic Projects and Public Realm Team showing the importance of public realm spaces interlinking with adaptive climate action measures.
Updates were given on the background work for Maynooth DZ.

Energy

Energy Management Team

Kildare County Council's Energy
Management Team has been meeting
monthly since its re-establishment in
February 2021. The Energy
Management Team is currently
progressing several key areas,
including the development of Kildare's
register of opportunities (projects,
initiatives for energy savings), analysis





of Kildare's top twenty energy users and potential areas for reducing their energy consumption. The Energy Management Team has strengthened its membership with a representative from Fire Services joining the Energy Management Team and further reps will be required from Libraries and Leisure Facilities in the near future. The Energy Management Team has received presentations and direction on applying for ISO 5001; this being a recognised energy management standard being adopted by many local authorities and other public bodies to assist in reducing energy consumption in a standardized manner.

Kildare Climate and Energy Week (26 October to 29 October)

A sub-group of the Energy
Management Team has put forward a
proposal to Senior Management to
hold Kildare's first week long climate
and energy event in October of this
year. The Event Team have now
moved to planning and delivery phase
of this Event, with key direction on the
event being to demystify climate and
energy topics and mainstream
awareness through engaging and
interactive events. The Event will also

host main events which will be a mix of in-person and online platforms.

The event itself will be targeted at both the internal workings, staff of Kildare County Council and outward looking to the wider communities within the county.

There will be a comprehensive communications plan for the Event to ensure maximum exposure through local media and online social media sources. The Event is also being supported by SEAI and Creative Ireland.

Energy Usage Monitoring and Reporting (M and R)

Kildare County Council continues to make good progress on reducing its energy usage across the council. Our provisional scorecard for energy usage in 2020 shows a 32.7% energy reduction against its baseline year of 2009, which is significant progress from the 2019 figure of 24%. Although this is a provisional figure from Sustainable Energy Authority of Ireland (SEAI) it shows continued progress on energy efficiencies through Kildare County Council driven largely by the Facilities Team to date.





The final scorecard is to be received by SEAI by mid-September.

Energy Bureau

Progress has slowed on the establishment of the Mid-East Energy Bureau mainly due to summer holidays during July and August. However, meetings are scheduled for September to reinvigorate the formation of the Bureau. It is still the proposal of the Energy Bureau to be established with the assistance of SEAI's pathfinder program which will assist with funding towards energy related projects across the region and also funding for the Bureau establishment and staffing needs over a fixed period of time. Currently Kildare, Wicklow and Meath Local Authorities are partnered to deliver this initiative, with support from CARO. Kildare's Energy Efficiency Officer is also assisting with a subgroup of the Bureau establishment Team to develop tender documentation to procure a suitable consultant to drive this project.

Sustainable Energy Communities (SEC's)



Kildare County Council continues to make good progress on Sustainable Energy Communities in the county.

There are currently 22 SEAI registered SEC's in County Kildare, with four of these nearing the end of their energy master plan stage which will allow them to move to the action phase.

After previous meetings with the four most advanced SEC's and their common requirements for a community engagement piece to be included in their energy master plans, we have met with the consultant to action this piece.

t is expected that three other established SEC's in Kildare are considering applying to Kildare County Council for support in delivering their energy master plan.





Fleet Electrification



Recently the CCMA has published its Electric Vehicle Guidance Document for Local Authoriteis: this is welcome guidance and direction for LA's as demand for public EV charging points and Kildare County Council's suitable small vehicle fleet need to be considered for electrification. In communication with Municipal District Engineers in Kildare's municipal district offices there has been agreement with two of the municipal district offices to progress the area of fleet electrification by way of installing EV charging points at Municipal District offices. While there are currently four small EV vans in Kildare County Council's fleet, it is very much hoped to increase the presence of EV's in the fleet in the coming years and by having the infrastructure in place to support fleet electrification this will facilitate such growth.

As fleet electrification starts to embed in Kildare County Council through infrastructural changes and greater awareness of EV's it will also be key to facilitate specific EV driving training for

all drivers of fleet vehicles to ensure potential EV drivers are fully informed and upskilled in this area.

Forestry

The finalised document 'Woodland Creation on Public Lands Scheme' was released on 28 May 2021. The project is being advanced by a subgroup of the CAT called, Coillteach Chill Dara, with the respective functional areas of the council being notified of the potential sites being considered in each municipal district. A presentation was made to the management team in July to seek support to advance the establishment of woodlands on public lands in response to the Environment Strategic Policy Committee (SPC) work programme which was approved. Potential sites are being investigated with the relevant functional areas. Template tender documents for procuring the different elements of this scheme are currently being drawn up by a CARO Working Group and these will be available for use by all local authorities. The CARO is seeking

A quarterly update from the Kildare County Council Climate Office

The Climate Action Office will publish its third edition of the year during October with a view to circulating widely as a mainstreaming tool.

The edition will have items of relevance to council staff with a sprinkling of fun.

Graduate LGMA

The Climate Action Office team was strengthened by the arrival of Ciara O'Flynn on the 26 July. Ciara is a graduate appointed under the three year LGMA programme. Ciara's role is to progress climate activation initiatives in the community by assisting communities in their understanding and acting on climate adaptation and mitigation measures.

Ciara has already communitizated with various groups and community contacts and has applied for grant funding to embed sustainable climate action and community art under the ESB Brighter Future Ireland Grant in

conjunction with ACDAL and associated local artist.

It is expected introductions will be made to the council representatives and the management team in October.

Just Transition

The municipal districts of Athy, Clane-Maynooth and Kildare-Newbridge have generously contributed €15,000 per municipal district to establish a fund to engage a consultant to develop and prepare a 'Local Just Transition Plan for West Kildare'. Urban Regeneration Limited are working in earnest to finalise the plan by late November. The plan will be presented to the public representatives in October to inform the final document.

Alternatives to Herbicides Project

The Parks/Climate Action Office's project including scientific research together with practical assessment in the field (Kildare County Council Parks Department and National University of Ireland, Maynooth) is designed to produce a practical maintenance guide for public open spaces.

Cork City, Galway City, Meath,
Kilkenny, Westmeath, Roscommon
Fingal, Offaly and Tipperary Councils





have confirmed their partnership.

Responses are awaited from two other councils. Irish Water is unable to assist at this time, however,

Waterways Ireland has confirmed that they will partner shortly.


Sophia Couchman, Masters student, has since June, undertaken field data collection from the research sites, citizen science initiatives, commenced desktop research and initial baseline experiments have taken place on the Millenium Link Road in Naas.



Community Stories is continuing to roll out monthly updates and profile posts of those involved in the background and of the work being undertaken.

Work on a circular economy model with regard to disposal of grass not suitable for use as fodder is well advanced with material being sent to Green Generation in late September to ascertain it's potential use to create bio-energy. The results of the experiment when known will have the potential to reduce the carbon footprint of maintenance and disposal works.

We are working with including planning such as the CDP, community including Age Friendly and Climate Action Plan for Ballymore Eustace, sustainable transport with future community consultation.



Projects Update

M4 Maynooth to Leixlip

The 'M4 Maynooth to Leixlip' is listed as a section of the transport network to be progressed through pre-appraisal and early planning and prioritised for delivery under the National Development Plan 2018–2027. The aim of the project is to assess the needs of the M4/N4 mainline corridor and junctions from Maynooth to Junction 5 Leixlip in terms of catering for future demand from a capacity, safety and operational perspective.

TII deliverables for Phase 1 are now complete and signed off by both Kildare County Council and Transport Infrastructure Ireland (TII). The scheme has now moved to Phase 2 Option Selection. The scheme will take a number of years to pass through the





various steps required for Phase 1 (Concept and Feasibility), Phase 2 (Option Selection), Phase 3 (Design and Environmental Evaluation) and Phase 4 (Statutory Processes), provided it successfully progresses through each phase.

Athy Distributor Road

The Stage 2 tender process is

complete with approval to award the construction contract from the Department of Transport and the Minister for Transport. Notices to Treat have been issued. Notice of Entry on lands has been issued. Advance works between Corran Árd and Fortbarrington Road have been completed. The Córas Iompair Éireann (CIE) lands have been secured from trespassers. The CIE/IE Bridge Agreement has been signed by both parties and the Waterways Ireland Licence is being finalised. Compensation for compulsory land acquisition is ongoing. The resident engineering (RE) team is currently

It is expected to have a contractor on site by Quarter 4 2021.

being procured.

New Machinery Yard Relocation and Regional Salt Barn

Part 8 approval in respect of the New Machinery Yard and Regional Salt Barn Project was confirmed on the 13 May 2019. The development will replace the existing Machinery Yard in Newbridge and will include a new Regional Salt Barn. This barn will provide storage for approximately 22,500 tonnes of salt for use by Kildare County Council and a number of other local authorities in the region.

The Enabling Works Contract undertaken by Clonmel Enterprises Ltd. has now been completed. The design and tender documents for the main contract are being progressed by Kilgallen and Partners Consulting Engineers. The equipment contract tender analysis has been completed and the preferred tenderer will be novated into the main contract. The main contract is due to go to tender in October 2021.

It is expected to have a main contractor on site for Quarter 4 2021.





Maynooth Eastern Ring Road (MERR)

The preferred route option (C), was presented in-committee to the Maynooth Municipal District Committee on 05 April 2019. The Clane-Maynooth Municipal District Committee confirmed approval of the Part 8 in respect of Option C on the 29 July 2019.

Kildare County Council is currently endeavouring to gain control of the lands (identified under the Local Infrastructure Housing Activation Fund (LIHAF) Scheme) as a prerequisite to the CPO going ahead. aluers have been appointed.

Discussions with Waterways Ireland, larnrod Éireann and CIE are ongoing in relation to the design of the bridge structure which will span the Royal Canal and Dublin/Sligo railway line. Agreement has been reached with Irish Water on the servicing of the lands associated with the MERR LIHAF project.

Detailed design of the scheme, including drainage design, is at an advanced stage.

Arrangements are being made for funding discussions with the Department of Housing, Local Government and Heritage (LIHAF), the Department of Transport and the National Transport Authority.

Celbridge to Hazelhatch Link Road

Engineering Consultants RPS have been engaged for the Celbridge to Hazelhatch Link Road Project. Kildare County Council was successful in securing funding under Call 1 of the Urban Regeneration Development Fund (URDF). The scheme, which will connect Celbridge Town and the Hazelhatch Train Station, will include a second bridge over the River Liffey. The project is currently at Route Selection stage. A four-week virtual Public Consultation on the route corridor options has been completed and submissions have been compiled.

A URDF Call 2 Application for further funding has been successful with Kildare County Council receiving €10,237,500 for this project (75% Funding, Kildare County Council to contribute 25%). This will facilitate the development of this project to construction stage.





A public consultation associated with the emerging preferred route will commence in Quarter 4 2021.

Newhall Junction Improvement

Newhall Crossroads is located on the R445 dual carriageway between Naas and Newbridge. It is the junction of three roads: the R445 the L2031 local road and the L6064 local road. The existing junction is considered unsafe as it is a cross-roads junction on a busy dual carriageway.

A preliminary design for a new roundabout at Newhall has been developed. The Part 8 process has been completed with approval to proceed with the project confirmed at the July Municipal District meeting.

Affected landowners are being consulted at present and a decision on whether to proceed with a CPO (rather than by agreement) will be confirmed in early October.

Naas to Sallins Greenway

Kildare County Council are currently engaging with the National Transport Authority on this project and have secured funding to bring this scheme to Part 8.

Consultants (ATKINS) have been recently appointed. It is expected to proceed to Part 8 in Quarter 4 2021.

Naas/Sallins Transport Strategy

The Naas/Sallins Transport Strategy for has been completed and published.

Athy Area Based Transport Assessment (ABTA)

The Athy Area Based Transport
Assessment has recently been
completed and the Planning
Department have included it in the
Draft Athy Local Area Plan Process.

Kildare Town Transport Strategy

The Kildare Town Transport Strategy is currently at DRAFT stage. Meetings with the Kildare-Newbridge Municipal District Councillors were held on the 07 April 2021 and the 26 April 2021. The non-statutory public consultation was completed in August 2021. It is expected to have a final document available in October.

Maynooth Transport Strategy

AECOM Consultants have been appointed to the develop of the Maynooth Transport Strategy. It is expected to take twelve months to complete and this will facilitate the





development of the Maynooth Local Area Plan.

Bridge Rehabilitation Programme

Kildare County Council received funding for 2021 from the Department of Transport for bridge rehabilitation works.

The Monasterevin Bridge has significant structural issues in two centre-pier cutwaters. Emergency works are not deemed necessary at this stage. An application to An Bord Pleanála for an EIAR/NIS approval (as the River Barrow is a Special Area of Conservation) has been approved subject to conditions. It is anticipated that rehabilitation works will be undertaken in Quarter 3 2021.

Four bridge projects funded by the Department of Transport for 2021 have been awarded to TRUIR and are to be completed by Quarter 4 2021.

Brook bridge has commenced the approval process with An Bord Pleanála and it is proposed to proceed to construction stage Quarter 3 2022.

Newbridge Southern Relief Road / Second Bridge Crossing

The section of the Newbridge Southern Relief Road (NSRR)

between the Newbridge to Naas dual carriageway (R445) and the Great Connell road is now substantially complete and the Roads Planning Section is currently engaging with the developer on the completion of snags, the transfer of lands and the submission of the taking in charge documentation.

Following the unsuccessful application for funding under URDF Call 2, the Project Team has commenced the tender process for the appointment of consultants to progress the project to stage 4 of the TII Project Management Guidelines (Planning Stage). It is expected to award the contract by October 2021.

Maynooth Inner Relief Street

This road with signalised junctions and a new bridge over the Lyreen River has been substantially completed by Cairn Developments Plc. The Roads Planning Section is engaging with the developer on the opening of the street to traffic, pedestrians and cyclists. The road safety audit stage 3 is being carried out on the completed works. It is proposed to be opened in Quarter 3





2021, subject to COVID-19 restrictions.

Kildare Town Northern Link Road and South Green Area Access Improvement Scheme

The Route Selection Report is substantially complete. This project will not proceed further until the Kildare Town Transport Strategy is completed.

Royal Canal Greenway – Maynooth to Moyvalley

The Greenway from Maynooth to Moyvalley is now substantially complete and operational. A stage 4 safety audit and snags are now being completed for this project.

Kildangan Railway Bridge Footpath Scheme

The scheme is now substantially complete, with the footpath is operational.

Maynooth North South Corridor – Phase 6 – Moyglare Road Improvement Scheme.

This scheme is substantially complete, except for snags which are outstanding due to COVID-19 restrictions.

Kildare LCDC was successful in securing Athy as one of 17 areas in the Sláintecare Healthy Communities Programme. This means intensive health and wellbeing supports and programmes focussing on Athy through the HSE, and other agencies. Kildare County Council will employ a dedicated worker to ensure a collaborative approach is taken to coordinate activities under this programme. This post will be part of and will report to Kildare LCDC. Work

is commencing to sanction this post and recruitment will follow. The HSE have committed dedicated posts and programmes in line with the programme nationally. The Healthy Communities Programme is a very positive opportunity for Athy.

COVID-19 Community Response Forum

The Kildare COVID-19 Community Response Forum have had 27 meetings to date via Teams. The last meeting took place on 03 September chaired by Ms Sonya Kavanagh, Interim Chief Executive. The purpose of the Response Forum is to lead the co-ordination of COVID-19 community supports and resilience. A dedicated COVID-19 support helpline was established on the 30 March 2020 by Kildare County Council. The Response Forum has representation from key statutory and voluntary organistions across the county. The last meeting discussed the vaccination roll out and an update on responses from members. It was agreed that due to the current re-opening, low levels of demand for support and calls to the helpline that the Response Forum would not schedule further meetings. A meeting can be scheduled in October if required.





Rural Development LEADER

Applications are now being sought from individuals, businesses and community groups/organisations seeking grant aid to progress enterprise, community development and environmental initiatives.

The LCDC/LAG have agreed priorities for funding. Applications are invited for grants ranging from €15,000 to €100,000. There are strict criteria and priorities for the funding.

In July, Kildare Fáilte held their Annual General Meeting reviewing the year past and KPIs achieved. Marketing plans for the future were also shared with attendees. Insights provided by our guest speaker, Mr Eoghan Corry (travel writer and industry expert), were well received by those in attendance. The Royal Canal Greenway Marketing Group, made up of representatives from each county tourism board and Waterways Ireland, met to discuss promotions and activity for the remainder of the year and into 2022 to encourage visitors to use the Greenway. The product is a year round activity, and marketing activity will reflect this. Kildare Fáilte also attended a Barrow Blueway steering group meeting, where work continues to progress.

Kildare Fáilte attended the launch of the Kildare Economic Strategy 2025 and also took part in the Curragh Plains Consultation Workshop.

KPMG Future Analytics, who have been engaged by Kildare Fáilte to develop a tourism strategy for the county, in line with the County Kildare Development Plan, continued on-site interviews with stakeholders and visited key tourism sites throughout the county.

Kildare Library Service has been shortlisted for the Chambers Excellence in Local Government Award in the category of Best Library Service for its 'Supporting Families, Sharing the Learning' training initiative.

The programme will take place during the first three weeks in November and will see a host of public talks and workshops for all ages including events for local DEIS (Delivering Equality of Opportunity in Schools) schools.

Mother and Toddler Group

Newbridge Library were successful in their application for a grant through the Dormant Account funding to start a mother and toddler group with the Eyre Powell direct provision centre. As part of this, arts and crafts materials, board games and other equipment were purchased and gifted to the Eyre Powell centre to facilitate the group meeting and enjoying activities in between the monthly sessions coordinated by the library.

Age Friendly Programme

Kildare Libraries Age Friendly
Programme has just been launched
and includes 'Soap Making',
'Handmade Gifts', 'Weaving' and

'Watercolour Painting'. The September and October workshops will take place in the outdoor spaces under cover. This week Naas Library welcomed Naas Men's Shed for two painting workshops followed by refreshments.

Outdoor Spaces

Funding received from the 'DRCD Healthy Ireland at Your Library 2021' allowed three libraries Naas, Leixlip, Newbridge and Ballitore to furnish outdoor spaces and host some workshops at the end of the summer.

Kildare Library Service had a range of events such as Parent and Child Storytelling and Yoga, Gymboree Music for Toddlers, Weaving, Painting, and a series of Archaeology Workshops. It was wonderful to have patrons back socialising and being active in a healthy, safe setting.

Library IT Projects

Eduroam

Kildare Library Service and IT

Department recently piloted with

HEAnet the Eduroam service aimed at third level students and institutions.

Eduroam (education roaming) is the secure, world-wide roaming access service developed for the international research and education community.





It allows students, researchers and staff from participating institutions to obtain Wi-Fi connectivity and access to campus resources by simply logging on using their credentials.

Since we completed the pilot we have now expanded Eduroam to all 14 library branches and five street Wi-Fi locations. The uptake has been great with up to 300 clients using Eduroam in one location alone.

New Library Website

In another partnership with colleagues in the IT Department, the Library Service has been working on a new library website. A library working group of four people have been working with Dawn Halpin, IT on a brand-new library website Kildare Library Service are very excited with the progress. It is much more visually appealing and user friendly. We are aiming for Autumn launch.

Library Management System (LMS)

As part of a national tender process a new LMS has been acquired for the country. The LMS called Spydus from Civica, is widely used in public and academic libraries throughout the world. The implementation process should take approximately six months,

so we expect to be up on running on it by next Spring.

Capital Projects

Naas Library and Cultural Centre

Duggan Lynch, main contractor for Naas Library and Cultural Centre Capital Project are progressing works as per contract programme.

County Library, Archives and Cultural Centre

This Capital Project received Urban Regeneration Development Funding (URDF) under Category B as part of the Newbridge Cultural and Civic Quarter. Metropolitan Workshop Architects have been appointed as the Design Team lead and the first meeting of the Project Team took place on 02 September 2021 to get the project underway.

MERITS – Innovation and Incubation Centre
