Alcohol Bye Laws

Kildare County Council has finalised the erection of signage regarding Alcohol Bye Laws across all Municipal Districts.

These bye laws prohibit the consumption of intoxicating liquor on streets and in public places in the County and are enforced by An Garda Síochána and administered by Kildare County Council.

The penalty for breach of the bye law is a fixed payment of €75 served by An Garda Siochána in the form of a fixed penalty notice.

Official Languages Acts 2003 to 2021

Section 10 of the Act recently commenced. This grants An Coimisinéir Teanga additional monitoring functions. As a result, in addition to monitoring compliance by public bodies with the Official Languages Acts 2003 to 2021, An Coimisinéir Teanga will now monitor compliance of public bodies with any other enactment linked to the status or use of Irish and/or English, where appropriate, for example, the Road Traffic Act 1961 and Planning and Development Act 2000, to name but a few.

As members may be aware Kildare
County Council is pursuing creation of
a permanent full-time post of Irish
Officer to aid compliance with the Acts
and grow the presence of the Official
Language.

St. Patrick's Day Visit to New York 2023

The President of the Kildare Association of New York, Mrs Carmel Mangan, invited the Cathaoirleach, Cllr Fintan Brett to New York for St. Patrick's Day. As the Cathaoirleach was unable to attend, Cllr Evie Sammon travelled on his behalf and was accompanied by Joe Boland, Director of Service who represented the Council's Chief Executive. It was good to have continued the very positive momentum which had been generated as part of the 2022 visit. It was also good to promote Kildare's unique relationship with St. Brigid which was again highlighted during the visit. The delegation wore St Brigid's crosses while 'Brigid' themed gifts again featured strongly.





Mass in St Patrick's Cathedral



The mass is a unique experience which includes a theme reflective of our military heritage; past and present. Irish Tenor Emmet Cahill sang Amhrán na bhFiann at the conclusion of mass and was accompanied by the Cathedral's choir and organist. Many local authorities, including Kildare County Council, were prominent in their attendance while its conclusion heralds the beginning of the parade.

Kildare Association of New York

The Association hosts its annual dinner in Yonkers. It is an informal occasion and another great opportunity to meet the Committee and its members, many of whom are long

serving. There was a discussion regarding potential future initiatives which would strengthen the Association. In addition, the work which the Associations carries out 'behind the scenes' in helping people from this County, particularly those who might be in difficulty, should be noted.

Opportunities for Networking

In the course of the visit there are many opportunities to network with a range of entities and to explore the potential for interaction with the wider international community. The attendance of the Cathaoirleach or their Deputy means so much to our colleagues in New York and, indeed, is their annual highlight and it is important to keep those links between New York and Kildare.

SKS Communications have been selected as the 'preferred vendor'. SKS have been involved in implementing similar solutions in the Houses of the Oireachtas, Cork County Council, Laois County Council, Wexford County Council, Offaly County council and other Local Authorities. A formal 'kick off' meeting was held on the 23rd of March with SKS and the KCC project team. We plan to finalise work on the contract and SLA over the next few weeks, and we have already started to put together the outline project plan and have identified prerequisites. All going well significant progress is expected on this project in Q2 2023. Based on the experience of other local authorities it should be noted that delays due to supply chain issues may happen during the life of the project.



Cashflow / Overdraft

Kildare County Council manages its cashflow requirements on a daily basis and did not avail of its overdraft facility during the period 1 January 2023 to 31 March 2023.

Value for Money (VFM) report on Rebuilding Ireland Home Loans (RIHL)

The Local Government Audit Service produced a Value for Money (VFM) report on Rebuilding Ireland Home Loans from 2021-2021 inclusive. The report can be found on government portal at:

In the first three years, the report shows that Kildare had the third highest number of approvals at 163 RIHL approvals (after Dublin City (982) and Fingal (331)). This translated into 85 loans being drawn in the same period.

Innovation

In March Kildare County Council signed the Declaration on Public Service Innovation in Ireland, declaring our continued commitment to embracing innovation as one of the ways that we can achieve our goals and deliver effective public services.





Housing

Housing for All Exemption from Part 8

The Planning and Development and Foreshore (Amendment) Act 2022 has now commenced. This act provides an exemption from Part 8 of the Planning and Development Act 2002 for local authorities for the provision of specified forms of housing developments on designated state lands.

This provision is time limited and it is mandatory that local authorities use the exemption. The following criteria applies to the use of the exemption:

- The land is owned by the council or another specified state body.
- The land is zoned for residential development.
- The proposed development does not contravene the County Development Plan or the relevant Local Area Plan.
- The proposed development is in accordance with the council's housing strategy.
- The land is serviced or serviceable within the timeframe of the development.

- The proposed development is not required to undergo environmental impact assessment under the EIA Directive or appropriate assessment under the Habitats Directive.
- The development works are commenced no later than 31 December 2024.

The Chief Executive is required to formally notify the Members prior to issuing the site notice and newspaper notice, which must be eight weeks prior to the commencement of works. The council is required to notify the relevant prescribed bodies of proposed developments. The council will be required to enter the details of the proposed development on the planning register providing details of the plans and particulars of the proposed development. Plans must also be available for inspection on the council's website and office.

Homeless Services

Tenant in Situ Scheme

Local authorities have been provided with delegated sanction to purchase up to 1,500 properties under the tenant in situ scheme; Kildare County Council has been provided with delegated



sanction to purchase up to 55 properties under this scheme. This scheme applies to housing applicants who have received a notice to quit. Use of this scheme will be considered where a valid notice to quit has been served.

Cost Rental Tenant in Situ Scheme

A temporary Cost Rental Tenant in Situ Scheme (CRTiS) has been established. The purpose of CRTiS is to provide an additional option for tenants at risk of homelessness who do not qualify for social housing. The following tenant conditions must be met:

- The property they reside in is being sold.
- They are not in a position to purchase the property.
- They are assessed by the
 Housing Officer as being at risk
 of homelessness as defined in
 Section 2 of The Housing Act
 1988, i.e., there is no
 accommodation available which
 they can reasonably occupy,
 and they are unable to provide
 accommodation from their own
 resources.
- They are not in receipt of HAP.

 They meet income eligibility rules, the net annual household income must not exceed
 €53,000 per annum, the final assessment of the income is undertaken by The Housing Agency.

Details of tenants who fulfil the criteria will be forwarded to The Housing Agency for consideration as a potential acquisition under the CRTiS. In the event that a property is purchased the tenant will pay the same rent, any increase will be in accordance with the current conditions for private residential tenancies, which is limited to two percent per annum. The Housing Agency will contract a third party to arrange the letting and manage the tenancy. The Housing Agency has absolute discretion on whether to acquire the property. This scheme is operating on a temporary administrative basis prior to the legislative enactments, or further sanctions, required to establish a longer-term scheme.

Homeless Outreach

Street work was completed in Kildare-Newbridge Municipal District, Naas Municipal District and Celbridge-Leixlip





Municipal District in March. Clinics were held in the Athy Family Resource Centre and Cuan Mhuire. An outreach clinic was also provided for residents of Jigginstown Manor.

A new clinic providing information on Housing and Homelessness will commence on 5 April 2023 in Ballymakealy Community Centre, Celbridge.

43 applications have been received for the Vacant Property Refurbishment Grant

Town Centre First

Consultants have been appointed to prepare a Masterplan for Clane Town Centre under the Town Centre First policy.

Housing Allocations

In March 2023, the council allocated a total of 164 properties throughout the county. 75 were social properties and 89 were Approved Housing Bodies properties. This is 75 units more than in March 2022. Among the locations that allocations took place were Newbridge, Athy, Leixlip, Naas, Kilcullen and Kildare Town. In order to address the number of refusals of offers of allocation, the use of Choice Based Letting has been increased.

Planning and Strategic Development and Public Realm

Kildare County Development Plan 2023-2029:

The Kildare County Development Plan 2023-2029 came into effect on 28 January 2023 and replaced the Kildare County Development Plan 2017-2023. In February 2023 Kildare County Council was notified of two applications to the High Court for leave to seek a judicial review of the Plan, specifically the housing targets and the addition of a structure to the Record of Protected Structures.

The first case is expected to take some time and updates will be provided as appropriate. The second case was ruled by Judge Humphreys on the 28 March 2023 and through a Consent Court Order, it has been agreed that Gowran Grange House, the Demesne of Gowran Grange House, including all historic buildings, structures and decorative features, (RPS No. B24-28) be removed from Kildare County Council's Record of Protected Structures. Once the Order has been perfected it's terms will come into effect and the alteration to the

County Development Plan should be publicised and notified to various persons in the same way as the passing of the County Development Plan was.

The draft Kildare Town Local Area
Plan 2023-2029 was published for
consultation on Tuesday the 21 March
2023. Members of the public will be
invited to make submissions during a
six week public consultation period

Inaugural Rubbish Film Festival



The first-ever Kildare "Rubbish Film Festival" for Transition Year Students in Secondary Schools was held on a pilot basis this year with entries from five participating schools across the County, and it was a resounding success.



The festival, which challenged students to create a one-minute short film on the theme of reducing waste and encouraging sustainability, was facilitated by Createschool and supported by Kildare County Council. The festival received a great response from the schools, with students showing their creativity and innovation in producing ten short films that were both educational and entertaining. Two films and a poster design were selected as the winners in their respective categories (see details below) and they will go forward to represent County Kildare at the National Awards in Meath on 3 May 2023. Fifty-two schools and over

seventy entries from six counties are competing for the National Awards. The festival has proven so successful that plans are already underway to expand it next year to include more schools in the County. The organisers hope that the festival will become an annual event that will help to raise awareness about environmental issues among young people and inspire them to take action to protect the planet.

Community Clean-ups

Green Kilometre groups continue to be very active. There is also continued demand from community and Tidy Towns groups for supplies to aid with clean-ups and litter picking around the county. Some Residents Associations are expressing interest in installing compost areas for green waste on their estates.

GAA Green Clubs Initiative



Cappagh GAA club is the pilot club for Kildare for this national initiative.

The next phase of the project involves reducing waste arisings within the clubhouse and work on this is proceeding.

New Initiatives – Civic Amenity Site North – Near Celbridge

A Market Sounding exercise took place in late 2022. An update on the finding were presented to the Celbridge/Leixlip Municipal District in March. Capital funding is the key challenge delaying the delivery of this project.

Kildare County Council Launches New Anti-Dog Fouling Initiative



The council is keen to encourage dog owners to take positive action, to promote responsible dog ownership and encourage dog owners to pick up after their dog, bag the waste and safely bin it. The council has installed several audio or visual (LED) devices at key locations in the Municipal Districts to remind owners to clean up after their pet, and the council encourage people to use any bag, any public bin."





Catchment Flooding

Catchment Flood Risk Assessment and Management Study (CFRAMS)
A steering group with the Office of Public Works (OPW) has been established to progress the consultant's brief for schemes within Kildare. The municipal districts will be briefed as schemes from the Catchment Flood Risk Assessment Management (CFRAM's) Programme commence.

Kerdiffstown Park project

The construction of Kerdiffstown Park is at an advanced stage with the bulk of the main works completed in terms of landfill gas and leachate infrastructure, capping works, playing pitches, walking trails, playground facilities, carparking facilities, pond areas and art trail. It is anticipated that the park will be operational later this year.



Monitoring of the gas and groundwater boreholes as well as the management of the leachate and gas continues, in accordance with the Environmental Protection Agency (EPA) Licence.

This will continue through the works.

Climate Action Teams (CATs)

A new webinar series, to support the work of CATs has been launched including themes of Local Authority Climate Action Plans, Trajectory 2030: Local Authority Mitigation and Energy, Community Climate Action, Creative Climate Action, Climate Action through Heritage and Biodiversity, Adapting to Climate Change, Decarbonizing Zones.

Online Training

Since its launch in January 2021, the rollout of the Raising Awareness online programme has seen a total of 17,531 staff at grades seven, six, five, four, three (and equivalent technical grades) enrolled on the programme, with a total of 13,561 (78%) having completed the programme. The programme has now been substantially updated, with a much greater emphasis on the use of short videos to aid in the learning process. This new version is being rolled out by all Local Authority training departments, with assistance from the Local Authority Services National Training Group (LASNTG), from the 1 March 2023.



Thematic Training

Training under this pillar responds to identified training needs of specific local authority groupings. Other training courses under this pillar are at



various stages of design and progression towards delivery, including training aimed at/focusing on the Older Persons Council, Economic/Enterprise Opportunities and Roads Infrastructure.



Outdoor Staff

This training focuses on outdoor staff in local authorities, with trainers working on behalf of the Local Authority Services National Training Group and commenced in January 2023.



Frontline Staff

This training is targeting staff of local authorities who are front line or community-facing and will be delivered in person by the Institute of Public Administration (IPA) and Local Authority Services National Training Group (LASNTG), who will coordinate with training officers in local authorities to make registration arrangements. The programme was piloted in March 2022 and rolled out across the CARO

regions over the year, before opening to all local authorities in October / November.



Economic Opportunities Conference 2023

Discover how local authorities, working through their economic and enterprise remit, are supporting existing and new business to embrace the innovation required for the transition to a net-zero economy.

The local government County and City Management Association (CCMA) are hosting a national conference event on Wednesday, 26 April 2023. This exciting conference at the Tullamore Court Hotel explores how businesses, in addressing and responding to climate change, can realise unique economic and business opportunities. This event seeks to build on the success of the inaugural conference, held in Tullamore in October 2019 and the subsequent online event in 2021, and will highlight some of the research work undertaken. by the sector that explores how local authorities can, through reinforcing their economic remit, support and encourage new and existing business





and enterprise to aid the transition to a net zero economy.

Local Authority Climate Action Plans (LA CAP)

The Minister has approved a business case for local authority climate action resources in respect of two roles. A letter of comfort has been issued by the Department of the Environment, Climate and Communications (DECC), relating to the recruitment of these resources on a five-year term for the purposes of developing and implementing the LA CAP as aligned

with the provisions of the business case.

The Climate Action Plan 2023 was published by the Minister on the 21 December 2022 with the Annex of Actions due to published early in 2023. To support local authorities, CARO have established three national frameworks of consultants for county wide BEIs (Baseline Emission Inventories), Climate Change Risk Assessments as well as BEIs for Decarbonising Zones (DZs) and planning and implementation activities linked to Climate Action Plans or commitments under the Local Authority Climate Action Charter. The development of a framework for the provision of services for Strategic **Environmental Assessment and** Appropriate Assessment screening is also being finalised. On the 24 February 2023, the Minister

On the 24 February 2023, the Minister issued instructions to all Local Authorities to commence the process of preparing the Local Authority Climate Action Plan (LACAP).

Local Authority Progress Reporting
– Climate Adaptation Strategies:
Annual reporting on progress of the implementation of Local Authority
Climate Adaptation Strategies / Plans has been undertaken by all Climate
Action Officers / Leads in all local authorities. A sectoral report is being collated by CARO for submission to the Department.



Sub-Regional Energy Projects

The CARO are working with local authorities in each of the four sub-regions to develop regional energy bureaus or regional energy efficiency projects.

In the Mid-East, the three local authorities involved (Kildare, Meath, Wicklow) with the assistance of CARO, are in the process of finalising a contract with Codema to provide an energy service for local authorities in this sub-region.

In the Border sub-region (Cavan, Monaghan, Leitrim): A tender for a

public building energy efficiency report resulted in Codex Energy being appointed. Their final report identifies 18 buildings with a project pipeline of over 100 potential projects for each building to attain a B2 rating.

In the Southeast (Kilkenny, Carlow, Wexford, Waterford, Tipperary): The four Directors of Carlow, Waterford, Wexford and Kilkenny, have instructed the South East Energy Agency (formerly 3CEA) to pursue Pathfinder Support.

In the Midlands (Laois, Offaly,
Longford, Roscommon, Westmeath):
Roscommon County Council has
become the fifth member of the
Midlands Energy Agency (MEA). The
MEA local authorities with the support
of SEAI, have formed a working group,
to focus on pursuing Pathfinder Capital
Support.



Reimagining Local Authority Fleet

The vision of this project is to develop a pathway for decarbonizing local authority fleet with a view to realizing emission reduction and energy efficiency targets. The sector has one



of the largest fleets with approx. 6,500 vehicles.

Stage one saw completion of a Fleet Survey and Fleet Manager Survey. Stage two is underway and will see the development of a more in-depth analysis document, with expected publication in early 2023. CARO are examining the development of a number of local authority case studies to support the solutions identified, including a HVO trial undertaken in Tipperary and Galway City; transition to EVs in Cork City and Dublin City; as well as fleet management and eco driver training undertaken in Donegal.



Development of Local Authority Key Performance Indicators on Climate Action

In light of the evolving policy context of climate action and increased ambition for the local government sector, the County and City Managers Association (CCMA) Climate Action and Transport Network (CATN) committee endorsed convening of a KPI working group to achieve specific objectives. This working group, chaired by Paul Kennedy of Dún-Laoghaire Rathdown

Council, will work with a number of local authorities across the country, with the intention to have KPIs decided upon and tested to align with the implementation stage of Local Authority Climate Action Plans (LACAPs).

GAA / CCMA Green Clubs Programme:



Phase one of the Green Club
Programme is now complete with
toolkits almost finalised. Phase two will
commence at the beginning of 2023,
with applications for an additional 70
clubs anticipated.

The programme successfully secured €100,000 funding through Strand two of the Community Climate Action
Fund. These funds will be used to develop an educational model to assist with the building of knowledge and capacity of Green Club Members and participating Clubs, to deliver projects under the five thematic areas of the programme. The Department of Environment, Climate and Communications (DECC) have also



committed funding for phases two and three of the programme and will provide through 2023 and 2024.

Sustainable Energy and Climate Action Plan (SECAP)/Climate Action Plan (CAP)

The draft Local Authority Climate Action Guidelines as endorsed by the Climate Action and Transport Networks (CATN) committee of the CCMA on 15 September 2022 were issued to local authorities. The guidelines have been updated to reflect the incorporation of Decarbonisation Zones as per action 80 of the Climate Action Plan 2021. Together with the requirement under the Covenant of Mayors and Climate Action and Low Carbon Development (Amendment) Act Kildare County Council is preparing a five-year Sustainable Energy Climate Action

Plan/Climate Action Plan (SECAP/CAP).

The Minister formally activated the programme as of the 24 February 2023 giving until the 23 February 2024 to finalise the plans plus one month for publication. Given the availability of the published guidance RPS group are reviewing the elements undertaken to date and assessing the path forward to undertaking the SECAP/CAP and DZ plans. Currently the project is at the scoping of the actor's stage.

The Senior Management team and associated senior staff members undertook an interactive session on the Vision for Kildare by 2050 and potential actions to advance decarbonizing of the council's services and functions in January. Information was also given on how to commence decarbonizing the work of the various sections.



Decarbonising Zone (DZ) – Maynooth Nominee

The Climate Action Office is streamlining consultation efforts with An Taisce who are developing a Low Carbon Community Plan for Maynooth

(national example) under the Legacy 4
Life programme, Maynooth University,
RPS Group (consultants) and various
local actors. The Emissions Baseline
Inventory (EBI) and a potential Carbon
Calculator are being advanced.
Consultation methods are advancing
to enable citizen engagement with
surveys to commence in April and
physical events up to and including the
summer to encourage accessible
interaction across the demographic
spectrum.

The Climate Action Strategic Policy
Committee was made aware of
progress and updated during
December's meeting. The
Decarbonisation Zone actions plan will
also inform the Maynooth joint Local
Area Plan (LAP) Local Economic and
Community Plan (LECP) and other
policies.

Climate Action Energy Management Team



The Climate Action and Energy

Management Team met on 23 March

2023 in Solas Bhride, Kildare town to undertake the first of four workshops to inform the formulation of Kildare's Climate Action Plan. The workshop was facilitated by CARO. The members of the Climate Action Team and Energy Management Team undertook a review of the adaptation measures under the existing strategy and brainstormed on the potential mitigation measures. Three further workshops will be undertaken over the next two months to advance the process.

Maynooth Community Council in conjunction with the Climate Action Office are jointly organizing an event in Maynooth to increase awareness of climate action. The fun event to will inform on consultation opportunities and build awareness

The Mid East Energy Unit



The three local authorities of Wicklow, Meath and Kildare County Councils have come together to address their combined climate mitigation ambitions through the formation of the Mid East



Energy Unit. Kildare County Council signed a Service Level Agreement (SLA) with the lead Local authority Wicklow County Council in December. The formation of the unit is to support the three Local Authorities to meet their 2030 energy efficiency and carbon emissions targets and show leadership and CODEMA will provide core services to the local authorities associated.

The unit will combine efforts to effect change utilising the SEAI's Pathfinder funding scheme to provide finance support for defined projects.

A Director's Order was signed in February to enable the use of Energy Elephant to commence data collection and analysis of all fuels used by the council from 1 March 2023.

Climate Action SPC:

The latest scheduled meeting took place on 8 February 2023. Two presentations were given. The first by CODEMA on the Mid East energy Unit and the National four Day Working Week Trial. The second presentation was by Kildare Chamber on Business and Energy Efficiency in the Future. The next meeting is scheduled for 10 May 2023.

Sustainable Energy Communities (SEC's)



Kildare County Council continues to make good progress on Sustainable Energy Communities (SEC) in the county. The number of SEC's continues to grow. There are currently 29 SEAI registered SEC's in county Kildare.

Further strengthening of the Energy
Master Plan (EMP) process has been
developed by SEAI, which now
includes greater structure and
guidelines to ensure quality
standardized Energy Master Plans
(EMP) are delivered. Kildare County
Council can now also utilize an EMP
delivery framework structure
established by CODEMA to streamline
the administration for all parties
involved.

Ballymore Eustace, Naas and Kilcock have agreements in place with Kildare County Council in 2022. Kilcock are finalizing their Energy Master Plan and propose to launch it on 3 April 2023. The SEC's of Monasterevin, Clane, Kilcullen and Maynooth are

undertaking an activation program under the stewardship of the Energy Team, a social enterprise formed from Dunleer SEC, to advance building retrofits successfully under the SEAI retrofit fund. The initial expressions of interest received have been refined. Building assessments are underway to assess the works to be grant aided to inform a community application to SEAI to access grant funding. Should funding be awarded it will be used to undertake energy upgrades in a number of properties across the county under the Better Energy program.

Fleet Electrification



The CCMA has recently published its Electric Vehicle (EV) Guidance Document for Local Authorities; this is a welcome development which gives direction for Local Authorities as demand for public EV charging and fleet electrification grows. Kildare County Council's suitable small vehicle fleet can also be considered for electrification. The council currently have four EV vans in the fleet but there is growing interest in the electrification of other suitable vehicles in the fleet.

Some Municipal District offices have also expressed interest installing electric vehicle charging points in their depots to facilitate EV charging.

As fleet electrification starts to embed in Kildare County Council through infrastructural changes and greater awareness of EV's it will also be key to facilitate specific EV driving training for all drivers of fleet vehicles to ensure potential EV drivers are fully informed and upskilled in this area.

The Climate Action Office is also examining the potential to introduce a compressed natural gas heavy goods vehicle into Kildare County Council's fleet with mechanical services, while smaller vans have suitable options such as electrification; the larger trucks are an issue. One solution to this is a compressed natural gas vehicle. Presently the installation of a pumping station at the New Hall Depot is being

planned.



An opportunity to collaborate with Eir Evo https://www.eirevo.ie/ to advance ICT solutions was acted upon and the inaugrual sprint is now completed.





The initial contact was made via our IT Department.

The work included the development of an app linking plant passport statutory recording and tree surveys (Parks Department has usage) together with the potential for the creation of a dashboard.

The potential to gamify the Carbon Calculator associated with Maynooth DZ has been discussed given the national potential community usage. An introduction has been made between An Taisce and Eir Evo to advance the option.

Advancement is dependent on funding allocations with Eir Evo seeking further assistance.

The programme is funded by Microsoft.

Disability Participation and Awareness Fund 2021

€75,000 has been awarded under the Creative Ireland's Climate Action: Invitation to Collaborate fund an application, led by Carlow County Council, in conjunction with Kildare and Meath County Councils. Gnáthóga Nádúrtha will be an ambitious arts led inquiry, an interdisciplinary, collaborative intervention, sited across three natural heritage peatland habitats in Carlow, Kildare and Meath that brings the urgency of climate action to the forefront. The focus of this initiative is on Climate Action and place-based practice in these rich natural heritage sites across three counties, including Rathangan in Kildare. Site visits with though provoking

Site visits with though provoking interactive are being conducted on the various bogs during December,
January and February to inform then project.

Other Initiatives

'Stitching the Community Together'
The Climate Action Office, Community
and Libraries section were successful
in attaining just over €30,000 in
funding from Creative Ireland for the
project 'Stitching the Community
Together'. The project is based on
intergenerational art project centered
around the medium of wool and

knitting and will include three elements to the project: intergenerational workshop on wool and knitting between nursing homes and schools, virtual reality (VR) educational piece to explore the 'Farm-to-Fleece' process of wool co-created with students and an exhibition phase showcasing the work. The work with schools and nursing homes has concluded. We are working closely with the virtual reality artist to deliver the co-creation piece. The associate exhibition called 'Future Tapestry' will take place on the 25 May to 27 May 2023 in McAuley place including exhibit and VR experience. The launch will be on the 25 May 2023 and the opportunity will also be used to launch the Age-Friendly strategy.

Gas Innovation Fund and Public Service Innovation Fund



The Climate Action Office applied to the Gas Network Ireland's Gas Innovation Fund in conjunction with Maynooth University's Terrain-Ai research group and Teagasc. This project aims to assess the potential for green spaces to generate biomass e.g. grass-clippings as a feedstock for energy generation in Kildare with

potential of scaling the study up to different county councils and state bodies nation-wide. If successful the main body of work will be carried out by a postdoctoral researcher with project support from the Climate Action Office, Maynooth University and engagement with Teagasc.



To advance the project financially an application was made to the Public Service Innovation Fund 2023. To our delight the bid has been successful and funding of €50,000 (€60,000 requested) is to be awarded on signing of Memorandum of Agreement (MOA) in March. The funding will be used to enable a researcher(s) to commence the works associated.

Kildare Creative Ireland Bursary Award





The Climate Action Office supported a local artist and community organisation with a successful application to the Kildare Creative Ireland Bursary Award. The project called 'We Hold the Power' involves creating a collaborative community mosaic art piece with the Allenwood Community **Development Association community** groups and the artist Marta Golubowska. The mosaic will reflect the imagery of the community centre's history, ecology, and heritage which was originally a former ESB peat power station. The project work has concluded with the adults in the area and work with children from Allenwood and Roberstown National Schools is to commence after midterm break in February.

Climate Innovation Fund – First Round

Earlier this year, the Climate Action
Office launched its Climate Innovation
Fund and in June 2022 three
applicants were successfully awarded
funding. The projects that were
awarded are as follows:

Maynooth Sustainable Energy Community

A community climate app to nudge hyper local sustainable community behaviours through gamification and reward.

The Climate Hub

A project that aims to capture data on traffic types and speeds data that will be used to co-develop active-travel related initiatives/nudging behaviour with the community.

Climate Response Ireland

A project that will develop real time information technology on indoor air quality in residents' homes, highlighting the damage pollution can cause in the home.

The Climate Innovation Fund is reissuing a second call for projects for Athy, Kildare-Newbridge, Naas and Clane-Maynooth.



Climate Innovation Fund – Second Round

Despite many potential projects being developed none met the criteria set. The fund is still at embedding stage and will be further examined with a view of developing the research and developed potential with other stakeholders.





Forestry

The finalised document 'Woodland Creation on Public Lands Scheme' was released on 28 May 2021.

The project is being advanced by a subgroup of the CAT called, Coillteach Chill Dara. The templates for tendering have been finalised and are available to utilize.

Alternative Fuels for Plant and Machinery

The use of Compressed Natural Gas (CNG) powered vehicles is seen as a viable option for larger machinery eg. Vans, trucks, tractors etc. while transitioning to a carbon neutral economy. Indigenous produced biogas could be a viable business model given the initial results from the Grass to Gas experiments. In February, Stephen Nolan of Green Generation, gave presentations hosted generously by the Continuing Professional Development (CPD) team. The presentations informed on the anaerobic digestion process, advantages and opportunities for climate action and circular economy.





The mechanical section in conjunction with the development of the new depot at New Hall by Roads Transportation and Public Safety Department has finalised an agreement to install a higher-grade gas pipeline to supply a fueling point to incorporate biogas into the fleet.

Research

Alternatives to Herbicides Project

The Parks/Climate Action Office's project including scientific research together with practical assessment in the field (Kildare County Council Parks Department and National University of Ireland, Maynooth) is designed to produce a practical maintenance guide for public open spaces.

Ten Local Authorities have partnered together with Waterways Ireland.
Green Clubs have expressed their willingness to join in the near future.
Ms Sophia Couchman, Masters student, together with Dr James
Carolan Maynooth University, Teagasc

and Kildare County Council have undertaken the scientific experiments in Kinsealy, County Dublin (Teagasc lands) along with practical experiments on Millennium Link Road, Naas while Eire Landscapes continue practical experiments on roundabouts in the Naas town area. Sophia is currently compiling the data from the various experiments to formulate the report due in late spring or early summer of 2023. A presentation was given in late October to Teagasc student's on the initial Entomology qualitative data. Each Municipal District received a presentation in March on the progress to date.

Pride of Premises.

Kildare County Council held its Pride of Premises Awards on Tuesday, 28 March, at the MERTIS building to recognise the great work Kildare businesses have done in enhancing their shopfronts by way of the council's Retail Support Scheme.

Leas-Chathaoirleach Joe Neville and Chief Executive Sonya Kavanagh presented the awards in 14 categories with the Overall County Winner being Boyle's Bar (Kildare Town) while the winners of the Overall Window Display went Lips and P's (Naas); both awards were adjudicated by Denise Doyle (retail consultant) and Vivian Cummins (professional architect). The Shining Stars Academy (Athy) won the Accessibility Award; this category was adjudicated by Michael Hurley of Kildare County Council.



Over 50 guests attended the evening where Barry Flanagan of Lock 13 (Sallins) also received an award recognising his nomination for the National Enterprise Awards.

Retail Support Scheme 2023 now open.

Kildare County Council has launched a range of financial supports for retailers to avail of in 2023. The scheme includes the annual Shop Front Improvement Scheme to financially assist business owners to improve the





appearance of their shop fronts or commercial properties. The scheme, which supported over 60 businesses in Kildare last year, aims to increase visibility for businesses and enhance the streetscapes of towns and villages around the county.

The scheme provides for up to 50% of the cost of shop front refurbishment, depending on the work proposed, with a maximum allowable contribution of €5,000 per applicant. The scheme also incentivises applicants to incorporate accessibility and age-friendly improvements to their shopfront with up to 75% of eligible costs covered under this measure.

The Retail Window Merchandising
Scheme is available for interior window
decoration and design of a shop with
funding of 80% to a maximum of €500.
This scheme is eligible for applications
from businesses year on year to keep
a modern, attractive window display.

Kildare Craft, Creativity and Design Hub

Following a competitive public procurement process, the council appointed a consultancy team to undertake a feasibility study of the Old Kildare Town Courthouse; it is proposed that a dedicated Craft, Creativity and Design Hub will be built

to act as a sectoral stimulus to develop a hub of enterprise, innovation, commercialisation, and learning.

Streetscape Enhancement Scheme (SES) 2022-2023

Athy successfully bid for €100,000 in funding as part of an initiative funded by the Department of Rural and Community Development. Under the SES, retailers, property owners and local groups can apply for grants that they can use to improve the facades of their buildings, carry out artwork or install features such as street furniture or canopies.

After an expression of interest process, the formal application for approved projects is now open and works are expected to commence in the coming weeks.

Diaspora Strategy

Kildare County Council recently completed its procurement process for a Diaspora Coordinator to be appointed to assist in the delivery of Kildare's Diaspora Strategy. It is anticipated that contracts will be agreed upon in the coming weeks and that a work package will be put forward.

Kildare Fashion and Textiles Hub
Kildare County Council recently
completed its procurement process to



engage a consultancy to undertake a feasibility study for a dedicated fashion and textiles hub to be located in Monasterevin. The former Bank of Ireland and surrounding sites will be assessed while the consultants will also engage stakeholders to quantify needs and demand.

It is anticipated that contracts will be agreed upon in the coming weeks and that a work package will be put forward.

Hub Activity Enterprise Europe Network (EEN) Company Mission:

A delegation of members from the Sachsen-Anhalt region of Germany were hosted in MERITS for discussions with Kildare County Council's Chief Executive, the Local Enterprise Office and Economic Development Department and Kildare's innovation hubs.



MERITS Hosts the Rubbish Film Festival:

Organised by Kildare County Council, the Rubbish Film Festival screening was hosted in MERITS with 35 students from local schools showcasing their short films highlighting Climate Action issues and Sustainable Development Goals.



Occupancy increase in MERITS:
