Kildare County Council took home two awards at the 2023 Excellence in Local Government Awards, which took place in the Crown Plaza Hotel, Dublin on Thursday 23 November 2023.

Winning Projects: Category: Festival of the Year Project: Brigid 1500 – St Brigid's Festival 2023



Brigid 1500 is a two-year programme to celebrate and commemorate St. Brigid; a woman, a life and a legacy. The aim of Brigid 1500 is to create a meaningful cultural and societal legacy that appeals to a diverse contemporary audience. Brigid 1500 engages communities with the story and heritage of St. Brigid, providing a



tangible connection with the past through events and programmes. The programme engages with the values St. Brigid championed, including faith and spirituality, biodiversity and sustainability, arts and culture, social justice, peace, hospitality and education. A ten-day festival took place to celebrate the inaugural St. Brigid's Bank Holiday, from 28 January to 07 February 2023. This programme was delivered in partnership with a dedicated Brigid 1500 Steering Committee. The celebrations included a school programme and four large flagship events alongside various community events delivered via a grant scheme and in collaboration with partner agencies.

The Wellbeing roadshow by Kildare County Council was a targeted countywide event hosted in the

Kildare/Newbridge Municipal District. The roadshow took place in the Kilcullen Mart on Tuesday 07 February. They partnered with Kildare West Wicklow Irish Farmers Association (IFA) to bring a community roadshow targeting isolated Farmers in to bring a community roadshow targeting isolated Farmers in Kildare. They made a deliberate decision to hold the event in a local mart to reduce barriers to participation and to ensure a sense of belonging on the day. They had over 25 information stands from various agencies and services including farmer related services and supports. They also introduced new Fitsticks for Farmers programme and had Minister Heydon in attendance and Ceann Comhairle speak on his journey with prostate cancer.

#### Partnership for Climate Action



Kildare and Kilkenny County Council announced the renewal of their partnership agreement to lead the Eastern and Midlands Climate Action Regional Office (CARO) for the next six years.

Kildare County Council as the lead authority in the region, supported by Kilkenny County Council, coordinates the delivery of climate action across 17 Local Authorities, encompassing the border, midlands, mid-east and southeast counties of the country (with the exception of Dublin).

Kildare County Council welcomes EPA Environmental Enforcement Performance Report for 2022 Kildare County Council welcomed the Environmental Protection Agency's Environmental Enforcement Performance Report for 2022 which shows that Kildare County Council achieved the required standard across

all of the National Enforcement Priorities (NEPs).

This is the second report under the revised Local Authority Performance Framework, which aims to align performance scores to the delivery of environmental outcomes under the National Enforcement Priorities (NEPs) by targeting key environmental issues. The NEPs cover the areas of air enforcement, waste enforcement, water enforcement and noise enforcement. Local Authorities are assessed based on set criteria including compliance rates, compliance promotion and awareness, enforcement actions and environmental outcomes. Each NEP is scored according to a four-point scale – excellent, strong, moderate and limited, where local authorities demonstrate performance by the end of the three-year cycle, 2022 – 2024. Kildare County Council scored excellent and strong across all of the national waste, water, air and noise enforcement categories as well as governance processes, and achieved the highest ranking across the following areas:

The awards are an All-Island competition whereby local authorities from across the island of Ireland nominate groups in their communities who they feel have made a significant contribution to improving their neighbourhood, working collectively. Maynooth Access Group, The Newbridge Women's Shed and Ballymore Eustace Community Development Association were the Kildare Nominees.

#### **Members Services**

The members of Kildare County Council adopted the 2024 Budget at the statutory budget meeting on the 20 November.

A special Meeting to discuss the three year Capital Programme 2024-2026 was held on Monday 27 November at 10.00 am.



The monthly meeting was held on the 28 November at which the reports on the audit of the Annual Financial Statements 2022 were noted. The Meetings Calendar for 2024 was also approved.



Donadea Forest Park Visit Malcolm Noonan TD, Minister of State for Nature, Heritage and Electoral Reform, met with Kildare County Council and Coillte staff at Donadea Forest Park in County Kildare on Tuesday 28 November. This visit was organised on foot of a resolution that was passed by the Clane Maynooth Municipal District members.

In partnership with Kildare County Council, Coillte successfully applied for funding this year to continue

restoration of the castle in Donadea forest park under the Department of Housing, Local Government and Heritage's Community Monuments Fund (CMF). The Community Monuments Fund (CMF) was established in 2020 to provide investment in Ireland's archaeological heritage and to prioritise funding for the care, conservation, maintenance, protection and promotion of archaeological monuments. In total Coillte has received close to €300,000 in funding from the Department since 2020 for the conservation of Donadea Castle under CMF and the Historic Structures Fund and Coillte has provided approximately €200,000 in matching funds.

#### **Capital Projects**

Naas Library and Cultural Centre The Library Service received handover of Naas Library on 29 November. The Library Service will need an additional four weeks to deliver and install furniture, staff and public IT equipment and systems, book stock, audio visual (AV) equipment, artwork, to test systems, train staff and complete snagging. We expect to open to the public early in 2024. The current library service in the building at Canal Harbour will close to the public from 09 December to allow for stock and equipment to be moved over.

#### Publication

The library service has partnered with Kildare County Council Access Officer, Creative Ireland and County Kildare

Access Network (CKAN) to publish Johnny Magory and the Mystery of the Missing Puppies by Emma Jane Leeson. The book follows the quest of seven children from Kildare, five of whom are disabled, to find their missing assistance puppies. The story is a celebration of diversity and inclusion and will be distributed through Kildare Libraries and given to every primary school in the county and every public library in the country.

#### Library Works

### Local Studies, Genealogy and Archives

The service will close from 09 December and re-open in the old Naas Library building at Canal Harbour location in early 2024. During this period customers can access our online resources. Free access to online resources including newspapers is available through the library network, inc. the Irish Newspaper



Archive, FindMyPast and the Journals of the County Kildare Archaeological Society.

#### **County Archives**

An update of the archival catalogue software has been completed. Three volumes of Naas Urban District Council minutes 1910 -1924 have been digitised (funded by County Kildare Decade of Commemorations programme). These will be online shortly.

Under the Creative Ireland: Kildare programme the archivist hosted a workshop 'Unfurling the Archives' for creative practitioners in St. Vincent's Hospital, Athy, on 08 November. As part of this project conservation work is being carried out on three Athy Poor Law Union admission and discharge registers.

#### **Decade of Commemorations**

The final meeting of the County Kildare Decade of Commemorations Committee took place on 17 November. Several legacy projects from the programme will continue into 2024, including the Irish Military Seminar and the events to mark the

centenary of the return visit of John Devoy to County Kildare in 1924. A special performance of the musical extravaganza Birth of a Nation took place in Riverbank Arts Centre on 09 November to mark the formal conclusion of the programme. Historians, artists, and members of the community who contributed to the programme attended the event where their contribution was acknowledged. It was preceded by the Kildare launch of A Nation is Born, Ireland in Colour 1923-1938 by historian Michael Barry and Ellistown native John O'Byrne. A talk and launch were held in association with Cill Dara Historical Society on 08 November to mark the publication of Strength of Comradeship; The killing of Private Joseph Bergin 13 December 1923 written by Mark McLoughlin. Free copies are available in all public library branches, it will also be available online through the Library Service BorrowBox service and as a pdf.

#### **Arts Services**

Arts Council Research Visit to Athy The Arts Council has engaged a consultancy firm to undertake research on the Creative Places programme



across the country. A representative from Counterculture/Amanda Smethurst met with community members who have been involved in Creative Places Athy programming to reflect on their experiences and the impact of the programme on the town of Athy (22 November).

### Made of Athy Grants Closed for 2023

The final deadline for Made of Athy grants for 2023 has passed and applications have been assessed.

#### Local Arts Officers AGM

Acting Arts Officer Eláine Donnelly attended the Local Arts Officers AGM in Thurles (16 and 17 November) which also included meetings with the Arts Council and Age and Opportunity.

### Artist support/Project development The Arts Service is in conversation with several independent artists, working across various artforms. As part of their applications to the Arts Council for Project Award and Festival Investments Scheme funding (deadline 16 and 23 November). The support offered aims to build relationships and provide resources to artists working

and/or living in the county, towards professional development and capacity building, project development and audience engagement. More details will be available following announcements by the Arts Council of funding decisions (expected early 2024).

Athy Access Billboard Project

Athy Disability Access Group and Creative Places Athy have created a project to encourage people to consider the barriers to access in our communities. Artist and illustrator: Ciara Chapman worked with three groups in Athy, Irish Wheelchair Association Athy, KARE Central Services and The Dara Project over a period of three months to co-create content for billboards which has the participants voice at the heart of the message.

This two-and-a-half-month campaign takes the form of creating a series of seven billboards on Leinster Street, Athy from November 2023 to February 2024.



budget provision, they need to find the funding elsewhere by reducing some other line of expenditure. #### **Cashflow / Overdraft**

Kildare County Council manages its cashflow requirements daily and did not avail itself of its overdraft facility during the period 01 January to 30 November 2023.

#### Rates

New legislation regarding commercial rates will take effect from 01 January 2024. The Local Government Rates

and Other Matters Act 2019 effects the following changes:

Replaces the payment of rates in two moieties with one rates amount due on the first of the year.

Replaces the issuing of Property Entry Levy (PEL) and valuations taking effect the year after issue of a schedule (by Tailte Eireann) with immediate billing through the calendar year.

- Provides for the application of interest on unpaid rates from 2025. Interest will be added to rates bills issued from 2026.
- Removes the requirement for public notice to be given regarding Kildare County Council's intention to 'make the rate'. This is replaced by a notice advising that a 'rate has been levied'.
- Removes the requirement for the rate book to be available for inspection, either in paper form or electronically.

Kildare County Councils' Finance Department will be writing to all rates customers in December to advise them of these changes, particularly the transition from two moieties to one and advising of their payment options, including Direct Debit to facilitate payment across the calendar year. #### Housing

Housing for All Room for a Student – Local Authority Tenancies

The Government has introduced a new scheme called 'Room for a Student'. Council tenants with a spare bedroom may let that bedroom to a third-level student for the academic term. The tenant requires the consent of the council prior to the letting, and income earned is included in the calculation of differential rent. The scheme will operate on the basis of a license agreement between the tenant and the student. Local authorities will be responsible for operating and managing the scheme and the administration of the individual applications and agreements locally. The Scheme is open from 01 December 2023 and details are available on the council's website.

#### **Housing Allocations**

For the period January to November 2023, the council allocated a total of 1,118 social properties. Expected delivery before the end of the year includes 167 AHB properties, 43 leased properties and 84 Part V properties at various locations throughout the county. Allocations are ongoing and, in an effort to address the number of refusals of offers of accommodation, the use of Choice Based Letting (CBL) has been continually increased.

### Homeless Services Street Work / Outreach Clinics During November the Outreach Team visited all Municipal District areas on a regular basis to identify rough sleepers. The areas covered were: Leixlip, Celbridge, Kilcock, Rathangan, Maynooth, Naas, Newbridge, Sallins, Broadford, Athy and Kildare Town.





The Outreach Team offered housing advice clinics during the month for individuals and families who could not attend the council offices in person. These clinics were facilitated in Newbridge Family Resource Centre, Athy Family Resource Centre, Celbridge Community Centre in Ballymakealy, Cuan Mhuire Athy, Teach Tearmainn, Teach Dara Family resource centre Kildare Town, Maynooth Library, Platinum Clubhouse Newbridge, Heads Up Programme, Kildare Town and Aras, Newbridge. The team also conducted assessments with hospital and prison discharges.

#### **Visits to Service Providers**

Meetings were held with The Peter McVerry Trust in Eyre Street, Newbridge and Kerdiffstown, Mount



Offaly in Athy and Tiglin in Jigginstown to review clients' housing needs and to discuss exit strategies.

#### Exits from Emergency Accommodation

There were 15 'move-ons' in November, facilitated through HAP, social housing and some clients returning to family.

#### **Tenancy Sustainment**

At present there are 41 active tenancy sustainment cases, with 23 on the waiting list for support; 17 cases were closed during November. Sustainment Officers have ongoing engagement with two housing clinics, in the Family Hubs in Prosperous and Athy.

Homeless HAP and Cost Rental Tenant in Situ Scheme (CRTiS) The Housing Department has processed 68 Homeless HAP applications to date. The Council has submitted eight CRTiS applications to the Housing Agency; one has been withdrawn and the outcome of the others is awaited.

#### Offer a Home – Ukraine



A national 'refresh' promotional campaign has been undertaken in November for the 'Offer a Home' scheme. This call is for offers of houses, apartments or holiday homes that are currently unoccupied and could provide accommodation to those fleeing war in Ukraine.

Currently in Kildare, there are 39 such properties occupied by individuals and families, with an additional 17 being assessed.

A tax-free recognition payment of €800 per month is available to anybody offering accommodation to those fleeing Ukraine. Details of the scheme can be accessed online at www.offerahome.ie

**Traveller Accommodation** The Annual Estimate of Accommodation of Traveller families was carried out on 24 November last. The estimate provides a measure of



the accommodation position of Traveller families, and changes to that position, year on year. The report will be considered at the next meeting of the Local Traveller Accommodation Consultative Committee.

### Addressing Vacancy Croí Cónaithe

One Hundred and thirty-nine (139) Vacant Property Refurbishment Grant applications have been received.

#### **Town Centre First**

In preparation of the Town Centre First Plan for Clane, there were 766 responses to the public survey and the public workshop held on 07 November. Members of the public attended and participated in the workshop and gave their views on Clane and its future direction. The consultants are currently compiling all data from both the public survey and the workshop with the intention of issuing a baseline report in December.

**Compulsory Purchase Orders (CPO)** Following is an update on the council's Compulsory Purchase Order (CPO) programme:

20 Compulsory Purchase Orders commenced. 12 CPO's confirmed. Three with An Bord Pleanala for decision. Two CPOs under derelict sites legislation will be confirmed on 05 December 2023 if no objections received.



Three CPOs withdrawn (two sold on the private market and one purchased by agreement under buy and renew). 44 pre-CPO notices erected in 2023; ongoing contact and engagement with 36 of these property owners around bringing the properties back into use and the various schemes available.

**Uisce Éireann Framework** The Framework for the Future Delivery of Water Services was published in June 2022, setting out the Government policy with Uisce Éireann taking full control of all aspects of the delivery of water and wastewater services. Uisce Éireann is engaging with key national bodies and representative groups to prepare for the

implementation of the Framework provisions.

The existing Service Level Agreement will be replaced by a Master Agreement for all local authorities and an individual support service agreement per local authority, taking into consideration changes included in the new Framework. In this regard, the Master Cooperation and Data Sharing Agreements were signed by Kildare County Council in May 2023.

### Environment

Draft National Waste Management Plan for a Circular Economy. Section 22 of the Waste Management Act 1996, as amended requires each local authority to make a Waste Management Plan. The Regional Waste Management Planning Offices, under the auspices of the County and City Management Association, are coordinating the preparation of a new Plan on a national basis, titled "National Waste Management Plan for a Circular Economy." A copy of the latest update was recently circulated to each Chief Executive.



The Plan sets out a framework for the prevention and management of waste in Ireland for the period 2023 – 2029, and it is expected that the new Plan will be implemented in Q1 2024 by Chief Executive Order in each of the Local Authorities. Details are on www.mywaste.ie

A National Deposit Return Scheme (DRS) has been launched by Department of Environment, Climate and Communications (DECC). The Deposit Return Scheme (DRS) being introduced is a circular economy initiative, focused on plastic bottles and aluminium/steel cans. Latest info suggests a go live date in February /March 2024.

# Public consultation on Disposable Vaping Devices

Minister of State at the Department of the Environment, Climate and Communications with special responsibility for Communications and the Circular Economy, Ossian Smyth TD, launched a public consultation to help inform Ireland's response to disposable vaping devices.

### **Tidy Towns**

Grants to local Tidy Towns committees were approved by the respective Municipal District members and have been processed for payment.

### Water Framework Directive

Monitoring and investigation work continue in the water priority areas under the Water Framework Directive. The council awaits the publication of the third cycle of the River Basin Management Plan for the period up to 2027.

This document is expected to be published this year and will set the priorities and areas for action over the next cycle.

### **Enforcement Priorities 2024**

The National Waste Enforcement Priorities 2022-2024 were recently reviewed by the National Steering Group and a number of changes were made to reflect these discussions. The following remain as high-level priorities in the area of waste enforcement:



Tackling significant illegal waste activity, Construction and Demolition activity, End-of-Life Vehicles, Waste collection, PRI initiatives. The Kildare County Council Recommended Minimum Criteria for Environmental Inspections (RMCEI) and the 2023 Plan submitted to the Environmental Protection Agency (EPA) Kildare County Council was judged as one of the top performers Nation-wide in terms of environmental inspections.

### **Environment Complaints**

Pollution complaints continue to be investigated in accordance with national guidelines.

### Domestic/Commercial Refuse Collections

Domestic and commercial waste collections are continuing as normal. Details of approved operators are available via the National Waste Collection Permit Office (NWCPO) website: www.nwcpo.ie



### GAA Green Clubs Initiative



Cappagh GAA club is the pilot club for Kildare for this national initiative. The next phase of the project involves reducing waste arisings within the clubhouse and work on this is proceeding.

New Initiatives – Civic Amenity Site North – Near Celbridge A joint project of the civic amenity in conjunction with the proposed Municipal District depot is being assessed.

Catchment Flooding Catchment Flood Risk Assessment and Management Study (CFRAMS) A steering group with the Office of Public Works (OPW) has been established to progress the consultant's brief for schemes within Kildare. The municipal districts will be briefed as schemes from the Catchment Flood Risk Assessment Management (CFRAM's) Programme commence.



Morell Flood Management Scheme Construction of this scheme is continuing.

### **Cemetery Capital Programme**

This programme, which includes cemetery extensions, capital type internal improvements and proposals for columbarium walls is currently being reviewed in line with funding availability.



#### **Columbarium Walls**

New Columbarium walls were completed in Crookstown and Rathangan cemeteries. It is proposed to install further Columbarium Walls in St. Michaels Athy, Leixlip Confey, and St. Conleth's Newbridge cemeteries as part of the current capital programme of works. Detailed design drawings are currently being worked on and it is envisaged that the project will advance to tender stage prior to the end of 2023. It is hoped that works will commence onsite in Q1 2024 subject to funding approval.

### **Cemetery Works**

#### Allen

Works have been recently completed on a cemetery extension.

### Staplestown

Landscape improvement works are expected to commence during Q1 2024 to open the lands to the rear for future internments.

### Confey

Works have been recently completed to allocate additional plots for internments within the cemetery.

Athy Cemetery Boundary Wall

Works completed on new boundary wall between the cemetery and the new Athy Southern Distributor Road.

### Boycetown, Kilcock

Tenders have issued for major drainage improvement works. It is hoped that this will help deal with ground water problems that hamper winter time internments in certain parts of the cemetery.

### Newbridge

Works on improvements to Newbridge cemetery carpark recently commenced and are expected to be completed prior to end of 2023.

### Monasterevin

Works have been carried out on cutting back shrubs and bushes within the cemetery. Removal of rubbish (stone, clay etc) from the cemetery has also taken place recently.

# Local Authority Climate Action Training Programme



The training programme 2020-2023 is nearing the end of its term. The programme maintains an objective to build capacity of the c.29,000 staff and 949 elected members on climate change, climate action and the role of local authorities on climate action. Through six unique training pillars the programme has to date, provided some 23,000 training places to 21,600 participants (figures correct as of end of October). Training continues with

outdoor staff till the end of the year and into early 2024 and will include fire services staff.

A high level steering group chaired by a representative of the Climate Action, Transport, Circular Economy and Network (CATCEN) committee will be convened in early 2024 to oversee the development of a training plan guiding future training needs and priorities in the area of local authority climate action.

### Local Authority Climate Action Plans (LA CAP)

All local authorities continue to engage with the process of developing their LA CAPs for adoption on or before the 23 February 2024.

Currently local authorities are at draft stage and engaging in public consultation activities. This stage sits ahead of the completion stage where written submission will be considered and elected members will have the opportunity to consider all documentation including adaptation and mitigation evidence base, draft plan, SEA and AA reports and submissions of stakeholders before adopting the plan by way of resolution.



Local Authority Progress Reporting – Climate Adaptation Strategies: Annual reporting on progress of the implementation of Local Authority Climate Adaptation Strategies / Plans has been undertaken by all Climate Action Officers/Leads in all local authorities. A sectoral report is being collated by CARO for progress in the 2022 – 2023 period, for submission to the Department.



Sub-Regional Energy Projects The CARO are working with local authorities in each of the four subregions to develop regional energy units to avail of funding for projects that support the decarbonisation of local authority buildings. The energy units comprise:

Mid-east (Kildare, Meath, Wicklow and Louth), commencing projects and accessing Pathfinder support from SEAI.

Midlands (Laois, Offaly, Westmeath, Longford, Roscommon), have developed their project pipeline and

sourced funding to match Pathfinder support.

Border (Cavan, Monaghan, Leitrim) are working with project manager assistance from SEAI to build a project pipeline.

South-east (Carlow, Kilkenny, Tipperary, Wexford, Waterford City and County) convening to agree partnership approach to access Pathfinder support.



Reimagining Local Authority Fleet The CARO supports the reconfigured working group established to explore support and options for local authorities on fleet decarbonization. A survey was distributed to local authorities recently to gauge their alignment with Avoid-Shift-Improve principles. The findings of this survey will be compiled for the CATCEN committee meeting in December.

Development of Local Authority Key Performance Indicators on Climate Action



Data collation for 2022 will be published towards the end of December 2023. Data collection for 2023 will be done in March 2024. Thereafter, data collection will be undertaken every March.

### GAA / CCMA Green Clubs Programme:



The CARO continues to work with the GAA and expert partners to advance the Green Club Programme. Phase two of the Programme commenced in early 2023 increasing the number of participating clubs to approximately 200. During phase two of the Programme clubs are working their way through a range of sustainability and climate action related projects as

provided for by Green Club Toolkits covering the five themes of Energy, Water, Waste, Biodiversity and Travel.

Participating clubs are working to implement actions and projects detailed within the toolkits towards supporting the pursuit of climate action initiatives at club and community level. Kildare County Council's continued support of Green Clubs will help to achieve climate actions and targets set out in the Council's new Climate Action Plan.

## Climate Action Plan (SECAP) /Climate Action Plan (CAP)



Public consultation closed on 03 November resulting in 35 submissions. Overall, the submissions were positive with many welcoming the plan. The plan is on track to be adopted on 18 December and published in January 2024 to coincide with the start of the new working year.

Designedly are undertaking the graphic input required to publish the

plan and will be finalised post adoption of the plan. Star Translations Services have commenced work on translating the document into Irish.

### The Mid East Energy Unit (MEEU)



The baseline of energy usage to inform the decarbonising of our buildings' energy usage has been presented by CODEMA. To advance the Register of Opportunities (RoO) the SEAI have agreed to pilot Pathfinder funding for the Photo Voltaic (PV) cells at the Cotton Mills, PV and Geothermal for K Leisure pools facilities at Naas and Athy in conjunction with works on swimming pools in Meath and Wicklow. The work will enable retrofit works (energy efficiency and decarbonisation) on existing buildings.

Given the potential for future district heating in Naas the unit is working to ascertain the capacity to undertake a district heating feasibility study in the first half of 2024.



#### **Climate Action SPC:**

The scheduled meeting on 06 December 2023 took place and included presentations from Fergus Sharkey, (Head of Business Supports and Transport, SEAI) on SEAI Supports for Business Low Carbon Transition, followed by a presentation from Meabh Boylan (Kildare County Council Biodiversity Officer) on Kildare County Council Biodiversity and Climate Change and an update from Paula O'Rourke (Climate Action Coordinator) on the Draft Climate Action Plan and Maynooth DZ.

# Climate Action Community Initiatives Items Awarded:



An Roinn Leanaí, Comhionannais, Míchumais, Lánpháirtíochta agus Óige Department of Children, Equality, Disability, Integration and Youth

The successful implementation of Gnáthóga Nádúrtha (Natural Habitats) - initiative as part of the Arts Council's Invitation to Collaboration scheme has been completed.

€75,000 was awarded under the Creative Ireland's Climate Action: Invitation to Collaboratively fund an application, led by Carlow County Council, in conjunction with Kildare

and Meath County Councils. The ambitious arts led inquiry, an interdisciplinary, collaborative intervention, sited across three natural heritage peatland habitats in Carlow, Kildare and Meath brought the urgency of climate action to the forefront. An application to the Arts Council for a continuation / Phase two of the project that focusses specifically on the artists has been successful and provides an additional €35,000 in funding.

### People's Patches for Community Climate Action:

Kildare, Longford and Laois County Council along with Maynooth University, The Useless Project and Neighbourhood Network (lead) have been awarded by Pobal €271,000 funding for the Community Climate Action project submitted in January 2022. The project is to inform in communities how to source and grow quality local food and increase cooking skills to enable meaningful dietary skills to combat poor nutritional uptake especially within deprived neighbourhoods.





'Climate Design Lab: Where Creativity In Practice Meets Climate Action' Under Creative Climate Action Fund II: 'Agents for Change Creative Ireland' informed Kildare County Council on 12 July that a conditional award of funding of €250,000 has been approved. This conditional offer is subject to a Service Level Agreement (SLA). Climate Design Lab: Where Creativity In Practice Meets Climate Action Kildare County Council along with the Design Innovation Department in Maynooth University and Riverbank Arts Centre will pilot a Climate Design Lab that aims to use design-thinking and behavioural economics to co-create fun theory solutions for Maynooth, the decarbonising zone for the county. Preliminary work has commenced with Maynooth University.

### Community Climate Action Fund Program:

Our Community Climate Action Officer has undertaken a scheduled program of outreach to gain appropriate submission by the end of February deadline. To date the information has been received well and potential projects are being put forward by interested parties. The official launch

by the Department was rescheduled to 11 December based on the need to program in GDPR requirements specific to the fund. The date is to be confirmed.

Open Data Engagement Fund: In collaboration with the innovation Team and MERITS we have successfully been awarded €5,000 from the Open Data Unit in the Department of Public Expenditure and Reform. The funding is to sponsor prizes for our Hackathon in February which should place us firmly on the map for participants.

### Research

Gas Innovation Fund and Public Service Innovation Fund: This project aims to assess the potential for green spaces to generate biomass e.g., grass-clippings as a feedstock for energy generation in Kildare with the potential of scaling the study up to different county councils and state bodies nationwide. If successful the main body of work will be carried out by a postdoctoral researcher with project support from the Climate Action Office, Maynooth University, and engagement with Teagasc. To



advance the project financially an application was made to the Public Service Innovation Fund 2023. Funding has been rewarded and the Memorandum of Agreement is in place with the Public Bodies Innovation Fund coordinator. An agreement has been formulated with Maynooth University to enable the research to commence at pace. It is expected that the project will be completed by Q2/3 of 2024.

Alternatives to Herbicides Project Kildare County Council's research project - alternatives for pesticides continues with the help of our collaborating partners, Maynooth University, Trinity College Dublin, National Biodiversity Data Centre and Teagasc. The finalised data report and practical guide for the maintenance of open spaces have been disseminated to all partners. Analysis of soil biomes continues with additional experiments being undertaken to finalise maintenance aspects. Sophia Couchman has commenced her PhD and it is expected she will have the work completed Q1/2 of 2025. It is with thanks to our Local Authority partners together with WI and the GAA we can

continue to fund this valuable research to enable change on the ground. The partnership has agreed to allow the use of the findings in the work of the National Biodiversity Data Centre to inform the latest brochures and to have the guidance officially published.

# Local Community Development Committee

The last meeting of the Local Community Development Committee (LCDC) was held on the 29 November 2023 in the Merits building.

### SICAP - Social Inclusion Programme

County Kildare LEADER Partnership, who are contracted to run SICAP in Kildare are focusing on responding to priorities agreed by Kildare LCDC that fit with current national priorities. A national tendering process is underway for the SICAP programme 2024 to 2028. It is anticipated that this contract will be issued before the end of the year.

AIRO in Maynooth University are finalising updating and analysing Census 2022. The plan is on track to be finalised in early 2024.

Annual call from DoT for grant funding requests on Bridge Rehabilitation, Road Safety works, CCAR (Climate) and former National roads (FNR) for 2024 have been submitted to DoT. 711 Road Surfacing grant to value €67,500 to be drawn down via PRS to cover works carried out on N78 (Athy – M9 Roundabout). Other maintenance monies will be utilised on both N78 and N81 before year end.

Winter Maintenance season commenced on 16 October. 705 km of roads now being treated and allowing for National Primary roads covered by TII – 31.5 % of all public roads included in county Winter Maintenance programme – higher than neighbouring counties. Salting route map is available to view on the Council website.

### **Public Lighting**

PLEEP Survey to commence in November of this year followed by detailed design in March 2024 with works on site to commence in Q3



2024. Contract duration is for eight months and due for completion in Q2 2025 which will lead to annual savings of approx € 750,000 on energy and maintenance costs going forward.

# Open Spaces (Parks) News and Highlights Allenwood Playground

Works are continuing on the site. The pump track is complete. Work on the installation of play equipment is due to start the second week of December. Fencing for the multi use games area has also started.








**Number of Buildings Inspected**



#### Skills Audit:

"Kildare County Council published a request for tender for a suitable

consultancy to undertake a skills audit of County Kildare; responses are expected 04 December 2023. The audit will comprise a detailed analysis of the existing talent and skills within the county and the skills requirements across the county over the medium term. It is anticipated the audit will be completed by April 2024 when, at this point, it will inform Kildare County Council's strategic employment/ industrial land study (currently being undertaken by Kildare County Council's Forward Planning Department) and the tenderer will then work to deliver a comprehensive report to determine a strategy for the County by June 2024."

### Athy Food, Beverage and Skills Innovation Hub

Kildare County Council was required to submit its tender documents to Department of Rural and Community Development for approval before publication; Kildare County Council received positive feedback and its design team has published the tender documents.

The Innovation Exchange came to MERITS during October to offer businesses the opportunity to learn about their network. The programme offers the opportunity for small and medium sized enterprises (SMEs) to sell their products and services to Multinational Corporations with whom they may traditionally find it difficult to engage.
