Minister of State in the Department of Health with responsibility for Mental Health and Older People, Mary Butler TD was guest of honour at the launch of the Kildare Age Friendly Strategy 2023 – 2027 in McAuley Place, Naas on Thursday 25 May 2023. The Strategy sets out the shared ambitions and goals to ensure the creation of an age-friendly county and one which is a good place to grow old.

Attendees at the launch in McAuley Place, Naas also had the opportunity to experience 'Future Tapestry' a newly commissioned virtual reality artwork which is an artistic response to the current state of sheep farming and wool production in Ireland. Directed

and produced by John Conway and written by Aisling Byrne, with visual by NOHO Dublin. The artwork was Commissioned by Kildare County Council Library Service, Climate Action and Age Friendly Co-ordinators and funded by Creative Ireland through the Creativity in Older Age Scheme.

Kildare County Council Welcomes
Funding from Community
Recognition Fund



Kildare County Council has welcomed the announcement by the Government of over €768,000 in funding for ten projects in Kildare as part of the first ever Community Recognition Fund.

The major initiative of over €50 million in funding for over 880 projects across the country is designed to support and reward communities that have welcomed families and citizens from Ukraine and other countries.

In Kildare, the successful projects range from community buildings,



upgrade works to sports facilities to installation of new heating systems, age friendly facilities, multi-purpose facilities, equipment for sports clubs and much more.

Kildare County Council Awards
Contract for Major Rehabilitation
Works on M7 Bridges



Kildare County Council confirmed that the Civils works contract for Major bridge rehabilitation works on the M7 has been awarded to GLAS Civil Engineering Limited. The successful contractor has been appointed following an extensive tender process. The Major bridge rehabilitation works, which are being funded by Transport Infrastructure Ireland, are being undertaken at the M7, Junction 10, Newbridge Road Overbridge and the M7, Newhall Overbridge (Rathangan Road). Upon completion, the structures will be re-waterproofed,

resurfaced and their parapets upgraded. At the M7, Newhall Overbridge a shared cycleway and footway is also being constructed to facilitate a future active travel route across the M7 motorway.

## **AV Upgrade in Council Chamber**

The revamp of the Chamber has commenced. To go live with the new revamped chamber in September a detailed project plan needed to be put in place. There are three main vendors involved in the revamp of the Chamber, the joiners (M and C Joiners), electricians (Jones Electrical) and SKS Communications who are looking after the Audio-Visual upgrade.

The Chamber will need to be completely rewired and this encompasses both electrical and network requirements and includes an upgraded induction loop to support the new AV equipment. As the panels on the desks will need to be replaced new desktops will also need to be installed on each desk, this requires custommade work for each desktop.





The templates for the new desktops have been created and work has already started with the joiners. The plan is to do the full rewiring in July and the installation of the new desktops and AV equipment in August with time for testing and training.

The upgrade will include screens on each side of the chamber, a new speaker system and individual speakers on each desk with plug-in for earphones. Members speaking will be highlighted on screen for the benefit of both those in the chamber and those online. Separately, testing is ongoing on an electronic voting app for members attending in person or remotely to vote on their phone or laptop.

Libraries provided music,





song, exhibitions, seed sowing, crafts, film screening, history talks and exercise, all with tea/coffee and chat.

## **Better Basics Boosting Reading**

Kildare Libraries in partnership with
County Kildare LEADER Partnership
have completed this year's Better
Basics Boosting Reading Programme.
This is a reading enhancement
programme with paired one-to-one
reading with a volunteer, twice a week
for 15 weeks, aimed at primary school
children who are not in receipt of





mainstream supports but who are struggling to keep up in class. We celebrated the end of this year's programme with a prize giving in St. Bridget's School, Kildare Town. This year we had 32 children participate in the programme, 5 schools and 15 volunteers. The reading improved on average by approximately 12 months.

## Football Association of Ireland (FAI) Women's World Cup Activity Book

The FAI Activity Books are available to collect from all Kildare Libraries now.

The activity book is aimed at third to sixth class primary school children and the FAI are keen to get this out to as many children as possible, before and during the World Cup this summer.

#### My Little Library Book Bag

The 'My Little Library Book Bag' initiative is a collaboration between the library and the Department of Children, Equality, Disability, Integration and Youth as part of the First 5 Strategy. The bags are now available in all Kildare library branches to collect by parents/guardians of children starting Junior Infants in September 2023.

## Local Studies, Genealogy and Archives



Kildare County Council's senior staff are scheduled to workshop risk with IPB over the coming weeks.

To this end a "Call for Ideas" initiative was recently launched asking staff to come forward with any idea that might have the potential to benefit staff, our organisation and/or the citizens of Kildare.

The Innovation Team were delighted with the response to the initiative which saw 59 submissions received from staff across all grades and departments.

The Evaluation Committee will meet on the 16 June 2023 and is comprised


of a multi-disciplinary team including internal colleagues and colleagues from other Local Authorities and the Department of Public Expenditure, National Development Plan Delivery and Reform.

## **Homeless Services**

#### **Homeless Outreach**

Street work was completed in Athy and Newbridge. Outreach clinics were provided in Newbridge Family Resource Centre, Athy Family Resource Centre and Ballymakealy Community Centre, Celbridge. During May the rough sleeper count reduced to three people, overall, there has been a reduction of 11 rough sleepers since the start of the year.

## Presentations and Exits from Homelessness

During the month of May, homeless presentations were down, with 148

presentations in May compared to 169 in April. A new Housing First tenancy was created in May. Seven families and seven individuals exited emergency accommodation in May. Six families entered emergency accommodation in May.

## **Tenancy Sustainment**

At present we have 84 active tenancy sustainment cases. Tenants are receiving assistance with issues such as rent compliance, community service provision and social welfare.

## **Housing Assistance Payment (HAP)**

There are currently 1,881 active HAP tenancies being supported. 166 new tenancies have been set up year to date (with 151 being ended). Year to date 28 Homeless HAP applications have been received, compared to 26 applications being received in 2022.

### **HAP Landlord Guarantee**

The Department of Housing, Local
Government and Heritage has
introduced a HAP landlord guarantee,
this measure has been introduced to
ease the impact of the ending of the
Winter Emergency Period. Landlord
payments are guaranteed for a period
of 12 months where tenants default in






their differential rent payment, this guarantee does not extend to top-up payments being made to landlords. Further details of this scheme are available from the HAP Section.

## **Uisce Éireann Framework**

The Framework for the Future Delivery of Water Services was published in June 2022, setting out the Government

policy on Uisce Éireann taking full control of all aspects of the delivery of water and wastewater services.

Uisce Éireann is engaging with all the key national bodies and representative groups to prepare for the implementation of the Framework provisions.

The existing Service Level Agreement will be replaced by a Master Agreement for all local authorities and an individual support service agreement per local authority, possibly by end of Quarter two 2023 taking into consideration changes included in the new Framework. In this regard, the Master Cooperation and Data Sharing Agreements were signed by Kildare County Council in May 2023.

## **Environment**

#### Kerdiffstown Landfill

The retired director of a waste management company has been sentenced to three years in jail at Dublin Circuit Criminal Court, with the final 12 months of the sentence suspended.



The Director of the EPA's Office of Environmental Enforcement, Dr Tom Ryan, said: "Waste crime can cause harm to the environment and public health and have significant consequences for the taxpayer. "This conviction is a vindication of the resilient efforts of the State authorities working together for the public good over almost two decades.

Kildare County Council was granted a licence to remediate the site in 2011.

## Draft National Waste Management Plan for a Circular Economy.

The Regional Waste Management
Planning Offices, under the auspices
of the County and City Management
Association, have co-ordinated the
preparation of the National Waste
Management Plan for a Circular
Economy.

The Plan sets out a framework for the prevention and management of waste in Ireland for the period 2023 – 2029. Public Consultation for the Draft National Waste Plan for a Circular Economy commenced on Wednesday 3 May 2023 and will run until Wednesday 5 July 2023. Details are on www.mywaste.ie

The draft plan was discussed at the Environment and Water Services SPC meeting on 9 May 2023. The SPC members undertook to make a joint submission on the draft plan.

A National Deposit Return Scheme (DRS) has been launched by the Department of the Environment, Climate and Communications (DECC). The Deposit Return Scheme (DRS) being introduced is a circular economy initiative, focused on plastic bottles and aluminium/steel cans. Latest info suggests a go live date in Feb /Mar 2024.

## Public consultation on Disposable Vaping Devices

Minister of State at the Department of the Environment, Climate and Communications with special responsibility for Communications and the Circular Economy, Ossian Smyth TD, has launched a public consultation to help inform Ireland's response to disposable vaping devices.



### **Inaugural Rubbish Film Festival**



The first-ever Kildare "Rubbish Film Festival" for Transition Year Students in Secondary Schools was held on a pilot basis this year with entries from five participating schools across the County, and it was a resounding success.



The festival, which challenged students to create a one-minute short film on the theme of reducing waste and encouraging sustainability, was

facilitated by Createschool and supported by Kildare County Council. The festival received a great response from the schools, with students showing their creativity and innovation in producing ten short films that were both educational and entertaining. Two films and a poster design were selected as the winners in their respective categories and will go forward to represent County Kildare at the National Awards in Meath in May 2023.

The organisers hope that the festival will become an annual event that will help to raise awareness about environmental issues among young people and inspire them to take action to protect the planet.

#### **Community Clean-ups**

Green Kilometre groups continue to be very active. There is also continued demand from community and Tidy Towns groups for supplies to aid with clean-ups and litter picking around the county. Residents Associations who express interest in installing compost areas for green waste on their estates will also receive council support.

- a) Athy Cemetery Boundary Wall Awaiting the completion of a new boundary wall between the cemetery and the new Athy Southern Distributor Road.
- b) Boycetown, Kilcock
  Investigation works are
  underway in terms of resolving
  serious groundwater drainage
  issues within the cemetery.
  Expected that major capital
  improvement works will begin
  during Quarter three 2023.

#### **Cemetery Maintenance Programme**

This programme includes footpath resurfacing, drainage improvements, tree maintenance, and completion of old works. Some of the works currently at planning stage include the following:

connection for the public lighting on this project.

b) Confey Cemetery

### **Climate Action Regional Office**



The Climate Action Regional Office (CARO) works to support local authorities to drive climate action in their counties, with particular focus on implementing actions contained within climate adaptation strategies /climate action plans. For more information on the work of the CARO, see our website at www.caro.ie



#### **Climate Action Teams (CATs)**

A new webinar series, to support the work of CATs has been launched including themes of Local Authority Climate Action Plans, Trajectory 2030: Local Authority Mitigation and Energy, Community Climate Action, Creative Climate Action, Climate Action through Heritage and Biodiversity, Adapting to Climate Change, Decarbonizing Zones.



### **Online Training**

Since its launch in January 2021, the rollout of the Raising Awareness online programme has seen a total of 17,531 staff at grades seven, six, five, four, three (and equivalent technical grades) enrolled on the programme, with a total of 13,561 (78%) having completed the programme. The programme has now been substantially updated, with a much greater emphasis on the use of short videos to aid in the learning process. This new version is being rolled out by





all Local Authority training departments, with assistance from the Local Authority Services National Training Group (LASNTG), from the 1 March 2023.



### **Thematic Training**

Training under this pillar responds to identified training needs of specific local authority groupings. Other training courses under this pillar are at various stages of design and progression towards delivery, including training aimed at/focusing on the Older Persons Council, Economic/Enterprise Opportunities and Roads Infrastructure.



#### **Outdoor Staff**

This training focuses on outdoor staff in local authorities, with trainers working on behalf of the Local Authority Services National Training

Group and commenced in January 2023.



#### **Frontline Staff**

This training is targeting staff of local authorities who are front line or community-facing and will be delivered in person by the Institute of Public Administration (IPA) and Local Authority Services National Training Group (LASNTG), who will coordinate with training officers in local authorities to make registration arrangements. The programme was piloted in March 2022 and rolled out across the CARO regions over the year, before opening to all local authorities in October, November.

# Economic Opportunities Conference 2023

A very successful Economic
Opportunities conference was held in
Tullamore on the 26 April 2023. With
over 140 in attendance, the
conference looked at how businesses
are capitalising on new opportunities
and becoming green pioneers.

# Local Authority Climate Action Plans (LA CAP)

The Minister has approved a business case for local authority climate action resources in respect of two roles. A letter of comfort has been issued by the Department of the Environment, Climate and Communications (DECC), relating to the recruitment of these resources on a five-year term for the purposes of developing and implementing the LA CAP as aligned with the provisions of the business case.

The Climate Action Plan 2023 was published by the Minister on the 21 December 2022 with the Annex of Actions published in March 2023. To support local authorities, CARO have established three national frameworks of consultants for county wide BEIs (Baseline Emission

Inventories), Climate Change Risk Assessments as well as BEIs for Decarbonising Zones (DZ) and planning and implementation activities linked to Climate Action Plans or commitments under the Local Authority Climate Action Charter. The development of a framework for the provision of services for Strategic **Environmental Assessment and** Appropriate Assessment screening is also being finalised. On the 24 February 2023, the Minister issued instructions to all Local Authorities to commence the process of preparing the Local Authority Climate Action Plan (LACAP). "Through the leadership role of local government on climate action, the LACAP will support meaningful and innovative climate action across all local communities."

# Local Authority Progress Reporting - Climate Adaptation Strategies:

Annual reporting on progress of the implementation of Local Authority
Climate Adaptation Strategies / Plans has been undertaken by all Climate



Action Officers/Leads in all local authorities. A sectoral report is being collated by CARO for submission to the Department.



### **Sub-Regional Energy Projects**

The CARO are working with local authorities in each of the four subregions to develop regional energy bureaus or regional energy efficiency projects.

In the Mid-East, the three local authorities involved (Kildare, Meath, Wicklow) with the assistance of CARO, are in the process of finalising a contract with CODEMA to provide an energy service for local authorities in this sub-region.

In the Border sub-region (Cavan, Monaghan, Leitrim): A tender for a public building energy efficiency report resulted in Codex Energy being appointed. Their final report identifies 18 buildings with a project pipeline of

over 100 potential projects for each building to attain a B2 rating.
In the Southeast (Kilkenny, Carlow, Wexford, Waterford, Tipperary): The four Directors of Carlow, Waterford, Wexford and Kilkenny, have instructed the South East Energy Agency (formerly 3CEA) to pursue Pathfinder Support.

In the Midlands (Laois, Offaly,
Longford, Roscommon, Westmeath):
Roscommon County Council has
become the fifth member of the
Midlands Energy Agency (MEA). The
MEA local authorities, with the support
of SEAI, have formed a working group
to focus on pursuing Pathfinder Capital
Support.



### **Reimagining Local Authority Fleet**

The vision of this project is to develop a pathway for decarbonizing local authority fleet with a view to realizing emission reduction and energy efficiency targets. The sector has one



of the largest fleets with approx. 6,500 vehicles.

Stage one saw completion of a Fleet Survey and Fleet Manager Survey. Stage two is underway and will see the development of a more in-depth analysis document, with expected publication in early 2023. CARO are examining the development of a number of local authority case studies to support the solutions identified, including a HVO trial undertaken in Tipperary and Galway City; transition to EVs in Cork City and Dublin City; as well as fleet management and eco driver training undertaken in Donegal.



# Development of Local Authority Key Performance Indicators (KPI) on Climate Action

In light of the evolving policy context of climate action and increased ambition for the local government sector, the County and City Managers Association (CCMA) Climate Action and Transport Network (CATN) committee endorsed convening of a KPI working group to achieve specific objectives. This

working group, chaired by Paul
Kennedy of Dún-Laoghaire Rathdown
Council, will work with a number of
local authorities across the country,
with the intention to have KPIs decided
upon and tested to align with the
implementation stage of Local
Authority Climate Action Plans
(LACAPs).

# GAA / CCMA Green Clubs Programme:



Phase one of the Green Club
Programme is now complete with
toolkits almost finalised. Phase two will
commence at the beginning of 2023,
with applications for an additional 70
clubs anticipated.

The programme successfully secured €100,000 funding through Strand two of the Community Climate Action Fund. These funds will be used to develop an educational model to assist with the building of knowledge and capacity of Green Club Members and participating Clubs, and to deliver projects under the five thematic areas



of the programme. The Department of Environment, Climate and Communications (DECC) have also committed funding for phases two and three of the programme and will provide through 2023 and 2024.

# Kildare County Council Climate Action



### **Energy**

Sustainable Energy and Climate
Action Plan (SECAP)/Climate Action

The draft Local Authority Climate
Action Guidelines as endorsed by the
Climate Action and Transport
Networks (CATN) committee of the
CCMA on 15 September 2022 were
issued to local authorities. The
guidelines have been updated to
reflect the incorporation of
Decarbonisation Zones (DZ) as per
action 80 of the Climate Action Plan

2021. Together with the requirement under the Covenant of Mayors and Climate Action and Low Carbon Development (Amendment) Act Kildare County Council is preparing a five-year Sustainable Energy Climate Action Plan/Climate Action Plan (SECAP/CAP).

The Minister formally activated the programme as of the 24 February 2023 giving until the 23 February 2024 to finalise the plans plus one month for publication.

RPS are the consultants assigned to produce the SECAP/CAP. Our plan is unusual and complex as it encompasses not only the LA CAP including the DZ but also aligns with the LCP (An Taisce's Low Carbon Community national example) and the requirements of SECAP (Sustainable Energy Climate Action Plan). The overall LA CAP therefore will incorporate four elements to create one overriding document.

The SECAP section is largely completed. The scoping of actors, BEI, consultation with councillors (9 May) and the CA SPC (10 May) have been undertaken. The Climate Action Office is collaborating with the LECP, and the Community Wellbeing processes to

enable cross functional and coherent policy. A draft plan is to be undertaken during the summer with consultation expected to commence in September. The team are working towards adoption by Full Council in November/December 2023 to enable the plan to be launched on or by January 2024.



# Decarbonising Zone (DZ) – Maynooth Nominee

The Climate Action Office is streamlining consultation efforts with An Taisce who are developing a Low Carbon Community Plan for Maynooth (national example) under the Legacy 4 Life programme, Maynooth University, RPS Group (consultants) and various local actors. The Emissions Baseline Inventory (EBI) and a potential Carbon Calculator are being advanced. Consultation methods are advancing to enable citizen engagement with surveys to commence in April and physical events up to and including the

summer to encourage accessible interaction across the demographic spectrum.

The Climate Action Strategic Policy
Committee was made aware of
progress and updated during
December's meeting. The
Decarbonisation Zone actions plan will
also inform the Maynooth joint Local
Area Plan (LAP) Local Economic and
Community Plan (LECP) and other
policies.

The Climate Action Office is streamlining consultation efforts with An Taisce who are developing a Low Carbon Community Plan (LCP) for Maynooth (national example) under the Legacy 4 Life programme. The work is being undertaken in combination with Maynooth University, RPS Group (consultants) and various local actors. The Emissions Baseline Emissions Inventory (BEI) and a potential Carbon Calculator are being advanced. Master Students from the Business School, MU (Maynooth University) undertook surveys with business and agricultural stakeholders in Maynooth and their final report will be made available at the end of May.



During the month of May targeted consultation was undertaken with Agri/landowners, Business sector and community. We are working with Maynooth Community Council's on their Picnic in the Park fun event to be held on 18 June 2023 in Harbour Field. This is an opportunity to provide informal citizen engagement through the arts, including use of the Future Tapestries VR piece, the carbon calculator, and traditional stands to encourage accessible interaction across the demographic spectrum. It is expected the DZ Plan will be made available for adoption in July to inform the Maynooth LAP (Local Area Plan) being compiled presently.

Climate Action Energy Management
Team



A series of four workshops have been created for the team to inform the advancement of the CAP process. The

first was held on 23 March 2023 with the final session undertaken on 8 June 2023 in Solas Bhride. The drafting of the LA CAP actions continues and input from the Strategic Management Team (SMT) will be requested to inform the process further.

# Public Awareness of DZ and Climate Action

Maynooth Community Council in conjunction with the Climate Action Office are jointly organizing an event in Maynooth to increase awareness of climate action. The "Picnic in the Park" fun event will inform on consultation opportunities and build awareness around the decarbonizing Zone and Climate action at the personal and community levels.

**The Mid East Energy Unit** 



The three local authorities of Wicklow, Meath and Kildare County Councils



have come together to address their combined climate mitigation ambitions through the formation of the Mid East Energy Unit. Kildare County Council signed a Service Level Agreement (SLA) with the lead Local authority Wicklow County Council in December. The formation of the unit is to support the three Local Authorities to meet their 2030 energy efficiency and carbon emissions targets and show leadership and CODEMA will provide core services to the local authorities associated.

The unit will combine efforts to effect change utilising the SEAI's Pathfinder funding scheme to provide finance support for defined projects.

A Director's Order was signed in February to enable the use of Energy Elephant to commence data collection and analysis of all fuels used by the council from 1 March 2023.

#### **Climate Action SPC:**

At the SPC meeting on 8 February 2023. Two presentations were given. The first by CODEMA on the Mid East energy Unit and the National four Day Working Week Trial. The second presentation was by Kildare Chamber

on Business and Energy Efficiency in the Future.

At the SPC meeting on 10 May 2023. Two presentations were given. The first by Teagasc on the Signpost programme which is in keeping with a bespoke DZ for individual farms. This was followed by a presentation on the approved CA SPC workplan and an overview of the LA CAP and DZ. The next meeting is scheduled for 13 September 2023.

# Sustainable Energy Communities (SEC's)



Kildare County Council continues to make good progress on Sustainable Energy Communities (SEC) in the county. The number of SEC's continues to grow. There are currently 29 SEAI registered SEC's in county Kildare.



Further strengthening of the Energy
Master Plan (EMP) process has been
developed by SEAI, which now
includes greater structure and
guidelines to ensure quality
standardized Energy Master Plans
(EMP) are delivered. Kildare County
Council can now also utilize an EMP
delivery framework structure
established by CODEMA to streamline
the administration for all parties
involved.

Ballymore Eustace, Naas and Kilcock have agreements in place with Kildare County Council in 2022. Kilcock are finalized their Energy Master Plan and launched it on 3 April 2023. The SEC's of Monasterevin, Clane, Kilcullen and Maynooth are undertaking an activation program under the stewardship of the Energy Team, a social enterprise formed from Dunleer SEC, to advance building retrofits successfully under the SEAI retrofit fund. The initial expressions of interest received have been refined. Building assessments are underway to assess the works to be grant aided to inform a community application to SEAI to access grant funding. Should funding be awarded it will be used to

undertake energy upgrades in a

number of properties across the county under the Better Energy program.

The number of SECs (Sustainable Energy Communities) in the county continues to grow and there are currently 29 SEAI registered SEC's in County Kildare. Kilcock are nearing completion of their Energy Masterplan and Ballymore Eustace are progressing theirs.

The SEC's of Monasterevin, Clane, Kilcullen and Maynooth undertook an activation program under the stewardship of the Energy Team, a community enterprise formed from Dunleer SEC, to advance building retrofits successfully under the SEAI retrofit fund. Technical Assessments are well advanced and the application to the SEAI will advance when the appropriate funding round opens.

#### Fleet Electrification



The CCMA has recently published its Electric Vehicle (EV) Guidance Document for Local Authorities; this is



a welcome development which gives direction for Local Authorities as demand for public EV charging and fleet electrification grows. Kildare County Council's suitable small vehicle fleet can also be considered for electrification. The council currently have four EV vans in the fleet but there is growing interest in the electrification of other suitable vehicles in the fleet. Some Municipal District offices have also expressed interest installing electric vehicle charging points in their depots to facilitate EV charging. As fleet electrification starts to embed in Kildare County Council through infrastructural changes and greater awareness of Electric Vehicles's (EV) it will also be key to facilitate specific EV driving training for all drivers of fleet vehicles to ensure potential EV drivers are fully informed and upskilled in this area.

The Climate Action Office is also examining the potential to introduce a compressed natural gas heavy goods vehicle into Kildare County Council's fleet with mechanical services, while smaller vans have suitable options such as electrification; the larger trucks are an issue. One solution to this is a

compressed natural gas vehicle.

Presently the installation of a pumping station at the New Hall Depot is being planned.

Gnáthóga Nádúrtha (Natural Habitats) - new initiative as part of the Arts Council's Invitation to Collaboration scheme €75,000 has been awarded under the Creative Ireland's Climate Action: Invitation to Collaborate fund an application, led by Carlow County Council, in conjunction with Kildare and Meath County Councils. Gnáthóga Nádúrtha will be an ambitious arts led inquiry, an interdisciplinary, collaborative intervention, sited across three natural heritage peatland habitats in Carlow, Kildare and Meath that brings the urgency of climate action to the



forefront. The focus of this initiative is on Climate Action and place-based practice in these rich natural heritage sites across three counties, including Rathangan in Kildare.

Site visits with though provoking interactive are being conducted on the various bogs during December,
January and February to inform then project.

#### Other Initiatives

### 'Stitching the Community Together'

The Climate Action Office, Community and Libraries section were successful in attaining just over €30,000 in funding from Creative Ireland for the project 'Stitching the Community Together'. The project is based on intergenerational art project centered around the medium of wool and knitting and will include three elements to the project: intergenerational workshop on wool and knitting between nursing homes and schools, virtual reality (VR) educational piece to explore the 'Farm-to-Fleece' process of wool co-created with students and an exhibition phase showcasing the work. The work with schools and nursing homes has concluded. We are working closely with the virtual reality

artist to deliver the co-creation piece.
The associate exhibition called 'Future Tapestry' took place on the 25 May to 27 May 2023 in McAuley place including exhibit and VR experience. It was also used as an opportunity to launch the Age-Friendly strategy.

# Gas Innovation Fund and Public Service Innovation Fund



The Climate Action Office applied to the Gas Network Ireland's Gas Innovation Fund in conjunction with Maynooth University's Terrain-Ai research group and Teagasc. This project aims to assess the potential for green spaces to generate biomass e.g., grass-clippings as a feedstock for energy generation in Kildare with potential of scaling the study up to different county councils and state bodies nationwide. If successful the main body of work will be carried out by a postdoctoral researcher with project support from the Climate Action Office, Maynooth University and engagement with Teagasc.





To advance the project financially an application was made to the Public Service Innovation Fund 2023. To our delight the bid has been successful and funding of €50,000 (€60,000 requested) is to be awarded on signing of Memorandum of Agreement (MOA) in March. The funding will be used to enable a researcher(s) to commence the works associated. An agreement is now being formulated with Maynooth University to enable the research to commence at pace. It is expected that the project will be completed by Quarter two/three of 2024.

Kildare Creative Ireland Bursary

Award



The Climate Action Office supported a local artist and community organisation with a successful application to the Kildare Creative Ireland Bursary Award. The project called 'We Hold the Power' involves creating a collaborative community mosaic art piece with the Allenwood Community Development Association community groups and the artist Marta Golubowska. The mosaic will reflect the imagery of the community centre's history, ecology, and heritage which was originally a former ESB peat power station. The project work has concluded with the adults in the area and work with children from Allenwood and Roberstown National Schools is to commence after midterm break in February. The piece will be put in place as part of the Allenwood playground project.

# Climate Innovation Fund – First Round

Early last year, the Climate Action
Office launched its Climate Innovation
Fund and in June 2022 three
applicants were successfully awarded
funding. The projects that were
awarded are as follows:





# Maynooth Sustainable Energy Community

A community climate app to nudge hyper local sustainable community behaviours through gamification and reward.

#### **The Climate Hub**

A project that aims to capture data on traffic types and speeds data that will be used to co-develop active-travel related initiatives/nudging behaviour with the community.

#### **Climate Response Ireland**

A project that will develop real time information technology on indoor air quality in residents' homes, highlighting the damage pollution can cause in the home.

The Climate Innovation Fund is reissuing a second call for projects for Athy, Kildare-Newbridge, Naas and Clane-Maynooth.



# Climate Innovation Fund (CIF) – Second Round

Despite many potential projects being developed none met the criteria set. The fund is still at embedding stage and will be further examined with a view of developing the research and developed potential with other stakeholders.

CIF for 2023 is scheduled to be launched later this summer.

# Alternative Fuels for Plant and Machinery

The use of Compressed Natural Gas (CNG) powered vehicles is seen as a viable option for larger machinery e.g., Vans, trucks, tractors etc. while transitioning to a carbon neutral economy. Indigenous produced biogas could be a viable business model given the initial results from the Grass to Gas experiments. In February, Stephen Nolan of Green Generation gave presentations hosted generously by the Continuing Professional Development (CPD) team. The

presentations informed on the anaerobic digestion process, advantages and opportunities for climate action and circular economy. The mechanical section in conjunction with the development of the new depot at New Hall by Roads Transportation and Public Safety Department has finalised an agreement to install a higher-grade gas pipeline to supply a fueling point to incorporate biogas into the fleet.



#### Research

### **Alternatives to Herbicides Project**

The Parks/Climate Action Office's project including scientific research together with practical assessment in the field (Kildare County Council Parks Department and National University of Ireland, Maynooth) is designed to produce a practical maintenance guide for public open spaces.

Ten Local Authorities have partnered together with Waterways Ireland.

Green Clubs have expressed their willingness to join in the near future.





Ms. Sophia Couchman, Masters
Student, together with Dr James
Carolan Maynooth University, Teagasc
and Kildare County Council have
undertaken the scientific experiments
in Kinsealy, County Dublin (Teagasc
lands) along with practical experiments
on Millennium Link Road, Naas while
Eire Landscapes continue practical
experiments on roundabouts in the
Naas town area.

The research report and practical guidance are due to be completed in the coming weeks.
