Reader Services – Right to Read Activities

Spring into Storytime

Spring into Storytime is a national story-time initiative in public libraries which runs during the month of April. It celebrates the importance of families reading together and sharing stories. Kildare Libraries held 51 events around the county. Over 1,495 participants attended these events this April.

Irish Sign Language (ISL)

Classes for families were fully subscribed in April and there is great interest in the monthly conversation



meet-up for ISL users/learners to sustain and practice their skills. Chime, the National Charity for Deafness and Hearing Loss are interested in facilitating these conversation group meetings on a fortnightly basis going forward. This connection also opens the possibility of accessing 'signing' at some of our main library events, which would give access to a very marginalised group in our society.

The Irish Deaf Society held a second full-day workshop in the library for deaf parents and parents of deaf children. They are a very positive link in the support we are trying to provide to our borrowers.

RehabCare Reading Group

continues their Book Club meetings following their relocation to Kildare Town Centre. We have service users from the RehabCare Centre coming in daily to borrow books and read. Two of the RehabCare users are now on work experience with us and we are delighted to be able to provide meaningful tasks and challenges for them.

EmployAbility Services

We are delighted to welcome
EmployAbility Services back to the
library every Friday following their

withdrawal due to the pandemic. They have already established a connect with RehabCare (newly situated beside the library) and will assist with getting meaningful employment for their users.

Interagency Collaboration re International Protection applicants and Celbridge Manor Hotel

A funding application has gone in from Kildare Children and Young People Services Committee (CYPSC) to the DCEDIY (Department of Children, Equality, Disability, Integration and Youth) re Enhancing supports for Children and Young People in the International Protection System. Kildare County Council are one of the partners organisations listed and the library service has offered support for potential after-school, out of school and summer activities for the children there.

The fund is intended to support children, young people and their parents living in Direct Provision Centres.

Celbridge Library will be present at a Meet and Greet in the Celbridge Manor on 26 May 2023, offering information and support along with other organisations including the Kildare County Childcare Committee,





Kildare LEADER, and the HSE (public health nurses and GP). It is hoped that the residents might come on board also with the Kildare libraries 'Seed library' initiative and grow vegetables in a communal garden area there.



Housing and Regeneration Housing

Summary of Social Housing Assessments

The Summary of Social Housing
Assessments 2022 (SSHA) was
recently published. The purpose of the
SSHA is to count the total number of
households qualified for social housing
support across the country whose
social housing need is not being met.
The count date was 1 November 2022.
The SSHA does not include
households availing of the Housing
Assistance Payment (HAP). Nationally,
the total number of qualified

households in SSHA 2022 was 57,842, a reduction of 2.4% when compared to SSHA 2021. Following are the some of the key statistics for Kildare:

- SSHA 2022 counted 3,008
 households, this is an increase
 of 71 households (2.4%)
 compared to SSHA 2021.
- Kildare has the fifth highest number of qualified households, behind Dublin City Council,
 Fingal County Council, South Dublin County Council and Cork City Council.
- 41.8% of applicants are aged between 30-49, 13.5% of applicants are aged 60 and over.
- The three largest household types are one adult (53%), one adult plus one to two children (20%), couple plus one to two children (9.3%).
- 9.2% of households have a person with physical, sensory,





- mental or intellectual impairment.
- The length of time on the list is as follows: 0-3 years (39%), 0-5 years (63%), over five years (37%).

Homeless Services

Homeless Outreach

Street work was completed in Newbridge, Sallins, Kildare Town and Celbridge. We had one new participant move into a housing first property in April. Outreach attended clinics in Newbridge Family Resource Centre, Cuan Mhuire and Ballymakealy Community Centre, Celbridge. Meetings were held in Kerdiffstown House and Jigginstown with participants and management on exits out of emergency accommodation. Outreach attended meetings with hospitals and prisons on discharges into homeless.

Presentations

During the month of April,
presentations were slightly up from
March, this includes repeat
presentations.
Six families exited emergency
accommodation in April, one into an

Approved Housing Body (AHB) allocation, two into Local Authority allocation, one returned to family and friends due to non-bed usage and two moved into HAP properties.

Seven families, including two couples, went into emergency accommodation in April, four were for Notice to Quits, one exited a refuge and two due to family circumstances.

Tenancy Sustainment

At present we have 83 active tenancy sustainment families.

For the month of April there were 18 visits to clients where issues such as rent compliance, Family Support Worker referrals, budgeting, social welfare assistance were worked through resulting in preventing two tenancies from breaking down.

Families have also been set up on household budgets and MABS support. Support work carried out for an allocation for a client in a Family Hub and follow up meeting attended with AHB.






Homeless HAP (HHAP)

HHAP received five applications in April; with 21 applications in total for 2023 to the end of April. In comparison, to the end of April 2022 there were 16 applications in total.

Housing Allocations

In April 2023, the council allocated a total of 99 properties throughout the county. 29 were social properties and 70 were AHB properties. Among the locations where allocations took place were Celbridge, Straffan, Robertstown, Newbridge, Athy and Naas.

In order to address the number of refusals of offers of an allocation, the use of Choice Based Letting (CBL) has been increased and 17 properties were advertised on CBL during April in various locations including Ballymore Eustace, Kill, Derrinturn and Clane.

The first-ever Kildare "Rubbish Film Festival" for Transition Year Students in Secondary Schools was held on a pilot basis this year with entries from five participating schools across the County, and it was a resounding success.



The festival, which challenged students to create a one-minute short film on the theme of reducing waste and encouraging sustainability, was

facilitated by Createschool and supported by Kildare County Council. The festival received a great response from the schools, with students showing their creativity and innovation in producing ten short films that were both educational and entertaining. Two films and a poster design were selected as the winners in their respective categories and will go forward to represent County Kildare at the National Awards in Meath in May 2023.

The organisers hope that the festival will become an annual event that will help to raise awareness about environmental issues among young people and inspire them to take action to protect the planet.

Community Clean-ups

Green Kilometre groups continue to be very active. There is also continued demand from community and Tidy Towns groups for supplies to aid with clean-ups and litter picking around the county. Residents Associations who express interest in installing compost areas for green waste on their estates will also receive council support.

Since its launch in January 2021, the rollout of the Raising Awareness online programme has seen a total of 17,531 staff at grades seven, six, five, four, three (and equivalent technical grades) enrolled on the programme, with a total of 13,561 (78%) having completed the programme. The programme has now been substantially updated, with a much greater emphasis on the use of short videos to aid in the learning process. This new version is being rolled out by all Local Authority training

Thematic Training

Training under this pillar responds to identified training needs of specific local authority groupings. Other training courses under this pillar are at various stages of design and progression towards delivery, including training aimed at/focusing on the Older Persons Council, Economic/Enterprise Opportunities and Roads Infrastructure.



Outdoor Staff

This training focuses on outdoor staff in local authorities, with trainers working on behalf of the Local



Authority Services National Training Group and commenced in January 2023.



Frontline Staff

This training is targeting staff of local authorities who are front line or community-facing and will be delivered in person by the Institute of Public Administration (IPA) and Local Authority Services National Training Group (LASNTG), who will coordinate with training officers in local authorities to make registration arrangements.

The programme was piloted in March 2022 and rolled out across the CARO regions over the year, before opening to all local authorities in October / November.

Economic Opportunities Conference 2023

A very successful Economic
Opportunities conference was held in
Tullamore on the 26 April 2023. With
over 140 in attendance, the
conference looked at how businesses

are capitalising on new opportunities and becoming green pioneers.

Local Authority Climate Action Plans (LA CAP)

The Minister has approved a business case for local authority climate action resources in respect of two roles. A letter of comfort has been issued by the Department of the Environment, Climate and Communications (DECC), relating to the recruitment of these resources on a five-year term for the purposes of developing and implementing the LA CAP as aligned with the provisions of the business case.

The Climate Action Plan 2023 was published by the Minister on the 21 December 2022 with the Annex of Actions published in March 2023. To support local authorities, CARO have established three national frameworks of consultants for county wide BEIs (Baseline Emission

Inventories), Climate Change Risk
Assessments as well as BEIs for
Decarbonising Zones (DZs) and
planning and implementation activities
linked to Climate Action Plans or
commitments under the Local
Authority Climate Action Charter.
The development of a framework for
the provision of services for Strategic
Environmental Assessment and
Appropriate Assessment screening is
also being finalised.

On the 24 February 2023, the Minister issued instructions to all Local Authorities to commence the process of preparing the Local Authority Climate Action Plan (LACAP).

Local Authority Progress Reporting - Climate Adaptation Strategies:

Annual reporting on progress of the implementation of Local Authority

Climate Adaptation Strategies / Plans

has been undertaken by all Climate Action Officers/Leads in all local authorities. A sectoral report is being collated by CARO for submission to the Department.



Sub-Regional Energy Projects

The CARO are working with local authorities in each of the four sub-regions to develop regional energy bureaus or regional energy efficiency projects.

In the Mid-East, the three local authorities involved (Kildare, Meath, Wicklow) with the assistance of CARO, are in the process of finalising a contract with Codema to provide an energy service for local authorities in this sub-region.

In the Border sub-region (Cavan, Monaghan, Leitrim): A tender for a public building energy efficiency report resulted in Codex Energy being appointed. Their final report identifies 18 buildings with a project pipeline of

over 100 potential projects for each building to attain a B2 rating.
In the Southeast (Kilkenny, Carlow, Wexford, Waterford, Tipperary): The four Directors of Carlow, Waterford, Wexford and Kilkenny, have instructed the South East Energy Agency (formerly 3CEA) to pursue Pathfinder Support.

In the Midlands (Laois, Offaly,
Longford, Roscommon, Westmeath):
Roscommon County Council has
become the fifth member of the
Midlands Energy Agency (MEA). The
MEA local authorities, with the support
of SEAI, have formed a working group
to focus on pursuing Pathfinder Capital
Support.



Reimagining Local Authority Fleet

The vision of this project is to develop a pathway for decarbonizing local authority fleet with a view to realizing emission reduction and energy efficiency targets. The sector has one of the largest fleets with approx. 6,500 vehicles.

Stage one saw completion of a Fleet Survey and Fleet Manager Survey. Stage two is underway and will see the development of a more in-depth analysis document, with expected publication in early 2023. CARO are examining the development of a number of local authority case studies to support the solutions identified, including a HVO trial undertaken in Tipperary and Galway City; transition to EVs in Cork City and Dublin City; as well as fleet management and eco driver training undertaken in Donegal.



Development of Local Authority Key Performance Indicators on Climate Action

In light of the evolving policy context of climate action and increased ambition for the local government sector, the County and City Managers Association (CCMA) Climate Action and Transport Network (CATN) committee endorsed convening of a KPI working group to achieve specific objectives. This working group, chaired by Paul Kennedy of Dún-Laoghaire Rathdown



Council, will work with a number of local authorities across the country, with the intention to have KPIs decided upon and tested to align with the implementation stage of Local Authority Climate Action Plans (LACAPs).

GAA / CCMA Green Clubs Programme:



Phase one of the Green Club
Programme is now complete with
toolkits almost finalised. Phase two will
commence at the beginning of 2023,
with applications for an additional 70
clubs anticipated.

The programme successfully secured €100,000 funding through Strand two of the Community Climate Action Fund. These funds will be used to develop an educational model to assist with the building of knowledge and capacity of Green Club Members and participating Clubs, to deliver projects under the five thematic areas of the programme. The Department of

Environment, Climate and Communications (DECC) have also committed funding for phases two and three of the programme and will provide through 2023 and 2024.

The draft Local Authority Climate

guidelines have been updated to
reflect the incorporation of
Decarbonisation Zones (DZ) as per
action 80 of the Climate Action Plan



2021. Together with the requirement under the Covenant of Mayors and Climate Action and Low Carbon Development (Amendment) Act Kildare County Council is preparing a five-year Sustainable Energy Climate Action Plan/Climate Action Plan (SECAP/CAP).

The Minister formally activated the programme as of the 24 February 2023 giving until the 23 February 2024 to finalise the plans plus one month for publication. Given the availability of the published guidance RPS group are reviewing the elements undertaken to date and assessing the path forward to undertaking the SECAP/CAP and DZ plans. Currently the project is at the scoping of the actor's stage.

The Senior Management team and associated senior staff members undertook an interactive session on the Vision for Kildare by 2050 and potential actions to advance decarbonizing of the council's services and functions in January. Information was also given on how to commence decarbonizing the work of the various sections. RPS are the consultants assigned to produce the SECAP/CAP. Our plan is unusual and complex as it encompasses not only the LA CAP

including the DZ but also aligns with the LCP (An Taisce's Low Carbon Community national example) and the requirements of SECAP (Sustainable Energy Climate Action Plan). The overall LA CAP therefore will incorporate four elements to create one overriding document.

The SECAP section is largely completed. The scoping of actors, BEI, consultation with councillors (9 May) and the CA SPC (10 May) have been undertaken. The Climate Action Office is collaborating with the LECP, and the Community Wellbeing processes to enable cross functional and coherent policy. A draft plan is to be undertaken during the summer with consultation expected to commence in September. The team are working towards adoption by Full Council in November/December 2023 to enable the plan to be launched on or by January 2024.





Decarbonising Zone (DZ) – Maynooth Nominee

The Climate Action Office is streamlining consultation efforts with An Taisce who are developing a Low Carbon Community Plan for Maynooth (national example) under the Legacy 4 Life programme, Maynooth University, RPS Group (consultants) and various local actors. The Emissions Baseline Inventory (EBI) and a potential Carbon Calculator are being advanced. Consultation methods are advancing to enable citizen engagement with surveys to commence in April and physical events up to and including the summer to encourage accessible interaction across the demographic spectrum.

The Climate Action Strategic Policy
Committee was made aware of
progress and updated during
December's meeting. The
Decarbonisation Zone actions plan will
also inform the Maynooth joint Local
Area Plan (LAP) Local Economic and
Community Plan (LECP) and other
policies.

The Climate Action Office is streamlining consultation efforts with An Taisce who are developing a Low Carbon Community Plan (LCP) for Maynooth (national example) under the Legacy 4 Life programme. The work is being undertaken in combination with Maynooth University, RPS Group (consultants) and various local actors. The Emissions Baseline Emissions Inventory (BEI) and a potential Carbon Calculator are being advanced. Master Students from the Business School, MU (Maynooth University) undertook surveys with business and agricultural stakeholders in Maynooth and their final report will be made available at the end of May. On 4 May 2023 targeted consultation with the agri/land use sector was undertaken, with business sector scheduled for 17 May and rest of society on 24 May 2023. We are working with Maynooth Community Council's on their Picnic in the Park fun event to be held on 18 June 2023 in Harbour Field. This is an opportunity to provide informal citizen engagement through the arts and traditional stands to encourage accessible interaction across the demographic spectrum. It is expected the DZ Plan will be made available for adoption in July to inform the Maynooth LAP (Local Area Plan) being compiled presently.



Climate Action Energy Management Team



The Climate Action and Energy Management Team met on 23 March 2023 in Solas Bhride, Kildare town to undertake the first of four workshops to inform the formulation of Kildare's Climate Action Plan. The workshop was facilitated by CARO. The members of the Climate Action Team and Energy Management Team undertook a review of the adaptation measures under the existing strategy and brainstormed on the potential mitigation measures. Three further workshops will be undertaken over the next two months to advance the process.

A series of four workshops have been created for the Climate Action and Energy Management Team to inform the advancement of the LA CAP process. The first was held on 23 March 2023 with the final session will being held on 18 May 2023 in Solas

Bhride. The workshops are being facilitated by our consultants RPS.

Public Awareness of DZ and Climate Action

Maynooth Community Council in conjunction with the Climate Action Office are jointly organizing an event in Maynooth to increase awareness of climate action. The "Picnic in the park" fun event will inform on consultation opportunities and build awareness around the decarbonizing Zone and Climate action at the personal and community levels.

The Mid East Energy Unit



The three local authorities of Wicklow, Meath and Kildare County Councils have come together to address their combined climate mitigation ambitions through the formation of the Mid East Energy Unit. Kildare County Council signed a Service Level Agreement (SLA) with the lead Local authority Wicklow County Council in December.



The formation of the unit is to support the three Local Authorities to meet their 2030 energy efficiency and carbon emissions targets and show leadership and CODEMA will provide core services to the local authorities associated.

The unit will combine efforts to effect change utilising the SEAI's Pathfinder funding scheme to provide finance support for defined projects.

A Director's Order was signed in February to enable the use of Energy Elephant to commence data collection and analysis of all fuels used by the council from 1 March 2023.

Climate Action SPC:

The latest scheduled meeting took place on 8 February 2023. Two presentations were given. The first by CODEMA on the Mid East energy Unit and the National four Day Working Week Trial. The second presentation was by Kildare Chamber on Business and Energy Efficiency in the Future. The next meeting is scheduled for 10 May 2023.

Sustainable Energy Communities (SEC's)



Kildare County Council continues to make good progress on Sustainable Energy Communities (SEC) in the county. The number of SEC's continues to grow. There are currently 29 SEAI registered SEC's in county Kildare.

Further strengthening of the Energy
Master Plan (EMP) process has been
developed by SEAI, which now
includes greater structure and
guidelines to ensure quality
standardized Energy Master Plans
(EMP) are delivered. Kildare County
Council can now also utilize an EMP
delivery framework structure
established by CODEMA to streamline
the administration for all parties
involved.

Ballymore Eustace, Naas and Kilcock have agreements in place with Kildare County Council in 2022. Kilcock are finalizing their Energy Master Plan and propose to launch it on 3 April 2023. The SEC's of Monasterevin, Clane, Kilcullen and Maynooth are



undertaking an activation program under the stewardship of the Energy Team, a social enterprise formed from Dunleer SEC, to advance building retrofits successfully under the SEAI retrofit fund. The initial expressions of interest received have been refined. Building assessments are underway to assess the works to be grant aided to inform a community application to SEAI to access grant funding. Should funding be awarded it will be used to undertake energy upgrades in a number of properties across the county under the Better Energy program.

The number of SECs (Sustainable Energy Communities) in the county continues to grow and there are currently 29 SEAI registered SEC's in County Kildare. Kilcock are nearing completion of their Energy Masterplan and Ballymore Eustace are progressing theirs.

The SEC's of Monasterevin, Clane, Kilcullen and Maynooth undertook an activation program under the stewardship of the Energy Team, a community enterprise formed from Dunleer SEC, to advance building retrofits successfully under the SEAI retrofit fund. Technical Assessments

are well advanced and the application to the SEAI will advance when the appropriate funding round opens.

Fleet Electrification



The CCMA has recently published its Electric Vehicle (EV) Guidance Document for Local Authorities; this is a welcome development which gives direction for Local Authorities as demand for public EV charging and fleet electrification grows. Kildare County Council's suitable small vehicle fleet can also be considered for electrification. The council currently have four EV vans in the fleet but there is growing interest in the electrification of other suitable vehicles in the fleet. Some Municipal District offices have also expressed interest installing electric vehicle charging points in their depots to facilitate EV charging. As fleet electrification starts to embed in Kildare County Council through infrastructural changes and greater awareness of EV's it will also be key to facilitate specific EV driving training for all drivers of fleet vehicles to ensure



potential EV drivers are fully informed and upskilled in this area.

The Climate Action Office is also examining the potential to introduce a compressed natural gas heavy goods vehicle into Kildare County Council's fleet with mechanical services, while smaller vans have suitable options such as electrification; the larger trucks are an issue. One solution to this is a compressed natural gas vehicle.

Presently the installation of a pumping station at the New Hall Depot is being planned.

ICT Solutions



An opportunity to collaborate with Eir Evo https://www.eirevo.ie/ to advance ICT solutions was acted upon and the inaugural sprint is now completed. The initial contact was made via our IT Department.

The work included the development of an app linking plant passport statutory recording and tree surveys (Parks Department has usage) together with the potential for the creation of a dashboard.

The potential to gamify the Carbon Calculator associated with Maynooth DZ has been discussed given the national potential community usage. An introduction has been made between An Taisce and Eir Evo to advance the option.

Advancement is dependent on funding allocations with Eir Evo seeking further assistance.

The programme is funded by Microsoft.

Visualisation and gamification of the Carbon Calculator being developed by An Taisce and Kildare County Council for Maynooth DZ/Low Carbon Community is being considered through potential partnership with Terrain Ai in MU or Eir Evo. It is hoped we can showcase the prototype application at the Picnic in the Park on 18 June 2023 in Harbour Field, Maynooth.

Gnáthóga Nádúrtha (Natural Habitats)

€75,000 has been awarded under the Creative Ireland's Climate Action:
Invitation to Collaborate fund an application, led by Carlow County
Council, in conjunction with Kildare and Meath County
Councils. Gnáthóga Nádúrtha will be an ambitious arts led inquiry, an interdisciplinary, collaborative

interdisciplinary, collaborative intervention, sited across three natural heritage peatland habitats in Carlow, Kildare and Meath that brings the urgency of climate action to the forefront. The focus of this initiative is on Climate Action and place-based practice in these rich natural heritage sites across three counties, including Rathangan in Kildare.

Site visits with though provoking interactive are being conducted on the various bogs during December,
January and February to inform then project.

Other Initiatives

'Stitching the Community Together' The Climate Action Office, Community and Libraries section were successful in attaining just over €30,000 in funding from Creative Ireland for the project 'Stitching the Community Together'. The project is based on intergenerational art project centered around the medium of wool and knitting and will include three elements to the project: intergenerational workshop on wool and knitting between nursing homes and schools, virtual reality (VR) educational piece to explore the 'Farm-to-Fleece' process of wool co-created with students and an exhibition phase showcasing the work. The work with schools and nursing homes has concluded. We are working closely with the virtual reality artist to deliver the co-creation piece. The associate exhibition called 'Future Tapestry' will take place on the 25 May to 27 May 2023 in McAuley place including exhibit and VR experience. The launch will be on the 25 May 2023 and the opportunity will also be used to launch the Age-Friendly strategy.



Gas Innovation Fund and Public Service Innovation Fund



The Climate Action Office applied to the Gas Network Ireland's Gas Innovation Fund in conjunction with Maynooth University's Terrain-Ai research group and Teagasc. This project aims to assess the potential for green spaces to generate biomass e.g., grass-clippings as a feedstock for energy generation in Kildare with potential of scaling the study up to different county councils and state bodies nationwide. If successful the main body of work will be carried out by a postdoctoral researcher with project support from the Climate Action Office, Maynooth University and engagement with Teagasc.



To advance the project financially an application was made to the Public Service Innovation Fund 2023. To our delight the bid has been successful and funding of €50,000 (€60,000 requested) is to be awarded on signing of Memorandum of Agreement (MOA)

in March. The funding will be used to enable a researcher(s) to commence the works associated. An agreement is now being formulated with Maynooth University to enable the research to commence at pace. It is expected that the project will be completed by Quarter two/three of 2024.

Kildare Creative Ireland Bursary Award



The Climate Action Office supported a local artist and community organisation with a successful application to the Kildare Creative Ireland Bursary Award. The project called 'We Hold the Power' involves creating a collaborative community mosaic art piece with the Allenwood Community Development Association community groups and the artist Marta Golubowska. The mosaic will reflect the imagery of the community centre's



history, ecology, and heritage which was originally a former ESB peat power station. The project work has concluded with the adults in the area and work with children from Allenwood and Roberstown National Schools is to commence after midterm break in February. The piece will be put in place as part of the Allenwood playground project.

Climate Innovation Fund – First Round

Early last year, the Climate Action
Office launched its Climate Innovation
Fund and in June 2022 three
applicants were successfully awarded
funding. The projects that were
awarded are as follows:

Maynooth Sustainable Energy Community

A community climate app to nudge hyper local sustainable community behaviours through gamification and reward.

The Climate Hub

A project that aims to capture data on traffic types and speeds data that will be used to co-develop active-travel

related initiatives/nudging behaviour with the community.

Climate Response Ireland

A project that will develop real time information technology on indoor air quality in residents' homes, highlighting the damage pollution can cause in the home.

The Climate Innovation Fund is reissuing a second call for projects for Athy, Kildare-Newbridge, Naas and Clane-Maynooth.



Climate Innovation Fund – Second Round

Despite many potential projects being developed none met the criteria set. The fund is still at embedding stage and will be further examined with a view of developing the research and developed potential with other stakeholders.



Forestry

The finalised document 'Woodland Creation on Public Lands Scheme' was released on 28 May 2021.

The project is being advanced by a subgroup of the CAT called, Coillteach Chill Dara. The templates for tendering have been finalised and are available to utilize.

Dara Wyer, Environment Awareness
Officer is looking at other avenues
such as self-regeneration of land
locked sites in particular as a means to
increase forestry naturally while
awaiting further information from
various functional areas.

Alternative Fuels for Plant and Machinery

The use of Compressed Natural Gas (CNG) powered vehicles is seen as a viable option for larger machinery e.g., Vans, trucks, tractors etc. while transitioning to a carbon neutral economy. Indigenous produced biogas could be a viable business model given the initial results from the Grass to Gas experiments. In February, Stephen Nolan of Green Generation gave presentations hosted generously by the Continuing Professional Development (CPD) team. The presentations informed on the



anaerobic digestion process, advantages and opportunities for climate action and circular economy. The mechanical section in conjunction with the development of the new depot at New Hall by Roads Transportation and Public Safety Department has finalised an agreement to install a higher-grade gas pipeline to supply a fueling point to incorporate biogas into the fleet.

Agreement for the installation of natural gas pipeline and apparatus in respect of industrial and commercial connection(s)

Research

Alternatives to Herbicides Project
The Parks/Climate Action Office's
project including scientific research
together with practical assessment in
the field (Kildare County Council Parks
Department and National University of
Ireland, Maynooth) is designed to
produce a practical maintenance guide
for public open spaces.

Ten Local Authorities have partnered together with Waterways Ireland.
Green Clubs have expressed their willingness to join in the near future.
Ms. Sophia Couchman, Masters
Student, together with Dr James
Carolan Maynooth University, Teagasc

and Kildare County Council have undertaken the scientific experiments in Kinsealy, County Dublin (Teagasc lands) along with practical experiments on Millennium Link Road, Naas while Eire Landscapes continue practical experiments on roundabouts in the Naas town area. Sophia is currently compiling the data from the various experiments to formulate the report due in late spring or early summer of 2023. A presentation was given in late October to Teagasc student's on the initial Entomology qualitative data. Each Municipal District received a presentation in March on the progress to date.

Community Stories continues to roll out updates.

The results of our monthly Parks Pilot posts on Kildare Community Stories are set out below with one of the videos being the most viewed on Community Stories during 2022. Kildare County Council's research project - alternatives for pesticides - continues with the help of our collaborating partners, Maynooth University, Trinity College Dublin, National Biodiversity Data Centre and Teagasc. Sophia Couchman is





finalising her data report and will commence the practical guide for the maintenance of open spaces using alternatives to pesticides in late May. Analysis of soil biomes continues. Sophia has agreed to advance to PhD level in the Autumn and it is expected she will have the work completed Quarter one/two of 2025. It is with thanks to our Local Authority partners together with Waterways Ireland and the GAA we can continue to fund this valuable research to enable change on the ground.

Community Stories continue to assist with communicating to their audience

aspects of the research and related items.

Transport, Mobility and Open Spaces

Roads, Transportation and Public Safety May 2023 M4 Maynooth to Leixlip

The aim of the project is to assess the needs of the M4/N4 mainline corridor and junctions from Maynooth to
Junction 5 Leixlip in terms of catering for future demand from a capacity, safety and operational perspective.
The scheme is moving through the various steps required for Phase one (Concept and Feasibility), Phase two (Option Selection), Phase three (Design and Environmental Evaluation) and Phase four (Statutory Processes), provided it successfully progresses through each phase.
Plan for the new few months is

- Completion of Stage two Multi-Criteria Analysis.
- Completion of public consultation on Emerging Preferred Option.
- Completion of the Option
 Selection Report.
- Completion of all TII Project
 Management Guidelines Phase
 two deliverables and completion
 of Phase two (Option Selection).
 It is proposed to prepare a staging
 paper/phasing of the delivery of the
 preferred option.

M4 Eastbound Bus Priority Measures

The Part 8 for the M4 Eastbound Bus Priority Measures was presented at the February 2023 Council meeting and was approved. KNRO are now preparing contract documents for Phase five (Enabling and Procurement).

Athy Main Street (N78)






Kildare Fáilte Key Activities





Economic Support Services Retail Support Scheme 2023 now open.

Kildare County Council launched a range of financial supports for retailers to avail of in 2023. The scheme includes the annual Shop Front Improvement Scheme to financially assist business owners to improve the appearance of their shop fronts or commercial properties. The scheme, which supported over 60 businesses in Kildare last year, aims to increase visibility for businesses and enhance



the streetscapes of towns and villages around the county.

The scheme provides for up to 50% of the cost of shop front refurbishment, depending on the work proposed, with a maximum allowable contribution of €5,000 per applicant. The scheme also incentivises applicants to incorporate accessibility and age-friendly improvements to their shopfront with up to 75% of eligible costs covered under this measure.

The Retail Window Merchandising
Scheme is available for interior window decoration and design of a shop with funding of 80% to a maximum of €500.
This scheme is eligible for applications from businesses year on year to keep a modern, attractive window display.
The economic development team have also been visiting retailers across the county providing them with information on supports available.

To date, **13 businesses** have been awarded funding to support their shopfront improvements. The closing date for applications is Friday 30 June 2023.



Athy Streetscape Enhancement Scheme 2022-2023

Under this scheme, retailers, property owners and local groups can apply for grants that they can use to improve the facades of their buildings, carry out artwork or install features such as street furniture or canopies in Athy. The economic development team have been working with the project team and supporting prospective applicants with the application process and the scheme remains open for applications until 30 June 2023. All works are required to be completed by 31 August 2023.

Athy Food, Drink and Skills Innovation Hub

The team have engaged with the Department of Rural and provided updated costings for the project and





are awaiting correspondence from the Department regarding the contract stage that will allow the project to commence the tendering process for construction

Kildare County Council appointed a consultancy team to undertake a feasibility study of the Old Kildare Town Courthouse; it is proposed that a dedicated Craft, Creativity and Design Hub will be built to act as a sectoral stimulus to develop a hub of enterprise, innovation, commercialisation, and learning. The team met with the consultants on site and a site survey and key stakeholder engagement is taking place during May.

Kildare Fashion and Textiles Hub

Consultants have been appointed to undertake a feasibility study for a dedicated fashion and textiles hub to be located in Monasterevin. The former Bank of Ireland and surrounding sites will be assessed while the consultants will also engage stakeholders to quantify needs and demand in advance of any future funding application. The project

initiation meeting with the consultants is taking place in May.

Kilcock Enterprise Park Feasibility Study

The appointed consultants are currently undertaking a technical examination of the site and have engaged with some of the key stakeholders. A draft report is due by the end of June and a final report is expected to be presented to the economic development team by the end of July.

Diaspora Strategy

A Diaspora Coordinator has been appointed to assist in the delivery of Kildare's Diaspora Strategy. The project initiation meeting on targets and delivery has taken place and one of the first tasks of the co-ordinator is to identify the diaspora and build a database through a communications strategy. A dedicated page and link will be hosted on the Brigid 1500 website to receive information on the Kildare diaspora.

Hub Activity

MERITS content creation lab:

The content creation lab in MERITS is fully operational and is supporting





businesses to create professional product photography, videography and podcast episodes.





MERITS industry partnership:

MERITS has recommenced it's industry partnership with Grant Thornton which will support businesses in the MERITS community with specialist advice and guidance.

National Equine Innovation Centre (NEIC) collaboration:

The National Equine Innovation Centre based in the Irish National Stud will collaborate with Thoroughbred Country to support the development of equine businesses.

Hubs occupancy:

MERITS welcomed three new tenants in April, all of whom are working on developing and progressing their startup businesses in the tech sector.
