

# **Corporate Services**

Communications Official Opening of new Athy Distributor Road



Kildare County Council hosted Taoiseach, Leo Varadkar, in the presence on the Cathaoirleach of the County of Kildare, Councillor Daragh Fitzpatrick for the official opening of the new Athy Distributor Road on 31 October.

The official opening marked the completion of a new 3.4km road that commences east of Athy and provides a southern bypass of the existing town. The scheme includes 5.8km of combined walking and cycling infrastructure including a repurposed railway bridge over the River Barrow, two new roundabouts, new signalised junctions at the Carlow Road and Fortbarrington Road, an 80m single span steel bridge over the River Barrow and a new railway bridge over the Dublin to Waterford railway line. The scheme will also create a safer travel environment in Athy as well as reducing journey times and improving public transport accessibility. The project is fully funded by the Department of Transport under Project Ireland 2040.



# Public Workshops and 'Drop-in' Information events

Kildare County Council has hosted a number of workshops and 'Drop-in' information events in recent weeks regarding the development of new plans for various locations across the county, which were supported by social media coverage to raise awareness of the events.

**Clane Town Centre First Plan** In preparation of a 'Town Centre Plan' for Clane, Co Kildare, as part of the ongoing consultation process, Kildare County Council hosted a public



workshop in Clane GAA on 07 November from 5:00 p.m. – 7:00 p.m. Members of the public are encouraged to come along and find out more about the development of the plan.

### Newbridge Local Area Plan

Kildare County Council has commenced the preparation of a Local Area Plan for Newbridge town (2025 – 2031). This important plan will set out an overarching land use strategy for the proper planning and sustainable development of Newbridge over the lifetime of the Plan to 2031. The Plan will incorporate a framework for guiding the future development of transportation, housing, employment, retail, heritage, environmental and community infrastructure for the area.

A 'drop-in' event took place at the Town Hall, Main Street, Newbridge from 2:30 p.m. to 6:30 p.m. on Thursday the 09 November 2023 where Kildare County Council staff were available to answer general queries and provide guidance on the pre-draft consultation and plan-making process. We have also provided posters and leaflets throughout our Libraries and to Garda Stations, Post Offices, Intreo Offices.








Contact has also been made with Nursing Homes, Secondary Schools, the Department of Defence and many other organisations to brief them on the possibilities for online registration and to propose further in-person events involving our Register Team.



### Impacts

- Almost 3,000 online applications on CheckTheRegister.ie received in last three months alone.
- Almost 2,700 citizens added to the Register since 2022.
- An Eircode project has resulted in County Kildare's Register having 10% above the national average, in terms of recorded Eircodes on the Register.

- Almost 90% of applications now online.
- Arising from our campaigns online applications are running 50/50 new registrations/updates to existing electors.



The above shows the increase in applications notably rising following radio, bus-shelter, and leaflet campaign.

Thank you to our elected representatives for spreading awareness, encouraging political participation, sharing our materials, our social media content and promoting the online options available. A more detailed presentation will be circulated to elected members in the coming days.

### **Summer Stars**

The summer reading challenge has finished for another year. Over 3,300 children took part in summer reading this year in Kildare.

### My Little Library Book Bag

The 'My Little Library Book Bag' initiative is a collaboration between the library and the Department of Children, Equality, Disability, Integration and Youth as part of the First 5 Strategy. Over 2,600 My Little Library Bags books have been collected by children starting junior infants in 2023 to help them to prepare for this big step. This initiative will be ongoing until the end of October and Kildare Libraries have gained 338 new members as a result.

### Little Library at Bedtime

Little Library at Bedtime is a collaboration between the library and the Department of Children, Equality,



Disability, Integration and Youth as part of the First 5 Strategy. Over 700 Little Library Bedtime books have been collected by children under the age of four since the start of October. This initiative will be ongoing until the end of December, Kildare Libraries have gained 251 new members as a result.

### **Kildare Readers Festival 2023**

The Kildare Readers Festival took place from 02 October to 08 October 2023. There were 17 events with over 900 attendees.

Outreach and Integration Activities Following 34 outreach and in house Summer activities provided by the library service to residents of the two direct provision centres in Kildare (the Hazel Monasterevin and the Eyre Powell Newbridge) and the Celbridge Manor emergency centre (34 events in

total),

50 children attended Mid-term activities, including two art workshops and a puppet show in the Celbridge Manor, and a group from the Hazel attended Monasterevin library for facepainting. Kildare Library Service is a partner organisation in a funding application awarded by Department of Children, Equality, Disability, Integration and Youth (DCEDIY) to Kildare Children and Young People's Services Committee. (CYPSC) in May, of 50,000 to support children, young people and their parents living in Direct Provision Centres in 2023.

### **Dads Fest**

Kildare Library Service is part of a multi-agency collaboration with In Sync Youth and Family Services, Newbridge Family Resource Centre, Kildare CYPSC, Heads Up Kildare, County Kildare LEADER Partnership, Kildare Sports Partnership, HSE and Tusla to try to engage more Dads with our services. A 'Dads Fest' was held in Newbridge Town Hall on Saturday 21 October 2023, with Baby Beats, Drumming, Men's Shed, Library Reading Corner, Games, Refreshments and information stands from each service provider. 50 Dads attended with their children with feedback hugely positive. Over 30 surveys were collected which will be valuable in helping inform all our service delivery going forward.



# Upgrade to Kildare Libraries public PC management system

Kildare Library Service recently completed an upgrade to a new reservation management system for public PCs, allowing for more accessible and streamlined access to their network of public PCs across 14 branches. Alongside improved compatibility with the Library Management System, new features to improve the user experience include the ability for users to self-extend their sessions and, in a first for Kildare Libraries, the option to directly reserve a PC in any of our branches at a time and day of their choosing, up to seven days in advance, via an online booking system: netloan.kildarecoco.ie. Links to the booking page are live on the library app and online public catalogue, with updates to the website to follow. The library social media team will be promoting this new and exciting development in the coming weeks.

# Local Studies, Genealogy and Archives

Kildare County Archives has digitised over 6,000 pages of the surviving County Kildare Grand Jury records from 1810-1893 and these are now available online. These are some of the oldest records held in County Archives. This brings the total number of volumes online to 131, including records of the Poor Law Unions of Athy and Naas, Kildare County Council Minutes, and burial grounds registers. Conservation work has also been carried out on several items in the archives and local studies collections continuing preparation for move of the collections to Naas.

### **Decade of Commemorations**

Staff of the Local Studies, Genealogy and Archives Department continue to co-ordinate the Decade of Commemorations programme. The national Decade of Centenaries programme is concluding next month. Co-ordinator Senior Executive Librarian Mario Corrigan recently spoke at a national reflective forum for local authority staff in the National Concert Hall on County Kildare's busy programme over the past decade.

A large number of activities took place during October. Castledermot Local History Group hosted a screening of a new documentary on the 1919 Farm Labourers Strike in Kildare on Thursday 12 October. The Federation of County Kildare Local History Groups held their annual Seminar on Saturday 14 October, supported by the Decade



of Commemorations Committee, with historian James Durney speaking on those involved in the revolutionary struggle in Kildare based on his new book Stand You Know For Ireland's Cause. Artist Greg Hallahan opened his 'Nine Lives' exhibition in Kildare Courthouse in late October with his Civil War themed exhibition currently on display in Kildare Town Library. Athy Library hosted the 'Ag Fanacht – Waiting' exhibition based on the First World War Widows project by artist Angelina Foster during the last week of October.

# Gnáthóga Nádúrtha event in Rathangan

Tales and Tastes from the Bog - a free event for children and adults, took place on Sunday 01 October in The Old Schoolhouse in Rathangan. The Gnáthóga Nádúrtha/Natural Habitats project is funded by the Arts Council Invitation to Collaboration Scheme. It promotes collaboration with environmental activists, artists and community mapping experts in an ambitious arts-led inquiry, aiming to bring the urgency of climate action to the forefront. The project is sited across three natural heritage peatland habitats in each of the partner counties: Drummond, County Carlow,

Rathangan, County Kildare and Girley Bog, County Meath communities.





#### **Risk Management**

IT ran a Cybersecurity 'Table-Top Exercise' with Senior Management on 10 November. This was a round-table simulation of a cyber-attack on the





organisation to help assess our preparedness for such an incident. The exercise was overseen by cybersecurity firm BH Consulting. This is still a major risk 'event' so ongoing training and phishing exercises will continue with all users as will the work in the background by the IT team.

### Innovation

"Public Service Transformation Week" took place from 23 October – 27 October 2023 to celebrate and reflect on the ongoing work on innovation and transformation initiatives across the public service.

The Innovation Team attended the flagship Public Service Transformation Conference on Monday 23 October. The event explored the key pillars of Better Public Service and was a great opportunity for networking and learning from other PSB colleagues working in Innovation and transformation. MyCoCo took centre stage under the Digital and Innovation at scale and Kildare County Council were highlighted as a key partner/champion of this project.

The Team also attended the NOAC Good Practice Event (online) which focused on a diverse range of local authority projects and initiatives. Charlie Tuxworth of Celsio delivered an engaging Innovation Masterclass in the chamber on how we can continue to keep innovation business as usual in Kildare. Over 40 of our colleagues attended the event.



We also had a Creative Ideation Workshop where we got to be superheroes for the afternoon! We were exploring the area of voter registration and participation amongst our new communities and youth. This was a very powerful tool for thinking very differently about our challenges and opportunities and coming up with some novel ideas!!

# Development Contributions Waiver Scheme

Circular PL 04/2023 introduced a Temporary Time-Limited Waiver for Development Contributions in respect of residential developments with commencement notices issued on or after 28 March 2023 and completion of





the build of the units by 31 December 2025.

On the fifteenth of each month each Local Authority is to submit a claim to the Department of Housing, Local Government and Heritage with the value of waivers applied.

# Housing and Regeneration

### Housing

### Housing for All Affordable Housing

The Department of Housing, Local Government and Heritage recently announced an amendment to the Help to Buy Scheme for Local Authority Affordable Purchasers (LAAP). LAAPs who entered a contract to purchase an affordable property from 11 October 2023 can combine the value of their mortgage and the affordable dwelling contribution to calculate their loan to value ratio for the purpose of qualifying for the Help to Buy Scheme. To qualify for the Help to Buy Scheme, LAAPs must have a minimum of a 70% loan to value ratio. This amendment will assist more LAAPs to qualify for Help to Buy, and where applicable this amendment will be applied to the Grey Abbey Scheme. For example, if the mortgage value is €175,000, and the affordable dwelling contribution is €50,000, then the combined figure of €225,000 can now be used as the figure to calculate Loan to Value (LTV) in a HTB application, enabling more applicants of LAAPS homes to reach the 70% threshold to be eligible for the HTB scheme.

# Kildare



In the month of October, the Outreach Team visited all Municipal District areas on a regular basis to identify rough sleepers. The areas covered were: Leixlip, Celbridge, Maynooth, Naas, Newbridge, Sallins, Prosperous, Robertstown, Kilcullen, Athy and Kildare Town.

The Outreach Team offered housing advice clinics in October to those who could not attend the council offices in person. These clinics were facilitated in Newbridge Family Resource Centre, Athy Family Resource Centre and Celbridge Community Centre in Ballymakealy, Cuan Mhuire Athy and Aras Newbridge. The team also conducted assessments with hospital and prison discharges.

### **Visits to Service Providers**

Meetings were held with The Peter McVerry Trust in Eyre Street, Newbridge and Kerdiffstown, Mount Offaly in Athy and Tiglin in Jigginstown to review clients housing needs and to discuss exit strategies.

# Exits from Emergency Accommodation

There were 18 'move-ons' in the month of October, facilitated through HAP, social housing and some clients returning to family. Two of these were actioned through new Housing First tenancies.

### **Tenancy Sustainment**

At present there are 48 active tenancy sustainment cases, with 11 on the waiting list. Sustainment Officers have engaged in two housing clinics, in the Prosperous Family Hub and Athy Family Hub.

# Cost Rental Tenant in Situ Scheme (CRTiS) and Homeless HAP

The Housing Department has processed 61 Homeless HAP applications to date. The Council has submitted seven CRTiS applications to the Housing Agency; one has been withdrawn and the outcome of the others is awaited.

# CARA Mental Health Visiting Tenancy Support Service

A Tenancy Sustainment Officer for mental health has been appointed to Kildare and Wicklow. In Kildare, the focus of the Cara Mental Health Visiting Tenancy Support Service will



be working with clients who are <u>not</u> linked with mental health services. The service is open to tenants of the local authority or approved housing bodies including both nominations to new tenancies and those in established tenancies. An information leaflet on this service accompanies this report.

# Irish Refugee Protection Programme II

The Government agreed to resettle 2,900 programme refugees in Ireland in the period 2020-2023 through the Irish Refugee Protection Programme II (IRPP). Kildare County Council is required to accommodate 66 refugees, which represents 15-20 households. Kildare was not included in IRPP I. The Members will be updated as the programme progresses; the following is a summary of the programme:

- Refugees will be relocated from Reception and Orientation Centres.
- They will be classified as refugees by the United Nations High Commission for Refugees.
- Background checks are carried out by An Garda Siochana prior to arrival in Ireland.

- Individuals/Families will be housed in council or AHB provided properties.
- Grant funding is available to provide supports to refugees.
   Funding is provided for a support worker and intercultural worker for a period of 18 months.

### Traveller Accommodation

The DHLGH is continuing the nationwide Pilot Caravan Loan Scheme, to support the provision of Traveller-specific accommodation providing preferential loans to Travellers to purchase their own caravan/mobile home on halting sites for use as their primary residence. In July, Kildare was allocated one mobile home, and the installation took place in October. This allocation was inadequate to meet demand. As a result of Kildare's ongoing engagement with the Department of Housing, Local Government and Heritage (DHLGH) an additional allocation of one mobile was secured at the end of October. A family has since been identified and work is progressing to purchase a mobile home on their behalf.





During October, a Fire Safety Awareness Programme was delivered by Kildare Fire Services to the Travelling community on each of the Halting Sites. This event was attended by members of the Local Traveller Accommodation Consultative Committee (LTACC), Kildare Traveller Action and Council officials from the Traveller Accommodation Unit.





### Addressing Vacancy

### Croí Cónaithe

One Hundred and twenty-eight (128) applications have been received for the Vacant Property Refurbishment Grant.

### Town Centre First

In preparation of the Town Centre First Plan for Clane, the first public workshop was held on 07 November. Members of the public came along and participated in the workshop and gave their views on Clane and its future direction.

### **Housing Allocations**

For the period January to October 2023, the council allocated a total of 1,011 throughout the county, which includes 123 properties allocated in the past month and 341 more properties than allocated for the same period in 2022. Among the locations that allocations took place were Newbridge, Leixlip, Naas, Celbridge and Kildare Town. In an effort to address the number of refusals of offers of accommodation, the use of Choice Based Letting (CBL) has been continually increased.

# Summary of Social Housing Assessments – SSHA

The closing date for SSHA 2023 has now passed. The SSHA 2023 Return is being prepared for submission ahead of 29 November 2023 deadline.

### **Uisce Éireann Framework**

The Framework for the Future Delivery of Water Services was published in June 2022, setting out the Government policy with Uisce Éireann taking full control of all aspects of the delivery of water and wastewater services. Uisce Éireann is engaging with key national bodies and representative groups to prepare for the implementation of the Framework provisions.

The existing Service Level Agreement will be replaced by a Master Agreement for all local authorities and an individual support service agreement per local authority, taking into consideration changes included in the new Framework. In this regard, the Master Cooperation and Data Sharing Agreements were signed by Kildare County Council in May 2023.

### Environment

Draft National Waste Management Plan for a Circular Economy.

The Regional Waste Management Planning Offices, under the auspices of the County and City Management Association, are co-ordinating the preparation of the National Waste Management Plan for a Circular Economy.





This programme, which includes cemetery extensions, capital type internal improvements and proposals for columbarium walls is currently being reviewed in line with funding availability.

#### **Columbarium Walls**

It is proposed to install new Columbarium Walls in St. Michaels Athy, Leixlip Confey, and St. Conleths Newbridge cemeteries as part of the current Capital delivery program of works. Detailed design drawings are currently being worked on and it is envisaged that the project will advance to tender stage in early Quarter 4 2023. It is hoped that works will commence onsite in Quarter 1 2024 subject to funding approval.

#### **Cemetery Works**

#### Allen

Works have been recently completed on a new lawn cemetery.

#### **Staplestown**

Landscape improvement works are expected to commence during Quarter 4 2023 and Quarter 1 2024 to open the lands to the rear for future internments.

#### Confey

Works have been recently completed to allocate additional plots for internments within the cemetery.

#### Athy Cemetery Boundary Wall

Works completed on new boundary wall between the cemetery and the new Athy Southern Distributor Road. **Boycetown, Kilcock** Tenders have been issued for major drainage improvement works. It is hoped that this will help deal with

ground water problems that regularly hamper winter time internments in certain areas of the cemetery.

#### Newbridge

Works on improvements to Newbridge cemetery carpark are scheduled to commence mid November and last approximately four weeks.

#### Monasterevin

Works have been carried out on cutting back shrubs and bushes within





the cemetery. Removal of rubbish (stone, clay etc) from the cemetery will take place in November.

The Climate Action Regional Office (CARO) works to support local authorities to drive climate action in their jurisdictions and coordinate activities to promote effective climate action across the local government sector For more information on the work of the CARO, see our website at www.caro.ie

Local Authority Climate Action Training Programme

LOCAL AUTHORITY Climate Action Training Programme

The training programme 2020-2023 is nearing the end of its term. The programme maintains an objective to build capacity of the c.29,000 staff and 949 elected members on climate change, climate action and the role of local authorities on climate action. Through six unique training pillars the programme has to date, provided some 23,000 training places to 21,600 participants (figures correct as of end of October). Training continues with outdoor staff till the end of the year and into early 2024 and will include fire services staff.

A high level steering group chaired by a representative of the Climate Action, Transport, Circular Economy and Network (CATCEN) committee will be convened in early 2024 to oversee the development of a training plan guiding future training needs and priorities in the area of local authority climate action.

## Local Authority Climate Action Plans (LA CAP)

All local authorities continue to engage with the process of developing their LA CAPs for adoption on or before the 23 February 2024.

Currently local authorities are at draft stage and engaging in public consultation activities. This stage sits ahead of the completion stage where written submission will be considered and elected members will have the opportunity to consider all documentation including adaptation





and mitigation evidence base, draft plan, SEA and AA reports and submissions of stakeholders before adopting the plan by way of resolution.

Local Authority Progress Reporting – Climate Adaptation Strategies: Annual reporting on progress of the implementation of Local Authority Climate Adaptation Strategies / Plans has been undertaken by all Climate Action Officers/Leads in all local authorities. A sectoral report is being collated by CARO for progress in the 2022 – 2023 period, for submission to the Department.



Sub-Regional Energy Projects The CARO are working with local authorities in each of the four subregions to develop regional energy units to avail of funding for projects that support the decarbonisation of local authority buildings. The energy units comprise:

Mid-east (Kildare, Meath, Wicklow and Louth), commencing projects and

accessing Pathfinder support from SEAI.

Midlands (Laois, Offaly, Westmeath, Longford, Roscommon), have developed their project pipeline and sourced funding to match Pathfinder support.

Border (Cavan, Monaghan, Leitrim) are working with project manager assistance from SEAI to build a project pipeline.

South-east (Carlow, Kilkenny, Tipperary, Wexford, Waterford City and County) convening to agree partnership approach to access Pathfinder support.



Reimagining Local Authority Fleet The CARO supports the reconfigured working group established to explore support and options for local authorities on fleet decarbonization. A survey was distributed to local authorities recently to gauge their alignment with Avoid-Shift-Improve principles. The findings of this survey





will be compiled for the CATCEN committee meeting in December.

## Development of Local Authority Key Performance Indicators on Climate Action



Data collation for 2022 will be published towards the end of December 2023. Data collection for 2023 will be done in March 2024. Thereafter, data collection will be undertaken every March.

## GAA / CCMA Green Clubs Programme:



The CARO continues to work with the GAA and expert partners to advance the Green Club Programme. Phase two of the Programme commenced in early 2023 increasing the number of participating clubs to approximately 200. During phase two of the Programme clubs are working their way through a range of sustainability and climate action related projects as provided for by Green Club Toolkits covering the five themes of Energy, Water, Waste, Biodiversity and Travel.

Participating clubs are working to implement actions and projects detailed within the toolkits towards supporting the pursuit of climate action initiatives at club and community level. Kildare County Council's continued support of Green Clubs will help to achieve climate actions and targets set out in the Council's new Climate Action Plan.



## Climate Action Plan (SECAP) /Climate Action Plan (CAP)



Public consultation closed on 03 November resulting in 33 submissions. Overall the submissions were positive with many welcoming the plan. The final draft and Chief Executive report are scheduled to be compiled in midNovember. The aim is to have the plan adopted on 18 December and published in January 2024 to coincide with the start of the new working year.

## Decarbonising Zone (DZ) – Maynooth



The Climate Action Office has streamlined consultation efforts with An Taisce who are developing a Low Carbon Community Plan for Maynooth (national example) under the Legacy 4 Life programme, Maynooth University, RPS Group (consultants) and various local actors.



The DZ Plan was adopted on 31 July to inform the Maynooth Local Area Plan (LAP) being compiled presently and Local Economic and Community Plan (LECP) and other policies.





An Taisce held a public consultation event on the evening of the 28 September to gather the local community's preferred actions.

#### The Mid East Energy Unit



The baseline of energy usage to inform the decarbonising of our buildings' energy usage has been presented by CODEMA. To advance the Register of opportunities (RoO) the SEAI have agreed to pilot Pathfinder funding for the Photo Voltaic (PV) cells at the Cotton Mills, PV and Geothermal for K Leisure pools facilities at Naas and Athy in conjunction with works on swimming pools in Meath and Wicklow. The work will enable retrofit works (energy efficiency and de-carbonisation) on existing buildings.

Given the potential for future district heating in Naas the unit is working to ascertain the capacity to undertake a district heating feasibility study in the first half of 2024.

#### **Climate Action SPC:**

The scheduled meeting on 13 September took place and two presentations were given. The first by Dr. Ursula King on conservating and restoring Kildare's Biodiversity. This was followed by a presentation-on the progression of the LA CAP and DZ. The next meeting is scheduled for 06 December 2023.

## Alternative Fuel of the Council's Fleet

The CCMA have published its Electric Vehicle (EV) Guidance Document for Local Authorities;

The Climate Action Office is examining the potential to introduce compressed natural gas heavy goods vehicles into Kildare County Council's fleet with mechanical services. Smaller vans have a variety of potential options such as electrification; the larger trucks are an issue. One solution to this is compressed natural gas options. Presently the installation of a pumping station at the New Hall Depot is being progressed and potential vehicle types are being analysed.







## Climate Action Community Initiatives Items Awarded:



An Roinn Leanaí, Comhionannais, Míchumais, Lánpháirtíochta agus Óige Department of Children, Equality, Disability, Integration and Youth

The successful implementation of Gnáthóga Nádúrtha (Natural Habitats) - initiative as part of the Arts Council's Invitation to Collaboration scheme has been completed.

€75,000 was awarded under the Creative Ireland's Climate Action: Invitation to Collaboratively fund an application, led by Carlow County Council, in conjunction with Kildare and Meath County Councils. The ambitious arts led inquiry, an interdisciplinary, collaborative intervention, sited across three natural heritage peatland habitats in Carlow, Kildare and Meath brought the urgency of climate action to the forefront. An application to the Arts Council for a continuation / Phase two of the project that focusses specifically on the artists has been successful and provides an additional €35,000 in funding.

## People's Patches for Community Climate Action:

Kildare, Longford and Laois County Council along with Maynooth University, The Useless Project and Neighbourhood Network (lead) have been awarded by Pobal €271,000 funding for the Community Climate Action project submitted in January 2022. The project is to inform in communities how to source and grow quality local food and increase cooking skills to enable meaningful dietary skills to combat poor nutritional uptake especially within deprived neighbourhoods.



## 'Climate Design Lab: Where Creativity In Practice Meets Climate Action'

Under Creative Climate Action Fund II: 'Agents for Change Creative Ireland' informed Kildare County Council on 12 July that a conditional award of funding of €250,000 has been approved. This conditional offer is subject to a Service Level Agreement (SLA). Climate Design Lab: Where Creativity In Practice Meets Climate Action Kildare





County Council along with the Design Innovation Department in Maynooth University and Riverbank Arts Centre will pilot a Climate Design Lab that aims to use design-thinking and behavioural economics to co-create fun theory solutions for Maynooth, the decarbonising zone for the county. Preliminary work has commenced with Maynooth University.

#### Research

Gas Innovation Fund and Public Service Innovation Fund



The Climate Action Office is reapplying for the Gas Network Ireland's Gas Innovation Fund in conjunction with Maynooth University's Terrain-Ai research group and Teagasc. This project aims to assess the potential for green spaces to generate biomass e.g., grass-clippings as a feedstock for energy generation in Kildare with potential of scaling the study up to different county councils and state bodies nationwide. If successful the main body of work will be carried out with project support from the Climate Action Office, Maynooth University and engagement with Teagasc.



To advance the project financially an application was made to the Public Service Innovation Fund 2023 the bid has been successful and funding of €50,000 awarded. An agreement is now being formulated with Maynooth University to enable the research to commence at pace. It is expected that the project will be completed by Quarter 2/3 of 2024.

#### **Climate Innovation Fund 2023**



The projects funded under the 2022 scheme are concluding in July 2023. The fund launched on 30 June and the closing date was 30 July 2023. One successful submission was made in the Kildare Newbridge Municipal District.





Alternatives to Herbicides Project

The Parks/Climate Action Office's project including scientific research together with practical assessment in the field (Kildare County Council Parks Department and National University of Ireland, Maynooth) has produced a practical maintenance guide for public open spaces and documented research practices undertaken and disseminated to ten Local Authorities have partnered together with Waterways Ireland.

PhD research has commenced-and the final scheduled experiments have been undertaken on Millenium Link Road, Naas. The site will be monitored over the coming year to inform the research further.

#### **Climate and Me! Day**



Occurred on the 20 October 2023 with activities in the Aras, associated car park and MERITS. Activities in general were well attended regardless of the rain. The day informed on items of interest to people's areas of work and life.

To increase accessibility and knowledge sharing, videos of the speakers' sessions, donut economics and a short sum-up of the day will be made available to all council staff and councilors in the near future.

Thank you to all for their support and attendance on the day.

Health and Safety Conference The Climate Action Office was delighted to be invited to have a stand at this year's Annual Health and Safety Conference which took place on Wednesday the 25 October 2023 in the Osprey Hotel.

The theme of this year's event was "How do you look after your Mental Health" which was very apt given climate anxiety is felt by many.

#### Branding

The Climate Action Office has engaged Designedly to brand the office and Decarbonising Zone along with the graph input to finalise Kildare's Climate Action Plan. The Climate Action Office branding is complete and the DZ branding being advanced swiftly.





## Local Community Development Committee

The last meeting of the Local Community Development Committee (LCDC) was held on the 27 September 2023 in the Merits building.

SICAP- Social Inclusion Programme County Kildare LEADER Partnership, who are contracted to run SICAP in Kildare are focusing on responding to priorities agreed by Kildare LCDC that fit with current national priorities. A national tendering process is underway for the SICAP programme 2024 to 2028. It is anticipated that this contract will be issued before the end of the year.

## Empowering Communities Programme Athy

Athy has been selected by Department of Rural and Community Development (DRCD) as a target area for a new community development programme 'Empowering Communities Programme' (ECP) with a funding allocation of €140,000. County Kildare LEADER Partnership are the programme lead on this work and employ the project staff.

# Local Economic and Community Plan (LECP)

Stage two, Consultation, to inform the development of the LECP is now concluding. The Advisory Steering Group met on 06 November 2023 to consider progress and agree next steps. The consultation process included: Kildare Public Participation Network (PPN) ran five Municipal District consultations with 94 community groups attending. The outcomes from these meetings will feed into the LECP and PPN Wellbeing Plan. The LECP survey closed with 869 respondents. Engagement with employers and business leaders took place through the Economic Development Forum, Foreign Direct Investment (FDI) meeting and ongoing engagement with a range of employers across the county. Consultations took place with a broad range of statutory bodies,





voluntary sector organisations and collaborative structures (over 224 people participated). Engaging with representatives of the most excluded was a key consideration. The Advisory Steering Group are recommending the final LECP vision and high-level goals go to the LCDC and SPC for Enterprise, Economic Development and Planning at their upcoming meetings. While consultation is a distinct stage in the guidelines, it continues throughout the development and implementation of the LECP. Drafting of the objectives and actions to finalise the plan will then commence. Work continues to compile the analysis of Census 2022, as it is released by AIRO in Maynooth University.

## Transport, Mobility and Open Spaces

### Transport

M4 Maynooth to Leixlip M4 Eastbound Bus Priority Measures The Part 8 for the M4 Eastbound Bus Priority Measures was presented at the February 2023 Council meeting and was approved. Work is ongoing with TII to progress to construction.

#### M4 Westbound

The Westbound project will progress to the end of Phase 2. It is likely at that stage that the project will be divided into three areas- Westbound Bus Running, Active Travel and Safety Measures



This scheme is likely to transfer to the Roads Projects team.

Idare

Kildare National Roads Office have undertaken a pavement design and safety improvement for pavement improvement works on the existing N78 through Athy town and have also been liaising with Public Realm and Kildare County Council Roads with regard to the Emily Square project. Now that the Athy Distributor Road (ADR) is open, Transport Infrastructure Ireland (TII) are being asked by Department of Transport (DoT) to contribute to a more significant public realm type project through Athy Main street. If agreement can be reached then Kildare County Council Roads Project team will assume responsibility for delivery.

Existing N78 to be reclassified - new ADR will become N78 in Athy – DoT / TII in discussion as to further requirements.

#### Leinster Road Bridges

Rehabilitation Contract Scheme involves rehabilitation works to M7, Junction 10 Overbridge; M7, Newhall Overbridge; M7 Greatconnell Overbridge; M7 Corbally Overbridge; M9, Kineagh Road Overbridge. Glas Civil Engineering Limited has been awarded this contract.

Athy Distributor Road (BAM, Roughan and O Donovan) The Athy Distributor Road is now open (31 October 2023). BAM has achieved substantial completion, however snagging work still continues.

New Machinery Yard Relocation and Regional Salt Barn (Clonmel Enterprises, Kilgallon and Partners) Project is nearing completion. Regional Salt Barn is 95% complete. Yard is 95% complete. Admin Building is 90% complete. Project has largely transferred from Project to Implementation phase.

Maynooth Eastern Ring Road (Roughan and O Donovan) The Oral Hearing for the CPO went ahead on 04 May 2023 via Teams. A decision is expected in 2023.

## Maynooth Transport Strategy (Aecom)

The ABTA is currently being finalised and will issue to councillors for information before being published.





# Newbridge Transport Strategy (Aecom)

AECOM have started modelling and option development for Newbridge. Phase 2 consultation will be scheduled for later this year.

#### **Junction Programme**

Phase 1A of the Rural Junctions Improvement Project is for the delivery of five separate schemes, which are to be delivered in tandem. These schemes are listed below. Phase 1B tender assessment is

complete and has been awarded for design. Consultants are Clandillon Consulting.

#### **Speed Limit Review**

No update from the Department of Transport at present.

#### **Municipal District Works**

Roads Works Programme 2023 is nearing completion – all records now to be uploaded onto MapRoad PMS system. Surface Dressing work carried out by direct labour is fully complete and again Kildare County Council treated over 4% of Non-National Road network.

Annual call from Department of Transport for grant funding requests on Bridge Rehabilitation, Road Safety works, CCAR (Climate) and former National roads (FNR) for 2024 are currently being prepared to be submitted in coming weeks. TII Road Surfacing grant to value €67,500 to be drawn down via PRS to cover works carried out on N78 (Athy – M9 Roundabout). Other maintenance monies will be utilised on both N78 and N81 before year end. Winter Maintenance season starts commenced on 16 October. Duty Engineers are appointed to monitor weather via Viasala system. Tool-Box Talk carried out in Machinery Yard for all drivers before start of season.

### **Public Lighting**

PLEEP Survey to commence in November of this year followed by detailed design in Quarter 1/2 2024 with works on site to commence in Quarter 3 2024. Contract duration is for eight months and due for completion in Quarter 2 2025 which will lead to annual savings of approx €750,000 on energy and maintenance costs going forward.

## **Open Spaces (Parks)**

News and Highlights Allenwood Playground Works are continuing on the site. Works on the pump track have commenced.





Outdoor Gym, Celbridge

## Monread Park Playground

Works on the installation of a new basket swing, sandpit and seesaw has been completed.

## Local Area Plans Kildare Town

The Kildare Local Area Plan 2023 – 2029 was adopted at a Special Planning Meeting held in Merits on Thursday 26 October 2023 and will take effect from 06 December 2023

Joint Maynooth and Environs Work is on-going in relation to the preparation of evidence-based reports to support the draft plan. The Area





Based Transport Assessment for the plan is being finalised. Visioning workshop was arranged for the 06 October 2023.


#### Newbridge



## BUILDING CONTROL





## AGILE INNOVATION FUND:

Sportsfuel limited t/a Nutracopack and lead by David Carey was approved €41,235 in Research Development funding. An ambitious product, packaging and automation project is underway at the Celbridge based food production plant that will see potentially five new jobs for the growing company over the next three years.

The Retail Window Merchandising Grant remains open to applicants until November and businesses can avail of 80% funding on eligible expenditure up to a maximum of €500 for outlets to enhance their window displays for Hallowe'en and Christmas.

The Brigid 1500 Window Grant has opened for businesses to apply for support to celebrate St Brigid next February.

## Athy Streetscape Enhancement Scheme 2022-2023

Under this scheme, property owners and local groups have applied for grants to improve the facades of their buildings, carry out artwork or install features such as street furniture or canopies in Athy. The economic development team continues to work with the project team and is supporting prospective applicants with the application process. The scheme is closed for applications and successful applicants are completing projects presently.

## Kildare Craft, Creativity and Design Hub, Courthouse Kildare.

The consultants have completed the stakeholder analysis and are finalising the draft feasibility study at present. Kildare County Council has reached a lease agreement for the deployment of a pilot on a smaller footprint in two Retail Units in Kildare Town Square.

# Fashion, Textiles and Design Hub (former BOI Monasterevin)

The consultants have submitted the feasibility study for the building; funding mechanisms are now being investigated, should the appropriate planning and development regulations be in order, for the proposed development we will commence work in Quarter 1 2024.

Elected Members of the Clane-Maynooth Municipal District. Funding mechanisms are now being investigated. Progression will be very much subject to the appropriate planning and development regulations be in order, for the proposed development.

## Athy Green and Sustainable Enterprise Park Feasibility Study

A study is underway to acquire lands and develop Green and Sustainable Enterprise Park in Athy. Funding mechanisms are also now being investigated. Progression will be very much subject to funding availability and the appropriate planning and development regulations be in order for the proposed development.

## Kildare County Council Industrial Estate Enhancement

A project manager and contractor has been procured to deliver enhancement works on four industrial estates owned by Kildare County Council in Newbridge, Kilcullen, Rathangan and Celbridge; the works have commenced and will enhance the exteriors and signage of the respective estates.

## **Online Retail Series**

34 retailers across the County participated in the four sessions of retail-focused webinars covering trends and peak trade, visual merchandising, and online trading and marketing that were delivered by expert retail professionals.





#### **K-Hub Network**

Kildare County Council's Economic Development Team successfully organised and supported a diary of events and open days in October for people to visit Kildare's hub network.

#### K-Hub activity:

The MERITS Hub hosted a Venture Capital and Investment networking morning during October as part of the K-Hub promotional activity. The event was attended by 13 business owners who are exploring funding opportunities.

#### Coding for Kids Camp:

The MERITS hub hosted a "Coding for Kids" camp during the mid-term break. 12 children participated in this pilot programme which saw them learn the basics of coding and further their insight into the world of technology and innovation.

#### The Innovation Exchange:

The Innovation Exchange came to MERITS during October to offer businesses the opportunity to learn about their network. The programme offers the opportunity for small and medium sized enterprises (SMEs) to sell their products and services to Multinational Corporations with whom they may traditionally find it difficult to engage.


## Report on Visit to Lexington Kentucky by delegation from Kildare from 11 to 15 October 2023.



#### Background


This visit, arranged through Kildare County Council, was continuing the relatonship be- tween Kildare and Lexington, Kentucky. This twinning was instigated in 1984 by then County Manager, Gerald Ward, and has been sustained since through the Twinning Committee and Kildare County Council. Originally based around the equine industry in both areas, it has also embraced culture, industry, and other aspects.







The concept of twinning is about development and sustaining friendships between different parts of the world and in this case is reflected in the work of the Kildare Twinning Committee chaired currently by Councillor Fintan Brett. The committee includes representatives of the local authority as well as members with long relationships with their counterparts in Lexington Sister Cities Committee (Sister Cities is the name given to twinning throughout the U.S.). In addition to Kildare, Lexington is a Sister City with a region in Japan, with Deauville in France and with Newmarket in the UK. In each case, the original basis for the relationship was the strong equine tradition and industry.



Throughout the period since 1984, there have been regular reciprocal visits between Lexington and Kildare, with the Lexington group last visiting in September 2022 when they spent three days in Kildare including a Gala dinner and an afternoon at Taste of Kildare at the Curragh.



The programme for this visit in October 2023 was agreed through engagement between the offices of the Chief Executive of Kildare County Council and Ms. Kay Sargent, Executive Director of Sister Cities in Kentucky. The composition of the group was agreed by the Chief Executive and comprised members of the Twinning Committee as well as representatives of the tourism and equine industries and the Chamber of Commerce.

#### Programme

In advance of the visit extensive communication took place between the office of the CE and Ms. Sargent to ensure that the content of the visit would be relevant and use- ful as well as enjoyable. As a result, the programme for the members of the travelling party was developed to ensure that the various interests were covered. Sample pro- grammes are attached for information.

A significant part of the programme concentrated on the equine industry, with visits to Jonabell Farm (Godolphin) and to Ashford Stud (Coolmore). Interestingly, in both these cases, the input at the farms was presented by Irish staff and there was ample

time for discussion and engagement on issues of relevance, including tourism potential and experience.

There was a visit to the State Capital of Kentucky, Frankfort where the group was welcomed by the State representateive, Chad Auli and enjoyed a tour of the hugely impressive Capital Building. Later that day the group was welcomed formally by the Mayor of Lexington, Ms. Lin- da Gorton, and full Council at a Council Meeting in Lexington where Kildare CE Sonya Kava- nagh addressed the attendance.

The remainder of the 3-day programme provided for visits to and meetings with representa- tives of Commerce Lexington, Visit Lex, KY World Trade Centre, Environmental, Planning, Housing Advocacy and Community Development departments for the relevant member(s) of the group as well as site visits including to public realm, community/recreational and cultural sites of relevance. The social aspects of the visit were very impressive and included attendance by the group at Keenland Races and a welcome reception and formal dinner hosted by the Mayor at the Lexington Club, held in an impressive Heritage Building in Lexington. At this dinner, Councillor Brett addressed the

attendance on behalf of the Kildare delegation and presentations were exchanged.

Finally, the group were invited to visit the international Headquarters of Alltech International and were given a guided tour of the magnificent new building and museum, by Mrs. Deirdre Lyons, Co-founder of the company. This was followed by a very informative visit to Lexington Brewing and Distilling.









#### **Comments and observations**

- This was a very successful visit and reflected the advance preparation both from Kildare County Council and the Sister Cities office. This resulted in a very relevant and enjoyable programme for all involved.
- 2. It is clear that the Twinning arrangement is hugely valued by the Sister Cities group in Lexington, led by Kay Sargent.
- 3. It is worth noting that apart from Kay Sargent, there is a very active group of Friendship Volunteers who support and work with Kay in sustaining the arrangement, as well as contributing financially. For instance, they were available as volunteer drivers throughout the visit and it was clear that they were very involved in all aspects.
- 4. Throughout the visit we met with several proud Irish business people who are involved in various industries in Kentucky, principally equine related. They may represent useful contacts for follow up actions. (it is worth noting that a former pupil from Maynooth was delighted to welcome his former Headmaster, Senan Griffin, to Alltech – he is now a senior member of staff based in Kentucky!)
- 5. Members of the delegation made useful personal contacts with their counterparts, which, if pursued, offer opportunities for effective collaboration.
- 6. The expectations of the Lexington counterparts are high and mean that there is a need to continue to support and strengthen the Twinning Committee here to ensure that a suitable programme of activity can be delivered on an ongoing basis. This may present a challenge but one that will be worthwhile.
