That Kildare County Council writes to the Minister for Housing, Local Government and Heritage to oppose the proposed changes to apartment standards, which reduce local authority discretion and risk undermining the proper planning and sustainable development of housing, as well as public confidence in local and national democracy, and seek a meeting to ensure that any future standards reflect a locally informed and community-led approach to housing delivery.

That the council writes to the Department of Climate, Energy and the Environment for a policy on the disposal of large nitrous oxide canisters.
