#### **Protected Disclosures**

The Protected Disclosures Act 2014 was amended by the <u>Protected</u> Disclosures (Amendment) Act 2022.

This legislation which came into force on 01 January 2023 imposes new requirements on employers in both the public and private sectors and for prescribed persons. The scope of the act was widened to include board members (this includes Councillors), shareholders, job applicants and volunteers.

The Minister issued final guidance for public bodies and prescribed persons which was received in December 2023. Kildare County Councils Protected Disclosures policy and procedure for internal disclosures has been updated and along with a new policy and procedure for external reporting to the Chief Executive of a local authority as a prescribed person under SI 367 of 2020, is available on the council website, the staff app and the members portal.

#### **Annual Ethics Declaration**

On 08 January 2024, the Ethics
Registrar issued notices to all
Councillors and Relevant Employees
via email regarding their obligation
under the Local Government Act 2001
to submit an annual written declaration
containing particulars of their
declarable interests. Copies of the
Code of Conduct for Councillors and
blank 2024 declaration forms were
appended to her email.

The annual declaration form includes a declaration that Councillors have read the Code of Conduct for Councillors



and that they understand its meaning, and an undertaking to have regard to and be guided by the Code of Conduct for Councillors in the exercise of their functions.

The legislation requires that completed forms must be furnished to the Ethics Registrar by 29 February 2024.

# Kildare County Archives and Local Studies

The process of unpacking both the County Archives and Local Studies collections in the new location at



Harbour View, Naas is ongoing. Both services are currently closed to the public, although emails and phone calls are being dealt with by staff.

Local Studies collections will be accessible to the wider community when we re-open, with most of the collection searchable through the library catalogue. Historic Irish newspapers, including many decades of The Leinster Leader and Kildare Nationalist, can be accessed through the Irish Newspaper Archives resource that is now available in all branch libraries in County Kildare. Further digital content is available on the library website, with more to be added in the coming weeks.

The installation of the archival shelving is complete.

# **Financial Reports**

### **Annual Financial Statement**

The Annual Financial Statement for year ended 31 December 2023 is currently being prepared and will be completed by 31 March 2024. It will be brought to Council when complete.

#### Schedule of Uncollected Rates

The schedule of uncollected rates was completed in January 2024, the total amount collected on Rates for 2023 was €57.9m compared to €55.6m for 2022.

The closing arrears balance has decreased from €9.9m for 2022 to €8.3m for 2023.

The overall collection percentage for 2023 is 88% an increase on the 2022 collection percentage of 86%.

The total amount of rate vacancy adjustments has decreased from €3.9m in 2022 to €3.4m for 2023.

The total amount of rate waivers for 2023 was €50k compared to €1.9m rate waivers for 2022.



#### Rates Demands 2024

The Rate Demands for 2024 will issue in February to all ratepayers.

New legislation regarding commercial rates took effect from 01 January 2024. The Local Government Rates and Other Matters Act 2019 effects the following changes:

- Replaces the payment of rates in two moieties with one rates amount due on the first of the year
- Replaces the issuing of Property Entry Levy (PEL) and valuations taking effect the year after issue of a schedule (by Tailte Eireann) with immediate billing through the calendar year.
- Provides for the application of interest on unpaid rates from 2025. Interest will be added to rates bills issued from 2026.
- Removes the requirement for public notice to be given regarding Kildare County
   Council's intention to 'make the rate'. This is replaced by a notice advising that a 'rate has been levied'.



 Removes the requirement for the rate book to be available for inspection, either in paper form or electronically.

Kildare County Council Finance
Department wrote to all rates
customers in December 2023 to
advise them of these changes,
particularly the transition from two
moieties to one and advising of their
payment options, including Direct
Debit to facilitate payment across the
calendar year.

### **Increased Cost of Business Grant**

As part of Budget 2024, the
Government announced a €257m
package to help small to medium
businesses deal with the rising costs
facing businesses. Guidance is to
issue from the Department on this
grant scheme and it is expected to roll
out in March 2024.

The grant is for commercially trading businesses operating from a rateable premises. The grant is as follows:



- For qualifying businesses with a 2023 Commercial Rate bill of <€10,000, the ICOB grant will be paid at a rate of 50% of the business's Commercial Rate bill for 2023.
- For qualifying businesses with a 2023 Commercial Rate bill of between €10,000 and €30,000, the ICOB grants will be €5,000.
- Businesses with a 2023 Commercial Rates bill greater than €30,000 are not eligible to receive an ICOB grant.

  The excluded categories are identified based on the following assumptions:
  - Anything that cannot be defined as a 'commercially trading business operating directly within a premises that is commercially rateable' should be excluded (e.g., advertising stations).
  - For the sake of clarity, this includes, but is not limited to:
    - Public institutions do not qualify.
    - Financial

       institutions do not
       qualify, with
       exceptions for
       credit unions and
       post offices (i.e.,
       larger financial



institutions are excluded).

Vacant properties do not qualify.

# Housing

# Homeless Services Homeless Action Plan

The Draft Homeless Action Plan 2024
-2026 (Mid-East Region) is being
finalised and will be presented to the
Council in the coming months.
The plan seeks to address issues
relating to the prevention of
homelessness; reduction of
homelessness in its extent or duration;
the provision of services, including
accommodation, to address the needs
of homeless households; the provision
of assistance to persons who were
formerly homeless; and the promotion
of effective co-ordination of activities



by relevant agencies and stakeholders in the county.

#### Street Work / Outreach Clinics

During January, the Outreach Team visited all Municipal Districts on a regular basis to identify rough sleepers. The areas covered were Leixlip, Kilcock, Celbridge, Maynooth, Naas, Newbridge, Sallins, Kilcullen, Athy and Kildare Town.



The Outreach Team continues to facilitate monthly housing advice clinics (in each Municipal District) for individuals and families who cannot attend the council offices in person. The team also conducted assessments with hospital and prison discharges.

## **Visits to Service Providers**

Meetings were held with The Peter McVerry Trust in Eyre Street, Newbridge and Kerdiffstown, Mount



Offaly in Athy and Tiglin in Jigginstown to review clients' housing needs and to discuss exit strategies.

# Exits from Emergency Accommodation

There were nine (9) move-ons in January, facilitated through HAP, social housing and some clients returning to family. In 2023, a total of 199 households left emergency accommodation, comprising 61 families and 138 singles.

# **Tenancy Sustainment**

At present there are 45 active tenancy sustainment cases receiving TSO support (21 cases closed in January). Tenancy Sustainment Officers have ongoing engagement with clients referred to the service and through the two housing monthly clinics (Family Hubs in Prosperous and Athy).

#### **Homeless HAP**

The Homeless HAP scheme helps people who are homeless or at risk of becoming homeless. The scheme offers additional support to applicants, including assistance in locating a property. Eight applications were



received in January and are being processed.

# Cost Rental Tenant in Situ Scheme (CRTiS)

The scheme (introduced in April last year following the end of the winter eviction ban) allows the Housing Agency to buy rental properties from private landlords who are selling. The Agency rents these properties to the tenants who are living there. To date nine applications (including one in 2024) have been received by the Council and submitted to the Housing Agency. Of these, one purchase has now been completed, three properties are sale agreed, two at purchase offer stage and two awaiting inspection.
One application has been withdrawn.

### **Housing Allocations**

In January, there were 112 social housing allocations of which 42 were council properties and 70 were nominated to Approved Housing Bodies (AHBs). The majority of AHB nominations were for the new development at Ardrath,

Celbridge. Throughout January, there were 24 refusals of an allocation. A total of 30 properties were allocated



through the Choice Based Lettings system.

# Affordable Housing Grey Abbey Scheme

This scheme is now finalised. Out of a potential 21 sales, 19 sales concluded. The Housing Department is engaging with the Department of Housing, Local Government and Heritage on a post project review.

# Ready to Build/Serviced Sites Scheme

Work on preparing the Clogherinkoe serviced sites is ongoing. Tenders have been received for site clearance. A sewer upgrade is required and we are liaising with Uisce Eireann on this matter. We will keep the elected members updated as the scheme progresses.

# Traveller Accommodation Sixth Traveller Accommodation Programme 2025 -2029



The Climate Action Regional Office (CARO) works to support local authorities to drive climate action in their jurisdictions and coordinate activities to promote effective climate action across the local government

### Local Authority Climate Action Training Programme



The training programme 2020-2023 is nearing the end of its term. The programme maintains an objective to build capacity of the c.29,000 staff and 949 elected members on climate change, climate action and the role of local authorities on climate action.

Through six unique training pillars the programme has to date, provided some 27,000 training places to almost 23,000 participants (figures correct as of end of January 2024). Training continues with outdoor staff until the end of March 2024 under an extended Service Level Agreement (SLA) with





the Department. Training will also include fire services staff.

A high level steering group chaired by a representative of the Climate Action, Transport, Circular Economy and Network (CATCEN) committee has progressed the development of a training plan guiding future training needs and priorities in the area of local authority climate action. Quantitative and qualitative data is currently being explored to help inform the training plan.

## Local Authority Climate Action Plans (LA CAP)

Local authorities continue to engage with the process of developing their LA CAPs for adoption on or before the 23 February 2024.

Kildare County Council adopted their LACAP on the 18 December 2023 and nine other local authorities in the EM region have adopted their plan (as of 12 February). Currently local authorities are at the third and final stage preparing the final draft for adoption by resolution with the elected members of the council. Elected members will have the opportunity to consider all documentation including adaptation and mitigation evidence base, draft plan, SEA and AA reports

and submissions of stakeholders before adopting the plan by way of resolution.

### Local Authority Progress Reporting - Climate Adaptation Strategies:

Annual reporting on progress of the implementation of Local Authority Climate Adaptation Strategies / Plans has been undertaken by all Climate Action Officers/Leads in all local authorities. A sectoral report collated by CARO for progress in the 2022 – 2023 period was submitted to the Department in November 2023.



#### **Sub-Regional Energy Projects**

The CARO are working with local authorities in each of the four subregions to develop regional energy units to avail of funding for projects that support the decarbonisation of local authority buildings. The energy units comprise:

Mid-east (Kildare, Meath, Wicklow and Louth), commencing projects and accessing Pathfinder support from SEAL.





Midlands (Laois, Offaly, Westmeath, Longford, Roscommon), have developed their project pipeline and sourced funding to match Pathfinder support.

Border (Cavan, Monaghan, Leitrim) are working with project manager assistance from SEAI to build a project pipeline.

South-east (Carlow, Kilkenny, Tipperary, Wexford, Waterford City and County) have prepared a position paper and issued to SEAI for their consideration. Further discussion will continue to progress to MOU stage.



#### **Reimagining Local Authority Fleet**

The CARO supports the reconfigured working group established to explore support and options for local authorities on fleet decarbonization.

A survey was distributed to local authorities recently to gauge their alignment with Avoid-Shift-Improve principles. The findings of this survey was compiled for the Climate Action, Transport, Circular Economy and Network (CATCEN) committee meeting in December and will be used

as the basis for a fleet manager network meeting on 27 March 2024.

### Development of Local Authority Key Performance Indicators on Climate Action



Data collation for 2022 was published in December 2023. Data collection for 2023 will be undertaken in March 2024. Data collection will be undertaken from 26 February to 09 March from all local authorities.

### GAA / CCMA Green Clubs Programme:



The CARO continues to work with the GAA and expert partners to advance the Green Club Programme. Phase two of the Programme commenced in early 2023 increasing the number of participating clubs to approximately 200. During phase two of the Programme clubs are working their way through a range of sustainability and climate action related projects as



provided for by Green Club Toolkits covering the five themes of Energy, Water, Waste, Biodiversity and Travel. Participating clubs are working to implement actions and projects detailed within the toolkits towards supporting the pursuit of climate action initiatives at club and community level. Kildare County Council's continued support of Green Clubs will help to achieve climate actions and targets set out in the Council's new Climate Action Plan.

Points of Contact have been identified in each local authority and CARO has undertaken two webinars to support points of contact in engaging with clubs in their area.

The CARO office provides support to the Climate Action Office (CAO). In turn the CAO assists the functional areas of the council to decarbonise their roles and work through the members of the Climate Action Team and Energy Management Team together with the Senior Management Team.

## Kildare County Council Climate Action Plan (with DZ and SECAP)



Kildare County Council Climate Action Plan 2024-2029 was officially the first plan to be adopted in the country as of the 18 December 2023. The plan and associated documentation are digitally available on our Council website from 17 January 2024 as statutorily required. The plan is available digitally in Irish.

The challenging work of all contributors is acknowledged, and we look forward to continuing to work together to reach the targets set.





The official launch of the CAP is being considered as part of 'Hacktheclimate' on 23 February 2024.

#### **Decarbonising Zone Maynooth**



#### Together for a sustainable tomorrow

Chapter five of the Climate Action Plan is dedicated to the Decarbonising Zone (DZ), a test bed or living laboratory to test solutions to decarbonising society. To promote this essential element that will inform other towns and villages known as fast followers, a logo and byline as depicted above has been developed to market and brand the associated research, actions and resulting outcomes.

#### The Mid East Energy Unit (MEEU)

SEAI have agreed to pilot Pathfinder funding (approx. €20m between the four Mideast Energy Unit (MEEU) LA's) for various Energy/Carbon savings related projects at scale, these include the installation of approx. 220 Photo Voltaic (PV) solar panels at the Cotton Mills, PV and Geothermal heat pumps for heating at K Leisure pools facilities at Naas and Athy in conjunction with

works on swimming pools in Meath, Wicklow and Louth. The Aras PV panel project was tendered late 2023 and contract has been awarded. The heating system appraisals of the Aras and K-Leisure buildings is at an early stage and is being undertaken by our MEEU consultants Codema.

There may also be pathfinder funding available for upgrading works to some of our library buildings, this will include some energy related elements of the new Clane Library. The work will enable retrofit works (energy efficiency and decarbonisation) on our existing buildings, thus reducing energy utility bill costs.

Given the potential for a future district heating scheme (DH) in Naas, a DH feasibility study will be undertaken by Codema in Q2/Q3 of 2024. SEAI have agreed to 100% fund this Naas study. There may also be scope to undertake a similar DH study for Maynooth later in 2024/early 2025, this to be funded directly by our planning dept. Kildare County Council hopes to apply for ISO 50001 (Energy Management System) certification in Q3/Q4 of 2024, for the organisation as a whole. Our Energy Officer and the SEE of Property Management will be attending the



SEAI ISO50001 accelerator training from 12 March as part of this process.

#### **Climate Action SPC:**

The scheduled meeting on 07
February 2024 took place in the newly refurbished Naas Library in the former Town Hall. All Councilors and members of the six SPC were invited to attend.

The meeting gave an overview of the work of the Climate Action Office to explain the basis of the plan for the next five years including: Victoria Kavanagh (Community Climate Action Officer) presenting on the Community Climate Action Programme Fund, Paddy Lynch (Energy Efficiency Officer) presenting on the KCC's Energy Efficiency Plan to reach the National Objective of 50% increase in energy efficiency within the council and his experience in the field, Mary Morrissey (Climate Action Officer) presented on her work and expertise in built environment, Paula O'Rourke (Climate Action Coordinator) presented on the monitoring and reporting of CA SPC's work plan together with Kildare's Climate Strategy 2019-2024, CARO, the Climate Action Plan and Decarbonising Zone.

This was complimented, given the biodiversity crisis, with a presentation by Meabh Boylan (Kildare County Council Biodiversity Officer) on Biodiversity and Climate change. The information was actively discussed and well received.

The next meeting is scheduled for the 08 May 2024.

# Climate Action Community Initiatives Funding Aids and Projects:



An Roinn Leanaí, Comhionannais, Míchumais, Lánpháirtíochta agus Óige Department of Children, Equality, Disability, Integration and Youth

The successful implementation of Gnáthóga Nádúrtha (Natural Habitats) - initiative as part of the Arts Council's Invitation to Collaboration scheme has been completed.

The ambitious arts led inquiry, an interdisciplinary, collaborative intervention, sited across three natural heritage peatland habitats in Carlow, Kildare and Meath brought the urgency of climate action to the forefront.

An application to the Arts Council for a continuation / Phase two of the project that focusses specifically on the artists has been successful and provides an additional €35,000 in funding.





### People's Patches/'Our Shared Plate Project' for Community Climate Action:

Kildare, Longford and Laois County
Council along with Maynooth
University, The Useless Project and
Neighbourhood Network (lead) have
been awarded, by Pobal, €271,000
funding for the Community Climate
Action project submitted in January
2022. The project is to inform in
communities how to source and grow
quality local food and increase cooking
skills to enable meaningful dietary
skills to combat poor nutritional uptake
especially within deprived
neighbourhoods.

The name of the project has changed to 'Our Shared Plate Project' to reflect the community cohesion through the celebration of food. We await the outcome of the County Community Gardens/Allotment proposal to inform the sites proposed in Kildare.



Climate Design Lab: Where
Creativity In Practice Meets Climate
Action'

Under Creative Climate Action Fund II:

'Agents for Change Creative Ireland' informed Kildare County Council on 12 July that a conditional award of funding of €250,000 has been approved. This conditional offer is subject to a Service Level Agreement (SLA).

Kildare County Council along with the Design Innovation Department in Maynooth University and Riverbank Arts Centre will pilot a Climate Design Lab that aims to use design-thinking and behavioural economics to cocreate fun theory solutions for Maynooth, the decarbonising zone for the county. Preliminary work has commenced at Maynooth University. To advance understanding of the 19 Ignite projects Creative Ireland held a four day workshop for project teams in Borris House from 30 January to 02 February. The Climate Design Lab has been provisionally asked to attend the National Climate Stakeholder Forum being organised by the Department of Environment, Climate and Communications (DECC) on the 28 February in the Convention Centre Dublin. We await clarification.





### Community Climate Action Program Fund:

Our Community Climate Action Officer has undertaken a scheduled program of outreach to gain appropriate submission by 06 March deadline. Kildare at county level has been awarded €897,000 grant funding. To date the information has been received well and potential projects are being put forward by interested parties with 28 projects at various stages of the application process.

### 'HacktheClimate' and Open data Engagement Fund:

In collaboration with the innovation
Team and MERITS we have
successfully been awarded €5,000
from the Open Data Unit in the
Department of Public Expenditure and
Reform. The funding is to sponsor
prizes for our hackathon called
'Hacktheclimate' on 23 February which
should place us firmly on the map for
participants. Final calls are being
made for attendees as the registration
numbers are reaching capacity. It is
expected between 40-55 attendees will
be achieved on the day.

#### Research

### Gas Innovation Fund and Public Service Inovation Fund:

This project aims to assess the potential for green spaces to generate biomass e.g., grass-clippings as a feedstock for energy generation in Kildare with the potential of scaling the study up to different county councils and state bodies nationwide. An agreement has been formulated with Maynooth University to enable the research to commence and the work is progressing at a pace. It is expected that the project will be completed by Q2/3 of 2024.

#### **Alternatives to Herbicides Project**

Kildare County Council's research project - alternatives for pesticides continues with the help of our collaborating partners, Maynooth University, Trinity College Dublin, National Biodiversity Data Centre and Teagasc. The finalised data report and practical guide for the maintenance of open spaces have been disseminated to all partners. Analysis of soil biomes continues with additional experiments being undertaken to finalise maintenance aspects. Sophia Couchman has commenced her PhD and it is expected she will have the work





completed Q1/2 of 2025. It is with thanks to partners the findings will inform the National Biodiversity Data Centre latest brochures. Presently the short guidance document is to be graphically designed and published with copies provided to each partner.

#### **Awards**

The Grass2Gas project was shortlisted for the Chambers Ireland – Excellence in Local Government Awards 2023, Sustainability Environment and Biodiversity Award held in November 2023.

The project is shortlisted for the Green Awards under the Green Technology Award which will be held on 27 February 2024.

#### **Water Services**

#### **Uisce Éireann Framework**

The Framework for the Future Delivery of Water Services was published in June 2022, setting out the Government policy on Water Services in Ireland. Kildare County Council signed its Master Co-operation and Data Sharing Agreement with Uisce Eireann in May 2023, and Uisce Éireann are now in full control of all aspects of the delivery of water and wastewater

services in County Kildare.

As per its Master Co-operation
Agreement and in support of the
delivery of Water Services functions up
to the end of December 2026, Kildare
County Council are in the process of
agreeing its Shared Support Services
agreement with Uisce Eireann, which
is due for final sign off in Q1 2024.

#### **Environment**

## **Plan for a Circular Economy.**

The Waste Management Act 1996, as amended requires each local authority to make a Waste Management Plan.

The Regional Waste Management Planning Offices, under the auspices of the County and City Management Association, are co-ordinating the preparation of a new Plan on a national basis, titled "National Waste Management Plan for a Circular Economy." A copy of the latest update was recently circulated to each Chief Executive.

The Plan sets out a framework for the prevention and management of waste in Ireland for the period up to 2030,

and it is expected that the new Plan will be implemented in Q1 2024 by Chief Executive Order in each of the Local Authorities.

The National Waste Management Plan for a Circular Economy 2024-2030 is to be launched on Friday 01 March in Limerick.

A National Deposit Return Scheme (DRS) has been launched by DECC. The Deposit Return Scheme (DRS) being introduced is a circular economy initiative, focused on plastic bottles and aluminium/steel cans. The scheme went live on 01 February.

#### **Irish Business Against Litter**



Maynooth topped the rankings as the cleanest town in Ireland by Irish Business Against Litter (IBAL) in their 2023 survey.

Maynooth was commended for attaining a level of cleanliness over the





course of 2023 which 'IBAL "have not encountered in two decades of surveying".



Naas, the top ranking town in 2021 and 2022 also performed well achieving status 'cleaner than European norms."

#### **Christmas Tree Recycling scheme**

This scheme was in operation at seven different sites around the county for three weeks in January. The scheme again proved very popular, with approximately 5,000 trees shredded for composting. In addition, eight different community groups took delivery of loads of mulch to use in community gardens etc. and as a circular economy action, this will be promoted further next year.

#### **Water Framework Directive**

Monitoring and investigation work continue in the water priority areas under the Water Framework Directive. The council awaits the publication of the third cycle of the River Basin Management Plan for the period up to 2027.

This document is expected to be published this year and will set the priorities and areas for action over the next cycle.

#### **Enforcement Priorities 2024**

The National Waste Enforcement
Priorities 2022-2024 were recently
reviewed by the National Steering
Group and a number of changes were
made to reflect these discussions. The
following remain as high-level priorities
in the area of waste enforcement:

- Tackling significant illegal waste activity,
- Construction and Demolition activity,
- End-of-Life Vehicles,
- Waste collection,
- PRI initiatives.

The Kildare County Council
Recommended Minimum Criteria for
Environmental Inspections (RMCEI)
and the 2023 Plan submitted to the
Environmental Protection Agency
(EPA) Kildare County Council was
judged as one of the top performers
Nation-wide in terms of environmental
inspections.





#### **Environment Complaints**

Pollution complaints continue to be investigated in accordance with national guidelines.

#### **GAA Green Clubs Initiative**

A joint project of the civic amenity in conjunction with the proposed Municipal District depot is being assessed.

# Catchment Flood Risk Assessment and Management Study (CFRAMS)

A steering group with the Office of Public Works (OPW) has been established to progress the consultant's brief for schemes within Kildare. The municipal districts will be briefed as schemes from the Catchment Flood Risk Assessment Management (CFRAM's) Programme commence.

#### **Morell Flood Management Scheme**

Construction of this scheme is continuing, with 58% of the scheme completed.

Landscape improvement works are expected to commence during Q1





2024 to open the lands to the rear for future internments.

#### Confey

Works have been recently completed to allocate additional plots for internments within the cemetery.

Athy Cemetery Boundary Wall

Works completed on new boundary wall between the cemetery and the new Athy Southern Distributor Road.

#### Boycetown, Kilcock

Tenders have issued for major drainage improvement works and a letter of intent has issued to a preferred contractor. Works will commence in mid-February 2024.

#### Newbridge

Works were completed on Newbridge Cemetery car park in December 2023 providing a new surfacing, delineated parking, fencing and improved drainage.

#### Monasterevin

Works have been carried out on cutting back shrubs and bushes within the cemetery. Removal of rubbish (stone, clay etc) from the cemetery has also taken place.

# Transport, Mobility and Open Spaces

#### **Transport**

### M4 Maynooth to Leixlip M4 Eastbound Bus Priority Measures

The Part 8 for the M4 Eastbound Bus Priority Measures was presented at the February 2023 Council meeting and was approved. Work is ongoing with Transport Infrastructure Ireland (TII) to progress to construction.

#### **M4** Westbound

The Westbound project will progress to the end of Phase 2. It is likely at that stage that the project will be divided into three areas- Westbound Bus Running, Active Travel and Safety Measures

#### **Athy Main Street (N78)**

Kildare National Roads Office (KNRO) have undertaken a pavement design and safety improvement for pavement improvement works on the existing N78 through Athy town and have also been liaising with Public Realm and Kildare County Council Roads with regard to the Emily Square project. Now that the Athy Distributor Road (ADR) is open, TII are being asked by the Department of Transport (DoT) to

contribute to a more significant public realm type project / one way pilot, through Athy Mainstreet. If agreement can be reached then Kildare County Council Roads Project team will assume responsibility for delivery. Existing N78 to be reclassified - new ADR will become N78 in Athy – DoT / TII in discussion as to further requirements.

#### **Leinster Road Bridges**

Rehabilitation Contract Scheme involves rehabilitation works to M7, Junction 10 Overbridge; M7, Newhall Overbridge; M7 Greatconnell Overbridge; M7 Corbally Overbridge; M9, Kineagh Road Overbridge. Glas Civil Engineering Limited has been awarded this contract.

#### **Athy Distributor Road**

The ADR is now open (31 October 2023). BAM has achieved substantial completion however, snagging work still continues.

## New Machinery Yard Relocation and Regional Salt Barn

Project is nearing completion.

Regional Salt Barn is 99% complete.

Yard is 99% complete. Admin Building is 95% complete. Project has largely





transferred from Capital Project to Implementation phase.

The construction phase of the project is due to be completed by Mid-February 2024 (There was a slight delay due to ESB connection of distribution board – which is now in hand). The IT department will then commence the delivery of IT to the facility in February, with commencement of staff moving to the new offices in March. Insurances (IPB) are in place, furniture has been ordered and arrangements being made for security.

A tender is being prepared for consultancy services for traffic management and operational plans for the site. It is expected that the machinery yard operatives will commence moving into the new facility in May 2024.

#### Maynooth Eastern Ring Road

The CPO has been approved by An Bord Pleanala. The project team is now focusing on completing the CPO administrative procedures, completing the detailed design and compilation of tender documents.

The Economic Development team continues to visit retailers across the county providing them with information on all the supports available.

#### **Skills Audit**

Kildare County Council is evaluating Responses for Quotations from suitable consultancy to undertake a skills audit of County Kildare.

The audit will comprise a detailed analysis of the existing talent and skills within the county and the skills requirements across the county over the medium term. It is anticipated the audit will be completed by April 2024 when, at this point, it will inform Kildare County Council's strategic employment/ industrial land study (currently being undertaken by the councils Forward Planning Department) and the tenderer will then work to deliver a comprehensive report to determine a strategy for the County by June 2024.

### Kildare Diaspora Engagement Strategy

Kildare County Council published its first Diaspora newsletter with a New Year message from Ms. Sonya Kavanagh, Chief Executive Kildare County Council; the newsletter comprised topical stories of interest to Kildare's global population including Brigid 1500, the 'Gather' pop-up shop experience at Kildare Village and a profile of Ernest Shackleton. The Irish World interviewed Paula O'Brien, Senior Executive Officer Community, on behalf of Kildare County Council and its Brigid 1500 program; the Irish World is a leading diaspora publication in the UK.

### Athy Food, Beverage and Skills Innovation Hub

The date for tender submissions passed end-January and the evaluation committee is reviewing the application.

The successful bidder is anticipated to be appointed by late-March once the tender validation and evaluation process has been completed. It is anticipated that the project will be completed in 13 months upon commencement.





### Kilcock Green and Sustainable Enterprise Park Feasibility Study

Upon the completion of a feasibility study, Kildare County Council applied to the Just Transition Fund for potential funding for the proposed development. Progression will be very much subject to the appropriate planning and development regulations be in order.

### Athy Green and Sustainable Enterprise Park Feasibility Study

Upon the completion of a feasibility study, Kildare County Council applied to the Just Transition Fund for potential funding for the proposed development. Progression will be very much subject to the appropriate planning and development regulations be in order.

### Kildare Craft, Creativity and Design Hub, Courthouse Kildare

The consultants have completed feasibility study of the proposed development. Kildare County Council is now reviewing funding options potentially though the Department of Rural and Community Development. Kildare County Council has reached a lease agreement for the deployment of a pilot on a smaller footprint in two

retail units in Kildare Town's Market Square.

### Fashion, Textiles and Design Hub (former BOI Monasterevin)

The consultants have submitted the feasibility study for the building; Kildare County Council has included its proposed development as part of its capital projects and will fund its development should the appropriate planning and development regulations be in place.

#### **Kildare Hub Strategy**

Kildare County Council was awarded
Town and Village Renewal Scheme
(TVRS) funding to assist in the
marketing of the KHUB Network.
In January, the Sunday Business Post
published a two-piece article with
Sonya Kavanagh, Chief Executive

second piece interviewed Hub
Managers throughout the County
offering exposure to their locations and
offerings.
