# Corporate Services Communications

Digital on-line Archives include Town Commissioners' records and Poor Law Union

Kildare and Mountmellick, Co Laois. The first volume records arrears and rents, 1874 to 1875 for the Manors of Fontstown and Monasterevin in Co. Kildare, and Maryborough, Mellifont and Mountmellick in Co. Laois.

 The second volume documents arrears and rents, 1879 to 1888, for the Monasterevin and Mountmellick estates.

These records serve as valuable census substitutes, in the absence of Irish census returns before 1901.

The digitisation of these volumes was funded by the Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media's Commemorations Fund 2024.

Kildare County Council's Local Enterprise Office accredited with creating 323 jobs in 2024 Recent figures released by Minister of Enterprise, Trade and Employment, Peter Burke, T.D., reveal that companies supported by Kildare County Council's Local Enterprise Office (LEO) created 323 jobs in 2024.





Taking into account companies that amalgamated, ceased trading or transferred to Enterprise Ireland, there were 163 net jobs created by LEO Kildare supported clients in 2024.

The tree, a mature Coastal Redwood (Seqouia sempervirens) stood approximately 40ft (13m) tall, with an estimated value of €63,000, and is believed to be over 100 years old, planted back when the park opened in the 1860's, was cut down in the early hours of Monday 27 January, possibly between 4.00-5.00am. The event marked a significant milestone for the community, celebrating the transformation of the former Kerdiffstown landfill into a 30hectare multi use vibrant public space.

Sláintecare Healthy Communities Kildare announced as a successful project for the Traveller Health Initiative



The Minister for Public Health, Wellbeing and the National Drugs Strategy, Colm Burke TD recently announced Athy, Co.Kildare as one of five areas nationally to share in a €710,000 Dormant Accounts fund, to address the social determinants of Traveller health.



Kildare secured the maximum allocation of €142,000, for this two year programme. The successful application was made as part of the Sláintecare Healthy Communities programme, through the Local Development Officer in Kildare County Council. Athy is one of 20 Sláintecare Healthy Community Programmes, established throughout Ireland by the Department of Health, in areas with a higher population of Travellers compared to the rest of the country.

Arts Grants Information Sessions Three grants information sessions were delivered by the Kildare Arts Service in Athy, Maynooth and Naas libraries during January. 19 arts grants are currently live.

First Fortnight: projects supported by Kildare Arts Service First Fortnight is Ireland's national Mental Health Arts and Culture Festival which takes place in January each year. Several events took place in Kildare as part of the festival including STEREO, a performance challenging stereotypes and celebrating the diverse creative expressions of young individuals with Down syndrome. Singer-songwriter Megan O'Neill's new album exploring grief and resilience was also funded by Kildare Arts Service First Fortnight Award 2024.



# Finance

Financial Reports Annual Financial Statement The Annual Financial Statement for year ended 31 December 2024 is currently being prepared and will be completed by 31 March 2025. It will be brought to Council when complete.

Schedule of Uncollected Rates The schedule of uncollected rates was completed in January 2025, the total amount collected on Rates for 2024





The overall collection percentage for 2024 is 92% an increase on the 2023 collection percentage of 88%.

The total amount of rate vacancy adjustments for 2024 is €5m as compared to €3.4m in 2023.

The total amount of rate write-off adjustments for 2024 is €1.1m as compared to €3.1m in 2023.

The total amount of rate waivers for 2024 was €482k compared to €50k rate waivers for 2023.

### **Rates Demands 2025**

The Rate Demands for 2025 will issue in February to all ratepayers.

New legislation regarding commercial rates took effect from 01 January 2024. The Local Government Rates and Other Matters Act 2019 effects the following changes:

• Replaces the payment of rates in two moieties with one rates

amount due on the first of the year

- Replaces the issuing of Property Entry Levy (PEL) and valuations taking effect the year after issue of a schedule (by Tailte Eireann) with immediate billing through the calendar year.
- Provides for the application of interest on unpaid rates from 2025. Interest will be added to rates bills issued from 2026.
- Removes the requirement for public notice to be given regarding Kildare County Council's intention to 'make the rate'. This is replaced by a notice advising that a 'rate has been levied'.
- Removes the requirement for the rate book to be available for inspection, either in paper form or electronically.

# Innovation



### GeoCollect

GeoCollect is a collaboration between our Commercial Rates and Geographical Information Systems (GIS) sections. Kildare is a large and fast-growing county. Keeping abreast of changes to commercial activity is challenging. GeoCollect answers this challenge and will maximise our commercial rates income, which is fundamental to funding the delivery of services to our citizens and communities.

The Good Practice in Local Government event is organised by NOAC (National Oversight and Audit Commission), in collaboration with the LGMA (Local Government Management Agency) and the CCMA (County and City Management Association). The event celebrates outstanding examples of Local Authority Innovation. Each year numerous projects from across the 31 Local Authorities are nominated for the event and this year, GeoCollect has been selected as one of only six Local Authority projects to be showcased at this event.

### **Serviced Sites Scheme**

The Serviced Sites Scheme at Clogherinkoe ran for four weeks in December. Despite an extensive advertising campaign and over 2,000 views on MyHome.ie only 2 expressions of interest were received. The scheme was reopened on 27 January and will remain open for four weeks until midday, Monday, 24 February 2025.

### **Cold Weather Initiative**

A Cold Weather Initiative (CWI) remains in operation up to 31 March 2025 to provide additional emergency beds for rough sleepers where needed. Additional bed capacity is also available under the Extreme Cold Weather Beds. The service is operated by The Peter McVerry Trust on our behalf. Over the recent cold weather period and Storm Éowyn, the Outreach Team actively assisted individuals and families to access services.

Traveller Accommodation Annual Estimate of Accommodation of Traveller Families The annual estimate of the accommodation position of Traveller families for 2024 has been completed. The report is considered and noted by the Local Traveller Accommodation Consultative Committee (LTACC).

# Regeneration - Addressing Vacancy – Overview of 2024

140 vacant property inspections were carried out in 2024.

The targets set for Kildare County Council in 2024 of 70 properties to enter the CPO activation programme and 15 compulsory

purchases/compulsory acquisitions to commence were exceeded, with 99 properties entering the CPO activation programme and 19 compulsory acquisitions commencing in 2024. The Derelict Sites Register transferred from the Environment Department to Housing in 2024. 15 properties have been added to the Derelict Sites register in 2024 and compulsory acquisition under the Derelict Sites Act

commenced for ten derelict properties.

Work has commenced to refurbish properties acquired compulsorily, The Urban Regeneration and Development Fund [URDF] Call 3 programme saw a dedicated fund being made available to local authorities to tackle long term vacant and derelict properties in URDF eligible areas. 56 properties across the eligible towns in the county were identified and approved for inclusion on the Call 3 programme. Compulsory acquisition has commenced on ten of the approved properties. 142 vacant property grant applications were received and processed in 2024.114 applications were approved and 69 grants paid in 2024.





## **Town Centre First**

The Clane Town Centre First Plan was published in April 2024 and work has now commenced in preparing a Town Centre First Plan for Castledermot with the establishment of a Town Team.

Consultants have been appointed to provide support to town teams in Kilcullen and Ballymore Eustace. Following consultation with Local Enterprise Office, an Invitation to Quote has been issued for a consultant to complete a training needs analysis linked to the development of the Textile Hub.

A further three Masterplans are to come in 2025:

Strategic Projects and Public Realm have no defined schedule for funding opportunities to support the progression of these projects, they are released by Government departments several times during the year. To ensure that Kildare County Council can identify a suitable project, prepare a funding application and submit it within the timeframe required, it is necessary to have the Kildare County Council match funding in place. It is also a requirement to have that funding in place for the duration of the project. Some funding models require 20/25% of match funding to be assigned. Other funds, such as the Historic Structures Fund, allows us to recover 50%. Having LPT funding committed by the elected members on an annual basis is key to updating our work programme as other projects progress, ensuring continued project delivery in our towns and villages.

## Relocation for Beneficiaries of Temporary Protection

The Department of Children, Equality, Disability, Integration and Youth (DCEDIY) have indefinitely paused the process of consolidating their portfolio of contracted accommodation for **Beneficiaries of Temporary Protection** around the country. No existing accommodations centres in Kildare have been identified for closure in the short term. Kildare LAIT support individuals and families through relocations. These moves can be incredibly stressful and unsettling, and the role the LAIT plays is mainly ensuring a smooth transition in terms of integration supports. As relocations continue, individuals and families are given the contact details of the LAIT in the county they are relocating to so they can reach out for support directly. In many cases, residents are receiving 48 hours notice of where they are moving to. This is being raised with the DCEDIY and more advanced notice is being sought, where operationally possible, to allow residents to make necessary arrangements in their new locations.

# Accommodation Recognition Payment (ARP)

The Accommodation Recognition Payment (€800 grant) that supports the Offer a Home and pledged properties, is due to end on 31 March 2025.

The ARP is directly linked to the Temporary Protection Directive (TPD) for the protection of individuals fleeing the Ukraine. There are ongoing consultations across Government departments and, as yet no confirmation has been issued that the ARP will continue. Accommodation offered with the benefit of an ARP is a major source of accommodation for Beneficiaries of Temporary protection particularly for residents exiting the Designated Accommodation Centres who have a maximum of 90-days State provided accommodation.

## Recent Developments Resources

Kildare County Council has received approval for one additional permanent post for Integration Support Worker and one 12-month contract post to cover maternity leave of one of the Integration Support Workers.





Moyvalley Hotel and Resort The International Protection Procurement Service (IPPS) in DCEDIY was in has confirmed that they are not continuing negotiations for the establishment of IPAS accommodation at the Moyvalley Hotel and Resort at this time. A number of protests had been held at the entrance to the hotel in recent weeks.

#### Eyre Powell Hotel, Newbridge

Residents of the Eyre Powell have received letters from IPAS confirming that they are to be relocated from that accommodation centre. No further details are available at the time of writing.

# Local Authority Integration Team (LAIT)

## Local Authority Integration Teams | Local Government Ireland

The Local Authority Integration Teams (LAITs) have been set up in all local authorities to facilitate coordination of the different kinds of support available for people who are applying for international protection, refugees, and others in similar situations. The goal of LAITs is to help IP applicants and refugees become independent, settle into their new communities, and participate in Irish life. They do this by connecting people to important services that can help them integrate into the community. The LAIT is part of a national government policy - White Paper to end direct provision (February 2021) - and a new international protection service model grounded on supporting the principles of 'integration from day one'. The LAIT identifies needs through outreach work and clinics in accommodation centres and in the community, and provides the necessary information, advice and guidance so individuals and families can access services locally appropriate to needs.

#### Clinics

Kildare LAIT organises regular drop-in information clinics in IPAS and BOTP centres, that allow service users to access Integration Support Workers on 1:1 basis. This has fostered strong relationships between service users, accommodation providers, and other services. From the 06 - 31 January 2025, Kildare LAIT carried out five outreach visits to UCTAT centres (two) and IPAS accommodation centres (three) and arranged one information



clinic in an IPAS accommodation centre, which was attended by two international protection applicants. The session was focused on immigration and employment. The team has also developed a needs system based on regular communication with service users and accommodation providers that inform how often clinics are arranged at each centre.

#### Queries

From the 06 – 31 January 2025, Kildare LAIT received and solved 26 queries. Out of those, queries were raised by beneficiaries of temporary protection, eight by international protection applicants and two by persons with status. Most queries were related to access to State provided accommodation, employment, DSP financial support, childcare, secondary school education, medical cards, youth work and services, and immigration queries.

Service users have reported ongoing issues with the ISD Online Forms Portal and difficulties experienced when trying to communicate these issues with the International Protection Office (IPO). This has been shared with the LGMA to advocate for a solution, in addition to a dedicated information session for the LAIT's to discuss this directly with the DCEDIY.

#### **Data Sharing:**

Discussions are ongoing between the LGMA and the DCEDIY in relation to a formalised Joint Controller Agreement between DCEDIY and Local Authorities to govern the processing of personal data in LAIT work. In the meantime, all data sharing continues to follow existing KCC policies and GDPR principles.

#### Networking

Kildare LAIT hosted the first Peer Support Network Group Meeting for frontline workers engage in integration (08 January). The meeting took place online and was attended by 12 integration workers including Kildare LAIT Integration Support Workers, Kildare County Council Community Workers, In-Sync, CKLP and Childcare Committee staff. The group will meet every two months.

Moreover, Kildare LAIT attended the Ukraine Forum Meeting (14 January) led by Ukraine Civil Society Forum (UCSF) a national coordination forum of civil society and community responses, connecting into the State's








response structures supporting reception and integration. Discussion around relocations.

Kildare LAIT is included in the Irish Refugee Council (IRC) Support Maps to ensure visibility of Kildare services nationally. Beneficiaries of Temporary Protection (Ukraine): BOTP in State provided accommodation in Kildare: 933 (692 adults/ 241 children) Data source DECDIY – 09 February 2025.


#### National overview of Beneficiaries of Temporary Protection





## International Refugee Resettlement Programme (IRPP)

Through the model for distribution for IRPP Phase II Local Authorities, Kildare County Council has accepted the allocated quota of 66 refugees for 2024-26. The resettlement will be carried out in a combination of AHB and Kildare County Council housing units through various tranches 2024, and the second quarter of 2025. The first resettlement of three families took place at the beginning of October 2024 with two more resettlements due to take place in Q1 2025. The target is to have all 66 participants resettled in Kildare by the end of Q2 2025.

Integration supports are in place with EU funds through the IRPP/DECDIY

with a view to achieving the best possible outcome for each individual and family. County Kildare Leader Partnership (CKLP) was identified by Kildare County Council as an implementing partner through a tender process for the provision of appropriate post-resettlement supports for 18 months through an Integration Support Worker, and an Intercultural Support Worker (in place from the end of July 2024).

The Refugee Resettlement Programme is supported by the Inter-Agency Working Group (IAWG) chaired by Kildare LAIT. The IAWG have met on 01 July and 27 September in 2024 and on 31 January 2025 to coordinate the second resettlement, discuss the integration





supports planned, and start planning for the third resettlement (March 2025). The LAIT Integration Support Coordinator regularly provides updates to all the relevant agencies engaged in the programme.

#### National ISC and ISW Networks

The LAIT continues participating in the Integration Support Coordinators (ISC) and Integration Support Workers (ISW) networks. The aim of these networks is to facilitate the sharing of tools and best practices across LAITs.

## Designated Accommodation Centres (DAC's)

Established to accommodate Beneficiaries of Temporary Protection arriving in the State after 14 March 2024. Kildare has two DAC's:

#### **Punchestown:**

Opened in mid-March with a capacity of 378 people. Current occupancy is 209 people (DCEDIY 10 February 2025).

#### Newhall:

Opened in mid-May with a capacity of 985 people. Current occupancy is 405 people (DCEDIY 10 February 2025). Residents were temporarily decanted from Newhall during Storm Eowyn and transported to Naas GAA club as a precautionary measure.

Kildare County Council integration staff held Day-75 Clinics at the Newhall and Punchestown DAC's on 05 December 2024 accommodation clinics on 17, 18 and 19 December 2024. An accommodation clinic was held in Newhall on 08 January 2025 and a further Day-75 clinic is scheduled for both Newhall and Punchestown on 14 January 2025.

# Accommodation of International Protection Applicants:

The area of responsibility also extends to appraisal of properties referred to Kildare County Council by the International Protection Accommodation Service (IPAS) in DCEDIY for accommodation of IPA's.

A technical working group (TWG) has been established in Kildare County Council to access accommodation proposals referred to Kildare County Council by DCEDIY, IPAS/IPPS and the LGMA and continues to deal with queries related to existing and proposed accommodation.

The Internation Protection Procurement Service (IPPS) in DCEDIY is currently negotiating a contract for the establishment of an IPAS accommodation centre at the Moyvalley Hotel and Resort.

#### The Community Integration Forum

Meetings are taking place the first Wednesday of each month chaired by the Director of Services for Integration. The Community Integration Forum has met 6 times in 2024 on the 01 May, 05 June, 03 July, 04 September, 02 October and 04 December.

A revised format has been agreed with members, and in 2025 meetings will be held bi-monthly with targeted, thematic meetings to address specific items on each alternative month. A meeting of the CIF was held on Wednesday 05 February 2025. The next CIF meeting is scheduled for Wednesday 02 March 2025.

The role of the Community Integration Forum is to enhance information





sharing, collaboration and coordination among service providers to maximise integration supports outcomes. The role of the Community Integration Forum is reflected in the LCDC (Action 1.7.7 KCC-LAIT). Links with the Kildare Integration Strategy Working Group need to be defined. The migrant integration strategy is much broader and implemented through local community strategies. Participation in the CIF includes Kildare County Council (LAIT and Accommodation Team, Community Services, Library Services) Citizens Information Centre, An Garda Siochana Community Policing, County Kildare Leader Partnership, The Irish Red Cross, Kildare County Childcare Committee, Kildare CYPSC/Tusla, Kildare/Wicklow Education and Training Board, **INTREO, HSE Social Inclusion** coordinator, InSync, Local Link, **Regional Education and Learning** Teams Coordinator.

## Climate

Climate Action Regional Office (CARO)



The Climate Action Regional Office (CARO) works to support local authorities to drive climate action in their jurisdictions and coordinate activities to promote effective climate action across the local government sector. For more information on the work of the CARO, see our website at <u>www.caro.ie</u>

Kildare County Council is the host local authority for the Eastern and Midlands (EM) CARO, one of four CAROs working as a shared service within local government on climate. There are 17 local authorities within the EM CARO region.



The CAROs are funded by the Department of Environment, Climate and Communications (DECC) and work through the four lead local authorities by way of a Service Level Agreement (SLA) to mid 2029.

## Local Authority Climate Action Training Programme



Training Service Level Agreement between Kildare County Council and DECC signed as of 01 June 2024. This marks the start of second phase climate training for the sector.

Executive Training Group for oversight of training delivery for 2025 convened its first meeting on 15 January 2025. The group is Chaired by Teresa Walsh Director of Service with South Dublin County Council on behalf of CCMA and group comprises representation





from Climate Ireland, AILG, SEAI, Met Eireann, Heritage Council, LASNTG and CARO. Planning for training delivery underway as follows:

- Fire Services Staff commenced training delivery in August to run until all fire services staff complete. 21/27 have taken up training to date.
- Outdoor staff training commenced in September through regional training centres. Completion of outdoor staff training in Q1 2025.
- Procurement of Learning Management System ongoing.

In addition to the above, 2025 Training Programme targeting:

- Senior Management and Elected Members (in association with AILG).
- New Revised Raising Awareness Programme (online) for all indoor staff.
- Climate Action staff and teams through webinar series.
- Bespoke Urban Water Nature based Solutions training
- Bespoke Green Public
  Procurement training

## Local Authority Climate Action Plans (LA CAP)

Review of all 31 LACAPs to ascertain robust information on action typology, is now complete. A robust central database is in place that can be utilised to identify commonality of actions to support local authorities to work together, to inform of action prioritisation, reveal challenges in implementation, to help identify pertinent case studies and inform reporting and monitoring requirements. A PowerBI module has been used to aid the generation of reports for sectoral stakeholders.

Sub-Regional Energy Projects The EM CARO is working with local authorities in each of the four sub-





regions to develop regional energy units to avail of funding for projects that support the decarbonisation of local authority buildings. The energy units comprise:

Mid-east (Kildare, Meath, Wicklow and Louth), commencing projects and accessing Pathfinder support from SEAI.

Midlands (Laois, Offaly, Westmeath, Longford, Roscommon), have developed their project pipeline and sourced funding to match Pathfinder support.

Border (Cavan, Monaghan, Leitrim) are working with project manager assistance from SEAI to build a project pipeline.

South-east (Carlow, Kilkenny, Tipperary, Wexford, Waterford City and County) have issued a position paper to SEAI for their consideration. Further discussion will continue to progress to MOU stage.

Reimagining Local Authority Fleet The EM CARO supports the reconfigured working group established to explore support and options for local authorities on fleet decarbonisation and is now working to finalise recommendations for the CCMA on support for fleet decarbonisation into the future.



Development of Local Authority Key Performance Indicators (KPIs) on Climate Action



Data collation for 10 KPI's from 2024 was completed on 07 February 2025. This data works to highlight the sectoral performance of the network of local authorities on climate action. Report to be published Mid-year. ## GAA / CCMA Green Clubs Programme:

The EM CARO continues to work with the GAA and expert partners to advance the Green Club Programme.



A recognition event was held in Croke Park on 09 November 2024 to celebrate the work of over 70 clubs from Phase two of the Programme.



Phase three is now open to c 400 clubs to work their way through a range of sustainability and climate action related projects as provided for by Green Club Toolkits covering the five themes of Energy, Water, Waste, Biodiversity and Travel.

Inspiring change, shaping tomorrow

The CARO office provides support to the Climate Action Office (CAO). In turn the CAO assists the functional and operational areas of the council to decarbonise their roles and work through the members of the Climate Action Team and Energy Management Team together with the Senior Management Team.

Kildare County Council Climate Action Plan (with DZ and SECAP (Sustainable Energy and Climate Action Plans) The Decarbonising Zone – 'Show and Tell' house: Launch of the house expected late February or early March.

## Augmented Reality Image Maynooth:

The initial piece has been created and currently exploring how to build on the project further to enable greater understanding and outreach.

Kildare County Council Climate Action Plan (CAP) Implementation Report for Elected Members and Stakeholders:

This is the first report based on the 2024-2029 CAP. It is also the first in the country and will inform other Local Authority's report format with the assistance of the EM CARO.



#### Recruitment

The interviews for the position of Decarbonising Climate Officer took place at the end of January and a panel formed.

### Energy Updates: ISO 50001:

The energy efficient officer and assistant are working diligently toward the time audit dates as follows: Stage 1 Thursday 19 June 2025 Stage 2 Tuesday – Fri 05 – 08 Aug 2025 If successful, the council will be ISO 50001 certified as statutorily required

#### **District Heating (DH)**

Codema are presently finalising the DH feasibility study for Naas and commencing the Maynooth feasibility study. The latter is in conjunction with the Strategic Projects and Public Realm Team with funding from SEAI and URDF.An opportunity is being explored to realise DH in Maynooth and possibly Celbridge area.

#### **DISCO Project:**

'Advancing District Heating and Cooling solutions for efficient waste heat utilisation' in conjunction with CODEMA as associate partner has successfully received 70% Interreg Europe Funding. This will enable the task under action B13 of Kildare County Council CAP to perform a county wide assessment of waste heat and district heating. Work is scheduled to commence after the Maynooth feasibility study is finalised. Formal matching funding agreement being finalised between Kildare County Council and CODEMA.

#### Energy Management Team:

The first meeting of the newly formed Energy Management Team took place on 30 January. Patricia Brennan gave an overview of the council's position to date, projects being advanced, decarbonising path and EPC framework to advance competitive negotiated procedure to undertake works on Naas and Athy swimming pools and Aras Chill Dara.

Libraries – Energy Audits: Review of the audits for Athy and Leixlip libraries have been undertaken, and the documents are being finalised. The documents will help to inform the works to be undertaken.





**SEAI Monitoring and Reporting** 

The requirement to update MPRN's for Council properties was completed by the end of January deadline. Further reporting will be required in May.

## Staff use EV (Electric Vehicles) GoCar

The dedicated charge point has now been installed and commissioned.

#### SMT presentation:

A summary report of Kildare County Council's energy review will be given by Patricia Brennan on 18 February.

People's Patches/'Our Shared Plate Project' for Community Climate Action:



The project is going from strength to strength with three active community efforts in Maynooth, Newbridge and Athy. Maynooth University continues to monitor the social effects and Neighbourhood Networks are advancing plans with the groups to create community gardens. The 18month programme will see the planting of trees this winter, edible hedges and vegetables in the spring.

## Community Climate Action Program Fund:

Twenty-four projects were approved by the Department of Environment, Climate and Communications (DECC) for the Community Climate Action Fund grant. Grantees have 18 months to complete the projects and in the time since the grants were finalised in September, four of the projects have already been completed. The first recoupment from DECC was completed in early December and covered approximately €200,000 of the total allocation of €897,000. The next drawdown by groups is the end of February.

When all the projects are completed 635 solar PV panels will have been installed as well as pumped wall insulation for four social housing units and two community halls. Other projects focus on replacing floodlights or pitch walkways with LED bulbs. A number of biodiversity measures will also be implemented, including native tree planting and the installation of swift nest boxes.



DECC have indicated that they will be finalising the second iteration of the grant in 2025 for climate projects for community groups in the county next year. As there are some geographic and demographic gaps in the county in the applications for the first round, it is proposed to highlight the scheme to these groupings to improve participation.

#### **Climate Design Lab:**

Logo being developed to advance link to initiatives on site and social media. Artists position to be advertised during January in conjunction with the Arts Officer.

Co-creative events with the wider community planned for late February.

#### **Climate Innovation Fund 2024:**

Depending on LPT discussion we hope to be able to run the fund again in 2025.

## Grass to Gas and Alternative Maintenance:

The project has been extended out to January/February 2025 as a little more time is required to complete aspects. Maynooth University wish to provide an informative session on the dashboard to full Council and SMT in April. Also, CARO are hoping to have a webinar based on the work to date.

### Water Services

#### Water Action Plan 2024

The Water Action Plan is Ireland's third River Basin Management Plan and it outlines the measures the Government and other sectors – local authorities, public sector agencies, public and private sector companies, environmental organisations, farm organisations, etc - are taking to improve water quality in Ireland's groundwater, rivers, estuaries and coastal waters.

#### Environment

National Waste Management Plan for a Circular Economy The Waste Management Act 1996, requires each local authority to make a Waste Management Plan. The Regional Waste Management Planning Offices, under the auspices of the County and City Management Association, co-ordinated the preparation of the National Waste Management Plan for a Circular Economy 2024-2030. The Plan sets out a framework for the prevention and





management of waste in Ireland for the period up to 2030.

The NWMP for a Circular Economy 2024-2030 was formally launched on 01 March 2024.

The Plan has reviewed the current waste management situation in Ireland and used key drivers and policy proposals to project future trends to identify a range of challenges to be managed over the lifetime of the Plan. The Plan now sets out policy responses and actions to address the current and future challenges identified and provides a delivery roadmap to help navigate the Plan period

National Deposit Return Scheme The National Deposit Return Scheme (DRS) was launched by the Department of Environment, Climate and Communications in February 2024. The DRS is a circular economy initiative, focused on plastic bottles and aluminium/steel cans.

The scheme is operated by Deposit Return Scheme Ireland (DRSI) CLG trading as Re-turn. Larger retailers have installed Reverse Vending Machines (RVM's) at their premises to automate the deposit return process. Smaller retailers will operate the scheme on a manual, over-the-counter basis.

From 01 June, all stock not branded with the Re-turn logo has been phased out of shops and consumers are now only able to buy drinks for which a deposit is payable.



Re-turn, the operator of Ireland's Deposit Return Scheme (DRS), Last week announced the milestone of 1 billion drinks containers returned by the public under this scheme.

The local government sector has the responsibility for monitoring compliance and enforcement of the Deposit Return Scheme.





#### **Entente Florale 2025**

Kildare County Council is supporting the nomination of Maynooth in the Large Town Category for the Entente Florale Europe Competition in 2025. An on-site briefing from reps of the Department of Rural and Community Development has taken place along with representatives from the Maynooth Tidy Towns group.

#### Water Framework Directive

Monitoring and investigation work continue in the water priority areas under the Water Framework Directive. The council awaits the publication of the third cycle of the River Basin Management Plan for the period up to 2027. This document is expected to be published this year and will set the priorities and areas for action over the next cycle.

#### **Enforcement Priorities 2025**

The NEP's have been reviewed and there is a reduction in the number of priorities for 2025, moving from 20 in 2024 to 15 in 2025. The breakdown is as follows:

**Environmental Enforcement** The Environmental Protection Agency (EPA) published its report on the environmental enforcement performance of local authorities in 2023 on 03 December. The EPA's Local Authority Performance Framework measures and reports on performance against National Enforcement Priorities, focused on improving environmental compliance and achieving positive outcomes for water quality, air quality and waste management. The report shows that the scale of environmental enforcement work carried out by local authorities in 2023 was significant. For the second consecutive year, Kildare County Council was the only local authority in the country to achieve a "Strong or Excellent" score across all 20 National **Enforcement Priority categories**

#### **Veterinary Services**

Transfer of services undertaken by Local Authorities under its SLA with FSAI including official controls of Local Authority slaughter plants is transferring to the Department of Agriculture Food and the Marine (DAFM). Statutory responsibility for these services has moved to DAFM with effect from the 01 January 2025

#### **Green Schools**

Renewal visits to all the eligible schools have commenced for the 2025 Green Schools programme. Schools have until the end of March to book in their renewal visits. All successful schools will receive their flags in the Green School award ceremony in May.

#### **GAA Green Clubs Initiative**



Cappagh GAA club is the pilot club for Kildare for this national initiative. The next phase of the project involves reducing waste arisings within the clubhouse and work on this is continuing.

#### **Christmas Tree Recycling**

360 tonne of mulch from trees was collected during the Christmas tree recycling initiative this year.

Flood Risk Management Catchment Flood Risk Assessment and Management Study (CFRAMS) A steering group with the Office of Public Works (OPW) has been established to progress the consultant's brief for schemes within





Kildare. The municipal districts will be briefed as schemes from the Catchment Flood Risk Assessment Management (CFRAM's) Programme commence.

Morell Flood Management Scheme Construction of this scheme is continuing.

## Sustainable Drainage Systems (SuDS) Guidelines.

New Sustainable Drainage Systems (SuDS) guidelines have been published. The preparation of the guidelines was an action of the newly adopted County Development Plan. The document establishes a strong vision for implementing excellent SuDS in County Kildare through the planning process and for the lifelong maintenance of SuDS landscapes.

#### Kerdiffstown Park project

The official opening of Kerdiffstown Park took place on 31 January. The event was attended by Secretary General of the Department of Climate, Environment and Energy, Oonagh Buckley, Minister of Further and Higher Education, Research,





Innovation and Science, James Lawless TD and Minister for Agriculture, Food, Fisheries and the Marine, Martin Heydon TD, along with 400 pupils from the local Scoil Bhríde in Kill who formed a St Brigid's Cross to mark the occasion.



#### **Cemetery Capital Programme**

This programme, which includes cemetery extensions, capital type internal improvements and proposals for columbarium walls is currently being reviewed in line with funding availability.

#### **Columbarium Walls**

Columbarium walls have been substantially completed in Athy, Leixlip Confey, and St. Conleth's Newbridge cemeteries.

## Cemetery Works Staplestown

Landscape improvement works have commenced in the new extension to Staplestown Cemetery. Civil improvement works are ongoing in terms of road surfacing, drainage, kerbing, and general landscaping.

#### Boycetown Kilcock

Works were completed in Boycetown cemetery to help alleviate the ongoing drainage problems. Additional road and pathway resurfacing works as well as landscape improvements were also carried out as part of the project.

#### Ballybracken

Additional plinths are planned at this cemetery to facilitate burials.

### Legislation XL Bully Type dogs

The last date for receipt of applications for exemption certificates was 31 January, 2025. This certificate is unique to each XL Bully type dog and owner. It is now illegal to own an XL Bully dog without a certificate of exemption.





## Local Community Development Committee

#### February 2025

The next meeting of the Local Community Development Committee (LCDC) is scheduled for 12 February 2025. The previous meeting was held on the 27 November 2024 in Merits.

SICAP - Social Inclusion and Community Activation Programme County Kildare LEADER Partnership are contracted by the LCDC to implement SICAP 2024-2028 in Kildare.

Both the SICAP annual review 2024 and SICAP plan 2025 were submitted in January. The SICAP budget 2025 is €1,425,342. Both the review and plan 2025 will be considered at the upcoming LCDC meeting. An audit of the programme 2023 by Kildare County Council in line with requirements is concluded. In addition the SICAP 2023 programme was audited by LGAS. This is concluding. # Local Enhancement Programme 2025

#### **R448 National Cycle Network Pilot**

Tender recommendation report is due for review ahead of the appointment of a contractor. Works will commence following the completion of the appointment process.



## Road Safety Speed Limit Review

The implementation date of the rural local road default speed limit of 60 was 07 February 2025. Subsequent phases (i.e. urban speed limit of 30kph and national secondary speed limit default of 80kph) are scheduled to be implemented in 2025.

The Municipal District offices continue to deliver a significant volume of LPT funded projects, improving roads, footpaths and associated works throughout the county.

#### **General Maintenance**

Kildare County Council maintains in excess of 2,600 kilometres of National Secondary, Regional and Local roads throughout the county. Included in this work are road surface repairs, footpath repairs, drainage maintenance, sign maintenance, road marking renewals





and the delivery of the Road Opening Licence system (ROL).

#### **National Roads**

Allocation: €22,386 for N78/N81 for the general maintenance of both National Secondary roads completed in 2024.

#### **Public Lighting**

Kilaree Lighting Services are the public lighting maintenance contractor. Public lighting faults should be logged on the following website:

The PLEEP (Public Lighting Energy Efficiency Project) is ongoing, with significant survey works completed across all five municipal districts Works are due to commence in 2025.

## Machinery Yard and Regional Salt Barn

Vehicle servicing and associated works have been transferred to the new facility, with road salting being the focus of operations over the winter months. Tender for the supply of telematics (GPS tracker systems) to all vehicles has been completed with the installation process ongoing. Five electric vehicles and a velocity patcher to assist in the delivery of services across the Municipal Districts are now in operation.

#### Winter Maintenance

Winter maintenance operations commenced for the 2024/2025 season. Recent severe weather, with both snow, ice and freezing temperatures required the services of 30 drivers to treat the primary routes in Kildare in accordance with the Winter Maintenance Plan. This work continued from Saturday 04 January to Friday 10 January on a 24-hour basis. Due to the extreme nature of this weather event, footpaths at schools and town centre locations were salted and secondary routes treated, using all available Transportation outdoor staff. Approximately 1,300 tonnes of salt was used over this period.

Sustainable Transport (2025 NTA Allocations) Royal Canal Greenway (Maynooth-Leixlip) 2025 Allocation: €3,000,000 Construction ongoing – due for completion by early Summer 2025.





Green Lane Active Travel Scheme 2025 Allocation: €250,000 There was insufficient grant allocation to commence the construction works in 2025. It is intended to proceed with accommodation works along the route in anticipation of an increased allocation in 2026 for the scheme.

# Naas to Sallins Greenway (Naas Harbour to Sallins)

Kilcullen Road Active Travel Scheme 2025 Allocation: €100,000 Work is complete and retention monies to be paid.

## Celbridge Active Travel Bridge 2025 Allocation: €300,000 Detailed design of bridge structure progressing with a view to having construction documents completed in 2025.

Dublin Road Active Travel Scheme 2025 Allocation: €50,000 Construction documents are ready for Phase 1 of the works, subject to NTA approval and funding in 2026.

Bus Stop Enhancement Programme 2025 Allocation: €500,000 List of key sites being prepared to progress the prioritising of work across the county. Preparations are being made for the new Local Link 888 Route as a template process for future works.

National Roads Office M4 Maynooth to Leixlip M4 Eastbound Bus Priority Measures The M4 Eastbound Bus Priority Measures are being constructed by the TII MMaRC contractor. Progress to date includes drainage works, safety barriers and construction of the ERAs (emergency refuge areas) see photo below.



The expected completion date for the first phase of the project (Junction 5 to





6) is April 2025. Legislative changes are required to allow buses travel in the hard shoulder and the preparation of the new legislation is with the Department of Transport and TII.

## M4 Maynooth to Leixlip M4 Westbound Bus Priority Measures

Arup are progressing with Phases 3 (Design and Environmental) for the M4 Westbound Bus Priority Measures.




#### **Fire Safety Certificates**





The ED and LEO team hosted this masterclass on Thursday 16 January in MERITS; the session equipped the 32 attendees from local SMEs in navigating the technical aspects of national procurement portals (etenders and SupplyGov) and how to bid for tenders in an effective manner. The masterclass was a direct follow on from Kildare County Council's Public Procurement Briefing Day which was delivered in late-November 2024, which provided guidance on Irish public procurement and overviews of procurement plans of five Kildare County Council departments.

#### European Projects

Erasmus+ Repower Regions
 This three-year project formally
 commenced in December.
 Kildare County Council, as project
 coordinator, hosted the first online
 meeting on 28 January where work
 packages and deadlines were
 addressed.

The first in-person meeting will occur in Kildare 19 – 21 March; agenda will follow to align with project work packages as well as site visits to facilities demonstrating innovation in heating and cooling systems.

 Erasmus+ Young Equine Innovators

This three-year project (comprising five partners) is completing its work packages in accordance with the project objectives. An online meeting occurred on 21 January where partners provided updates on work packages relating to trends across Europe's equine sector.

#### Kildare COUNTY COUNCIL

#### **County Kildare Skills Audit**

The skills audit of the County will be published and circulated to Elected Members in February 2025. Kildare County Council, in partnership with County Kildare Chamber, commissioned KPMG in 2024 to undertake an audit of the County's current and future skills and training requirements through a series of consultations with key stakeholders, employers, trainers, and employees.

Fashion, Textiles and Design Hub Part 8 submissions period for the proposed Fashion, Textiles, and Design Hub closed on the 10 December 2024. All submissions received were collated and a Submissions Report was created and forwarded to the Planning Department. This report will be used to form the Planning Report and Chief Executive Report which will be presented to the Elected Members at the Kildare/Newbridge Municipal District Meeting in February 2025 for decision. Procured Architectural lead to commence development of detail design, costs, and review outcomes: prepare construction tender documents, assess tender returns and

recommend successful tenderer; progress operations on site and close out of project upon outcome of Part 8 process.

## Athy Food, Beverage and Skills Innovation Hub

Construction works have entered week 39. 58.5% of construction programme has been completed.



#### **MERITS** Innovation Hub

MERITS is now operating at 97% occupancy across the Founders Lab, hot desks and office spaces. Meetings, events and the use of the Content Creation Lab continue apace. A number of resident businesses have expanded to the point of needing to exit the hub into their own dedicated space though some delays are being experienced resulting from a lack of available office space in the local area.

The VECTOR Digital Arts Residency, run in partnership with Kildare County Council Arts Service, has commenced with the successful artist – 1iing Heaney – having started working in MERITS on her project portfolio of digital art, technology, and ecology.

# National Equine Innovation Centre (NEIC) Hub

The NEIC is now operating at 100% capacity across office space and hotdesks. Collaborations are being developed between resident clients in some cases and clients are integrating with the tourism opportunities being developed by Thoroughbred Country, also based in the hub.

#### Athy Enterprise Centre (AEC) Hub

The AEC hub is now utilizing all available capacity. More capacity is being developed onsite. Security upgrades are being investigated and costed with a view to implementation in Q2. The outcome of a funding application is awaited from Pobal (Dormant Accounts Fund) which would see the creation of a pilot Paint Reuse Facility in the Hub. Works will commence in Q2 on the installation of an EV charging station at the hub.

#### Tourism

# EU JTF – Regenerative Tourism and Placemaking Scheme Fáilte Ireland have updated the role and responsibilities for the next phase of the tourism activation programme. The activators met as a team on 29 January to agree a common network roadmap and progression pathway. This proposal was presented to Fáilte Ireland on 06 February. It will then be shared with local authorities, tourism officers and destination marketing companies in the relevant areas so that local activities can be agreed collaboratively and without duplication.





In County Kildare, a calendar of activities is being prepared, and procurement processes are being set up for tourism client business development supports. This will include supporting the quarterly network events with INTO Kildare. These networking events will connect new and emerging tourism providers with an established network. These events will be scheduled to take account of seasonal factors, the enterprise supports calendar and regional tourism enterprise supports.

#### Athy Circular Economy Hub (ACEH)

The AECH hub will be constructed in the CBS in Athy once sufficient funding received. An initial tranche of funding has been secured from Pobal which will facilitate some upgrade works. This hub will house the Paint Reuse Facility, pending the success of the pilot scheme. In time, will also be home to a bicycle repair and upcycling workshop, training and development programmes based around the circular economy and other "green" initiatives.
