Kildare County Council signs Works Contract for Barrack Close Housing Project



Kildare County Council has today signed a contract appointing Suirside Construction Limited as the Main Contractor and Project Supervisor Construction Stage (PSCS), for the Barrack Close housing project located on Woodstock Street, Athy, Co Kildare.





The Part VIII design was completed by the Kildare County Council Architects Department. The construction stage design team is led by Vincent Hannon Architects (VHA) with the other design team members including Tom Mc Namara, Quantity Surveyors, Tobin Consulting Engineers (Civil and Structural+ PSDP), Coffey Consulting Engineers (Mechanical, Electrical and BER) and Cunnane Stratton Reynolds (Landscape Architects).

The project involves the construction of five new social housing units, known as Barrack Close, and the refurbishment of the existing Glandore House to bring this property back into use. The project is funded through the Social Housing Investment Programme (SHIP), via the Department of Housing, Local Government and Heritage and is scheduled for completion in 2025.

Commencement of works, Mill Street, Maynooth

Kildare County Council is delighted to announce that Glas Civil Engineering has been awarded the Mill Street Active Travel Contract. This project includes a comprehensive upgrade of Mill Street, spanning from the Leinster Street /Main Street junction to the Kilcock Road / Moyglare Road junction.

Kildare County Council remind landowners and occupiers of the restrictions on cutting hedges and clearing vegetation on uncultivated lands from 01 March to 31 August. These restrictions are in place to protect nesting birds, as outlined in Section 40 of the Wildlife Act 1976, amended by the Wildlife (Amendment) Act 2000 and the Heritage Act 2018.

Hedgerow cutting is permitted from September to February, when hedgerows are dormant.

Kildare Creative Ireland Bursary Award 2025

Applications for the Kildare Creative Ireland Bursary Award 2025 closed on 07 March.

An assessment panel will meet in mid-March. The number of applications has significantly increased from previous years.

Shortlisted applicants are liaising with the Creative Communities

Engagement Officer to submit a full project plan and proposal. These targeted community-based projects compliment a wider programme of free workshops and creative events in Kildare libraries and arts venues.

Creative Communities Evaluation meeting

On 20 February Sheila Deegan (APO Creative Ireland) and Caomhín Corrigan (evaluator from M.CO) met with Kildare County Council's Culture and Creativity Team to evaluate Creative Communities 2023-2027 which is taking place across all counties. This meeting included a presentation regarding the strategic direction of Creative Ireland, data from Kildare County Council's 2023 programme, and discussions regarding how these projects and others have enabled change and impacted on communities and the local authority. Further evaluation will occur later this year.





Kildare County Archives and Local Studies

The archivist is assisting IS with the development and testing of Kildare County Council-Files, a physical file management app for current and non-current files.

The ninth annual Irish Military Seminar is taking place in Riverbank Arts
Centre on Friday 16 and Saturday 17
May 2025. The programme again features a stellar line-up of speakers exploring a wide range of topics relating to Irish military history. The Local Studies Librarian facilitated an Irish language tour of the collections during Seachtain na Gaeilge.

Kildare Arts Service Funding Approved for Creative Movement Project

Kildare Arts Service, in collaboration with Kildare Sports Partnership, were successful in their proposal for funding through Kildare's 2025 Creative Communities programme. €15,000 will support the proposed project of demarcating a number of 'movement zones' in public spaces, that will be 'activated' through a series of fun, creative and active interventions that

draw attention to physicality and movement in response to Creative Ireland's key strategic priority of enhancing wellbeing through creative participation. This proposal aims to function as a catalyst in inspiring and engaging new audiences while bridging gaps between artistic and sporting communities in County Kildare.

Municipal Art Collection, Evie Hone Stained Glass, Loaned for National Gallery Exhibition

Three Small Fishes, a stained-glass panel by Evie Hone (1894-1955), which is part of Kildare Art Service's Municipal Art Collection has gone on loan to the National Gallery of Ireland, an upcoming exhibition Mainie Jellett and Evie Hone. The Art of Friendship which will run from 10 April - 10 August 2025.

Kildare Arts Service Bursaries for Performing Arts Forum Gathering

Annual Financial Statement

The Annual Financial Statement for the year ended 31 December 2024 shows a surplus for the year of €7,204 and will be submitted to the Department of Housing Local Government and Heritage by 31 March 2024 in accordance with statutory requirements. The Annual Financial Statement for 2024 is now subject to audit by the Local Government Auditor.

Cashflow / Overdraft

Kildare County Council manages its cashflow requirements daily and did not avail of its overdraft facility in January or February 2025.

Innovation

The organisation is currently in the second cycle of Lean Six Sigma. A further 18 staff undertook training in this continuous improvement methodology and are working on eight improvement projects in areas including etranslation, climate reporting, capital project mapping, a new starters training platform, a library data dashboard and standardisation of National Transport Authority reporting.

Second Hand Acquisition Programme 2025

Minister Browne has announced €325 million in funding for a secondhand acquisition programme in 2025.

Priority categories for funding are:

- Tenant in Situ
- Older Persons and Persons with a Disability
- Exits from Homeless Services
- Buy and Renew which tackles vacancy

In terms of the Tenant in Situ local authorities are required to prioritise acquisitions for families with children, older persons or people with a disability who are at serious risk of homelessness where a valid notice of termination has been issued due to the landlord's intention to sell. Properties may only be purchased in cases where a tenant has been in receipt of HAP or RAS support on the property for at least two years. The council will not be entitled to claim any refurbishment costs on Tenant in Situ acquisitions. Properties included in the 2024 acquisition programme where the sale

did not conclude in the year will be funded from the 2025 Acquisition Programme.

We are awaiting receipt of a circular detailing the specifics terms of the scheme and the council's allocation under the scheme and will keep the Members updated.

Affordable Purchase Scheme at Hereford Park, Leixlip

Hereford Park Affordable Purchase
Scheme was launched on 04 March,
and applications are being accepted
via an online application portal, which
remains open for a period of three
weeks. This is the first Part V
affordable scheme in County Kildare, it
delivers 16 houses at a 30% discount
from the market rate. To date we have
received 105 complete applications.

The prices of the units are as follows:

- Two Bed, from €310,000-€320,000
- Three Bed, from €343,000 €355,000

Integration

General

Relocation for Beneficiaries of Temporary Protection

Kildare County Council were informed that the Department of Children, Equality, Disability, Integration and Youth(DCEDIY) had indefinitely paused the process of consolidating their portfolio of contracted accommodation for Beneficiaries of Temporary Protection around the country. No existing accommodations centres in Kildare had been identified for closure in the short term.

Kildare County Council were informed on 12 March of the relocation of 79 Beneficiaries of Temporary Protection including 14 children from the Hubble Living, Dublin to the Kill Equestrian Centre on 14 March. Kildare LAIT support individuals and families through relocations. These moves can be incredibly stressful and unsettling, and the role the Local Authority Integration Team (LAIT) plays is mainly ensuring a smooth transition in terms of integration supports. As relocations continue, individuals and families are given the contact details of the LAIT in the county they are relocating to so they can reach out for support directly. In many cases, residents are receiving 48 hours notice of where they are moving to. This is being raised with the DCEDIY and more advanced notice is being sought, where operationally possible, to allow residents to make necessary arrangements in their new locations.





Accommodation Recognition Payment (ARP)

The Accommodation Recognition

Payment (€800 grant) that supports
the Offer a Home and pledged
properties, is due to end on 31 March
2025.

The ARP is directly linked to the Temporary Protection Directive (TPD) for the protection of individuals fleeing the Ukraine. There are ongoing consultations across Government departments and, as yet no confirmation has been issued that the ARP will continue. Accommodation offered with the benefit of an ARP is a major source of accommodation for Beneficiaries of Temporary protection particularly for residents exiting the Designated Accommodation Centres (DAC) who have a maximum of 90-days State provided accommodation.

Recent Developments Newhall Designated Accommodation Centre

The Newhall DAC will close on 28 March 2025. Any residents remaining at that time will likely be relocated to the Punchestown DAC or to a new DAC opened at Wallslough, Kilkenny (capacity of 280 people).

Eyre Powell Hotel, Newbridge

Design work is continuing to address fire safety requirements related to the basement area of the property. The overall occupancy of the building has been reduced to 61 people.

Local Authority Integration Team (LAIT)

Local Authority Integration Teams | Local Government Ireland

The Local Authority Integration Teams (LAITs) have been set up in all local authorities to facilitate coordination of the different kinds of support available for people who are applying for international protection, refugees, and displaced persons. The goal of LAITs is to help IP applicants and refugees become independent, settle into their new communities, and participate in Irish life. They do this by connecting people to important services that can help them integrate into the community. The LAIT is part of a national government policy - White Paper to end direct provision (February 2021) - and a new international protection service model grounded on supporting the principles of 'integration from day one'. The LAIT





identifies needs through outreach work and clinics in accommodation centres and in the community, and provides the necessary information, advice and guidance so individuals and families can access services locally appropriate to needs.

Clinics

Kildare LAIT organises regular drop-in information clinics in IPAS and BOTP centres, that allow service users to access Integration Support Workers on one to one basis. This has fostered strong relationships between service users, accommodation providers, and other services. From the 06 January -12 March 2025, Kildare LAIT carried out 16 information clinics in accommodation centres, attended by 98 people. Three clinics were conducted in the first week of March 2025. The LAIT have fostered strong relationships between service users, accommodation providers, and other services, and have developed a needs system based on regular communication.

Newhall 90-Day Designated
Accommodation Centre (DAC)

will close on the 28 March 2025. The LAIT have supported Newhall residents since the centre opened. The LAIT facilitated coordination meetings between Pastures New and relevant local services and facilitated and coordinated the initial access to the centre. To date, the LAIT has organised 19 information clinics in Newhall, and solved 260 queries raised by residents, mostly related to accommodation, employment, transport, immigration, disability, education, supplementary welfare, and health. The LAIT have directly assisted 99 residents to access local services and facilitated group sessions on topics such as primary and secondary education in Ireland. The LAIT have worked very closely and collaboratively with Newhall staff and management, who have participated in various trainings organised by Kildare LAIT, including training on the international protection system in Ireland and on how to counteract the far-right movement in our communities.

Queries

From the 06 January – 12 March 2025, Kildare LAIT received 486 queries and solved 478 queries. The first week of





March 2025 the LAIT received 58 queries and resolved 55. Out of those, 80 queries were raised by beneficiaries of temporary protection, 18 by international protection applicants and 12 by persons with status. Most queries were related to immigration assistance, access to accommodation, employment, and education, recognition of foreign qualifications, school transport, medical cards, and language support.

Activities

Kildare LAIT organised an Information Session on Social Housing (HAP) jointly with the Kildare County Council Housing Team and an awareness session with the HSE Social Inclusion Team, targeted at managers and staff in emergency accommodation centres in Kildare. A total of 15 persons participated including six managers from IPAS centres. The session took place on 18 February 2025 in Áras Chill Dara.



To mark the International Day for the Elimination of Racial Discrimination on the 21 March 2025, the Local Authority Integration Team (Kildare LAIT) is inviting Kildare County Council staff to wearing red and meet in the main entrance to show their support to the anti-racism campaign (Wear Red Day | Immigrant Council of Ireland) and opposition to racism, xenophobia, and far-right ideologies. This follows similar events last year, including a training on intercultural competency and antiracism in collaboration with the Immigrant Council of Ireland, and two workshops on understanding how the far right operates and how to counteract disruption within our communities facilitated by the Hope and Courage Collective.

The event to mark International Day for the Elimination of Racial





Discrimination follows Kildare County Council passing a motion, in its February 2025 meeting, to commit to eliminate discrimination and "promote equality of opportunity, and protect the human rights of its members, staff, and the persons to whom it provides services". The motion was jointly brought by Councillors Peter Melrose and Chris Pender, formally stating that "the council affirms its commitment to eliminate discrimination, and provides training for staff and elected members on, Section 42 of the Irish Human Rights an Equality Commission Act 2014, which seeks to eliminate discrimination". The motion followed an election pledge as part of the #CheckTheFacts campaign by Belong To, which was developed by the youth organisation in response to the increase in misinformation and disinformation, and the contribution of both to the erosion of human rights, both in Ireland and internationally.

Networking

Kildare LAIT actively participated in the LAITs National Network Event organised by the LGMA on the 26-27 Feb. This was a two-day programme designed specifically for Integration

Support Coordinators (ISCs) and Integration Support Workers (ISWs) in local authority integration teams (LAITs) across the country. The programme included one day conference on integration supported by the Immigrant Council of Ireland (26 Feb). The network event was attended by the Department of Children, Disability and Equality.

Kildare LAIT continues participating in the Integration Support Coordinators (ISC) and Integration Support Workers (ISW) networks. The aim of these networks is to facilitate the sharing of tools and best practices across LAITs. Kildare LAIT continues participating in the National Asylum Support Network (meeting held on the 12 February) and the National Ukraine Civil Society Forum (meetings held on the 11 February and 12 March) connecting civil society and community responses into the State's response structures supporting reception and integration. UCTAT and IPAS will be transferred from DCEDIY to the Department of Justice, Home Affairs and Migration, headed by Jim O'Callaghan, with Colm Brophy as Junior Minister for





Migration. Around 2,000 staff will be relocated.

Kildare LAIT had an initial engagement with Tusla Aftercare Separated Children Seeking Asylum through the LGMA to increase communication and coordination regarding age out minors moving from Tusla care into IPAS accommodation.

Kildare LAIT is working closely with Kildare Sports Partnership and the Immigrant Council of Ireland to engage local sports and GAA clubs in the Show Racism the Red Card Programme that has been operating in Ireland since 2007. In 2021, the programme was relaunched under the leadership of the Immigrant Council of Ireland. This is an educational initiative that uses different sports as a vehicle to combat racism and raise awareness in primary and secondary schools, youth groups and sporting. The programme is supported by the Ireland Against Racism Fund overseen by the Department of Children, Disability and Equality.









Current IPAS Accommodation Overview

International Refugee Resettlement Programme (IRPP)

Through the model for distribution for IRPP Phase II Local Authorities, Kildare County Council has accepted the allocated quota of 66 refugees for 2024-26. The resettlement will be carried out in a combination of Approved Housing Bodies (AHB) and Kildare County Council housing units through various tranches 2024, and the second quarter of 2025. The programme has resettled a total of 24 adults and children (five families) in two locations. These were completed in October 2024 and January 2025.

Families participating in the programme receive direct integration supports funded by AMIF (EU funds) through the IRPP/DECDIY with a view to achieving the best possible outcome for each individual and family. County Kildare Leader Partnership (CKLP) was identified by Kildare County Council as an implementing partner through a tender process for the provision of appropriate postresettlement supports for 18 months through an Integration Support Worker, and an Intercultural Support Worker (in place from the end of July 2024).





The Refugee Resettlement

Programme is supported by the Inter-Agency Working Group (IAWG) chaired by Kildare LAIT. The IAWG have met on 01 July and 27
September in 2024 and on 31 January 2025 to coordinate the second resettlement programme, discuss the integration supports planned, and plan for subsequent resettlements in Q1 and Q2 2025. The LAIT Integration Support Coordinator regularly provides updates to all the relevant agencies engaged in the programme.

The LGMA initiated at the beginning of 2025 a Working Group with all LAITs and local authorities participating in the IRPP to share good practice and lessons learned. Kildare LAIT has participated in two meetings arranged by the LGMA for this purpose and shared lessons learned and standardised practice and protocols.

Accommodation Team Offer a Home Scheme

The Accommodation Team manage the Offer a Home Scheme in County Kildare in conjunction with the Irish Red Cross (IRC) and International Organisation for Migration (IOM). (update 27 January 2025 – note that the supply of offers for OAH and pledged accommodation has reduced significantly due to the uncertainty regarding continuation of the ARP scheme)



Newhall:

A St. Patrick's Day event is being held in the Newhall DAC on Friday 14 March. Local elected representatives and local residents have been invited. The centre management have also arranged for residents to participate in the St. Patrick's Day parade in Newbridge on 17 March.

A Day-75 clinic was held in Newhall on 11 March to assist residents with sourcing of accommodation.





Punchestown:

The numbers accommodated in Punchestown is expected to increase with the closure of the Newhall DAC on 28 March.

Accommodation of International Protection Applicants:

The area of responsibility also extends to appraisal of properties referred to Kildare County Council by the International Protection
Accommodation Service (IPAS) in DCEDIY for accommodation of IPA's.

A technical working group (TWG) has been established in Kildare County Council to access accommodation proposals referred to Kildare County Council by DCEDIY, IPAS/IPPS and the LGMA and continues to deal with queries related to existing and proposed accommodation.

The Community Integration Forum (CIF)

Meetings are taking place on the first Wednesday of each alternative month chaired by the Director of Services for Integration with targeted, thematic meetings to address specific items. The role of the Community Integration Forum is to enhance information sharing, collaboration and coordination among service providers to maximise integration supports outcomes. The role of the Community Integration Forum is reflected in the LCDC (Action 1.7.7 KCC-LAIT). Links with the Kildare Integration Strategy Working Group need to be defined. The migrant integration strategy is much broader and implemented through local community strategies. Participation in the CIF includes Kildare County Council (LAIT and Accommodation Team, Community Services, Library Services) Citizens Information Centre, An Garda Siochana Community Policing, County Kildare Leader Partnership, The Irish Red Cross, Kildare County Childcare Committee, Kildare CYPSC/Tusla, Kildare/Wicklow Education and Training Board, INTREO, HSE Social Inclusion coordinator, InSync, Local Link, Regional Education and Learning Teams Coordinator.

Climate

Climate Action Regional Office (CARO)



The Climate Action Regional Office (CARO) works to support local authorities to drive climate action in their jurisdictions and coordinate activities to promote effective climate action across the local government sector. For more information on the work of the CARO, see our website at www.caro.ie

Kildare County Council is the host local authority for the Eastern and Midlands (EM) CARO, one of four CAROs working as a shared service within local government on climate. There are 17 local authorities within the EM CARO region.



The CAROs are funded by the Department of Environment, Climate and Communications (DECC) and work through the four lead local authorities by way of a Service Level Agreement (SLA) to mid 2029.

Local Authority Climate Action Training Programme



Training Service Level Agreement between Kildare County Council and DECC signed as of 01 June 2024. This marks the start of second phase of climate training for the sector.

Executive Training Group for oversight of training delivery for 2025 convened its first meeting on 15 January 2025. The group is chaired by Teresa Walsh Director of Service, with South Dublin County Council on behalf of CCMA and group comprises representation





from Climate Ireland, AILG, SEAI, Met Eireann, Heritage Council, LASNTG and CARO. Planning for training delivery underway as follows:

- Fire Services Staff commenced training delivery in August to run until all fire services staff complete. 21/27 have taken up training to date.
- Outdoor staff training commenced in September through regional training centres. Completion of outdoor staff training in Q1 2025.
- Procurement of Learning
 Management System ongoing.

Local Authority Climate Action Plans (LA CAP)

Review of all 31 LACAPs to ascertain robust information on action typology, is now complete. A robust central database is in place that can be utilised to identify commonality of actions to support local authorities to work together, to inform of action prioritisation, reveal challenges in implementation, to help identify pertinent case studies and inform reporting and monitoring requirements. A PowerBI module has been used to aid the generation of reports for sectoral stakeholders.

The EM CARO is working with local authorities in each of the four subregions to develop regional energy units to avail of funding for projects that support the decarbonisation of local authority buildings. The energy units comprise:

Mid-east (Kildare, Meath, Wicklow and Louth), commencing projects and accessing Pathfinder support from SEAI.

Midlands (Laois, Offaly, Westmeath, Longford, Roscommon), have developed their project pipeline and sourced funding to match Pathfinder support.

Border (Cavan, Monaghan, Leitrim) are working with project manager assistance from SEAI to build a project pipeline.

South-east (Carlow, Kilkenny, Tipperary, Wexford, Waterford City and County) have issued a position paper to SEAI for their consideration. Further discussion will continue to progress to MOU stage.



Reimagining Local Authority Fleet

The EM CARO supports the reconfigured working group established to explore support and options for local authorities on fleet decarbonisation and is now working to finalise recommendations for the CCMA on support for fleet decarbonisation into the future.

Development of Local Authority Key Performance Indicators (KPIs) on Climate Action

Energy Management Team:

The first meeting of the newly formed Energy Management Team took place on 30 January. Patricia Brennan gave an overview of the council's position to date, projects being advanced, decarbonising path and EPC framework to advance competitive negotiated procedure to undertake works on Naas and Athy swimming pools and Aras Chill Dara.

Libraries – Energy Audits:

Review of the audits for Athy and Leixlip libraries have been undertaken, and the documents are being finalised. The documents will help to inform the works to be undertaken.

SEAI Monitoring and Reporting

The requirement to update MPRN's for Council properties was completed by

the end of January deadline. Further reporting will be required in May.

SEAI Pathfinder Strategic Review:

Request for information on match funding has been returned to enable the SEAI to reinforce their next five-year business case and outline challenges Kildare County Council will have in meeting financials.

Critical Success Factors Audit

A meeting with SEAI regarding Monitoring and Reporting (M+R) progress took place on 10 March, Kildare progressing well.

Staff EV (Electric Vehicles) GoCar

The dedicated charge point has now been installed and commissioned.

Sports Partnership will also have use of the charge point and are awaiting the arrival of their electrically powered van.

SMT presentation:

A summary report of Kildare County Council's energy review was given by Patricia Brennan on 18 February. An update will be given later in the year.





People's Patches/'Our Shared Plate Project' for Community Climate Action:



The project is going from strength to strength with three active community efforts in Maynooth, Newbridge and Athy. Maynooth University continues to monitor the social effects and Neighbourhood Networks are advancing plans with the groups to create community gardens. The 18-month programme has seen the planting of trees, edible hedges and vegetables this winter. Presently a tool kit is being developed to provide scalability and longevity to the programme.

Community Climate Action Program Fund:

Twenty-four projects were approved by the Department of Environment,
Climate and Communications (DECC) for the Community Climate Action
Fund Grant. Grantees have 18 months to complete the projects and in the time since the grants were finalised in

September, four of the projects have already been completed. The first recoupment from DECC was completed in early December and covered approximately €200,000 of the total allocation of €897,000. The next drawdown by groups was the end of February.

When all the projects are completed 635 solar PV panels will have been installed as well as pumped wall insulation for four social housing units and two community halls. Other projects focus on replacing floodlights or pitch walkways with LED bulbs.

A number of biodiversity measures will also be implemented, including native tree planting and the installation of swift nest boxes.

Second quarterly drawdown from DECC applied for by the deadline of Friday 14 March.

Climate Design Lab:

Co-creative events with the wider community undertaken in late February.

Both the artist in resident and the Creative Collaborator have been assigned to the project.





Grass to Gas and Alternative Maintenance:

Maynooth University's Terrain AI team will be presenting the dashboard and findings from 2.00-3.00pm on the 28 April in the Chamber before the scheduled Full Council Meeting.

Also, CARO are organising national session webinar based on the work to date.

Entente Florale:

The Climate Action Office plans a visit to Maynooth by the delegates and is working towards a sustainable visit where feasible.

Environment

National Waste Management Plan for a Circular Economy

The Waste Management Act 1996, requires each local authority to make a Waste Management Plan. The Regional Waste Management Planning Offices, under the auspices of the County and City Management Association, co-ordinated the preparation of the National Waste Management Plan for a Circular Economy 2024-2030. The Plan sets out a framework for the prevention and

management of waste in Ireland for the period up to 2030.

The NWMP for a Circular Economy 2024-2030 was formally launched on 01 March 2024.

The Plan has reviewed the current waste management situation in Ireland and used key drivers and policy proposals to project future trends to identify a range of challenges to be managed over the lifetime of the Plan. The Plan now sets out policy responses and actions to address the current and future challenges identified and provides a delivery roadmap to help navigate the Plan period.

National Deposit Return Scheme

The National Deposit Return Scheme (DRS) was launched by the Department of Environment, Climate and Communications in February 2024. The DRS is a circular economy initiative, focused on plastic bottles and aluminium/steel cans.

The scheme is operated by Deposit Return Scheme Ireland (DRSI) CLG trading as Re-turn.

Larger retailers have installed Reverse Vending Machines (RVM's) at their





premises to automate the deposit return process. Smaller retailers will operate the scheme on a manual, over-the-counter basis.

From 01 June, all stock not branded with the Re-turn logo will have been phased out of shops and consumers are now only able to buy drinks for which a deposit is payable.

Ireland's Best Kept Towns Competition 2025

Naas Tidy Towns have been nominated by the Department of Rural and Community Development to participate in Ireland's Best Kept Towns Competition 2025 for the Best Kept Large Urban Centre Award.

Adjudication takes place anonymously during the month of May by two Adjudicators, one from the SuperValu TidyTowns Competition and one from the Best Kept Awards Competition

Water Framework Directive

Monitoring and investigation work continue in the water priority areas under the Water Framework Directive. The council awaits the publication of the third cycle of the River Basin Management Plan for the period up to 2027.

This document is expected to be published this year and will set the





priorities and areas for action over the next cycle.

Enforcement Priorities 2025

The NEP's have been reviewed and there is a reduction in the number of priorities for 2025, moving from 20 in 2024 to 15 in 2025. The breakdown is as follows:

Environmental Enforcement

The Environmental Protection Agency (EPA) published its report on the environmental enforcement performance of local authorities in 2023 on 03 December. The EPA's Local Authority Performance Framework measures and reports on performance against National Enforcement Priorities, focused on improving environmental compliance and achieving positive outcomes for water quality, air quality and waste management. The report shows that the scale of environmental enforcement work carried out by local

authorities in 2023 was significant. For the second consecutive year, Kildare County Council was the only local authority in the country to achieve a "Strong or Excellent" score across all 20 National Enforcement Priority categories.

GAA Green Clubs Initiative



Cappagh GAA club is the pilot club for Kildare for this national initiative.

The next phase of the project involves reducing waste arising within the clubhouse and work on this is continuing.

Flood Risk Management Catchment Flood Risk Assessment and Management Study (CFRAMS)

A steering group with the Office of Public Works (OPW) has been established to progress the consultant's brief for schemes within Kildare. The municipal districts will be briefed as schemes from the Catchment Flood Risk Assessment Management (CFRAM's) Programme commence.

Morell Flood Management Scheme

Construction of this scheme is continuing.

The document establishes a strong vision for implementing excellent SuDS in County Kildare through the planning process and for the lifelong maintenance of SuDS landscapes.

Kerdiffstown Park project

The official opening of Kerdiffstown
Park took place on 31 January. The

Columbarium walls have been substantially completed in Athy, Leixlip Confey, and St. Conleth's Newbridge cemeteries.

Cemetery Works

Staplestown

Landscape improvement works have commenced in the new extension to Staplestown Cemetery. Civil improvement works are ongoing in terms of road surfacing, drainage, kerbing, and general landscaping.





Boycetown Kilcock

Works were completed in Boycetown cemetery to help alleviate the ongoing drainage problems. Additional road and pathway resurfacing works as well as landscape improvements were also carried out as part of the project.

Ballybracken

Additional plinths are planned at this cemetery to facilitate burials.

Legislation XL Bully Type dogs

The last date for receipt of applications for exemption certificates was 31 January, 2025. This certificate is unique to each XL Bully type dog and owner. It is now illegal to own an XL Bully dog without a certificate of exemption.

The Department will soon be introducing some minor amendments to the regulations to address some concerns that have been raised. The new regulations will provide details of an appeals process, specifically in cases where a Dog Warden seizes a dog on the premise that it is an XL Bully type that has not obtained a Certificate of Exemption, and the owner then wishes to appeal the

determination of the Warden that the dog is an XL Bully type dog.

maintenance, road marking renewals and the delivery of the Road Opening Licence system (ROL).

The PLEEP (Public Lighting Energy Efficiency Project) is ongoing, with significant survey works completed across all five municipal districts. New LED installation works have commenced and will continue throughout 2025.

Machinery Yard and Regional Salt Barn

Vehicle servicing and associated works have been transferred to the new facility, with road salting being the focus of operations over the winter months.

Installation of telematics (GPS tracker systems) to all vehicles has been completed.

Five electric vehicles and a velocity patcher to assist in the delivery of services across the Municipal Districts are now in operation.

Documentation is being finalised for the procurement of further electric vehicles in 2025, to further the fleet decarbonation process.

Winter Maintenance



Winter maintenance operations commenced for the 2024/2025 season. 8,000 tonnes of salt was delivered to the Regional Salt Barn in September 2024.

Recent severe weather, with both snow, ice and freezing temperatures required the services of 30 drivers to treat the primary routes in Kildare in accordance with the Winter Maintenance Plan. Approximately 1,300 tonnes of salt was used over this period. Currently 10,000 tonnes of salt are being delivered to the salt barn.





It is proposed that the Regional Salt barn will be fully operational for the 2025/2026 winter maintenance

season.


Fire Safety Certificates

Applications received to the end of February 2025 compared with the totals received in previous years.





Fashion, Textiles and Design Hub

Athy Food, Beverage and Skills Innovation Hub

Construction works have entered the forty-fifth week of the programme. 67% of construction programme has been completed. First floor ceiling, electrical containment and stud partition metal standing completed. Lime render to external walls complete and ready for lime skim. Stone infill replacing blockwork, stone cleaning and installation of kerbing ongoing. Roof and gutting repairs underway. Electrical second fix, Mechanical first fix in progress and relaying of flagstones nearing completion. Kitchen specialist equipment tender published on 20 February with a closing date of 14 March.

Tourism

EU JTF – Regenerative Tourism and Placemaking Scheme

Fáilte Ireland have estimated that the assessment of funding applications under the SME scheme will be completed by end of March 2025. It has been flagged to Fáilte Ireland that some applications were submitted





several months before the January 2025 deadline, but still have not been assessed, and this delay will have a knock-on impact of shortening the time for project implementation. The first joint networking event with Into Kildare took place on 11 March and was hosted by Kilkea Castle who have completed an accessibility audit and will feature their learning as part of the event. The keynote speaker on the topic of Regenerative Tourism was Tina O'Dwyer of The Tourism Space.
