Communications Kildare County Council launches Active Travel Scheme



Kildare County Council hosted Minister of State in the Department of Transport and the Department of the Environment, Climate and Communications, Jack Chambers TD in the presence of the Cathaoirleach of the County of Kildare for the official opening of the Kilcullen Road Active Travel Scheme in Naas, Co Kildare. The Kilcullen Road Active Travel Scheme forms part of the cycle network in Naas. It consists of the upgrade of approximately 900m of the Kilcullen Road, improving the connectivity of the overall existing cycle network, specifically linking to the Piper's Hill cycle infrastructure and

connecting to the existing cycle facilities on the South Ring Road.

Official Opening of new Kildare County Council Machinery Yard and Regional Salt Barn



Kildare County Council hosted the Cathaoirleach of the County of Kildare, Councillor Daragh Fitzpatrick for the official opening of the new Kildare County Council Machinery Yard and Regional Salt Barn. The official opening marks the culmination of years of design, planning, consultation, and construction works. The new development replaces the existing Machinery Yard facility currently located in Newbridge and will be used by Kildare County Council to carry out a range of activities. The new development comprises two main elements, namely a new Machinery Yard and a new Regional Salt Barn. The Regional Salt Barn provides





storage for approximately 23,000 tonnes of salt for use by Kildare County Council and several other local authorities in the region as part of winter maintenance operations. The storage and distribution of the salt will be operated by Kildare County Council on behalf of the Department of Transport.

# New Playpark opened in Allenwood by Kildare County Council



Kildare County Council has officially opened a new playpark featuring a Multi-Use Games Area (MUGA), Playground Outdoor Gym and BMX Pump Track in Allenwood. The completion of this project marks a significant milestone in Kildare County Council's ongoing commitment to providing exceptional recreational facilities for the local Community. The project was funded through contributions from Development Levies, local property tax, and Drehid community grants scheme. The Playpark covers an area of 3200M<sup>2</sup> and aims to create an environment where children, young people, and families can come together to engage in active play and enjoy the outdoors. A diverse range of activities is offered to allow children of all ages and abilities to play, interact and socialise together.

# Public Amenity set to open at De Burgh Woodland Gardens



Kildare County Council hosted members of the Naas Municipal District to mark the launch of the initial phase of works being undertaken to provide public access within the De Burghs Woodland Gardens. Located in the heart of Nass, and accessed off Mill Lane, the De Burghs Woodland Garden date back to around 1696. The woodland gardens are an important historic landscape, the area





of estate subject to this initial opening consists of circa 18 acres of mature woodlands, walkways, water features including an octagonal pond, waterfalls, and canals and a rich collection of plants and trees. Once opened, the woodland gardens will provide a much-needed amenity and resource to the community. The gardens, which will open to the

public in the coming weeks, will initially open on a ticketed managed basis for weekend access only. A free online booking system will allow users to prebook day tickets.

# Official Opening of Food Distribution Hub in Athy Enterprise Centre



Kildare County Council in the presence of the Cathaoirleach of the Athy Municipal District, Veralouise Behan, recently welcomed the opening of Bradbury's "Irish School Meals" dedicated distribution hub in the Athy Enterprise Centre. Each day, over 6,000 hot meals are prepared and delivered to Kildare-based schools from the hub, with all used packaging returned and recycled in line with circular economy principles. Technology and innovation are at the heart of the operation, which supports a number of local jobs and will create further jobs in the coming months as

#### Naas Library

Naas Library and Cultural Centre hosted several events in the large multi-functional Chamber space in May.

As a nod to times past when Naas Cinema occupied this building, a special showing of the old classic film 'Mata Hari' was put on for Age Friendly Day. This was just one of many Age Friendly events which took place across the Kildare Library Service on 17 May.

The Libraries Association of Ireland Youth Library Group were delighted to host the annual conference in Naas, and it was an opportunity for librarians around the country to enjoy some wonderful speakers in this beautiful, new library.

### Rathangan Library

The library welcomed special visitors from Freehold, New Jersey on Saturday 18 May, including Mayor Kevin Kane, Freehold Library trustee Jane Kaye, Glen Cashion (cousin of Bruce Springsteen) and members of the Freehold–Rathangan Twinning Committee. They called into the library in advance of their tour of Rathangan and tree planting ceremony to chat





with the librarian and view the painting donated by Mr. Cashion.

**Creative Health and Wellbeing in the** Community Award €140,000 Kildare Culture and Creativity Team, spearheaded by Kildare Arts Service, have successfully applied for, and been granted €140,000 via the Creative Health and Wellbeing in the Community Scheme. This funding will support the project 'Did I Ever Tell You...' a storytelling project focused on collecting the thoughts and memories from older people in HSE healthcare settings across Kildare, Offaly, and Westmeath. Creative practitioners will facilitate a bespoke programme of sustained engagement over the period September 2024-December 2025, with selected stories from each county published in a collective book. The project is designed and delivered in partnership between the three local authorities' Creative Ireland, Healthy Ireland, and Age Friendly teams along with the HSE, with approx. €46,000 going

towards Kildare based projects over two years.

# Kildare Readers' Festival presents Kildare Reads

Singer-songwriter and author Declan O'Rourke and former RTÉ presenter and broadcaster Flor MacCarthy discussed his famine trilogy in Newbridge Library on Tuesday 28 May. It was the second Kildare Reads event of the series, presented by





Kildare Readers Festival in association with the Irish Writers Centre. Declan O'Rourke's Pawn Broker's Reward and Whisper of Oblivion are the first two books of his trilogy set in the famine years. They tell the story of Pádraig and Cáil Ua Buachalla, based on real lives and events in the early months of the Great Hunger.

UEFA EURO 2024 Activity Book The Football Association of Ireland continues its collaboration with Libraries Ireland this year with the launch of the UEFA EURO 2024 Activity Book, aimed at inspiring young football enthusiasts across Ireland. The activity book is available in all Kildare Libraries while stock lasts and is aimed at 10–14-year-olds. Kildare County Archives and Local Studies

The service re-opened to the public on 23 May at its new location. The building now houses a large amount of the county's historical archival material, as well as its extensive Local Studies collections including Special Collections. It has a large Reading Room, along with a microfilm/public access PCs area. Researchers will be able to avail of assistance with their local history or genealogical research from our experienced staff. Kildare County Archives is open to researchers on Thursdays and Fridays, 10.00am-1.00pm and 2.00-5.00pm by prior appointment. Local Studies is open to researchers from Wednesday-Saturday, 10.00am -1.00pm and 2.00pm-5.00pm by prior appointment.

The eight annual Irish Military Seminar which took place on 10-11 May in Riverbank Arts Centre and included the launch of The Colour of Kildare 1913-1923 by James Durney, Mario Corrigan and John O'Byrne, was a great success. Speakers included author and broadcaster Ralph Riegel who gave a talk on the Elizabethville ambush, Congo, to an audience of serving and retired Defence Force personnel and the current Cadet Class.





The Archivist is working on Kildare County Council Records Management, listing and processing collections. Digitised Journals of the County Kildare Archaeological Society from 2007-2019 have now been uploaded, along with volumes previously available from 1891-2006, to https://archive.irishnewsarchive.com/ol ive/apa/KCL.Edu/#panel=home Migration of content from Kildare.ie to the Library website and eHistory ongoing. 

### **Risk Management**

The individual directorates have had workshops on their individual Risk Registers with IPB and are finalising the individual directorate risk registers. The Information Technology risk register was presented to the Audit Committee at their May meeting.





Increased Cost of Business Grant As part of Budget 2024, the Government announced a €257m package to help small to medium businesses deal with the rising costs facing businesses. A second round of ICOB grants was announced in May 2024 and we await further guidance as to those eligible for second round payments.

Portal closed for first round grant registrations on 01 May.

A total of 3165 grant submissions have been received

2168 grants have been paid as of 05 June with a value of €4.464 million It's expected all first round applications will be approved by 14 June.

# Development Contributions Waiver Scheme

Circular PL 04/2023 introduced a Temporary Time-Limited Waiver for Development Contributions in respect of residential developments with commencement notices issued on or after 28 March 2023 and completion of the build of the units by 31 December 2025. The Government has approved, on 23 April 2024, an extension of the current arrangements for the waiving of local authority "section 48" development contributions to 31 December 2024 and the refunding of Uisce Éireann water and waste water connection charges to 30 September 2024.

On the 15th of each month each LA is to submit a claim to the Department of Housing, Local Government and Heritage the value of waivers applied.

### **Digital Services**

After using the Office of Government Procurement (OGP) print framework, IT have selected Opogee Corp to provide and support our new print, scanning and copying solution for the





next three years (including the option to extend by three years).

This deployment of new devices will ensure all devices used by Council staff in all locations will be using the same printers and same support contract.

Rollout of the new devices commenced week beginning 03 June and should be completed in three to four weeks for all areas in Aras Chill Dara.

### Innovation

The Innovation Team in collaboration with Paula Comerford, Ethics Registrar and our colleagues in Corporate Services, HR and IT are pleased to advise that a new Ethics Register application is now live in Kildare County Council.

The new application digitises the Ethics Declaration requirement for relevant staff and Councillors. The application replaces the paper form requirement with an online form that is prepopulated with key information including relevant dates, email, department and various signature options. The application includes all relevant documentation, user guides and videos.

New relevant employees or Councillors who take up their position during the remainder of this year will be invited to submit their declaration on the new application. Any paper forms completed for 2024 remain valid.

In early 2025, all relevant employees and Councillors will be asked to complete their annual declaration in the new application form. Further information and guidance will issue at this time.

Phase 2 is planned for Quarter 4 2024 and includes the Donation Statement requirement for Councillors

# Integration Team Designated Accommodation Centres (DAC's) DAC's reaching the end of the first 90day accommodation period. The Department of Children, Equality, Disability, Integration and Youth (DCEDIY) to issue protocol for Day-90





to Local Authority's. Note that Beneficiaries of Temporary Protection (BOTP's) are not entitled to social housing or homeless services. On leaving DAC's BOTP's will be entitled to full social welfare payment and rent supplement.

DCEDIY consolidating existing accommodation centres for Beneficiaries of Temporary Protection (BOTP's) that arrived prior to 14 March 2024 and numbers decline. All new arrivals since 14 March are now accommodated in DAC's.

### **Recent Developments**

New contracts with DCEDIY for BOTP accommodation will have the option to pivot to accommodation for International Protection Applicants where the building has the relevant statutory approvals or exemptions.

# Local Authority Integration Team (LAIT)

The main role of the LAIT is to provide integration supports to international protection applicants, persons with status, beneficiaries of temporary protection and programme refugees resettling in county Kildare. This includes information, advice, and guidance. The LAIT identifies needs through outreach work and clinics in accommodation centres and in the community, signposting mainstream and other services available locally appropriate to needs, supporting access (particularly for the most vulnerable), and helping to resolve any issues arising.

# Beneficiaries of Temporary Protection (BOTP)

Statistics: BOTP in State provided accommodation nationally: 45,216. In Kildare: 928 (698 adults/230. children) - Source LGMA update – 05 June 2024

- The LAIT has visited to date all seven accommodation centres for BOTPs in Kildare, carrying out 14 outreach visits and organising 12 clinics.
- The LAIT has identified language and transport as the main barriers accessing mainstream services.





Most services are at full capacity and have been for some time.

- Vulnerable groups identified include older persons (over 65) with limited English who need additional supports to integrate in the community.
- Designated Accommodation Centres (DACs): DECDIY is finalising a protocol for residents who complete the 90 days period. Residents will be transfer to City West Transit Hub where they will receive a transport/accommodation voucher (value TBD). Vulnerable cases will be relocated to an alternative accommodation: vulnerability criteria include medically vulnerable persons assessed by the HSE, children (under 18) and older persons (over 65). DECDIY/LGMA to provide further guidelines.

# International Protection Applicants and Persons with Status Statistics: IP applicants in State provided

accommodation nationally: 30,757.

In Kildare: 628 (487 adults/141 children). - Source DECDIY 26 May 2024

- To date the LAIT has visited all ten IPAS accommodation centres in Kildare and carried out 15 outreach visits and organised 13 clinics to signpost services available locally based needs and resolve queries.
- De Burgh Manor (formerly known as Bert House). Transport continues to be the main barrier for residents to access services in the community. Staff at the centre has advocated for public transport or for service providers to provide transport for residents. The LAIT has sent a query to IPAS as centres situated more than 2km from a town are obliged by contract to provide regular transport to amenities. The LAIT has asked what is the minimum that the centre should offer in terms of transport.





## Vulnerable groups identified among IP applicants include:

- Single women (no family and/or supports) GBV survivors.
- 'Age out' minors: The Child and Family Agency (Tusla) is statutorily responsible for Separated Children Seeking International Protection/ Unaccompanied Minors. Those who reach 18 years of age ('aged out' minors) are transferred from Tusla care accommodation to IPAS accommodation. Generally, a transfer from Tusla care to an IPAS accommodation will not take place in the middle of an academic school year, but the LAIT has identified 'age out' minors transferred before seating their leaving cert. Working with 'aged out minors' the LAIT has learned that only those who have been under Tusla's care for a minimum of one year received aftercare.

The LAIT has received 271 queries and resolved 221 to date. Mostly were related to Housing (21%), Employment (14%), Adult Education (12%) half of them were related to English classes, and Healthcare (8%).

New IP Applicants Daily Expenses Allowance Policy (from June 2024): An income assessment is being introduced for the Daily Expenses Allowance with effect from June 2024, for persons 18 years or over. For claims involving couples or families, the Daily Expenses Allowance payment of the person who has income may be reduced or withdrawn. This will not impact on any payment in respect of other family members. Note that 'income' includes pay from employment, self-employment and social welfare payments. The Daily Expenses Allowance payment will cease where a person has income of more than €125 per week for a combined total of 12 weeks or more.

# International Refugee Resettlement Programme (IRPP)

Through the model for distribution for IRPP II Local Authorities, Kildare County Council has accepted the allocated quota of 66 refugees for





2024-26. IRPP will start in July 2024 with the resettlement of three Syrian families in the first location. It will be carried out in various tranches (in July, August and November 2024; dates in 2025 TBD) in a combination of Approved Housing Bodies and Kildare County Council housing units.

An implementing partner for the provision of integration support over 18 months has been identified through a tender process. This includes the recruitment of an Integration Support Worker, and an Arabic-speaking Intercultural Support Worker. The Tender applications were submitted on the 14 May. Clarifications requested by the Assessment Team on the 23 May. A Notice Letter confirming CKLP's success in the tender process was issued on the 29 May. Subsequently CKLP furnished all the required documentation (04 June). The Chief Executive Order was signed on the 05 June, and a Letter of Acceptance from Kildare County Council accepting the tender was sent to CKLP (06 June), allowing CKLP to commence the

recruitment process. Formal signing of the service contract in the coming days.

IRPP/DECDIY submitted in May the social housing applications for the families selected for the first two locations and details to initiate the garda vetting.

The Integration Team met with Oaklee and Tuath (AHBs for the first two locations) and the Department of Social Services to agree upon the next steps. Action trackers were drafted to ensure coordination in the delivery.

Community Integration Forum Meetings are taking place the first Wednesday of each month, starting on the 01 May (expansion of the integration remit, rename of the forum, ToR, membership and procedural matters discussed). Meeting 05 June (ToR approved). Focus on info sharing, coordination and collaboration to deliver better services to persons in need of international protection. Links between the CIF and the LCDC and





Kildare Integration Strategy Working Group need to be defined, including establishing communication channels and areas of collaboration.

### National ISC and ISW Networks

The LAIT continues participating in the Integration Support Coordinators (ISC) and Integration Support Workers (ISW) networks. The aim of these networks is to facilitate the sharing of best practice across the sector.

### Accommodation Team:

The Accommodation Team manage the Offer a Home Scheme in county Kildare in conjunction with the Irish Red Cross (IRC) and manage the SLA agreed with The Peter McVerry Trust for the management of the Rest Centre at Liffey Lodge, Newbridge.

The Accommodation Team are also involved in the following accommodation programmes:

### **Refurbishment Programme**

Assessment and reporting on proposals logged on the LGMA refurbishment portal. As the number of BOTP's arriving is declining the portal is currently closed for new applications. All current applications must be complete and delivered by 31 October 2024 as the temporary directive expires on 04 March 2025. A minimum capacity of 30 people is required for all refurbishment proposals.

# Designated Accommodation Centres (DAC's)

Established to accommodate BOTP's arriving in the State after 14 March 2024. Kildare has two DAC's.





### **Punchestown:**

Opened in mid-March with a capacity of 378 people. Current occupancy is 136 people (06 June 2024).

### Newhall:

Opened in mid-May with a capacity of 985 people. Current occupancy is 321 people (06 June 2024).

The area of responsibility also extends to appraisal of properties signposted to Kildare County Council by the International Protection Accommodation Service (IPAS) in DCEDIY for accommodation of IPA's.

A technical working group (TWG) has been established to access accommodation proposals referred to Kildare County Council by DCEDIY, IPAS and the LGMA.

### Housing and Regeneration

### Housing

Local Authority Home Loan (LAHL) The Department of Housing, Local Government and Heritage [DHLGH] has widened the definition of the Fresh Start Principle for Local Authority Home Loan applicants. Persons who have experienced divorce/separation or insolvency/bankruptcy will be eligible to apply for LAHL, irrespective of the number of previous dwellings that person may have owned. In such cases the most recently owned home must have been lost due to the 'Fresh Start' event.

### Town Regeneration

The Minister for Rural and Community Development, Heather Humphreys, has announced a new initiative to support Town Teams. The Support Fund will deliver funding for communities that have never had a Town Team before. Three towns in Kildare will receive funding of €10,000 each: Kilcullen, Monasterevin and Ballymore Eustace. The funding may





be used to support the establishment and/or development of town teams where they are not already well established, and to better understand the unique features of towns. Kildare town and Athy have been added to the Urban Regeneration and Development Fund [URDF] eligible towns and an increase in funding under Call 3 allocations has been received. In terms of the Call 3 programme, which saw a dedicated fund being made available to local authorities to tackle long term vacant and derelict properties in their URDF eligible areas. Properties which are located within the newly eligible towns, and meet the criteria of the fund, have been included on the approved acquisition programmes.

Homelessness Action Plan Launch The new Homelessness Action Plan 2024 -2026 (Mid-East Region) was formally launched at the Regional Homeless Forum meeting on 30 May. The plan can be accessed online at Homeless Services - Kildare County Council (kildarecoco.ie)

The Climate Action Regional Office (CARO) works to support local authorities to drive climate action in their jurisdictions and coordinate activities to promote effective climate action across the local government sector. For more information on the work of the CARO, see our website at www.caro.ie

## Local Authority Climate Action Training Programme



LOCAL AUTHORITY Climate Action Training Programme

The Local Authority Climate Action Training Plan 2024-2027 was endorsed by a specially convened steering group, chaired by a representative of the Climate Action, Transport, Circular Economy, and Networks (CATCEN) committee. The training plan will oversee the delivery of training guided by the training needs and priorities of elected members and local authority staff on climate action. The CATCEN committee and the CCMA have endorsed the plan. Kildare County Council signed the Service Level Agreement with the Department of Environment, Climate and Communications (DECC) to fund the delivery of training over the duration of the plan.

## Local Authority Climate Action Plans (LA CAP) All 31 local authorities have adopted their climate action plans.

LACAP Review: Review of all 31 LACAPs is underway to ascertain robust information on action typology. The review process involves a three phased approach including:

 Scope: Requirements, outputs and needs were identified as well as options for data analysis. Status: Complete.





- Develop: Information Management System was established, tested and refined. Status: Complete.
- Data processing: Input of actions of all 31 LACAPs and DZs (3919 actions) against predetermined categories, actions analysed, actions peer reviewed for consistency in interpretation. Status: Quality check is nearing completion.

The outcome will be a robust central database that can be utilised to identify commonality of actions to support local authorities to work together, to inform of action prioritisation, reveal challenges in implementation, to help identify pertinent case studies and inform reporting and monitoring requirements. Database will inform sectoral reports.



Sub-Regional Energy Projects The CARO is working with local authorities in each of the four subregions to develop regional energy units to avail of funding for projects that support the decarbonisation of local authority buildings. The energy units comprise:

Mid-East (Kildare, Meath, Wicklow and Louth), commencing projects and accessing Pathfinder support from SEAI.

Midlands (Laois, Offaly, Westmeath, Longford, Roscommon), have developed their project pipeline and sourced funding to match Pathfinder support.

Border (Cavan, Monaghan, Leitrim) are working with project manager assistance from SEAI to build a project pipeline.

South-East (Carlow, Kilkenny, Tipperary, Wexford, Waterford City and County) have issued a position paper to SEAI for their consideration. Further discussion will continue to progress to MOU stage.







Reimagining Local Authority Fleet The CARO supports the reconfigured working group established to explore support and options for local authorities on fleet decarbonization. The working group are focusing on a publication for local authorities on fleet management system elements necessary to guide and monitor fleet decarbonisation.

## Development of Local Authority Key Performance Indicators on Climate Action



Data collation for 2023 is nearing completion with a report due in June to CATCEN.

## GAA / CCMA Green Clubs Programme:



The CARO continues to work with the GAA and expert partners to advance the Green Club Programme. Phase two of the Programme sees c.200 clubs working their way through a range of sustainability and climate action related projects as provided for by Green Club Toolkits covering the five themes of Energy, Water, Waste, Biodiversity and Travel. Points of Contact have been identified in each local authority and CARO is planning a further webinar in September to support points of contact in engaging with clubs in their area.

Inspiring change, shaping tomorrow

The CARO office provides support to the Climate Action Office (CAO). In turn the CAO assists the functional areas of the council to decarbonise their roles and work through the members of the Climate Action Team and Energy Management Team together with the Senior Management Team.

## Kildare County Council Climate Action Plan (with DZ and SECAP)

# The Decarbonising Zone – 'Show and Tell' house:

With thanks to the Senior Management Team, we are working closely with the housing section, accessibility officer and Maynooth University to refurbish a house and associated garden to enable a 'Show and Tell' home. The tender was published on Supplygov.ie and it is expected the house will open in October 2024.

The Mid-East Energy Unit (MEEU) SEAI have agreed to pilot Pathfinder funding (approx. €20m between the four Mideast Energy Unit (MEEU) LA's) for various Energy/Carbon savings related projects at scale. This matched grant funding includes projects such as:

- The installation of approx. 220
   Photo Voltaic (PV) solar panels at
   the Cotton Mills. This contract was
   awarded and an application To ESB
   for the generation connection has
   been approved. Works are due to
   start over the next two months.
- PV and Geothermal/Air heat pumps for heating at K-Leisure pools facilities at Naas and Athy in conjunction with works on swimming pools in Meath, Wicklow and Louth.
- The appraisal of the Aras and K-Leisure buildings' heating systems has been undertaken by our MEEU consultants Codema and reports produced.





 Pathfinder funding is potentially available for upgrading works to some of our library buildings. This may include energy-related elements of the new Clane Library.
 These projects will enable retrofit works (energy efficiency and decarbonisation) on our existing buildings, thus reducing energy utility bill costs.

## **District Heating (DH)**

Given the potential for a future district heating scheme (DH) in Naas, a DH feasibility study will be undertaken by Codema in Q3/Q4 of 2024. SEAI have agreed to 100% fund this Naas study. Preliminary discussions on this scheme are ongoing with potential customers (Naas Hospital, local hotels, schools) and suppliers.

A more in-depth discussion into the sustainable sources of the supplied heat for this DH scheme will be required. There may also be scope to undertake a similar DH study for Maynooth later in 2024/early 2025, this to be funded directly by our planning dept. Kildare has signed a partnership agreement with Intereg to partake in their DH DISCO scheme.

#### **Display Energy Certs/ BER**

All public buildings with a floor area over 250 m2 require Display Energy Certificates (DEC). A DEC was recently procured through our facilities department, for the Aras, the grade received for the building was a D2 grade.

An in-depth energy audit and BER survey took place of the Aras building by a company called IES and the initial report is under reviewed.

## ISO 50001 Energy Management System

Kildare County Council hopes to apply for ISO 50001 (Energy Management System) certification in Q4 of 2024, for the organisation as a whole. Our Energy Officer and Climate Action Officer are attending the SEAI Ten-day ISO50001 accelerator training programme as part of this process. The implementation of ISO 50,001 is a statutory requirement. The timeline is likely to be impacted by staff movement.

Energy Audit/Analysis/BER of Aras: Took place 02 April, the initial report has been received, and will feed into





decarbonisation strategy for the Aras building. Report published by the Sustainable Energy Authority of Ireland (SEAI) also sets out that non-electricity greenhouse gas emissions in 2022 were 17% below the baseline (2016-2018 average), Energy efficiency Performance -32% improvement in 2022.

#### **Swimming Pools:**

CODEMA undertook site visits to inform decarbonisation appraisal reports at Athy and Naas pools and the resulting reports have now been received with stakeholders meeting held 13 May to inform the path forward.

#### **SEAI Monitoring and Reporting**

First deadline of the year was 22 March, MPRN's and GPRN's verified, and target met.

#### Staff use EV GoCar

A six-month trial of a staff use GoCar Electric Vehicle (EV) has been under way since the start of the year. Approx 50 staff have signed up to the scheme and 60 work-related trips have been undertaken.

#### Staff use E Bikes

Work on the back of house elements is close to being finalised and IPB have been very helpful in assisting. It is hoped the bikes can be launched soon through interdepartmental cooperation.

## Climate Action Strategic Policy Committee (SPC):

On the 08 May, the Climate Action SPC with the Environment SPC as guests collectively journeyed by bus to view climate action projects in action. The first stop was a talk on rewetting of the bog at Prosperous under the Bord na Mona Bog Rehabilitation Scheme. The second stop was Hortland Solar Farm. The attendees enjoyed wide and varied discussions on both elements. Participants found the trip insightful.

The next meeting is scheduled for the 11 September 2024.





## Climate Action Community Initiatives Funding Aids and Projects:



An Roinn Leanaí, Comhionannais, Míchumais, Lánpháirtíochta agus Óige Department of Children, Equality, Disability, Integration and Youth

Following successful implementation of Gnáthóga Nádúrtha (Natural Habitats) a second phase of the project focusses specifically on the artists resulted in an additional €35,000 in funding. Arts Section are working dilligently with the arts and organised Bog Eco Literacy and Community Communication day in Lullymore on 23 April, 2024.

People's Patches/'Our Shared Plate Project' for Community Climate Action:



Kildare, Longford and Laois County Council along with Maynooth University, The Useless Project and Neighbourhood Network (lead) have been awarded by Pobal €271,000 funding for the Community Climate Action project submitted in January 2022. The name of the project has changed to 'Our Shared Plate Project' to reflect the community cohesion through the celebration of food. Sites in Maynooth, Newbridge and Athy have been chosen for the project and community contacts identified. The Maynooth grouping had a highly successful street feast in May to commence the project. Athy's first event took place on the 07 June.



**'Climate Design Lab: Where Creativity In Practice Meets Climate Action'** 

Under Creative Climate Action Fund II:

'Agents for Change Creative Ireland' informed Kildare County Council on 12 July that a conditional award of funding of €250,000 has been approved. Kildare County Council along with the Design Innovation Department in Maynooth University and Riverbank Arts Centre will pilot a Climate Design





Lab that aims to use design-thinking and behavioural economics to cocreate fun theory solutions for Maynooth, the decarbonising zone for the county. Preliminary work has commenced at Maynooth University. The new Principal Investigator has been assigned and is Dr. Amy Fahy, School of Business, Maynooth University. Amy is coordinating aspects of the work with other third level institutes to increase awareness and has formulated communications elements alongside information gathering methodologies to inform the process. Work continues apace.

## Community Climate Action Program Fund:

The list 25 projects across all Municipal District's and size of project has been submitted to the Department for consideration as of 01 May. The list also includes reserve projects should they be required.

We await the outcome.

#### Grass to Gas:

This project aims to assess the potential for green spaces to generate biomass e.g., grass-clippings as a feedstock for energy generation in Kildare with the potential of scaling the study up to different county councils and state bodies nationwide. An agreement has been formulated with Maynooth University to enable the research to commence and the work is progressing at a pace. It is expected that the project will be completed by Q2/3 of 2024.

Stakeholders including Microsoft, Teagasc, Kildare County Council, Gas Networks Ireland, Green Generation met in Maynooth University hosted by Terrain AI in April to advance the project inputs. A follow-up meeting in Green Generation is being undertaken in June.

Phase two of the project has now been agreed between Terrain Ai and the Climate Action Office to advance the measurement of the gas production and the wider socio-economic, biodiversity and carbon reduction potentials.

IRESI - International Renewables and Energy Systems Integration A workshop was held in February with IRESI led by Fabiano Pallonetto and Amy Fahy of Maynooth University and





their team, to balance energy grid usage and potential Kildare County pilot project for up to 500 houses (social and private). We continue to work collaboratively on this project and the meeting held with SFI enshrines the milestones being met.



## Water Services

**Uisce Éireann Councillor Clinics** Uisce Éireanns quarterly Councillor Clinics are held online for local representatives on selected dates throughout the year. Dates for 2024 are as follows: Monday 26 June at 11.00am Monday 23 October at 11.00am Uisce Éireann formulates responses to any outstanding queries via the Local representative Support Desk. ## **Uisce Éireann Framework**

The Framework for the Future Delivery of Water Services was published in June 2022, setting out the Government policy with Uisce Éireann taking full control of all aspects of the delivery of water and wastewater services. Uisce Éireann is engaging with key national bodies and representative groups to prepare for the implementation of the Framework provisions.

The original Service Level Agreement has been replaced by a Master Cooperation Agreement with all local authorities and an individual Support Service Agreement (SSA) per local authority, takes into consideration the changes included in the new Framework.

In this regard, the Master Co-operation and Data Sharing Agreements were signed by Kildare County Council in May 2023.

Kildare County Councils Shared





Service Agreement is at the final stage of completion.

## Environment

National Waste Management Plan for a Circular Economy. The Waste Management Act 1996, requires each local authority to make a Waste Management Plan. The Regional Waste Management Planning Offices, under the auspices of the County and City Management Association, have co-ordinated the preparation of the National Waste Management Plan for a Circular Economy 2024-2030." The Plan sets out a framework for the prevention and management of waste in Ireland for the period up to 2030.

The National Waste Management Plan for a Circular Economy 2024-2030 was formally launched on Friday 1st March

The Plan has reviewed the current waste management situation in Ireland and used key drivers and policy proposals to project future trends to identify a range of challenges to be managed over the lifetime of the Plan. The Plan now sets out policy responses and actions to address the current and future challenges identified and provides a delivery roadmap to help navigate the Plan period

National Deposit Return Scheme A National Deposit Return Scheme (DRS) has been launched by the Department of Environment, Climate and Communications. The DRS is a circular economy initiative, focused on plastic bottles and aluminium/steel cans. The scheme went live on 01 February.

The scheme is operated by Deposit Return Scheme Ireland (DRSI) CLG trading as Re-turn.

Re-turn foresees more than 2,000 return points being ready to accept returns and refund deposits at launch date. Larger retailers have installed Reverse Vending Machines (RVM's) at their premises to automate the deposit return process. Smaller retailers will operate the scheme on a manual, over-the-counter basis.

An interim report details that 6,004,496 containers have been accepted in Kildare. There are 103 Reverse Vending Machines in the county and 70 stores are accepting containers.





From 01 June, all stock not branded with the Re-turn logo will be phased out of shops and consumers will only be able to buy drinks for which a deposit is payable. Further details can be found at www.re-turn.ie

## Water Framework Directive

Monitoring and investigation work continue in the water priority areas under the Water Framework Directive. The council awaits the publication of the third cycle of the River Basin Management Plan for the period up to 2027.

This document is expected to be published this year and will set the priorities and areas for action over the next cycle.

#### **Enforcement Priorities 2024**

The National Waste Enforcement Priorities 2022-2024 were recently reviewed by the National Steering Group and a number of changes were made to reflect these discussions. The following remain as high-level priorities in the area of waste enforcement:

 Tackling significant illegal waste activity,

- Construction & Demolition activity,
- End-of-Life Vehicles,
- Waste collection,
- PRI initiatives.

The Kildare County Council Recommended Minimum Criteria for Environmental Inspections (RMCEI) and the 2023 Plan submitted to the Environmental Protection Agency (EPA) Kildare County Council was judged as one of the top performers Nation-wide in terms of environmental inspections.

#### **Environment Complaints**

Pollution complaints continue to be investigated in accordance with national guidelines.

#### **Poster Monitoring**

Monitoring compliance of regulations for election posters is ongoing in conjunction with the Transportation Department.

## Domestic/Commercial Refuse Collections

Domestic and commercial waste collections are continuing as normal.

#### **Green Schools**

Participation in the Green Schools initiative is increasing as schools improve their waste management, the rollout of the brown bin food waste infrastructure has been a catalyst for this. The schools will be awarded their coveted Green Flags at an awards ceremony this month.

## **Rubbish Film Festival**



This is the second year that Kildare "Rubbish Film Festival" for Transition Year Students in Secondary Schools was held with 13 entries from ten participating schools across the County. It was a resounding success. The festival, which challenged students to create a one-minute short film on the theme of reducing waste and encouraging sustainability, was facilitated by Createschool and supported by Kildare County Council. The festival received a great response from the schools, with students showing their creativity and innovation in producing ten short films that were both educational and entertaining. Two films and a poster design were selected as the winners in their respective categories and went forward to represent County Kildare at the National Awards which was held online, in May. A Kildare entry from Cross and Passion in Kilcullen, came first in a special category – The Judges Award. The organisers hope that the festival will continue on as an annual event that will help to raise awareness about environmental issues among young people and inspire them to take action to protect the planet.

#### **Single Use Plastics**

Single Use Plastics campaign was run from 20 May - 02 June. The campaign by MyWaste.ie will be run on radio, print and digital media.







## GAA Green Clubs Initiative



Cappagh GAA club is the pilot club for Kildare for this national initiative. The next phase of the project involves reducing waste arisings within the clubhouse and work on this is proceeding.

## New Initiatives – Civic Amenity Site North – Near Celbridge

A joint project of the civic amenity in conjunction with the proposed Municipal District depot is being assessed.

## Flood Risk Management

Catchment Flood Risk Assessment and Management Study (CFRAMS) A steering group with the Office of Public Works (OPW) has been established to progress the consultant's brief for schemes within Kildare. The municipal districts will be briefed as schemes from the Catchment Flood Risk Assessment Management (CFRAM's) Programme commence.

Morell Flood Management Scheme Construction of this scheme is continuing.

New Sustainable Drainage Systems (SuDS) guidelines have been published. The preparation of the Guidelines was an action of the newly adopted County Development Plan. The document establishes a strong vision for implementing excellent SuDS in County Kildare through the planning process and for the lifelong maintenance of SuDS landscapes.

## Kerdiffstown Park project

The construction of Kerdiffstown Park is at an advanced stage and it is anticipated that the park will be operational in 2024. Final snagging on the landfill infrastructure is being completed ahead of issuing the substantial completion certificate to the contractor.

**Cemetery Capital Programme** This programme, which includes cemetery extensions, capital type internal improvements and proposals for columbarium walls is currently being reviewed in line with funding availability.

## **Columbarium Walls**

New Columbarium walls were completed in Crookstown and Rathangan cemeteries. Tenders have been returned and assessed for new Columbarium Walls in St. Michaels Athy, Leixlip Confey, and St. Conleth's Newbridge cemeteries as part of the current capital programme of works. All going well, it is expected works to commence in June, with completion expected by mid Q3 2024.

#### **Cemetery Works**

Allen Works have been completed on a cemetery extension.

#### Staplestown

Landscape improvement works have commenced and are expected to continue until early summer in the new extension to Staplestown Cemetery. Civil improvement works are expected to commence in mid-summer in terms of road surfacing, drainage, kerbing, and general landscaping.

#### **Boycetown**, Kilcock

Works were recently completed in Boycetown cemetery to help alleviate the ongoing drainage problems. Additional road and pathway resurfacing works as well as landscape improvements were also carried out as part of the project.

#### Ballybracken

Additional plinths are planned at this cemetery to facilitate additional burials.

# Local Community Development Committee

Work continues to complete the implementation plan. AIRO have completed demographic, economic development/commuting, housing, education and health analysis from Census 2022. LGBTI+ Dormant Account Funding Kildare LCDC has been awarded Dormant Account funding of €16,852 in 2024 to support LGBTI+ Community Organisations. Local Enhancement Funding Kildare was allocated Local Enhancement Funding in 2024 to

Kildare Children and Young People's Services Committee (CYPSC) in collaboration with the LCDC will submit an application in June to the Department of Children, Equality, Disability, Integration and Youth's (DCEDIY) and DRCD to establish a Local Area Child Poverty Action Plan in Kildare. There will be at least four areas selected nationally under this pilot scheme.

# Transport, Mobility and Open Spaces

## Transport

M4 Maynooth to Leixlip M4 Eastbound Bus Priority Measures Works have now commenced (a speed limit reduction will be in place from April to December 2024).

M4 Maynooth to Leixlip M4 Westbound Bus Priority Measures Contract signed with Arup for Phases 3 and 4 (Design and Statutory Process) on 26 May 2024 for the M4 Westbound Bus Priority Measures.

M9 Park and Share Scheme Kildare National Roads Office (NRO)

have been asked to get involved in Transport Infrastructure Irelands (TII) Park and Share sites along the National Road Network, initially there were three locations on the M9 indicated to Kildare NRO (Junctions 3,4 and 5). TII have now asked Kildare NRO to assist with Park and Share sites on the N11 and on the N3 at the Meath Cavan border and a further one on the M9 (junction 9). The priority is the M9 and a consultant has prepared





an draft 'Ad Hoc Parking Report' for the M9 for junctions 3 through to 11 based on traffic surveys and windshield surveys on the M9 at junctions 3, 4, 5, 6, 7, 8, 9, 10 and 11. Junctions 3, 4, 5 and ( are to be investigated further at this time (the remaining junctions may follow in the future). Kildare NRO will now look at lands available around junctions 3, 4, 5 and 9 and work towards feasibility and options and will liaise with Carlow County Council regarding junction 5 and Kilkenny County Council regarding junction 9.

(Junctions 14-12). Until 15 July 2024 M4 Road Works Speed Limit Order NRO2-2024. (Junctions 6 – 5). Until 02 December 2024 M7 Road Works Speed Limit Order NRO4-2024. (Junctions 14-12) – Starting 19 June 2024 until 23 August 2024.

## N78 Athy to the M9 Pavement Scheme

Funding requested from TII for pavement testing and topographical surveys to commence a pavement rehabilitation scheme on the N78 from Athy town to the M9 motorway. No response yet.

## Transport Infrastructure Ireland (TII) Active Travel Severance Seed Funding

Application made to TII for funding for four active travel measures crossing the M7 (one) and the M4 (three), however there have been hundreds of applications from local authorities





around the country and only a small number of projects will receive funding.

# New Machinery Yard Relocation and Regional Salt Barn

The official opening of the project took place on 27 May 2024. Machinery yard outdoor staff and drivers are currently moving to the new building, and this is substantially complete.

A contract has been awarded for consultancy services for traffic management and operational plans for the development, in line with Department of Transport requirements. A draft traffic management plan has been completed and is under review. An operational plan for the development has commenced and will be developed over the coming months. A tender process has been commenced for a teleporter for the new machinery yard. Maynooth Eastern Ring Road The CPO has been approved by An Bord Pleanála. The project team is now focusing on completing the CPO administrative procedures, completing the detailed design and compilation of tender documents.

The DHLGH (administrators of the Local Infrastructure Housing Activation Fund (LIHAF) element of the scheme) have been informed accordingly. The first few LIHAF landowners were met in February to appraise them of status of project.

## Celbridge Hazelhatch Mobility Corridor

It is expected that the Compulsory Purchase Order (CPO) and Planning Consent will be submitted in Q3 2024. DHLGH / URDF team have been kept informed and expect/require a Business Case to be submitted. A draft has been completed and this will be finalised and submitted once the CPO and Planning Consent are submitted.

Murtagh's Corner/ Corban's Lane The Project Team are in the process of putting a brief together, to expedite this project.





Maynooth Transport Strategy The ABTA is complete and is due to be published in June.

Newbridge Transport Strategy AECOM are finalising the ABTA document ahead of Phase 2 consultation which is due to take place in June 2024.

#### **Junction Programme**

Phase 1A and 1B of the Rural Junctions Improvement Project is for the delivery of five separate schemes each (10 in total), which are to be delivered in tandem. Consultants are O'Connor Sutton Cronin (1A) and Clandillon (1B). Option reports have been received for both phases and these are under review by the project teams.

# Newbridge Southern Orbital Relief Road.

Planning permission 22/1504 for part of relief road and second bridge over the Liffey has been granted by Kildare County Council to Aston Ltd. Transport Department have been in contact with Department of Transport in relation to a funding application. R448 National Cycle Network Pilot The Project Team are working with the Department of Transport and Transport Infrastructure Ireland to progress this project. A design has been prepared by AECOM and a Section 38 public consultation is live at present with a closing date of 14 June. It is hoped to tender this project in July and start work on the ground before the end of 2024 subject to contractor availability.

## Sustainable Transport Section -Projects Update Maynooth North-South Corridor (Phase 5)

An allocation of €1,500,000 has been received from the National Transport Authority (NTA) to start construction of this scheme in 2024. Discussions continuing with Manor Mills Shopping Centre to agree a temporary works licence and a construction tender will be released on completion in Q3.

## Royal Canal Greenway (Maynooth-Leixlip)

An allocation of €2,750,000 has been received from the NTA and the





construction of this scheme is progressing.

#### **Green Lane Active Travel Scheme**

An allocation of €1,200,000 has been received from the NTA to start construction of this scheme in 2024. The scheme will be tendered in Q3 2024.

#### Naas to Sallins Greenway

An allocation of €225,000 has been received from the NTA in 2024. A Section 38 public consultation process has closed and report being prepared for the section of project along the public road (from Abbey Bridge to Osberstown Bridge).

# Sallins Village Active Travel Scheme

An allocation of €50,000 has been received from the NTA in 2024. The preliminary design of the permanent scheme is progressing.

## Celbridge Road Active Travel Scheme

An allocation of €75,000 has been received from the NTA in 2024. Following the Phase 2 A tender process to appoint a consultant to progress the Preliminary Design to public consultation has commenced. **Kilcullen Road Active Travel Scheme** Scheme substantially completed.







On 12 June, Ruth Gaj McKeever (LAWPRO) will give a presentation titled 'Local Authority Waters Programme – Structures and Opportunities'



## Athy Food, Beverage and Skills Innovation Hub



Construction works have officially commenced on 13 May 2024. Site setup has been fully completed. Dilapidation condition surveys, and asbestos surveys have been completed with supporting reports. Protection inspections were carried out identifying salvageable structural items (doors/windows, flagstones, etc). Hoarding licences progressed allowing works to commence on the demolition of the boundary wall to create planned new entrances. Wall realignment works envisaged to commence for week ending May/start of June.



An invitation has been circulated to stakeholders in the food and beverage sector in Kildare to Clonard Court on 28 June at 9:30am as we share the vision for The Athy Food, Drink, and Skills Innovation Hub.

## Kildare Craft, Creativity and Design Hub, Courthouse Kildare and Southwell's Unit

A suite of contract documents to be developed to procure an architect-led detail design contract for the development. Subject to planning and development regulations, tender package will be published to align with





an appropriate funding mechanism once identified.

Fashion, Textiles and Design Hub (former BOI Monasterevin) Capital funding for the proposed development of the former BOI building has been secured. A suite of contract documents has been developed to procure an architect-led detail design contract for the development. Tender documents to be peered reviewed. Subject to planning and development regulations, it is anticipated that the tender package will be published in Q3/Q4 2024.

Kilcock Green and Sustainable Enterprise Park Feasibility Study Kildare County Council; applied to the EU Just Transition Fund: Local and Regional Economic Strategies Support Scheme, as managed by Pobal in late January.

The application seeks to commission a master plan and technical support to achieve full planning, procurement, and a strategic business plan for the proposed development of the site as a 'Sustainable Growth Business Park'. Awaiting confirmation from Pobal on application status.

Age Friendly Ireland (AFI) Business Recognition Programme Economic Development completed a training session in May to accredit to accredit Life Credit Union with Age Friendly certification.



Economic Development will continue to work closely with Kildare County Council Age Friendly Team and Age Friendly Ireland to roll out a further training session in the coming months.

Erasmus+ Young Equine Innovators







The first onsite meeting for the Erasmus+ project was held at Holar University, Iceland, in late May. We are working with its university as well as project partners from Ireland, Sweden and Denmark to deliver the objectives of the project which is aimed at enabling pathways of innovation in Europe's equine industry with a special focus on young innovators and trainers.

## Kildare County Council Industrial Estate Enhancement

Signage infrastructure for three of the industrial sites have been manufactured and are to be supplied and erected by June. It is anticipated the contractor's works will be completed to align with signage erection including greening and final enhancements.

#### Tourism

During the month of May the Tourism team held two information nights (Clane and Castledermot) and one webinar on the EU Just Transition Tourism fund. Through the fund 41 potential

applicants from Kildare were engaged,

including 31 businesses and ten Community Enterprises. Of these, ten Expressions of Interest were deemed eligible and one application for the fund has already been submitted. There are currently 15 expressions of interest awaiting assessment by Failte Ireland.

The Tourism team facilitated a meeting between Kildare County Council's Planning department and Coillte to discuss collaboration to enhance tourism and Forrest Recreation.

#### K-Hub Activity:

MERITS in Naas hosted a number of training and capability-development programmes in May including a Masterclass in UX and UI Design.

MERITS continues to facilitate a pilot Coder-Dojo project and the most recent iteration of the MERITS-led, LEO Tech PreAccelerator Programme commenced in May with 14 founders taking part.

MERITS also welcomed visits from two separate delegations - a group from Shandong Province in China and a separate group from Tulsa State University in Oklahoma.





The Hub team attended the Dublin Tech Summit 2024 in the RDS, networking and collaborating with thought leaders and founders from the tech industry.
