Budget 2026

Relocation of Beneficiaries of Temporary Protection in State Accommodation

With the declining demand for accommodation for people fleeing the war in Ukraine some existing accommodation centres across the country will be closing, returning to their original use or an alternative use. This will result in the relocation of existing residents to alternative accommodation (see page 31).

Community Climate Action Program Fund

Twenty-four projects were approved by the Department of Environment, Climate and Communications (DECC) for the Community Climate Action Fund Grant. Grantees have 18 months to complete the projects and since the grants were finalised in September, ten of the projects have been completed (see page 48).

Erasmus+ Repower Regions

Kildare County Council, in collaboration with twelve European partners, continues to progress the Erasmus+ Repower Regions project, which aims to strengthen regional cooperation and skills development in the heating and cooling sector. 

The National Famine Way Roadshow came to Leixlip Community Library, on Wednesday 21 May. This is part of a nationwide initiative designed to engage communities in the heritage, history, and legacy of the Famine through the story of the 1,490 walkers from Strokestown to Dublin. The fascinating talks were very well received by the large turnout that attended. Speakers included Caroilin Callery, National and Global Famine





Way; Dr. Jason King, Irish Heritage Trust; Kildare County Archivist, Karel Kiely who spoke about the Poor Law Unions that served Kildare and the three workhouses at Athy, Naas and Celbridge.

Kildare Libraries say Welcome: Kilcock Branch Librarian, Siobhán, was on hand on Saturday 24 May to support the local community for Africa Day 2025; Kildare Libraries also provided a professional face painter to the delight of the children on the day.

Librarian, Catherine, showcased her storytelling skills and entertained the children with traditional African traditional folktales and a book display in Celbridge Library.

The Athy Library opened on Sunday 25 May for Bernie and Jane Sanders visit. Jane traced her roots back to Athy, and found she still has family locally. The visit was part of the "Made of Athy" series, with a plaque unveiling commemorating the anti-war song 'Johnny I hardly knew ye' and a music session in the town. Athy Library hosted over 180 guests.

At Kildare Town Library, illustrator David Butler recently launched his

graphic novel celebrating the life of Irish Antarctic explorer Tom Crean which was written by Michael Smith. The special guest speaker was Ivan O'Brien of O'Brien Press, and the book was launched by Kevin Kenny of Athy Shackleton Museum.

Kildare Arts service hosted one of eight professional development sessions available to Kildare musicians on Monday 12 May - Approaching Media: How to use media to grow your reach. This April and May First Music Contact partnered with Kildare Arts Office, as well as arts offices in Galway City, Galway County and Roscommon to deliver a high level of professional development series to musicians in Kildare as well as creating an opportunity for musicians to give feedback on what local





supports are needed to develop a career as a professional musician.

First Music Contact is the leading national music organisation for resourcing popular musicians and the independent music sector in Ireland.

This new Regional Development Project aims to develop a way of offering equal access to professional development services to musicians all around Ireland as well as developing a framework for supporting artists at a local level.

VECTOR Digital Arts Residency

Open Studio

On Thursday, 22 May colleagues from the Kildare County Council and local art world were invited to the open studio of 1iing Heaney at MERITS as part of the new VECTOR digital arts residency initiated by Kildare Arts Service. 1iing has been working at MERITS since January 2025 and has been working on new projects using exciting augmented reality glasses (Hololens) and other new tech available at MERITS. During her time at MERITS, 1iing has been developing artwork examining environmental loss using Ireland's ancient oak forests, as a reference point. At the open studio,

1iing presented previous work, alongside current research documents and visual experiments from her practice at MERITS since January 2025.

Performing Arts Forum, Limerick Gathering Conference

The Arts Service attended a two-day Performing Arts Forum, the Limerick Gathering on 27 and 28 May. This important annual event in the performing arts calendar took place this year at the Lime Tree Theatre for two days of conversation, provocation, inspiration and included performances by Limerick musicians, comedians, dancers and arial performers.






The Council recently issued a public tender for a new or upgraded SAN, which serves as the primary digital storage infrastructure.

Housing

Social Housing Delivery – Public Private Partnership (PPP) Schemes

On 05 June, the Council received notification from the Department of Housing, Local Government and Heritage (DHLGH) that they had decided not to award the contract for PPP Bundle 3 which involved the construction of 486 homes nationally, including our site at Ardrew, Athy (73) social housing units and a community building). The Department advised that the decision not to award the contract was made following a cost evaluation but that they remain committed to delivering the social housing that PPP Bundle 3 was designed to provide. They indicated that the homes to be provided under PPP Bundle 3 will be delivered by way of an alternative procurement and delivery strategy and that the investments already made in securing planning consent and progressing design work will not be lost and will in fact facilitate delivery of the 486 homes as expeditiously as possible under a new procurement and delivery strategy.





As part of the decision not to progress to award the contract for PPP Bundle 3, DHLGH advise that they are initiating a review, in collaboration with the National Development Finance Agency, of PPP Bundles 4 to 7 to ensure value for money and that the most appropriate delivery strategies

are used to ensure homes proposed under PPP Bundles 4 to 7 are delivered.



Integration

General

Numbers of New Arrivals

The number of people arriving in the State seeking temporary protection or international protection continues to decrease.

Accommodation Recognition Payment (ARP)

The ARP was extended in March 2025 until March 2025. A second order was signed on 30 May to reduce the payment from €800 to €600 commencing on 01 June 2025. As payments are made monthly in arrears the first payment at the reduced rate will be received by hosts on 08 July.

Recent Developments Further Extension to Temporary Protection Directive

The political agreement has been reached at the EU Justice and Home Affairs Committee on the 13 June

2025 to extend Temporary Protection status for Ukrainians until March 2027. The Council will formally adopt the decision to extend the temporary protection at one of its upcoming sessions.

Eyre Powell Hotel, Newbridge

Fire Safety remedial works at the Eyre Powell are complete and Kildare Fire Service has confirmed that the Fire Safety Notices in place for the building have been lifted.

Ryevale House, Leixlip

A recent decision by An Bord Pleanala on the use of Ryevale House has been referred to the Courts for Judicial Review. The case was expected back before the Courts on 12 May 2025 but





has been further put back until 11 June.

Former Kilcock Convent and Nursing Home

The Community Engagement Team in Department of Justice, Homeland Affairs and Migration has confirmed that that the Department had previously received an offer of potential accommodation for people seeking international protection at Shalom Nursing Home,16 R148 Church Street, Kilcock, County Kildare but the property is no longer under consideration.

Relocation of Beneficiaries of Temporary Protection in State Accommodation

With the declining demand for accommodation for people fleeing the war in Ukraine some existing accommodation centres across the country will be closing, returning to their original use or an alternative use. This will result in the relocation of existing residents to alternative accommodation.

This process of accommodation portfolio consolidation was paused

during March 2025. This process has recommenced and the relocation of residents from some of the centres identified for closure will begin in June 2025. The link below provides details of the centres where contracts for the accommodation of Beneficiaries of Temporary Protection are finishing over the coming months.

Accommodation centres returning to original or alternative use

Local Authority Integration Team (LAIT)

Local Government Ireland

The Local Authority Integration Teams (LAITs) have been set up in all local authorities to facilitate coordination of the different kinds of support available for people who are applying for international protection, refugees, and others in similar situations. The goal of LAITs is to help IP applicants and refugees become independent, settle into their new communities, and participate in Irish life. They do this by connecting people to important services that can help them integrate into the community. The LAIT is part of a national government policy - White Paper to end direct provision





(February 2021) - and a new international protection service model grounded on supporting the principles of 'integration from day one'. The LAIT identifies needs through outreach work and clinics in accommodation centres and in the community, and provides the necessary information, advice and guidance so individuals and families can access services locally appropriate to needs.

Clinics

Kildare LAIT organises regular drop-in information clinics in IPAS and BOTP centres, that allow service users to access Integration Support Workers on 1:1 basis. This has fostered strong relationships between service users, accommodation providers, and other services. From the beginning of the year, as to the 16 June 2025 the LAIT has organised 50 clinics (one-to-one session between a service user and the Coordinator or an Integration Support Worker), four group clinics (sessions held by the LAIT for multiple people at once) and nine informal sessions (where service users can meet staff and learn about available supports). In this way the LAIT has supported 299 people (137

beneficiaries of temporary protection and 151 international protection applicants and 11 persons with status) in state-funded accommodation centres in Kildare.

Queries

From the beginning of the year, as to the 16 June 2025 the LAIT has received 655 queries, and resolved 636. Out of those, 346 queries were raised by beneficiaries of temporary protection, 213 by international protection applicants and 93 by persons with status. Most of the queries are received in the information clinics, others are received by email, drop-ins or outreach visits to the centres.

Queries raised by persons with status accommodated in IPAS centres: on going queries about employment and enterprise; community groups and networks; family reunification; and housing and tenancy supports.

Accommodation moves for those with status: Families with status who have been in IPAS centres for over a year after receiving status have been requested by IPAS to seek independent accommodation before





the 01 July 2025. De Paul Ireland is responsible for supporting these families to source alternative accommodations and are directly funded by IPAS to provide this support.

Queries raised by International
Protection Applicants in IPAS
accommodation centres: queries about
labour market permission and
employment supports; access to
employment and third level education;
queries related to immigration;
revenue and taxation; financial and
budgeting support; sports and
wellbeing; volunteering; adult
education and literacy; and delays with
medical cards.

Queries raised by persons with temporary Protection: Most queries were related to access to medical cards and primary care services and public health; job search and work experience; financial and budgeting support; and private accommodation search. On going queries about the UCTAT absence policy. Vulnerable groups in UCTAT emergency accommodation include children, youth and adults impacted by loss.

LAIT Activities

LAIT Information Session on the differences between Temporary and International protection delivered in partnership with UNHCR Ireland in Kill Full Board DAC on the 11 June 2025 with simultaneous English Ukrainian interpretation onsite. Attended by 28 residents.

LAIT Monthly Women's Group holds meetings with vulnerable residents in IPAS accommodation centres for single women. Linking residents with the local library, and community centre, and key service providers such as Kildare Sports Partnership, Kildare County Council Community Workers and CKLP New Communities Worker among others.

Networking

- Kildare LAIT continues participating in the National Asylum Support Network and the National Ukraine Civil Society Forum connecting civil society and community responses into the State's response structures supporting reception and integration.
- Collaboration with Naas Library in hosting an activity to mark <u>Refugee</u>





- Week Ireland Get involved which runs from 16-22 June. Refugee Day is on the 20 June.
- Kildare LAIT attended the Immigrant Council of Ireland's National Integration Conference (22 May) in Dublin. The theme was "stronger and united, building the future of migrant integration together". The Minister of State for Migration, Colm Brophy, was one of the key speakers, he announced changes to the National Integration Strategy which was due to be published this year. The strategy will now be a National Migration and Integration Strategy, for publication in 2026.
- Ongoing collaboration with Kildare Sport Partnership, Kildare County Council Library Services, Kildare County Council Housing, Kildare County Council Community, Healthy Ireland, other local services, and national organisations.

- Engagement with LCDC
 Coordinator and SICAP Manager to support the request of additional funding to support new arrivals.
 Kildare LAIT provided an overview of statistics and needs and supported the funding application which was successful.
- Kildare LAIT attended the LGMA sessions to foster coordination and collaboration between the LAITs and the Sport 4 Empowerment (20 May) and Regional Literacy Programmes (10 June).
- Kildare LAIT is supporting the LGMA in the development of a Joint Working Model between the Tusla Separated Children Seeking International Protection Unit and LAITs, which focuses on supporting aged-out minors within the international protection process or with status. ISC is part of the Working Group at the request of the LGMA.





Current IPAS Accommodation Overview



International Refugee Resettlement Programme (IRPP)

On 10 September 2015, as part of Ireland's response to the migration crisis in central and southern Europe, the Government established the Irish Refugee Protection Programme (IRPP). Under this programme, the IRPP has seen the arrival of over 4,000 refugees under various resettlement strands, the largest of which is the UNHCR led programme.In December 2019, the second phase of the IRPP (IRPP II) was put in place to welcome up to 2,900 refugees through the UNHCR programme between 2020 and 2023 through a combination of resettlement and new community sponsorship initiatives. The new phase planned for 650 UNHCR resettlements in 2020, 700 in 2021, 750 in 2022 and 800 in 2023. This commitment was to be made up of a majority of Syrian refugees' resident in Jordan and Lebanon. The numbers assisted over this period was impacted by Covid 19.

Ireland's pledge for resettlement and humanitarian admission under Article 19 AMIF for 2023, along with forecasted resettlement numbers for 2024-2025 was submitted to the European Commission on 07 October 2024. Ireland pledged to support the arrival of 800 refugees under the UNHCR resettlement process from Lebanon and Jordan, with a further 100 humanitarian admissions from Afghanistan.

The programme has two strands, The Local Authority Resettlement
Programme and the Community
Sponsorship Programme.

The IRPP has worked with Local Authorities engaged in resettling refugees. Local authorities have housed approximately 3,000 programme refugees across Ireland. On 20 May, 2021, the County and City Management Association's (CCMA), submitted the new proposed model for distribution for IRPP II, CCMA HBLU IRPP II Model for Distribution". It is anticipated that the ongoing requirement for local authority accommodation to resettle refugees will require some 150 to 200 homes each year.

Through the model for distribution for IRPP Phase II, Kildare County Council has accepted the allocated quota of 66





refugees for 2024-26. The resettlement will be carried out in a combination of AHB and Kildare County Council housing units through various tranches planned for completion during the second and third quarter of 2025. The programme to date has resettled to date a total of 34 persons (fourteen adults and seven children) in County Kildare. The remaining families are scheduled to be resettled before the end of 2025, reaching the agreed quota of 66 refugees (before January 2026) under this agreement.

A delegation from the IRPP travel to refugee camps and select, interview and vet the families identified for the programme. Families are brought to Ireland and accommodated initially in Reception and Orientation Centres until such time as they are linked with Local Authority's who have sourced suitable accommodation. Families are accommodated in social housing units either by Kildare County Council or our partner Approved Housing Bodies operating in the county.

Families participating in the programme receive direct integration

supports funded by AMIF (EU funds) through the DECDIY with a view to achieving the best possible outcome for each individual and family. County Kildare Leader Partnership (CKLP) was identified by Kildare County Council through a tender process as the implementing partner for the provision of appropriate postresettlement supports for a set period of 18 months. Integration supports are provided by an Integration Support Worker, and an Intercultural Support Worker, recruited at the end of July 2024. When the programme ends, Kildare LAIT will continue supporting these families. The overall programme is managed by the LAIT Coordinator.

The Refugee Resettlement
Programme is supported by the InterAgency Working Group (IAWG)
chaired by Kildare LAIT. The IAWG
have met on 01 July and 27
September in 2024 and on 31 January
and 07 April in 2025. The LAIT
Integration Support Coordinator
regularly provides updates to all the
relevant agencies engaged in the
programme.





The LGMA initiated at the beginning of 2025 a Working Group with all LAITs and local authorities participating in the IRPP to share good practice and lessons learned. Kildare LAIT has participated in three meetings arranged by the LGMA for this purpose and shared lessons learned and standardised practice and protocols.

Programme

Ukraine Services and Accommodation Team Offer a Home Scheme

The Accommodation Team manage the Offer a Home Scheme in County Kildare in conjunction with the Irish Red Cross (IRC) and International Organisation for Migration (IOM). Note that the supply of offers for OAH and pledged accommodation has reduced, due initially to the uncertainty regarding continuation of the ARP scheme but also due to the time of year where there is less availability of holiday homes. We will monitor activity as the ARP payment reduces from €800/month to €600/month.

The Ukraine Services and accommodation team liaise with other local authority's where surplus accommodation has been identified. These offers are usually in rural locations.

Designated Accommodation Centres (DAC's)

DAC's were established to accommodate Beneficiaries of Temporary Protection arriving in the State after 14 March 2024.

The Integration Team hold Day-75
Clinics in the Punchestown DAC on a fortnightly basis to assist residents with the sourcing and matching of accommodation. A clinic was held on 28 May 2025 with further clinics scheduled for 18 June and 01 July 2025.

Accommodation of International Protection Applicants:

The area of responsibility also extends to appraisal of properties referred to





Kildare County Council by the
International Protection
Accommodation Service (IPAS) in
DCEDIY for accommodation of IPA's.

A technical working group (TWG) has been established in Kildare County Council to access accommodation proposals referred to Kildare County Council by DCEDIY, IPAS/IPPS and the LGMA and continues to deal with queries related to existing and proposed accommodation. The most significant developments in accommodation for International Protection Applicants are detailed above.

The Community Integration Forum

Meetings are taking place the first
Wednesday of each alternative month
chaired by the Director of Services for
Integration with targeted, thematic
meetings to address specific items on
each alternative month. The last CIF
meeting took place on the Wednesday
04 June 2025 online. The next CIF
meeting is scheduled the first
Wednesday in September 2025.
Additionally, a thematic meeting on
Children and Youth is planned for the

17 September, which will be facilitated by CYPSC.

The role of the Community Integration Forum is to enhance information sharing, collaboration and coordination among service providers to maximise integration supports outcomes. Membership includes Kildare County Council (LAIT, Accommodation Team, Community Services/Sport Kildare Partnership, Library Services/Creative Communities); Citizens Information Centre; An Garda Siochana; CKLP; Irish Red Cross; KCCC; Kildare Children and Youth People's Services Committee (CYPSC) hosted by Tusla; In Sync; KWETB Board; Regional Education and Learning Team Coordinator; INTREO, Department of Social Protection; Tusla Prevention, Partnership and Family Support (PPFS) Kildare West Wicklow (KWW) HSE Social Inclusion Team; Local Link.

The role of the Community Integration
Forum is reflected in the LCDC (Action
1.7.7 KCC-LAIT). The Migrant
Integration Strategy is much broader
and implemented through local
community strategies.





Kildare County Council completed a survey prepared by the LGMA gathering information on how the Community Integration Forum (CIF) is operating locally in Kildare (21 March).

Climate Action Regional Office (CARO)



The Climate Action Regional Office (CARO) works to support local

authorities to drive climate action in their jurisdictions and coordinate activities to promote effective climate action across the local government sector. For more information on the work of the CARO, see our website at www.caro.ie





Kildare County Council is the host local authority for the Eastern and Midlands (EM) CARO, one of four CAROs working as a shared service within local government on climate. There are 17 local authorities within the EM CARO region.



The CAROs are funded by the Department of Environment, Climate and Communications (DECC) and work through the four lead local authorities by way of a Service Level Agreement (SLA) to mid 2029.

Local Authority Climate Action Training Programme



Training Service Level Agreement between Kildare County Council and the Department of Environment, Climate and Communications (DECC) signed as of 01 June 2024. This marks the start of second phase Climate Action training for the sector.

Executive Training Group for oversight of training delivery for 2025 convened its first meeting on 15 January 2025.



Local Authority Climate Action Plans (LA CAP)

Review of all 31 LACAPs to ascertain robust information on action typology, is now complete. A robust central database is in place that can be utilised to identify commonality of actions to support local authorities to work together, to inform of action prioritisation, reveal challenges in implementation, to help identify pertinent case studies and inform reporting and monitoring requirements. A PowerBI module has been used to aid the generation of reports for sectoral stakeholders.

Sub-Regional Energy Projects

The EM CARO is working with local authorities in each of the four subregions to develop regional energy units to avail of funding for projects that support the decarbonisation of local authority buildings. The energy units comprise:

Mid-east (Kildare, Meath, Wicklow and Louth), commencing projects and accessing Pathfinder support from SEAI.

Midlands (Laois, Offaly, Westmeath, Longford, Roscommon), have developed their project pipeline and sourced funding to match Pathfinder support.

Border (Cavan, Monaghan, Leitrim)
are working with project manager
assistance from SEAI to build a project
pipeline.





South-east (Carlow, Kilkenny,
Tipperary, Wexford, Waterford City
and County) have issued a position
paper to SEAI for their consideration.
Further discussion will continue to
progress to MOU stage.



Reimagining Local Authority Fleet

The EM CARO supports the reconfigured working group established to explore support and options for local authorities on fleet decarbonisation and is now working to finalise recommendations for the CCMA on support for fleet decarbonisation into the future.

Development of Local Authority Key Performance Indicators (KPIs) on Climate Action



Data collation for 2024 completed on 07 February 2025. This process

collects data relating to ten KPIs. This data works to highlight the sectoral performance of the network of local authorities on Climate Action.

Report to be published mid-year.

GAA / CCMA Green Clubs Programme:



The EM CARO continues to work with the GAA and expert partners to advance the Green Club Programme. A recognition event was held in Croke Park on 09 November 2024 to celebrate the work of over 70 clubs from Phase two of the Programme. Phase three is now open to c 400 clubs to work their way through a range of sustainability and climate action related projects as provided for by Green Club Toolkits covering the





five themes of Energy, Water, Waste, Biodiversity and Travel.

Kildare County Council Climate Action Kildare Climate Action Office



Inspiring change, shaping tomorrow

The CARO office provides support to the Climate Action Office (CAO). In turn the CAO assists the functional and operational areas of the council to decarbonise their roles and work through the members of the Climate Action Team and Energy Management Team together with the Senior Management Team.

Augmented Reality Image Maynooth:

Additional funding allocated by Kildare Arts Section to gamify the augmented reality piece.

Energy Updates: ISO 50001:

The Council are working toward ISO 50001 Certification. SGS have been appointed as the Certification Body. Stage 1 Audit is scheduled for 19 June, this will determine our readiness for Stage 2 Audit which is scheduled for 05 August to 07 August 2025. The Stage 2 Audit will determine if we will be recommended for Certification. SEU owners (Public Lighting, Fleet, Leisure Centres and Facilities) as well as a representative for Procurement and Design (Architects and Fire or Libraries), will need to be available on the dates above.

Energy Management Team:

Energy Team meetings are ongoing; two were held this year (30 January and 01 April) and there is one more scheduled for June. Meetings are well attended, and engagement has been excellent.

Energy metering and monitoring is being considered for the Significant Energy Users to establish energy consumption profiles.

Staff Energy Awareness

Free one to one Energy Clinics were setup online with the Optimising Power at Work Campaign for 09 and 11 April





2025. All 20 appointments were booked up within a few hours. We hope to organise and offer further clinics later in the year.

A Staff Energy Awareness Day took place on 29 April from 10.00am to 2.00pm with experts attending from across the industry focusing on improving Home Energy. Information stands representing Heat Pumps, PV Panels, One Stop Shops, Optimizing Power at Work, SEAI, Codema and Green Loans.

Energy Performance Contract

The Energy Performance Contract (EPC), for Aras Chill Dara and K
Leisure Naas and Athy has moved to
the next stage. Outline Solution reports
were received from two Energy
Service Companies (ESCo) on 12 May
2025. We have moved to Competitive
Dialogue Stage, interviewing the
ESCos based on their reports and
finalising our client requirements. Inperson interviews will be held in early
July.

District Heating (DH)

Codema have finalising the DH feasibility study for Naas. Maynooth feasibility study has commenced. The

latter is in conjunction with the Strategic Projects and Public Realm Team with funding from SEAI and URDF.

An opportunity is being explored to realise DH in Maynooth and possibly Celbridge area.


DISCO Project:

'Advancing District Heating and Cooling solutions for efficient waste heat utilisation' in conjunction with CODEMA as associate partner has successfully received 70% Interreg Europe Funding. This will enable the task under action B13 of Kildare County Council CAP to perform a county-wide assessment of waste heat and district heating. Kick off occurred in April of the ten countries involved with Sweden leading the project. The first in-person consultation session and site visits of various District Heating and Circular Economy examples were held in

Energy Audits:

Aalborg, Denmark in April.

The Energy Audits for Athy and Leixlip Libraries have been finalised. The documents will help to inform the works to be undertaken. We are





preparing a tender for decarbonising of Athy Library due to the conservation constraints and Leixlip Library in 2025. An Energy Audit has been carried out on Athy Municipal District offices and we are awaiting the initial report.

SEAI Monitoring and Reporting:

The SEAI M&R reporting window for 2024 closed on 16 May and we are awaiting the final verified 2024 position on Kildare County Council's progress towards 2030 targets.

SEAI Pathfinder Strategic Review:

Request for information on match funding has been returned to enable the SEAI to reinforce their next five-year business case and outlining challenges Kildare County Council will have in meeting finances.

Critical Success Factors Audit

A meeting took place with SEAI regarding M&R and decarbonisation progress on 10 March. We are awaiting the final report but Kildare is progressing well.

Staff EV (Electric Vehicle) GoCar

The dedicated charge point has now been installed and commissioned.

Sports Partnership will also have use of the charge point and are awaiting the arrival of their electrically powered van.

A tender for the supply of a shared car service is being progressed by the Sustainable Transport Section.

SMT presentation:

A further update on Kildare County Council's energy status will be given on 08 July ahead of the ISO 50001 Stage 2 External Audit.

Community Based Projects:

Our Shared Plate:



The project is going from strength to strength with three active community efforts in Maynooth, Newbridge and Athy. Maynooth University continues to monitor the social effects and Neighbourhood Networks are advancing plans with the groups to create community gardens. The 18 month programme has seen the planting of trees this winter, edible





hedges and vegetables. Presently, a tool kit is being developed to provide scalability and longevity to the programme.

Picnic in the Park:

The annual collaboration with Maynooth Community Council was held on Sunday 15 June (Father's Day) from 2.00pm to 5.00pm in Harbour Field Maynooth. The collaboration is resulting in over 40 stands and activities providing climate action items through creativity and fun to nudge people towards sustainable lifestyles.

Community Climate Action Program Fund:

Twenty-four projects were approved by the Department of Environment,
Climate and Communications (DECC) for the Community Climate Action
Fund grant. Grantees have 18 months to complete the projects and in the time since the grants were finalised in September, ten of the projects have been completed. The second recoupment application has been approved by DECC. The third recoupment application was submitted by 14 June.

Climate Design Lab:

The first two innovations will be available to see at Picnic in the Park.

The remaining innovations are in various stages of concept and design.

Climate Innovation Fund (CIF) 2025:

We thank all for their consideration of LPT funding for 2025. CIF to assist Grassroot Innovation in Climate Action. Based on LPT funding made available the Climate Action Office is formulating a plan of approach for this year.

One of the projects funded in 2024 was a film written and produced by youth in the Kildare town area. The short film is called 'Dance of the Cranes' and a special showing for all involved has been sponsored by the Odean Cinema, Newbridge.

Grass to Gas and Alternative Maintenance:

The launch of the 'Grass to Gas
Dashboard' took place in the chamber
on the 28 April from 2.00pm3.00pm. Maynooth University's
Terrain-Al team presented the
dashboard and findings. A





presentation was made at the Climate Action SPC on 14 May.

CARO organised a national webinar based on the work to date on 16 May to inform all Climate Action Offices. A further national event is planned for October with additional presentations being made where requested.

Climate Action Awareness Building Climate:

To act, we must first understand what climate change is and the causes.

The 60+ programme in Maynooth is very well attended, using a cup of tea to explain the concepts.

Monica Hayes, Climate Graduate, with a background in education and communications, has worked closely with LEO to provide training to students in Athy and Monasterevin. We are working with Libraries to assist them with outreach programme to increase awareness and action behavioural change.

The Public Participation Network (PPN) with the assistance of the county SEAI Mentor are utilising a visit to the DemoHouse during Climate Action Series 22 May to 24 May.

Climate Champions has been launched in Maynooth. Nominations have been assessed, and nine winners were announced at Picnic in the Park on 15 June. Listen to our podcast with Marian Higgins, Director of Service and Paul Regan, Decarbonising Officer to learn more

Demo House:

Over 200 people have visited the house to date. Various bodies such as the SEAI, LGMA, DCEE, IPB have visited the house. The reactions have been very favourable from all visitors. They have found the house and curtilage an inspirational space to discuss and examine the 'Show and





Tell' items to further their joint understanding.

Environment

National Waste Management Plan for a Circular Economy

The Waste Management Act 1996, requires each local authority to make a Waste Management Plan. The Regional Waste Management Planning Offices, under the auspices of the County and City Management Association, co-ordinated the preparation of the National Waste Management Plan for a Circular Economy 2024-2030. The Plan sets out a framework for the prevention and management of waste in Ireland for the period up to 2030.

The NWMP for a Circular Economy 2024-2030 was formally launched on 01 March 2024.

The Plan has reviewed the current waste management situation in Ireland and used key drivers and policy proposals to project future trends to identify a range of challenges to be managed over the lifetime of the Plan. The Plan now sets out policy

responses and actions to address the current and future challenges identified and provides a delivery roadmap to help navigate the Plan period

National Deposit Return Scheme

The National Deposit Return Scheme (DRS) was launched by the Department of Environment, Climate and Communications in February 2024. The DRS is a circular economy initiative, focused on plastic bottles and aluminium/steel cans.

The scheme is operated by Deposit Return Scheme Ireland (DRSI) CLG trading as Re-turn.

Larger retailers have installed Reverse Vending Machines (RVM's) at their premises to automate the deposit return process. Smaller retailers will operate the scheme on a manual, over-the-counter basis.

The local government sector has the responsibility for monitoring compliance and enforcement of the Deposit Return Scheme.

National Tidy Towns 2024

The Tidy Towns competition involves participating areas being rated on





various aspects of their local environment.

Silver medals were awarded to Ballymore Eustace, Kilcullen and Rathangan.

Broadford received a bronze medal and Kildare town received a special Endeavour award.

Tidy Towns Event

A workshop was held with Tidy Towns Groups with presentations given by the Biodiversity Officer, Climate Action Co-Ordinator and Cormac McCarthy, former national adjudicator for Tidy Towns. The event was well attended.

Irish Business against Litter (IBAL)

Naas topped the rankings as the cleanest town in Ireland by Irish Business Against Litter (IBAL) in their 2024 survey.

This is the third time in four years that Naas has finished atop the rankings.

Maynooth, a former top-ranking town in the IBAL litter league, also performed well achieving status

"cleaner than European norms" and fifth place overall in the IBAL survey.



Litter Management Plan

A draft of the Council's Litter

Management Plan is currently out on
public consultation. It will remain open
for submissions until Wednesday, 09

July.

Entente Florale 2025

Kildare County Council is supporting the nomination of Maynooth in the Large Town Category for the Entente Florale Europe Competition in 2025. Judging will take place on 12 July.

Ireland's Best Kept Towns Competition 2025

Naas Tidy Towns have been nominated by the Department of Rural and Community Development to participate in Ireland's Best Kept Towns Competition 2025 for the Best Kept Large Urban Centre Award.





Adjudication took place anonymously during the month of May by two Adjudicators, one from the SuperValu TidyTowns Competition and one from the Best Kept Awards Competition. The results/Awards Ceremony is to take place in June.

Water Framework Directive

Monitoring and investigation work continue in the water priority areas under the Water Framework Directive. The council awaits the publication of the third cycle of the River Basin Management Plan for the period up to 2027.

This document is expected to be published this year and will set the priorities and areas for action over the next cycle.

Enforcement Priorities 2025

The NEP's have been reviewed and there is a reduction in the number of priorities for 2025, moving from 20 in 2024 to 15 in 2025. The breakdown is as follows:

Environmental Enforcement

The Environmental Protection Agency (EPA) published its report on the environmental enforcement performance of local authorities in 2023 on 03 December. The EPA's Local Authority Performance Framework measures and reports on performance against National Enforcement Priorities, focused on improving environmental compliance and achieving positive outcomes for water quality, air quality and waste management. The report shows that the scale of environmental enforcement work carried out by local authorities in 2023 was significant. For the second consecutive year, Kildare County Council was the only local authority in the country to achieve a "Strong or Excellent" score across all 20 National Enforcement Priority categories

The events, hosted by WEEE Ireland in partnership with Kildare County Council, commenced on Saturday 07 June from 10.00am-4.00pm at Kilcock GAA Club.


On Saturday 14 June, a collection took place at the Tesco Superstore,

The document establishes a strong vision for implementing excellent SuDS in County Kildare through the planning process and for the lifelong maintenance of SuDS landscapes.

Cemetery Capital Programme

This programme, which includes cemetery extensions, capital type internal improvements and proposals for columbarium walls is currently being reviewed in line with funding availability.

Columbarium Walls

Columbarium walls have been completed in Athy, Leixlip Confey, and St. Conleth's Newbridge cemeteries.

Grant funding

Applications for Tidy Towns and Cemetery Committee grants are now closed. The closing date was 16 April.





Legislation XL Bully Type dogs

The last date for receipt of applications for exemption certificates was 31 January, 2025. This certificate is unique to each XL Bully type dog and owner. It is now illegal to own an XL Bully dog without a certificate of exemption.

Amendments to the regulations have been notified which include an appeals process any dog confirmed to be an Bully dog born before 10 December 2024.

Local Community

Development Committee

A meeting of the LCDC and LAG (to oversee LEADER) took place on 28 May.

Annual Report:

The LCDC Annual Report 2024 was approved by the LCDC. Copies were left for elected members at Corporate. The LCDC oversaw €3.5m directly in 2024 and worked to oversee and lead on a number of programmes to support communities, particularly the most excluded to develop.





LEADER Programme:

Funding of €5.44 million has been allocated to Kildare to implement the Rural Development LEADER Programme 2023-2027.

There was one project approved for LEADER grant aid at the May meeting. Teach Tearmainn Housing were approved for LEADER grant aid of €11,152.80 to aid the development of their strategic plan.

Two new staff have joined the CKLP LEADER team as development workers: Sabrian Whelan and Christopher Morrison.

SICAP Programme:

Work is progressing to implement the Social Inclusion Programme SICAP across the county. An opportunity to apply for additional funding to support new arrivals occurred in late May. A meeting with the KCC LAIT Team and CKLP was held. The LCDC made the application based on this meeting to request an additional €45,000 to support enhanced English language classes, health and wellbeing initiatives, transport and day to day essentials. The SICAP mid year review

will take place as part of the July LCDC meeting.

Sláintecare Healthy Communities:

The LCDC approved the seed funding of €75,000 available as required by Department of Health by 30 June 2025. This funding will be used to support a) Neurodiversity and Inclusion supports, b) Trauma informed practice training c) Children's Recreation and Play in Castlepark, d) Older Adults Living Well.

Work is very advanced to open the Athy Wellbeing Hub (kiosk) and Slaintecare continues to progress a range of initiatives in Athy.

Healthy Ireland:

Pobal approved the HI Report 2024 and plan 2025. Work is underway to transfer funding to the approved projects. The Healthy Ireland Coordinator is progressing the Plan for 2025 and working with a broad range of organisations.

Local Enhancement Programme 2025

These grants were approved at LCDC in March, the outcome cannot be





announced until the Department issue their press release.

Family Resource Centres

Minister Foley recently announced that five new Family Resource Centres will be established nationally in 2025. The LCDC Co-ordinator and LECP Coordinator, worked to highlight awareness of this opportunity and to support any applicants practically. There was close liaison with the CYPSC Co-ordinator. Two applications in Kildare were submitted by ACDAL and Leixlip Youth and Community centre. There is a real need to establish FRCs in both areas. Letters of support were given by the LCDC, Kildare County Council and other LCDC representatives to accompany the applications.

Local Economic and Community Plan (LECP)

A presentation was made on the progress to establish an online monitoring tool developed using Microsoft Lists. Training is taking place with organisations leading out on actions. A progress report will be prepared at the end of 2025.

Work has also advanced to develop an online portal to access Census 2022 and other updated data sets.



The M4 Eastbound Bus Priority
Measures are being constructed by the
TII MMaRC contractor and there is a
speed limit reduction order on the M4
between junctions 5 and 6 until 31
August 2025 to facilitate the pavement
works and completion of the civil
works.

The contractor is aiming to have all the pavement and civil works completed no later than the end of the summer.

The ITS (Intelligent Transport Systems) works may be completed in tandem or will follow e.g. electronic gantry signage. However, the ITS works will be less intrusive and should not require the varioguard and/or speed limit order.

The contractor must wait until after the bird breeding and nesting season before commencing installation of noise barriers to safeguard nesting birds and other wildlife. Legislative changes are required to allow buses travel in the hard shoulder and the preparation of the new legislation is


