

Kildare County Council has today published its Gender Pay Gap Report, highlighting the percentage difference between what men and women are paid on average in the organisation, irrespective of roles or levels.

The 2024 report shows a Gender Pay Gap of -3.87% mean and -12.45% median.

### Kildare County Council Allotment and Community Garden Strategy 2024 – 2030



Kildare County Council is excited to publish its first Allotment and Community Garden Strategy – which aims to develop a pilot programme of allotment and community garden projects to be delivered across the county over the next six years.

The popularity and rise of allotments and food growing as a land use and leisure pastime was recognised by the inclusion of an objective in the Kildare County Development Plan 2023 – 2029. The case for allotments and community gardens received strong support through a public interest survey which garnered c.1350 responses, with people and communities right across County Kildare requesting allotments and community gardens. # Finance, Digital Services and Innovation

#### **Finance**

#### **Revenue Account**

The 2024 Annual Financial Statements (AFS) are currently being prepared.

The draft AFS will be brought to the Members once complete.

#### Cashflow / Overdraft

Kildare County Council manages its cashflow requirements daily and did not avail itself of its overdraft facility in 2024.

#### **Risk Management**

A review of the corporate risk register will take place in January 2025. The Head of Internal Audit, Risk and Governance is working with the sections on this review.

## Increased Cost of Business Grant/Power Up Grant

The total amount paid to small and medium businesses in Kildare by way of ICOB and Power Up Grants in 2024 by Kildare County Council on behalf of the Department of Enterprise Trade and Employment in 2024 is €16.97million.

The first ICOB grant was equivalent to 50% of each customer's rates bill up to a maximum grant of €5,000. A total of €6.25 million was paid to 3,187 small and medium businesses in County Kildare who had a rates bill of less than €30,000 (78% take up). The second ICOB grant totalling €3.7m was paid to 1,807 businesses in the Retail and Hospitality industry. A third grant called the 'Power Up' grant was announced in Budget 2025. Those businesses who received the second ICOB retail and hospitality payment could receive a further €4,000 payment each before the end of 2024. 1758 payments totalling €7.02 million were paid in December 2024.

#### Rates

New legislation regarding commercial rates took effect from 01 January 2024. The Local Government Rates and Other Matters Act 2019 effects the following changes:

Replaces the payment of rates in two moieties with one rates amount due on the first of the year.

Provides for the application of interest on unpaid rates from 2025. Interest will be added to rates bills issued from 2026.





Removes the requirement for public notice to be given regarding Kildare County Council's intention to 'make the rate'. This is replaced by a notice

advising that a 'rate has been levied'.

The Draft Kildare County Council
Rates Abatement Scheme in respect
of Vacant Properties (Vacancy Relief)
Scheme for 2025 was adopted at the
Budget 2025 meeting on 18 November
2024

The proposed scheme continues to give 100% vacancy relief to eligible properties but with an application limit of five consecutive years.

### Housing

#### **Private Grants Schemes**

In September 2024 the Government published the Report on the Review of the Housing Adaptation Grants for Older People and People with a Disability Scheme. Following on from this review the Department of Housing, Local Government and Heritage introduced significant revisions to the operation of the schemes. The changes are effective from the 01 December 2024.

The keys changes are:

The local authority contribution decreases from 20% to 15%.

An increase in maximum grant limits:

The Housing Adaptation Grant for
people with a Disability increases from
€30,000 to €40,000

The Housing Aid Grant for Older People increases from €8,000 to €10,700

The Mobility Aids Grants increases from €6,000 to €8,000 Income thresholds increased by 25%\*
\*Tables on changes to grant limits and income thresholds are appended to this report.

Arising from an EU directive, changes have been made to the funding of fossil fuel burners under the Housing Aid for Older People Grant. For applications approved on or after the 01 January.2025, funding cannot be provided for the purchase of new standalone fossil fuel boilers.

The grant scheme continues to be available for:

the repair of an existing fossil fuel boiler by a qualified contractor (oil or gas); or

the purchase and installation of a second-hand fossil fuel boiler by a qualified contractor (oil or gas).

Grants may continue to be paid in respect of electric or biomass central heating solutions i.e. wall mounted electric heaters or wood pellet stoves, where either are deemed to be a suitable option in line with applicant's circumstances.

Applications received and approved for fossil fuel boilers prior to the 01 January 2025 may be granted.

# Homeless Services Families in Emergency Accommodation at Christmas

#### **Cold Weather Initiative**

A Cold Weather Initiative is in operation (from 30 October last to 31 March) to provide additional emergency beds for rough sleepers where needed – ensuring that additional temporary beds can be brought into use across a range of existing services and facilities, for singles during periods of cold weather. The service is operated by the Peter McVerry Trust.

#### **Traveller Accommodation**

#### **National Caravan Loan Scheme**

The National Caravan Loan Scheme is continuing this year. The scheme offers preferential, discounted loans, for Traveller families to purchase a caravan / mobile for use as their primary residence. The loan limit has increased from €40,000 to up to a maximum of €80,000, in certain circumstances (for example, providing accommodation for larger households). An update will be provided to the Local Traveller Accommodation Committee at their next meeting on 11 February.

#### Integration

#### General

### Relocation for Beneficiaries of Temporary Protection

The Department of Children, Equality, Disability, Integration and Youth (DCEDIY) are continuing the process of consolidating their portfolio of contracted accommodation for Beneficiaries of Temporary Protection around the country. No existing accommodation centres in Kildare have been identified for closure in the short term.

# Designated Accommodation Centre (DAC) Severe Weather Arrangements

DCEDIY have reconfirmed that no exits will take place from DAC's while weather warnings are in place. There were no exits from Newhall or Punchestown during recent low temperature snow/ice warnings.

The Kildare County Council Integration
Team and the LGMA assisted Irish
Red Cross (IRC) and the International
Organisation for Migration (IOM) in
sourcing and matching of
accommodation for Beneficiaries of

Temporary Protection across the country using links with other Integration Teams. All Beneficiaries of Temporary Protection due to exit the DAC's and requiring accommodation up to and over the Christmas/New Year period were accommodated.

#### **Extension of Temporary Protection**

There are indications that Temporary
Protection will be extended for a
further year until 04 March 2026 in line
with the EU Temporary Protection
Directive.

## Accommodation Recognition Payment (ARP)

The ARP is directly linked to the Temporary Protection Directive (TPD) for the protection of individuals fleeing the Ukraine. There are ongoing consultations across Departments and the expectation is that the ARP will continue as is, with minor adjustments possible. Availability of the ARP is important to the supply of Offer a Home and Pledged accommodation.

### Recent Developments

#### Resources

Kildare County Council has received approval for one additional permanent





post for Integration Support Worker and one twelve month contract post Integration Support Worker to support the work of the Local Authority Integration Team.

Local Authority Integration Team (LAIT)

Local Authority Integration Teams | Local Government Ireland The Local Authority Integration Teams (LAITs) have been set up in all local authorities to facilitate coordination of the different kinds of support available for people who are applying for international protection, refugees, and others in similar situations. The goal of LAITs is to help IP applicants and refugees become independent, settle into their new communities, and participate in Irish life. They do this by connecting people to important services that can help them integrate into the community. The LAIT is part of a national government policy - White Paper to end direct provision (February 2021) - and a new international protection service model grounded on supporting the principles of 'integration from day one'. The LAIT identifies needs through outreach work and clinics in accommodation centres.

and in the community, and provides the necessary information, advice and guidance so individuals and families can access services locally appropriate to needs.

#### Clinics

From 08 March to the end of December 2024, Kildare LAIT has arranged 175 information clinics, 90 clinics in Ukraine Crisis Temporary Accommodation Team (UCTAT) accommodation centres and eight in IPAS accommodation centres. Through information clinics, Kildare LAIT has supported 1,035 people to access local services, overcome barriers related to access and resolve queries in 2024. Out of this, 590 were beneficiaries of temporary protection, 420 were international protection applicants and 25 persons with status in IPAS accommodation. In addition, Kildare LAIT conducted 41 outreach visits to 22 visits to UCTAT centres and 19 visits to IPAS centres to facilitate coordination of service providers and build the capacity of staff and management at these centres.





Kildare LAIT organises regular drop-in information clinics in IPAS and BOTP centres, that allow service users to access Integration Support Workers on one to one basis. This has fostered strong relationships between service users, accommodation providers, and other services. The team has furthermore developed a needs system based on regular communication with service users and accommodation providers that inform how often clinics are arranged at each centre.

Queries

From 08 March to the end of December 2024, Kildare LAIT has received 1,623 and solved 1,617 queries. Out of those, 927 queries were raised by beneficiaries of temporary protection, 568 by international protection applicants and 126 by persons with status.

Kildare LAIT in collaboration with the Hope and Courage Collective organised a successful workshops on understanding how the far right operates and how to counteract

disruption within our communities. The sessions took place on the 13 November and 11 December 2024 in Naas and was attended by 60 participants from the gardai, youth sector (including youth advocates), Childcare Committee, Citizens Information Centre, accommodation centres managers, Kildare County Council Library Services, Homeless Services, Integration Team, and the **DCEDIY Community Engagement** Team representatives. Kildare LAIT through Willow Community Counselling delivered a six week psychosocial activities programme with body-based trauma informed practices targeted at GBV survivors accommodated in an IPAS centre in Athy. The programme ends on 12 December and includes yoga, group meditation, breath work, dance/movement work and female






The current distribution of Beneficiaries of Temporary Protection nationally is as follows:





### International Refugee Resettlement Programme (IRPP)

Through the model for distribution for IRPP Phase II Local Authorities, Kildare County Council has accepted the allocated quota of 66 refugees for 2024-26. The resettlement will be carried out in a combination of Approved Housing Bodies and Kildare County Council housing units through various tranches 2024, and the second quarter of 2025. The first resettlement of three families took place at the beginning of October 2024 with two more resettlements due to take place in Q1 2025. The target is to have all 66 participants resettled in Kildare by the end of Q2 2025.

Integration supports are in place with EU funds through the IRPP/DECDIY with a view to achieving the best possible outcome for each individual and family. County Kildare Leader Partnership (CKLP) was identified by Kildare County Council as an implementing partner through a tender process for the provision of appropriate post-resettlement supports for 18 months through an Integration Support Worker, and an Intercultural

Support Worker (in place from the end of July 2024).

The Refugee Resettlement Programme is supported by the Inter-Agency Working Group (IAWG) chaired/facilitated by Kildare LAIT. The IAWG first meeting took place on 01 July to review and accept the terms of reference by all members and agree upon preparatory actions. A second meeting took place on the 27 September to coordinate the first resettlement, discuss the integration supports planned, and start planning for the second resettlement. The LAIT Integration Support Coordinator regularly provides updates to all the relevant agencies engaged in the programme.

### National Integration Support Coordinators and Integration Support Workers Networks

The LAIT continues participating in the Integration Support Coordinators (ISC) and Integration Support Workers (ISW) networks. The aim of these networks is to facilitate the sharing of tools and best practices across LAITs.

Integration Support Coordinators met on the 25 November 2024 to discuss





the implementation of the Refugee Resettlement Programme in their respective counties. Kildare LAIT shared lessons learned to date and provided advice to other local authorities about to embark in this programme.

### Accommodation of International Protection Applicants:

The area of responsibility also extends to appraisal of properties referred to Kildare County Council by the International Protection
Accommodation Service (IPAS) in DCEDIY for accommodation of IPA's.
A technical working group (TWG) has been established in Kildare County Council to access accommodation proposals referred to Kildare County Council by DCEDIY, IPAS/IPPS and the LGMA and continues to deal with queries related to existing and proposed accommodation.

### The Community Integration Forum (CIF)

Meetings are taking place on the first Wednesday of each month chaired by the Director of Services for Integration. The Community Integration Forum has met six times in 2024 from May June, through to December.

A revised format has been agreed with members, and in 2025 meetings will

be held bi-monthly with targeted, thematic meetings to address specific items on each alternative month. The next CIF meeting is scheduled for Wednesday 05 February 2025. The role of the Community Integration Forum is to enhance information sharing, collaboration and coordination among service providers to maximise integration supports outcomes. The role of the Community Integration Forum is reflected in the LCDC (Action 1.7.7 Kildare County Council-LAIT). Links with the Kildare Integration Strategy Working Group need to be defined. The migrant integration strategy is much broader and implemented through local community strategies. Participation in the CIF includes Kildare County Council (LAIT and Accommodation Team, Community Services, Library Services) Citizens Information Centre, An Garda Siochana Community Policing, County Kildare Leader Partnership, The Irish Red Cross, Kildare County Childcare Committee, Kildare CYPSC/Tusla, Kildare/Wicklow Education and Training Board, INTREO, HSE Social Inclusion coordinator, Local Link, Regional **Education and Learning Teams** Coordinator.

#### Climate

### Climate Action Regional Office (CARO)



The Climate Action Regional Office (CARO) works to support local authorities to drive climate action in their jurisdictions and coordinate activities to promote effective climate action across the local government sector. For more information on the work of the CARO, see our website at www.caro.ie

Kildare County Council is the host local authority for the Eastern and Midlands (EM) CARO, one of four CAROs working as a shared service within local government on climate. There are 17 local authorities within the EM CARO region.



The CAROs are funded by the Department of Environment, Climate

and Communications (DECC) and work through the four lead local authorities by way of a Service Level Agreement (SLA) to mid 2029.

### Local Authority Climate Action Training Programme



Training Service Level Agreement between Kildare County Council and DECC signed as of 01 June 2024. This marks the start of second phase climate training for the sector.

Executive Training Group for oversight of training delivery for 2025 to convene its first meeting on 15 January 2025.

Group is Chaired by Teresa Walsh Director of Service with South Dublin County Council on behalf of CCMA and group comprises representation from Climate Ireland, AILG, SEAI, Met Eireann, Heritage Council, LASNTG and CARO. Planning for training delivery underway as follows:

 Fire Services Staff commenced training delivery in August to run until all fire services staff complete. 21/27 have taken up training to date.





 Outdoor staff training commenced in September through regional training centres. Completion of outdoor staff training in Q1 2025.

Procurement of Learning
 Management System ongoing.

### Local Authority Climate Action Plans (LA CAP)

Review of all 31 LACAPs to ascertain robust information on action typology, is now complete. A robust central database is in place that can be utilised to identify commonality of actions to support local authorities to work together, to inform of action

prioritisation, reveal challenges in implementation, to help identify pertinent case studies and inform reporting and monitoring requirements. A PowerBI module has been used to aid the generation of reports for sectoral stakeholders.

#### **Sub-Regional Energy Projects**

The EM CARO is working with local authorities in each of the four subregions to develop regional energy units to avail of funding for projects that support the decarbonisation of local authority buildings. The energy units comprise:

Mid-east (Kildare, Meath, Wicklow and Louth), commencing projects and





accessing Pathfinder support from SEAI.

Midlands (Laois, Offaly, Westmeath, Longford, Roscommon), have developed their project pipeline and sourced funding to match Pathfinder support.

Border (Cavan, Monaghan, Leitrim) are working with project manager assistance from SEAI to build a project pipeline.

South-east (Carlow, Kilkenny, Tipperary, Wexford, Waterford City and County) have issued a position paper to SEAI for their consideration. Further discussion will continue to progress to MOU stage.



Reimagining Local Authority Fleet

The EM CARO supports the reconfigured working group established to explore support and options for local authorities on fleet decarbonisation.

The working group published guidance for local authorities on fleet management system elements

necessary to guide and monitor fleet decarbonisation.

The Decarbonising Zone – 'Show and Tell' house:

An opportunity at national level to film the house and curtilage has arisen. We are working at a pace to increase the required communications and physical elements such as wi-fi and air monitors in the house to facilitate further filming with a view to being aired in Q1 of 2025.

### Augmented Reality Image Maynooth:

To increase climate literacy and buy in a call for bids was made to create a 3D visualisation of Maynooth main street to show the main features should the Decarbonising Zone (DZ) plan be implemented by 2030. NOHO has been the successful bidder with thanks to funding under the Creative Ireland funding administrated by the Arts Section. The piece has been completed and will be on view in the





Demo House and Maynooth Library soon.

Kildare County Council Climate
Action Plan (CAP) Implementation
Report for Elected Members and

This is the first report based on the 2024-2029 CAP. It will be made available at the January Full Council meeting. It is also the first in the country and will inform other Local Authority's report format with the assistance of the EM CARO.

#### Recruitment

We welcome Stephen O'Reilly who commenced the role of as the Community Climate Action Officer on 06 January.

Jordan Cooney is due to commence the role of Assistant Energy Efficiency Officer on 13 January.

The position of Decarbonising Climate Officer has been shortlisted, and interviews are scheduled to take place in late January.

#### **District Heating (DH)**

Codema are presently finalising the DH feasibility study for Naas and commencing the Maynooth feasibility

study. The latter is in conjunction with the Strategic Projects and Public Realm Team with funding from SEAI and URDF.

#### **DISCO Project:**

'Advancing District Heating and Cooling solutions for efficient waste heat utilisation' in conjunction with CODEMA as associate partner has successfully received 70% Interreg Europe Funding. This will enable the task under action B13 of Kildare County Council CAP to perform a county wide assessment of waste heat and district heating. Work is scheduled to commence after the Maynooth feasibility study is finalised.

#### **Energy Audit/Analysis/BER:**

#### Aras:

The energy review of Aras has been completed.

#### Libraries:

Reviews are underway for Athy and Leixlip libraries. Drafts being reviewed.

#### **Swimming Pools:**

A meeting was convened to discuss the implementation of the works based on the framework presently being





finalised. The tendering process is to commence soon pending final framework item being satisfactorily qualified.

#### **SEAI Monitoring and Reporting**

The next requirement is for MPRN's to be confirmed for all properties by the end of January.

### Staff use EV (Electric Vehicles) GoCar

The underground services to supply a dedicated charger for the Go Car and Sports Partnership vehicle have been installed with Facilities assistance while ESB consider the grid capacity before ruling on the installation of the charger points.

### People's Patches/'Our Shared Plate Project' for Community Climate Action:



The project vis going from strength to strength with three active community efforts in Maynooth, Newbridge and Athy. Maynooth University continues to

monitor the social effects and
Neighbourhood Networks are
advancing plans with the groups to
create community gardens. The 18
month programme will see the planting
of trees this winter, edible hedges and
vegetables in the spring.

### **Community Climate Action Program Fund:**

Twenty-four projects were approved by the Department of Environment, Climate and Communications (DECC) for the Community Climate Action Fund grant. Grantees have 18 months to complete the projects and in the time since the grants were finalised in September, four of the projects have already been completed. The first recoupment from DECC will be completed in early December and drawdowns will be quarterly from then on. The first drawdown will cover approximately €200,000 of the total allocation of €897,000 When all the projects are completed 635 solar PV panels will have been installed as well as pumped wall insulation for four social housing units and two community halls. Other projects focus on replacing floodlights or pitch walkways with LED bulbs.





A number of biodiversity measures will also be implemented, including native tree planting and the installation of swift nest boxes.

DECC have indicated that they will be finalising the second iteration of the grant in 2025 for climate projects for community groups in the county next year. As there are some geographic and demographic gaps in the county in the applications for the first round, it is proposed to highlight the scheme to these groupings to improve participation.

#### **Climate Design Lab:**

Logo being developed to advance link to initiatives on site and social media.

Artists position to be advertised during January in conjunction with the Arts Officer.

#### Climate Innovation Fund 2024:

Except for Naas which had no projects assigned, the county projects are well advanced, and funding is being drawn down as expected.

### Grass to Gas and Alternative Maintenance:

The project has been extended out to January/February 2025 as a little more time is required to complete aspects.

#### **Water Services**

#### Water Action Plan 2024

The Water Action Plan is Ireland's third River Basin Management Plan and it outlines the measures the Government and other sectors – local authorities, public sector agencies, public and private sector companies, environmental organisations, farm organisations, etc - are taking to improve water quality in Ireland's groundwater, rivers, estuaries and coastal waters.

#### **Environment**

### National Waste Management Plan for a Circular Economy

The Waste Management Act 1996, requires each local authority to make a Waste Management Plan. The Regional Waste Management Planning Offices, under the auspices of the County and City Management Association, co-ordinated the preparation of the National Waste Management Plan for a Circular





Economy 2024-2030. The Plan sets out a framework for the prevention and management of waste in Ireland for the period up to 2030.

The NWMP for a Circular Economy 2024-2030 was formally launched on 01 March 2024.

The Plan has reviewed the current waste management situation in Ireland and used key drivers and policy proposals to project future trends to identify a range of challenges to be managed over the lifetime of the Plan.

The Plan now sets out policy responses and actions to address the current and future challenges identified and provides a delivery roadmap to help navigate the Plan period

#### **National Deposit Return Scheme**

The National Deposit Return Scheme (DRS) was launched by the Department of Environment, Climate and Communications in February 2024. The DRS is a circular economy initiative, focused on plastic bottles and aluminium/steel cans.

The scheme is operated by Deposit Return Scheme Ireland (DRSI) CLG trading as Re-turn. Larger retailers have installed Reverse Vending Machines (RVM's) at their premises to automate the deposit return process. Smaller retailers operate the scheme on a manual, over-the-counter basis.

From 01 June, all stock not branded with the Re-turn logo has been phased out of shops and consumers are now only able to buy drinks for which a deposit is payable.





An October report indicates that over 600 million containers have been returned nationally since the beginning of the scheme. In Kildare 86 stores accept containers.

The local government sector has the responsibility for monitoring compliance and enforcement of the Deposit Return Scheme

#### **National Tidy Towns 2024**

The results of the national Tidy Towns competition 2024 were announced by





the Minister for Rural and Community Development, Heather Humphreys TD, at an awards ceremony in Croke Park on 01 November.

The Tidy Towns competition involves participating areas being rated on various aspects of their local environment.

Kildare participants fared well with gold medals awarded to Celbridge, Clane, Kill, Leixlip, Maynooth, Newbridge, Naas and Straffan. Silver medals awarded to Ballymore Eustace, Kilcullen and Rathangan. Broadford received a bronze medal and Kildare town received a special Endeavour award.

#### Irish Business against Litter (IBAL)

Naas has topped the rankings as the cleanest town in Ireland by Irish
Business Against Litter (IBAL) in their
2024 survey. This is the third time in four years that Naas has finished atop the rankings. Maynooth, a former topranking town in the IBAL litter league, also performed well achieving status "cleaner than European norms" and fifth place overall in the IBAL survey.



#### **Entente Florale 2025**

Kildare County Council is supporting the nomination of Maynooth in the Large Town Category for the Entente Florale Europe Competition in 2025. An on-site briefing from reps of the Department of Rural and Community Development has been scheduled for next week.

#### Water Framework Directive

Monitoring and investigation work continue in the water priority areas under the Water Framework Directive. The council awaits the publication of the third cycle of the River Basin Management Plan for the period up to 2027. This document is expected to be published this year and will set the priorities and areas for action over the next cycle.

#### **Enforcement Priorities 2025**

The National Waste Enforcement Priorities have been reviewed and





there is a reduction in the number of priorities for 2025, moving from 20 in 2024 to 15 in 2025. The breakdown is as follows:

#### **Environmental Enforcement**

The Environmental Protection Agency (EPA) published its report on the environmental enforcement performance of local authorities in 2023 on 03 December. The EPA's Local Authority Performance Framework measures and reports on performance against National Enforcement Priorities, focused on improving environmental compliance and achieving positive outcomes for water quality, air quality and waste management. The report shows that the scale of environmental enforcement work carried out by local authorities in 2023 was significant. For the second consecutive year, Kildare County Council was the only local authority in the country to achieve a "Strong or

Excellent" score across all 20 National Enforcement Priority categories

The document establishes a strong vision for implementing excellent SuDS in County Kildare through the planning process and for the lifelong maintenance of SuDS landscapes.

#### **Legislation XL Bully Type dogs**

From October 01, 2024, new regulations prohibit the importing, breeding, selling, and re-homing of XL Bully type dogs, and from 01 February 2025, it will be illegal to own an XL Bully type dog without a Certificate of Exemption. Last date for receipt of applications for exemption certificates is 31 January 2025. This certificate is unique to each XL Bully type dog and owner.





# **Local Community Development Committee**

The last meeting of the Local Community Development Committee (LCDC) was held on the 27 November 2024 in Merits.

SICAP - Social Inclusion and Community Activation Programme

County Kildare LEADER Partnership (CKLP)are contracted by the LCDC to implement SICAP 2024-2028 in Kildare.

The SICAP annual review 2024 is due for submission on Friday 17 January. The SICAP plan 2025 was submitted on 02 January 2025. The SICAP budget 2025 is €1,425,342. Both the review and plan for 2025 will be considered at the upcoming LCDC meeting.

The SICAP Manager post is currently vacant. Recruitment is underway. An audit of the programme by Kildare County Council in line with requirements is being concluded. In addition the SICAP 2023 programme was audited by LGAS. This is also concluding.

The SICAP Plan 2025 is due for submission for LCDC review on 13 December. A draft plan was submitted to the LCDC for review. Feedback was given to CKLP. The budget for 2025 is not yet known.

Secondary, Regional and Local roads throughout the county. Included in this work are road surface repairs, footpath repairs, drainage maintenance, sign maintenance, road marking renewals and the delivery of the Road Opening Licence system (ROL).

#### **Public Lighting**

Kilaree Lighting Services are the public lighting maintenance contractor. Public lighting faults should be logged on the following website:

The PLEEP (Public Lighting Energy Efficiency Project) is ongoing, with significant survey works completed across all five municipal districts Works are due to commence in 2025.

### Machinery Yard and Regional Salt Barn

Vehicle servicing and associated works have been transferred to the new facility, with road salting being the focus of operations over the winter months.

Tender for the supply of telematics (GPS tracker systems) to all vehicles





has been completed with the installation process ongoing.

Five electric vehicles and a velocity patcher to assist in the delivery of services across the Municipal Districts are now in operation.

#### **Winter Maintenance**

Winter maintenance operations commenced for the 2024/2025 season. 8,000 tonnes of salt was delivered to the Regional Salt Barn in September 2024. Recent severe weather, with both snow, ice and freezing temperatures required the services of 30 drivers to treat the primary routes in Kildare in accordance with the Winter Maintenance Plan. This work continued from Saturday 04 January to Friday 10 January on a 24-hour basis.



Due to the extreme nature of this weather event, footpaths at schools and town centre locations were salted and secondary routes treated, using all available Transportation outdoor staff.

Approximately 1,300 tonnes of salt was used over this period.







#### Dare To Lead

On 10 December 2024, Kildare County Council's Local Enterprise Office (LEO) celebrated its tenth anniversary with a milestone event titled Dare to Lead, held at The Osprey Hotel in Naas. The event brought together

entrepreneurs from across Kildare, alongside key stakeholders, to reflect on the past decade of entrepreneurship in the region, share visionary leadership insights, and foster new connections.



The event featured an inspiring keynote address from Leo Clancy, CEO of Enterprise Ireland, who commended the significant impact of LEO Kildare on the local economy. Since 2017, LEO Kildare has supported the creation of 2,107 new jobs and, in 2018, Kildare was recognised as having the highest net job creation increase in the country, with 285 jobs created — a 30% rise since 2017.

Key figures from the event highlighted LEO Kildare's extraordinary contribution to local business development:

• €13.8 million in direct financial assistance for 2,438 business projects since 2014
