## Chief Executive's Management Report - January, 2022





### **Access to Public Offices**

The Council's COVID-19 Team working with the Council's Business Continuity Group continue to support Management Team to apply the relevant public health advice in relation to the management of COVID-19 in our workplaces while continuing service delivery in a safe and sustainable manner across Council facilities/premises.

As outlined in *Reframing the Challenge: Continuing our Recovery and Reconnecting*, important and necessary public health guidance remains in place. This includes the requirement for physical distancing, the wearing of masks and appropriate ventilation along with the continued requirement for self-isolation / restricted movements for those with symptoms. These requirements remain as a core component of our response to prevent the spread of COVID-19. In line with Government guidance staff continue to work remotely where possible and attend at the office only where it is necessary to do so.

With restrictions and remote working continuing through the current phase of *Reframing the Challenge: Continuing our Recovery and Reconnecting* access to our public offices is by appointment only.


### **Book of Condolence**

## Housing

## Rebuilding Ireland: Action Plan for Housing and Homelessness

The programme of delivery of social housing under the Rebuilding Ireland: Action Plan for Housing and Homelessness, came to a conclusion at the end of 2021. Under the programme Kildare County Council received a target for social housing delivery of 2,426 units. Over the four years of the programme, 2018-2021, the council delivered a total of 2,697 social housing units across the county, thereby exceeding our target by 271 units. The council would like to acknowledge the support of the elected members, the Housing SPC and the work of the staff across the housing department in meeting, and exceeding, the delivery target set by the Department of Housing, Local Government and Heritage. Work has already begun on delivering on the targets set under the new Housing Programme; Housing for All: A New Housing Plan for Ireland. Kildare County Council has been set a target to deliver 2,416 social housing units across the five years of the

delivery programme. In addition, the council will be charged with delivery of affordable housing units under the Housing for All programme.

## Housing for All: A New Housing Plan for Ireland

The Housing Department finalised the Housing Delivery Action Plan which was submitted to the Department of Housing, Local Government and Heritage (DHLGH) in December. The action plan deals with social and affordable housing delivery targets; the social housing targets are laid down by the DHLGH and the affordable targets are derived from the Housing Needs and Demand Assessment. An update on the draft plan was provided at the December meeting of the Housing SPC.

The LGMA on behalf of the Housing Delivery Co-ordination Office issued a national press release and social media information on Monday 22 November to identify un-commenced residential developments. The campaign was aimed at developers and builders with turnkey units (10 to 150 units), where planning permission has been granted but is uncommenced. Primarily the campaign





will be aimed at affordable housing delivery however social housing delivery can also be considered.

A local media campaign will be launched by Kildare County Council in Quarter 1 2022 to identify uncommenced residential developments in the county.

## Mid-East Region Approved Housing Bodies (AHB) Forum

A meeting of the Mid East Region
Forum (Kildare County Council, Meath
County Council, Wicklow County
Council) took place on the 12 January
2022. AHBs working across the three
counties were invited to attend. The
forum received a presentation on
Housing for All delivery targets, Cost
Rental, the procedure for claiming
funds and the annual compliance
process. There was also a discussion
regarding the allocation process.

## Amendments to the Tenant Purchase Scheme

Amendments to the Tenant (Incremental) Purchase Scheme 2016 come into effect from 01 February 2022 – Circular Housing 01/2022 refers.

The Housing (Sale of Local Authority Houses) (Amendment) Regulations 2021 will give effect to the following amendments which include:

Minimum income requirements: The minimum income required for an applicant to be eligible to apply under the scheme has been revised downward from €15,000 per annum to €12,500 per annum.

Time receiving social housing supports: The period of time tenants will be required to be in receipt of social housing support to be considered eligible under the scheme has been changed from one to ten years. In the case of joint tenancies, both tenants must be in receipt of social housing support for at least ten years before being eligible to apply. Clarity on scheme eligibility that applicants must have received social housing support for a period of ten years has been sought from the DHLGH.

## **Affordable Housing Delivery**

Tuath Housing Association have received approval for the delivery of Cost Rental Units in Walkers Gate, Kildare (40 units) and Belin Woods,





Newbridge (50 units). Both schemes are due for delivery in 2022.

## National Housing Strategy for Disabled People 2022-2027

This strategy was launched on 14
January. The vision for the Strategy is to facilitate disabled people to live independently with the appropriate choices and control over where, how and with whom they live. It aims to promote their inclusion in the community and to further enable equal access for disabled people to housing, with integrated support services.

### **Homeless Services**

Homeless presentations remain high with increased presentations from families.

## **Update from National Homeless Leads Meeting**

The National Homeless Leads Covid meeting was held on 11 January; no positive cases of COVID-19 reported in emergency accommodation at the time of the meeting. In addition to the impact of COVID-19 concerns were raised across the regions in relation to a number of issues including, increased presentations, particularly by families, lack of availability of

private rented properties resulting in reduced numbers of exits from homeless services and limited options for intervention in terms of homeless prevention, HAP rates increasingly unsatisfactory to meet the rents being asked.

## **Tenancy Support**

There are currently 50 active tenancy support cases in the county with 12 additional cases being supported by the Homeless HAP Placefinder to address arrears in order to sustain tenancies.

## **Homeless HAP (HHAP)**

There continues to be a significant slow down in the availability of properties for HHAP in the County.

There were two new HHAP tenancies for the month of December.

The Placefinder has also joined the Outreach Team in engaging with members of the public in resource centres and is providing guidance for the HAP and Homeless HAP process.

## **Kildare County Council Homeless Outreach**

The Outreach Team continues to engage with rough sleepers and, through this work, have reduced the





homeless and tenancy sustainment

number of rough sleepers from 18 to
14. This work is a Key Added Value
Action to be achieved in the
Homelessness Action Plan 2021-2023.
Three street-work sessions were
completed in Kilcock, Maynooth and
Newbridge which resulted in a further
14 individuals engaging in services.

## **Shared Housing**

Two shared housing units are currently in operation in the county, with three male and two female clients in occupation.

Supports and tenancy management is being provided by Teach Íosa and consideration will be given to extending this service in 2022.

## **Family Hubs**

Santa visited the two family hubs on Saturday, 18 December with a gift for each child. In collaboration with the Library Service a gift pack was distributed to all children in the



## **Number of Allocations**

Allocations continued in December and included allocations to Kildare County Council and Approved Housing Bodies (AHBs) units. All allocations took place within the controls and restrictions of COVID-19. 472 social housing units and 315 AHB units were allocated in 2021.







## Housing Assistance Payment (HAP) Tenancies

447 new tenancies were set up during the year. A total of 2,320 active tenancies were in place at year end. The number of new tenancies in 2021 is a significant reduction on the number set up in previous years, the limited supply of units and high rents being sought are impacting on housing applicants securing private rented accommodation.

## **Traveller Community**

Traveller accommodation continues to demand resources in terms of both the halting sites and roadside encampments. Demands on the

council's social work service is high and the team are maintaining daily contact with traveller families, particularly those who may be at risk or vulnerable.

The next meeting of the Local
Traveller Accommodation Consultative
Committee (LTACC) will take place on
03 March next.

## Contract 2A (Newbridge Eastern Interceptor Sewer)

These works were completed and commissioned in 2020. The sewerage network is due to be handed over to Irish Water/Kildare County Council Operations by the end of Quarter 1 2022 pending all operation outstanding issues and Health, Safety, Quality, Environment (HSQE) issues are addressed.

The pumping stations are being operated by the contractor for a 12-month proving period. These are due to be handed over to Irish Water/Kildare County Council Operations in early 2022.

## **Contract 2B (Network)**

Works commenced on site in
September 2019 and are advancing
well. The major pipeline improvement
works carried out in Clane and
Newbridge are substantially complete.

The remaining pipeline works in Sallins will be completed in Quarter 1 2022.

Permanent road reinstatement has commenced in Clane and Naas town centres.

Upgrade and improvement works are continuing at Clane, Monread and Sallins pumping stations.

# Osberstown Sludge Treatment Facility - Design Build Operate (DBO) Contract Variation

Veolia Water Ireland advanced works on this variation to the Design Build Operate (DBO) contract and completed these works in Quarter 4, 2020. Operational commissioning of the Thermal Hydrolysis Process Plant is continuing. The Exelys Thermal Hydrolysis Process (THP) is intended to be fully operational by end of Quarter 4 2021 pending all operation outstanding issues and HSQE issues are addressed.

## **Maynooth Transfer Pipeline**

This project involves the upgrading of the existing Maynooth Sewerage Pumping Station and the construction of a new sewerage pipeline along a





new route from the pumping station to the Leixlip Wastewater Treatment Plant. This project is at planning and detailed design stage.

Irish Water and its representatives are currently negotiating with affected landowners and Irish Water published a Compulsory Purchase Order (CPO) for this scheme in late September 2021 as option agreements have not been reached with all landowners. Currently, an Oral Hearing is planned to take place for this project at the end of January.

## **Capital Projects**

Irish Water will have a brief on the
Allenwood Sewerage Network
(Vacuum System) Modification scoped
and set out through a series of
workshops in November and
December this year and will have the

This will unlock growth and development by ensuring the treatment infrastructure is in place to meet the needs of the community. There is no time line available at this stage. This follows the announcement of the upgrade of Derrinturn Wastewater Treatment Plant already this year.

## Water Networks Management Projects

Kildare Town Watermain Rehabilitation Works -

## Lourdesville BYSS (Back Yard Services scheme)

All public and private side watermain installation works have now been completed as part of this scheme. Prior to the decommissioning of the existing cast iron watermains throughout Lourdesville, further investigational works are required to





ensure all properties are connected to the new supply.

## **Assumpta Villas BYSS**

There are currently two premises remaining whereby customer consent has not yet been obtained throughout Assumpta Villas. Private side service connection works have still to be completed at each of the remaining properties prior to decommissioning the final sections of existing mains within Assumpta Villas.

### **Rowanville BYSS**

There is currently one property remaining within this scheme whereby customer consent has not yet been obtained. Decommissioning works have yet to commence. This work will commence once consent from the final customer has been provided and the properties service connection is installed.

## **Irish Water Councillor Clinics**

Irish Water quarterly Councillor Clinics are held online for approximately one hour. The 2022 schedule of clinics has not yet been received from Irish

Water but the first one is expected to be held in March.

Irish Water will contact members with details shortly.

The three Regional Waste Management Planning Offices have given notice of intention to commence preparation of the "National Waste Management Plan for a Circular Economy" to replace the existing Regional Waste Management Plans.

## Waste Management – Awareness Campaign

Kildare County Council has launched an awareness campaign reminding every household and commercial premises in Kildare of their responsibility to minimise, manage and dispose of their waste by using an authorised waste collection service, a civic amenity site or recycling centre.





The public awareness campaign is asking households and commercial premises to ensure they are waste compliant by correctly managing their waste. By doing so they will make an important contribution to meeting the climate challenge as well as improving the quantity and quality of recyclable material collected and help to reduce the amount of waste going to landfill and incineration.



Along with local authorities across the country Kildare County Council have adopted bye-laws to ensure a consistent approach to managing waste – Segregation, Storage and Presentation.

All household and commercial waste must be segregated into:

- Dry Recyclables
- Food and Compostable Waste
- Residual Waste

Food waste and other compostable waste must be disposed of by either composting, using civic amenity sites or via a brown bin service provided by your authorised waste collection service.

Authorised Waste Collection Services are obliged by law to provide separate bin service for food/compostable waste in agglomerations of 500 or more people.

Mr Joe Boland, Director of Services
Kildare County Council said; "The
intent of this campaign is to improve
general public awareness of their legal
obligations with respect to the proper
segregation of waste streams within
the homes and businesses of the
county. The purpose of the bye-laws
is to ensure every household and
commercial premises segregate and
dispose of their waste in an authorised
manner.

If people live in an urban area with a population of greater than 500 people, their authorised waste collector is obliged to provide them with a compostable bin collection service.

These simple actions will greatly improve the quality of recyclables





collected and significantly minimise the volume of residual wastes that are disposed of at landfill. In addition, there will be significant community benefits arising from a cleaner local environment."

Kildare County Council are actively carrying out inspections to help ensure compliance with the bye-laws and failure to comply with the requirements of the bye-laws may result in a fine or legal prosecution.

#### **Recycling Banks**

Tonnages at recycling banks continues to stabilise from previous years. In December 2020, 531 tonnes of glass and cans were recycled at the recycling banks. In 2021, this has reduced to 500 tonnes, in line with previous years. Improved signage was installed at ten sites in December to remind the public how to use the banks.

#### **Christmas Campaign**

A campaign to help the public to reduce waste over the festive season was rolled out over December, this included social media and website resources as well as information in the local press. The Christmas tree recycling facilities will be in operation during January.

#### **Civic Amenity Facilities**

The two civic amenity sites continue to operate as normal at Silliot Hill, Kilcullen and at Gallowshill, Athy.

#### **Water Framework Directive**

The Minister has published the draft third River Basin Management Plan 2022-2027 for public consultation and invited submissions, observations and comments on the proposed plan prior to 31 March 2022. Achieving good water quality in our rivers, lakes, estuaries and seas is essential for protecting Ireland's drinking water sources, environment and people's quality of life. The plan is produced in implementation of the EU Water Framework Directive (WFD).





#### **Enforcement Priorities 2022-2024**

The EPA have set out a new scheme of National Enforcement Priorities (NEP) to cover the period 2022-2024, as follows:

- Waste Enforcement
  - Illegal waste activities,
  - Construction and Demolition Activity,
  - End of Life Vehicles and Waste Metal.
  - Household and commercial waste.
  - Producer Responsibility
     Initiative's and local priorities
- Water Priorities
  - Pressures from agric storage,
  - Pressures from agric spreading,
  - DWWTS's,
  - Disch licenses,
  - Water quality monitoring.
- Air Priorities
  - Solid fuel regulations,
  - Air monitoring prog,
  - Noise directive,
  - Air/noise control, and
  - Ongoing air/noise enforcement.

In terms of the 2021 NEP's; Kildare County Council has met its 2021 targets. These will be outlined in the end-of-year Recommended Minimum Criteria Environment Inspections (RMCEI) report to the EPA.

#### **Environment Complaints**

Pollution complaints continue to be investigated in accordance with national guidelines.

### Domestic/Commercial Refuse Collections

#### **National Tidy Towns**

The National Tidy Towns competition proceeded this year, with the adjudication being done remotely. The Environment Department supported the entrants by providing grants to facilitate works, as well as offering advice on the wide range of areas covered by the competition.





There are 41 groups in county Kildare and 32 of them entered the Supervalu Tidy Towns competition.

Grants were processed and paid out to all applicants.

### Irish Business Against Litter (IBAL) Awards

Naas has been awarded the top spot in the 2021 Irish Business Against Litter (IBAL) League's cleanest towns. Leixlip was ranked fourth out of 40 towns and cities countrywide.

IBAL spokesperson Conor Horgan commented that Naas deserved its win saying "It's the first time Naas has taken the title and is a very worthy winner."

#### **Anti-Dog Fouling Initiative**

An anti-dog fouling initiative was carried out in each of the five municipal district areas. The wardens and staff from the Environment Department met with councillors in Naas, Athy, Kildare, Maynooth and Celbridge to hand out dog waste bags/dispensers to passing walkers. Stencils and an audio message reminding dog walkers to dispose of the waste were placed in each of these areas. There are plans to continue the scheme in several other areas suggested by the Community Wardens.

#### **Green Kilometre Scheme**

The Kildare Green Kilometres has been shortlisted for the Chambers Ireland Local Authority Awards under the Sustainability category. Kildare County Council continues to support these groups by providing clean up





equipment and collecting the waste in a timely fashion. Over 130 kilometres registered and well over 50 tonnes of waste gathered in the year to date.

#### **Environmental Education**

In line with Government guidelines, all in-person educational talks and events are suspended until further notice in the interests of public health and will be rescheduled at a later date where feasible. The Green Schools programme has continued in a number of schools and online assessments are now taking place in order to award the green flag. While the number of flags awarded will be substantially down on previous years, many schools are organising themselves to participate over the coming year. #### **Morell Flood Management Scheme**

Construction of this scheme is continuing, with embankments and walls in the Tuckmilltown and Turnings areas nearing completion and further works in Tuckmilltown, Killeen and Killeenmore commencing. Further details of the scheme can be found at: https://www.morellfms.ie/

#### **Athy Flood Relief Scheme**

The Kildare County Council and OPW
Steering Group has commenced
developing the scope of the Athy Flood
Relief Scheme. The first stage will be
the procurement of consultants to

#### **Naas Flood Relief Scheme**

The contract for consultancy services for the Naas Flood Relief Scheme has been awarded to ARUP. The first stage of the scheme will be a review of the existing hydrology and mapping. #### Kerdiffstown

Wills Bros Ltd was appointed in October 2020 for the remediation of the landfill and the construction of the park.

The site was closed for construction works over the Christmas. However, monitoring for gas, leachate and security continued. There were no issues during this period.

#### **Historic Landfill Programme**

Currently there are 28 sites listed on Kildare County Council's Section 22 Register for unregulated waste disposal sites. 100% funding is provided by the Department of Environment, Climate and Communications to carry out an Environmental Risk Assessment in accordance with EPA's Code of Practice on these sites. This must be

carried out on each site and an application is to be made to the EPA for a Certificate of Authorisation (CoA), outlining any required remediation works for approval. Currently, priority is given to the six Category A sites.

The status of these are as follows:

#### Carigeen, Clane

CoA issued by EPA. Previous tender had to be withdrawn due to technical issues. Proposed to retender in Quarter 1.

#### Digby Bridge, Sallins

Application for CoA submitted to the EPA. A draft CoA received in November 2021, but challenged by Kildare County Council. Once granted, design for remediation works to commence.

#### Pollardstown, The Curragh

Environmental Risk Assessment is being carried out. Further site investigation works are required which are currently underway and expected to be completed by Quarter 1 2022.

#### **Knocknagarm, The Curragh**

Environmental Risk Assessment is being carried out. Further site investigation works are required which





are due to be complete in Quarter 1 2022.

#### Greenhills, Athy

Application for CoA submitted and currently awaiting response from EPA.

#### Prusselstown, Athy

Application for CoA submitted and currently awaiting response from EPA.

#### **Cemetery Capital Programme**

This programme, which includes cemetery extensions, capital type internal improvements and proposals for columbarium walls is currently being reviewed in line with funding availability.

#### **Newbridge Cemetery Carpark**



#### **Community Climate Action Programme**

The Community Climate Action Programme, funded by the Climate Action Fund, will see €60 million invested in community climate action projects, initiatives, and capacity building, over the next three years. Details can be found at:

It will be rolled in two phases with €30 million allocated for the first phase.

The first phase is comprised of two strands:

Strand 1 - Action: Building Low Carbon Communities - €24 million is being provided to local authorities to support communities, large and small, rural and urban, to build low carbon communities in a considered and structured way. Further details on the roll out will be available in due course. Strand 2 - Education: Climate Education, Capacity Building and Learning by Doing - A total of €6 million is being provided to build





community capacity in relation to climate action. There are two elements to this strand:



A - Open Call for Education, Capacity
Building and Learning by Doing
Projects:

€5 million will be administered by Pobal on behalf of the Department of the Environment Climate and Communications(DECC). Applications opened on the 15 November and closed on 14 January 2022.



B - Creative Climate Action: €1 million which has already been allocated.

This scheme is administered by Creative Ireland.

#### **Capacity Building**



The CARO continues to work with its strategic training partners, to implement on behalf of the local government sector, a national training programme for all elected members and local authority staff. The training programme, which includes six pillars and has received CPD accreditation from a number of bodies (Engineers Ireland, Irish Planning Institute, CIWEM), are available to all local authorities:



#### **Elected Members/Senior Staff**

The Climate Leadership training for senior staff and elected members has been delivered to participants in 24 local authorities to date. The remaining seven counties will be completed in early 2022.







#### **Climate Action Teams**

This highly collaborative programme, with contributions from Met Éireann, Climate Ireland, the CAROs, the SEAI, the AIEI (Association of Irish Energy Agencies) and the IPA, is aimed at members of local authority Climate Action Teams. The course takes place over six half days and to date, has been delivered to CAT members in the three CARO regions of Atlantic Seaboard North, Dublin Metropolitan and Eastern and Midlands. Training is currently ongoing for CAT members in local authorities in the Atlantic Seaboard South region. Strong attendance has been reported, particularly for the leadership modules.



#### **Online Training**

The rollout of the Raising Awareness online programme is ongoing. To date, a total of 8,522 staff at Grades 7, 6, 5, 4 (and technical equivalents) have completed this programme across each of the 31 local authorities.

Participation rates have been positive – with average completion rates over

70% of enrolled participants. A further 4,540 Grade 3 and analogous staff enrolled to complete the programme, between 01 November to 23 December 2021 and an update on participation and completion rates is expected shortly.



#### **Thematic Training**

In the first training course of the
Actioning Policy training pillar, the
Planning for Climate Change training,
informed by workshops held in
conjunction with the three Regional
Assemblies was rolled out to 291 local
authority planners of all disciplines.

Other training courses being developed under the Actioning Policy pillar are at various stages as follows:

A Green Procurement course, to address a number of actions across local authority strategies, the Climate Action Charter and other environmental legislation, is expected to commence course rollout in 2022.





An introduction to Flood Risk
 Management is an eight module
 course designed to develop skills
 and knowledge in flood risk
 management for key staff involved
 in managing, planning and
 responding to flood risk.

A pilot took place in Quarter 3 of 2021 and the course rollout to all local authorities has commenced with 379 registered attendees and 212 in attendance over the initial five (of eight) modules rolled out to date.



#### **Outdoor Staff**

A pilot of the Delivering Action programme took place in Quarter 3 of 2021, with feedback from attendees being used to finalise course content and delivery method before rollout to all local authority outdoor staff. The LASNTG are recruiting in-house trainers to deliver this programme to outdoor staff on a county-by-county basis.



#### **Frontline Staff**

Training for front line or community engagement staff remains under design and development with the Institute of Public Administration. A pilot programme took place online on 15 and 16 December 2021 with further rollout planned during 2022.



## Guidance for Local Authorities – Preparing Local Authority Climate Action Plans

Section 16 of the Climate Action and Low Carbon Development (Amendment) Act 2021 calls for each local authority to develop a Climate Action Plan, to specify the mitigation and adaptation measures to be adopted. The CAROs, working in partnership with Climate Ireland/EPA convened a project advisory group and commenced work on guidelines for local authorities in support of the





development of their climate action plans.

The draft guidelines have been developed, comprising a main guidance document and three technical annexes. They will now be circulated through the governance channels of both the CCMA and EPA, before submission to the Department of the Environment, Climate and Communications by 01 December. Once finalised, the guidelines are to be published by the Minister of the Environment, Climate and Communications.



#### **Sub-Regional Energy Projects**

The CARO are working with local authorities in each of the four sub-regions to develop regional energy bureaus or regional energy efficiency projects.

In the Mid-East (Kildare, Meath, Wicklow, Louth): A position paper for pathfinder support has been developed and a Memorandum Of Understanding is awaited from the SEAI, prior to approval being sought from the local authority Chief Executives. The three local authorities involved (Kildare, Meath, Wicklow) are meeting regularly and it is hoped to progress this further in 2022. In the Border sub-region (Cavan, Monaghan, Leitrim): A public building energy efficiency report for the three local authorities went to tender, with Codex Energy being appointed. Their final report has been received and identifies 18 buildings with a project pipeline for each building to attain a B2 rating, as well as detailed costs of upgrade works, payback period and energy savings. The CARO were successful in securing funding from SEAI's Project Assistance Grant (PAG) Programme for the respective local authorities and this grant may cover up to 50% of the costs of the report.

In the South East (Kilkenny, Carlow, Wexford, Waterford, Tipperary): The





three Counties Energy Agency (CEA) have met with the CARO and are pursuing a position paper for approval from their local authorities (Kilkenny, Carlow, Waterford and Wexford), with the ambition of forming a Memorandum Of Understanding (MOU) with the SEAI in 2022.

In the Midlands (Laois, Offaly, Longford, Roscommon, Westmeath): the region intends to carry out a similar project to that of the Border region, to identify opportunities.



#### **Reimagining Local Authority Fleet:**

The vision of this project is to develop a pathway for decarbonizing local authority fleet with a view to realizing emission reduction and energy efficiency targets. A working group has been established under the stewardship of the CCMA Climate Change, Transport and Networks Committee, and to date, a survey has

been issued to all local authorities to establish a baseline. The initial phase of the project will be to examine the survey returns and to research and present opportunities for immediate reduction of carbon across the local authority fleet.

### Climate Change Adaption Strategy (CCAS)



CCAS Action Reporting was submitted on the 12 November to Department of Environment, Climate and





Communications (DECC). It was approved by the National CARO Steering Group beforehand. The number of actions being undertaken and completed by Kildare continue to increase. The final data shows 65.35% of all actions are ongoing, 16.5% are completed and 5.51% are new actions. Kildare is above the national average in the number of completions/ongoing actions. The update was warmly welcomed by the CAT.

# Sustainable Energy and Climate Action Plan (SECAP)/Climate Action Plan (CAP)

It is a requirement under the Covenant of Mayors and Climate Action and Low Carbon Development (Amendment)
Act that Kildare County Council prepares a five-year Sustainable Energy Climate Action Plan/Climate Action Plan (SECAP/CAP). RPS Group, contracted consultants, have delivered an estimation of emissions for the county as a baseline. Work is continuing on finalizing the data.

### Decarbonising Zone – Maynooth



The Climate Action Office, while awaiting the guidelines from the Department, is progressing the likely needs of the challenge ahead to decarbonize by 51% by 2030. To this end the team is aligning collaborations within and outside the council, is progressing funding opportunities for the local community and council, developing linkages to create a steering group and subgroups with stakeholders, seeking business opportunities, policies and projects established or in development, developing methods of citizen engagement and researching findings from other initiatives. It is envisaged this background work through the lens of climate action will inform the implementation plan and potential actions to create a proactive and achievable approach. The Climate Action SPC is being made aware of progress.





#### **Energy**

#### **Energy Management Team**

Kildare County Council's Energy Management Team met monthly throughout 2021 and moving forward into 2022 it has been agreed to align both the climate action team and energy management team meetings, this is seen as a more streamlined option which will reduce meetings for some members of the teams and will cross pollinate actions. It is proposed to hold the meetings every two months throughout 2022. Key areas are being targeted for the Team in early 2022; the recognized energy management standard of ISO 50001 is being considered by the Team and to decide Kildare County Council's next steps. The Energy Management Team through its register of opportunities is identifying suitable projects to move to action phase for 2022, these will be a mix of initiatives and projects to reduce our energy usage. Analysis of top energy users across our council remains a standalone agenda item and it is hoped to bring analysis of these top energy users to senior managers attention intermittently through 2022.

#### Kildare Climate and Energy Week

Kildare's first Climate and Energy
Week was delivered on 26 to 29
October 2021.

Ciara O'Flynn of the Climate Action
Office has compiled the Teams key
learnings from the week of events
which can be utilised for future events
by ourselves and other similarly
resourced councils. Our Climate
Action Office hopes to hold a
comparable or more targeted event in
2022 achieving greater strategic
collaboration with Kildare's climate
action groups.

### Energy Usage Monitoring and Reporting (M and R)

Our provisional scorecard for energy usage in 2020 shows a 33.3% energy reduction against its baseline year of





2009, which is significant progress from the 2019 figure of 24%. Although this is a provisional figure from Sustainable Energy Authority of Ireland (SEAI) it shows continued progress on energy efficiencies and also meets the national target of 33% reduction by 2020.

The monitoring and reporting system for 2021 is due to change during 2022 in that it will capture more energy usage across the council's functions, namely staff business travel and others.

Mid-East Energy Bureau

Kildare County Council is engaged in a process with other local authorities to form an Energy Bureau to drive energy efficiencies at a regional level. It is proposed to establish the Bureau with the assistance of SEAI's pathfinder program which will assist with funding towards energy related projects across the region and also funding for the Bureau establishment and staffing needs over a fixed period of time. Currently Kildare, Wicklow and Meath Local Authorities are partnered to deliver this initiative, with support from CARO. Kildare's Energy Efficiency

Officer is also assisting with a subgroup of the Bureau Establishment
Team to develop tender
documentation to procure a suitable
consultant to drive this project.
While the process is ongoing and is
taking more time than all parties had
hoped for, there are a number of
meetings through January 2022 to
progress the proposal, at which point
Chief Executives from each of the
Local Authorities will be asked to
approve the progression of the MidEast Energy Bureau.

Sustainable Energy Communities (SEC's)



Kildare County Council continues to make good progress on Sustainable Energy Communities in the county.

There are currently 22 SEAI registered SEC's in county Kildare, with four of these nearing the end of their energy





master plan stage which will allow them to move to the action phase. Further strengthening of the Energy Master Plan(EMP) process has been developed by SEAI, which now includes greater structure and guidelines to ensure quality standardized Energy Master Plans (EMP) are delivered. Kildare County Council can now also utilize an EMP delivery framework structure established by CODEMA.

Ballymore Eustace and Naas SEC's have lodged applications with Kildare County Council for funding assistance to deliver their energy master plans. It is hoped to have agreements in place in early 2022.

The Climate Action Office is considering working with CODEMA to streamline the administration of the system for all parties involved.

Fleet Electrification



The CCMA has recently published its Electric Vehicle Guidance Document for Local Authorities; this is a welcome development which gives direction for LA's as demand for public EV charging and fleet electrification grows. Kildare County Council's suitable small vehicle fleet can also be considered for electrification. The council currently have four EV vans in our fleet but there is growing interest in the electrification of other suitable vehicles in the fleet. Some Municipal District Offices have also expressed interest installing electric vehicle charging points in their depots to facilitate EV charging.

As fleet electrification starts to embed in Kildare County Council through infrastructural changes and greater awareness of EV's it will also be key to facilitate specific EV driving training for all drivers of fleet vehicles to ensure potential EV drivers are fully informed and upskilled in this area.

The Climate Action Office is also examining the potential to introduce a compressed natural gas HGV vehicle into Kildare County Council's fleet, while smaller vans have suitable options such as electrification the larger trucks are an issue. One solution to this is a compressed natural gas vehicle.

Disability Participation and Awareness Fund 2021

The Climate Action Office in conjunction with Age Friendly, Roads and the Ballymore Eustace Community Development Association successfully applied for funding for Ballymore Eustace Disability, Age and Climate Friendly River Walk. Carmel Cashin is working with all concerned to undertake the funded works. Phase 1 is to make the river walk accessible for all while enhancing biodiversity and climate proofing the project.

#### **Forestry**

The finalised document 'Woodland Creation on Public Lands Scheme' was released on 28 May 2021.
The project is being advanced by a subgroup of the CAT called, Coillteach Chill Dara. Dara Wyer, Environment Awareness Officer has five potential

sites chosen to be assessed provisionally.

The templates for tendering have been finalised and are available to utilize.

#### Ezine



A quarterly update from the Kildare County Council Climate Office

The December edition was published with a sleeker look. Further enhancements to make the ezine easy to read will be examined. Topics are informed by external and internal influences with media links being used to increase accessibility. Ideas and topic of interest are sought from council staff. A sample of staff led mainstreaming is highlighted by Architects. Mary Morrisey and colleagues have developed their own internal model of communication to assist with understanding to enable mainstreaming of actions under the Climate Change Adaptation Strategy in their functional area.

#### **Just Transition**

The municipal districts of Athy, Clane-Maynooth and Kildare-Newbridge have





generously contributed €15,000 per municipal district to establish a fund to engage a consultant to develop and prepare a 'Local Just Transition Plan for West Kildare'. Urban Foresight Limited presented the draft Local Just Transition Plan to the Climate Action SPC and the CPG in December. As circulation of the draft document increased, further consultation requests were received. Consultation is ongoing with various parties including Bord na Mona and will inform a more cohesive and workable document in the near future.

**Alternatives to Herbicides Project** 


The Parks/Climate Action Office's project including scientific research together with practical assessment in the field (Kildare County Council Parks Department and National University of Ireland, Maynooth) is designed to produce a practical maintenance guide for public open spaces.

Cork City, Galway City, Meath, Kilkenny, Westmeath, Roscommon Fingal, Offaly Tipperary and South Dublin Councils have confirmed their partnership together with Waterways Ireland. Ms Sophia Couchman, Masters student, has finalized her first report of what exists on the various sites with regard to vegetation and biodiversity. Her assessors have narrowed her remit regarding the continued approach requirements. Maynooth University, Trinity College, NBDC, Teagasc and Kildare County Council have reviewing the data collected to date. The potential experiments and follow up research items were designed in December to inform the scientific and practical process during 2022. Teagasc have made lands available for controlled experiments and practical experiment sites have been chosen within Kildare county.

Community Stories is continuing to roll out monthly updates. The November update shows the results of the circular economy experiment with Green Generation.







Waste grass has proven to be environmentally sound and efficient at creating energy. 16.16 tonnes of waste grass produced the equivalent of 1300 litres of diesel being produced post operational requirements being removed and the saving of four tonnes of carbon being released into the atmosphere - the equivalent of driving an SUV style vehicle 20,000km per annum. The next steps are to assess the financial costs further with the potential to break even or make a profit from using the circular economy model.

Gas Networks Ireland have invited the Climate Action Office to consider an

application for potential grant funding to assist with the circular economy model of maintenance given our results to date and the uniqueness of the project. Discussions will continue to be explored during 2022.



The CAT members visited Green Generation facility on the 02 December to fully understand the process and future possible applications.

### Alternative Fuels for Plant and Machinery

Gas Networks Ireland invited a small group to look at the use of Compressed Natural Gas (CNG) as an alternative fuel source for larger plant and machinery. The example was a grab truck untilising the gas to travel on average 600km between refueling at designated stations. The truck is 50% quieter than a diesel version while gas is considered the greenest carbon fuel in this case the gas is





produced by Green Generation making the vehicle carbon neutral with green certification available. It also significantly produces less air particulate matter and Nitrous Oxide. Plans are advancing to potentially provide fuel stations in the county of Kildare to increase the viability of CNG usage in transport.

Gas Networks Ireland (GNI) and Green Generation are exploring the increasing potential of CNG powered vehicles with the Climate Action Office.



### Council Policy Documents and Initiatives

The Climate Action Office is researching the viability of partnering with others to enable the use of the newly announced Strand 2 funding under the Governments Climate Action Fund and other funding strands.

The council are delighted to be working with various functional areas to enhance their work through a Climate Action lens.

The Climate Action Office continues to work with the Age Friendly section with a county wide 'Wool in Schools' programme to be distributed through older person care homes as an intergenerational piece.

Workshops are being undertaken with teenagers with access needs, potential An Gaisce Awards work and intergenerational works with requests from primary and secondary school children for guidance and information on Climate Action being received.

The Arts section is working with us to further expand Climate Action themed



mural work across the county.

Paul graduated from LSAD with a BA Honours Degree in fine art painting. He paints about personal, collective and universal histories. He focuses on details, minute elements and intricate patterns.

increase mitigation, adaptation and resilience within our communities.

### Roads, Transportation and Public Safety

#### **Key Highlights**



The new Lyreen Avenue and Lyreen Bridge officially opened to traffic on Monday 20 December. Lyreen Avenue, which connects the Moyglare and Dunboyne Roads is approximately 800 metres in length and includes new cycle tracks, footpaths, crossing facilities as well as signalised junctions at the Dunboyne Road and Moyglare Road.

#### **Storm Barra**

The first winter storm of 2021, Storm Barra, resulted in a Yellow level weather warning for county Kildare. Our Severe Weather Assessment Team (SWAT) was convened in advance of the storm to review local

preparedness and members of this team attended the National Directorate for Fire and Emergency Management's Crisis Management Team briefings over the duration of the event.

The council crews and emergency services were available to respond where required. No major issues arose during the storm event.

#### **Digital Strategy for Kildare**

Work has now commenced to develop a Draft Digital Strategy document for Kildare. The Strategy will set out an overall vision for the county outlining a number of core objectives, priorities and actions over the short, medium and long term. In line with the NBP deliverables, Kildare County Council is developing this digital strategy to maximise the opportunities of digital transformation for the benefit of our society and economy, ensuring that Kildare is among the best places to live, work, invest or visit. Following a tender process, the council have commissioned PMG Consult to conduct a strategic policy study leading to the development of the first Kildare Digital Strategy. A workplan based on the methodology of the successful tenderer has been agreed





which will require fairly extensive consultation around the strategy themes.

PMG Consult will be conducting consultations individually and collectively with key Kildare County Council personnel as well as other key stakeholders and agencies from the enterprise, education, community and other sectors.

#### M4 Maynooth to Leixlip

The aim of the project is to assess the needs of the M4/N4 mainline corridor and junctions from Maynooth to Junction 5 Leixlip in terms of catering for future demand from a capacity, safety and operational perspective. The scheme will take a number of years to pass through the various steps required for Phase 1 (Concept and Feasibility), Phase 2 (Option Selection), Phase 3 (Design and Environmental Evaluation) and Phase 4 (Statutory Processes), provided it successfully progresses through each phase.

#### **Athy Distributor Road**

Contractor is now on site. Kildare
County Council has appointed a Land

Liaison Officer to work with the Project Team.

### New Machinery Yard Relocation and Regional Salt Barn

Tender assessment is underway. It is expected to have a main contractor on site for Quarter 2 2022.

#### **Maynooth Eastern Ring Road**

Kildare County Council is currently endeavouring to gain control of the lands (identified under the Local Infrastructure Housing Activation Fund (LIHAF) Scheme) as a prerequisite to the CPO going ahead.

Detailed design of the scheme, including drainage design, is at an advanced stage. Discussions are ongoing with the Department of Housing, Local Government and Heritage (LIHAF).

#### Celbridge to Hazelhatch Link Road

Kildare County Council was successful in securing funding under the Urban Regeneration Development Fund (URDF). The scheme, which will connect Celbridge Town and the Hazelhatch Train Station, will include a second bridge over the River Liffey. The project is currently at Route Selection stage. Non-Statutory Public





Consultation no. 1, presenting the route corridor options has been completed and submissions have been compiled.

Non-Statutory Public Consultation no. 2, presenting the emerging preferred route option will commence in Quarter 1 2022.

#### **Newhall Junction Improvement**

A preliminary design for a new roundabout at Newhall has been developed. Attempts to acquire the lands by agreement on this scheme have not been successful so a CPO process has commenced. It is expected to advertise the CPO in January 2022.

#### **Naas to Sallins Greenway**

Kildare County Council are currently engaging with the National Transport Authority on this project and have secured funding to bring this scheme to Part 8. Consultants (ATKINS) have been recently appointed. It is expected to proceed to Part 8 in Quarter 1 2022.

#### **Kildare Town Transport Strategy**

The Kildare Town Transport Strategy is currently at DRAFT stage. Meetings with the Kildare-Newbridge Municipal

District Councillors were held on the 07 April 2021 and the 26 April 2021. The non-statutory public consultation was completed in August 2021. It is expected to have a final document available in January.

#### **Maynooth Transport Strategy**

AECOM Consultants have been appointed to the develop of the Maynooth Transport Strategy. The baseline analysis is broadly complete and AECOM are moving onto the strategy optioneering stage.

#### Naas Permeability Improvement Project

The non-statutory public consultation (via a leaflet drop and online survey) commenced in December and submissions are being examined.

#### **Bridge Rehabilitation Programme**

Four bridge projects funded by the Department of Transport for 2021 were awarded to TRUIR to be completed by Quarter 1 2022.

The Monasterevin Bridge has significant structural issues in two centre-pier cutwaters. Rehabilitation works are ongoing on-site.

Brook bridge has been approved by

An Bord Pleanála and it is proposed to





proceed to construction stage Quarter 3 2022.

### Newbridge Southern Relief Road / Second Bridge Crossing

The section of the Newbridge
Southern Relief Road (NSRR)
between the Newbridge to Naas dual
carriageway (R445) and the Great
Connell road is now substantially
complete and the Roads Planning
Section is currently engaging with the
developer on the completion of snags,
the transfer of lands and the
submission of the taking in charge
documentation.

Following the unsuccessful application for funding under URDF Call 2, the Project Team has commenced the tender process for the appointment of consultants to progress the project to stage 4 of the TII Project Management Guidelines (Planning Stage).

## Kildare Town Northern Link Road and South Green Area Access Improvement Scheme

The Route Selection Report is substantially complete. This project will not proceed further until the Kildare Town Transport Strategy is completed.

This post was advertised and interviewed, with the recruitment being finalised.

# Right to Read: Family Time at Your Library

Right to Read is the national programme to promote literacy and reading development for people of all ages and backgrounds. It includes four national programmes designed to promote children's reading and literacy, in addition to local programming.

Family Time at Your Library events take place in Kildare libraries every December to support a family-focused approach to reading with children and to increase awareness of the benefits of reading and promote reading as a fun, recreational activity for children. In December 2021 the libraries hosted 13 events online and one outdoor event with 233 children and families taking part.

## ComeBack Festival - supported by the Kildare Local Live Performance Programme Scheme Phase II

The Kildare Local Live Performance

Programming Scheme supported the ComeBack Returns series of online concerts filmed and broadcast during December. This scheme aimed to support the creation of employment opportunities in Kildare for professional artists and musicians of all genres, performers, technicians, crew, lighting and sound engineers and other support staff working in the live culture, creative and music industries. Premiering online from 16 to 22 December 2021, the Comeback Returns series of streamed performances featured artists including Sequence, Sharyn Ward, Celine Byrne, Eimear Quinn, Pillow Queens, Daire Patel, Sinéad White, Amy Dillon,

Loah and Jack L. Hosted by May Kay these concerts have already had over 100,000 online views to date. Comeback Returns, produced by Davis Events, was a festival of Kildare's creative spirit which showcased the county's musical diversity and talent. Presented as part of the Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media's Local Live Performance Programming Scheme (Phase II) in association with Kildare County Council and Kildare Libraries and Arts Service, Comeback concerts were recorded in St Mary's Church Maynooth and Village at Lyons Celbridge. It is hoped to develop a programme with Maynooth University, focusing on cultural diversity.

short video. Participants responded positively to the programme and the tutor, engaging enthusiastically in this upskilling and peer-to-peer learning experience. 'Digital Folklore and Stories Capturing the Ordinary' was supported through the Kildare Creative Ireland programme.

Online Consultation on pilot Basic Income for the Arts Scheme

Kildare Arts Service will support the national consultation towards the pilot Basic Income for the Arts Scheme led by the Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media. The online consultation is open and closes on 27 January 2022. It follows a successful stakeholder forum on 15 December that saw over 150 participants including 50 artists and arts workers resource and representative bodies come together to discuss the proposal and provide their views and feedback to the Minister and her Department.

### **Allenwood Playground**

A tender for initial site clearance of scrub to facilitate the playground has

been completed and the work is due to be carried out in February. Work on the tender for the playground has started and it is hoped to have this completed in the next eight weeks.

### **Tree Works Tender**

Tree works in Celbridge-Leixlip,
Kildare-Newbridge and ClaneMaynooth Municipal District areas
have been awarded and work on
finalizing the details of the work and
start dates is ongoing. Work on
preparing tenders for the Athy and
Naas Municipal Districts are ongoing.
It is hoped to tender Athy in the next
month and Naas after that.

### **Tree Planting Programme**

The 2021 tree planting programme is currently being completed. This work was delayed due to COVID-19 restrictions last year. A tender for this years planting is currently being prepared and is due to be awarded before the end of the month.

### **Sallins Amenity Land**

It is proposed to advertise the Part 8 masterplan for Sallins Amenity Land by the end of the month. The details





of the Part 8 will be available on the consultation portal on the Kildare County Council website and be advertised publically.

## **Newbridge Playground**

An online survey to ascertain adults and childrens opinions on play provision in Newbridge has been completed. The survey was also distributed to the primary schools in the town. The results will be analyzed in the coming weeks and the results will be used to initially inform the development of a natural play area in Liffey Linear Park. They will also inform the development of additional play facilities in Newbridge.

## **Celbridge Playground**

A new wheelchair swing is due to be installed in Celbridge playground in the next fortnight. The swing is being funded from LPT allocated by the Celbridge-Leixlip Municipal District members last year.

# Economic Development – Capital Projects

## MERITS – Innovation and Incubation Centre



MERITS continues to onboard new tenants. The latest additions include Genkos United t/a Fieldy, Vyra, CareerPathways2Success and Hub360.

The grand opening with An Tánaiste Leo Varadkar was scheduled for the end of January 2022 but has been deferred due a diary clash, but a series of open days/open evenings over the coming months to market the facility to local tech founders will now proceed in light of the relaxing of the COVID-19 restrictions.

The MERITS team has scheduled two LEO-funded programmes, Genesis and TechHatch for the coming month.

A number of webinars for StartUps will be held during January and February





along with the launching of a Digital Platform and online booking system.

## **National Equine Innovation Centre**

The programme of works at the Irish National Stud has now been completed and the marketing and promotion of the National Equine Innovation Centre (NEIC) will commence shortly to attract equine innovation companies from Kildare to locate there.

## Kildare Hub Strategy Athy Food, Drink and Skills Innovation Hub

The final design has been completed for the project. A pre-qualification process for interested contractors for the main construction contract was published in October and expressions of interest were submitted from a number of contractors. The successful contractors have been informed that they have been approved to tender for the main construction contractor which will be published for tender next year. Following the announcement of a new round of RRDF funding, the project team are preparing an application in advance of the deadline in April.

#### K-Hub Network

Hosted by Kildare County Council the public and private co-working and

innovation space owners/managers have been meeting regularly and have formed the K-Hub network. The network leverage economies of scale in research, collaboration, training and funding applications and is supported by the economic development unit in Kildare County Council.

## Kildare Hub Strategy

Kildare County Council appointed a consultant, PMG Consult, in July to develop a hub strategy that carries out a critical piece of analysis for the county to ensure it future growth and to align its approach and hub development strategy with regional and national policy. A consultation phase was completed with over 25 internal and external stakeholders and a draft strategy was presented to the Economic Development, Enterprise and Planning SPC for consideration in September. Following feedback from the SPC, a final version of the strategy was presented and approved at the December SPC meeting. The strategy will be presented to the members and published in early 2022.

## Kildare Mid-East Regional Enterprise Plan to 2024

The Economic Development team have worked closely with the regional

stakeholders to consult and prepare the final draft of the Mid-East Regional Enterprise Plan to 2024. It is expected that the Department of Enterprise, Trade and Employment will publish the plan in Quarter 1 2022.

## **Kildare Food Strategy and Food Network Co-Ordinator**

Kildare County Council has tendered for a Food Strategy and Food Network Co-Ordinator. The successful service

provider will be required to act as coordinator of the Kildare Food Network and drive the implementation of the Kildare Food, Beverage and Hospitality strategy on behalf of the key project stakeholders. The date for submission of tender was 22 December and it is envisaged that the successful applicant will be appointed in January 2022.
