That the council provides an update on the boardwalk to the bridge in Celbridge.

6. Motion – Councillor David Trost

That the council implements a speed check review on the road past St Wolstan's School, Celbridge towards Barberstown Cross, and past the entrance to Killeenlea.



7. Motion – Councillor Paul Brooks

That, with the members agreement, the council writes to St John of Gods seeking clarification regarding a resolution to the ongoing situation in the Abbey Carpark in Celbridge as a matter of urgency.

8. Question – Councillor Lumi Panaite Fahey

Can the council provide an update on the meeting with the Owners Management Committee OMC in relation to St Patrick's school?

9. Question – Councillor David Trost

Can the council provide a specific list of all the planned road marking replacements to be completed over the summer months in Celbridge/Ardclough now that schools are closed?

10. Question – Councillor David Trost

Can the council clarify if Uisce Éireann have provided a specific work plan on traffic restrictions for the mains replacement process on the Hazelhatch Road which are due to commence later this year and if not, when it is expected?

11. Question – Councillor Bernard Caldwell

Can the council provide an update on a 2024 motion on the purchase of the private carpark behind the shops on Captains Hill?

12. Question – Councillor Claire O'Rourke

Can the council confirm the 'Taken in Charge' status of the road in council ownership (folio KE591F) at the M4 access entrance and access road to Castletown Demesne lands?

13. Motion – Councillor Bernard Caldwell

That this municipal district sponsors the opening of our new playground at Leixlip Amenities hopefully at the end of September or early October.

14. Motion – Councillor David Trost

That the council urgently arranges for the clearing of the weeds on the Maynooth Road Roundabout and priority given to the planting of the Wheel as it is in very poor condition and is located on a main route for Celbridge and also clarify the position on sponsorship arrangement for this roundabout.

15. Motion – Councillor Rupert Heather

That the council works with relevant landowners to seek the cutting back of trees and other vegetation that is badly overgrown and obscuring the view of the Liffey towards Castletown from the Celbridge Bridge.

16. Motion – Councillor Nuala Killeen

That this municipal district agrees that a 'Happy to Chat', sign, which indicates that people are happy to engage in conversation, be added to an already installed bench in Leixlip Village or Confey or in the environs of the Wonderful Barn as a pilot and as a small measure to build community and help with loneliness.

That, in view of the council's targets on sustainability, the Kildare County Council policy of only budgeting for the cutting down of trees and not replacing them, is inconsistent with its environmental protection objectives.

Can the council confirm if it plans to carry out a review of community grants to 2025 funded groups in this municipal district, that includes engagement with grant recipients, to assess whether current funding levels remain sufficient given the increasing costs faced by community groups?

Can the council provide a detailed plan on current and future approaches for the control of dog fouling across the municipal district?
