### **Brigid 1500 Festival**

The members received an update on the programme for the 2024 Brigid 1500 Festival.

Ms. K. Lane outlined highlights in relation to the launch and media coverage of the 2024 Brigid 1500 Festival. Also informing the members that there were 101 Community and Creative Grant Applications received, with 58 Applications approved awarding over €188,000 to Creative and Community Groups across the county. The members were also informed of a number of Flagship Events which would be taking place in each Municipal District during the 2024 Brigid 1500 Festival from 27<sup>th</sup> January 2024 to 4<sup>th</sup> February 2024, details of which were available on <a href="https://www.brigid1500.ie">www.brigid1500.ie</a>

### **Just Transition Tourism Scheme**

Can the council provide an update on its proposals for funding under the Just Transition Tourism scheme in this municipal district?

A report was received from the Economic, Community and Cultural Development
Department informing the members that Kildare County Council are currently engaged with
Failte Ireland in the early stages of the Just Transition Tourism Scheme and this
engagement involves the prioritisation and agreement of projects across the two Municipal
Districts in the Just Transition area. This prioritisation will likely mean that there will, initially,
be one project put forward in each Municipal District with options currently being explored
for the development of feasibility study to deliver an accessible walkway and interpretive
route around and adjacent to Ballynafagh Lake. Other options within the Just Transition
Programme are also being explored for the completion/development of an Eco Park in
Robertstown.

# **Community Hub for Maynooth**

The members considered the following motion in the name of Councillor Feeney.

That the council prepare a plan for the vacated fire brigade and council yard in tandem with the Harbourfield area to create a community hub for Maynooth.

The motion was proposed by Councillor Feeney and seconded by Councillor Ó Cearúil.

A report was received from the Economic, Community and Cultural Development informing the members that the provision for a community centre at the vacated fire brigade/council site in Maynooth is expected to emerge from the Town Renewal Masterplan for Maynooth as one of the ten key town renewal projects. The business case, which forms part of the Urban Regeneration and Development Fund (URDF) application, has recently been approved by the Department. It is expected that the Town Renewal Masterplan for Maynooth will take place in 2024. The timelines for the Harbourfield developments have yet to be finalised.

Councillor Feeney enquired if there was a timeline in relation to the Fire Brigade moving out, would it be six or twelve months.

Councillor O'Cearúil informed the members that there was a collective frustration in Maynooth from all the councillors based there. A tracker system was needed with these large scale schemes to see what stage they were at and what political support was needed.

Councillor Hamilton said that the members were all aware of the various irritations in relation to the Community Centre and that this had been going on for the last 10 years. He put forward the idea of a multi-facility centre to include Health, Amenities and Services, perhaps to include a Cinema or Theatre.

Ms. P Pender advised the members that there were over 60 projects at various different stages currently underway. She advised that 2024 would be the earliest, that the business



case had been approved and there was a body of work involved before the tender process adding that any one project could not be bumped up the line.

Ms. M Higgins informed the members that discussions were taking place in relation to the Area Machinery Yard and the vacating of the Fire Station. The Maynooth Masterplan was prioritised for 2024 and that these were all parts of the jigsaw and Capital Programme Funding had to be ensured. Ms. M Higgins advised the members that a meeting was taking place the following week with various different departments to make everyone aware of each other's timelines, to ensure they were all on the one path. The report was noted.

He advised that he would be happy to make a phone call to the Minister of State for Sport and Physical Education, Mr. Thomas Byrne.

Ms. P O'Brien informed the members that they were looking at other solutions and maybe not what was in the original funding application. They were looking at different providers and new technologies. A meeting had taken place with Swim Ireland and they were looking



to the UK also. The statistics from the Pop-Up Swimming Pool in Leixlip had provided great insights in relation to its use within the Community.

Ms. M Higgins advised the members that there had been no formal response to the appeal and that they were going to Plan B behind the scenes. Swim Ireland had provided excellent advice and that technology had moved on. A meeting had taken place with a company this week that used fabrics instead of concrete.

- Transportation Strategies Projects are ongoing in Maynooth and Newbridge. Each project will provide recommendations for walking, cycling, public transport, parking and traffic.
- Decarbonisation.

- Key Metrices-Target Year 2030-Baseline 2018

A report was received from the Sustainable Transport and Traffic Management Team informing the members that the area close to the junction of R407 Kilcock Road and R403 Celbridge Road has many conflicting vehicular movements. In order to improve the provision for vulnerable road users, Kildare County Council can examine a reallocation of road space to reduce the carriageway width on the approaches to the area from the junction to Hillview Estate. This will assist in reducing vehicular speeds and provide a shorter crossing distance for pedestrians. The provision of a signalised crossing is complicated due to the number of turning movements into and out of private premises. The option of reconfiguring the main R407/R403/Ballinagappa Road/Main Street and the potential signalisation of this junction can be explored. It should be noted that no funding sources is available for such extensive works and any proposals will be developed in the context of the Clane Town Centre First Plan.

The members considered the following motion in the name of Councillor Weld.



That the council provide a pedestrian crossing on College Road at the Woods Centre, Clane in light of recent accidents at this location.

The motion was proposed by Councillor Weld and seconded by Councillor McEvoy.

A report was received from the Sustainable Transport and Traffic Management Team informing the members that the area close to the junction of R407 Kilcock Road and R403 Celbridge Road has many conflicting vehicular movements. In order to improve the provision for vulnerable road users, Kildare County Council can examine a reallocation of road space to reduce the carriageway width on the approaches to the area from the junction to Hillview Estate. This will assist in reducing vehicular speeds and provide a shorter crossing distance for pedestrians. The provision of a signalised crossing is complicated due to the number of turning movements into and out of private premises. The option of reconfiguring the main R407/R403/Ballinagappa Road/Main Street and the potential signalisation of this junction can be explored. It should be noted that no funding sources are available for such extensive works and any proposals will be developed in the context of the Clane Town Centre First Plan.

- Yellow Box was refused.
- Major health and safety issue, that needs to be addressed.

The District Engineer informed the members that he would speak with the Sustainable Transport and Traffic Management Team. He was aware of the issue and will enquire about the possibility of a Pedestrian Crossing, if possible in 2024. He also added that ramps were not in line with Design Manual for Urban Roads and Streets (DMURS).

funded projects are clearly dependent on NTA approval of the design proposals, in accordance with their Project Approval Guidelines. Whilst the NTA remain supportive of the scheme, they have requested further investigations of design interventions for the options selection stage of the project. The council has been asked to progress a more cost-effective design and we are currently reviewing alternative designs. Once the NTA commit to funding an agreed design, a confirmed timeline for public consultation can be agreed with the members. The Sustainable Transport Section is progressing the completion of a revised Option Selection Report for the Scheme for submission before the end of 2023 to the NTA for consideration and approval. This report will include consideration of a cost-effective design. Once Phase 2 approval (Concept Development and Option Selection) is received then the team will continue on Phase 3 (Preliminary Design) which on approval leads to Phase 4 – the Statutory Process. Councillor Durkan said that when he was elected that this was out to consultation, it then came back in house and at that time he attended a meeting in Buswells Hotel. He added that this was 950m of road with 850 Students attending 2 schools at this location. There had previously been a deputation from parents from both schools. He was sick and tired of this and the excuses as to why this project has not moved forward.

The members raised the following:

- It would be helpful if a member of the Sustainable Transport Team attended the meetings.
- National Transport Authority (NTA) had huge power over these issues and clarity was needed.
- Councillors were accountable to the people.
- Enquired if councillors could pull funds to push this issue on.

- Dereliction of duty in relation to safety of the children of the area.

A report was received from the Parks Department informing the members that there is no scope within the existing programme of works to undertake a landscaping plan for the R407 until the works and projects outlined in the 2023 Parks Works Programme are completed. A number of these are in progress or have to be progressed before any additional works can be committed to. These are Allenwood Playground, Bawnogues Playground and Outdoor Gym and storage cabin, Communications Board for Prosperous Playground and Carton Avenue conservation plan. The landscaping plan for the R407 will be considered for next year's works programme.



Councillor McEvoy welcomed these works being part of the Programme of Works for next year and encouraged design works to be put forward. He added that the M50 in Tallaght had improved landscaping. He appreciated that the works were not simple and hedge cutting was needed and considerations would need to be given to biodiversity and wildlife. He said the opportunity should not be wasted and the space should be used well.

Mr. S Wallace informed the members that he was happy to meet up to scope out and get ideas.

Councillor Weld requested biodiversity and pollination be included in the plans and welcomed the report adding this was positive for next year. He enquired if works could be carried out in stages and that the works would make a huge improvement to the approach to Clane.

### Clane Town Centre First Plan

The members considered the following question in the name of Councillor McEvoy.

Can the council summarize progress and the next steps in preparing the Clane Town Centre First Plan?

A report was received from Housing and Regeneration Department informing the members that in October the public were asked to get involved in the preparation of the Clane Town Centre First Plan by completing a survey, sharing their views and providing feedback on how they think Clane can be developed and revitalized into a sustainable, radiant and dynamic centre. 766 responses were received to the survey. A public workshop was also held in early November. The consultants are currently compiling all data from both the public survey and the workshop with the intention to issue a baseline report in December. The Town Regeneration Officer has also made contact with local schools and has asked them to participate in the town centre plan process. Following the baseline report the focus will be on town centre themes, project identification, categorisation and mapping, with the intention of having a second public workshop around this time also.

### **10-Minute Communities**

The members considered the following motion in the name of Councillor Hamilton and Councillor Ó Cearúil.

That the council set a vision and long-term plan for village centres and 'quarters' in the Maynooth Local Area Plan (LAP) integrating residential, commercial/retail and community centres including the new region proposed to the west of Maynooth, in the Kilcloon area,



and in existing quarters of the town – towards creating more sustainable, circular 10-minute communities supporting high quality of life in new quarters of a high growth town.

The motion was proposed by Councillor Hamilton and seconded by Councillor Ó Cearúil.

A report was received from the Planning Department informing the members that the '10 Minute Settlement' principle is enshrined in Objective UD O3 of the Kildare County Development Plan 2023–2029 whereby all Local Area Plans are required to incorporate policies that will assist in its implementation. The development strategy for the Joint Maynooth and Environs Local Area Plan, being prepared by Kildare and Meath County Council, will be evidence-based, supported by a Social Infrastructure Audit, a Settlement Capacity Audit, an Area Based Transport Assessment and Habitat Survey to ensure the settlement as a whole is vibrant, connected, well-functioning and supports the development of 10-minute communities whose needs are met within the neighbourhood as far as possible. To ensure consistency with the planning policy hierarchy, existing and new neighbourhoods within the plan area will be considered and brought forward under the shared regional Key Principle of 'Healthy Placemaking' as contained in the Regional Spatial and Economic Strategy (RSES).

Part of their remit is to work with local businesses and community groups to identify tourism opportunities in Maynooth and to access funding to realise suitable projects.

# Green Space between Towns and Villages in the Municipal District

The members considered the following motion in the name of Councillor Hamilton.

That the council include a plan for protection of green space between towns and villages in the planning process for the municipal district and relevant Local Area Plan (LAP) processes.

The motion was proposed by Councillor Hamilton and seconded by Councillor McEvoy.

A report was received from the Building and Development Control Department informing the members that the Kildare County Development Plan 2023-2029 provides the policy context for protecting green spaces between settlements in County Kildare. Of relevance are; Chapter 3: Housing provides a robust Rural Housing Policy that seeks to maintain green spaces between settlements in Zone 1 – Areas of Strong Urban Influence between defined settlements, which covers most of the County, by only allowing new homes where there is a demonstrable 'economic or social' need to live in a rural area and build their home to live on their productive land. A key part of the policy framework is for new housing in rural areas to be facilitated by "Serviced Sites" across a series of villages and rural settlements in County Kildare as a sustainable alternative to rural housing, thus contributing towards the protection of the open countryside.



Chapter 11: Built and Cultural Heritage that seeks to protect, conserve, and sensitively manage the built and cultural heritage, including historic landscapes and Architectural Conservation Areas that lie between settlements.

Chapter 12: Biodiversity and Green Infrastructure, which includes the Green Infrastructure Maps that illustrate areas of land that benefit from designation for a variety of purposes. There is a specific objective in Chapter 12 of relevance to the motion: Objective BI O66 states the following; Develop a strategy, to identify a series of greenbelt/green spaces (in addition to those identified in this CDP) to retain and protect between the growing settlements within Kildare during the lifetime of the Plan with particular attention to the undeveloped areas between Celbridge, Leixlip and Maynooth and to collaborate with South Dublin County Council, where appropriate.

Chapter 13: Landscape, Recreation and Amenity that seeks to protect the County's landscape of significance (e.g., Landscape Sensitivity Areas) and to ensure that appropriate recreational and amenity provision is made across the County (e.g. in the form of Regional Parks and Urban Neighbourhood Parks), including in those areas between settlements. One example objective is LR 066: Liffey Valley Park objective that seeks to progress the delivery of the park that will provide a pedestrian link along the River Liffey connecting green and open spaces along the river valley. A feasibility study on the first section of the River Liffey Park, between Celbridge and Leixlip Saint Catherine's Park, is programmed for completion in 2024.

The development plan therefore provides a broad-based protection to green space of significance between towns and villages, and objectives to provide further protection. Of direct relevance to the motion will be the implementation of Objective BI 066 to prepare a strategy for the protection and productive use of green spaces between settlements. This strategy will be delivered according to priorities and as resources allow.

# Taking in Charge Moyglare Hall Maynooth

Can the council provide a full update on the taking in charge of Moyglare Hall, Maynooth?

A report was received from the Building and Development Control Department informing the members that Development Control recently met with the developer and their design team in Kildare County Council's offices in order to progress the taking in charge of the Moyglare Hall estate. The developer has confirmed that they have had CCTV surveys, and any repairs identified completed on both the storm and foul lines throughout the estate. Development Control await the submission of a formal taking in charge request from the developer along with the associated documentation including the CCTV surveys, matching as-constructed drawings, taking in charge and vesting maps and any data sheets and operating and maintenance manuals pertaining to storm infrastructure. Any documentation required in relation to the pumping station serving the Moyglare Housing estate (originally constructed by the developer of Moyglare) must be submitted by the design team acting on behalf of the KWETB. This is because the pumping station was subsequently upgraded by the KWETB in order to serve the Maynooth Education Campus.
