Declaration of Pecuniary or Beneficial Interests

The following declarations were made by the members of pecuniary or beneficial interests under Section 177 of the Local Government Act 2001, as amended.

Councillor McEvoy advised that he was a member of a group receiving a grant under Item 29 Community, Festival and Resident Association Grant Awards and that he would excuse himself from the meeting when this item was being considered.

The Cathaoirleach noted that Councillor Fitzpatrick and himself would also leave the meeting when Item 30 was being considered as they were both part of the Drehid Committee that assessed the grant applications, and confirmed he would be asking another elected member to take the chair for this item.

Councillor McEvoy noted that the quorum of four elected members for this Municipal District needed to be maintained when considering these items.

The Cathaoirleach noted that as Councillor Fitzpatrick had to leave the meeting early, that his items - 15, 21, 28 and 34 on the agenda - would be taken next. All members agreed.

CM08/0422

Footpath from Allenwood Village to Derrymullen Bridge

The members considered the following motion in the name of Councillor Fitzpatrick.

That the council provide a cost for a footpath from Allenwood Village to Derrymullen Bridge.

The motion was proposed by Councillor Fitzpatrick and seconded by Councillor Wyse.

A report was received from the Roads, Transportation and Public Safety Department informing the members that there is currently a footpath on the left handside leaving Allenwood towards Derrymullen Bridge. The last section of approximately 125 metres is without a footpath. The existing road margin is not wide enough to facilitate a footpath without encroachment onto privately owned land. There is also an existing Irish Water infrastructure that would need to be relocated to facilitate a footpath. Without knowing the cost of relocating this infrastructure and without owning the land required to construct the footpath, it is difficult to give a costing. The rough cost of just constructing the footpath would be in the region of €125,000 without taking account of the cost of the issues highlighted.

The following points were raised by the members:

- This was an ongoing issue that had been present since the former council.
- A footpath was needed from the village of Allenwood up to the Derrymullen
 Bridge as it was a popular route for locals
- There was a section of the road that was especially dangerous for pedestrians coming up to the bridge.
- If this bridge was addressed it would give safe connectivity for pedestrians in this area.

 The ownership issues of the footpath at the bridge were well known and a conversation with the land owners should be arranged.

The District Engineer said that he had looked at this issue previously and that he had been advised that it was a multi party matter. He said that there was Irish Water infrastructure in the area and that the land was privately owned. He stated that it would be hard to put a price on this before addressing the issues mentioned.

Resolved on the proposal of Councillor Fitzpatrick, seconded by Councillor Wyse and agreed by the members present that the report be noted.

Serviced Sites in Clogherinkoe

The members considered the following question in the name of Councillor Fitzpatrick.

Can the council confirm what plans it has for providing serviced sites in Clogherinkoe, in light of the Draft County Development Plan going on display? A report was received from the Housing Department informing the members that the Draft Kildare County Development Plan 2023-2029 is scheduled for adoption in December 2022, if adopted it will take effect from January 2023. The preparation of a County Kildare Serviced Sites Initiative is an action of the plan. In consultation with the councillors and the Planning and Economic Development SPC a Draft County Kildare Serviced Sites Initiative will be prepared in the coming months and this will determine the criteria for the sale/allocation of sites under the scheme. The site owned by Kildare County Council in Clogherinkoe will be considered as part of this initiative.

The report was noted.

Litter at an Old Reservoir Structure at the lock at Digby Bridge

The members considered the following motion in the name of Councillor Fitzpatrick.

That the council engage with Waterways Ireland with a view to tidying up and removing litter at an old reservoir structure at the lock at Digby Bridge.

The motion was proposed by Councillor Fitzpatrick and seconded by Councillor McEvoy.

A report was received from the Environment Department informing the members that with the members agreement the council will make contact with Waterways Ireland as requested.

Councillor Fitzpatrick raised the following points:

- It was noticeable while walking by Digby Bridge that there was an accumulation of litter in the reservoir
- People from all areas used this location as a destination for walking.
- A consultation between Waterways Ireland and Kildare County Council should be set up to address this issue and to agree to maintain the area.

Resolved on the proposal of Councillor Fitzpatrick, seconded by Councillor McEvoy and agreed by the members present that the council engage with Waterways Ireland and that the report be noted.

Playground at ACDAL in Allenwood

The members considered the following question in the name of Councillor Fitzpatrick.

Can the council provide a timeframe for the completion of the playground at ACDAL in Allenwood?

A report was received from the Community and Cultural Department informing the members that it is planned to tender the playground in April. The council hope to have a contractor on site by the end of the Summer but the timeframe for this and a completion date can only be established once the council know the successful tenderer and what lead times they have starting and on the delivery of equipment. The council will keep the members informed of all timeframes once a contractor has been appointed.

Taking in Charge of Meadowbrook estate in Maynooth

The members considered the following question in the name of Councillor Feeney.

Can the council provide an update on the taking in charge of Meadowbrook estate in Maynooth?

A report was received from the Roads, Transportation and Public Safety Department informing the members that a Development Control legacy team has been appointed to progress legacy taking in charge requests and are currently working through the list. Meadowbrook is on a priority list and will be progressed in due course. The report was noted.

Housing Estates to be Taken in Charge

The members considered the following question in the name of Councillor Durkan.

Can the council provide an update and timeline for housing estates yet to be taken in charge in the Clane-Maynooth Municipal District?

A report was received from the Roads, Transportation and Public Safety Department informing the members that a Development Control legacy team has been appointed to progress legacy taking in charge requests. The team are currently working through a county wide list. Estates from each municipal district are being looked at in tandem. The Development Control legacy team are working closely with the Municipal District Engineers and Irish Water to progress the taking in charge, where possible. Simultaneously, the existing Development Control team continues to progress current developments through the process. There are a number of estates within the Clane-Maynooth Municipal District progressing.

There are 23 estates in the Clane-Maynooth Municipal District where a taking in charge request has been submitted to the council, but they have not yet been taken in charge for a variety of reasons. As you will appreciate it is impossible to provide definitive timelines for the taking in charge process for each of these estates as it involves many stakeholders, however if there is a specific development you have in mind, please advise and we shall provide an update.

The next bi-annual report to council, which shall include the current situation and potential obstacles to taking in charge, will be presented at the plenary meeting in July 2022.

Councillor Durkan suggested that it would be a great help if the council could work from the oldest to newest requests for taking in charge.

The District Engineer advised that some estates that were considered easier to advance that only had small issues to be dealt with before being taken in charge, were generally completed first.

Ms S Walsh said that there had been a listed drafted that included the detail of the prioritization of the estates to be taken in charge. She highlighted that the Meadowbrook estate had a tree survey gone to tender and that another two estates in the municipal district are to be advertised for taking in charge at an upcoming meeting. She explained that due to the fact that estates can be finished to different standards that this could affect the time for them to be taken in charge.

Councillor Durkan asked that Castledawon, Newtown Hall and Chambers Park be considered for prioritization. Ms Walsh said that the councillor may contact her by phone or email to discuss these futher.

The report was noted.

Update on Roads Design Projects

The Cathaoirleach welcomed Mr S Deegan, Senior Engineer from the Roads Design team.

Mr Deegan delivered an update to the members highlighting the following projects:

- Roads Projects and Planning Team
- Maynooth Eastern Relief Road
- Capdoo Clane
- Transport Strategies

- Junction Programme
- Bridge Programme
- Roads Planning
- Department of Transport Support Office

The following points were raised by the members:

- Dagwelds Cross needs to be advanced as a matter of urgency.
- The Maynooth Transport Strategy should look to include accessibility within its plan to pre-empt any accessibility issues.
- They were disappointed to see that the Maynooth Eastern Relief Road would not be completed sooner than 2025.
- Would it be possible to have a copy of the slides of the given presentation?
- Under the Junction Programme section could the rational of not incorporating all of Firmount, Prosperous and Dagwelds at the first stage be explained.
- Was the funding allocated for the design stage or for the actual works?
- The Maynooth Orbital Route seemed to have fallen by the wayside. Was there any chance to compress the timeline for the works on this project?
- Was the Allenwood Cross traffic counting data available to the elected memebrs?

Mr S Deegan confirmed the following points:

- Acknowledged and has noted the importance of Dagwelds Cross.
- Accessbility issues are included in conversations of the Maynooth Transport
 Strategy and also as part of the consultation for the same plan.
- The slides could be made available to the elected members.
- The rationale for the junctions within the plan was that there was a number of junctions to be dealt with for each municipal district. There was also funding received and to be used for certain junctions and that would dictate in some instances which ones were addressed first. Data from the Department of Transport and information regarding accidents and traffic would impact the priorization of the junctions also.
- The meetings with the landowners along the Maynooth Eastern Relief Road had been very good and once the council has been given the go ahead they

will progress with the works. This project also included working alongside the Housing Department as it was a LIHAF project.

- He was unsure of the traffic count infrastructure at Allenwood Cross.

Bike Repair Stations on the Royal Canal Greenway

The members considered the following motion in the name of Councillor Durkan. That the council, in conjunction with Waterways Ireland, install public bike repair stations on the Royal Canal Greenway to aid cyclists on their journeys.

The motion was proposed by Councillor Durkan and seconded by Councillor Feeney.

A report was received from the Roads, Transportation and Public Safety Department informing the members that Kildare County Council will engage with Waterways Ireland to determine the types of infrastructure provided on other Greenways, the funding mechanism used to provide, install and maintain the stations. Consideration will also need to be given to the ongoing costs and maintenance of this infrastructure. With the members agreement, this request can be referred to the Transportation SPC for further investigation and analysis.

Councillor Durkan raised the following points:

- Had already approached and spoken with local bike shops about the idea of installing the public bike repair stations.
- These bike repair stations would be aimed more so at the occasional cyclist as they were more likely to be caught out than experienced cyclists.
- The bike repair stations would be secured by chains and/or wires.
- This motion could be sent to Full Council with the support of the elected members and then sent onto the Transportation SPC.
- Waterways Ireland should be consulted regarding the installations of the bike repair stations.

Resolved on the proposal of Councillor Durkan, seconded by Councillor Feeney and agreed by the members present that this motion be sent to Full Council for consideration and that the report be noted.

Surface Repairs on the Royal Canal Greenway

The members considered the following motion in the name of Councillor Durkan.

That the council request Waterways Ireland to carry out surface repairs on the Royal

Canal Greenway between Maynooth and Kilcock.

The motion was proposed by Councillor Durkan and seconded by Councillor Farrelly.

A report was received from the Roads, Transportation and Public Safety Department informing the members that the Municipal District Engineer will liase with the Waterways Ireland counterpart to arrange for necessary maintenance to be carried out.

Councillor Durkan raised the following points:

- Some areas on the Royal Canal Greenway between Maynooth and Kilcock have significant potholes that are in need of repair.
- Could tarmac be used instead of gravel as previous repairs with gravel did not last.

Resolved on the proposal of Councillor Durkan, seconded by Councillor Farrelly and agreed by the members present that the report be noted.

CM17/0422

Installing a Footpath and Public Lighting on the Ardrass Road Straffan

The members considered the following motion in the name of Councillor Feeney.

That the council explores the possibility of installing a footpath and public lighting at the section of the Ardrass Road Straffan along the north-facing perimeter of Straffan GAA to enhance safer active travel.

The motion was proposed by Councillor Feeney and seconded by Councillor Durkan.

A report was received from the Roads, Transportation and Public Safety Department informing the members that as part of a granted planning permission, Straffan GAA are conditioned to install a footpath along this section to link the facility to the Village.

Councillor Feeney raised the following points:

- The public are encouraging children to be active and walk to the GAA club.
- This section of road was currently dangerous for walkers, especially during the darker months due to no street lighting.
- Could any timeline be provided for the this and could any pressure be applied for it to commence?

The District Engineer advised that Straffan GAA club were in the process of considering installing a footpath and what would be suitable for this area. He said that he expected the club to make a planning submission in the coming month.

Resolved on the proposal of Councillor Feeney, seconded by Councillor Durkan and agreed by the members present that the report be noted.

Cul de Sacs/Roads in Courtown Estate, Kilcock

The members considered the following motion in the name of Councillor Ward.

That the council undertake to examine the numerous cul de sacs/roads in Courtown Estate, Kilcock with a view to undertaking the necessary repairs/resurfacing of localised flooding/potholes issues in the estate.

The motion was proposed by Councillor Ward and seconded by Councillor Durkan.

A report was received from the Roads, Transportation and Public Safety Department informing the members that the Municipal District Office will inspect the roads in Courtown and carry out repairs to any localised potholes. Where water is ponding in an estate, a full overlay to reshape the road may be required. If this is the case, funding will have to be identified.

Councillor Ward raised the following points:

- Agreed that a full overlay should be considered due to the ponding issue repeating.
- The issue had been that previous repairs did not last long enough.
- The pooling of water had been causing difficulties for cars in the area, especially when turning.

 Was aware that funding would be a key issue for this work and would appreciate meeting on site to identify what could be done and what amount of funding would be required.

The District Engineer said that he would meet the elected member on site. He noted that some of the roads were quite old and the gradient on them needed addressing. He agreed that funding could be identified for next year. Pothole repairs are more difficult in these older estates and sometimes a bigger overlay was required to resolve these issues.

Resolved on the proposal of Councillor Ward, seconded by Councillor Durkan and agreed by the members present that the report be noted.

Speed Analysis Review on Church Street Kilcock

The members considered the following motion in the name of Councillor Ward. That the council undertake a speed analysis review of traffic on Church Street Kilcock outside Abbeyfield estate as soon as possible.

The motion was proposed by Councillor Ward and seconded by Councillor Feeney.

A report was received from the Roads, Transportation and Public Safety Department informing the members that the Municipal District office would arrange for a speed survey to be carried out at this location.

Resolved on the proposal of Councillor Ward, seconded by Councillor Feeney and agreed by the members present that the report be noted.

Driver Feedback Sign on the Carbury side of Johnstownbridge

The members considered the following motion in the name of Councillor Wyse.

That the council repairs the driver feedback sign on the Carbury side of Johnstownbridge near the entrance to The Glebe housing estate, which is no longer providing a speed readout.

The motion was proposed by Councillor Wyse and seconded by Councillor Feeney.

A report was received from the Roads, Transportation and Public Safety Department informing the members that the Traffic Management Team have contacted the traffic maintenance contractor and they will attend the site and carry out the necessary repairs.

Resolved on the proposal of Councillor Wyse, seconded by Councillor Feeney and agreed by the members present that the report be noted.

Yellow Box Junctions on Main Street, Maynooth

The members considered the following question in the name of Councillor Hamilton. Can the council outline the plan for the repainting of the four sets of yellow box junctions on Main Street, Maynooth?

A report was received from the Roads, Transportation and Public Safety Department informing the members that the Municipal District office has ordered signage and plan to have it in place in the coming months once delivered.

The report was noted.

The members considered the following motion in the name of Councillor Farrelly. That the council outline the application process to seek permission to erect a monument at Hatters Cross Prosperous.

The motion was proposed by Councillor Farrelly and seconded by Councillor Ward.

A report was received from the Corporate Services Department informing the members that there is a Civic Memorial Policy that outlines the process for groups or individuals who are seeking to erect a civic memorial. All proposals are subject to assessment by the Civic Memorial Technical Committee and a recommendation of the Corporate Policy Group to go to municipal district or full council for final decision. The policy and application form are attached.

Councillor Farrelly raised the following points:

- This request had come about as a result of discussions around putting a monument at Hatters Cross Prosperous with the local Tidy Towns group.
- The information, application and policy was greatly appreciated and would be brought back to the group.

Resolved on the proposal of Councillor Farrelly, seconded by Councillor Ward and agreed by the members present that the report be noted.

Ms M Hunt informed the members that a report on all projects had been circulated to the members prior to the meeting and that she would be happy to respond to any questions that the members had.

Carton Avenue Master Plan

The members considered the following motion in the name of Councillor Hamilton. That the Carton Avenue master plan be a nature focused and net zero plan that includes specific objectives to support biodiversity, capture carbon, and the planting and protection of native species in a positive amenity space for the community.

The motion was proposed by Councillor Hamilton and seconded by Councillor Feeney.

A report was received from the Community and Cultural Department informing the members that any masterplan prepared for Carton Avenue will consider the factors above in conjunction with the amenity requirements needed to be delivered for Maynooth and surrounding areas within the lands.

Councillor Hamilton raised the following points:

- The support of the fellow members was appreciated to keep the focus on this project.
- What were the next steps for this plan?

Ms M Hunt said that a business case was to be approved and that engagement with a consultancy design team would then follow. She noted that this work would be carried out alongside the Parks section.

Mr S Wallace said that there was a conservation plan to be followed. He stated that initial archaeological works had been carried out but that there was more to be completed. He noted that this would inform the development of the masterplan for Carton Avenue.

Resolved on the proposal of Councillor Hamilton, seconded by Councillor Feeney and agreed by the members present that the report be noted.

A Similar project commenced in Kilcock and one is due to commence in Clane. In relation to the Prosperous Town Park project the fence and gate for Prosperous Town Park is currently in manufacture and will be installed by the end of April. The report was noted.

Disabled Parking Bays at Laraghbryan Cemetery Maynooth

The members considered the following motion in the name of Councillor Feeney.

That the council provides disabled parking bays at Laraghbryan Cemetery

Maynooth.

The motion was proposed by Councillor Feeney and seconded by Councillor Farrelly.

A report was received from the Environment Department informing the members that there is no car park nor designated car parking spaces – of any kind - at

Laraghbryan. There are parking spaces on the roadside immediately outside the cemetery road, and if the members are in agreement, the council can provide and install signage indicating an area for disabled parking beside the entrance gate.



The members raised the following points:

- Disabled parking was badly needed at Laraghbryan Cemetery in Maynooth.
- This area should be considered for review during the County Speed Limit Review as it was subject to high traffic speeds which was dangerous for people parking outside the cemetery.

Resolved on the proposal of Councillor Feeney, seconded by Councillor Farrelly and agreed by the members present that the council install signage on the roadside immediately outside the cemetery indicating an area for disabled parking. The report was noted.

Capacity of Wastewater Systems to Accommodate New Developments

The members considered the following motion in the name of Councillor Wyse. That the council requests Irish Water to provide a report outlining the current capacity of wastewater systems to accommodate new housing developments in the settlements of Allenwood, Coill Dubh, Derrinturn, Johnstownbridge, Kilmeague and Robertstown; and where capacity is currently unavailable, or will be exceeded in the next three years, the report should outline Irish Water's plans to increase capacity with projected timelines for those plans.

The motion was proposed by Councillor Wyse and seconded by Councillor Farrelly.

A report was received from the Water Services Department informing the members that in advance of the members consideration, Water Services has already forwarded this motion to the Local Representatives Desk in Irish Water and will update the municipal district as soon as their report is to hand.

The members raised the following points:

- The new part of the County Development Plan discusses the growth in areas around the county. The need for more capacity of wastewater systems for this growth needed to be addressed.
- The wasterwater capacity in Derrinturn and Allenwood was at a standstill.
- The County Development Plan needed to be practical in its approach with respect to capacity of wastewater systems.
- This was not just a rural issue, both Maynooth and Kilcock were struggling with their capacity of wastewater systems. There was an application for 70 houses refused permission due to lack of capacity of wastewater systems.
- Could this motion be amended to include Prosperous? There were similar issues in that area. The members agreed to include Prosperous in the letter to Irish Water.

Resolved on the proposal of Councillor Wyse, seconded by Councillor Farrelly and agreed by the members present that a request to Irish Water be made, to include the agreed amendment to include Prosperous.

Basketball Half-court in Prosperous Town Park

The members considered the following motion in the name of Councillor Farrelly. That the council investigates the feasibility of installing a basketball half-court in Prosperous Town Park.

The motion was proposed by Councillor Farrelly and seconded by Councillor Ward.

A report was received from the Community and Cultural Department informing the members that the feasibility of a basketball court or similar can be considered for Prosperous Town Park but work on this will not be possible in the current year as the Parks Section have already set out a works programme for the year and the Parks Section do not have the resources to facilitate any additional projects at this time. The members raised the following points:

- This idea was raised while speaking with the Prosperous Tidy Towns group.
- There looked to be sufficient space for a basketball half-court.
- Was there any possibility of it potentially being included in the 2023 work plan? This would be subject to funding.
- There were older children living in this area that would like to share the space in the park and have no suitable amenity for themselves.

Mr S Wallace asked would this be the right facility to be installed and the best use of the limited space there. He had no problem with the suggestion of the half-court in principal. He highlighted that he would prefer not to place it where there was currently the pond in the park as this was a biodiverse asset to the area. He agreed that consultation should be held with the Tidy Towns group from Prosperous for this suggestion.

Resolved on the proposal of Councillor Farrelly, seconded by Councillor Ward and agreed by the members present that a consultation be organised with the Tidy Towns Group from Prosperous and that the report be noted.
