

# Minutes of the Kildare Newbridge Municipal District held at 11.00 am on Wednesday, 21 July 2021 via Microsoft Teams

# **Declaration of Pecuniary or Beneficial Interests**

The Mayor welcomed everyone to the meeting and asked that if there were any declarations of interest under Section 177 of the Local Government Act 2001, as amended. There were no declarations of interest.

The Mayor suggested that the Bord na Móna presentation be taken next and the District Manager confirmed that the representatives from Bord na Móna were present.

#### Update from Bord na Móna on the Masterplan

The Mayor welcomed the representatives from Bord na Móna Mr John Rafferty and Mr Pat Sammon to the meeting.



Mr Rafferty delivered a presentation to the members which included a detailed aerial image of the Newbridge site and highlighted the points of access, the areas which will be open to the public and the vehicular access and inclusion of perpendicular cycle paths.

- He noted that this Masterplan had been designed to align with the Newbridge Local Area Plan (LAP) but understands that the LAP is to be reviewed.
- He also highlighted the inclusion of greenspaces and the expansion of the current greenspace which is on site.
- He identified the new headquarters of Bord na Móna which would be situated in a building adjacent to the street.
- The old English army barracks would be retained for historical purposes. This structure was not protected but was valued.
- He stated that residential units beside the Athgarvan Road entrance were included in the Masterplan. This was awaiting an architectural contest for the design..

The councillors raised the following points in response to the presentation:

- A request was made for the process of the Masterplan to be explained.
- Previously concerns were raised about the affect this plan would have on the Traffic Management Plan.
- There was a feeling that the public do not want to lose the green space in the middle of the town.
- More accessibility was needed in Newbridge Town and the saving of greenspaces was very important.
- Having the green space on Main Street would not be architecturally good.
- The opportunity to maintain the walkability and permeability was vital.
- If the buildings onsite could be of a good height that would be a positive.
- Would the materials to be used for this project match the current street design?
- Building D appeared to block off the green space to the Main Street.
- The increase of biodiversity on site was mentioned, how was this measured and where was this included in the plan?
- Will there be a financial gain for Bord na Móna?



Mr Rafferty responded with the following points:

- A number of subcontractors and consultants have been engaged with to progress this Masterplan.
- Bord na Móna want to develop a sustainable building for their new home. This will represent where they have come from and where they plan to go in the future. They have rebranded as a sustainable company with a focus on biodiversity.
- The new plan will have greater focus on biodiversity and this can be seen with the inclusion of the new green spaces.
- Units which are three or four stories high will be looked at so as to not overshadow the surrounds and take into account the neighbouring Whitewater shopping centre
- Stakeholders in the area will be consulted.
- The sustainability and materials of the Masterplan are set out in the tender brief. It was too early to discuss these in detail.
- Buildings C and D locations are indicative.
- The pedestrian routes on site will be adjacent to the roads. The segregated cycle ways are included here.
- This was just a concept Masterplan.
- There would be no financial gain for Bord na Móna.

Mr Sammon concluded the presentation with the following points:

- The redesign of the Bord na Móna site was a big change for the organisation and everyone connected with it.
- Bord na Móna were proud to stay sited in Newbridge Town.
- Biodiversity was very important to Bord na Móna and this new plan contains a number of positive wins around biodiversity.
- There was a lot of the tarmacadam on the site which will be revamped into green space.

The Mayor and members thanked Mr Rafferty and Mr Sammon for the very informative presentation and looked forward to further positive engagement on the masterplan in the future.

Councillor S Doyle also nominated the proposa of funding of €3,500 each from ClIrs Doyle; Stafford; Power and Duffy for the Kildare Heritage Centre, total of €14,000. Councillor Power seconded the proposal, it was also supported by Councillors Duffy and Stafford and agreed by the members.

**Resolved** on the proposal of Councillor Kevin Duffy seconded by Councillor Rob Power and agreed by the members, that the allocations as outlined be approved.

#### Capital Programme 2022-2024

A report in relation to Capital Programme was circulated to members in advance of their meeting. The District Manager gave a brief overview of the Capital Programme process. He asked that if any members had any issues to please convey them to him and he would relay the comments to Finance and other relevant departments. He went on to say that previously discussed projects have been progressed.

The Mayor asked if the members had any feedback to please provide comment.

The following points were raised by the members:

- The discussion around the Capital Programme warranted a separate meeting.
- The Newbridge second bridge looks to have been omitted from the Capital Programme.



- The Public Realm team was a victim of its own success. An increase of funding was required.
- The Cherry Avenue project was skipped. The space in this area could have been used throughout the past year, especially during the pandemic. This project needs to be advanced.
- Inclusion of the improvement of Thompson's Cross junction.
- The Kilcullen Industrial Estate road was still on the programme and should be revisited.
- Was there a live document which breaks down the timeline commencement and includes updates?
- There should be a dropdown line in the programme to explain projects.
- Can clarity be provided around the two land acquisition items?
- Had €1 million been allocated for cycle tracks in the municipal district?
- Why had the Curragh Plains €70,000 set aside for it?
- Why was €8,000,000 included for the Machinery Yard?
- Why was the playground in Newbridge currently pending?

The District Manager recalled that last year any clarifications were brought back to the members and he advised that the same approach would be taken this year. He explained that 80% of the Capital Programme funding comes from Central Government and projects are contingent on this. He acknowledged that the Capital Programme could be clearer. He assured the members that the second bridge was still included in the programme and that the council was committed to this project and that a briefing had been arranged for the members on this project. The Public Realm resources point was understood and the comments on this would be taken back to management. There was €6,800,000 for Cherry Avenue allocated and a timeline would be brought back for this project. The District Manager advised that he would revert on the inclusion of the improvement of Thompson's Cross junction and the Kilcullen Industrial Estate road queries. The Machinery Yard and the Curragh Plains projects costing were subject to tender. He also noted that he was not aware what the €1,000,000 for cycle tracks was for but that he would find out and enquire about the update on playgrounds.

# Part 8 – Proposed Improvements at Newhall Junction R445

The Senior Engineer introduced the Senior Executive Engineer who gave a quick overview of the pre-part 8 briefing which he had previously delivered to the landowners and the members.

Mr Paul Bergin, Director of Kilgallen and Partners Consulting Engineers, gave a presentation to the members. He noted that he had presented previously to the members before the Part 8 and showed them an aerial image of the Newhall Junction. The Roads, Transportation & Public Safety Department considers that the proposed Newhall Junction Improvement Scheme will have a significant positive impact on the R445 and the surrounds by improving and providing safe access and exit from the R445 for all road users and were seeking the approval of the members for the scheme.

The members raised the following points:

- Would a left turn at Lady crossroad still be possible with this scheme?
- Provision of cycle lanes was great for future.
- Can the landscaping use local/native trees?
- What was the likely costing? Where would the funding be coming from? Was there a cheaper option? Projects
- Applaud the engagement with locals. Would reassurances be given to locals with solutions?

Mr Bergin responded as follows:

- The left turn would be available off the local road onto the dual carriageway but not off the main road.
- Rural areas or roads of 80 km/hr don't have raised tables crossings. It's not the environment for them and people won't be expecting them. They would only be considered if the speed limit changed. Ramps/tables not currently advisable.
- Any future proofing, as with the provision of cycles lanes, will help future upgrades.
- The Parks Department will advise and approve the landscaping and the use of the native trees.



- The scheme would cost €3,000,000 and this was provided for in the Capital Programme however, it was hoped that it could be achieved for less. The scheme would be 100% funded subject to the Part 8 application and will go to Government for part funding.
- This scheme has been discussed with both land and property owners in the area. Any updates, changes or new information would also be highlighted with them.

**Resolved** on the proposal of Councillor Duffy, seconded by Councillor McLoughlin Healy and agreed by the members present that the Part 8 Proposed Improvements at Newhall Junction R445 be approved.

# Traffic Calming at Ballykelly Crossroads in Monasterevin

The members considered the following motion in the name of Councillor Noel Connolly. That the council implement traffic calming and accident prevention measures at Ballykelly Crossroads in Monasterevin as a matter of urgency.

The motion was proposed by Councillor N Connolly and seconded by Councillor Duffy.

A report was received from the Roads Transportation and Public Safety Department informing the members that there is no funding allocated to carry out any works at this location in the 2021 budget. The Municipal District Office will include the location in the line marking schedule for 2022 subject to budget availability.

The following points were raised by the members:

- This issue of traffic calming at the crossroads needs action.
- The grass cutting in the area has helped.



- Understands budget constraints.
- Situation should be monitored.

The District Engineer confirmed her team would explore the cost funding for this work next year.

**Resolved** on the proposal of Councillor N Connolly, seconded by Councillor Duffy and agreed by the members present that the report be noted.

# Speed reducing measures Roseberry/Barretstown Road/Newbridge College junction

The members considered the following motion in the name of Councillor Peggy O'Dwyer That the council consider additional speed reducing measures at the roundabout at Roseberry/Barretstown Road/Newbridge College junction.

The motion was proposed by Councillor P O'Dwyer and seconded by Councillor Stafford.

A report was received from the Roads Transportation and Public Safety Department informing the members that the roundabout is fully designed with all approaching signs in place, speed cushions on the Barrettstown approach road and it is within the 50 KMPH zone. The Municipal District Office will renew the road markings, however, speed after that is a matter for the Gardai. A site visit to be arranged.

**Resolved** on the proposal of Councillor P O'Dwyer, seconded by Councillor Stafford and agreed by the members present that the report be noted.

#### KN11/0721

#### Filter light on the Athy/Kilcullen road

The members considered the following motion in the name of Councillor Tracey O'Dwyer That the council carry out an assessment of the need for a filter light on the Athy/Kilcullen road to allow cars safely turn right onto the Newabbey road.

The motion was proposed by Councillor T O'Dwyer and seconded by Councillor A Connolly.



A report was received from the Roads Transportation and Public Safety Section informing the members that the provision of a right-hand filter signal for this approach will be assessed as part of any planned future upgrade works at these traffic signals.

The following points were raised by the members:

- Councillor T O'Dwyer did not accept the report.
- The filter light would warrant assessment, and this would be brought up with the team offline.
- Cross and Passion secondary school were giving land for a bus shelter. Suggestion that the council should consider looking at both in conjunction.

**Resolved** on the proposal of Councillor T O'Dwyer, seconded by Councillor A Connolly and agreed by the members present that the report be noted.

#### Sharp bend at Christianstown, Milltown

The members considered the following motion in the name of Councillor Anne Connolly That the council make safe a sharp bend at Christianstown, Milltown.

The motion was proposed by Councillor A Connolly and seconded by Councillor Stafford.

A report was received from the Roads Transportation and Public Safety Department informing the members that a full technical assessment and detailed design will be required to progress this request. Depending on the outcome of the assessment and design, this may also involve land acquisition and relocation of existing services. There are currently no resources available or funding identified to progress the request.

Councillor A Connolly stated that a design is required and should be done as soon as possible in the interest of safety.

**Resolved** on the proposal of Councillor A Connolly, seconded by Councillor Stafford and agreed by the members that the report be noted.

#### Traffic Calming Measures at Christianstown

The members considered the following motion in the name of Councillor Mark Stafford.



That the council install the appropriate traffic calming measures at Christianstown, Newbridge which has become an accident blackspot due to the sharp bends at this location and the speed of traffic.

The motion was proposed by Councillor Stafford and seconded by Councillor A Connolly.

A report was received from the Roads Transportation and Public Safety Department informing the members that a full technical assessment and detailed design will be required to progress this request. Depending on the outcome of the assessment and design, this may also involve land acquisition and relocation of existing services. There are currently no resources available or funding identified to progress the request.

Councillor Stafford asked that when the District Engineer and their department are addressing this issue could they also look toward the bend at Milltown. He also suggested a meeting with Councillor A Connolly and the District Engineer on site.

**Resolved** on proposal of Councillor Stafford, seconded by Councillor A Connolly and agreed by the members that the report be noted and an on site meeting to be arranged.

#### **Border Gritting Routes**

The members considered the following question in the name of Councillor Tracey O'Dwyer. Can the council provide an update following my motion at the February Kildare Newbridge Municipal District Meeting asking that Kildare County Council engage with neighbouring councils to identify border routes that could be shared in the 2021/2022 gritting route so as to allow additional accident prone roads such as Sunnyhill Road Kilcullen, Brannockstown to Naas road and Dunlavin to Kilcullen Road be included in the gritting programme for 2021/2022, and confirm if there has been progress made in this regard?

A report was received from the Roads Transportation and Public Safety Department informing the members that co-operation is ongoing with all neighbouring counties as regards Winter gritting, however, counties are unable to undertake additional routes. If any



additional roads are added to the gritting routes, Kildare County Council must identify what roads are to be omitted.

Councillor T O'Dwyer asked had the other council declined assisting or had Kildare County Council asked? The District Engineer advised that there was a cross county review and that funding was an issue.

The report was noted.

# Installation of Lighting on 100 Acres Route

The members considered the following question in the name of Councillor Doyle. Can the council confirm if it has any plans to install lighting (potentially solar) on the 100 acres route in Kildare town, in light of significant development in the area?

A report was received from the Roads Transportation and Public Safety Department informing the members that there are no plans to install any additional lighting along this route.

The report was noted.

The Mayor sought the members approval to adjourn the meeting for a 10 minute break. The members agreed.

#### **Pandemic Memorial**

The members considered the following joint motion in the names of Councillors N Heavey, C Pender, P O'Dwyer, R Power, F Mc Loughlin Healy, A Connolly, M Stafford, N Connolly, K Duffy, T O'Dwyer and S Doyle.

That in recognition of lives lost and suffering caused through the pandemic experience, that a memorial bench or other agreed installation, be located in an appropriate location within the municipal district.

The motion was proposed by Councillor Doyle and seconded by Councillor A Connolly.



A report was received from the Corporate Services Department informing the members that this is a matter for the members to agree.

The following points were raised by the members:

- Something as simple as a tree could be included in all towns across the county. A modest plaque could be considered but a tree would be more ideal.
- The Parks Section may have the capacity to carry out this.
- A conversation had already been had with the Chief Executive and this idea was fine to pass with proposal.
- The trees should be placed in a public space where people will be able to view them.
- The pandemic is still ongoing and this should be held off on until after.
- The Tidy Towns in the area could be included in this project.

The Meetings Administrator advised that upon the members agreement that the request plantation of trees would be noted for after the pandemic, an invitation to the Tidy Towns in the municipal district would be issued and the noted request would be passed on to the Parks Department and funded by them.

**Resolved** on the proposal of Councillor Doyle, seconded by Councillor A Connolly and agreed by the members that the report be noted.



# Land between Beechgrove and St Patricks Park in Rathangan in Council's Ownership

The members considered the following question in the name of Councillor Noel Connolly. Can the council outline its plans for the 8.22 acres in its ownership between Beechgrove and St Patricks Park in Rathangan (Folio KE39235F)?

A report was received from the Housing Department informing the members that council lands in Folio Ref KE39235F are partly zoned New Residential (C2 - 1.2ha) and partly zoned Agricultural. Assess to the public road is limited and the lands may need to be accessed through the adjacent St Patrick's Park estate. With the recent completion of 18 units at Beechgrove and proposed works to St Patrick's Park under the Remedial Works Scheme, there are no current plans to develop the Residential zoned lands in Folio KE39235F.

Councillor N Connolly noted that this is a large site in Rathangan and asked was there any medium-term plans to provide housing being considered?

Ms Scully said that there was no medium design as advised by the Chief Architect and that not all of the site is zoned residential. She confirmed that there another housing development planned in Rathangan.

# Land at the Pastures in Monasterevin in the Council's Ownership

The members considered the following question in the name of Councillor Noel Connolly. Can the council outline its plans for the 4.571 acres in its ownership beside The Pastures in Monasterevin (Folio KE4011N)?

A report was received from the Housing Department informing the members that Kildare County Council lands in Folio Ref KE4011N in Monasterevin are zoned amenity and are on a flood plain. Residential development is not open for consideration.





Councillor N Connolly asked could the council provide a new home for the Monasterevin Football Club?

Ms Scully advised that she will discuss with the architects department and revert to the councillor.

The report was noted.

# **Retrofitting Programme**

The members considered the following question in the name of Councillor Anne Connolly. Can the council confirm if it has received confirmation from Minister Noonan's office that windows and doors will be included in the Retrofitting Programme under the Just Transition Programme, in this municipal district, following his recent commitment made?

A report was received from the Housing Department informing the members that the council are not aware of any confirmation from Minister Noonan's office regarding the inclusion of windows and doors in the either the Midlands Energy Efficiency Retrofitting Programme (MEERP) or the Energy Efficiency Retrofitting Programme 2021 (EERP). There is a currently a funding cap of €27,000 per unit for retrofitting as outlined under Circular 8/2021 which is insufficient to include the funding of replacement windows and doors. The report was noted.

#### Adaptation Grant Scheme

The members considered the following question in the name of Councillor Duffy. Can the council provide an update on this year's Adaptation Grant Scheme for the municipal district detailing the number of grants submitted, awarded, refused and outstanding and the average timeframe from submitting an application to award of the application?

A report was received from Housing Department informing the members that the Housing Department administers three grant options to assist people with a disability and older people in carrying out works which are necessary for the purposes of rendering a house more suitable for their accommodation needs. All schemes are subject to a household income means test.

The grants available are:

- 1. Housing Adaptation Grant for People with a Disability
- 2. Mobility Aids Grant
- 3. Housing Aid for Older People Grant

The Housing Adaptation Grant for a Person with a Disability is available to assist in the carrying out of works which are reasonably necessary for the purposes of rendering a house more suitable for the accommodation of a person with a disability who has an enduring physical, sensory, mental health or intellectual impairment. The maximum available grant is  $\in$  30,000.

The Mobility Aids Grant Scheme is for older people and/ or people with a disability to address mobility problems in their home. The maximum grant under the scheme is €6,000.

The Housing Aid for Older People Scheme is available to assist people aged 66 years or older living in poor housing conditions to have essential repairs carried out so that they can continue to live in their home. The maximum grant under the scheme is  $\in$ 8,000.



Updates on applications are provided to the Members on a quarterly basis (CE Report). The table below provides details of applications received and processed by the Council over the past two years\*. Data is provided on a countywide basis and is not available for each Municipal District area.

A standardised application process was introduced nationally in January 2020 and applicants must submit the application with supporting documentation to be considered for the various schemes. The Members were provided with information and details of the new application form. Supporting documentation to accompany an application includes evidence of household income, doctor's certificate, LPT payment (if applicable) and specialist trade contractor reports (for the Housing Aid Grant). All applications are initially assessed by the Housing Department. The typical timeframe for processing applications is subject to a valid application being received by the Council. Where an incomplete application has been received, the application is returned to the applicant specifying the outstanding documentation required. For Housing Adaptation Grants, an occupational therapist report is sought and can be submitted by the applicant or arranged by the Council. These applications are prioritised based on current medical need\*\*.

In the case of private adaptation grants, approval letters are generally issued within 6-8 weeks of receipt of a valid application. For council owned properties, works for approved



applications in the Priority 1 category are progressed by the Architects Department, subject to available funding (Priority 2 approvals are placed on a waiting list).

All works proposed under a Housing Aid Grant are assessed by the Architects Department are processed in date order of receipt of the application.

In 2020, approximately 100 applications made under the Housing Adaptation Grant and Housing Aid Schemes were refused. The reasons for such refusals include - applicant over the income threshold, no works were recommended, requested documentation not submitted, applicant did not meet age criteria (Housing Aid), application withdrawn, etc. While these grants benefitted from an exemption under Covid restrictions, some applications were delayed due to the age/medical profile of applicants and Government restrictions on visits/inspections of houses.

In addition, it has also not been possible for some successful applicants to have internal works carried out by contractors at their homes due to restrictions. All works are carried out with the consent of applicants and in some cases vacating the property for a short period of time is necessary (i.e., bathroom works) and in the current Covid crisis, this is not an option for all.

While there is an unavoidable backlog in applications, work is underway to prioritise certain works and new protocols are in place to ensure full compliance with restrictions (i.e., questionnaires are issued to applicants, written agreements are put in place prior to any inspections, works etc). We are relying on information from applicants in order to assist in progressing works in a safe and compliant manner.

A total of 468 applications (205 Housing Adaptation and 263 Housing Aid) are being considered at present.

For the current year, a grant allocation of €3,162,288 was approved by the Department of Housing, Local Government and Heritage for private homes, and €517,504 for relevant works to the council's social housing stock.



Updates on the progress of applications are provided to the Members on a quarterly basis (Chief Executive's Report).

\*\* Definition of Priority Categories 1-3:

# Priority 1

Terminally ill or fully/mainly dependant on family or carer; or where alterations/adaptations would facilitate discharge from hospital or alleviate the need for hospitalisation in the future;

# Priority 2

Mobile but needs assistance in accessing washing, toilet facilities, bedroom etc; or where without the alterations/adaptations the disabled person's ability to function independently would be hindered;

#### Priority 3

Independent but requires special facilities to improve the quality of life, e.g. separate bedroom/living space.

Councillor Duffy said that the report was hard to follow. He said that he could understand the lead time, the received and approved applications in the text but the table only described the applications which were priority 1; the text didn't match the table. He asked could a table be provided of all applications, to include the approved/refused and the time period. A totals table was requested.

The report was noted.

#### **Criteria for Homeless HAP**

The members considered the following question in the name of Councillor Chris Pender. Can the council confirm the criteria for receipt of Homeless HAP in this municipal district?

A report was received from the Housing Department informing the members that to be eligible for Homeless HAP you must:

1. Be on Kildare County Council's housing list



- 2. Be residing in homeless accommodation or
- 3. Be registered as homeless in Kildare and engaging with the homeless team or
- 4. Have a valid Notice to Quit and in danger of becoming homeless

The Homeless HAP scheme provides additional financial and related supports to tenants and landlords. The local authority must have determined that the household is homeless and has no alternative accommodation options prior to approval of a HHAP payment. 67 Homeless HAP applications have been processed to date in 2021. The report was noted.

# Toilet Facilities and Water Points along Blueway

The members considered the following question in the name of Councillor Anne Connolly. Can the council confirm if it has plans to put in place toilet facilities and water points along the Blueway in this municipal district?

#### **Green Waste Collection Service**

The members considered the following question in the name of Councillor Peggy O'Dwyer Can the council confirm if there is a green waste collection service offered to Residents Associations within the municipal district?

A report was received from the Environment Department advising the members that while the council runs a scheme offering assistance in the removal of litter and waste from community clean-ups, it is not possible to collect green waste (leaves, grass clippings, sods, soil and hedge cuttings etc) due to the volume involved.

Green waste arising from grass-cutting of the common areas in housing estates is a common issue. In its efforts to promote waste minimisation, the council encourages community groups to compost green waste as a sustainable way of managing this material. Residents associations are encouraged to develop a community composting area in the estate for green waste with the added community benefits of having a source of compost from the process.

The Council's Environment Awareness Officer was available to support groups to set up local composting areas and to provide advice on managing green waste generally.

For the members' information, Kildare's two civic amenity sites also accept green waste for composting.

# **Dumping behind Donnelly's Hollow**

The members considered the following question in the name of Councillor McLoughlin Healy. Can the council provide a broad outline of the issue that it is at odds with the Department of



Defence over, in relation to the commercial scale dumping behind Donnelly's Hollow providing the details of who ordered the mediation and any schedule or deadline for its completion?

A report was received from the Water Services and Environment Department advising the members that as previously outlined, the matter at hand relates to the unauthorised disposal of waste at this location. The nature of the waste has been assessed and it is considered unlikely to constitute a risk to the local environment. However, it is unauthorised and therefore is subject to both planning and environmental enforcement. In this context, again as previously stated, it would not be good practice for two State entities to incur significant legal costs and therefore, both parties have agreed to try to resolve matters through mediation. Neither have been directed to do so. It might also be stated that there are significant delays ongoing at the moment in relation to the Courts. Both parties are currently discussing possible specific dates within the next few weeks and I can brief members further on this at the municipal district meeting. In the interim, the EPA are being kept informed.

Councillor McLoughlin Healy asked was one of the parties the Department of Defence? She also asked would an enforcement letter not a necessary follow on from unauthorised dumping?

The District Manager confirmed that it was the Department of Defence. He also hoped that mediation will have been concluded by the next meeting. The report was noted.

# Land zoned amenity beside Linear Park, Newbridge

The members considered the following motion in the name of Councillor McLoughlin Healy. That the council consider acquiring the land zoned amenity on the far side of the Linear Park, Newbridge that would provide an optimal location for a number of leisure amenities.

The motion was proposed by Councillor McLoughlin Healy and seconded by Councillor Pender.

A report was received from the Parks Department informing the members that there are two areas of land zoned for recreation and amenity opposite the Linear Park. The area of these is approximately 30ha (74acres). A valuation of the land would have to be sought and if an acquisition was possible how this would be financed.

The following points were raised by the members:

- Importance of outdoor spaces, especially during COVID-19, and there is a lack of youth facilities in the area.
- The land could be used for a BMX park.
- Have any monies been set aside for leisure facilities?
- This could be a flagship project.
- The prioritisation of space is important.



- How much would 74 acres cost? Would the cost be affected due to the proximity to the town?
- Would be good to have this included in the upcoming County Development Plan.
- Engagement with owners essential, they may anticipate zoning to be residential.
- If the land is a flood plain, then it should remain for amenity.

The Senior Parks Superintendent advised that a valuation would be looked for. Currently only levies would be funding this project. Acquisition of the land would be a long and costly process. Communication with the respective landowners would have to take place. **Resolved** on the proposal of Councillor McLoughlin Healy and seconded by Councillor Pender and agreed by the members that the report be noted.

- He described Kildare County Council's current Energy Efficiency projects including: the Energy Bureau, the Energy Management Team, Analysis of top energy users, Climate and Energy Week and the Sustainable Energy Communities.
- He informed the elected members of their role in the communicating and promoting of these projects.
- The members could work directly in the projects, in the development of the partnerships and garnering support through their networks.
