

## Minutes of the Kildare-Newbridge Municipal District held at 10:00 a.m. on Wednesday, 16 April 2025 in the Council Chamber

## KN01/0425 Declarations of Interest

Declarations of (a) conflicts of interest or (b) pecuniary or beneficial interests under section 177 of the Local Government Act 2001, as amended.

There were no declarations of interest.

### KN02/0425 Minutes and Progress Report

The members considered the minutes of the Kildare-Newbridge Municipal District meeting held on 19 March 2025 and the progress report was noted.

The mayor informed the members that on item 5 a comment was made that the road would be closed at Ladytown but under legislation the decision to close a road is a reserved function of the



elected members of the Municipal District, not an executive function. This means that the elected members, not the Council's Chief Executive or staff, are responsible for making this decision.

**Resolved:** on the proposal of Councillor Duffy, seconded by Councillor T O'Dwyer and agreed by all members present that the minutes of the Kildare-Newbridge Municipal District meeting held on 19 March 2025 be taken as read and the progress report be noted.

### KN03/0425 Municipal District Road Works

The members received an update on the Municipal District Road Works

#### **Road Resurfacing Works:**

#### NTA:

Works are ongoing at St. Brigid's School and surrounding area in Kildare Town.

#### LPT:

Works are now complete on the R445 Newbridge.

Footpath works commenced in Kilcullen, Conroy Park and St Brigid's Avenue to be completed in the coming weeks.

#### **Restoration Improvement / Maintenance:**

Road improvement works have commenced at: Church View, Suncroft.

#### Newbridge

Day to day litter picking, emptying bins, cleaning of lanes and general maintenance of Newbridge Town and small villages around Newbridge.

**McGuiness Jetting:** Two cattle grids either side of the Curragh racecourse.

**Drainage:** Lakeside inlets/outlets and all gullies around the lake, The Oaks, Acorn Downs, Old Connell, Mount Carmel, Wesley Manor. In Dara Park a new french drain and new concrete footpath installed to solve ongoing drainage issue, Lurg Lane.

**Patching:** Maddenstown to Kildare Town, Brownstown to Carna, Bougherguy, from Lidl roundabout to back road that leads back onto dual carriageway.

**Planning Works:** Chapel Lane, Athgarvan, College Park.



**Road Sweeping:** Back of Curragh racecourse, Sexton Bridge Road and footpath from Brennans Garage to Ballymany Roundabout.

**Topsoil:** Standhouse Road/Blackberry Lane, Lakeside, Dara Park.

#### Kildare

**Repairs:** Horse Bridge crossover on the R445 Kildare to Newbridge.

Water cuts: R445 Kildare to Monasterevin.

Pothole repair: Quinnsboro, Rathbride Close, Curragh Chase, Knavinstown.

**Drainage:** Flooding issue at Cleary's residence Ballalley was repaired.

**Bollards:** Junction bollards installed at Duneany Cross.

Signs: Stop sign and T junction sign installed at Redhills to Southgreen Road junction. Cul de sac

sign installed at Fire Castle Lane.

**Junction upgrade:** Signage installed at Mountrice junction.

#### Rathangan

Day to day street and path sweeping, cleaning and emptying of bins.

Signage: Installation of 4 signs at Spring Field Cross. Sign repair at Blacktrench.

Water cuts: Water cuts on the L7002, L7007, L3003 and Boston Hill.

**Patching:** L3003, Main Street Rathangan. **Road Reinstatement:** L3003 and L7007.

Oil Spill: Main Street Rathangan plus Ring Road.

Pothole Repair: L70062, Blacktrench, L3003, Thomastown and Ellistown.

**Drainage:** Gully cleaning R401 Glebe.

#### Kilcullen

**Pothole repairs:** Newlands Naas Mylerstown to Swordlestown. Brannockstown to Stephenstown R412. Knockbounce to Milemill. Kilcullen.

**Drainage:** Knockbounce, Milemill, Brannockstown, Mainstreet Kilcullen. Bishop Rogan Park entrance.



**Road Signage:** Erecting junction signs Thomastown. Replacing Speed limit signs. washed signage Victoria Bridge. Washed signage Mylerstown cross R448.

Replace litter bins: Kilcullen.

**Watercuts:** Melon Hill, Yellowbog Common, Castlefish, Knockbounce to Giltown Cross. Silliot Hill to Carnalway, Long Staight Dunstown, Mullaghboy.

The District Engineer informed the members that the map she had distributed to the members was showing the areas for road maintenance and improvements for 2025. Some works have gone to tender and would depend on budgets available but would keep the members up to date. The report was noted.

## KN04/0425 Residual LPT Allocations

There was no LPT nominated for allocation this month.

## KN05/0425 Section 38 of the Road Traffic Act 1994

To note commencement of Section 38 of the Road Traffic Act 1994 – proposed installation of a new Bus Shelter at the following locations:

- Bus Stop 11670, Arthgarvan, Co. Kildare (South-bound).
- Bus Stop 11689, Arthgarvan, Co. Kildare (North-bound).
- Bus Stop 132301, Maddenstown, Co Kildare (West-bound).
- Bus Stop 104041, Maddenstown, Co Kildare (East-bound).

Councillor T O'Dwyer informed the members that she wanted it noted that as part of the Active Travel Scheme where the two Arthgarvan bus stop routes were being installed the road was being widened.

The report was noted.



### KN06/0425 L2028 Old Connell Newbridge

The members considered the following motion in the name of Councillor P O'Dwyer

That the council considers installing a series of ramps to replace the Speed Flashing Signs which
are frequently out of order, at L2028 Old Connell Newbridge.

The motion was proposed by Councillor P O'Dwyer and seconded by Councillor Pender

A report was received from the Transportation Department informing the members that the Municipal District office have no funding in place to consider this proposal.

Councillor P O'Dwyer informed the members that the area is around Byrnes Cross, near Pfizer, and the speed flashing signs are not working in this area, and it was being used as a detour road for short cuts. She asked was this road not listed as a "quiet road".

The members raised the following points:

- The issue on this road was going to get worse and traffic calming measures needed to be increased.
- Were there were other alternatives to ramps.
- Was there a policy relating to traffic calming or slowing traffic.
- Vehicles going too fast in this area.

The District Manager informed the members that there was a policy for traffic calming measures and speed checks are done in areas. All of this cost money and unfortunately if there was no money the works could not be carried out.

**Resolved** on the proposal of Councillor P O'Dwyer and seconded by Councillor Pender that the report be noted.



# KN7/0425 Traffic Calming Measures

The members considered the following motion in the name of Councillor T O'Dwyer

That the council carries out an assessment with a view to installing traffic calming measures on
the approach road from Carnalway to the Logstown Road, Kilcullen at the start of the residential
row of houses.

The motion was proposed by Councillor T O'Dwyer and seconded by Councillor Duffy

A report was received from the Transportation Department informing the members that the Municipal District office agrees to include the location for assessment, however, as previously advised there is a long list of traffic calming requests and no available budget for assessments or works.

Councillor T O'Dwyer informed the members that speed in this vicinity was an issue especially on rural roads where drivers are not aware when they come around a corner that they are entering a town. She asked if further down the line that a scheme could be looked at to help make drivers aware when approaching a town to slow down. Councillor McDonnell informed the members that he felt the slow down digital signs worked better than ramps. He said when he saw the digital speed signs it would make him more aware of his speed and felt it would be good in villages. The District Engineer informed the members that the digital speed signs worked well for a period of time but then regular drivers on these roads would get used to them. She said that they cost around 6-8 thousand euro and have to be replaced every 2-3 years.

**Resolved** on the proposal of Councillor T O'Dwyer and seconded by Councillor Duffy that the report be noted.

# KN08/0425 Pinkeen Bridge exit into Cnoc na Greine, Kilcullen

The members considered the following motion in the name of Councillor T O'Dwyer

That the council assesses what safety measures, to include signage, can be installed at the

pedestrian crossing at the Pinkeen Bridge exit into Cnoc na Greine, Kilcullen, to alert drivers to

pedestrians crossing.



The motion was proposed by Councillor T O'Dwyer and seconded by Councillor Duffy

A report was received from the Transportation Department informing the members that the Municipal District office agrees to include this location for assessment, however, as previously advised there is a long list of traffic calming requests and no available budget for assessments or works.

Councillor T O'Dwyer informed the members that the cross over to the school was sorted which has now created this other issue. She said drivers entering the estate are not stopping or may be unaware of the pedestrian crossing as there was no signage. Councillor T O'Dwyer said that drivers need to be reminded that there was a pedestrian crossing and was also aware that driver behaviour was an issue.

**Resolved** on the proposal of Councillor T O'Dwyer and seconded by Councillor Duffy that the report be noted.

# KN09/0425 Active Travel Report

The members considered the following motion in the name of Councillor Pender

That the council provides a written monthly Active Travel Report in tabular format for this meeting
and all future monthly meetings, to include (a) The projects identified within the municipal district,
(b) The funding source or likely funding source for each project, (c) The current stage of
progress for each project and any other relevant information.

The motion was proposed by Councillor Pender and seconded by Councillor Balfe
A report was received from the Transportation Department informing the members that this
information is already provided as part of the monthly Chief Executive's report to Full Council. The
Sustainable Transport Section will review the suggested format to determine if there is a more
optimum way to present the data.



Councillor Pender raised the following points:

- Understood that it was in the CE Report but felt it would be easier to provide the report at municipal district level like the vacant house report.
- If the members were getting this report every month at municipal district level it would help stop the members submitting motions and questions unnecessarily.
- The members receive the progress report every month which wouldn't really change on a monthly basis
- Councillors need to be made aware when changes happen.
- Councillors time is very limited, and it would help to have this report every month in a smaller document and it would be easier to be kept updated this way.

Mr McLoughlin informed the members that this information was given every month in the CE Report. He felt there was no added value to giving the report at municipal district level and didn't see what purpose it would serve. He said the Capital Projects did not really change much unlike the vacant housing report. He informed the members that he would commit to keeping the members updated at municipal district level when there was an update or change with the Active Travel Report. The District Manager informed the members that the CE Report was a valued document and did not feel the need to be duplicating work when there were staff shortages, and this would be putting extra work on staff.

Councillor Pender informed the members that he was happy enough to go with the commitment from Mr M McLoughlin on receiving any updates/changes from the Active Travel Report at municipal district level.

**Resolved** on the proposal of Councillor Pender and seconded by Councillor Balfe that the report be noted.

#### KN10/0425 L7010 and L7012

The members considered the following motion in the name of Councillor O'Loughlin

That the council resurfaces the road L7010 from Mountrice Cross to the junction where it joins the

L7012.



The motion was proposed by Councillor O'Loughlin and seconded by Councillor T O'Dwyer

A report was received from the Transportation Department informing the members that the Roads Programme has been prepared for 2025. There is a limited budget available and the L7012 is not listed for 2025, however, it can be included for consideration for 2026.

Councillor O'Loughlin informed the members that this stretch of road was particularly bad and there was also a school along this road. He said it was disappointing that this road would not be resurfaced but asked if the municipal district office would commit to patch repairs. Councillor Duffy informed the members that this was a very busy road and especially with a school on it and needed to be on the list for next year. The District Engineer informed the members that there was a process for deciding on what roads were dealt with first using the hierarchy method and regional roads were always first. She said with the budget the municipal district office had they could only resurface 20/30km of road yearly.

**Resolved** on the proposal of Councillor O'Loughlin and seconded by Councillor T O'Dwyer that the report be noted.

### KN11/0425 Bridge Street, Rathangan

The members considered the following motion in the name of Councillor O'Loughlin That the council installs a bus shelter at the bus stop on Bridge Street, Rathangan.

The motion was proposed by Councillor O'Loughlin and seconded by Councillor Pender

A report was received from the Transportation Department informing the members that the Sustainable Transport Team are currently assessing the feasibility of relocating the bus stop in Rathangan to facilitate existing bus services along with future planned routes. It would be premature to install a bus shelter at an existing stop in Rathangan at this stage.

**Resolved** on the proposal of Councillor O'Loughlin and seconded by Councillor Pender that the report be noted.



### KN12/0425 L703610

The members considered the following motion in the name of Councillor McDonnell That the council resurfaces the L703610, Piercetown, Newbridge which is in poor condition.

The motion was proposed by Councillor McDonnell and seconded by Councillor O'Loughlin

A report was received from the Transportation Department informing the members that there are no plans for surfacing this road in the 2025 budget.

Councillor McDonnell informed the members that it was frustrating for him and his constituents that he was not able to do his job properly for the community due to budget constraints. He said it had been 40 years since this lane had been resurfaced. The district engineer informed the members that there was a very limited budget, and she had to manage this budget and prioritise the work. The District Manager informed the members that the budget for this year for Kildare County Council was €260 million which had to be distributed between 1100 different services. She advised the members present there was a limited budget, and all had to work within the budget. **Resolved** on the proposal of Councillor McDonnell and seconded by Councillor O'Loughlin that the report be noted.

### KN13/0425 Nags Head, Monasterevin

The members considered the following motion in the name of Councillor Balfe

That the council implements appropriate traffic calming and safety measures at the junction at the

Nags Head, Monasterevin, to enhance road safety and reduce accident risks.

The motion was proposed by Councillor Balfe and seconded by Councillor Pender

A report was received from the Transportation Department informing the members that the Roads Projects Teams are currently progressing a Junction Improvement Project including ten junctions. There are no resources at present to consider further junctions, however this location can be considered but priority will be given to Locations of Interest identified as part of the Collison Analysis carried out the Department of Transport Support Office.



Councillor Balfe informed the members that it was reassuring that this junction was going to be considered. He said that this was a busy junction, and he used it regularly himself. This junction was an access road to egress to the church, community centre and school. Councillor Balfe informed the members that there were limited measures for coming out of this junction and the location of it doesn't lend itself well. Councillor Duffy informed the members that as far as he was aware this junction was part of the Active Travel Safe Routes to School scheme but wondered why it was not mentioned in the report. He said he was told that the Part 8 was imminent and asked could this be clarified. Mr M McLoughlin informed the members that he would come back to them with this information.

**Resolved** on the proposal of Councillor Balfe and seconded by Councillor Pender that the report be noted.

### KN14/0425 R417

The members considered the following motion in the name of Councillor Duffy

That the council assesses the public lighting coverage and lighting levels along the R417 Athy

Road in the vicinity of the Monasterevin Cemetery.

The motion was proposed by Councillor Duffy and seconded by Councillor T O'Dwyer

A report was received from the Transportation Department informing the members that there are no current plans to install public lighting at this location. Any requests for public lighting should include a description of the issue and a location map showing the area of concern. Following this, the request will be assessed and may be included in the KLIPS register, and prioritised subject to resources.

Councillor Duffy informed the members that he would progress this offline.

**Resolved** on the proposal of Councillor Duffy and seconded by Councillor T O'Dwyer that the report be noted.



### KN15/0425 Mount Carmel, Newbridge

The members considered the following question in the name of Councillor P O'Dwyer

Can the council confirm if agreed plans to carry out an assessment on the suitability of the general
area of Mount Carmel, Newbridge for a safe pedestrian crossing (motion from 21 February 2024)
has been carried out?

A report was received from the Transportation Department informing the members that there is no budget available for requested assessment or associated works.

Councillor P O'Dwyer asked for clarification on who does the assessments as her previous motion was answered by Mr D Hodgins. The District Engineer informed the members that it would depend on the work but as this was not an NTA project it would be the Municipal District Office.

The report was noted.

### KN16/0425 M9/M7 to Service Newbridge

The members considered the following question in the name of Councillor T O'Dwyer Can the council confirm if they have raised with TII the need for a slip road off the M9/M7 to service Newbridge and if not, what is the mechanism to commence this process?

A report was received from the Transportation Department informing the members that the Kildare County Development Plan 2023-2029 has identified the upgrade of this junction as an objective (TM084) and the Newbridge Area Based Transport Assessment has also identified this as supporting infrastructure that should be delivered to support the long-term development of Newbridge. This project is not currently included in the Capital Programme 2025-2027.

Councillor T O'Dwyer asked for clarification if the Council had engaged with TII. Mr M McLoughlin informed the members that they had not been in contact with TII as this was not in the pipeline at



the moment. He said if the members wanted to put forward a motion to write to TII he would be happy to facilitate this.

The report was noted.

### KN17/0425 Thompson's Cross, Kilcullen

The members considered the following question in the name of Councillor T O'Dwyer

Can the council outline what the next steps are for Thompson's Cross, Kilcullen as it would

appear, without seeing the findings, that none of the recommendations by consultants seem to be

appropriate?

A report was received from the Transportation Department informing the members that there are no resources at present to progress works to this junction. It is hoped to revisit this location later this year with a view to progressing an appropriate solution for this location.

Councillor T O'Dwyer asked for clarification on how much it would cost to carry out this work. Mr M McLoughlin informed the meeting that he would check the cost and revert.

The report was noted.

## KN18/0425 Public Lighting

The members considered the following question in the name of Councillor Duffy

Can the council provide an update on the rectification of public lighting along Cowpasture Road,

Togher Road and Brook Lawns, Monasterevin which have not been operating since Storm

Eowyn?

A report was received from the Transportation Department informing the members that the average length of time from report to repair/replacement is 4 weeks. However, where ESB attendance is required, the length of time from report to repair/replacement may be longer. The public lighting maintenance contractor and the public lighting department will continue to liaise with ESB.

The report was noted.



## KN19/0425 Playgrounds Newbridge

The members considered the following motion in the name of Councillor Pender and P O'Dwyer That the council commits to ring-fencing and allocating any residual/remaining income from the development of the Moorefield Park, Newbridge Playground/Area towards the delivery of the playground and masterplan for Lakeside Park, Newbridge ensuring continued investment in community recreational facilities within the area.

The motion was proposed by Councillor Pender and seconded by Councillor P O'Dwyer

A report was received from the Parks Department informing the members that any residual funding following the completion of Moorefield Park will be allocated to Lakeside Park and also to an upgrade of the existing playground in Newbridge Sports Centre which involves replacing of the junior multi-unit and the iplay unit and safety surface.

Councillor Pender informed the members the reason he and Councillor P O'Dwyer put this motion forward was to ensure the funding remained within Newbridge for it to be invested in the area. Councillor P O'Dwyer informed the members that €30k had been allocated to start the masterplan for the Lakeside Park area.

**Resolved** on the proposal of Councillor Pender and seconded by Councillor P O'Dwyer that the report be noted.

## KN20/0425 Liffey Linear Park and adjacent lands

The members considered the following question in the name of Councillor Pender

Can the council provide an update on the ownership status of Liffey Linear Park and any adjacent
lands, and whether the council has engaged, or plans to engage, in adverse possession to secure
these lands for community use given their current use and importance to the local area?

A report was received from the Parks Department informing the members that considerable research has been carried out regarding the ownership of land in Liffey Linear Park and the



information obtained has been forwarded to our legal representatives to ascertain ownership rights in Liffey Liner Park.

The report was noted.

## KN21/0425 Part 8 St Evins Access Road, Monasterevin, Co Kildare

Ms A Dutczak gave a presentation to the members on the Chief Executives Part 8 Report P82024.17 for the proposed St Evins Access Road, Monasterevin, Co Kildare

Ms A Dutczak informed the members that the following Part 8 was an amendment to the previously approved Part 8 ref. P82023.06, which would consist of new access road with new proposed access point from the south of site at St Evins Park. Part 8.

**Resolved** on the proposal of Councillor Duffy, seconded by Councillor Balfe and approved by all members present that the Chief Executives Part 8 Report P82024.17 for the proposed St Evins Access Road, Monasterevin, Co Kildare be approved with the amendments as outlined in the presentation.

#### KN22/0425 Newhall site

The members considered the following question in the name of Councillor Pender

Can the council clarify why the Newhall site (Floods Cross Designated Accommodation Centre)

cannot be used for frontline staff or emergency accommodation in the short term and if there is

any scope for a more flexible or creative approach to utilise this site for urgent housing needs?

A report was received from the Integration Department informing the members that the development of the Designated Accommodation Centre for the provision of temporary accommodation for Beneficiaries of Temporary Protection at Newhall, Naas was exempt development on foot of the introduction of SI 306 of 2022 following the approval of the EU Temporary Protection Directive in March 2022. The benefit of the exemption came to an end when the contract with the Minister for the Department of Children, Equality, Disability, Integration and Youth (State Authority) expired in March 2025.



The land developed at Newhall is unzoned, agricultural land and cannot be developed for the uses suggested. No proposals have been submitted to Kildare County Council to develop this land for the uses suggested.

The report was noted.

### KN23/0425 Social Housing

The members considered the following question in the name of Councillor McDonnell Can the council provide a breakdown on the number of houses allocated in this municipal district in the last 5 years to include social housing and which approved housing bodies/associations were involved?

A report was received from the Housing Department informing the members that the following table gives a breakdown of Kildare County Council social allocations recorded over the past 5 years in the Kildare Newbridge Municipal District:

This information is not available by municipal district for properties provided by Approved Housing Bodies (AHB). The total number of housing units delivered by AHB's in Kildare Newbridge Municipal District for the past 5 years from 2020 to 2024 is 2,117, provided by Cill Dara, iCare, Co-Operative Housing, Cluid, Oaklee, Tuath, Clanmill, Circle, North and East and Cill Urni Housing Association.

Councillor McDonnell asked for clarification on where the figure of 2,117 came from. Ms S Farrer informed the members that these figures were provided from the Approved Housing Bodies (AHB), and the properties were allocated to those on the Kildare County Council housing list. The report was noted.



### KN24/0425 Heat Pumps

The members considered the following question in the name of Councillor McDonnell
Can the council confirm why it is installing heat pumps in badly insulated Kildare County Council
houses?

A report was received from the Housing Department informing the members that since no specific property is mentioned, it is assumed that the question relates to the upgrade of the existing KCC housing stock under the Energy Efficiency/Retrofitting Programme (EERP).

This programme provides funding to ensure that the fabric of the home is upgraded, and an efficient decarbonized heating system is provided, namely a heat pump. The works carried out to achieve this energy rating may or may not include attic insulation, wall insulation/dry lining, windows and door upgrade, renewable heating systems, replacement radiators and pipework. The extent of these works will be decided upon based on those needed to achieve a B2 BER rating and ensuring costs are balanced to maximise the no. of units retrofitted.

The report was noted.

## KN25/0425 Arts Awards and Bursaries for 2025

The mayor informed the members that the list for the Arts Awards and Bursaries for 2025 for the Kildare-Newbridge Municipal District was previously circulated and they were not for publication until after 30 April 2025, to allow the Arts Service team to present to all municipal districts.

Councillor P O'Dwyer informed the members that she was wondering why two of the approved grants were not happening in Kildare and asked how this worked. Ms E Donnelly informed the members that the grants approved were assessed by 17 assessors and had different criteria they had to meet in order to qualify. The two in question were professional artists which under their criteria had to show that the projects benefited the artist and the county.

The members considered the following motion in the name of Councillor McDonnell

That the council addresses the uneven distribution of LPT monies allocated to towns within the

Kildare-Newbridge Municipal District.

The motion was proposed by Councillor McDonnell and seconded by Councillor Heavey

A report was received from the Finance Department informing the members that the allocation of retained LPT in the Kildare-Newbridge Municipal District is matter for the Members of the District.

Councillor McDonnell informed the members that there are 11 councillors in the Kildare-Newbridge Municipal District and there should be fair distribution for each councillor to help get work done for their community. He said that there was over €300k from LPT given towards the library, but he said this should be coming from government funds and not taking so much away from LPT for the next few years. Councillor McDonnell asked how can jobs get done in the area if there was not fair distribution.

The members raised the following points:

- The distribution between towns and villages may not be fair but as a municipal district the members work and vote together to make decisions on the distribution and approval of the LPT.
- Fully understand councillors not getting projects across the line that they would like but this
  was part of the difficult decisions that had to be made.
- Yes, the library should be funded from government but as there was a shortfall the
  members voted to put the money towards the library so they would not lose this funding as
  this was an important infrastructure within the town.
- The members have to work within the budget they are given and difficult decisions had to be made together.
- It was difficult when small villages were losing out, but the members try to be decent and fair when it comes to allocating LPT.



The District Manger informed the members that LPT monies were for the municipal district and there were no individual allocations for the members and all allocations were agreed as a municipal district.

A report was received from the Planning Department informing the members that Local Area Plans and County Development Plans (CDP) including Settlement Plans are, in all aspects, statutorily required to comply with the requirements of the National Planning Framework (NPF). It should be noted that the NPF does not make provision for specific standards for quantum's of land to be designated/zoned for amenity/open space/community. All CDP Settlement Plans and Local Area Plans prepared by Kildare County Council Planning Team are informed by Social Infrastructure Audits which identify deficits in the provision of civic, social and recreational amenities. The published land use plans address the land use requirements, in the context of appropriately zoned lands, to address deficits and make provision for additional requirements as a result of planned population growth. The progression and delivery of these areas/facilities is outside the remit of a land use plan and will be subject to necessary funding and, where appropriate, land acquisition.

#### KN30/0425

#### **Sports Facilities in Compliance with National Planning Framework**

The members considered the following motion in the name of Councillor Heavey



That the council outlines its plans to provide for obligations and opportunities to deliver sports facilities in compliance with National Planning Framework.

A report was received from the Planning and Community Department informing the members that Local Area Plans and County Development Plans including Settlement Plans are, in all aspects, statutorily required to comply with the requirements of the National Planning Framework (NPF). It should be noted that the NPF does not make provision for specific obligations for the delivery of sports facilities, however states that the continued provision and enhancement of facilities and amenities for children and young people, such as childcare, schools, playgrounds, parks and sportsgrounds, remains necessary and will need to be maintained at similar levels for the foreseeable future thereafter. All CDP Settlement Plans and Local Area Plans prepared by Kildare County Council Planning Team are informed by Social Infrastructure Audits which identify existing deficits and future requirements for the provision of sports and recreational amenities. The published land use plans address the land use requirements associated with the deficits and make provision for additional requirements as a result of planned population growth. The progression and delivery of these areas/facilities is outside the remit of a land use plan and will be subject to necessary funding and, where appropriate, land acquisition.

Kildare County Council is currently developing a Local Sports Plan for the county. This five-year plan will align with national and local public health and physical activity policies. The plan will detail the required sports, recreation and physical activity actions for the county, particularly in relation to key target groups. The plan will include recommendations for operational, structural, and other required service enhancements relating to sports and recreation for Kildare.

Councillor Heavey informed the members that he remembered when there was a lot of land available for community/open spaces but now it was difficult to find any. He said young people need the facilities for recreation. Councillor Pender informed the members that recreation or recreational space was one of the important things to consider. He said that some councillors had made submissions for the Local Area Plan. Councillor Pender said it was important that they get it right to future proof these lands in Newbridge. Councillor P O'Dwyer informed the members that the Settlement Plan was coming up soon and advised of the need to encourage private owners on



zoning of land. Mr M McLoughlin informed the members that it was important from the social aspect of the LAP and that it was a collaborative approach.

Until specific dates are advised regarding the commencement of Part 3 (Plan making) of the Planning and Development Act, 2024, no schedule is available. The Forward Planning team will



continue to provide timely updates to the Elected Members on the progression of the commencement of the new Act.
