8. **Motion – Councillor Seamie Moore**
- That the council, either directly or in conjunction with Waterways Ireland discussions, confirm the following:
- a) if an illegally constructed bridge/barrier wall on the Corbally Branch Canal can be removed or must be allowed to remain
 - b) if a modern system of water underpass, could be advanced, to overcome the blockage by the Naas-Newbridge Road, as a solution to any future consideration to the re-opening of the Corbally Canal Line and
 - c) if an expanded volume of water can be sourced and supplied to the Naas-Corbally Branch in the event of an agreed promotion of new marinas, boat flotillas or daily boat traffic into Naas Harbour or of an extended canal to Corbally.

- That the Naas Municipal District and Kildare County Council Roads Section consider a banning of HGVs using the town section of the Blessington Road (R 410) from its junction with the Ballycane Road to its junction with the Dublin Road (R445) and from entering the Racecourse Road through the Gallops and other internal residential developments within the Racecourse Complex, in favour of re-routing to/from the M7 via the Naas Inner Relief Road and Newbridge Road (R445).
