Mr Y Khan said the following:

- Uisce Éireann had damaged the loops for the traffic lights at Murtagh's Corner and they were being repaired.
- The nominated company advised that Sallins Clane road would be completed in August.
- It was a different contractor carrying out the works at Hillview Sallins.

Naas Municipal District LPT Schedule of Works 2023

The members considered the remaining LPT 2023 allocations for the Naas Municipal District Committee.

The Meetings Administrator informed the members that a request had been received for LPT funding to be allocated to the following project:

Councillor S Moore asked the members to confirm and agree that €30k had been allocated from the LPT to the Bealtaine Festival Committee in 2023. He stated that there was €5,046



unspent by the Bealtaine committee in 2022 which was requested to be carried forward into 2023 and should be included to make up the €30k grant in 2023. The members agreed that this was the case.

Resolved on the proposal of Councillor Clear, seconded by Councillor Kelly and agreed by all the members that the above request received for LPT funding be approved.

Summertime Bins

The members considered the following motion in the name of Councillor Kelly

That the council confirm when the extra "Summertime Bins" will be installed along the Canal
at Sallins

The motion was proposed by Councillor Kelly and seconded by Councillor Brett.

A report was received from the Transport, Mobility and Open Spaces Department informing the members that the Naas Municipal District office propose to review the number of bins in Sallins as part of the ongoing bin emptying programme in the district.

Councillor Kelly said that she was not happy with the report. She stated that the members were told 12 weeks ago that there was a review being carried out. She stated that the details needed were already given to the council and a review was not needed. Thirteen bins were not sufficient, and this needed to increase in the summertime with the provision of temporary bins.

Councillor B Quinn said that Sallins was getting busier, he asked was there a strategy or was it done on an ad hoc basis?

Mr Y Khan advised the members he would come back to them with a timeline of when the review would happen after the meeting.



Resolved on the proposal of Councillor Kelly, seconded by Councillor Brett and agreed by the members that the report be noted.

Road markings for the Sallins Bypass

The members considered the following motion in the name of Councillor Kelly

That the council confirm if interim measures such as road markings and signage are being considered for the Sallins Bypass?

The motion was proposed by Councillor Kelly and seconded by Councillor Moore.

A report was received from the Transport, Mobility and Open Spaces Department informing the members that the Naas Municipal District office and NRDO have met with the An Garda Síochána and discussed proposals to improve signage and road markings on the Sallins bypass to raise driver awareness of the road layout and increase driver attention while using the Sallins Bypass. Road markings are currently being installed and road signage is being procured and will be installed in the coming weeks.

Councillor Kelly said that it was important to mark these lanes as it was still unclear. She stated that 4 sets of arrows were not enough. She requested that the council put interactive signs there and queried the timeframe for the installation of signage.

Mr Y Khan advised that more signs would be put in place, and these had already been ordered, he advised he would come back to the members with a timeframe.

Resolved on the proposal of Councillor Kelly, seconded by Councillor Moore and agreed by the members that the report be noted.

A report was received from the Transport, Mobility and Open Spaces Department informing the members that the Naas Municipal District office will review signage and road markings at this location.

Councillor Breen informed the members that it was important that it was clearly marked that there was one way in and out of the car park.

Resolved on the proposal of Councillor Breen, seconded by Councillor Kelly and agreed by the members that the report be noted.

The members considered the following motion in the name of Councillor Brett

That the council outline a roadmap to the elected members on the delivery of the Naas

Pathfinder project.

The motion was proposed by Councillor Brett and seconded by Councillor Kelly

Item 13:

The members considered the following question in the name of Councillor Quinn
Can the council confirm what is required to unlock the €20,000,000 Pathfinder Project
funding for Naas?

A report was received from the Transport, Mobility and Open Spaces Department informing the members that the Sustainable Transport Section does not have a funding allocation for this project. However, we are working very closely with Department of Transport officials to develop a mechanism to secure funding to progress this important initiative. The appointment of a service provider is necessary to progress the scheme to a statutory public consultation process.

The members raised the following points:

- It was imperative that the council ensured that Naas got access to the €20m fund for the complex programme of works.
- Been at this since 2014, the funding needed to stay in Naas to help make it a vibrant town.
- Pathfinder project announced last October. Minister E Ryan had queried what was happening with Naas?
- Video by the Minister stating that Naas was at risk of losing a potential €20m.
- The council needed to do what it could to get it going.
- Did the funds need to be fully spent or partially drawn down by 2025?
- Outline on the Part 8, when would the council get to it?



Mr D Hodgins informed the members of the following:

- There were a number of hurdles to overcome before funding could be acquired.
- Seed funding was needed to procure a service provider for the drawings and application documentation.
- The pathfinder project was for new and existing projects. Naas would be a new project so would have no access to funding through the NTA.
- The project would involve a reconfiguration of Poplar Square and Murtagh's Corner with priority being given to Vulnerable Road Users.
- The plan for Naas was ambitious and cutting edge.
- The project needed to be delivered by 2025 but this would not be possible.
- It had been outlined to the minister what would be done by 2025.
- To spend €20 million on a scheme by 2025 was unrealistic.
- The 2025 deadline was for partial completion.
- Anticipated it would be the end of quarter 1 in 2024 for the Part 8
- The public consultation process would determine if ambitions would be embraced.

The District Manager clarified that positive meetings had been held and that the Minister had not been briefed on this prior to his comments.

Resolved on the proposal of Councillor Brett, seconded by Councillor Kelly and agreed by the members that the report be noted.

Analysis on the restricted bridges

The members considered the following motion in the name of Councillor Brett

That the council carry out an analysis on the restricted bridges in the Naas Municipal District
and or the whole county with a view to improving active travel measures.

The motion was proposed by Councillor Brett and seconded by Councillor Kelly



A report was received from the Transport, Mobility and Open Spaces Department informing the members that an analysis on the restricted bridges in the Naas Municipal District and or the whole county in the context of improving active travel measures would be a very significant undertaking, involving a large number of stakeholders. In Kildare, there are a number of organisations with responsibility for certain bridges, which can be summarised broadly as follows:

- Waterways Ireland own a large number of restrictive bridges in Kildare on the Royal Canal, Grand Canal, Naas Branch, and Barrow Line. The majority of these bridges would be considered restrictive.
- Irish Rail also own a large number of bridges in Kildare along the rail lines through Leixlip, Maynooth, Kilcock, and through Sallins, Newbridge, Kildare and Athy. The majority of these are also considered restrictive in nature with only a few capable of providing full active travel measures.
- Transport Infrastructure Ireland (TII) own any bridges across the national / motorway
 network. Whilst these may be more modern, in most cases, than canal / rail bridges they
 have not been built with full vulnerable road users (VRU) access in mind.
- Kildare County Council are responsible for any bridges on the regional and local road
 network and in that regard the council operates a bridge programme which ensures those
 bridges are maintained in a proper manner and, where damaged, are repaired as
 expediently as possible. In many cases, the bridges in the county have heritage and
 architectural protections which make any interventions very complex.
- River towns in County Kildare are a particular issue when it comes to bridges. Ballymore
 Eustace, Kilcullen, Athgarvan, Newbridge, Caragh, Clane, Celbridge and Leixlip on the
 Liffey and Athy and Monasterevin on the Barrow have what would be considered
 restrictive bridges bridges that are also given a very strong weight in terms of heritage
 or architectural protection. This would also apply to smaller rivers, such as the Rye,
 Lyreen, Greese, to name a few.

There are a number of schemes in the capital programme that are endeavouring to deal with certain restrictive bridge scenarios, for example, the Athy Distributor Road (ADR) crosses the Rail line and Barrow, and the Newbridge Southern Outer Orbital, The Celbridge Hazelhatch Mobility Corridor and the Celbridge VRU bridge will cross the



Liffey. The Greenway Programme is providing new vru bridges at certain canal locations e.g., Sallins. There is no specific programme to improve rail crossings although, for example, the ADR and the Maynooth Eastern Ring Road have beneficial rail corridor crossings (and the Dart +). Where Planning applications are submitted, where it is deemed improvements to restrictive bridges are considered necessary for the delivery of any particular development, this is also dealt with.

Councillor Brett thanked Mr S Deegan for the detailed report and noted that he understood this would be a significant undertaking. He stated that Alexandra Bridge affected two villages. In Rathmore parents needed to drive their children to school as there was no safe pedestrian route and this was a serious problem for the area. He stated that funding needed to come from central government.

Resolved on the proposal of Councillor Brett, seconded by Councillor Kelly and agreed by the members that the report be noted.

Pedestrian crossing in Sallins

The members considered the following question in the name of Councillor Clear

Can the council confirm if it plans on constructing a pedestrian crossing on the north side of
the pedestrian bridge currently being constructed in Sallins connecting the school to the
north side of the town and will the missing piece of footpath at Willouise be connected to the
bridge.

A report was received by the Strategic Projects, and Public Realm team advising the members that internal discussions are underway with the Transportation Department to progress the Part 8 for Sallins which will include a pedestrian crossing. The footpath referred to at Willouise is outside the scope of this project.

The report was noted.

Kilteel as a Service Route

The members considered the following question in the name of Councillor Moore



Can the council confirm who should nominate the Townland Centre of Kilteel for its inclusion as a Service Route to other Kildare and Wicklow Towns on the Local Link Service or is this possible?

A report was received from the Transport, Mobility and Open Spaces Department informing the members that this is a matter for the National Transport Authority (NTA). With the members agreement, the Transport Department can write to the NTA. The members agreed for the Transport Department to write to the NTA. The report was noted.

Placemaking strategy for Naas Town

The members considered the following question in the name of Councillor Quinn Can Kildare County Council outline its placemaking strategy for Naas Town?

A report was received by the Strategic Projects, and Public Realm team advising the members that the County Development Plan, Chapter 14 – Urban Design, Placemaking and Regeneration and in particular sub para 14.3.1 refers to Placemaking and Placemaking Strategies. Table 14.1 sets out in the detail the types of Placemaking Strategies available, including Town and Village Renewals and Town Masterplans. Following a successful URDF application, the Strategic Projects and Public Realm team submitted a business case to the Department of Housing, Local Government and Heritage to undertake the preparation of the Naas Town Renewal Masterplan (TRMP). The Department has yet to make a decision on the business case.

Councillor Quinn asked when was the URDF application made and was there any update on it?

Mr E Ryan advised that the original URDF application was made back in 2019.

Ms P Pender advised that the business case was submitted last November and there had been several follow ups but there was no indication of a decision or timeline as of yet.

The report was noted.

Ecology report on the lakes in Naas

The members considered the following question in the name of Councillor Breen

Can the council update the members on the status of the pending ecology report with regard
to the infestation of weeds on the lakes in Naas.

A report was received from Mr. S Wallace, A/Senior Parks and Landscaping Officer informing the members that an ecologist is due to visit the site in the next 2 weeks to assess the lake. The conclusions of this will be communicated with Councillors.

Councillor Breen stated that while she was happy with the report, there was a need to find the cause of the weed infestation. She requested that the water be tested to check if it was contaminated?

Mr S Wallace agreed and advised the members that Parks department would have the water tested and results circulated as part of the ecology report.

The report was noted.

Opening of the DeBurgh Estate

The members considered the following question in the name of Councillor Quinn

Can the council confirm what conservation works are required to open up the DeBurgh

Estate on a phased basis to the people of Naas?

A report was received from Mr. S Wallace, A/Senior Parks and Landscaping Officer informing the members that guided tours of the site will run facilitated by Councillor Moore and the Parks Section for Heritage Week 12 to 20 August. Participants will be required to book online for the tours.

A tender to procure consultants to prepare a conservation plan is part of the Parks Section works programme for this year. This will be used to inform what conservation works need to be considered and will inform a masterplan for the site. It is also hoped to progress plans to resurface some of the existing paths this year. Once this is completed, we will allow occasional access to the grounds on a trial basis. Access and numbers visiting the gardens will be controlled due to the sensitivity of the woodland. This will possibly involve a booking



system to facilitate access and control. The Parks department will need to ascertain what level of resources are required for this and the cost and how parking can be accommodated.

Councillor Quinn asked the following:

- Could the council reconsider and open it up on a phased basis?
- How occasionally would it be open to the public?
- Was the conservation happening this year?

Mr S Wallace said the following:

- Opening up the gardens to the public required management to preserve the landscape so it must be done occasionally and on a trial basis.
- The conservation would happen this year but could not confirm when.

The report was noted.

Naas Town Centre Survey

The members considered the following question in the name of Councillor Moore

Can the council confirm how much progress has been made on the long awaited completion
of a Naas Town Centre Survey, to establish the number of sandwich boards, swing signs,
private cones, ground level menu boards, novelty attractions, domestic refuse bins that
loosely clutter the pavement of the public realm, hinder the public safety of those with
mobility difficulties and restrict progress to towards the LA commitment to provide alternative,
attractive, directional, pole signage for town services, tourism spots and trader locations, as
are seen in the better managed and more modern cities and towns of Ireland.
A report was received by Mr E Ryan, Municipal District Manager informing the members that
there has been no progress made on the Naas Town Centre Survey. This work will take
place as part of the Naas Pathfinder Project and will require a multi-disciplinary team
comprising engagement from urban designers/architects (most likely from the Strategic
Projects and Public Realm Team) and the Sustainable Travel Team.
The report was noted.

NS17/0723 Update on Cemex/Applegreen



The members considered the following motion in the name of Councillor Clear

That the council provide an update on the situation regarding the progress, if any, of the

Cemex/Applegreen site Masterplan to include any documents submitted.

The motion was proposed by Councillor Clear, seconded by Councillor Kelly

A report was received by the Planning Department informing the members that the Forward Planning Team and the Roads and Transportation team met with the landowners in May this year to discuss access and traffic modelling for the Maudlins Key Development Area, in the context of objectives URD 1.13 and URD 1.14 of the Naas Local Area Plan 2021-2027. Feedback from the landowners is anticipated in Q3 which will progress the preparation of the masterplan. The removal of existing structures on site will be addressed in the Masterplan.

Councillor Clear stated that there are two items being held up and preventing Naas wining more Tidy Town awards, the shopping centre and the Cemex site. He said that there are people living on the site and stated this is not acceptable. The people living there need to contact Kildare Co Councils homeless services. He asked will the members see the master plan this year.

Mr E Ryan said that it was not straight forward as there were two different landowners to deal with. He advised that a detailed analysis transport assessment was required to protect junctions and ensure no tailbacks at the roundabout. He stated there would be a meeting to agree the masterplan and he would try to progress this but failing agreement the council would have to step in.

Councillor Kelly asked how long the landowners would be given to find agreement before the council would step in.

Mr E Ryan advised they would have a period of 6 months after the detailed transport assessment.



Resolved on the proposal of Councillor Clear, seconded by Councillor Kelly and agreed by the members that the report be noted.

CPO for the McInerney Lands

The members considered the following motion in the name of Councillor Moore

That this council request the council to immediately initiate the process of a CPO to bring
clarity to the unacceptable duration of time taken by the legal restraints and lack of action on
the finalising of the transfer of the Canal Area McInerney Lands into the ownership of the
Local Authority, unless this issue has recently been solved.

The motion was proposed by Councillor Moore, seconded by Councillor Kelly

A report was received by Mr E Ryan, Municipal District Manager informing the members that a CPO is under consideration.

Resolved on the proposal of Councillor Moore, seconded by Councillor Kelly and agreed by the members that the report be noted.

Renovation of St David's Castle

The members considered the following question in the name of Councillor Breen Can the council update the members on the renovation of St David's Castle A report was received by the Planning Department informing the members that St. David's Castle was awarded a grant of €160,000 under Stream 2 of the 'Historic Structures Fund 2023' run by the Department of Housing, Local Government and Heritage to repair/reinstate or replace each window in the Castle. A Conservation Architect has been appointed by the grant applicant to coordinate the tendering (underway) and works for the window conservation and repairs. An indicative timeframe of up to 24 weeks has been provided to complete the installation of window joinery i.e., to December 2023. The subsequent window reveal lime plastering / weathering would then be possible c. Spring 2024.

Management structure of the Farmers Market

The members considered the following question in the name of Councillor Quinn

Can the council confirm the management structure of the Farmers Market, and whether this differs to the management structure of the Potato Market?

A report was received by Mr E Ryan, Municipal District Manager informing the members that the management structure of the Naas Farmers Market is different from The Potato Market, Church Lane, Naas. The Potato Market is a venue, that can be booked via the County Council by an enquiry to thepotatomarket@kildarecoco.ie. The Naas Farmers Market is a separate entity from Kildare County Council. It is a collective group of stall holders. Kildare County Council signed a Memorandum of Understanding with their de facto chairman that set out the standards and conditions to be abided by stall holders and the services to be provided by Kildare County Council. The Naas Farmers Market takes place every Saturday at the Potato Market from 10:00 to 15:00. The management structure is now under review since the departure of the chairperson of the Naas Farmers Market and the increasing number of enquiries being directed to the Municipal District Manager.

Councillor Quinn made the following points:

- He believed the Potato Market was not achieving its potential as it was unclear how the space could be booked by community groups or how it could be used.
- The generator was too noisy and should be removed as a priority.
- The surface needed to be changed as it was not suitable for wheelchair users.

Mr E Ryan said the following:

- People interested in booking the potato market could do so by emailing thepotatomarket@kildarecoco.ie
- The generator was just an interim measure. A power supply and new circuit board were required and the ESB would need to dig a trench for a new connection.
- Archaeologist supervision was required for all works which would include toilets and means of escape through connections to adjacent properties.



 The change of the surface was something that could be considered when works were complete.

The report was noted.

Naas Women's Shed

The members considered the following motion in the name of Councillor Clear

That the council assist the very successful Naas Women's Shed that has over 170 members in finding a suitable premises.

The motion was proposed by Councillor Clear and seconded by Councillor Breen

A report was received from Economic, Community and Cultural Development Department informing the members that the local community worker is working closely with the group to build capacity and to help to find a suitable location for their organisation.

The members made the following points:

- It was a continuously growing and active group that had not be able to meet lately due to the GAA using the space the usually occupied.
- Besides the Monread centre there had been no new facilities built.
- Community centres who received grand funding should be prioritising community groups and offering them a discount.

Resolved on the proposal of Councillor Clear, seconded by Councillor Breen and agreed by the members that the report be noted.

The motion was proposed by Councillor Moore and seconded by Councillor Kelly

A report was received from Economic, Community and Cultural Development Department informing the members that in 2023, resident association grants were calculated on the basis of the open space area being maintained by each residents' association. This is a change from the previous calculation based on the number of houses in each estate. In some cases, grants were increased and in others, they decreased.

Mr J Shannon advised there was a typo on the report previously circulated to the members, the Area section on the report should be square meters not euros as per the below report.
