# ADMINISTRATIVE COUNTY OF KILDARE.

THE DOGS' ACT, 1906.
REGULATIONS FOR CONTROL OF DOGS
BETWEEN SUNSET AND SUNRISE.

Notice is hereby given that at a meeting held on 12th day of June, 1911, the Local Authority under Diseases of Animals' Acts, 1894 to 1910, for the Administrative County of Kildare in exercise of the powers conferred upon them by the County Kildare (Control

of Dogs) Order, 1911, made the following regulations to come into operation when same should have been submitted to and confirmed by the Department of Agriculture and Technical Instruction for Ireland.

1.—No dog during any of the hours between sunset and sunrise shall be allowed outside the house or adjoining premises of the owner thereof, unless such dog shall be under the effectual control of and in the company of its owner or some other responsible person so as to prevent such dog from breaking away and worrying cattle or sheep.

2.—Any dog in respect of which an offence is committed against any of these regulations may be seized and treated as a stray dog under the powers conferred by Section 3 of the Dogs' Act, 1906.

OFFENCES.—If a dog between the hours of sunset and sunrise is allowed outside the house or adjoining premises of the owner and such dog shall not be in the charge of, and in the company of the owner or some other person, and shall not be under such control that such dog cannot break away or werry cattle or sheep, the owner of the dog and person (if any) for the time being in charge thereof, and any person causing, directing or permitting such dog to be outside such house or premises shall cach be deemed guilty of an offence against the Act of 1894.

3.—These Regulations shall apply to the entire Administrative County of Kildare and shall be in force during the whole year.

Courthouse, Naas, 24th June, 1911.
To the Committee under the Diseases of Animals' Acts.

Mr. Chairman and Gentlemen,-

In pursuance of an order made by you at meeting held on 29th May, 1911, relative to Inspection and Dipping of Curragh Sheep, I beg to report as follows:—

On Friday, 16th June, 1911, being the date fixed by the Committee for the Re-Inspection and Dipping of all Sheep at present grazing on the Curragh. I attended at the Sheep Dipping Station at Ballymanny with a view to making arrangements for the collecting of the charge for Dipping. The following Veterinary Inspectors, viz., Messrs. Jones, Knight, and White, from the Department, and Messrs. Coffey, Naas, and Holland, Athy, were in attendance at the Dipping Station on date mentioned, and after inspection reported that they found no case of disease. The total number of Sheep on the Curragh on 16th June, 1911, was 6,220, and it is satisfactory to note that there was no case of Sheep Scab detected by the Veterinary Inspectors. After examination all the sheep referred to were dipped in the new

Swim Bath recently erected, and I must say that the Inspectors and Sheep Owners were satisfied that the Bath in question is a great success.

Previous to the sheep being dipped I collected the charge fixed by the Committee, viz., one penny per head, and realised a total sum of £25 18s. 4d., which I have lodged with your Treasurer. As regards the collecting of the charge referred to, I must ask you to appoint your local Veterinary Inspector, Mr. W. J. Coffey, to carry out this duty, as owing to pressure of business in the office I could not possibly attend to it, and I would suggest that in future two days be appointed for the dip-ping of all sheep on the Curragh. This would prevent any unnecessary hurry and would also permit of the sheep being kept longer in the drying and retaining pens. In order to prevent waste of Dip, there are some slight additions to the Bath necessary, which I have marked in red ink on original plan, and I would ask you to direct the County Surveyor to have same carried out before the next Dipping.

I have again to state that Mr. J. S. McElveen, Head Bailiff, rendered every assistance in his power to make the Inspection and Dipping a success.

Mr. Chairman and Gentlemen,-

Applications for payment on behalf of Contractors to be considered at this meeting amount to £1,704 16s., which I recommend to be disposed of as follows, namely—To pay, £604 16s., and to defer, £1,100. The £604 16s. recommended for payments consists of £561 16s. for Steam Roller and Plant and £43 for sanitary work at Naas Courthouse in laying a system of drains and connecting with the town main drain in Basin Street.

The Steam Roller and Plant arrived in Naas on 23rd May, 1911. Next day the Roller travelled to Celbridge, where I went the same evening and provisionally came to the conclusion that the Roller and equipments were as specified and agreed upon. Except for a padlock and tool-box and two drag bar pins, all the stores which usually accompany a Steam On Contractors being Roller were supplied.

notified, the padlock and pins were sent to me.

The Roller commenced working on 26th May, 1911, upon road between Celbridge and Lucan, and has been practically working full time ever since. In my report to Roads Committee will be found all details of effective hours worked by Roller, the quantity of broken stone consolidated, working cost, etc., up to last night (27th July, 1911). From my experience of the Roller since 26th May I find myself able to certify for payment to the Contractors who supplied it including for all appliances connected with it. There is one thing which I omitted to include in specification amongst the necessary appliances for the Steam Roller, and that was a force pump for washing out Boiler. At this meeting an application for £6 to purchase a force pump will come before the Committee. I should say that the Contractors who supplied Steam Roller give a Public Works

12 months' guarantee to supply and replace any part required through faulty workmanship or material.

The contract for drainage work at Naas

Courthouse has been satisfactorily completed, and as said I am certifying for same.

The deferred money (£1,100) is for the new offices intended for Agricultural Committee.

Sanction for the loan has not yet been received, but the Contractor took it upon himself to start the work on his own responsibility the loan, however, is sure to be sanctioned.

Some repairs are required to roofs of Naas Courthouse before the winter, which will pro-

bably cost £12.

At last quarterly meeting £30 was granted to paint front of Naas Courthouse and all external woodwork and roof lights two coats. I selected the colour myself for Courthouse front, but when it was finished I thought it was not a proper one. Accordingly I got a third coat probability I believe to the control of the coat was not a proper one. Accordingly I got a third coat put on which I believe is of suitable colour—the cost is £5. I am applying for this sum, and hope the Committee will approve of it. To get a third coat of paint for £5 is good value apart from sentiment about colour.

## COUNTY SURVEYOR'S REPORT.

A report from the County Surveyor dated 28th July, 1911, was read and approved as follows:—

Mr. Chairman and Gentlemen,-

The Steam Roller and Plant arrived in Naas on 23rd May, 1911. Next day it travelled to Celbridge. On 26th May the Roller commenced work of consolidating material upon the road between Celbridge and Lucan—it has been practically working full time ever since. To get a new Roller and a new staff into smooth working requires some time, but I am glad to say that even from the very commencement there was nothing to complain about—good work in quantity and quality has been done. The Driver and Flagman are receiving respectively 28s. and 15s. a week. I took every possible care in selecting these men, remembering the value of county property in their charge and the risk of accidents that would arise from carelessness or neglect.

Up to last night (27th July, 1911) the number of effective hours worked by the Roller was 452 hours, during which time it consolidated 1,954 tons of broken stone, which covered 330 perches in length of road; that is, one mile and ten perches. Only about 200 tons of stone remain to be rolled upon this contract. The payment which the County Council will receive for hire of Roller is 2s. for each effective hour worked. Up to last night the 452 hours' hire amounts to £45 4s. The actual working expenses of every kind up to last night since Roller arrived, including travelling from Naas to Celbridge, was £37 13s., of which £20 13s. is for wages of Driver and Flagman; £1 7s. 3d. for two Warning Notice Boards and a Red Flag; £13 3s. 9d. for 11½ tons of coal, and the balance for lubricating and cylinder oil, 3 hand lamps, paraffin oil and small sundries.

Out of the 11½ tons of coal, one ton was supplied at Naas for £1 2s. 3d. (which included

return of bags from Celbridge); the remaining  $10\frac{1}{2}$  tons of coal (Whitehaven) was procured from a coal merchant at Hazelhatch at 23s. a ton delivered in bags to Roller on road—this price was the lowest I could get the coal for.

The Roller has been working say 9 weeks near Celbridge, and during that time used 11½ tons of coal, which is something over 1¼ tons

a week.

A great anxiety about a county-owned Roller is to obtain constant work for it to do. And this anxiety confronts me at the present There is about £30 to be expended in doing patchwork rolling upon three roads using portion of the ordinary maintenance supply of material-but to do patchwork rolling at this season of the year is not advisable for various reasons. There is rolling work to be done (to the extent of 800 tons or thereabouts) near Carbury, but I am afraid the harvest work may interfere with it. tised for tenders to spread materials, etc., before the Roller at this place, but got no response from people in the locality

During short periods when a Roller has to be idle for want of work it would be a serious thing to be compelled to dismiss the Driver

and Flagman.

At last quarterly meeting of Celbridge No. 1 District Council the sum of £2,400 was approved for Steam Rolling (half the amount to be contributed by Road Board).

be contributed by Road Board).

In case I could hire the Roller to private persons at 3s. an hour when not engaged on county work, I think the Committee might

approve of my doing so.

Also it will often happen that a Roller may have to be laid up and be idle from many causes—one of which would be frosty or snowy weather. In such cases there should be provision made to place Roller and Plant under cover. This could be done by paying some small rent at suitable places convenient to wherever the Roller may be located.

An application dated July 20th, 1911, from Veterinary Inspector Coffey asking the Committee for an increase in his remuneration consequent on additional duties imposed on him by the Curragh Sheep Order of 1911, was read as follows:—

Naas, July 20th, 1911.

To the Committee appointed under the Diseases of Animals' Acts.

Mr. Chairman and Gentlemen,-

I beg to apply for an increase in my remuneration on account of additional duties imposed on me by having to superintend the admission and removal of all sheep from the Curragh Greenlands.

In support of my application I would point out that in pursuance of a resolution of the County Council adopted at meeting held on 17th May, 1910, relative to inspection of Sheep, I attended at the Curragh on 80 different occasions during the period ended 30th June, 1911, as per particulars herewith, with a view to

having all necessary precautions taken so as to try and stamp out Sheep Scab. I also attended at the offices of the Department of Agriculture on three occasions for the purpose of making arrangements relative to the compulsory Dipping of all Sheep and also the steps to be taken to have the wool disinfected immediately on being shorn. This process necessitated my attendance at the different shearing stations almost daily during the month of June, 1910.

The Department of Agriculture issued an Order dated 20th February, 1911, entitled "The Curragh Sheep Order, 1911." This Order necessitated my attendance at the Sheep Dipping Station at Ballymanny on every alternate Friday during the months of March, April, and May, 1911, for the purpose of examining all sheep brought in for admission to the Curragh so as to see that nothing but clean sheep were admitted. The result of this examination is borne out by the fact that on the 16th June, 1911, the Department's Veterinary Inspectors failed to discover any case of disease among the 6,220 sheep collected for Inspection and Dipping.

If you are satisfied with the manner in which I have carried out my duties as Veterinary Inspector, I sincerely trust you will see your way to increase my remuneration commensurate with increase of work consequent on dealing with the question of Sheep Scab on the Greenlands of the Curragh, which I am glad to say has now completely been stamped out.

At a meeting of the Roads' Committee held on 2nd inst. I reported on matters connected with the County Steam Roller and the work done by it up to evening of 27th July. Report contained some suggestions which the Committee approved of subject to confirmation by the County Council. The Steam Roller and Plant arrived in Naas on 23rd May last. Next day it travelled to Celbridge and on 26th May commenced working on the Dublin Road near that town. The work upon this road was completed on 4th August. The total quantity of broken stones consolidated was 2,250 tons and the number of effective hours worked by the Roller was 508 at 2s. per hour. 16s. Od. was earned by the Roller up to evening of 4th August. The working expenses of Roller from 24th May to 4th August amounted to £42 12s. 9d. of which £23 3s. 4d. is for wages of Driver and Flagman, and the balance (£19 9s. 5d.) for coal, oil and various sundries required from time to time. I should say that in the £19 9s. 5d. is included the sum of £1 6s. 3d. for two moveable Danger Notice Boards to guard against accidents-these Notice Boards will of course last for many a year. The consumption of coal from 24th May to 4th August (ten weeks and two days) was 12 tons which is at the rate of about 24 cwt. a week. The coal (Whitehaven) cost 23s. a ton-the cheapest tender I obtained. On 5th August the Roller worked 81 hours at 3s. an hour on a private road for Mr. Wardell near Celbridge-he is to pay £1 5s. 6d. to County Council for this work. Making arrangements for safe, efficient and conomical working of a County Steam Roller as well as having as few idle days and as little non-effective work as possible must always be a matter for anxiety. Up to the present the arrangements made have been satisfactory taking into account the money available for steam rolling and the extent and location of work to be done. I did intend after finishing work on Celbridge to Dublin Road to transfer the Roller to the Ardrass Road close to Celbridge to do some patchwork and improvement

to channels. But I had to give up this idea and wait for approach of winter. Also there is about a fortnight's rolling work consolidating patches upon a road between Curragh Camp and Kildare—but there is no water within reasonable distance of this road at the present time. There is between 3 and 4 weeks' rolling work of thorough sheeting near Carbury which will be commenced on Monday next. there is not a certainty of constant work for a Roller within a fairly small area one has to rely entirely upon such labour as can be picked up here and there. For small jobs long distances asunder a trained constant gang of labourers cannot be employed, and in harvest time it is difficult to get casual labour. Between thorough sheeting and patchwork the money available at present would provide for about two months' rolling work, but I cannot guarantee that any patchwork rolling can be done earlier than towards end of October. As mentioned later on in this report, the Council of Celbridge No. 1 District approved of rolling work which would keep a Roller employed for over eight months. But there will be delay in getting final legal sanction for this work Thus it is inevitable that the Roller will have enforced periods of idleness for some time, but it is most probable that this will not occur in future years. It was thought that all District Councils would be induced to approve of some rolling expenditure when the County Council had a steam roller of its own. So far, however, the Councils of Naas No. 1 and Athy No. I seem to put no special value upon the services of a county-owned roller.

The Driver and Flagman of the roller have given satisfaction and are good men, and it would be a most serious thing to think of dismissing them when the roller has no work to do. Very great care had to be taken in selecting the Driver of the Roller and by terms of his appointment one month's notice on either side to terminate agreement must be given. His wages is 28s. a week to be raised to not exceeding 30s. a week at such time or times as County Surveyor thinks right and fair. The

Flagman has 15s. a week and I believe will in due time make a good Driver. The Office files and books relating to matters connected with Steam Roller since it arrived on 23rd May will be placed before the County Courcil.

I believe the Steam Roller and Plant are as specified and agreed upon- the contractors give a 12 months' guarantee to supply and re place any part required through faulty work-

manship or material.

I applied for small sums of £100 and £200 in Athy No. 1 District and Naas No. 1 District respectively to do some steam rolling but the applications were not approved of. The Council of Celbridge No. 1 District approved of £2,400 (half cost to be contributed by the Road Board) for the cost of the Road by the Road Board) for the cost of the Road by the Road Board of the Road by the Board) for steam rolling upon part of the Dublin to Mullingar road between Leixlip and The half cost (£1,200) charge Maynooth. able to District to be borrowed and repaid in This work has been set to a contractor subject to approval of the specification, etc., by the Road Board and approval of loan by the Local Government Board. I have had statistics of various kinds of traffic taken upon this road adjoining Leixlip Station for seven consecutive days (commencing on 13th July) Taking, for between 6 a.m. and 10 p.m. example, four kinds of traffic passing over road the following is daily average for (1) Bicycles, 132; (2) Motor Cars, 33; (3) Motor Delivery Vans, 5; (4) Two-wheel Vehicles (horse-drawn), Between Leixlip and Maynooth in six different places I got excavations made for the purpose of reporting to the Road Board as to crust of road, the foundation and subsoil.

I request the County Council to authorize advances from time to time to contractors for Steam Rolling upon Mullingar road (assuming the necessary sanction of Road Board and Local Government Board will be obtained) and also to contractor for building New Offices adjoining Naas Courthouse for such sums as may be certified by County Surveyor up to 85 per cent. of work satisfactorily executed. Con-tractor for the New Offices has commenced the work. The new bridge over the Blackwater is

completed.

Inspections of work in progress upon rivers in the drainage districts have not yet commenced, but I hope if at all possible to have Foranwell and Gorteen Districts inspected before date of Quarterly Meeting.

I do not know of any other matter that requires to be mentioned in this report.

The Examination Papers will be of Honours' standard. Candidates will be required to answer on five subjects as at Marticulation, and as a minimum qualification for award of a Scholarship a candidate must obtain honour.

2. Candidates to whom Scholarships have been awarded as the result of the Special Scholarship Examination, must in addition comply with the University regulations, by passing the usual Matriculation Examination to be held in the last week of September, 1911 failing which the grant of a Scholarship will

3. Students must satisfy such tests (if any) as to knowledge of Irish as the County Council may prescribe prior to being permitted to enter for the Scholarship Examination.

4. Students must reside in a Collegiate

Hostel approved by the Council.
5. The cost of the maintenance of each Student-estimated at £31 per annum for a period of 31 weeks (the University Session) will be paid direct by the County Council to the Managers of the Collegiate Hostel selected.

6. The fees for the University course of each Student will be paid direct to the University authorities from the Scholarship Fund. These fees amount approximately to £10.

7. The balance of Scholarship Fund, estimated at £8 or £9, will be paid to each Student for the purpose of travelling and inci-

dental expenses.

8. Applications from Candidates for admission to the examination must be accompanied by a certificate as to education and character, signed by applicant's clergyman, and some other respectable person to whom applicant

9. The award of Scholarships is limited to such candidates as satisfy the County Council that they are qualified to profit by University instruction, and are in need of assistance to obtain it. And further, that they continue to satisfy during their University course such tests of ability as may be prescribed by the University.

1—No dog during any of the hours between sunset and sunrise shall be allowed outside the house or adjoining premises of the owner thereof, unless such dog shall be under the effectual control of and in the company of its owner or some other responsible person so as to prevent such dog from breaking away and worrying cattle or sheep.

2—Any dog in respect of which an offence is committed against any of these regulations may be seized and treated as a stray dog under the powers conferred by Section 3 of the Dogs' Act, 1906.

#### OFFENCES.

If a dog between the hours of sunset and sunrise is allowed outside the house or adjoining premises of the owner and such dog shall not be in the charge of, and in the company of the owner or some other person, and shall not be under such control that such dog cannot break away or worry cattle or sheep, the owner of the dog and person (if any) for the time being in charge thereof, and any person causing, directing or permitting such dog to be outside such house or premises shall each be deemed guilty of an offence against the Act of 1894.

3—These Regulations shall apply to the entire Administrative County of Kildare, and shall be in force during the whole year.



(2) During the last quarter (ending 30th September, 1911), in addition to the £4,473 15s. 3d. recommended for payment as above, the sum of £226 1s. 9d. was certified to Finance Committee for payment out of the Subsidiary Account relating to three heads of expenditure, namely (1) for work in charge of County Surveyor, (2) for sudden damages, and (3) for work done by County Surveyor under 54th

(3) On 1st July last Mr. Hugh Higgins, of Rathangan, became Contractor for two lengths of roads in Edenderry No. 2 District, his sureties being Messrs, James Maloney, of Cappanargid, and Patrick Flynn, of Kilmoney. The roads referred to are (1) 1,388 perches between Rathangan and King's County boundary at Cushaling bridge, and (2) 695 perches between Tullylost three roads and Barony Boundary near Knavenstown cross roads. As regards road No. 1 (1,388 perches) the price allowed was £80 19s. 4d. a year—the Contractor's price was £57 2s. According to specification the annual quantity of material was 220 cubic yards, but on 4th October it was found impossible to measure with accuracy the material supplied. There were about 80 loads of unbroken material and 49 cubic yards of broken material-the surfaces of road and footpath were neglected. As regards road No. 2 (695 perches) the price allowed was £34 15s. per annum, and the contract price was £31 17s. The specified quantity of material for this road was 70 cubic yards, but on 3rd October (date of measurement) material laid down was about 41 separate loads-also road and footpath badly neglected. On 10th October Contractor was written to and notified as to his neglect upon both roads, and a return was sent regarding the material supplied. Also on same date letters were written to Contractor's Sureties pointing out that they would be held responsible for Conractor's neglect, and for any damage that might occur to the roads thereby as well as for any increased cost that may have to be incurred owing to Contractor's default. To these letters I got no reply except from one of the Sureties (Jas. Maloney). He wrote on 15th October saying he is a poor working man with nothing only his day's labour to depend upon, and that he could do nothing with the roads. From inquiries made I came to the conclusion that the proper thing to do as regards road No. 1 (1,388 perches) was to have the contract broken and a new contract entered into. Accordingly at Edenderry No. 2 Quarterly Meeting on 21st October the Council approved of a new proposal for maintenance of this road (dividing it into two lengths) to commence on 1st January next. The new contract price is £66 10s. a year. I recommend that the action of Edenderry No. 2 Council be approved of. I should say that the County Council have power to cancel a contract at any time on the County Surveyor's Report of the Contractor's neglect or on his refusing his certificate for payment at any Quarterly Meeting. According to the opinion of a very eminent K.C., when a County Council rescind Meeting. a contract they can also sue the Contractor and his Sureties on the Bond for damages sustained by reason of the breach of contract. The measure of the damages would be the increased expenses which the County Council

are put to by reason of the breach of contract. And in this sum the Court hearing the case can take into account the increased amount which the Council have to pay on the new tenders.

I cannot yet say if it will be necessary to have the contract upon road No. 2 (695 perches) broken. The price for which this road was taken may be sufficient to have it worked by myself under Section 54 of the

Grand Jury Act.

On 24th October the Contractor's neglect upon these two roads was reported to Secretary of County Council, and he brought the matter before the Roads' Committee, who authorised Ten Day Notices (under Section 54 of Grand Jury Act) to be served. These Notices were served on 8th November. 22nd November the roads were inspected and it was found that the instructions in the notices were not complied with. I hope before date of Quarterly Meeting to have men working on these roads and get as much done as the money available will allow. My reason for reporting at such length about these two roads is that the principle involved in dealing with them is an important one.

(4) In September serious neglect was discovered upon two roads for which Patrick Kelly, of Newtown Great, is Contractor. The Roads' Committee authorised processes to be issued against Contractor and Sureties for damages. Notices to this effect were sent to Contractor and his Sureties. One of the Sureties undertook to do the work, and he has kept his promise. Although the processes were served they were not entered.

(5) Samples of the kind of stone proposed to be used for Steam-Rolling upon the road between Leixlip and Maynooth were sent to the Road Board to be tested. The Road Board approved of the stone, which is from a gravel pit near Leixlip Station. The Road Board is paying half cost (£1,200) of this work and have sent £400 as a first instalment. In writing the specification I provided for 3-inch size stones, but the Local Government Board thought that 21-inch stone would be more suitable, and the specification has been altered accordingly. The Contractor consents to this alteration.

(6) The County Steam Roller arrived in Naas on 23rd May last. Since then to 24th November, 1911, it has earned £132 12s., made up of £52 1s. 6d. earned rolling a road at Celbridge, £24 19s. rolling a road at Carbury, and £55 11s. 6d. doing pumping work for 5553 hours at Naas. The total expenses connected with Roller, including wages, coal, oil and various small stores up to same date (24th November, 1911) amount to £110 8s. 7d. I am expecting the Roller to commence doing patchwork on Monday, 27th November, at Celbridge-it should have work at this place for nearly three weeks. When finished at Celbridge I intend to send the Roller on to

the Curragh to consolidate patches of material between Kildare and turn to the Camp—there should be about a month's work at this

place.

(7) The question of erecting telephone poles at Maynooth and Celbridge was referred to me. Strong objections were made at Maynooth against putting up poles adjoining College entrance and the Protestant Church. I thought these objections could not be got over, but I am glad to say that the Duke allowed the poles to be placed along the grounds at back of Cromaboo Castle. In Celbridge I laid out positions of poles in places that should cause no inconvenience or unsightliness between the Charter School and a point near the Workhouse.

(8) A letter was written to the Board of Works by your Secretary giving three months' notice to terminate an agreement relating to a room used as Customs and Excise Office in Athy Courthouse. The Board of Works replied and asked if County Council had another room in the Courthouse which the Council would be prepared to let. I beg to report that there is another room in Athy Courthouse (in old times it used to be the Petty Jury Room). There is no fireplace in this room, but it would not be difficult to put one in it—this work, together with other necessary alterations, painting, etc. (and including sanitary work), would cost about £35.

(9) There is an action pending in reference to a road leading through Lullymore. landlord claims this road to be a private one, while it is contended by the defendant in the case (Mr. O'Riordan) that it is a public road. A resolution was passed at last Quarterly Meeting that the County Council be represented at hearing of this case with a view of safeguarding the rights of the public. road connects two public roads at present under contract and which terminate respectively at Barnaran at the Rathangan end and the boundary of Lullymore at the Clane (or Allenwood) end. The length of the road claimed to be a private road is 882 perches On looking up Grand Jury or thereabouts. Books I find that from Summer Assizes, 1866, to Summer Assizes, 1878, a length of 162 perches extending into Lullymore and included in the 882 perches just referred to was continuously repaired by the County. This fact I made known to the County Solicitoralso the Solicitors for both plaintiff and defendant. Since 1878 the length of 162 perches has been out of contract. I travelled the whole road lately to refresh my memory

(10) It is possible that a mistake may have occurred in the measurement of material upon a road in Naas No. 1, namely, Permanent Index No. 4, Registered No. 448 (782 perches). The sum of £2 was "struck off" at District Quarterly Meeting, but for fear of a mistake I recommend the County Council

to mark it "deferred," and the matter will be further inquired into.

(11) The transfer of Rathangan River Drainage District to the County Council has been sanctioned by Parliament, but before any steps whatever can be taken in my department a complete set of maps will be required showing exactly all the rivers and tributaries as well as collateral works legally

comprised in the original scheme.

(12) Mr. Doyle, of Suncroft, wrote asking permission to put a weighbridge on side of There is a space road adjoining his house. 9 feet wide between road channel and a road This place wall opposite Mr. Doyle's house. would be suitable for the weighbridge and would not interfere with traffic. The required permission may be granted to Mr. Doyle subject to his sending me a map showing approved position of weighbridge and also details of the weighbridge itself-a condition attached to the permission should be that the weighbridge is to be removed at any time the County Council may direct. I pointed out proper position for weighbridge a few days ago to a representative of Mr. Doyle's.

(13) The Contractor for Agircultural Committee Offices in Basin Street, Naas, is doing satisfactory work. Only for the recent strike all the masonry would have been completed and ready for roofing probably a fortnight ago. If the weather is suitable I expect the masonwork will be finished early in January.

(14) On 15th September the Assistant Surveyor for Northern Division of the County (Mr. Edward Coonan) wrote me regretting that he had no measurement reports to send that day, owing to the state of his knee, which was in an inflamed and swollen condition and so bad that the doctor insisted on his remaining in bed and giving the leg entire The matter was reported to the Finance Committee and leave of absence for three months ending 31st December was given to the Assistant Surveyor. The time for deciding about Contractors' payments was approaching, and I had therefore to get measurements made by Mr. Fullam, from my Office, and Mr. Domican, the Assistant Surveyor for Eastern Division of the County. Fortunately by continuous effort the measurements were completed in time for the Quarterly Meetings at Celbridge, Edenderry, and Naas. Coonan, I believe, intends to retire on 31st December, and I will be sorry to sever my long connection of about 23 years with him. It will be necessary without delay to appoint a temporary Assistant Surveyor until a permanent appointment can be made.

1—In these presents—The "Trust Estate" shall mean all that and those part of the lands of Smallford containing 9 acres and 4 perches, part of the lands of Ardmore containing 2

acres and 28 perches, part of the lands of Sawyerswood containing 17 acres 1 rood 36 perches, part of the lands of Ardscull containing 18 acres 1 rood 21 perches, part of the lands of Forest containing 1 rood 28 perches, and part of the lands of Russellstown containing 11 acres statute measure or thereabouts, situate in the Baronies of Narragh and Reban East and Narragh and Reban West, and County of Kildare, as delineated in the map annexed to these presents, and comprised in a certain purchase agreement dated twentyseventh day of February, one thousand nine hundred and eleven, and subject as in the said agreement mentioned:-

(b) The "Trustees" shall mean the County Council of the County of Kildare.

2-The Trustees shall stand possessed of the Trust Estate upon the Trusts and for the pur-

poses following

To preserve all trees, woods or plantations now growing on the Trust Estate or any part or parts thereof; to plant the Trust Estate or such part or parts thereof as may in their opinion be suitable for that purpose with timber or other trees and to preserve the timber or trees so planted; to thin out the trees, woods, or plantations in a proper manner when necessary, and if any such trees, woods or plantations should at any time hereafter fall, decay or become ripe for cutting, to cut down and remove the same or any of them and to sell the timber or trees so cut or removed and to receive the purchase moneys thereof and to replant the places from which such trees shall have been removed or any part thereof or to plant any other part or parts of the Trust Estate at their own sole discretion.

To preserve all game and fish upon the Trust Estate or any part thereof and to take such proceedings as may from time to time be necessary for the prosecution of persons wrongfully taking or injuring the same and to let the rights of shooting or fishing upon or over the Trust Estate to such persons and for such periods and on such terms as to payment or otherwise as may to the Trustees from time

to time seem fit.

3—Without prejudice to any other powers and authorities vested in the Trustees under these presents the Trustees shall have subject to the approval of the Department of Agriculture and Technical Instruction for Ireland, the special powers following:-

(a) Power to employ and remunerate any Solicitor, Land Agent, Engineer, Surveyor, Forester, Gamekeeper, Bailiff, or Caretaker or any other Agent or Servant they may think fit from time to time to employ in connection with the execution of the trusts of these presents.

(b) Power to make, do and execute all such deeds, acts and things as they may deem necessary or proper for giving effect to these presents.

4—(a) The power of appointing new Trus-

tees of these presents shall be vested in the County Council of the County of Kildare.

(b) The Lord Lieutenant shall have power to remove at any time by writing under his hand all or any of the Trustees, and to appoint a new Trustee or new Trustees in place of the person or persons so removed.

5—The Trustees shall meet at such times and places as they may arrange, and shall enter in a book or books to be kept for that purpose a record of all proceedings at their meetings and a full account of all moneys received or paid by them in the execution of the Trusts of these presents.

6—All moneys received by the Trustees that may not be required for the payment of the said annuity payable in respect of the Trust Estate and for the payment of necessary expenses of the management thereof, shall be laid out by the Trustees in the improvement and development of such Estate with a view to the several purposes contemplated by these presents so far as the same shall be required and subject thereto applied by them as they may from time to time determine, but the Trustees shall see that at all times the Trust Estate is being properly maintained for the purposes for which the same has been acquired.

7—Any person aggrieved by any action or omission of the Trustees in carrying these presents into effect may present a memorial in writing signed by such purchaser or other person to the Lord Lieutenant stating:—

(a) The locality of the Trust Estate and the interest of the memorialists therein.

(b) The names and postal addresses of the Trustees for the time being of these

(c) The precise action or omission by the Trustees of which the memorialist complains, and the Lord Lieutenant may on investigation into the matter so complained of make in writing under his hand such orders in the premises as may appear to him just including an order for the removal from office of all or any of the Trustees) and any orders so made shall thenceforth be binding on the Trustees and on all other parties interested in the Trust Estate.

8—If the Trust Estate or any part or parts thereof shall be no longer required for any of the purposes contemplated by these presents, the same may be sold or otherwise disposed of for such public purposes as the Lord Lieutenant may approve, and the net proceeds, if any, of any such sale shall be applied as the Lord Lieutenant shall direct.

Mr. Chairman and Gentlemen,-The only application for payment on Form 22 to come before this meeting is on behalf of contractor for the New Offices in Blasin Street, Naas. I am recommending payment of £350 which with £200 already paid makes When the site of £550 certified to date. building the new and adjoinbeen ground have cleared and levels finished brought to proper it will be necessary to consider new sanitary arrangements to supersede the existing pail I am not at present able to advise what the new arrangements should be, but I hope to have all details for next Quarterly Meeting. Meantime I recommend that Naas Urban Council be requested to give such time as may be reasonably necessary for abolition

of the existing pail system.

The contract for County Printing will expire on 1st April next and I am applying for the estimated sum of £800 to provide for renewal of the contract. This time three years the Committee approved of £1,200. am informed that the cost of printing for the year ending 30th September, 1911, was £633

12s. 3d. It will be necessary to agree upon an estimate for county-at-large expenditure upon public works such as repairs to Courthouses, sanitary work at rere of Naas Courthouse, expenses connected with steam-roller, etc. I should say that in May last the sum of £60 was allowed to provide a fund for payment of expenses connected with the steam-roller. I find that up to this day the expenses since the roller arrived last May amount in round numbers to £141—the money earned by the roller during same time amounts to £170. Hence the £60 allowed last May is still available. On account of the roller being a new one it is most probable that repairs will cost little, if anything, except perhaps some trifling re-newals. Therefore, I think in making the newals. estimate for coming year expenses connected with the steam-roller need not be taken into

account. The estimate usually adopted in the past was £200, but I think for the coming year the estimate should be £300.
